According to police the incidents reported are directly
related to increased racial tension in the Bedford - Stuyvesant
area of Brooklyn, New York, in the past few days. These are not
clashes between ethnic groups, but are described by police as
the result of racial tension between Negroes and whites (u)

At approximately 11:30 p.m., August 21, 1966, a group
of Negro youths who had attended a dance held by a group called,
"Youth in Action", assaulted a white youth at Skillman and Willoughby
Avenues, Brooklyn, New York, and cut him on the head. (u)

At 1:30 a.m., on August 22, 1966, two Negro youths,
ages 16 and 17, jumped an officer at Bedford and De Kalb Avenues,
Brooklyn, New York. According to [REDACTED] here was
no disorder and no arrests made in either instance. (u)

Incidents at Prospect Park West,
Bedford Avenue and Park Avenue,
and Skillman and Flushing Avenue,
all Brooklyn, New York, on August 22, 1966(u)

At approximately 7:00 p.m., a Brooklyn Summer Youth Theatre Group of 1151 Bedford Avenue, Brooklyn, were rehearsing in Prospect Park, Brooklyn, New York. During a rehearsal break five females and one male, all Negro, went to a "pizza joint" at 209 Prospect Park West, Brooklyn. In front of the "pizza joint" a group of whites made derogatory remarks to the Negroes and an altercation ensued. As a result of this altercation, one female Negro, age 16, a male Negro, age 19, and a white male, age 17, were taken to the Methodist Hospital in Brooklyn. All suffered slight injuries but no arrests were made and no one has pressed a complaint(u)

At 10:40 p.m. August 22, 1966, NYCPD arrested [REDACTED] b7c

[REDACTED] They were arrested at Bedford and Park Avenue, Brooklyn, and both were charged with:(u)

1. False alarm of fire.
2. Malicious Mischief (broken windows in area).
3. Disorderly conduct.
4. Violation of Section 1991, Subdivision 4 (throwing rocks at police and firemen answering the false alarm. NYCPD automobile number 1471, of the 90th Precinct was hit by a rock resulting in little or no damage(u) b7c

[REDACTED] advised that [REDACTED] admitted to police that he had been taking "instructions" from the "Five Percenters" for one week and [REDACTED] admitted taking instructions for two weeks. He described the "Five Percenters" as a militant Negro youth organization on the style of the Black Muslims(u)

[REDACTED] BSS, NYCPD, advised 6:25 a.m.,
August 23, 1966, that the racial situation in the Bedford - Stuyvesant
Section of Brooklyn continued tense until about 2:30 a.m. During
the night, a roving band of approximately 200 Negro youths between
the ages of 14 to 21 years old, created incidents in the area
involving clashes with patrolmen, bottle throwing and breaking
windows. The incidents were separate but related to the roving
band of youths. The band was dispersed and situation subsided
at approximately 2:30 a.m. Two NYCPD officers were injured and
taken to the Cumberland Hospital. Their condition not known at
this time. (u)

On August 8, 1966, [REDACTED] b7c
BSS, NYCPD, advised that the "Five Percenters"
have no clubhouse or headquarters. They operate
mainly as a Harlem and Bedford - Stuyvesant
street gang with an estimated membership of
300 youths. He stated that they were a very
loose organization with no real leadership.
The "Five Percenters" are made up of neighbor-
hood groups of young Negro teenagers who have
no respect for law and order (u)

[REDACTED] commented that the Police
Department has developed no information to
the effect that the "Five Percenters" are tied
in with any subversive organization. (u) b7c

APPROXIMATELY SIXTY NEGRO FOLLOWERS OF "FIVE PERCENTERS" IN COURT ON JUNE ONE INSTANT, WHEN SIX NEGROES ABOVE WERE ARRAIGNED. WHEN SIX DEFENDANTS APPEARED, THE SIXTY FOLLOWERS ROSE TO THEIR FEET AND SHOUTED "PEACE" HOLDING THEIR PALMS UPRAISED. JUDGE O-BRIEN CLEARED COURT IMMEDIATELY. (u)

NEGRO WHO IS SELF-IDENTIFIED AS LEADER OF "FIVE PERCENTERS" AND USES THE NAME ALLAH, BERATED JUDGE O-BRIEN AND INFORMED THE JUDGE THAT HE, ALLAH, IS GOD AND THREATENED TO KILL WILBERT LEE AND NYCPD PATROLMAN WHO ARRESTED HIM. (u)



On July 30, 1965, [redacted]
Bureau of Special Services, New York City Police Department,
furnished the following information (u)

[redacted] of the 28th Precinct, New
York City Police Department, Harlem, was on July 29, 1965,
at about 10:30 p.m., attempting to arrest [redacted]
[redacted] New York City, for disorderly conduct,
while trying to effect this arrest [redacted] was set
upon by sixteen other negro youths, who threw garbage cans
and bottles at him. These disorderly youths were described
by Police as belonging to the "Five Percenters", which is
described hereafter. (u)

With additional police assistance, seventeen arrests
were effected. Six of the youths arrested were 14 and 15
years of age and were booked as juvenile delinquents. The
remaining eleven, ages 16 to 18, were charged with disorderly
conduct, inciting to riot, unlawful assembly and resisting
arrest. The juveniles were to appear in Children's Court,
22nd Street, New York City, July 30, 1965 and the adolescents
in Adolescent Court, Centre Street, New York City, July 30,
1965 for arraignment. (u)

Disturbance By Group Called

Concerning the Fiver Percenters, [REDACTED]
[REDACTED] Bureau of Special Service, New York City Police
Department, on June 7, 1965, described this group as follows (u)

The "Five Percenters", who are on occasion, referred to as the "brotherhood of Blackmen" or the "Brotherhood of Allah," is a loosely knit group of Negro youth gangs in the Harlem section of New York City. They come from an area bounded by Fifth Avenue on the east, Seventh Avenue on the west, 120th Street on the south and 130th Street on the north. These particular gangs emanate from New York City Public School Number 120, which is a junior high school serving the above area and located near 120th Street at 1832 Madison Avenue. They also hang out around New York City Public School Number 68 located at 127 West 127th Street (u)

These youths are typical of the numerous street type gangs that exist in Harlem except that they have been influenced by an individual who refers to himself as "Allah" and has indoctrinated them in the distorted Muslim teachings of Nation of Islam (NOI) leader Elijah Muhammad (u)

A characterization of the NOI is attached and all sources therein have furnished reliable information in the past. (u)

This "Allah" is the recognized leader of the "Five Percenters" and was one of the six arrested on May 31, 1965 by the New York City Police Department. He has been identified as Clarence 13X Smith of 21 West 112th Street, New York City, apartment 5E. Although at the time of his arrest he denied being an NOI member at present, he is known to have been a member in the past where he received his "X name". He is unemployed and spends his time hanging around the above-mentioned area where he contacts and indoctrinates the youth of the area. (u)

APPENDIX

NATION OF ISLAM, formerly referred to as the Muslim Cult of Islam, also known as Muhammad's Temples of Islam

In January, 1957, a source advised ELIJAH MUHAMMAD has described his organization on a nationwide basis as the "Nation of Islam," (NOI) and "Muhammad's Temples of Islam." (u)

On May 8, 1964, a second source advised ELIJAH MUHAMMAD is the national leader of the NOI; Muhammad's Temple of Islam No. 2, 5335 South Greenwood Avenue, Chicago, Illinois, is the national headquarters of the NOI; and in mid-1960, MUHAMMAD and other NOI officials, when referring to MUHAMMAD'S organization on a nationwide basis, commenced using either "Mosque" or "Temple" when mentioning one of "Muhammad's Temples of Islam." (u)

The NOI is an all-Negro organization which was originally organized in 1930 in Detroit, Michigan. MUHAMMAD claims to have been selected by Allah, the Supreme Being, to lead the so-called Negro race out of slavery in the wilderness of North America by establishing an independent black nation in the United States. Members following MUHAMMAD'S teachings and his interpretation of the "Koran" believe there is no such thing as a Negro; that the so-called Negroes are slaves of the white race, referred to as "white devils," in the United States; and that the white race, because of its exploitation of the so-called Negroes, must and will be destroyed in the approaching "War of Armageddon." (u)

In the past, officials and members of the NOI, including MUHAMMAD, have refused to register under the provisions of the Selective Service Acts and have declared that members owe no allegiance to the United States. (u)

On May 5, 1958, the first source advised MUHAMMAD had, upon advice of legal counsel, tempered his personal statements and instructions to his ministers concerning the principles of his organization in order to avoid possible prosecution by the United States Government; however, he did not indicate any fundamental changes in the teachings of his organization. (u)

On May 7, 1964, a third source advised MUHAMMAD had, early in July, 1958, decided to de-emphasize the religious aspects of the teachings of Islam and to stress the economic benefits to be derived by those Negroes who joined the NOI. This policy change, according to MUHAMMAD, would help him acquire additional followers and create more interest in his programs. (u)



Previously a bar window had been broken by the group and a Negro male named Wilbert Lee had been struck on the head with a stick wielded by one of the six arrested. Approximately 90 minutes before this incident these same six individuals had caused a disturbance at the corner of Lenox Avenue and 116th Street in Harlem. ORGANIZATION OF AFRO-AMERICAN UNITY, INCORPORATED (OAAU)

On June 28, 1964, MALCOLM X LITTLE, founder and leader of the Muslim Mosque, Incorporated (MMI), publicly announced the formation of a new, all Negro, militant civil rights action group to be known as the Organization of Afro-American Unity (OAAU), with himself as Chairman. This announcement was made at a public rally held by the MMI in the Audubon Ballroom, Broadway and 166th Street, New York City. (u)

A printed and published statement of basic OAAU aims read by MALCOLM X at this meeting indicates that it shall include "all" people of African descent in the Western Hemisphere, as well as "our" brothers and sisters on the African continent. It is patterned after the "letter and spirit" of the Organization of African Unity established (by African heads of States) at Addis Ababa, Ethiopia, in May, 1963. (u)

A recording of the remarks of MALCOLM X at this meeting indicates that the aim of the OAAU is to eliminate differences between Negroes so they can work together for "human rights," while the initial objective is to "internationalize" the American civil rights movement by taking it to the United Nations. LITTLE condemned the non-violent civil rights movement and claims that Negroes should be taught to protect themselves, when and if necessary. Inasmuch as the NYCPD has identified "ALLAH" as CLARENCE 13X SMITH (NY closed NOI file 100-150520), the NYO will open an investigation into SMITH and consider him for inclusion on the security index. [REDACTED] advised that due to SMITH's actions, rantings and ravings, particularly in front of the judge at his hearing, he appears to have a "psychological problem" but the court has taken no action in this regard (u)

In view of the fact that the "Five Percenters" is a loose conglomeration of teenage street gangs in an area of Harlem without an overall organizational setup or meeting place, plus the fact that their mentor SMITH is incarcerated, the NYO feels they represent a local police problem and not a threat to the internal security. Consequently, the NYO will not at this time institute an investigation of the "Five Percenters" as an organization (u)

However, the NYO will continue to follow this incident under this caption to determine the extent of influence or infiltration by subversive type black nationalists groups into the "Five Percenters" (u)

In this regard the NYO will maintain liaison with BSS, NYCPD, to determine the identity of "GUMEAL" (age 21) and the exact status of JAMES HOWELL (age 37) with this group. Photographs of the six who were arrested have been obtained and are being shown to NOI, MMI, OAAU and racial informants. The names of the 48 youths known to be affiliated with the "Five Percenters" will be obtained from BSS and searched through NY indices.

In fact, none of them follow the tenets of the orthodox Islamic religion nor do they actually belong to or follow the teachings of the NOI. These youths do, however, claim to be the "five percent" of the followers of Elijah Muhammad who believe in smoking and drinking.(u)

[redacted] advised that their investigation has determined that the "Five Percenters" do not have any central meeting place or headquarters. Although each of the individual youth gangs formed from their respective neighborhoods has its own leader, they do not have an overall organizational setup other than to look up to Smith as their teacher and "Allah" (u) b7c

ORGANIZATION OF AFRO-AMERICAN UNITY, INCORPORATED (OAAU)

On June 28, 1964, MALCOLM X LITTLE, founder and leader of the Muslim Mosque, Incorporated (MMI), publicly announced the formation of a new, all Negro, militant civil rights action group to be known as the Organization of Afro-American Unity (OAAU), with himself as Chairman. This announcement was made at a public rally held by the MMI in the Audubon Ballroom, Broadway and 166th Street, New York City (u)

A printed and published statement of basic OAAU aims read by MALCOLM X at this meeting indicates that it shall include "all" people of African descent in the Western Hemisphere, as well as "our" brothers and sisters on the African continent. It is patterned after the "letter and spirit" of the Organization of African Unity established (by African heads of States) at Addis Ababa, Ethiopia, in May, 1963. (u)

A recording of the remarks of MALCOLM X at this meeting indicates that the aim of the OAAU is to eliminate differences between Negroes so they can work together for "human rights," while the initial objective is to "internationalize" the American civil rights movement by taking it to the United Nations. LITTLE condemned the non-violent civil rights movement and claims that Negroes should be taught to protect themselves, when and if necessary. The OAAU will sponsor a program for Negroes of education, politics, culture, economics, and social reform. (u)

On August 19, 1964, a confidential source advised that the headquarters of the OAAU are located in MMI headquarters, Suite 128, Hotel Theresa, 2090 7th Avenue, New York City (u)

MALCOLM X was assassinated on February 21, 1965, while addressing an OAAU rally at the Audubon Ballroom, New York City (u)

On April 13, 1965, a second confidential source advised that on March 26, 1965, the OAAU filed a Certificate of Incorporation with the Department of State, State of New York, Albany, New York, and henceforth the organization's true name will be Organization of Afro-American Unity, Incorporated (u)

gangs emanate from New York City Public School No. 120,
which is a junior high school serving the above area
and located near 120th Street at 1832 Madison Avenue.
They also hang out around New York City Public School No. 68,
located at 127 West 127th Street(u)

These youths are typical of the numerous
street-type gangs that exist in Harlem, except that they
have been influenced by an individual who refers to
himself as "Allah" and has indoctrinated them in the
distorted Muslim teachings of Nation of Islam (NOI)
leader, Elijah Muhammad(u)

A characterization of the NOI is

This "Allah" is the recognized leader of the
"Five Percenters." He has been identified as

In January, 1957, a source advised ELIJAH MUHAMMAD has described his organization on a nationwide basis as the "Nation of Islam," (NOI) and "Muhammad's Temples of Islam." (u)

On May 8, 1964, a second source advised ELIJAH MUHAMMAD is the national leader of the NOI; Muhammad's Temple of Islam No. 2, 5335 South Greenwood Avenue, Chicago, Illinois, is the national headquarters of the NOI; and in mid-1960, MUHAMMAD and other NOI officials, when referring to MUHAMMAD'S organization on a nationwide basis, commenced using either "Mosque" or "Temple" when mentioning one of "Muhammad's Temples of Islam." (u)

The NOI is an all-Negro organization which was originally organized in 1930 in Detroit, Michigan. MUHAMMAD claims to have been selected by Allah, the Supreme Being, to lead the so-called Negro race out of slavery in the wilderness of North America by establishing an independent black nation in the United States. Members following MUHAMMAD'S teachings and his interpretation of the "Koran" believe there is no such thing as a Negro; that the so-called Negroes are slaves of the white race, referred to as "white devils," in the United States; and that the white race, because of its exploitation of the so-called Negroes, must and will be destroyed in the approaching "War of Armageddon." (u)

In the past, officials and members of the NOI, including MUHAMMAD, have refused to register under the provisions of the Selective Service Acts and have declared that members owe no allegiance to the United States (u)

On May 5, 1958, the first source advised MUHAMMAD had, upon advice of legal counsel, tempered his personal statements and instructions to his ministers concerning the principles of his organization in order to avoid possible prosecution by the United States Government; however, he did not indicate any fundamental changes in the teachings of his organization (u)



The two enclosed articles deal primarily with a speech and subsequent impromptu press conference given by LIVINGSTON WINGATE on 10/14/65, before the eastern regional conference of the Urban League at the Belmont Plaza Hotel, New York City(u)

WINGATE is the Executive Director of the Harlem anti-poverty program known as Harlem Youth Opportunities Unlimited - Associated Community Teams (HARYOU-ACT). Both articles point out that WINGATE has been criticized for his handling of the program and that he is currently under investigation by the Manhattan District Attorney's Office and the Federal authorities following charges of fiscal mismanagement(u)

In his speech and press conference, according to these articles, WINGATE denied any fiscal wrongdoing and claimed the spending of certain monies on his part was necessary to avert racial violence in Harlem during the past summer. His main theme was that if anything happened to HARYOU-ACT there would definitely be racial violence. On this latter point, WINGATE referred to a mysterious "armed" group of Negro youth who are "prepared to die" in a struggle against white people. He refused to identify by name this group stating he feared for his life if he talked too much. He further implied that only HARYOU-ACT was stopping this group from acting(u)

Both articles indicated that WINGATE was apparently speaking of a Black Muslim-oriented extremist youth group known as the "Five Percenters." The "Tribune" article then set forth observations on this group which this paper developed in an "independent investigation" during the past three weeks(u)

It is noted that prior investigation by the NYO into the "Five Percenters" revealed that it was a Negro youth street gang in Harlem that has been influenced by CLARENCE SMITH JOWARS, aka (NY 100-150520), a former Nation of Islam (NOI) member who called himself "Allah". Under his influence and that of his associate, JAMES HOWELL [redacted] these youths became indoctrinated in the perverted NOI form of Muslim ideology with anti-white racial overtones. Many of these youths have adopted Muslim names although investigation revealed that they were not members of or affiliated with the NOI, Muslim Mosque, Inc. (MMI) or the Organization of Afro-American Unity, Inc. (OAAU). JOWARS and HOWELL were arrested on 5/31/65, and continue to be incarcerated awaiting trial which has been delayed due to extensive psychiatric examinations of JOWARS, which had been ordered by the court. Inasmuch as the gang was composed of teenagers without any real overall organizational setup or headquarters, the NYO conducted no extensive investigation of the group since they represented a local police problem. The NYO did institute investigation into JOWARS [redacted] (u)

In view of the publicity of the "Five Percenters" in the attached articles as a result of the WINGATE speech and, particularly, because of allegations outlined in the "Tribune" article, SA [redacted] conferred on 10/15/65, with [redacted] Bureau of Special Services, New York City Police Department (BSS, NYCPD) and [redacted] of BSS (u)

The results of this conference are not being set forth in an LHM on the specific request of [redacted] that none of the information be disseminated outside of the FBI. In view of the continuing extensive investigation by the NYCPD into the "Five Percenters" and the recent publicity thereon, because of the nature of the information, BSS could not be concealed by a "T" symbol without it being apparent that the concealed source was some branch of the NYCPD. (u)

[REDACTED] furnished the following information (u)

The NYCPD is continuing to conduct a full-time, extensive investigation of the "Five Percenters", which includes daily interrogation of gang members and nightly surveillances of them. The investigation is being handled by a special squad of the NYCPD Youth Division, known as the "Special Unit." The NYCPD feels that this extensive coverage has succeeded in deterring the activity of the gang and has opened the way for numerous arrests for assaults, muggings and marijuana smoking charges by gang members. (u)

The NYCPD investigation has determined that there are approximately 200 "Five Percenters" in NYC, ranging in age from 12 to 21. Approximately 125 of them are centered in Harlem, around the 120 series of streets, bounded by 7th and Lenox Avenues. The remaining 75 youths are scattered over Bronx, Brooklyn and Queens, with the most concentrated in the Fort Greene area of Brooklyn and the St. Marys Park area of the Bronx. The gang is responsible for numerous assaults and muggings, chiefly aimed at whites on the fringe area of Harlem. However, if the gang is unable to find a white victim they have no reservations about choosing a Negro victim. The gang has also caused a great deal of trouble in schools, chiefly Junior High School #120 at Madison Avenue and 120th Street in Harlem, where they disrupt classes, demand to be called by their Muslim name and have assaulted some teachers. (u)

N.Y. JAMES The leaders of the "Five Percenters" was JOWARS assisted by HOWELL, both of whom are incarcerated and JOWARS is undergoing psychiatric examination. JOWARS is known to gang members as "Allah", CLARENCE 13X or "Puddin". After JOWARS and HOWELL were jailed on 5/31/65, a third individual emerged as the leader of the gang. This was EUGENE WHITE aka "Hebeka", a Negro male, age 22, [REDACTED]

[REDACTED] However, WHITE was arrested for selling marijuana to one of the gang members on 8/29/65, and he is currently incarcerated awaiting sentencing after having

entered a guilty plea. There are no other leaders of the gang although they do instruct each other in Muslim-type ideology and the practice of judo and karate (u)

The gang has no meeting place other than the street, school yards and public parks (u)

The current meaning of "Five Percent" is that 85% of Negroes are cattle, 10% are Uncle Toms and the remaining 5%, which they are, are the real leaders of the Negro people. The Muslim indoctrination they receive in addition to the adoption of a Muslim name is the memorization of the questions and answers put out by the NOI which NOI members must learn before receiving their "X" name. This list of questions and answers appears to have originated with JOWARS, who was an NOI member under the name of CLARENCE 13X SMITH, and he undoubtedly obtained it when he joined the NOI (u)

The NYCPD investigation has developed no tie or relationship by the "Five Percenters" with the NOI, MMI, OAAU, Revolutionary Action Movement (RAM) or the individuals arrested in 1964 for attempting to blowup the Statue of Liberty nor has there been developed any link between the gang and Cuban or Chinese Communists (u)

The investigation has developed nothing to indicate that this gang is armed or has a cache of arms and weapons stored in Harlem. Undoubtedly some of the members have weapons or homemade-type zip guns but there is no evidence of wholesale arming of the gang. There is also nothing to indicate that the gang has training in garrotting or hand to hand killing methods (u)

With the exception of the above mentioned assaults and muggings of whites there is no definite policy or activity by the gang of violence against whites. However, the overall attitude of gang members is one of anti-white insofar as the racial situation is concerned. Also, the gang has never engaged in any pre-meditated attacks on police officers. The one incident involving an assault of a police officer occurred when an officer was attempting to make a disorderly conduct arrest on 7/29/65. (See referenced airtel and letterhead memorandum dated 7/31/65.) No information has been developed that money obtained from muggings and assaults by gang members is turned over to any specific leader or fund. (u)

Although a number of gang members have been arrested on numerous charges the incidents receiving the most publicity were the following (u)

The 5/31/65, arrest of JOWARS, HOWELL and four others. (See re NY airtels and letterhead memorandum dated 6/2/65 and 6/9/65.) (u)

The 6/18/65, arrest of eight gang members who were making Molotov cocktails. (See NY airtel and letterhead memorandum dated 6/22/65.) (u)

The 7/29/65, arrest of 17 gang members for disorderly conduct and resisting arrest. (See NY airtel and letterhead memorandum dated 7/31/65.) (u)

In reference to the killings mentioned in the "Tribune" article, [redacted] advised that CEDRIC AVERY, a Negro male, age 15, who was stabbed to death, was a "Five Percenter." AVERY had been bragging about the "Five Percenters" and EARL GREEN, a Negro male who was a recently discharged veteran, age 21, made a disparaging remark concerning the gang. AVERY attacked GREEN and in the fight AVERY was stabbed fatally. GREEN was absolved by a Grand Jury. The killing of IVAN TERACH, a white male, age 15, in the Bronx had no connection with the "Five Percenters." (u) b7c

[redacted] described the "Five Percenters" as a particularly vicious type of street gang that has found in this Muslim overtone a mysterious type of ideology that seems to unite and inspire them. Consequently, the NYCPD is following their activities very closely to control and identify them. (u) b7c

In view of the fact that the "Five Percenters" is a teenage Negro type of street gang, its leaders are currently incarcerated and the NYCPD is conducting an extensive investigation of the gang, the NYO feels that it represents a local police problem and no investigation of the gang, itself, is being conducted. The NYO will, however, institute an investigation of EUGENE WHITE, the third leader of the gang, to determine if he is affiliated with any organization inimical to the internal security. (u)

In regard to the remarks of WINGATE, it appears that he is attempting to utilize the "Five Percenters" and the threat of past and future potential racial violence to neutralize criticism and possible criminal proceedings against him for his administration of HARYOU-ACT. (u)

Inasmuch as investigation by the NYCPD has determined that all other identified individuals affiliated with the "Five Percenters", including the not further identified "Gumeal", have no influential or leadership type of position, but are strictly gang members, the NYO is not opening individual cases on them,

MEMORANDUM FOR THE DIRECTOR

On June 29, 1965, [redacted] BSS, NYCPD, and [redacted] 24th Precinct, NYCPD, both advised that investigation by the NYCPD into the various Harlem youth gangs who claim to be "Five Percenters", determined that Clarence 13X Smith was the recognized leader of the "Five Percenters" and James Howell was his assistant. All of the youths previously arrested or identified as being affiliated with the "Five Percenters" had no leadership position and were just members of the various Harlem youth gangs involved. This latter group includes "Gumeal", age 21, who was just the oldest of the many youth gang members. To date, "Gumeal" has not been further identified. At the time of his arrest, he gave an address of [redacted] New York City (u)

B. APPROX

On June 25, 1965, [redacted] New York City, advised Special Agents of [redacted] Bureau of Investigation (FBI) that a [redacted] reside in [redacted] and no young Negro male resides in that apartment. She viewed a photograph of [redacted] and advised he is unknown to her. (u)

On July 7, 1965, [redacted] BSS, NYCPD, advised that on July 6, 1965, the six individuals arrested on May 31, 1965, who called themselves "Five Percenters", appeared on misdemeanor charges in Part 2B of the Manhattan Criminal Court, New York City, and their case was adjourned until July 9, 1965. [redacted] advised that during the hearing, approximately 20 to 30 Negro teenagers, ranging from 13 to 19, milled around the courtroom and courthouse, but there were no demonstrations or incidents. The six who appeared in court were Clarence 13X Smith, James Howell, "Gumeal" (not further identified), [redacted] (u)

B. APPROX [redacted] advised that because of the number of young Negro supporters of these six that continually show up at the various court hearings, the District Attorney and the Court appear to be continually adjourning these hearings to a later

explanation among Negroes of the group's name is that its members believe 85 per cent of Negroes are "cattle," 10 per cent are "Uncle Toms" and 5 per cent are the leaders, members of the group. Another version is that 85 per cent of all Negroes are exploited, 10 per cent do the exploiting and the five Percenters will destroy the exploiters.

In those two versions, such Negro greats as Ralph Bunche and Jackie Robinson are included among the 10 per cent.

However, members of the group said recently that the 5 per cent are the "kindly, right-out people" who follow Allah, 18 per cent are the other followers of Islam and the 85 per cent are the rest of humanity.

ALLAN

A man who calls himself "Allah," the Moslem word for God, is the leader. He is more generally known as Clarence (Puddin') Smith and has been in jail since late May. His teenage followers are blamed for numerous muggings, some fire-bombings and several other acts of violence. They are believed to have been involved in at least one homicide.

Mr. Wingate's statement yesterday was one of the first public expressions of concern about the group and the first public statement that it has been made.

The Police Department has announced to the public that it is investigating the group.

It has been reported that the group has been trying to lead a civil rights and other organizations on the streets and have asked their organizations to discuss what they describe as a very dangerous group.

The Harlem weekly newspapers the New York Courier and the Amsterdam News yesterday published stories about the message from the five Percenters, reportedly at the request of police.

PUBLICITY

The five Percenters group steadily is widely known on the streets of Harlem, and apparently is equally feared. The Negro ghetto is full of rumors about it, with some Harlemites comparing it to the Ku Klux Klan and other comparing it to the Hitler Youth organization and the Nazis. They also are compared to the "Blood Brothers," publicized last year as a group of 400 youths trained to kill whites. Police maintained there were only 25 in the group.

One source has linked it to the Chinese and Cuban Communists and to the group convicted of attempting to dynamite the Statue of Liberty and other national monuments.

The only official agencies which have previously admitted knowledge of the group's existence are the Youth Board, which is charged with controlling and breaking up youth gangs in New York City, and the Board of Education, which believes Five Percenters were involved in two assaults, and one telephone threat of an assault, all involving teachers at Junior High School 120 in Harlem.

Harrison Lightfoot, deputy executive director in charge of community services for the Youth Board, said recently that the board's workers are not taking a direct interest in the Five Percenters, but are concentrating in keeping members of the supervised gangs from joining the group.

"It's something like a secret society," he said. "The Youth Division of the Police Department is working on it every day, and we don't wish to get in the Police Department's way."

School officials complain not only of rowdiness by the Five Percenters, but of their insistence that teachers tell them the names of their students who are in the group.


However, Daniel Schreiber, superintendent of District Four in Harlem, yesterday denied published reports that the Five Percenters had caused a wave of transfer requests by teachers in Harlem schools.

Sources in the Police Department said a special 21-man detail was assigned to investigate the Five Percenters last summer because of Police Commissioner Vincent Broderick's concern about them.

TRAINING

This detail also was assigned to St. Patrick's Cathedral during the recent visit of Pope Paul VI to New York City because of a rumor that the Five Percenters would make an attempt on his life at the Cathedral, the source said.

All sources agree that members, mostly youths from 15 years to 21 years of age, receive intensive training in Muslim theology, Black Nationalism, judo and karate. Some add that they are trained in garroting. Only Mr. Wingate so far has main-



FANATICISM

Police are concerned by the fanaticism of the youngsters who, the source said, believe that if Allah tells them to kill they must obey, and that policemen's bullets either will not penetrate or will not penetrate their bodies.

The Black Muslims disclaim any connection with the Five Percenters, the source said, but police do not believe them. Policemen point out that Malcolm X, who set up a rival organization to the Muslims, was killed, and another Muslim, who set up his own mosque in the Bronx early this year, was wounded by a gunshot.

Policemen believe that a man who calls himself "Allah" could not continue his organization in the Negro community without the tacit approval of the Black Muslims.

Harlem residents claim to see Five Percenters everywhere.

"I can tell them by the way they look at a store window," one man said recently. "They're not looking in it, like other people do; they're looking at it, like they want to break it."

The group's first publicity came when Smith was arrested May 11 after he led a crowd estimated at 150 persons across 126th St. to Harlem, allegedly carrying molotovs and police-bait. A Negro man was arrested for breaking windows and looting, and two policemen were assaulted in the process.

On the day of the following week, a group of about 100 persons gathered for an arrest in a Harlem street and looting. Smith also was charged with possession of molotovs. At his arraignment, he was held in lieu of \$2,500 bail, which his followers have been unable to furnish.

The group was next identified by police late in July when two policemen were injured going to the assistance of a Harlem woman who had been molested by a group of about 30 youths. When a policeman attempted to arrest a youth who struck him, there was a general melee in which the policemen were pelted with bottles, stones, bricks, garbage and trash cans. BAIL

On Sept. 18, Cedric Avery, 15, who had appeared in "Pony and Bear" at the City Center shortly before, was stabbed to death on a playground at 212 W. 129th St., in the St. Nicholas Houses, where he lived. Police who charged Earl Green, 21, of 275 W. 127th St., in the slaying said Green told them he had stabbed young Avery after he was attacked by the youth and a gang of other boys.

The slain boy's chest was covered with Muslim medals. Two youths who said they were Five Percenters later told the Herald Tribune reporter that young Avery was a member of their group.

A former employee of the group, Earl, said insurance was received there in the slaying. He said that the Five Percenters had contacted the insurance com-

pany of Ivan Terach, a 17-year-old white boy, in Bronx on June 27.

However, Assistant District Attorney Irvin Goldstein, in charge of the murder case, said he had never heard the group's name. The youths who knifed young Terach outside a candy store at 515 Charles Parkway said they were members of the "Barbarian Knights."

The two 17-year-olds who described themselves to the Herald Tribune as Five Percenters declared that Allah (Clarence Smith) is God.

"Even if he is in jail, he is still God," said one of them. "The Christians say that Christ was God, but when he was dying on the cross, he said, 'Father, forgive them, for they know not what they do.' This means that he was not God; his Father was Christ was a prophet and the son of God. Only Allah is God."

The boys denied that they were taught karate or judo in their Five Percenter classes.

Sarge (Sargent Shriver, head of the Federal antipoverty program) called it an amazing job."

Mr. Wingate indicated that Haryou-Act had appeased the movement last summer by giving the members "blind-alley jobs." These jobs were of little value to the youths, he said, because they offered no chance of upgrading their skills.

At one point, Mr. Wingate declared: "Kill Wingate if you will, but destroy Haryou-Act and you don't even have a pretense of stopping violence."

In his conference talk Mr. Wingate indicated disillusionment with the Johnson Administration. The antipoverty act is the Magna Carta of the poor, he said, but it is now in danger of becoming a "fraud."

"The Democratic Administration has pulled back on this situation," he said. "They have begun to recognize that community action is a little dangerous. They are trying to dilute the programs to nothing."

Yet, Haryou-Act has so far been able to "resist the clutches" of both the city government and of Representative Adam Clayton Powell, Harlem Democrat, Mr. Wingate said.

"The city is afraid to touch Haryou-Act because of Congressman Powell, Mr. Wingate explained, and "because of our integrity, Adam doesn't mess with us."

5 Percenters Called Hoodlums; Actions Blamed on Frustration

By THEODORE JONES

Concerned Harlem residents described the "Five Percenters" yesterday as a small hoodlum gang that championed a "hate philosophy" against both whites and Negroes.

They said the group, which was involved in several muggings and beatings last spring, was composed of misguided teen-agers who had "turned their frustrations in the black ghetto into antisociety actions."

"They're a pure growth of the slums," exclaimed a city youth worker who has dealt with members of the gang, "and they're being influenced by older and known subversive men who are only too happy to turn the community into chaos and turmoil."

This influence, according to social workers in the area, has helped to create a group of totally undisciplined youngsters, who have no respect for parents or anyone else not taken with their way of thinking.

The Five Percenters were said to have been an outgrowth of an older, militant, antiwhite group described as the Blood Brothers, which was linked by the police in the summer of 1963 to several murders of whites in Harlem.

Gained Attention in May

The younger group, which has been under constant police surveillance, gained public attention last May, when several youths led by a man who described himself as Clarence 13X Smith, a former Black Muslim, attacked a Negro man on a Harlem street.

When Smith was arrested and charged with the assault, the youths marched on a Harlem police station and demanded his release. The next day they appeared again at Smith's hearing in Manhattan Criminal Court and shouted "white man's injustice" and other black nationalist slogans until they were ejected from the courtroom.

Smith was charged with felonious assault, resisting arrest, unlawful assembly and possession of marijuana. He was held in \$9,500 bail and is still in

The next public incident occurred in July with a group of 10 youths who allegedly hurled garbage can covers, rocks and bottles at two white policemen who had stopped them from molesting a Negro woman.

The youths, who ranged in age from 16 to 18, were charged with riot, unlawful assembly, resisting arrest and disorderly conduct. Seven other youths, also involved in the incident, were booked as juvenile delinquents.

Black Muslims Practices

Both the police and Harlem community leaders describe the Five Percenters as a loosely knit group of youths ranging in age from 13 to 21. The group is said to follow many of the practices of the Black Muslims, although it is not affiliated with that sect.

Estimates of the strength of the group run between 60 and 100 members. Youths who identify with the group are said to operate in the Bedford-Stuyvesant area of Brooklyn as well as in Harlem.

The Five Percenters derive their name from a philosophical belief that 85 per cent of the country's Negro population is ignorant or "just cattle" and that 10 per cent are "Uncle Toms," or subservient to whites. The remaining 5 per cent, of which they are the self-chosen, eventually will lead the others out of "bondage."

"Many of these kids don't know what's going on," explained one community leader who has worked closely with the group in an attempt to change their direction. "But they identify with the powerlessness of the Negro in the ghetto, and if you're not saying how to end that, then you're not talking their language."

During the summer of 1965, the police and community leaders met frequently with the youths to get their views and to see where they could be helped. Many were taken into the HARKOFF-ACT summer program and given employment. Others refused jobs with the Harlem agency, declaring that they did not want "handouts."

The termination of the summer

mer ~~increased~~ increased the re-

Very few persons in Harlem
believed that the Five Percent-
ers could themselves precipitate

"These kids don't go around
armed, and anyone who says
that doesn't know what he's
talking about," one youth
worker said. "The cops have
been picking these kids up left
and right and not once have
they been charged with a viola-
tion of the Sullivan Law. They

they have a penknife on them.

"Our greatest fear now is
that, with all this publicity,
many of the youth who identify
with some of the beliefs of the
group but are not yet members
might be enticed now to join.
When you get a place like Har-
lem and the deprivations that
exist, then you're going to get
youth gangs like this until
something is done to solve the
basic problems."

Wingate Warns of Negro Revolt If Haryou's Program Is Curbed

By HOMER BIGART

Somber warnings of a Negro uprising in Harlem and other black ghettos if anything happens to Haryou-Act were voiced yesterday by Livingston L. Wingate, executive director of the controversial Harlem anti-poverty program.

The agency has been criticized for loose management and financial procedures, and about \$1 million in future grants of Federal funds is being held up by the Office of Economic Opportunity pending a special audit.

Mr. Wingate made an impassioned denial of any misuse of public funds by Haryou-Act. He said his staff had committed "not one act of malfeasance." But he conceded the books were not in order.

His warnings of violence startled an Urban League regional conference on poverty in

the Belmont Plaza Hotel. Later Mr. Wingate expanded on his revelation of a mysterious Harlem "movement" at an impromptu press conference.

He said the movement was composed of desperate youths who were "prepared to die" if the Haryou-Act project were halted.

He indicated that members of the movement were employed by Haryou-Act.

"Haryou-Act bought time with this movement," Mr. Wingate said, implying that his agency had forestalled rioting in Harlem last summer.

The police are sharply aware of the movement and want to crush it, Mr. Wingate said. But he said he had begged the police to withhold action until he had talked to the leaders of the movement and tried to appease

them. Mr. Wingate said he was too frightened for his own life to divulge any details of the "movement."

"If I tell you too much about this organization, I'll be 'the late Wingate,'" he said.

So he refused even to give the name of the sinister organization. However, it was apparent he was talking about a few young Harlem hate group called the "Five Percenters." The Police Department confirmed that this group was under investigation.

Members of the group told the police they had adopted the name "5 per center" because "85 per cent of the Negroes are like cattle, 10 per cent are Uncle Toms, and we are the 5 per cent who know what belongs to us."

The Police Department refused comment when asked if Mr. Wingate was serving as intermediary between the police and the "Five Percenters."

'Growing Rapidly'

Mr. Wingate said the movement was "growing rapidly" and that "the lid may blow off any day."

"Perhaps I'll be called an alarmist," he said, "so if you want confirmation, you can call some key police officials." He mentioned, among others, Deputy Chief Inspector Harry Taylor, who he said had met with representatives of the movement.

Inspector Taylor denied last night that Harlem was on the verge of racial violence. "We are not," he said, "in a dangerous situation."

But Mr. Wingate told about 55 leaders of poverty programs

at the National Urban League conference that Harlem was in imminent peril of bloodshed; that in that event the disorders could spread to the Bedford-Stuyvesant section of Brooklyn and to Rochester and other upstate cities.

"I come to you with a deep touch of fright in me," Mr. Wingate told the conference. He said he had been meeting with high-level police about an "ominous movement" of youths prepared to die.

55 Deaths Recalled

"There will either be a change in the situation," he said, "or you'll see something that'll make Watts look like a tea party." He was referring to the Negro riots in the Watts ghetto of Los Angeles, where at least 53 were killed last August.

Members of the movement know the police are about to

"crack down," Mr. Wingate said but they remain defiant. "The boys say: 'Let 'em crack down, we won't move.'"

Mr. Wingate warned that the public continued to "listen to the asinine lying and distorted press" about Harlem. "It would have to rely on 'guns' to contain Harlem."

"I can see bloodshed in Harlem and then in Bedford-Stuyvesant and then Rochester and other cities will move."

Later at the conference in another room, Mr. Wingate said that he had met with members of the group in the summer and that the "deeply disturbed" "Whitey" (the name of the group's leader) was "a very dangerous" person. "The boys are..."

rupted by boys who stood at unexpected moments and shouted at teachers:

"You blue-eyed white devil! You'll burn!"

If the teacher was Negro, the boys shouted, "You slave! You'll die!"

The disorder spread throughout the school, according to the report, with gangs of the boys roaming halls, insulting and threatening teachers and assistants who were patrolling the halls and beating non-Five Percenters outside the school. They added to the general disorder in classes by refusing to answer to their names and demanding to be addressed by Muslim names.

Both teachers and students were terrified by the threats and disorder and their terror was heightened by two incidents of violence. Within the first two weeks of school, a male teacher was beaten by a student and a female teacher was struck by an intruder identified in the report as a Five Percenter.

Both the assailants are known to have been arrested. Mr. [redacted] acknowledged that

he admitted a report, but refused to release it.

Teachers at the school say that the youths called non-members "pork-eaters" and demanded to know during classes if their teachers ate pork. Teachers were told by the Board of Education to make notes of the outbursts, but some of them, especially Negro teachers living in Harlem, were afraid of reprisals outside the school.

The Five Percenters are followers of a man named Clarence (Puddin') Smith, who calls himself "Allah." They are said to believe he is God. He has been in jail since he was arrested in a disturbance in early June, but the members insist that he still is God and that, as his followers, they cannot be killed.

The report said that when a 15-year-old student and member of the Five Percenters was killed as he and other members fought with an adult on a playground in St. Nicholas Homes, his friends shouted: "Get up! You're not dead. We can't die."

The boy was dead, however, and his friends gave his Muslim name to a recruit in

order to continue his life, the report stated.

Board of Education sources indicated the report was being withheld because of some of the statements of opinion in it.

The reference may have been to an impassioned paragraph which termed the Five Percenter philosophy "diabolical," said it was aimed at the destruction of every "desirable institution" of Harlem, and accused the group of combining brainwashing and terror.

The report said that after the youth was killed other Five Percenters threatened violence to non-members. Several "pork-eaters" brought weapons from their homes to defend themselves on the way to school. They checked their weapons with the principal when they arrived.

The report added that the Five Percenters undoubtedly have adult leaders and that there is evidence the group receives funds and advice "from outside the United States."

The report said that the incidents came to an end after the first two weeks of school and that 14 arrests had been made.

Teachers at the school agreed that the disorder had ceased, but said the violence which caused the disorder was apparent in the behavior of center students.

They believe the end of the disorders was brought about by five-day suspensions issued to students who insisted on being "called" by Muslim names, the arrests and the stationing of a policeman at the school to patrol the halls.

A board spokesman said there have been 12 to 15 arrests at the school this year, not all of them Five Percenters, ten five-day suspensions and two full suspensions.

Some teachers believe there may be further disorders pending. "We may be in the eye of the storm," one of them said.

Some police sources say they believe the group has become quiet in recent weeks because most of its leaders have been arrested or in charge of another part. They say the group still exists and believe that new leaders are moving in.

Reairtel sets out that [redacted] of the Bureau of Special Services (BSS), NYCPD requested that some of the information furnished by the NYCPD during this conference should be disseminated outside the Bureau in view of the continuing extensive investigation by the NYCPD regarding the "Five Percenters" and the recent publicity given to this matter. It was pointed out that due to the nature of this information, the NYCPD could not be properly concealed as the source (u) b7c

The information furnished by the NYCPD officials during the 10/15/65 conference is in line with information previously furnished to your office which in turn was submitted to the Bureau and has been disseminated to interested agencies. For your information, the information in letterhead memoranda accompanying New York airtels dated 6/2/65, 7/9/65 and 8/24/65 captioned "Disturbance by Group Called 'Five Percenters,' Harlem, New York City, Racial Matters" was disseminated to the military services, the Department and Secret Service. It is the Bureau's opinion that the information made available to your office during the October 15, 1965, conference with the NYCPD should also be disseminated to the above-mentioned agencies (u)

Also, much of the information furnished during this conference with the NYCPD has been set forth in articles appearing in New York City newspapers. One article which appeared in the "New York Herald Tribune" on 10/15/65, page 1, sets out that ranking police officers in Harlem have been briefing leaders of civil rights and civic organizations regarding the "Five Percenters" and have asked their cooperation in fighting what they described as a very dangerous group. This article also sets out that two Harlem weekly newspapers, the "New York Courier" and the "Amsterdam News" on 10/14/65 published stories regarding the menace posed by the "Five Percenters," reportedly at the request of the police. (u)

The "New York Herald Tribune" article continued with a comment to the effect that one source linked the "Five Percenters" to the Chinese and Cuban Communists and to the group recently convicted of attempting to dynamite the Statue of Liberty and other national monuments. (u)

As you are aware, the proper utilization of information received by the Bureau is foremost among our responsibilities as an investigative agency. Whenever information comes to the attention of the Bureau which appears to be of interest to another agency, that information should be forwarded to interested agencies unless there are good and compelling reasons for not doing so. You should recontact [redacted] and advise him of the Bureau's responsibility with regard to the dissemination of pertinent information to other government agencies and that the Bureau desires that the information furnished by him on 10/15/65 be disseminated to the military services, the Department, and Secret Service. You may advise him that this information will be appropriately classified and that the NYCPD will be concealed as the source. You may also point out to [redacted] that information similar to that furnished on 10/15/65 has already appeared in the New York newspaper articles mentioned above. (u) b7c

The Bureau agrees that the activities of the "Five Percenters" represent a local police problem; however, in view of the allegations that the "Five Percenters" may be linked with certain subversive and racist elements, as indicated in newspaper articles, your continuing investigation of these subversive and racist elements should specifically determine whether or not the "Five Percenters" are actually linked to these elements. (u)

Submit information furnished by NYCPD on 10/15/65 in form suitable for dissemination or fully justify not doing so. Also, submit future pertinent information developed in this matter in form suitable for dissemination. Handle promptly and keep the Bureau advised. (u)

NOTE:

Based on information from NYCPD, the "Five Percenters" is a gang of approximately 200 Negro youngsters who are scattered throughout the greater New York City area. They involve themselves in assaults, ^{and} muggings aimed chiefly at white people. Some of the leaders of this gang are currently incarcerated. The leaders have given instructions to each other in Muslim-type ideology. (u)

ReNYairtel 10/18/65 sets out information regarding the "Five Percenters" as obtained from [redacted] Bureau of Special Services, New York City Police Department, on 10/15/65. This information depicts, generally, the nature, scope and activities of the "Five Percenters" and sets out that [redacted] desires this information not be disseminated outside the Bureau since NYCPD could not be concealed as the source. This instructs New York to recontact [redacted] and advise him of the Bureau's responsibilities in this regard and to submit this information and future information developed in form suitable for dissemination or fully justify not doing so. 

[REDACTED] advised that at the time of the news stories on the "Five Percenters" his Department had ordered that absolutely no public disclosure be made of their extensive continuing investigation of the "Five Percenters" and the results thereof so as not to jeopardize this investigation. He advised that the nature of the investigation necessitated continuing contacts with various social type agencies which have led to numerous incidents of newspaper speculation and inquiries which the NYCPD has been answering with a "no comment". His Department, he continued, does not want anything in print that could directly quote them on stating that this investigation is being conducted. (u)

b7c
[REDACTED] advised, however, that they would have no objection if the FBI disseminate this information to pertinent government agencies so long as his Bureau is not identified as the source. (u)

Therefore, the enclosed LHM is being submitted concealing the source of the information and somewhat paraphrasing it so it will not be completely obvious that it originated from the NYCPD. (u)

The NYO will maintain contact with BSS, NYCPD, and will also canvass NY sources in Black Nationalist, Cuban and Chinese Communist activity to determine if these subversive and racist elements are linked in any way to the "Five Percenters". (u)

The October 15, 1965 edition of "The New York Times" and the "New York Herald Tribune", daily New York City newspaper, both contained articles on page one dealing with a speech and impromptu press conference given by Livingston Wingate on October 14, 1965, before the eastern regional conference of the Urban League at the Belmont Plaza Hotel, New York City. The two articles were respectively captioned "Wingate Warns of Negro Revolt If Haryou's Program Is Curbed" and "Harlem '5 Percenters' - Terror Group Revealed". Wingate is the Executive Director of the Harlem anti-poverty program known as Harlem Youth Opportunities Unlimited-Associated Community Teams (HARYOU-ACT). Both articles point out that Wingate has been criticized for his handling of the program and that he is currently under investigation by the Manhattan District Attorney's Office and the Federal authorities following charges of fiscal mismanagement (u)

According to these articles Wingate, in his speech and press conference, denied any fiscal wrongdoing and claimed that the spending of certain monies on his part was necessary to avert racial violence in Harlem during the past summer. Wingate's main theme was that if anything happened to HARYOU-ACT there would definitely be racial violence. On this latter point, he referred to a mysterious "armed" group of Negro youth who are "prepared to die" in a struggle against white people. Wingate refused to identify this group by name stating he feared for his life if he talked too much. He further implied that only HARYOU-ACT was stopping this group from acting (u)

Both of these articles further indicated that Wingate was apparently speaking of a Black Muslim-oriented extremist youth group known as the "Five Percenters" (u)

On October 15, 1965, a confidential source who has furnished reliable information in the past, advised that the "Five Percenters" is a particularly vicious type of a street gang in New York City composed of Negro youths who have found in their Muslim form of indoctrination a mysterious ideology that seems to unite and inspire them. The gang is composed of approximately 200 youths in New York City ranging in age from 12 to 21. Approximately 125 of them are centered in the Harlem section of New York City around the 120 series of streets bounded by Seventh and Lenox Avenues. The remainder are scattered throughout the Bronx, Brooklyn and Queens with concentrations in the Fort Greene area of Brooklyn and the Saint Mary's Park section of the Bronx. (u)

B. APPROX. 11/21

This same source advised that the original leader of the "Five Percenters" was one Clarence Smith Jowers, also known as (aka) Clarence Smith, "Puddin", who was a former member of the Nation of Islam (NOI). Jowers is a 36 year old Negro male who was known to the "Five Percenters" as "Allah" and along with his associate James Howell, a 37 year old Negro male, indoctrinated these youths in the perverted NOI form of Muslim ideology with anti-white overtones. Jowers and Howell were arrested for felonious assault with four youthful "Five Percenters" in New York City on May 31, 1965, and both are still incarcerated awaiting trial which has been postponed due to a court ordered psychiatric examination of Jowers. Following the jailing of Jowers and Howell one Eugene White, aka "Hebeka", a Negro male age 22, assumed a leadership position with the "Five Percenters". However, on August 29, 1965, White was arrested for selling marijuana to one of the gang members and is currently awaiting sentencing after having entered a guilty plea (u)

A characterization of the NOI is attached hereto and all sources therein have furnished reliable information in the past (u)

On November 1, 1965, this same source advised that on October 19, 1965, White was sentenced to two years in prison by the Bronx County Supreme Court, New York, on the above mentioned charge. (u)

On October 15, 1965, this source advised that the meaning of "Five Percent" is that 85% of the Negroes are cattle who just follow along, 10% are Uncle Toms while the remaining 5%, which they represent, are the real leaders of the Negro people. The Muslim type of indoctrination which they receive, in addition to the adoption of a Muslim name, is the memorization of the questions and answers put out by the NOI and which their new members must learn. This list of questions and answers appears to have originated with Jowars, who was an NOI member under the name of Clarence 13X Smith and undoubtedly obtained it when he joined the NOI (u)

This source further advised that the "Five Percenters" have been responsible for numerous assaults and muggings, chiefly aimed at whites on the fringe area of Harlem. However, if a White victim cannot be located they have no reservation about choosing a Negro victim. They have also caused a great deal of trouble in schools, chiefly Junior High School number 120 at Madison Avenue and 120th Street in Harlem, where they disrupt classes, demand to be called by their Muslim names and have assaulted some teachers. Since the jailing of Jowars, Howell and White they have no overall leadership although they instruct each other in Muslim-type ideology and the practice of judo and karate. They have no meeting place other than the street, school yards and public parks. Although some members of the "Five Percenters" may have access to weapons, there is nothing

to indicate that this gang is armed or has a cache of arms and weapons stored in Harlem. Also, there is nothing to indicate that they train in garrotting or hand to hand killing methods (u)

Although the general attitude of the "Five Percenters" is one of anti-white, there is no definite policy or program of violence against whites other than the above mentioned assaults and muggings. The gang has never engaged in any pre-meditated attack on a police officer and the one incident involving an assault of a police officer in which they were involved grew out of a disorderly conduct arrest (u)

This source further advised that the "Five Percenters" are not known to have any direct ties with the NOI, Muslim Mosque, Incorporated (MMI), Organization of Afro-American Unity, Incorporated (OAAU), Revolutionary Action Movement (RAM), the individual arrested in 1965 for attempting to blow up the Statue of Liberty, or with the Castroite Cubans or Chinese Communists. (u)

Characterizations of the MMI, OAAU, and RAM are attached hereto and all sources therein have furnished reliable information in the past (u)

This source also stated the "Five Percenters" are being closely watched by the Youth Division of the New York City Police Department and their extensive coverage has succeeded in deterring the activities of the gang and has led to numerous arrests of gang members for assaults, mugging and marijuana smoking (u)

MUSLIM MOSQUE, INCORPORATED (MMI)

The March 13, 1964 edition of "The New York Times," a daily newspaper published in New York, New York, contained an article on page 20 which indicated that MALCOLM X (LITTLE), former national official of the Nation of Islam (NOI) who broke with the NOI on March 8, 1964, publicly announced in New York City on March 12, 1964, that he had formed the Muslim Mosque, Incorporated (MMI). The MMI, according to the article, would be a broadly based politically oriented black nationalist movement for Negroes only, financed by voluntary contributions. In this public statement, MALCOLM X urged Negroes to abandon the doctrine of non-violence when it is necessary to defend themselves in the civil rights struggle, and he also suggested that Negroes form rifle clubs to protect their lives and property in time of emergencies in areas where the government is unable or unwilling to protect them. (u)

Incorporation papers of the MMI filed on March 16, 1964, with the Business Section, Clerk of Courts, New York County, New York, New York, reflect that the MMI was incorporated under the Religious Corporation Law of the State of New York to work for the imparting of the Islamic Faith and Islamic Religion in accordance with "accepted Islamic principals." The principal place of worship to be located in the Borough of Manhattan, New York, New York. (u)

The May 23, 1964 edition of the "New York Amsterdam News," a weekly Negro newspaper published in New York City, contained an article by columnist JAMES BOOKER in which he indicated that he had heard that the visit by MALCOLM X with Muslim leaders during his African tour has changed him to become more religious. (u)

On October 6, 1964, a confidential source advised that the MMI is apparently affiliated with the true orthodox Islamic Religion through its affiliation with the Islamic Foundation (of New York), 1 Riverside Drive, New York City. The only teachings of the MMI are on the Islamic Religion. (u)

MUSLIM MOSQUE, INCORPORATED (MMI)

This confidential source advised on May 17, 1965, that the headquarters of the MMI are located in Suite 128, Hotel Theresa, 2090 Seventh Avenue, New York, New York, where they were established on March 16, 1964. These headquarters are shared with the Organization of Afro-American Unity (OAAU) which was also headed by MALCOLM X(u)

MALCOLM X was assassinated on February 21, 1965 while addressing an OAAU rally at the Audubon Ballroom, Broadway and 166th Street, New York City(u)

NATION OF ISLAM

In January, 1957, a source advised ELIJAH MUHAMMAD has described his organization on a nationwide basis as the "Nation of Islam" and "Muhammad's Temples of Islam." (u)

On May 7, 1965, a second source advised ELIJAH MUHAMMAD is the national leader of the Nation of Islam (NOI); Muhammad's Temple of Islam Number 2, 5335 South Greenwood Avenue, Chicago, Illinois, is the national headquarters of the NOI; and in mid-1960 Muhammad and other NOI officials, when referring to Muhammad's organization on a nationwide basis, commenced using either "Mosque" or "Temple" when mentioning one of "Muhammad's Temples of Islam." (u)

The NOI is an all-Negro organization which was originally organized in 1930 in Detroit, Michigan. MUHAMMAD claims to have been selected by Allah, the Supreme Being, to lead the so-called Negro race out of slavery in the wilderness of North America by establishing an independent black nation in the United States. Members following MUHAMMAD's teachings and his interpretation of the "Koran" believe there is no such thing as a Negro; the so-called Negroes are slaves of the white race, referred to as "white devils," in the United States; and the white race, because of its exploitation of the so-called Negroes, must and will be destroyed in the approaching "War of Armageddon." (u)

In the past, officials and members of the NOI, including MUHAMMAD, have refused to register under the provisions of the Selective Service Acts and have declared that members owe no allegiance to the United States. (u)

On May 5, 1958, the first source advised MUHAMMAD had, upon advice of legal counsel, tempered his personal statements and instructions to his ministers concerning the principles of his organization in order to avoid possible prosecution by the United States Government; however, he did not indicate any fundamental changes in the teachings of his organization. (u)

On May 3, 1965, a third source advised MUHAMMAD had, early in July, 1958, decided to de-emphasize the religious aspects of the teachings of Islam and to stress the economic benefits to be derived by those Negroes who joined the NOI. (u)

ORGANIZATION OF AFRO-AMERICAN
UNITY, INCORPORATED (OAAU)

On June 28, 1964, MALCOLM X LITTLE, founder and leader of the Muslim Mosque, Incorporated (MMI), publicly announced the formation of a new, all Negro, militant civil rights action group to be known as the Organization of Afro-American Unity (OAAU), with himself as Chairman. This announcement was made at a public rally held by the MMI in the Audubon Ballroom, Broadway and 166th Street, New York City. (u)

A printed and published statement of basic OAAU aims read by MALCOLM X at this meeting indicates that it shall include "all" people of African descent in the Western Hemisphere, as well as "our" brothers and sisters on the African continent. It is patterned after the "letter and spirit" of the Organization of African Unity established (by African heads of States) at Addis Ababa, Ethiopia, in May, 1963. (u)

A recording of the remarks of MALCOLM X at this meeting indicates that the aim of the OAAU is to eliminate differences between Negroes so they can work together for "human rights," while the initial objective is to "internationalize" the American civil rights movement by taking it to the United Nations. LITTLE condemned the non-violent civil rights movement and claims that Negroes should be taught to protect themselves, when and if necessary. The OAAU will sponsor a program for Negroes of education, politics, culture, economics, and social reform. (u)

On May 17, 1965, a confidential source advised that the headquarters of the OAAU are located in MMI headquarters, Suite 128, Hotel Theresa, 2090 7th Avenue, New York City. (u)

MALCOLM X was assassinated on February 21, 1965, while addressing an OAAU rally at the Audubon Ballroom, New York City. (u)

ORGANIZATION OF AFRO-AMERICAN
UNITY, INCORPORATED (OAAU)

On April 13, 1965, a second confidential source advised that on March 26, 1965, the OAAU filed a Certificate of Incorporation with the Department of State, State of New York, Albany, New York, and henceforth the organization's true name will be Organization of Afro-American Unity, Incorporated. (u)

REVOLUTIONARY ACTION MOVEMENT

On November 3, 1964, a source made available a document entitled "The Revolutionary Action Movement Manifesto," the document having been obtained by the source from an individual known to be a member of the Revolutionary Action Movement (RAM). (u)

This document stated, in part, that RAM was officially organized in the Winter of 1963 by Afro-Americans who support the revolutionary objectives of ROBERT F. WILLIAMS, now residing in Cuba, and his concept of organized violence to achieve the liberation of the Afro-American people in the United States. This Manifesto disclosed that RAM had oriented its program to one of education and political revolution and the organization of a "black" political party with revolutionary objectives, having recognized the need for a "black revolution" that could and would seize power. RAM philosophy is described in this document as one of revolutionary nationalism, that is, one involving the struggles of the nonwhite races of the world against exploitation and enslavement by the white capitalist and imperialist nations. (u)

Regarding WILLIAMS, it should be noted that on August 28, 1961, a Federal warrant was issued at Charlotte, North Carolina, charging him with Unlawful Flight to Avoid Prosecution for the crime of kidnapping. Subsequent to the issuance of this warrant, WILLIAMS fled the United States to Cuba, where he now publishes a monthly newsletter entitled "The Crusader" from Havana. (u)

This source in September, 1964, advised RAM is dedicated to the overthrow of the capitalist system in the United States, by violence if necessary, and to its replacement by a socialistic system oriented toward the Chinese communist interpretation of Marxism-Leninism. Within recent months, according to the second source, dissension within RAM has become evident and some dissatisfaction with FREEMAN's leadership has arisen. So far as is known, however, he remains the titular leader of RAM. (u)

To date, according to the second source in May, 1965, RAM has organized units and membership in several of the larger cities in the United States east of the Mississippi River and the organization is currently active in attempting to recruit new members and expand its sphere of influence (u)



On November 13, 1965, [redacted] New York City, who is [redacted] 42nd Division, First Area Command New York Guard, made available information which he stated he and his commanding officer, [redacted] had received from two fellow officers in the New York Guard. (u)

The information, referred to above, consists of rumors that on January 15, 1966, the Harlem area of New York City will experience an unknown event which will make "Watts appear to be a minor accident". (Watts refers to that area of Los Angeles, California, wherein a racial riot occurred during the Summer of 1965). Allegedly there is increased apprehension in Harlem over the existence of a group of Negroes known as the "Five Percenters", a Harlem street gang which advocates violence against the whites. (u)

The "Five Percenters" allegedly are making efforts to infiltrate and subvert the Youth Cadet Corps which group has been sponsored by the United Block Associations (UBA) of Harlem (u)

[redacted] identified the source of the above allegations as [redacted] b7c

[redacted] respectively, of the 12th Battalion of the New York Guard, an all-Negro unit located in Harlem. (u)

(u)

Neither [redacted] could furnish any additional information. (u)

On November 22, 1965, [redacted] Bureau of Special Services (BSS), New York City Police Department (NYCPD), advised that the NYCPD had been unable to determine any significance to the date, January 15, 1966, or to develop any information that the "Five Percenters" had plans to cause trouble on this date or any future date. [redacted] further advised that he had been in contact with [redacted] in the New York City Housing Authority, [redacted] of the UBA Cadet Corps in the Bronx, New York. On November 15, 1965, a confidential source furnished information indicating that a number of Negro youths in the Harlem area of New York City, who claim to be Five Percenters, are affiliating and hanging around with Negro playwright, Leroi Jones and his Black Arts Repetory Theater, a black nationalist anti-white type theater group in Harlem operated by Jones (u)

The August 5, 1964 edition of the "Buffalo Courier Express", a daily Buffalo, New York newspaper, contained an article on page four of the appearance by Leroi Jones at a public meeting held in the headquarters of the Workers World Party (WWP), 831 Main Street, Buffalo, New York on August 4, 1964. According to this article Jones urged Negroes to disassociate themselves from "the American way of life", to quit their jobs, to stop voting and to steal food to live. He asserted that the "the American way of life" had done nothing for the Negro and he predicted that racial strife in the nation would grow increasingly worse. He was further quoted in the article as stating: "I am in trouble because I'd tell any son of mine not to fight in any of these silly wars going on and I'd tell my children to despise everything this country stands for. (u)"

Characterizations of the FPCC and the WWP are attached hereto (u)

During November and December, 1965, numerous sources familiar with activities in the New York City area of the NOI, MMI, OAAU, RAM, black nationalist and racial matters advised that they knew nothing concerning any planned or rumored violence or disturbance by the Five Percenter or other racist group scheduled to take place on January 15, 1966 (u)

On December 28, 1965, [REDACTED] Bureau of Special Services, New York City Police Department (NYCPD) advised that the NYCPD has been unable to determine any significance to the date, January 15, 1966, or to develop any information that the Five Percenter had plans to cause trouble on this or any other specific date (u)

All sources herein have furnished reliable information in the past. (u)

FAIR PLAY FOR CUBA COMMITTEE

The April 6, 1960, edition of "The New York Times" newspaper contained a full-page advertisement captioned "What Is Really Happening In Cuba," placed by the Fair Play for Cuba Committee (FPCC). This advertisement announced the formation of the FPCC in New York City and declared the FPCC intended to promulgate "the truth about revolutionary Cuba" to neutralize the distorted American press (u)

"The New York Times" edition of January 11, 1961, reported that at a hearing conducted before the United States Senate Internal Security Subcommittee on January 10, 1961, Dr. CHARLES A. SANTOS-BUCH identified himself and ROBERT TABER as organizers of the FPCC. He also testified he and TABER obtained funds from the Cuban Government which were applied toward the cost of the aforementioned advertisement. (u)

On May 16, 1963, a source advised that during the first two years of the FPCC's existence there was a struggle between Communist Party (CP) and Socialist Workers Party (SWP) elements to exert their power within the FPCC and thereby influence FPCC policy. This source added that during the past year there had been a successful effort by FPCC leadership to minimize the role of these and other organizations in the FPCC so that their influence as of May, 1963, was negligible (u)

The SWP has been designated pursuant to Executive Order 10450 (u)

On May 20, 1963, a second source advised that VINCENT "TED" LEE, FPCC National Office Director, was then formulating FPCC policy and had indicated that he had no intention of permitting FPCC policy to be determined by any other organization. This source stated that LEE believed that the FPCC should advocate resumption of diplomatic relations between Cuba and the United States and should support the right of Cubans to manage their revolution without interference from other nations. LEE did not advocate supporting the Cuban revolution per se (u)

The November 23, 1963, edition of "The New York Times" reported that Senator THOMAS J. DODD of Connecticut had called FPCC "the chief public relations instrument of the CASTRO network in the United States." It is to be noted that Senator DODD was a member of the Senate Internal Security Subcommittee which twice conducted hearings on the FPCC (u)

The December 27, 1963, edition of "The New York World Telegram and Sun" newspaper stated that the pro-CASTRO FPCC was seeking to go out of business and that its prime activity during its lifetime had been sponsorship of pro-CASTRO street rallies and mass picket lines, and the direction of an active propaganda mill highlighting illegal travel-to-Cuba campaigns. Its comparatively brief span of life was attributed to mounting anti-CASTRO American public opinion, the 1962 Congressional hearings which disclosed FPCC financing by CASTRO's United Nations Delegation, and ultimately, the bad publicity which the FPCC received from disclosure of activities on its behalf by suspected presidential assassin, LEE H. OSWALD (u)

On February 6, 1964, the previously mentioned second source advised that V. T. LEE had recently remarked that the FPCC was dead and that there were no plans to organize another similar organization (u)

On April 13, 1964, a third source advised that there had not been any FPCC activity in many months and that the FPCC had been dissolved. (u)

MUSLIM MOSQUE, INCORPORATED (MMI)

The March 13, 1964, edition of "The New York Times", a daily newspaper published in New York, New York, contained an article on page 20 which indicated that MALCOLM X (LITTLE), former national official of the Nation of Islam (NOI) who broke with the NOI on March 8, 1964, publicly announced in New York City on March 12, 1964, that he had formed the Muslim Mosque, Incorporated (MMI). The MMI, according to the article, would be a broadly based politically oriented black nationalist movement for Negroes, only, financed by voluntary contributions. In this public statement, MALCOLM X urged Negroes to abandon the doctrine of non-violence when it is necessary to defend themselves in the civil rights struggle, and he also suggested that Negroes form rifle clubs to protect their lives and property in time of emergencies in areas where the government is unable or unwilling to protect them. (u)

Incorporation papers of the MMI filed on March 16, 1964, with the Business Section, Clerk of Courts, New York County, New York, New York, reflect that the MMI was incorporated under the Religious Corporation Law of the State of New York to work for the imparting of the Islamic Faith and Islamic Religion in accordance with "accepted Islamic principals". The principal place of worship to be located in the Borough of Manhattan, New York, New York (u)

The May 23, 1964, edition of the "New York Amsterdam News", a weekly Negro newspaper published in New York City, contained an article by columnist JAMES BOOKER in which he indicated that he had heard that the visit by MALCOLM X with Muslim leaders during his African tour has changed him to become soft in his anti-white feelings and to become more religious (u)

On October 6, 1964, a confidential source advised that the MMI is apparently affiliated with the true orthodox Islamic Religion through its affiliation with the Islamic Foundation (of New York), 1 Riverside Drive, New York City. The only teachings of the MMI are on the Islamic Religion (u)

MUSLIM MOSQUE, INCORPORATED (MMI)

This confidential source advised on May 17, 1965, that the headquarters of the MMI are located in Suite 128, Hotel Theresa, 2090 Seventh Avenue, New York, New York, where they were established on March 16, 1964. These headquarters are shared with the Organization of Afro-American Unity, Incorporated (OAAU) which was also headed by MALCOLM X (u)

MALCOLM X was assassinated on February 21, 1965, while addressing an OAAU rally at the Audubon Ballroom, Broadway and 166th Street, New York City (u)

This same confidential source advised on September 8, 1965, that the activities of the MMI following the death of MALCOLM X were limited to the teaching of classes in the Islamic religion and a class in judo for self-protection. These classes were held regularly until the latter part of July, 1965, when they were discontinued. Since then, the MMI has held no meetings and there has been absolutely no activity by the MMI which appears to be completely "dead". (u)

NATION OF ISLAM

In January, 1957, a source advised ELIJAH MUHAMMAD has described his organization on a nationwide basis as the "Nation of Islam" and "Muhammad's Temples of Islam." (u)

On May 7, 1965, a second source advised ELIJAH MUHAMMAD is the national leader of the Nation of Islam (NOI); Muhammad's Temple of Islam Number 2, 5335 South Greenwood Avenue, Chicago, Illinois, is the national headquarters of the NOI; and in mid-1960 Muhammad and other NOI officials, when referring to Muhammad's organization on a nationwide basis, commenced using either "Mosque" or "Temple" when mentioning one of "Muhammad's Temples of Islam." (u)

The NOI is an all-Negro organization which was originally organized in 1930 in Detroit, Michigan. MUHAMMAD claims to have been selected by Allah, the Supreme Being, to lead the so-called Negro race out of slavery in the wilderness of North America by establishing an independent black nation in the United States. Members following MUHAMMAD's teachings and his interpretation of the "Koran" believe there is no such thing as a Negro; the so-called Negroes are slaves of the white race, referred to as "white devils," in the United States, and the white race, because of its exploitation of the so-called Negroes, must and will be destroyed in the approaching "War of Armageddon." (u)

In the past, officials and members of the NOI, including MUHAMMAD, have refused to register under the provisions of the Selective Service Acts and have declared that members owe no allegiance to the United States. (u)

On May 5, 1958, the first source advised MUHAMMAD had, upon advice of legal counsel, tempered his personal statements and instructions to his ministers concerning the principles of his organization in order to avoid possible prosecution by the United States Government; however, he did not indicate any fundamental changes in the teachings of his organization. (u)

On May 3, 1965, a third source advised MUHAMMAD had, early in July, 1958, decided to de-emphasize the religious aspects of the teachings of Islam and to stress the economic benefits to be derived by those Negroes who joined the NOI. (u)

ORGANIZATION OF AFRO-AMERICAN
UNITY, INCORPORATED (OAAU)

On June 28, 1964, MALCOLM X LITTLE, founder and leader of the Muslim Mosque, Incorporated (MMI), publicly announced the formation of a new, all Negro, militant civil rights action group to be known as the Organization of Afro-American Unity (OAAU), with himself as Chairman. This announcement was made at a public rally held by the MMI in the Audubon Ballroom, Broadway and 166th Street, New York City. (u)

A printed and published statement of basic OAAU aims read by MALCOLM X at this meeting indicates that it shall include "all" people of African descent in the Western Hemisphere, as well as "our" brothers and sisters on the African continent. It is patterned after the "letter and spirit" of the Organization of African Unity established (by African heads of States) at Addis Ababa, Ethiopia, in May, 1963. (u)

A recording of the remarks of MALCOLM X at this meeting indicates that the aim of the OAAU is to eliminate differences between Negroes so they can work together for "human rights," while the initial objective is to "internationalize" the American civil rights movement by taking it to the United Nations. LITTLE condemned the non-violent civil rights movement and claims that Negroes should be taught to protect themselves, when and if necessary. The OAAU will sponsor a program for Negroes of education, politics, culture, economics, and social reform. (u)

On May 17, 1965, a confidential source advised that the headquarters of the OAAU are located in MMI headquarters, Suite 128, Hotel Theresa, 2090 7th Avenue, New York City. (u)

MALCOLM X was assassinated on February 21, 1965, while addressing an OAAU rally at the Audubon Ballroom, New York City. (u)

On November 3, 1964, a source made available a document entitled "The Revolutionary Action Movement Manifesto," the document having been obtained by the source from an individual known to be a member of the Revolutionary Action Movement (RAM). (u)

This document stated, in part, that RAM was officially organized in the Winter of 1963 by Afro-Americans who support the revolutionary objectives of ROBERT F. WILLIAMS, now residing in Cuba, and his concept of organized violence to achieve the liberation of the Afro-American people in the United States. This Manifesto disclosed that RAM had oriented its program to one of education and political revolution and the organization of a "black" political party with revolutionary objectives, having recognized the need for a "black revolution" that could and would seize power. RAM philosophy is described in this document as one of revolutionary nationalism, that is, one involving the struggles of the nonwhite races of the world against exploitation and enslavement by the white capitalist and imperialist nations. (u)

Regarding WILLIAMS, it should be noted that on August 28, 1961, a Federal warrant was issued at Charlotte, North Carolina, charging him with Unlawful Flight to Avoid Prosecution for the crime of kidnapping. Subsequent to the issuance of this warrant, WILLIAMS fled the United States to Cuba, where he now publishes a monthly newsletter entitled "The Crusader" from Havana. (u)

This source in September, 1964, advised RAM is dedicated to the overthrow of the capitalist system in the United States, by violence if necessary, and to its replacement by a socialistic system oriented toward the Chinese communist interpretation of Marxism-Leninism. RAM is entirely nonwhite in membership, clandestine in nature, and owes its primary allegiance to the "Pandung World," that is, the nonwhite races of the world rather than to any national entity, as such. (u)

On November 16, 1964, a second source advised he learned recently from an RAM member that the organization began in Detroit, Michigan, largely under the impetus of DON FREEMAN, described as the "Father" of RAM and referred to

as RAM's "Black Stalin." FREEMAN served as RAM Chairman, with MAXWELL STANFORD, now of New York City, formerly of Philadelphia, Pennsylvania, serving as RAM Field Chairman (u)

This source stated in May, 1965, there has been no formal headquarters, as such, for RAM but that headquarters have been with FREEMAN since he has played such a dominant role in the leadership of and has directed the policies and activities of the organization (u)

Within recent months, according to the second source, dissension within RAM has become evident and some dissatisfaction with FREEMAN's leadership has arisen. So far as is known, however, he remains the titular leader of RAM. (u)

To date, according to the second source in May, 1965, RAM has organized units and membership in several of the larger cities in the United States east of the Mississippi River and the organization is currently active in attempting to recruit new members and expand its sphere of influence (u)

WORKERS WORLD PARTY

On April 17, 1959, a confidential source advised that on February 12, 1959, a Socialist Workers Party (SWP) minority group under the leadership of National Committee member, SAM BALLAN, split from the SWP (u)

The source stated that this minority group, referred to as the Marcyites, after many years of program and policy differences on varied issues concerning tactics and interpretation of political events, split from the SWP on the grounds that the Party was liquidating itself by departing from the Marxist precepts of LEON TROTSKY and retreating from the fight for the world socialist revolution. The final issue which ultimately forced the split was the minority's opposition to the SWP regroupment policy which involved cooperation with the Communist Party (CP) periphery-individuals characterized by the minority as petty-bourgeois (u)

The minority program, according to source, advocated unconditional defense of the Soviet Union and has as its goal the building of a revolutionary party with a complete proletarian orientation for the purpose of overthrowing capitalism in the United States and throughout the world (u)

On May 12, 1960, source advised that this minority group had chosen the name Workers World Party (u)

On May 3, 1965, second source advised that the Workers World Party, which maintains headquarters at 46 West 21st Street, New York, New York, supports the People's Republic of China in its ideological dispute with the Soviet Union (u)

The SWP and the CP have been designated pursuant to Executive Order 10450 (u)



On 8/30/66, [redacted] was interviewed at his place of residence, [redacted] NY, in the presence of [redacted]. The interviewing agents were SAS [redacted] and [redacted].

At the outset of the interview, [redacted] was advised by SA [redacted] that before agents could ask him any questions he must understand his constitutional rights. He was told that he had a right to remain silent; that anything he said could be used against him in a court of law; that he had a right to consult with an attorney before agents ask him any questions, and that his attorney could be present during the questioning period; that this right to attorney is possible even if he and his mother could not afford to hire one in the event that the matter should be taken to court; that if he wished to answer questions at that time without the presence of an attorney he had the right to stop at any point of the questioning, in that he could if he desired, then request the presence of an attorney and that no force or duress would induce him to make any comments. After hearing and understanding the above [redacted] agreed to cooperate with the agents by answering questions at that time (u)

b7c [redacted] advised that he first heard the term Five Percenters on the night [redacted] when officers questioning him mentioned it. He has, however, heard the terms "brothers and sisters" used when talking about young Negroes in the Brooklyn Bedford Stuyvesant area. He stated that on several occasions in a local park near Tompkins and Lafayette Avenues, many young Negroes would gather and openly discuss the tense racial situation throughout Bedford Stuyvesant and the rest of the US. [redacted] mentioned that on two occasions a young Negro approximately 19 years of age who calls himself ALLAH, who stands approximately 5'11" and weighs 170 pounds, dark brown skin and wears his hair in an Afro, has spoken about the fact that the devils, meaning white man, will not allow young Negroes to have anything and that you are supposed to beat them up when they come around. ALLAH mentioned the fact that these young Negroes were brothers and sisters since ALLAH was their father (u)

These types of gatherings in the park are not necessarily planned but take place at any given hour when someone decides to discuss anything at the park. The audience, which is composed of ~~over~~ 80 teenagers, may simply be sitting in the park awaiting a turn on the basketball court, a deal at cards or simply a game of softball. At these various gatherings no individual is considered the floor chairman and that anyone who desires to discuss anything simply stands and can be heard (u)

b7c At far as receiving actual instructions from any given organization, [redacted] indicated that this was not true and that his actions thus far were the result of his own doings or that of himself and a friend. (u)

b7c During the course of conversation, [redacted] indicated that white youngsters in the Bedford Stuyvesant area were not safe while walking the streets at night nor were young Negroes safe while walking the white sections of Brooklyn (u)

b7c During the course of interview, [redacted] mentioned many things which indicated that some of the ideas and statements made at the various gatherings were actually things which could have been heard at Black Muslim Meetings but that no black muslims nor anyone
