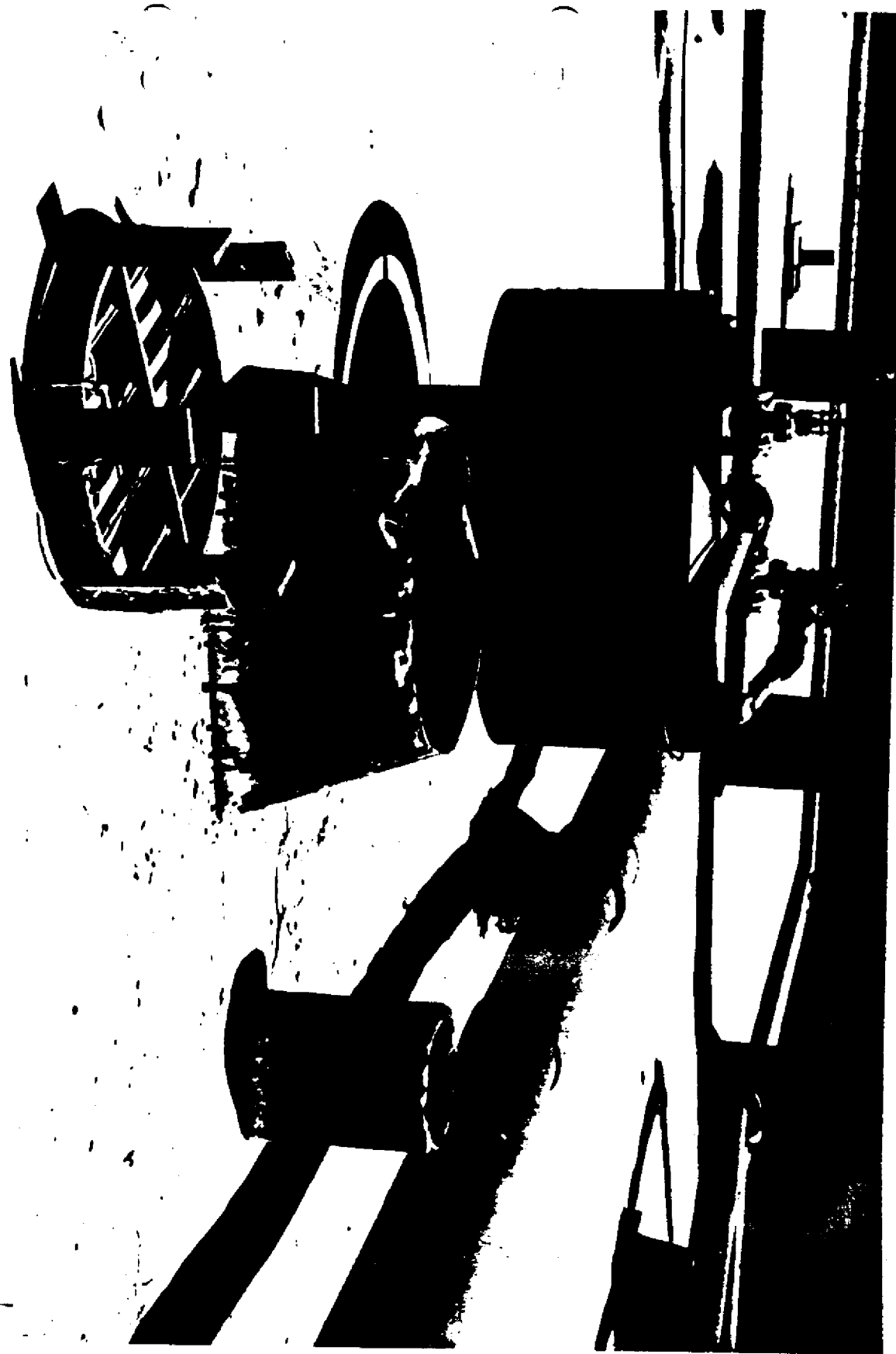

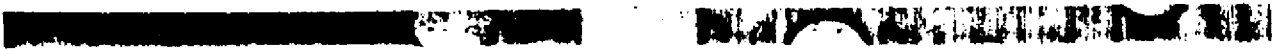

The object to the rear behind the opening is the ventilator top which was removed to permit the Subjects to escape.

The stub pipe appearing at center right is the vent stack for the lavatory facilities.

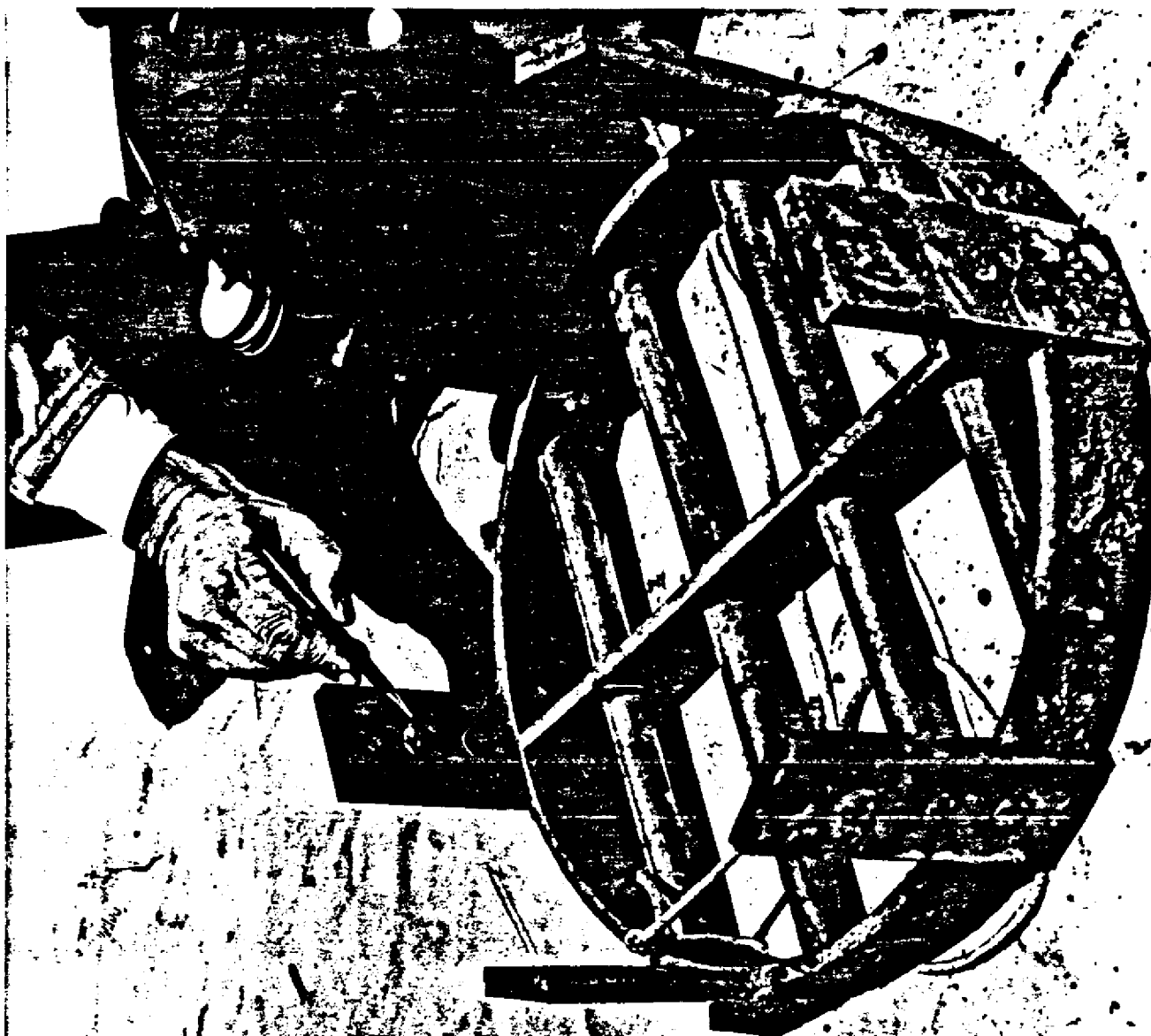




1-2 This is a more detailed photograph of the galvanized metal grate shown in 1-1.

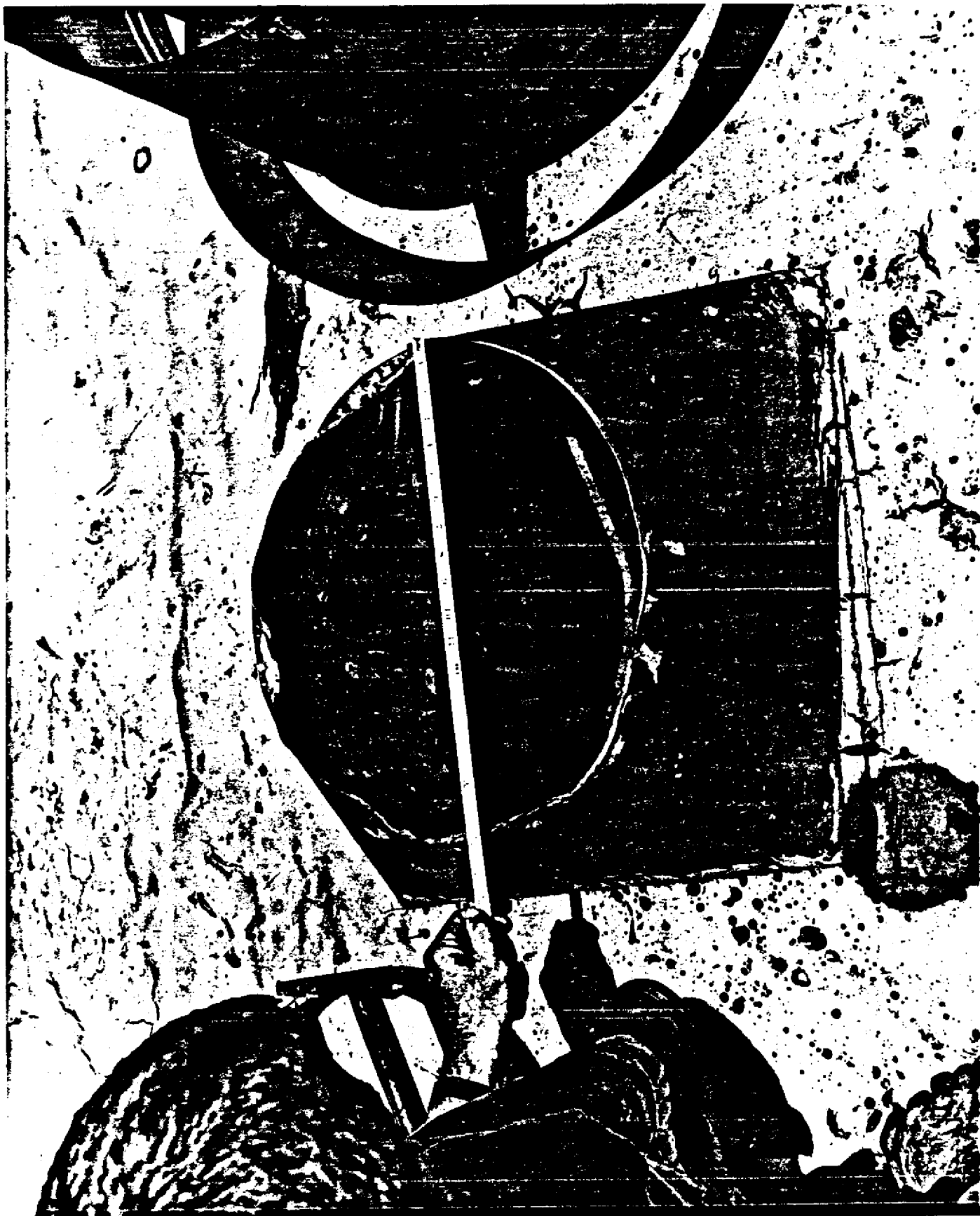

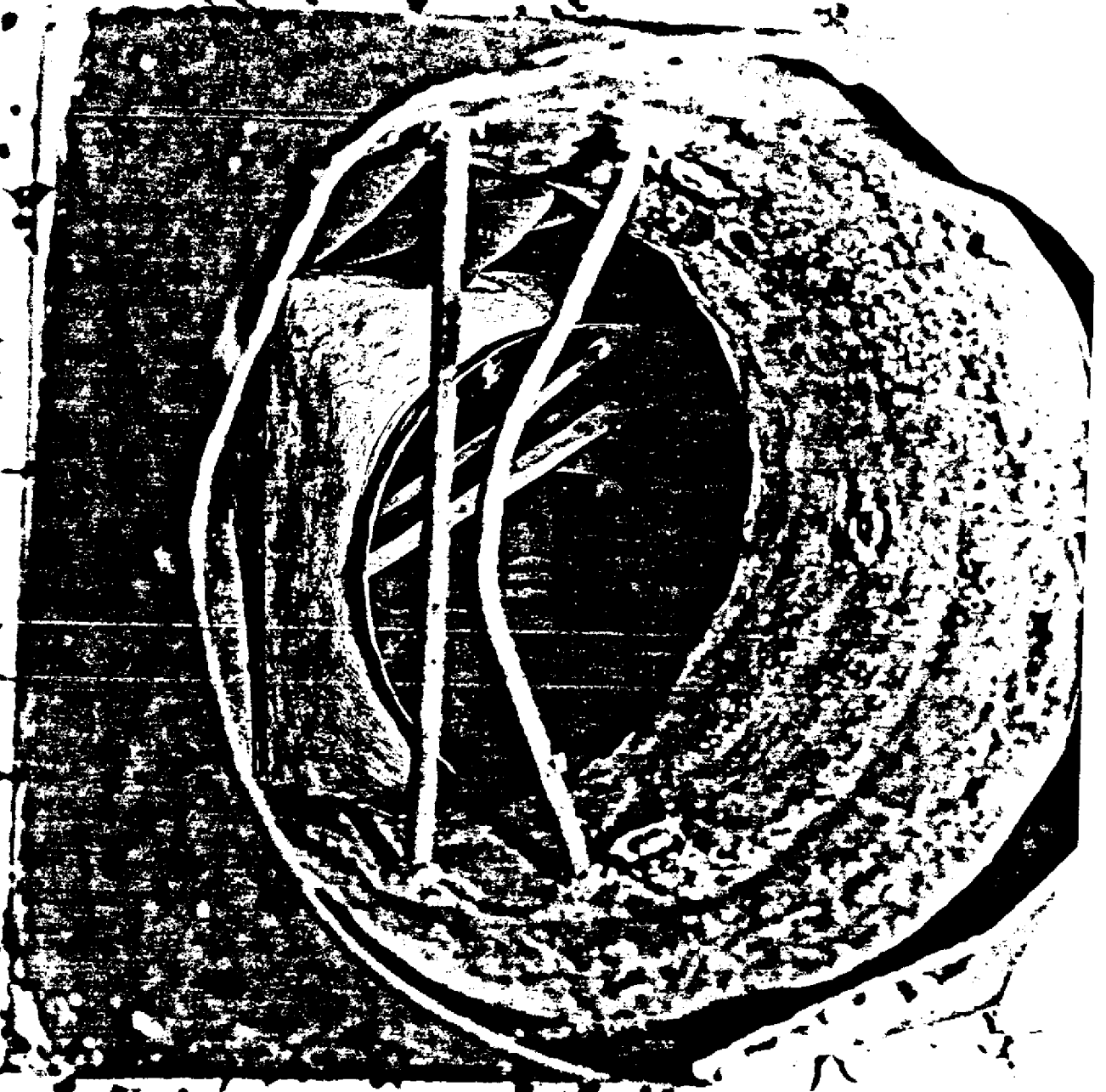


1-7 Photograph taken approximately twenty-five feet southeast of ventilator opening looking in a general northwesterly direction along the roof over Cell Block B toward water tower and is the direction foot prints led. The large skylights appearing on right and left center are skylights over the area between Cell Block A and B and at the far end of the photograph just below the catwalk around the water tower may be seen the catwalk which encircles the perimeter of the building and at the point where the pipes meet the end of the wall the catwalk drops down to a lower elevation of about six feet to eight feet and the far end of the building is reached by the catwalk.

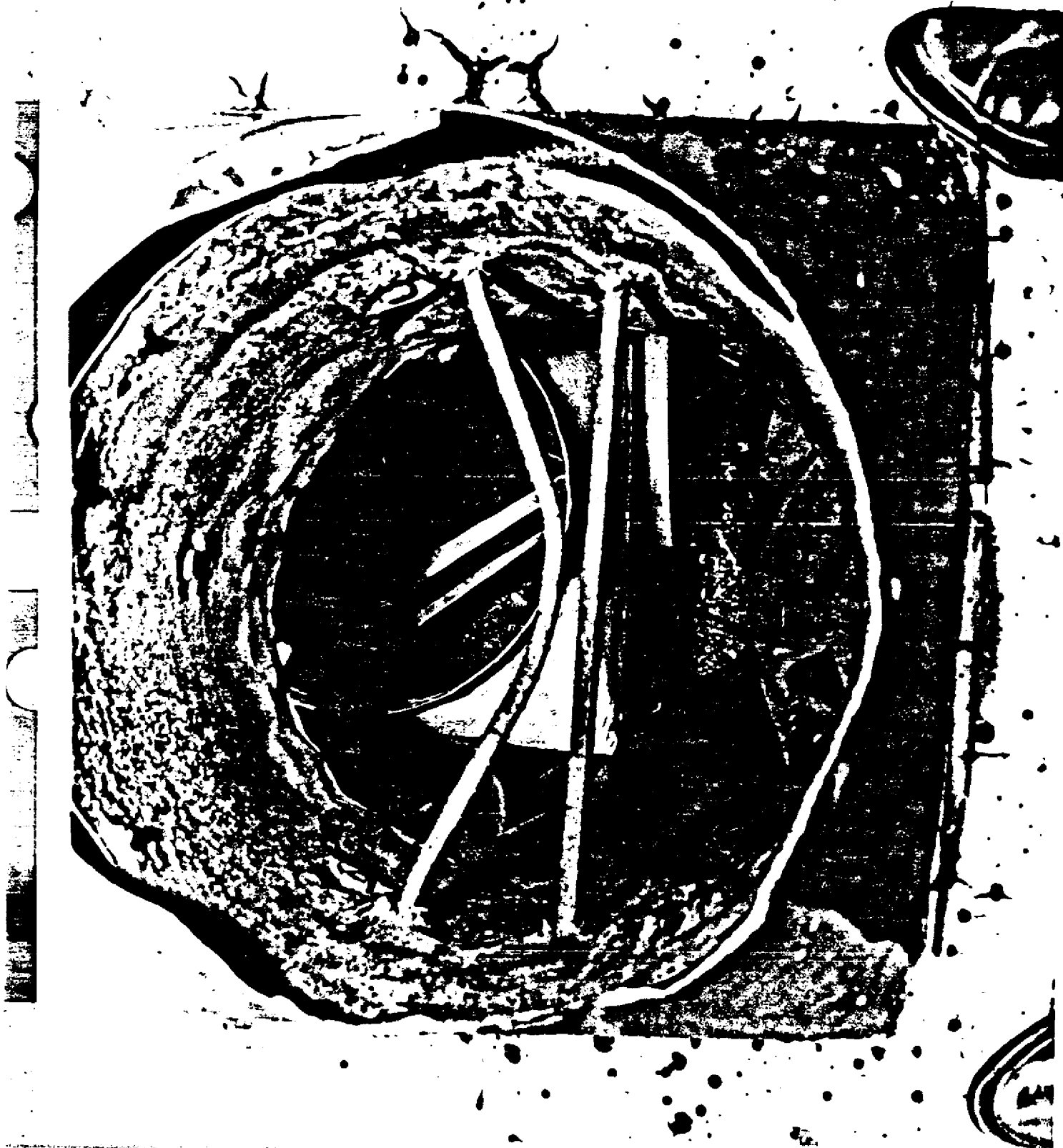

1-8 This photograph was taken directly over the ventilator opening on the roof and shows the vent re-enforcing rod and the stud holes normally used to fasten down the heavy galvanized grate shown in photographs 1-1, 2, and 3. Immediately below the opening may be seen the top of the motor housing which is normally offset from the roof opening and when in operation is joined by a galvanized gooseneck connection. The blades of the "squirrel cage" type air impeller may be seen just above the bent portion of the re-enforcing rod. The bent rod is on the eastern side of the hole.

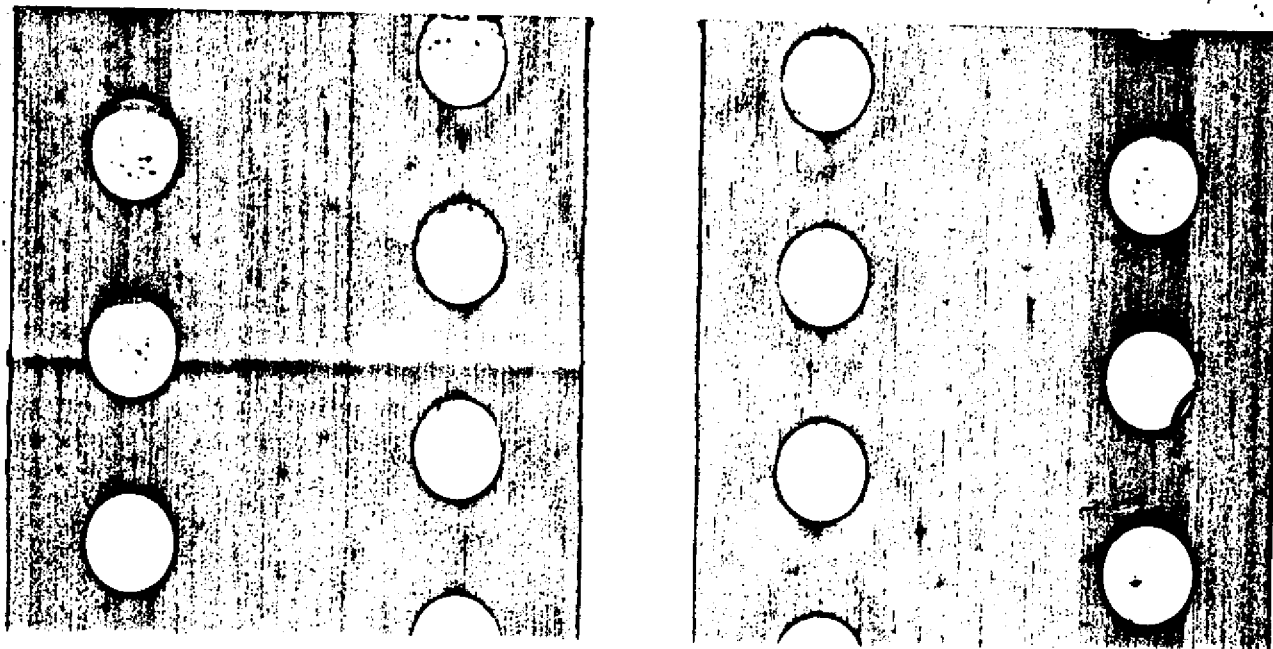

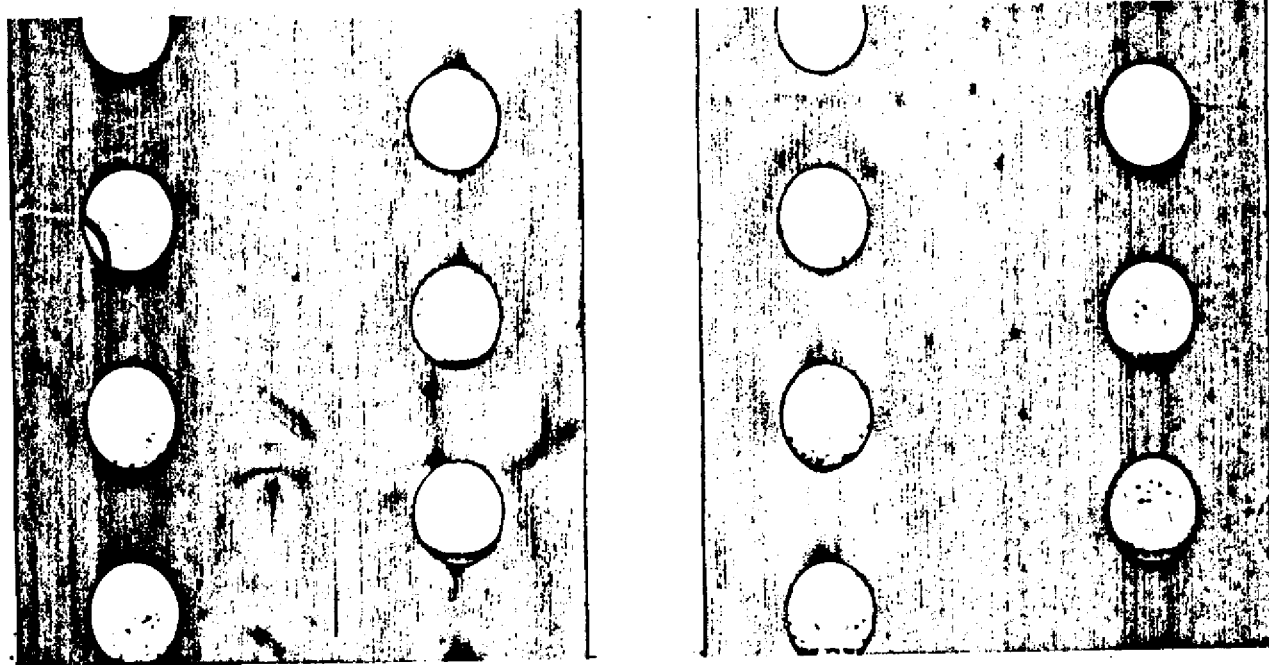
1-9 Same as 1-8 with the exception that more detail is shown concerning the blankets which were used to shield light from entering this opening.

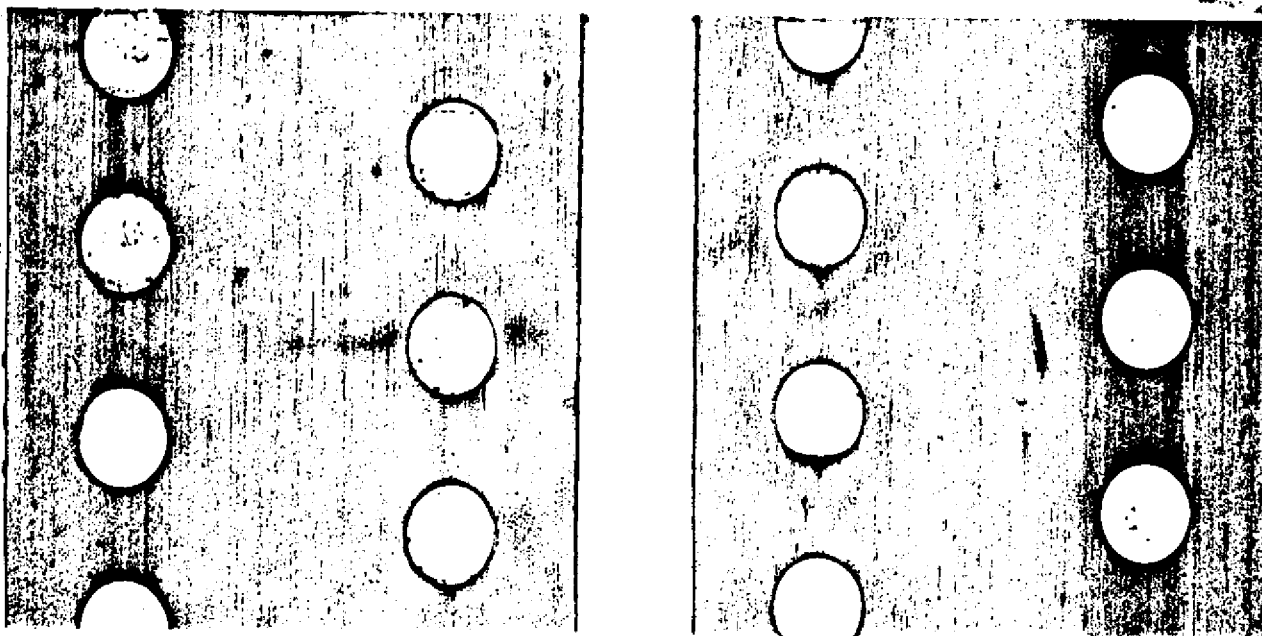

1-11 Photograph of two foot-print impressions, left one being the same as appearing in 1-10. Both prints headed in a northwesterly direction toward the water tower. While the impression of the foot print at the right appears to be distorted, it is a clear print and the angle of the photograph makes it appear in a distorted manner. The distance between the two prints was four feet one and one-eighth inches, indicating that someone apparently was running. These photographs were taken between the utility pipe and the skylight, which may be seen in photograph 1-7.

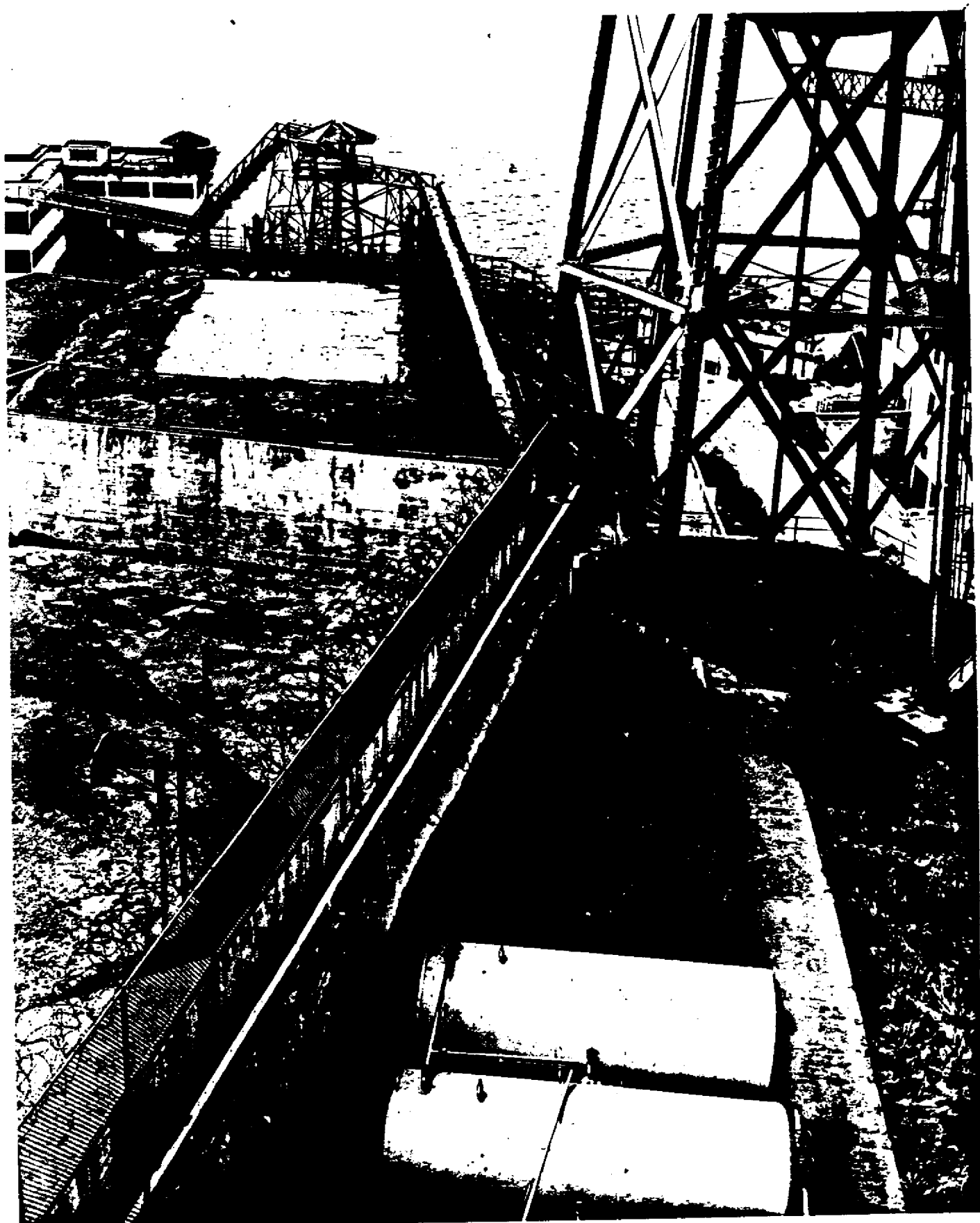

2-1 Photograph taken from top of prison building looking in a northern direction. The concrete decorative wall shown at bottom of photograph is the same as appearing at the top of 1-12. The two tanks shown in the foreground are salt water tanks with the base of the water tower shown at upper right. Top center is guardhouse number 3 and is not manned during the night hours. It is noted that lower left center along the fence, which encloses the walk to guard tower number 2, the barbed wire appears to have been cut and may have been the area over which the Subjects were able to make their escape.

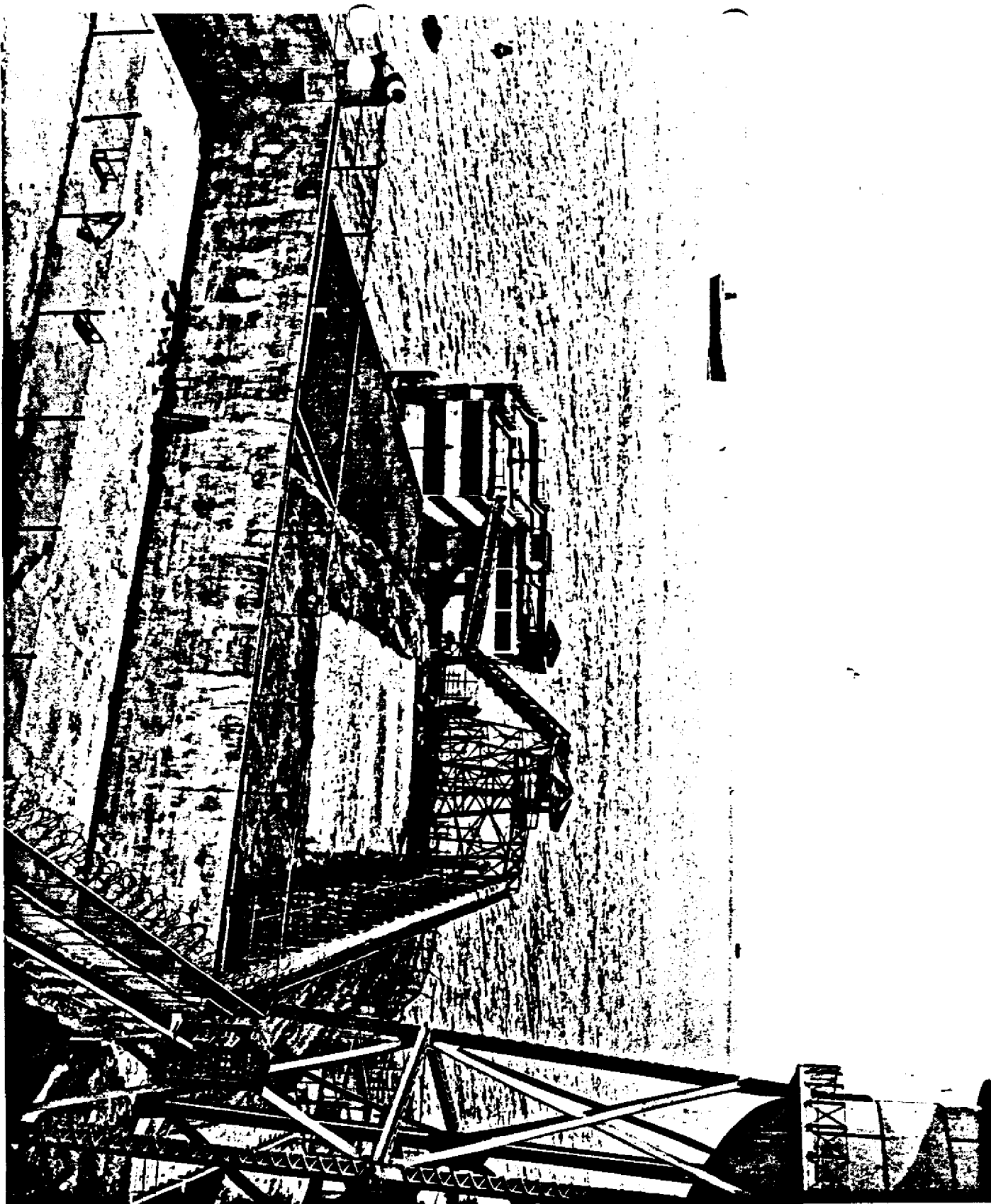

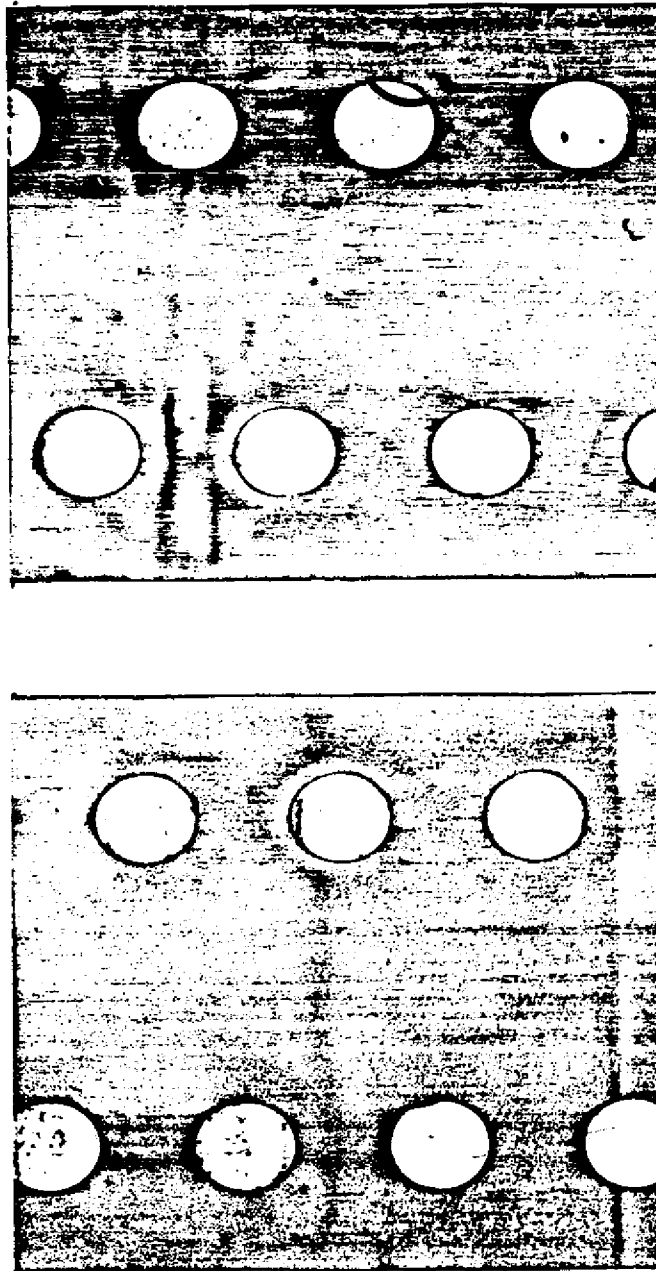


2-4 Same general view as previous photographs with the exception that the industrial building is shown in more detail.

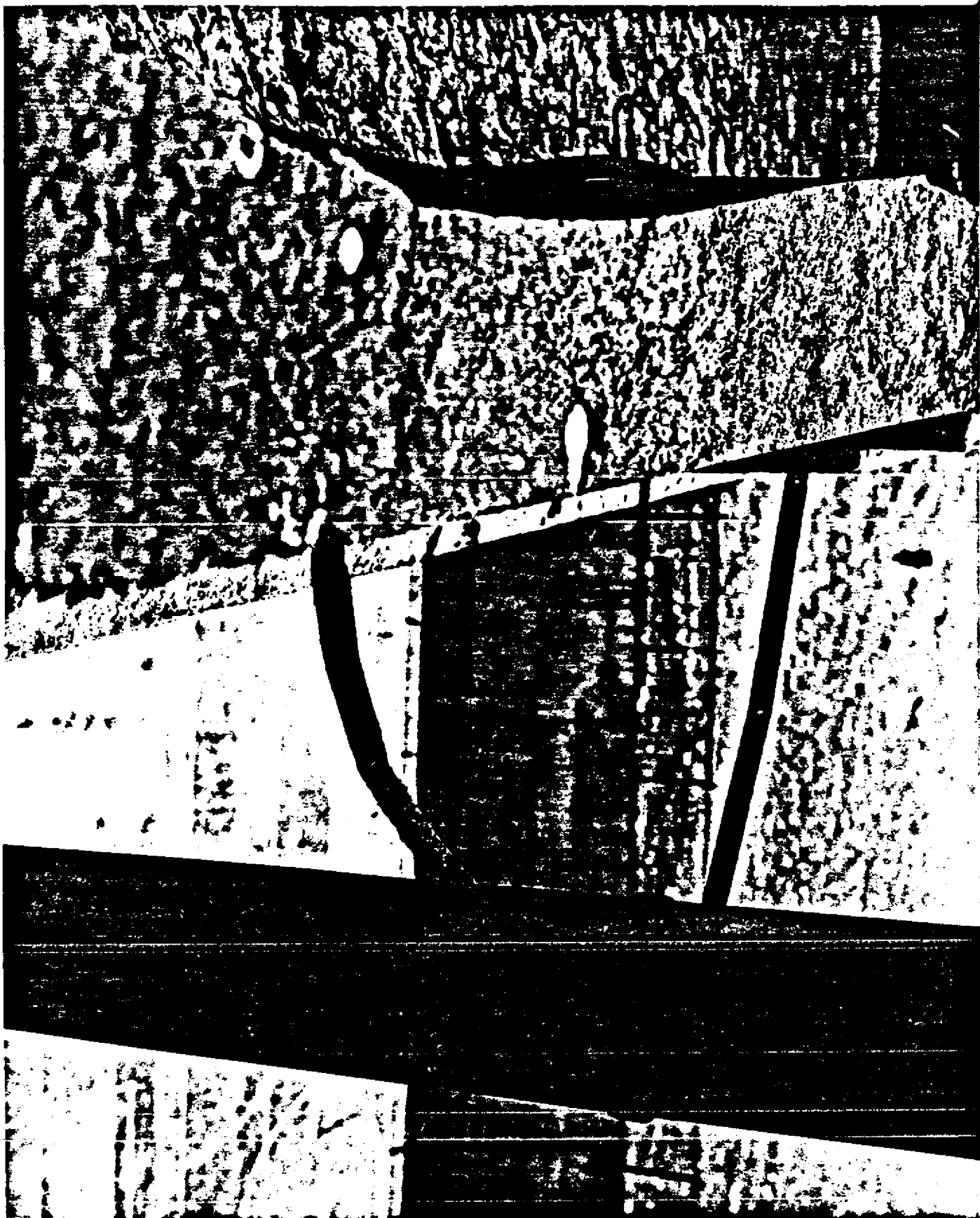

Photograph taken from roof as in preceding photograph, however this photograph shows the type of electrical fixture used to flood the sides of the building with light during the evening hours. Two such lights are spaced across the narrow or protruding end of the prison building and are spaced approximately ten to twelve feet apart. These lights receive their power from an externally mounted outlet on the inside of the edge of the roof and all connections were found to be tight and show no indications of having been tampered with. All lights were found to be in working order and were illuminated at the request of the photographer. The area at lower right is leading to the water line. It is the area believed to have been used by the Subjects in reaching the water.

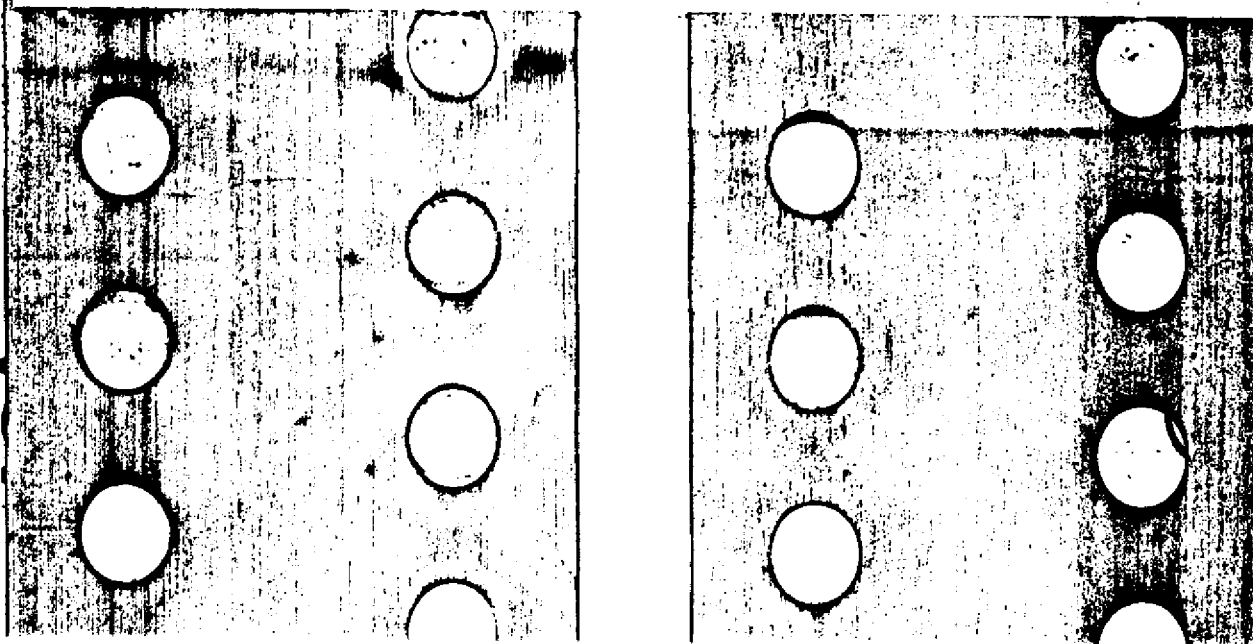


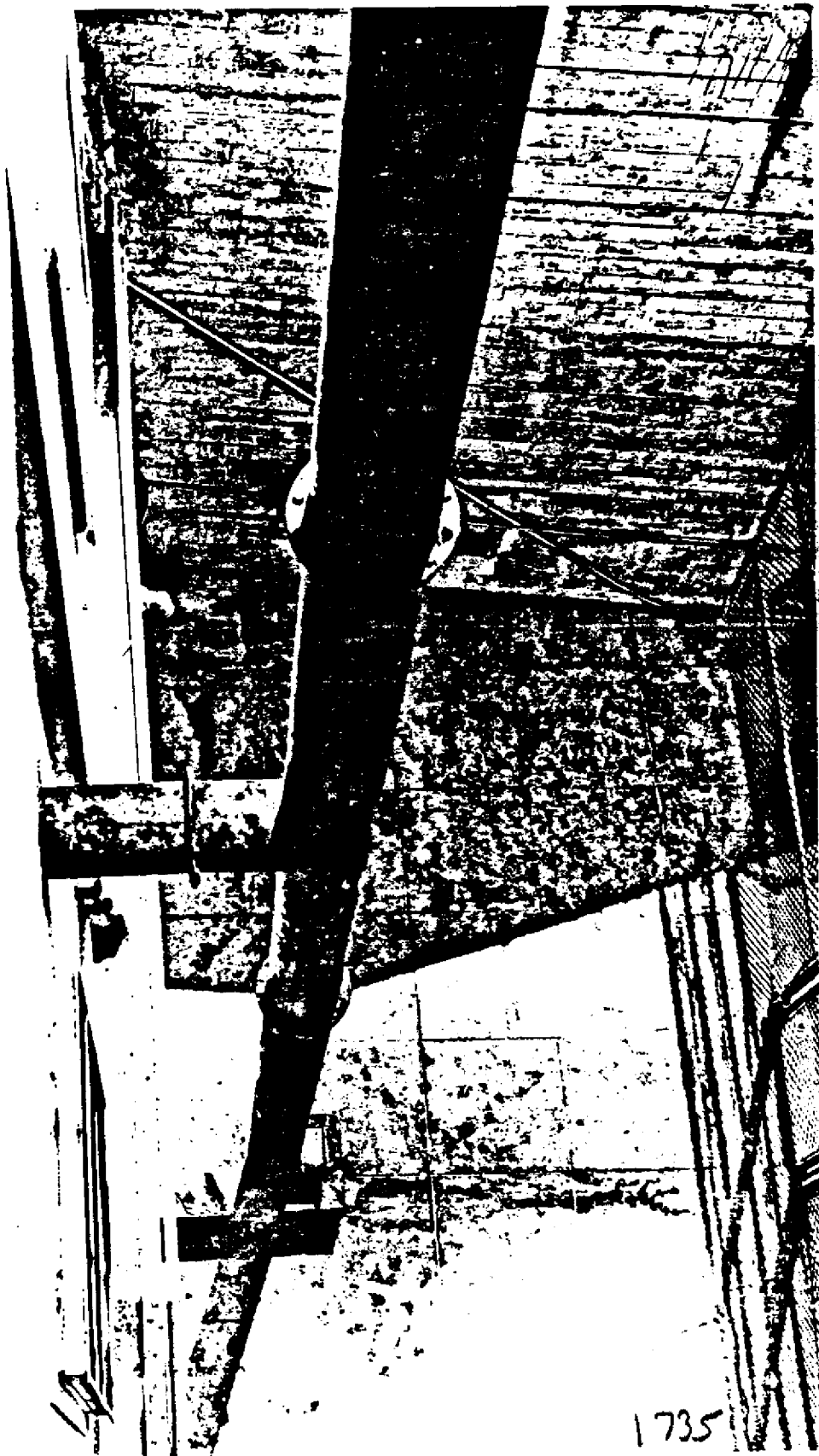

2-6 Photograph taken from top of prison building showing the edge of the building which extended approximately twenty-eight to thirty inches above the roof line. Immediately to the right will be observe angle iron brackets used to support the stack from the bake oven. This stack extends several feet above the edge of the roof and is approximately ten to twelve inches in diameter and appears to be made of cast iron.

The portion of the bracket which is visible in center foreground is noted to be bent. Prison guard [REDACTED] observed that this is a recent bend as he is quite certain this was not there the last time he observed it approximately a month ago. The stack extends to practically ground level on the exterior of the building.

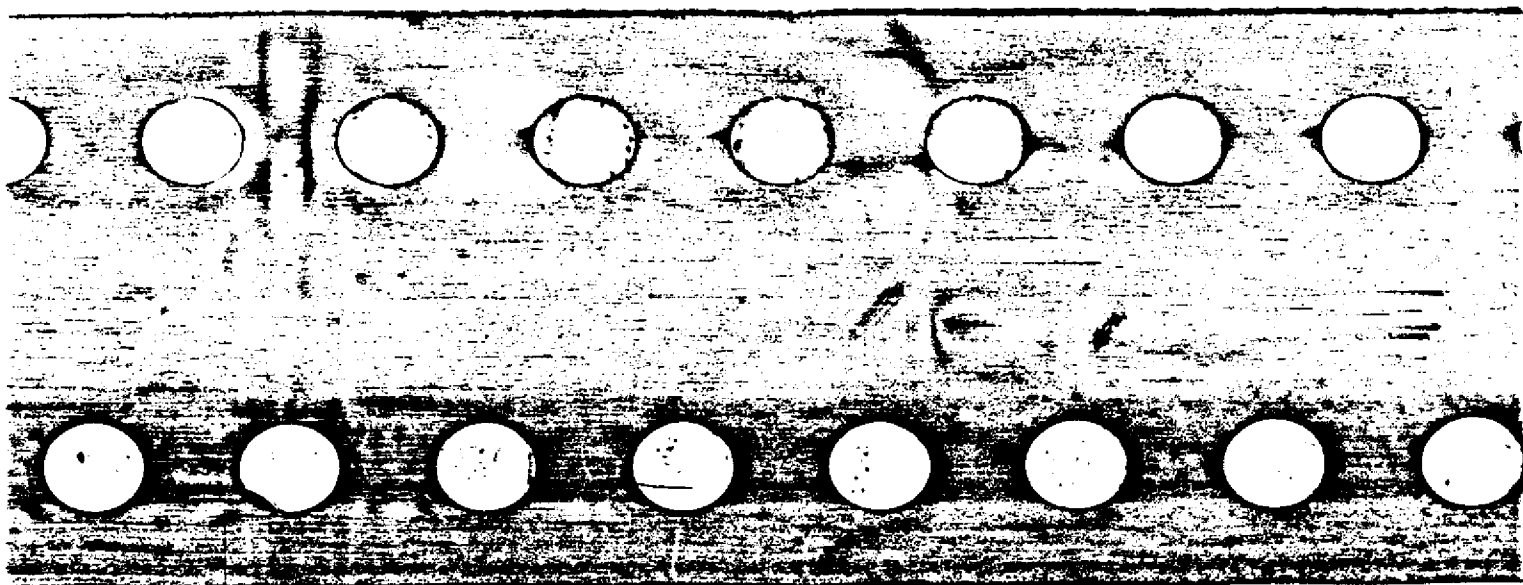

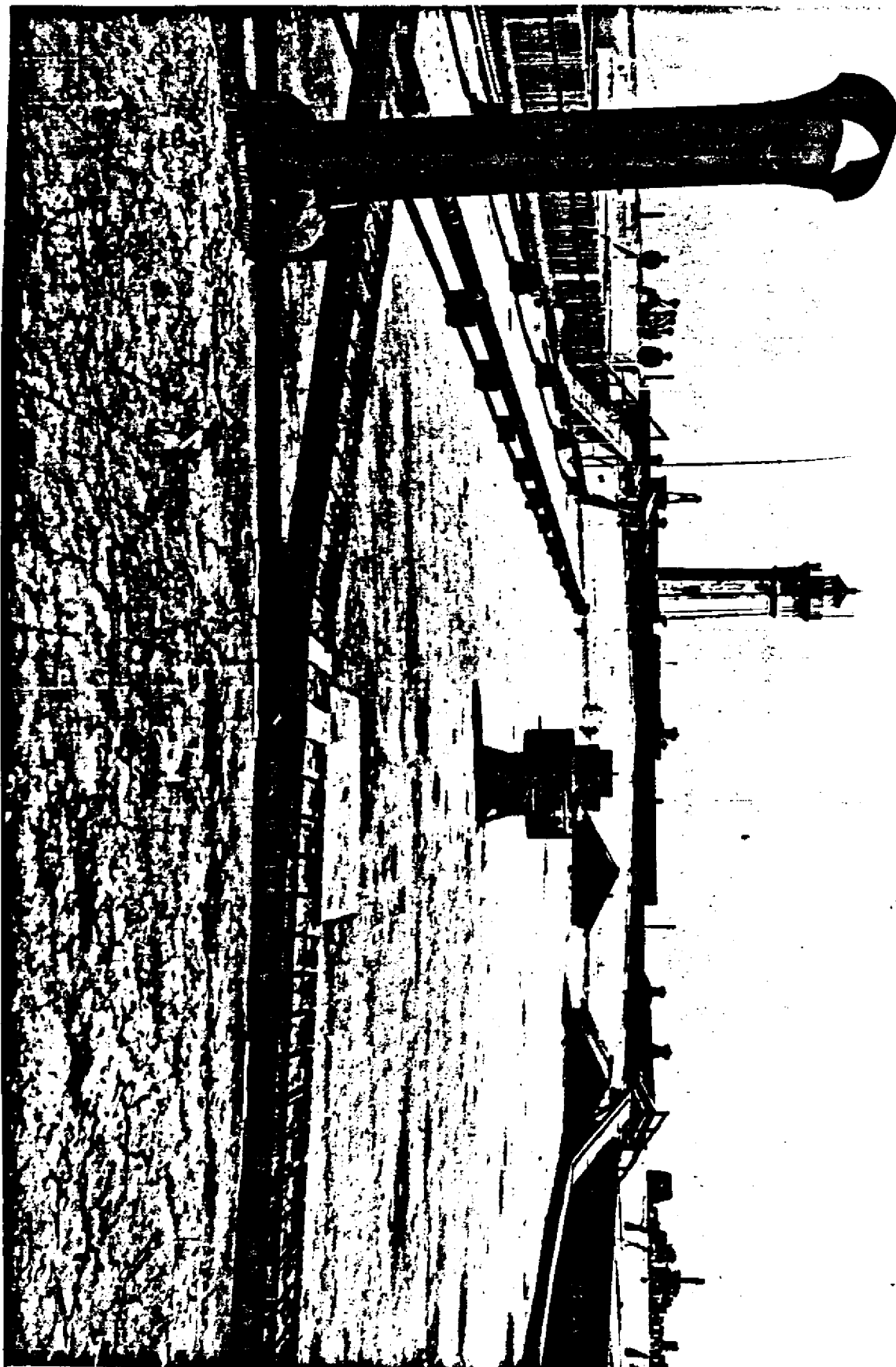

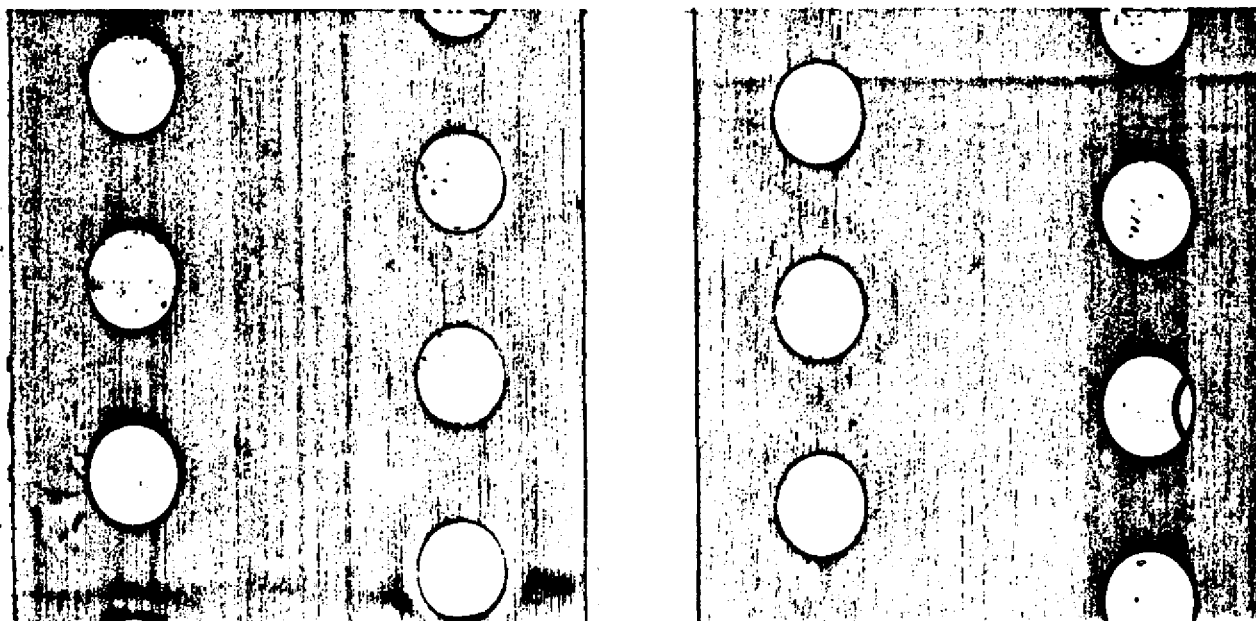

2-10 Photograph taken showing general roof area looking in a southerly direction from the bake oven stack toward the Coast Guard lighthouse. The change in the roof elevation from Cell Block A, B, and C, etc., may be observed with catwalks running on both sides of the picture. A paddle was found under the catwalk in approximate location indicated by the individuals seen in the photograph left center.

2-11 Photograph taken from roof of building at the northeast corner showing aluminum-plated utility pipes descending to ground level. These pipes are approximately six inches in diameter. Lower center of photograph shows the landing outside of the third floor entrance to the prison building. Stairs lead from this landing to the ground level in the same area as shown in photograph 1-12, however this corner of the building is illuminated by three flood lamps and is clearly visible to the guard in tower number 1 which is manned twenty-four hours a day. The angle iron crossbrace shown in the center of the photograph is the type used to support the illumination. Upper left hand corner shows the type of electrical connection for these lamps.

Photograph taken in the cell of CLARENCE ANGLIN showing detail of toilet facility at foot of bed. Portions of soap scraps and plaster are visible as are fragments of hair. Immediately forward of the toilet seat is a portion of the grill made by Subjects to replace that removed from the cell. The portion of the small circular object seen is the cup which is supplied to prisoners for shaving purposes. This cup contained water and a brush.

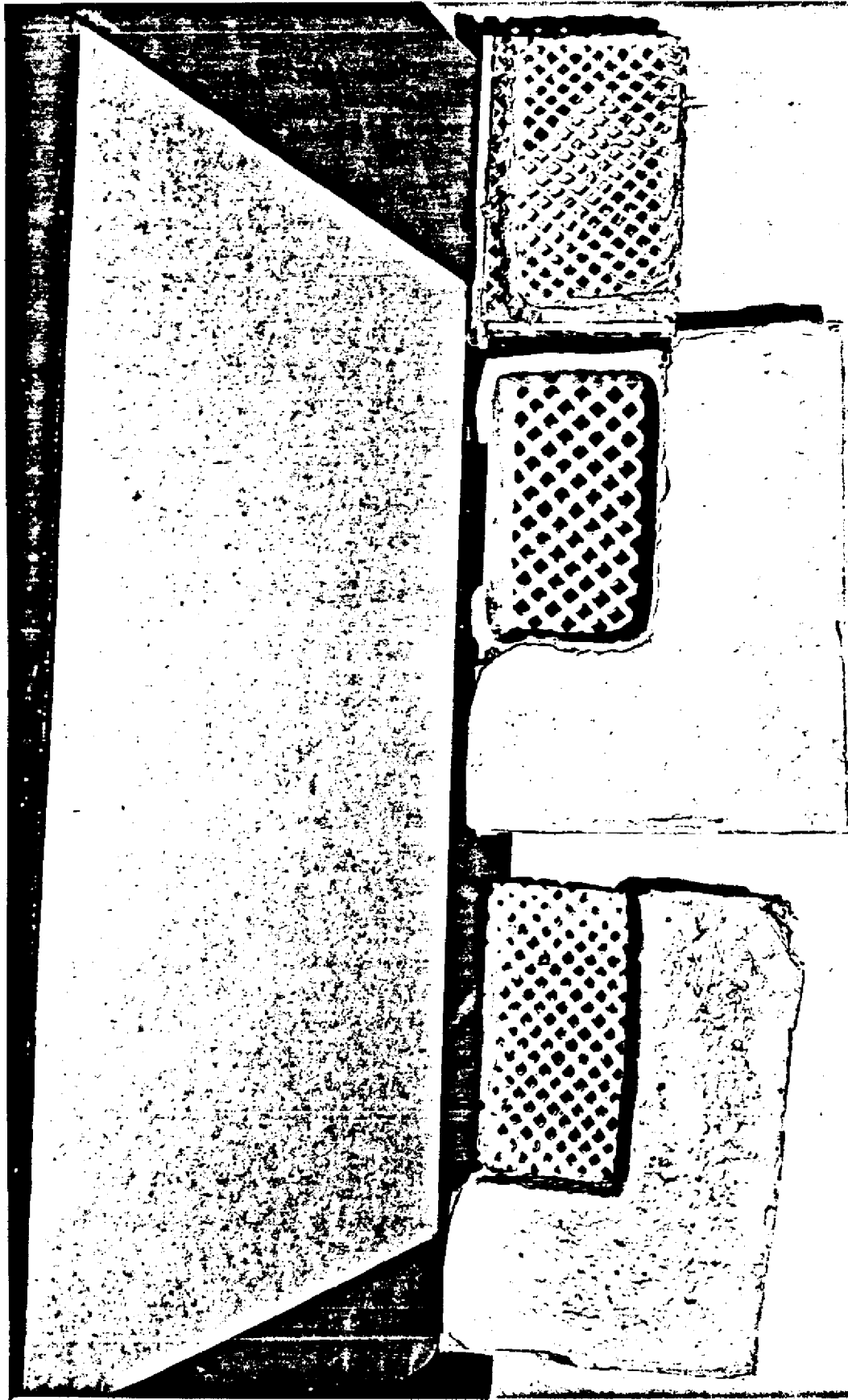

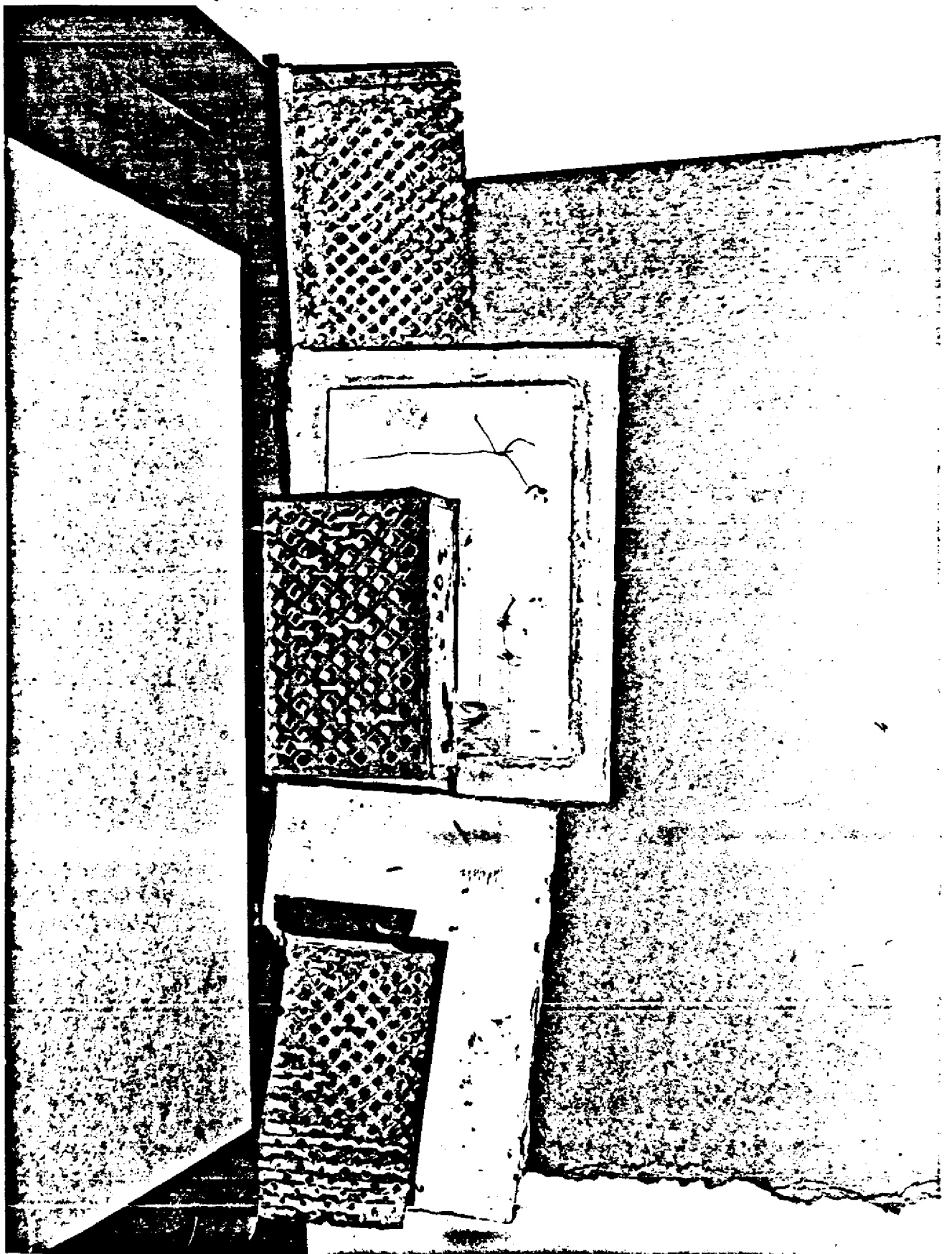

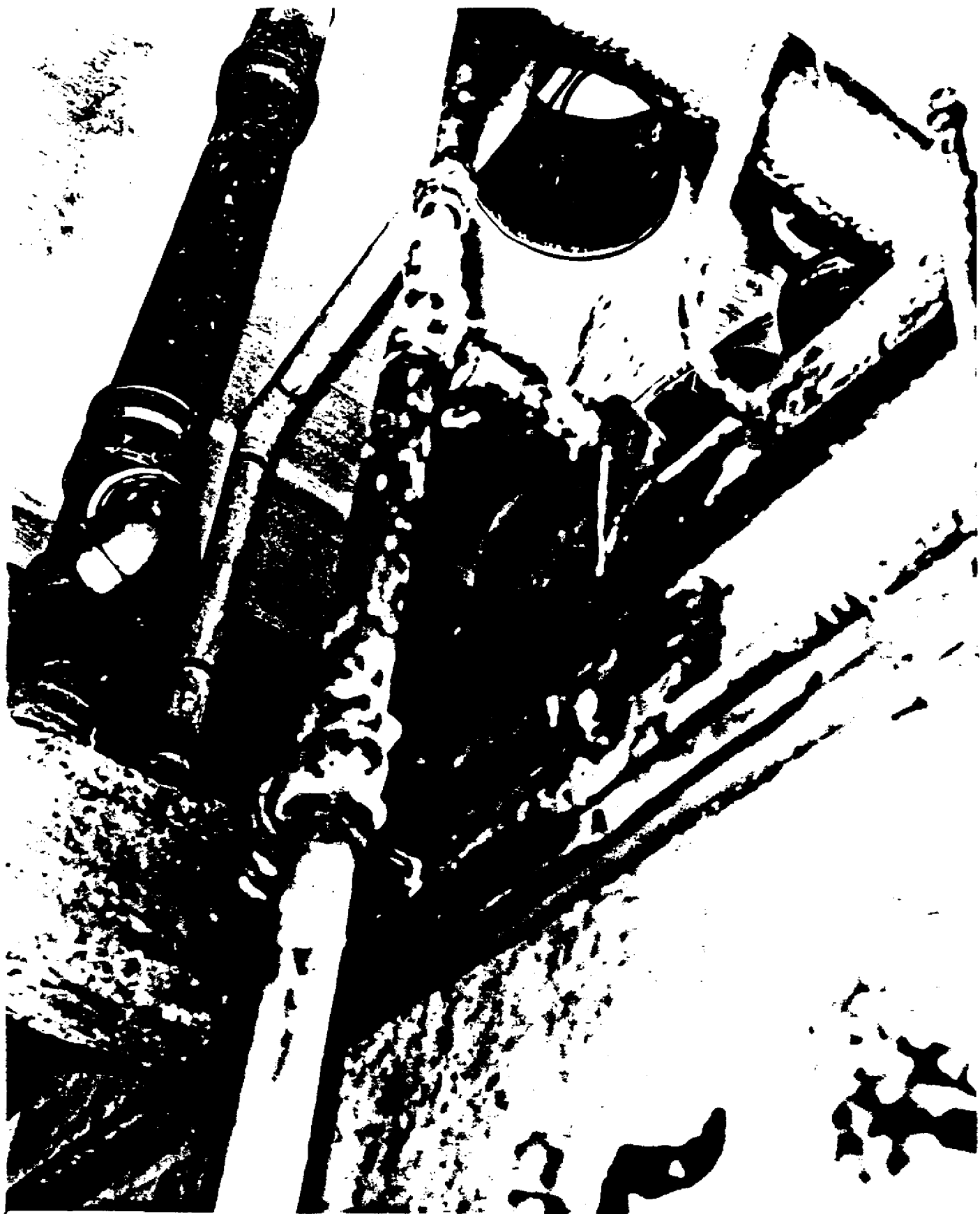

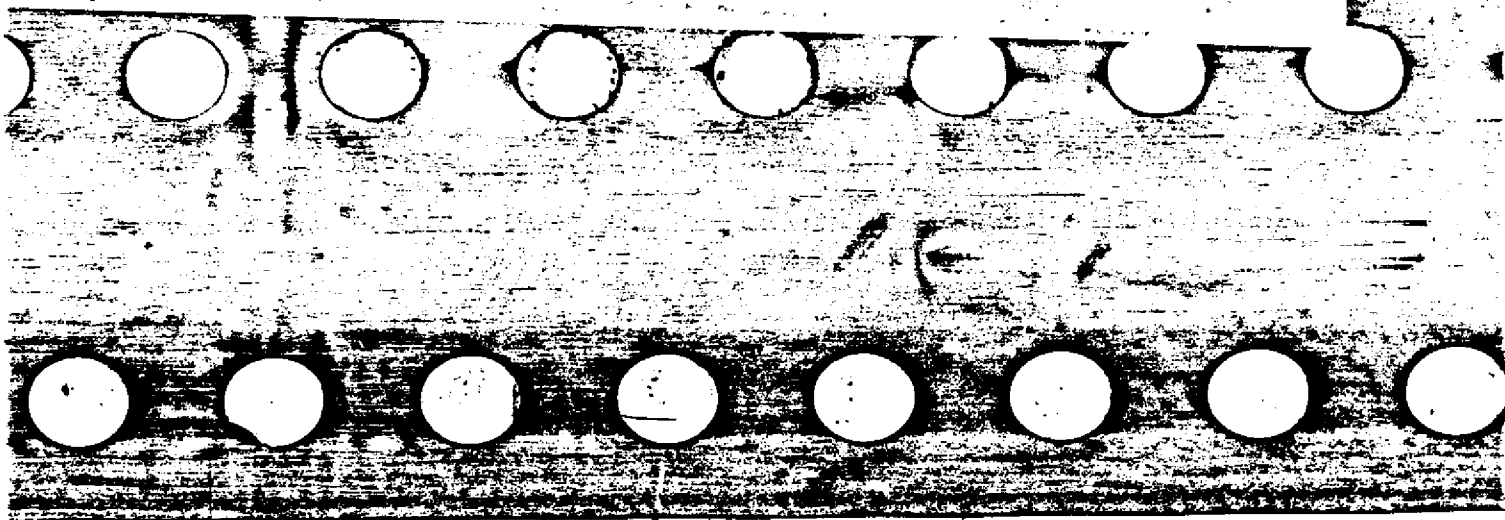

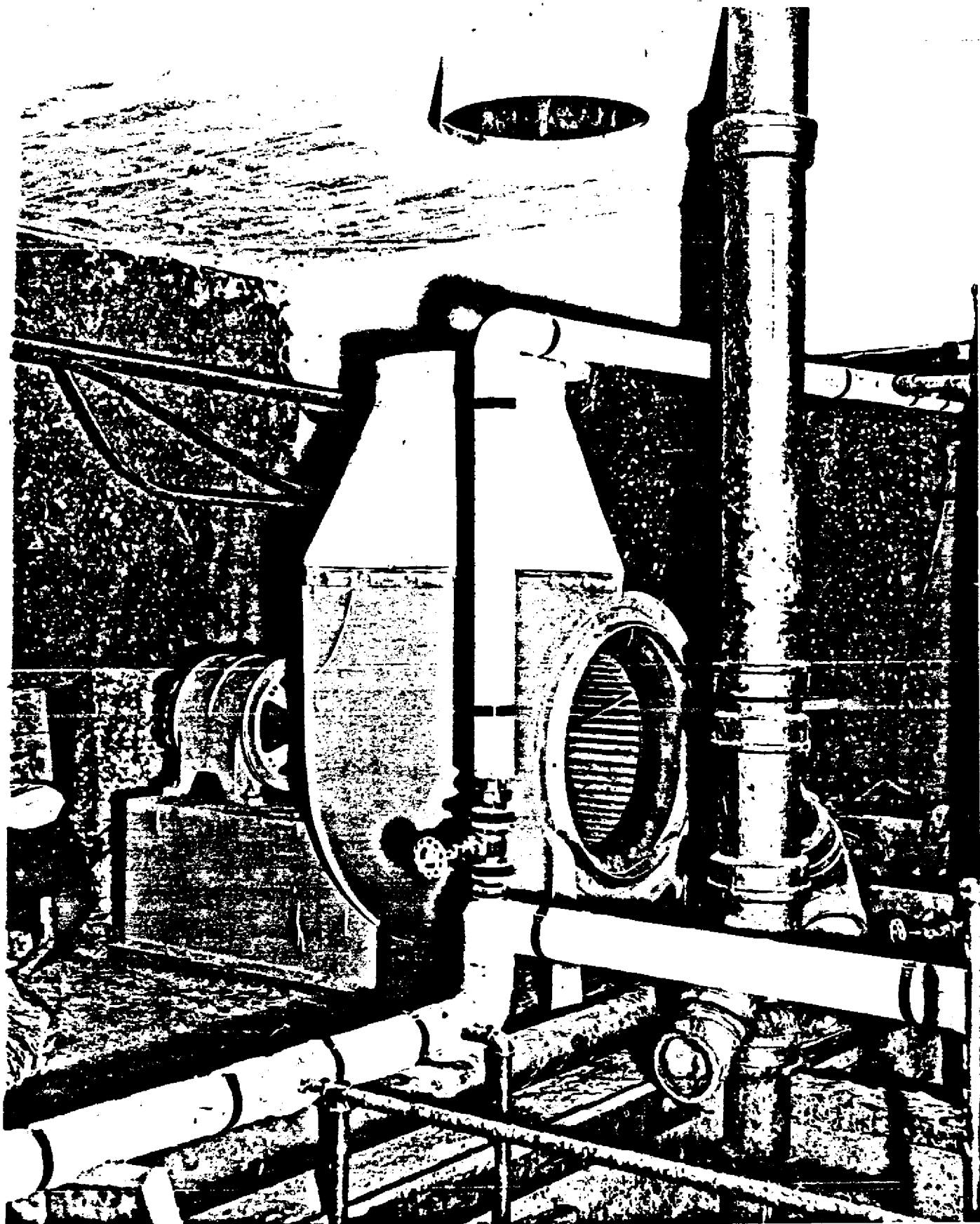


3-9 Photograph taken from a position directly above Cell 152 B

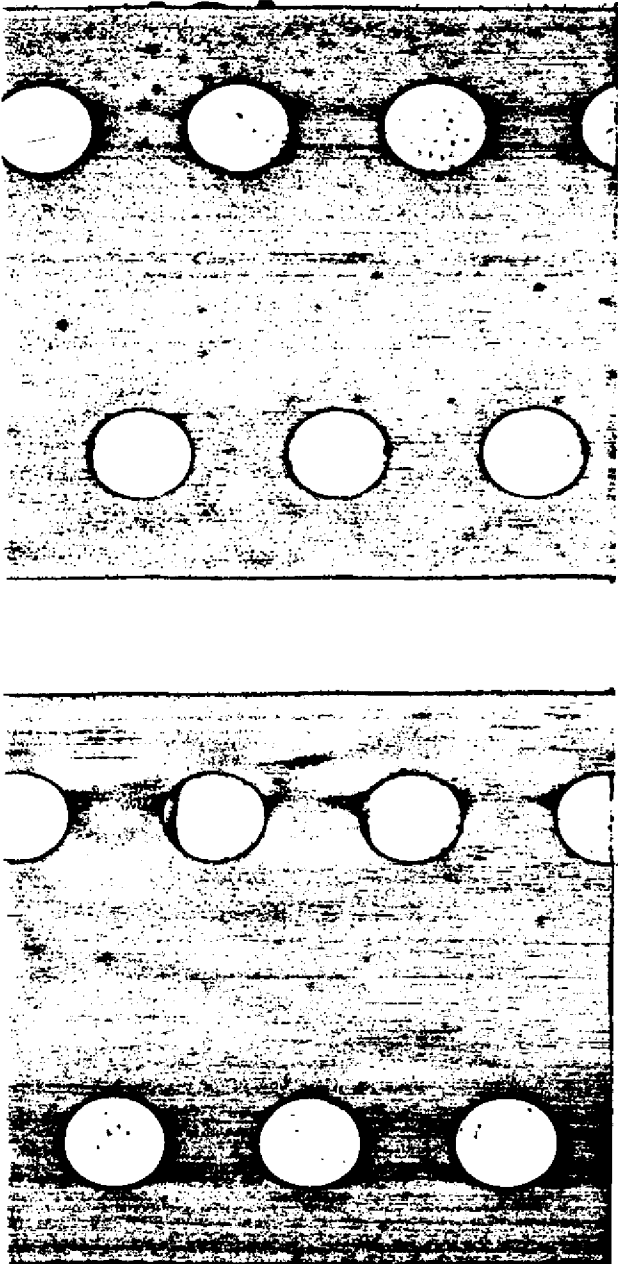


3-10 Photograph taken of the abandoned ventilating fan with opening through to the roof. Left rear and center background shows the manner in which this area was completely enclosed by drop cloths and blankets hung ostensibly to prevent splattering of paint into the cell block.

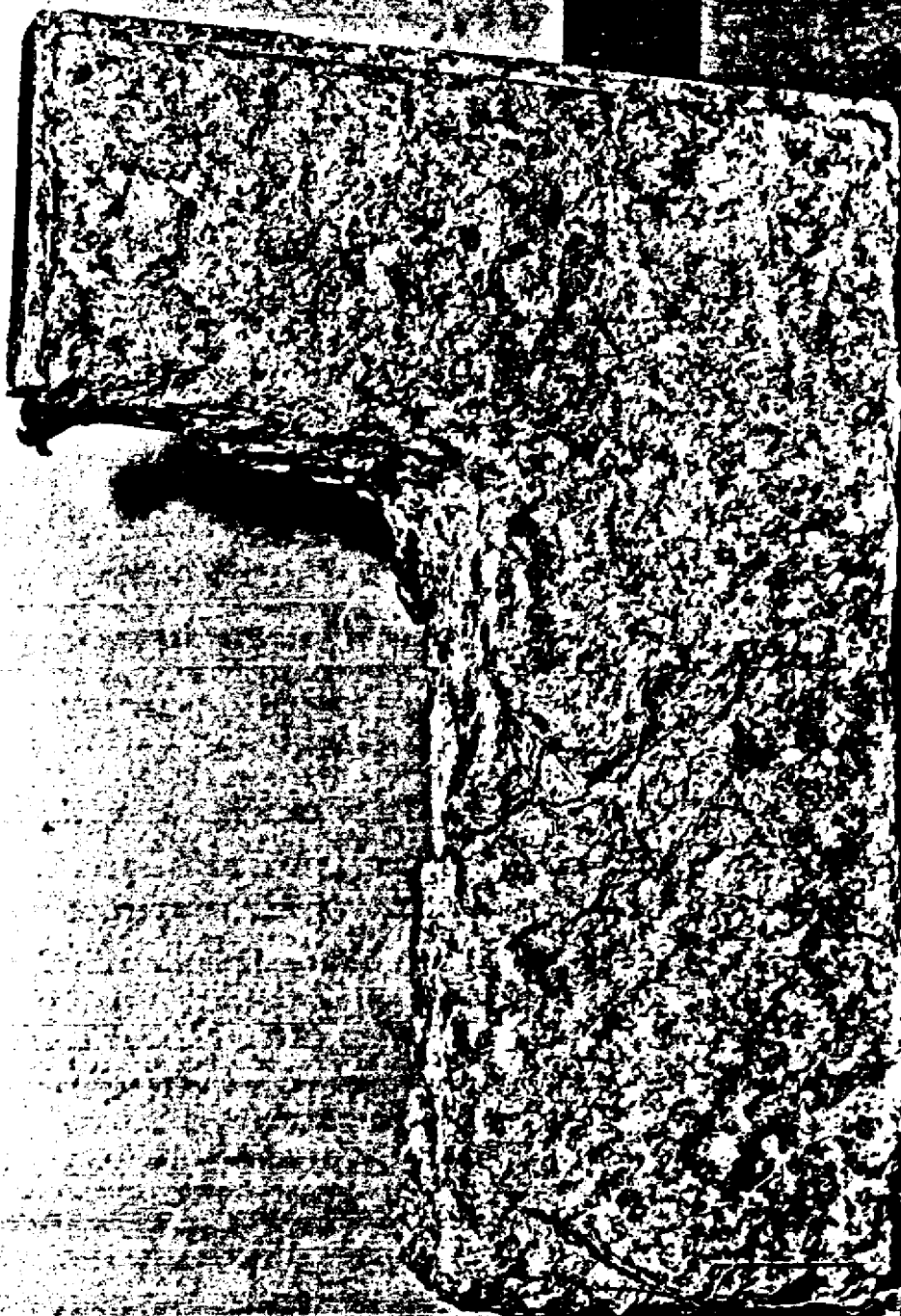
It was in this ventilator that the abandoned pantoon and two bundles of raincoats were located. Articles at the bottom of this ventilator could be reached by a long pole which had a nail protruding and could be used as a hook.

3-11 A general view looking toward the end of Cell Block B. The portion of the blanketed grill wall seen across the upper portion of the picture was across the end of the cell block. Approximately directly opposite the large black cast iron vent seen in upper right and down on the main floor was the main entrance to the entire cell area. The blanketed or screened-in area covered an area approximately thirty to thirty-five feet in length from the end of the cell block and extending on both sides, giving perfect concealment.

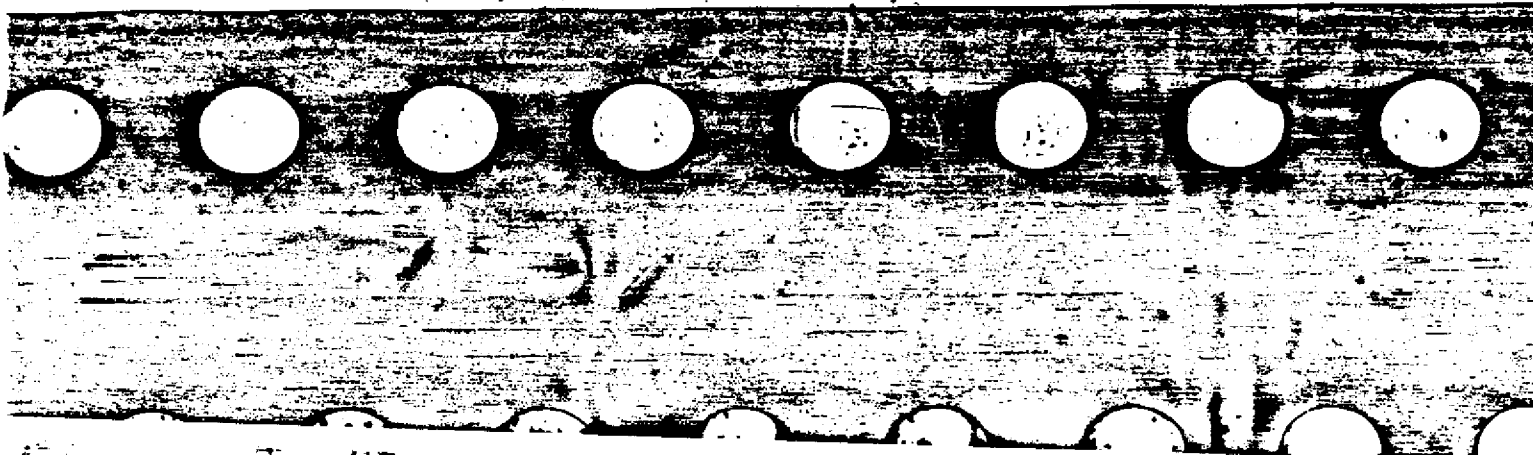
At lower right center may be seen a white cord which was tied to the hot water pipe crossing between Cell Block B and C and was one inch in diameter. This cord was lowered down the utility shaft and upon reaching the bottom, which was directly behind Subject's cells, it was determined to be twenty-six feet ten inches. Sections of this cord were knotted at intervals which apparently indicated the tier level reached when lowering or raising the rope. Fragments of raincoat material may be observed in general debris in center of picture. The five-gallon paint bucket from which a stick is seen protruding contained hardened cement paint and it was in this bucket a number of the Subjects' tools were subsequently located.

The heavy plank extending across the chair may have been used as the weight necessary when "vulcanizing" the seams on the raft and "Mae West" jacket.

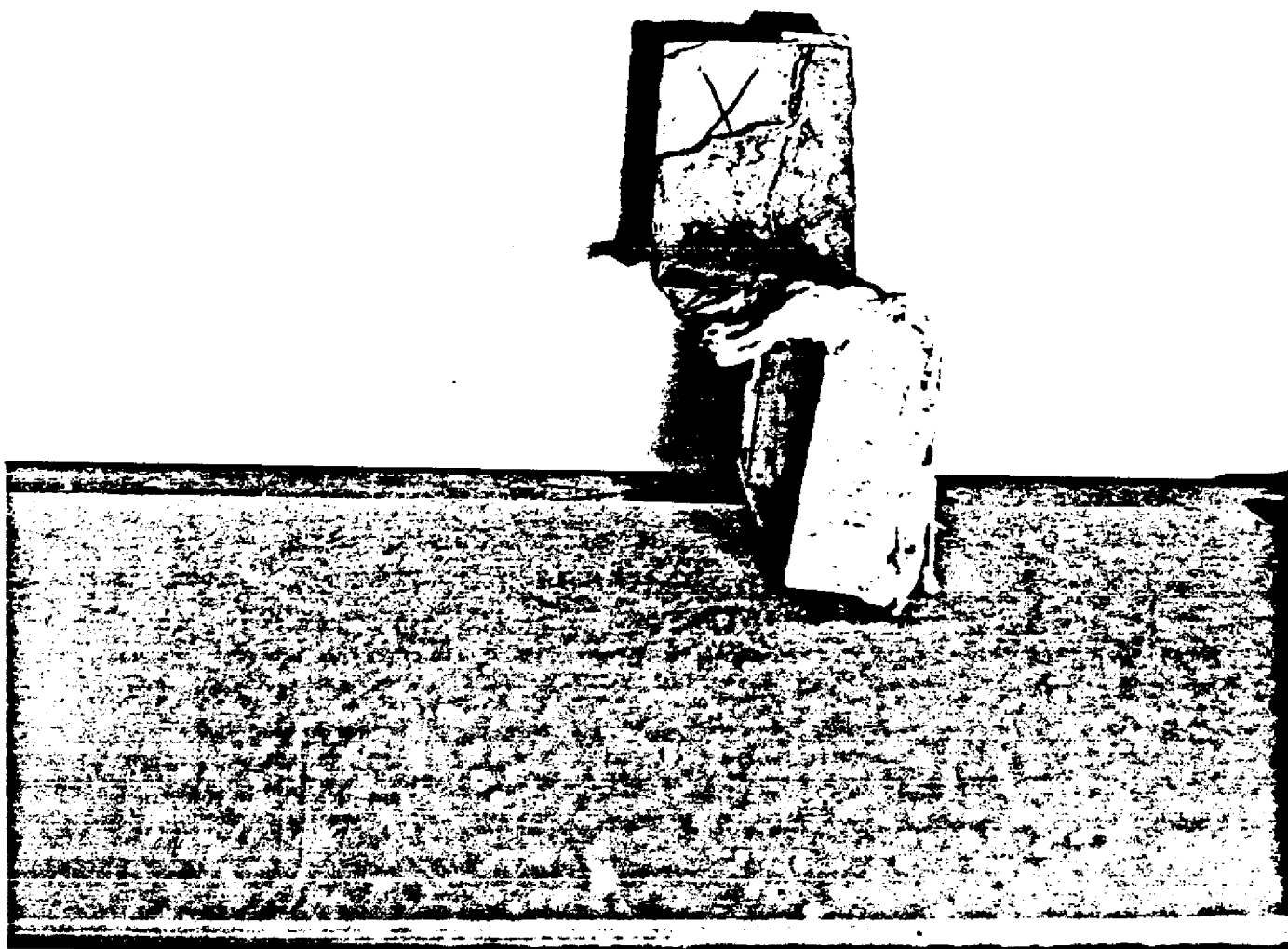


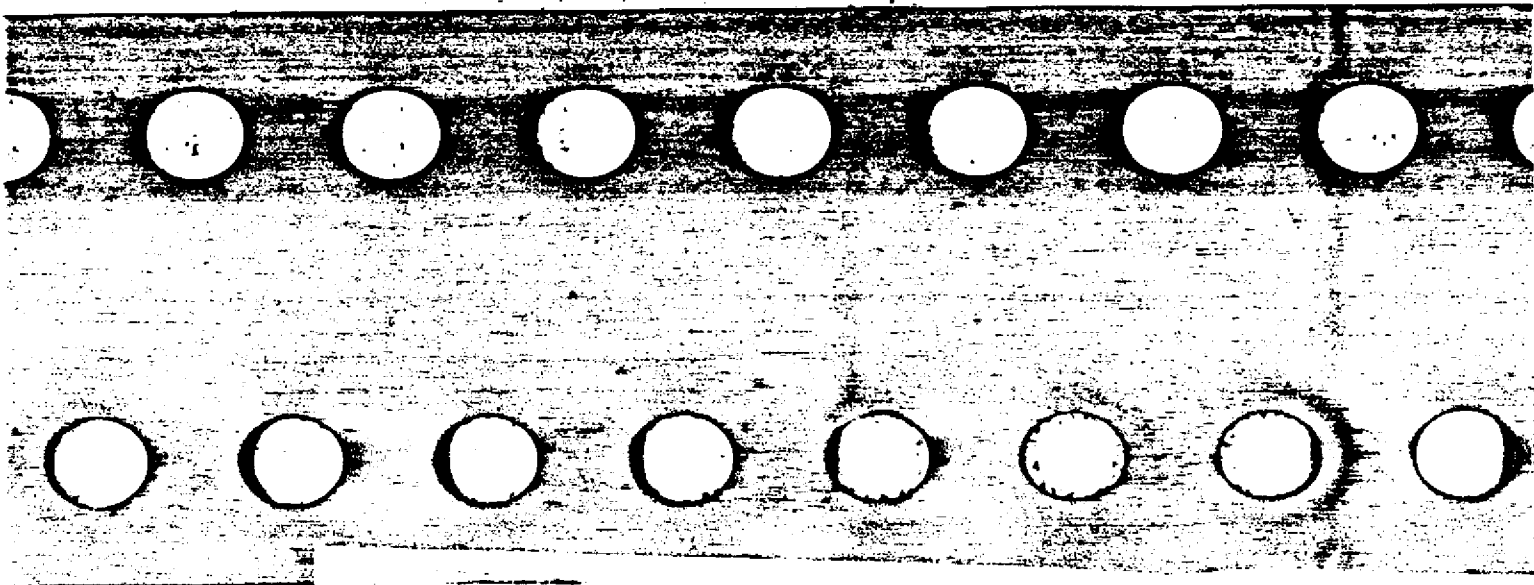


3-12 General view taken approximately fifteen feet from the bucket seen in center foreground. Lower left center are pieces of white Navy blanket cut in strips. The material seen at lower right is a type believed to have been used in making the raft. The goosenecked connector from the ventilating motor to the roof is seen in upper right. On the chair may be seen the remains of some brass bolts which were either machine or electrical bolts and brass washers and nuts identical to those found in the paddle.

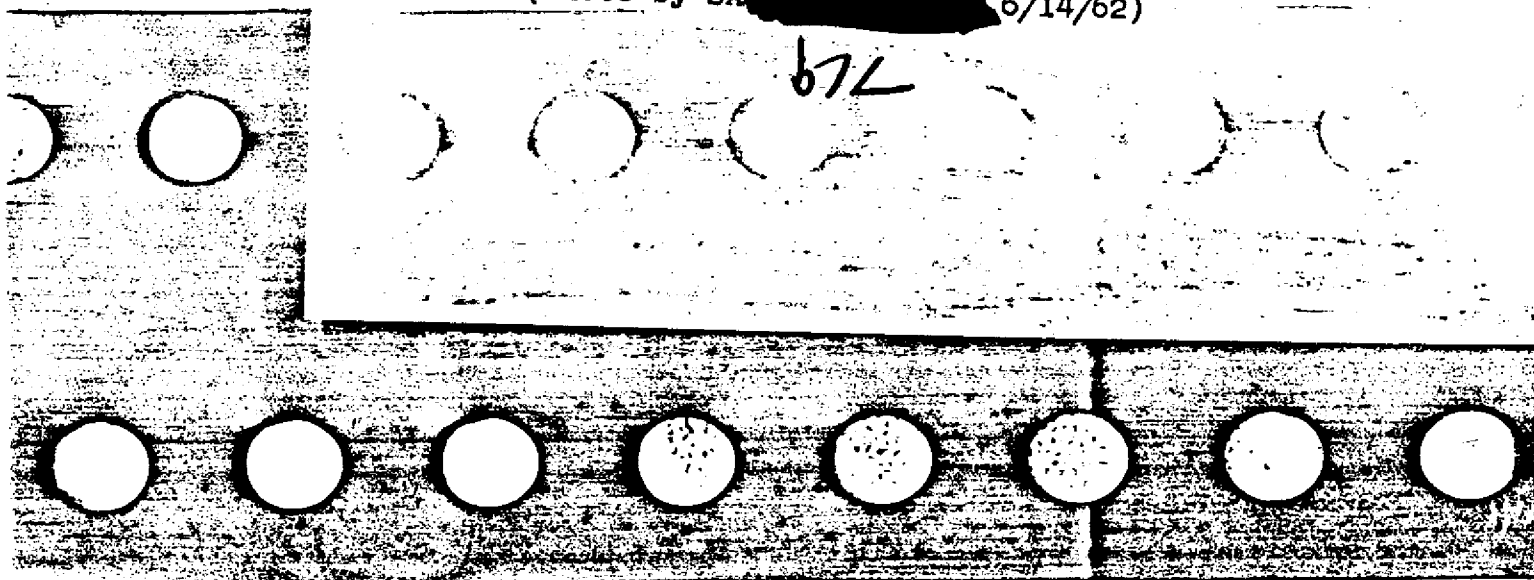


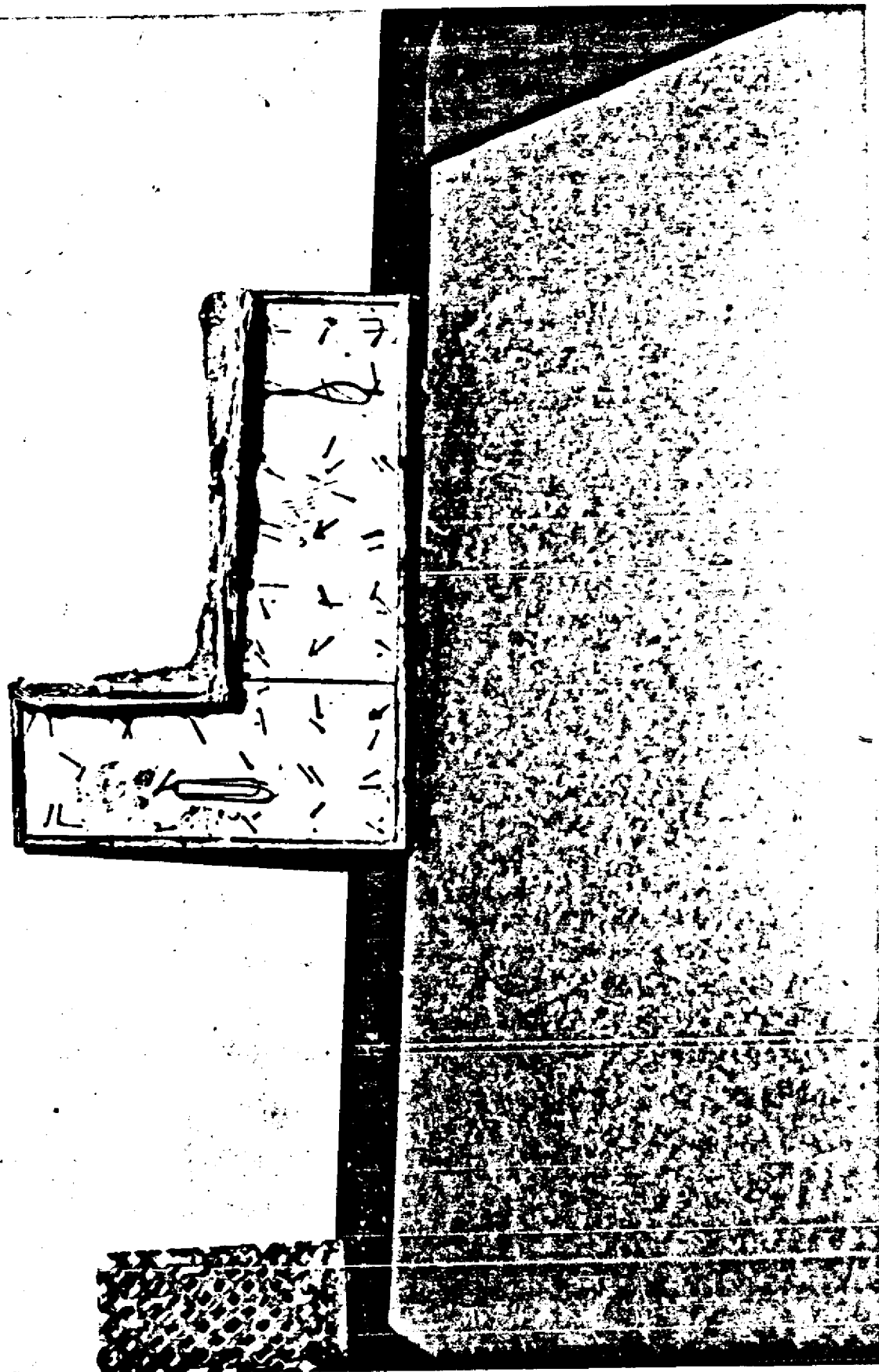


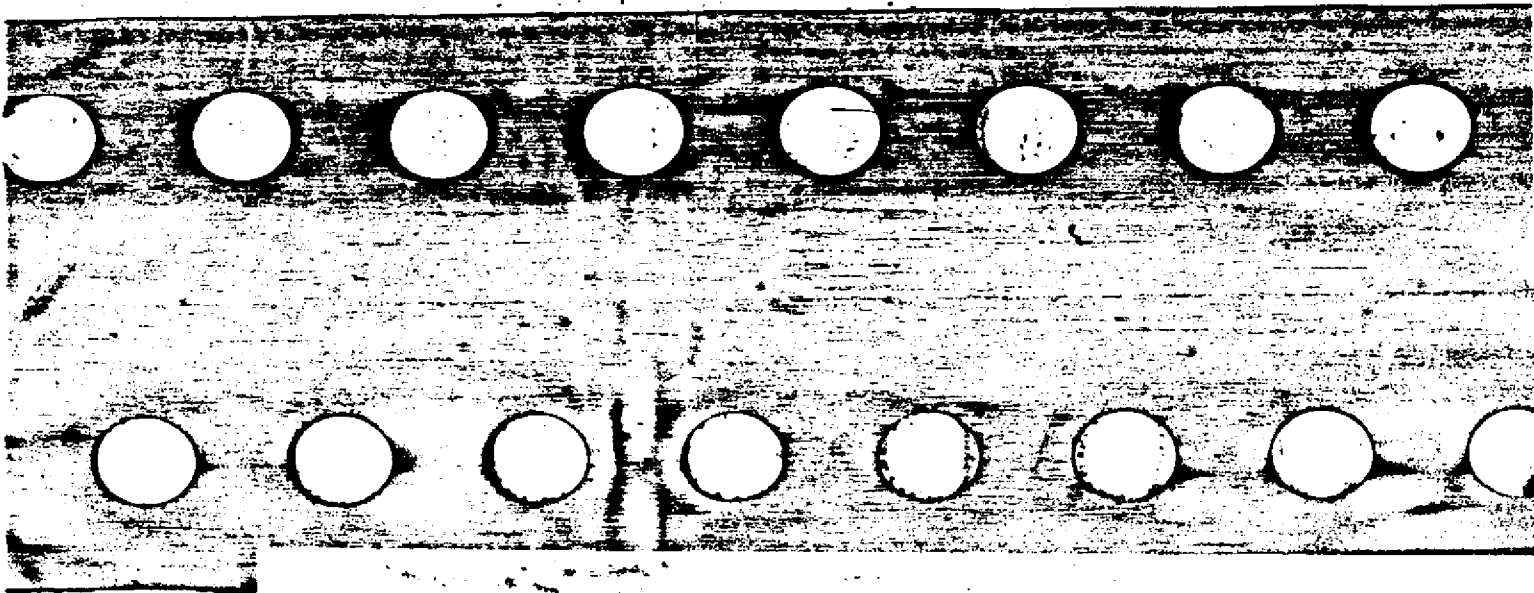
Side view of concrete replica.

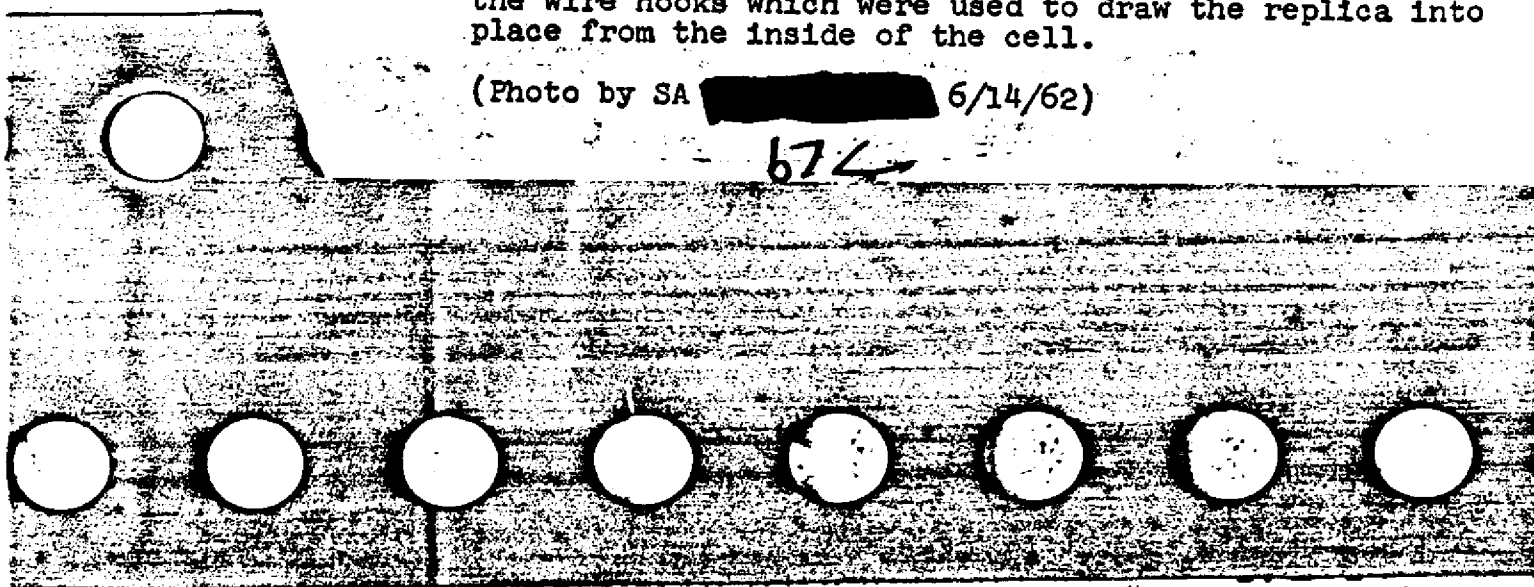




Rear view of concrete replica showing hard board. Note the wire hooks which were used to draw the replica into place from the inside of the cell.

Close-up view of "yoke type" or "Mae West" life preserver showing the seam which appears to be sealed by a vulcanization type treatment, achieved by the application of heat and pressure. The heat was readily available through an exposed 1" copper hot water pipe approximately four feet long which crossed from cell block B to cell block A and was located over the top of the third tier of cells and crossed the utility well. The pressure was readily available through the use of a large heavy section of planking located in this area.
