**BACKGROUND**

In connection with the Alcatraz escapees, Warden Olin D. Blackwell, U. S. Penitentiary, Alcatraz, has advised two guards, [REDACTED] and [REDACTED] have received 20 days suspension each. These guards had conducted prisoner counts on the night shift at Alcatraz and had apparently counted the subjects present based on the presence of the dummies in bed instead of the escapees. Inmates [REDACTED] and [REDACTED] who were in on original escape plan but remained behind, had access to area where additional tools found.

Warden OLIN D. BLACKWELL, USP, Alcatraz, advised that Guards [redacted] and [redacted] had received twenty working days suspension. These guards had over the past few months conducted prisoner counts on the night shifts at Alcatraz, and on the night of the escape evidently counted the dummies in bed instead of the escapees. Apparently they had done so upon several occasions due to the extensive work conducted by escapees outside of their cells.

The press in the San Francisco Bay area through some means learned of the suspension, and BLACKWELL, upon the instructions of the Director of the Bureau of Prisons, JAMES BENNETT, verified same to the press. However, BLACKWELL has steadfastly refused to identify the personnel disciplined, and their names as yet have not been in the local press.

Upon checking material stored in the paint room in "A" cell block at the USP, Alcatraz, Calif., a prison officer, [redacted] noted a five gallon can of white cement paint. He took the lid off the can and noticed that the paint was solidified, evidently due to someone placing water therein. He cracked the cement and upon doing so found the following items inside the cement:

7 spoon handles

9 pieces of heavy metal ranging from 2" to 12" in length, similar to the framework of the ventilator grills in the back of the inmate's cells.

4 pieces of heavy wire similar to that of the ventilator grills.

2 pieces of miscellaneous metal from 5" to 7" long.

1 Three-eighths inch screw bolt about 4" long.

He said that subject, [REDACTED] had been on the paint crew and would have had access to the paint room. In addition subject [REDACTED] as an inmate plumber in the main cell block, would also have had access to the paint boom. b7c

"A" cell block has not been used for housing prisoners since 1952 because of lack of plumbing and security grill work. The portion of "A" cell block housing the paint room is enclosed and locked off from the other cell blocks.

Continued contact throughout the country of former inmates, associates and relatives of subjects, as well as of certain Alcatraz inmates, has failed to locate anyone who has been contacted by the escapees since they left Alcatraz.

ESCAPEES AT LARGE ARE ALL CONVICTED BANK ROBBERS AND SHOULD BE CONSIDERED EXTREMELY DANGEROUS.

JOHN WILLIAM ANGLIN and CLARENCE ANGLIN transferred to Alcatraz from USP, Leavenworth, Mo., 10/22/60 and 1/14/61 respectively. Data concerning attempted escape by the ANGLINs at USP, Leavenworth, 8/60 set out. Details concerning another alleged escape attempt in which the ANGLINs involved at USP, Leavenworth set forth. All inmates involved in this incident interviewed. MORRIS resided KCMO late 1955 and was subject of UFAC and BE investigations conducted by Kansas City Office. Known acquaintances and associates of MORRIS at Kansas City during this period interviewed and state they have no knowledge concerning escape. [REDACTED] b7c

DETAILS:

The following investigation was conducted on June 12, 1962, by SA [REDACTED] at Leavenworth, Kansas: b7c

Records U. S. Penitentiary, Leavenworth, reflect CLARENCE ANGLIN, #75456-L, transferred from Leavenworth to Alcatraz January 14, 1961; JOHN WILLIAM ANGLIN, #77350-L, transferred Leavenworth to Alcatraz October 22, 1960. The files of these men accompanied them to Alcatraz. No record for MORRIS ever having been an inmate U. S. Penitentiary, Leavenworth.

On August 8, 1960, CLARENCE ANGLIN, inmate, U. S. Penitentiary, Leavenworth, attempted an escape by concealing self in metal bread boxes which were to be transported to the U. S. Penitentiary Leavenworth Honor Farm. Holes were cut in top of bottom box and bottom of top box connecting the two boxes. JOHN WILLIAM ANGLIN, brother of CLARENCE ANGLIN, believed to have assisted in escape attempt as he worked in the bakery section with his brother, and was observed pushing the bread boxes onto the elevator. U. S. Penitentiary employee, a bakery steward, detected movement between the boxes and discovered CLARENCE ANGLIN concealed inside and found to possess an improvised knife and an iron bar but offered no resistance when captured. CLARENCE ANGLIN admits he cut the boxes and concealed self, refused to implicate his brother or to admit escape attempt. JOHN WILLIAM ANGLIN denies any knowledge of brother's escape attempt. Prison officials state CLARENCE ANGLIN could have made escape possible if boxes had been put on the Honor Farm truck. Both subjects were sentenced February 10, 1958, at Montgomery, Alabama, for bank robbery, CLARENCE ANGLIN receiving 15 years and JOHN WILLIAM ANGLIN receiving 10 years.

On December 19, 1960, CLARENCE ANGLIN entered plea of guilty, U. S. District Court, Leavenworth, to offense of attempting to escape from U. S. Penitentiary, Leavenworth, and received a two-year sentence to run consecutively to sentence he is now serving. Assistant U. S. Attorney, Topeka, Kansas, declined prosecution on JOHN WILLIAM ANGLIN.

Subject FRANK LEE MORRIS was the subject of a previous investigation conducted by the Kansas City Office involving the burglary of the Bank of Slidell, Slidell, Louisiana, November 25, 1955. Also involved in this investigation were [REDACTED] b7c

[REDACTED] advised that in [REDACTED] he became involved with MORRIS [REDACTED] b7c b7D

[REDACTED] and that he could furnish no information as to their backgrounds. [REDACTED] stated the ANGLIN brothers were unknown to him. He said he has received no information from MORRIS since [REDACTED]. The provisions of the Harboring Statute were carefully explained to [REDACTED] b7c

[REDACTED] He stated the ANGLINs were unknown to him but he recalled MORRIS as an individual involved with [REDACTED] in 1955 as mentioned above. [REDACTED] said he had no knowledge of MORRIS or the ANGLINs attempting to contact [REDACTED] at Kansas City. He said he would remain alert for such information and advise the FBI in the event he learns of information concerning escapees.

On June 14, 1962, the San Francisco Office advised that [REDACTED] mentioned above, was reportedly confined at the Federal Penitentiary, Springfield, Missouri. b7c

On June 13, 1962, the San Francisco Office advised that records at Alcatraz reflect a notation made by prison officials U. S. Penitentiary, Leavenworth, to the effect that CLARENCE ANGLIN was one of a group of inmates at Leavenworth

who were plotting with a released inmate who was to furnish them with weapons for an escape attempt. Alcatraz records indicate this information was furnished to the U. S. Penitentiary, Leavenworth, Kansas, by the FBI, Kansas City.

Kansas City files indicate that one [REDACTED] was interviewed May 16, 1960, at [REDACTED]

[REDACTED] outlined an involved escape plan which he said existed at the U. S. Penitentiary, Leavenworth, [REDACTED]. Involved in this plan were [REDACTED] CLARENCE ANGLIN, JOHN ANGLIN, [REDACTED]

[REDACTED] claimed the break was planned for the latter part of July 1960.

[REDACTED] stated it developed that [REDACTED] and [REDACTED] then contacted CLARENCE ANGLIN, his brother JOHN ANGLIN, both serving bank robbery sentences, [REDACTED] and planned to escape.

AT LEAVENWORTH, KANSAS.

The following inmates of the U. S. Penitentiary were interviewed on June 18, 1962.

[REDACTED] advised he has been an inmate of this institution for a number of years and was previously confined to Alcatraz. He stated that in the past years, he has heard numerous inmates of both Leavenworth and Alcatraz discuss the possibility of escaping from Alcatraz. He stated almost without exception all the inmates he had talked to are in agreement that it is virtually impossible for an inmate to escape from Alcatraz unless he has some outside help, who could pick up the inmate on shore or in the water near the Alcatraz shore. He stated the water that surrounds Alcatraz is extremely dangerous and that he had personally tested the current which is extremely fast. [REDACTED] stated he had known the ANGLIN Brothers, but he had not been closely associated with them and was in no way involved in any escape plan that they had considered in past years. He stated that if he was planning an escape he would confide in no one else and this has been his policy over the years in his criminal activities. He stated he had not known the ANGLIN brothers well enough to have discussed any escape plan with them if he had wanted to. He stated he has heard no reports of any escape plan by the ANGLINs while they were at the U. S. Penitentiary, Leavenworth, although they had attempted to escape from this institution. He stated he did not know who had been closely associated with the ANGLIN brothers at Leavenworth or Alcatraz. b7c b7D

[REDACTED] advised he has been assigned to the hospital at this institution for several years and that he had not been acquainted with the ANGLIN brothers when they were at U. S. Penitentiary, Leavenworth. He stated he did not recognize their photograph when it appeared in the paper following the escape from Alcatraz and did not know where they were assigned when at Leavenworth. b7c b7D

He stated that at the time the ANGLIN brothers reportedly attempted to escape by one of the brothers being concealed in a bread box, [REDACTED] b7C b7D

[REDACTED] He said he did not know of the plan of the ANGLINs to escape until after the attempt to escape occurred. He stated that he was not acquainted with the associates of the ANGLIN brothers while at this institution and had heard no reports regarding their activities since leaving. b7C b7D

[REDACTED] advised that he had been assigned to the kitchen at U. S. Penitentiary, Leavenworth during periods that both the ANGLIN brothers worked in the kitchen. He stated that he had worked side-by-side with CLARENCE ANGLIN but that CLARENCE had not confided in him and he had had little or no contact with JOHN ANGLIN. He stated he had left the kitchen and had been employed in the shoe factory prior to the time that the ANGLINs were transferred from Leavenworth. He stated it was his impression that the ANGLIN brothers were known as "loners" while at this institution meaning that they did not associate with other inmates to any great extent. He stated he had heard no reports and had no personal knowledge of any escape plan that the ANGLINs might have been involved in while at Leavenworth. He stated he had not heard any comments regarding their activities since transferred from Leavenworth.

[REDACTED] advised that he arrived at Fort Leavenworth for commitment here on the same date that JOHN ANGLIN was committed. He stated that he, [REDACTED] was very much confused as to his future when he first arrived at this institution b7C b7D

[REDACTED] He stated the possibility of escaping is constant conversation among the inmates. He further stated that after he had been here a short time, he had made up his mind that the only thing for him to do was to serve his prison term, make the best record he could and become rehabilitated as quickly as possible. [REDACTED]

[REDACTED] He stated he may have mentioned this to JOHN ANGLIN but he could not be certain. He stated that neither of the ANGLIN brothers had confided in him any plan for their escape and he had not heard of the plan for their escape.

As the time JOHN ANGLIN concealed himself in a bread box which was being sent out of the institution, he stated he had worked with JOHN ANGLIN for about two months in the laundry and thereafter worked with him in the kitchen. He stated he had been rather close to JOHN ANGLIN and JOHN ANGLIN had let the inmates around him know that he would escape if he had the opportunity but that he had never discussed any definite plan for escape to his knowledge. He stated he was under the impression that CLARENCE ANGLIN is the leader and that JOHN ANGLIN will follow plans formulated by CLARENCE ANGLIN. He did not believe either of the ANGLINs were dangerous, but merely adventuresome. He stated he does not recall the identity of any other close associates of JOHN or CLARENCE ANGLIN, who usually stayed much to themselves while in the recreation areas. He recalled that JOHN ANGLIN was one of those participating in the weight lifting program and that he was alone in that particular area of the recreation grounds during his leisure hours. [redacted] stated that the ANGLIN brothers do not know the identity or whereabouts of his immediate family and does not believe any of his relatives would be contacted if the ANGLINs were successful in their escape attempt and were seeking help.

[redacted] reported that he and CLARENCE ANGLIN had celled together at this institution for about three months between December 1958 and February 1960. He stated that he had worked in the kitchen with CLARENCE ANGLIN and they were so assigned at the time of CLARENCE ANGLIN's transfer. He stated he was only slightly acquainted with JOHN ANGLIN as he was an individual who was hard to get acquainted with. He stated he and CLARENCE ANGLIN associated together in the recreation area and particularly in the area of the baseball yard where CLARENCE ANGLIN was one of the star players. He stated JOHN ANGLIN was a weight lifter and was usually alone in that particular area of the recreation area. [redacted] stated that CLARENCE and JOHN ANGLIN had never mentioned any escape plan that they might have had and he had not known in advance of their attempt to escape at the time JOHN ANGLIN concealed himself in the bread box within the walls of this institution but was detected prior to his leaving the prison walls. He stated that [redacted] was the only other person he recalls who was closely associated with either CLARENCE or

JOHN ANGLIN. [REDACTED] stated that the ANGLIN brothers could not have been well acquainted with [REDACTED] who was an inmate at this institution for only a period of nine days after the ANGLIN brothers were committed. He stated that he is certain that [REDACTED] had not become involved in any activities involving the ANGLIN brothers as he is extremely devoted to his present wife and would not want to be involved in anything that would affect this relationship. b7c b7D

[REDACTED] advised that he was not personally acquainted with the ANGLINs, had never worked with them in the institution and had not known of any escape plan that they might have been involved in. He stated that if he had had any knowledge of any escape plan or had any knowledge at this time of the activities of the ANGLIN brothers, he would not disclose same. b7c b7D

All of the above inmates were interviewed to determine if the ANGLIN brothers were acquainted with any relatives or the addresses of any of these inmates' relatives. They all denied that the ANGLIN brothers had such information.

[REDACTED] stated he has not associated with any criminals or with any of the former inmates of the U. S. Penitentiary, Leavenworth, since his release. [REDACTED] said that in about January 1960, he was in a group of five or six inmates of the U. S. Penitentiary, Leavenworth, who were plotting a break. He said the group, to his recollection, included JOHN and CLARENCE ANGLIN, [REDACTED] b7c b7D

[REDACTED] stated that many of the inmates talk about escape and many have vague plans for this. He said these plans are constantly undergoing change and modification. He said it is possible that the ANGLIMS and the others in his group had had a member named [REDACTED] at one time, but that was before he was a member of the group. [REDACTED] said he did not recall the inmate named [REDACTED] who was supposed to be a member of the group.

[REDACTED] said [REDACTED] has been living with him since his release and that he was confident [REDACTED] had not been in contact with the ANGLINS or MORRIS. He said he never heard [REDACTED] speak of the ANGLINS, and he is reasonably sure [REDACTED] received no correspondence from them. [REDACTED] said [REDACTED] mentality was not too great, and he personally doubts that the ANGLINS or any other escaped federal prisoners would conspire with, or later contact, [REDACTED]

Numerous searches were conducted during this investigation, each with negative results as to the location of the Escapees. These searches are summarized as follows:

SEARCHES BY WATER AND AIR

**b7c**  
[REDACTED] U. S. Coast Guard, Captain of the Port of San Francisco, arranged to have two 40-foot boats patrol the San Francisco Bay 24 hours a day, searching for any evidence relating to this matter and beginning on June 12, 1962. The area most frequently searched included the San Francisco piers and yacht harbor, the areas surrounding Alcatraz Island, Angel Island (about one mile north of Alcatraz), and the Marin County coastline from Belvedere to the Golden Gate.

[REDACTED] also arranged for a Coast Guard helicopter to be used in this search with Special Agents riding as observers. The helicopter was used daily from June 12 through 22, 1962, covering both the San Francisco Bay and the ocean front beaches approximately 20 miles north and south of the Golden Gate Bridge. Particular attention was paid to coves and ravines along the coast.

Special Agents of the FBI, using small boats, also patrolled the Marin County Bay shoreline on June 12 and 13, 1962, from Point Belvedere to the Golden Gate.

Special Agents of the FBI and Deputy Sheriffs of Marin County conducted aerial searches of the Marin County Bay coastline from San Quentin to Golden Gate Bridge, the San Francisco waterfront, the Point Richmond area, and the vicinity of Alcatraz and Angel Island on June 12, 1962, in a Piper Cub and a Stinson airplane.

FORT CRONKHITE BEACH

A thorough search of the Fort Cronkhite and Kirby Beaches was made by Special Agents of the FBI on June 15-17, 1962, immediately following the recovery of the first life preserver in that area on June 15, 1962.

Detachment, San Francisco Presidio, arranged for patrol of the Fort Cronkhite and Kirby Beach areas during the evening of June 15, 1962, and during the daylight hours of June 16, 17, 1962. #### GOLDEN GATE BRIDGE

Special Agents of the FBI conducted a visual search of the San Francisco coastline from the Golden Gate Bridge encompassing the shore from Old Fort Point to the east end of the San Francisco Yacht Club on June 13, 14, 1962.

#### ANGEL ISLAND

Angel Island is located in San Francisco Bay about one and one-quarter miles north of Alcatraz Island, between Alcatraz and the Marin County Bay shoreline. It is rugged terrain, parts of which are 750 feet above the water. Only a small part of this island is used as a picnic area and is maintained by the California State Park Service. b7c

[REDACTED], 561st M. P. Detachment, San Francisco Presidio, led a detachment of 35 Military Police and soldiers in a search of Angel Island on June 12, 1962. A small group of Military Police was left on this island overnight. On the following day, [REDACTED] made available 134 soldiers who worked with Special Agents of the FBI in a massive detailed search of Angel Island, including more than 100 deserted buildings. Coupled with this search was a search by Special Agents in small boats of the Angel Island beaches, some of which were inaccessible from the ground. No evidence was found to indicate the Escapees ever reached this island.

#### DEBRIS BOATS

When this investigation was instituted on June 12, 1962, it was arranged that the U. S. Army Corps of Engineers debris boats, which constantly sweep the Bay of flotsam, would report any suspicious objects retrieved. On June 14, 1962, one of these boats picked up two olive drab wallet type packets from a whirlpool approximately one-half mile east of Alcatraz Island

at a depth of two-three feet below the surface of the water. These packets contained pictures of JOHN and CLARENCE ANGLIN, among others, as well as names and addresses of numerous individuals. The details concerning this recovery have previously been reported.

#### MARIN COUNTY COASTLINE

Special Agents of the FBI, using eight power cruisers, searched the Marin County Bay coastline from Point Belvedere to the Golden Gate Bridge and the area surrounding Angel Island on June 12, 1962. Other Special Agents contacted boat owners operating in this area, as well as persons working on the shoreline the same day. Searches of this area by Special Agents continued daily through June 22, 1962.

#### NEIGHBORHOOD

Persons living on the Marin County Bay coast facing Angel Island and Alcatraz who lived in homes with a view of the water were interviewed June 14, 1962, by Special Agents. This encompassed the shoreline from the north end of Tiburon to the southwestern end of Sausalito.

#### ALCATRAZ ISLAND

Beginning on the morning of June 12, 1962, Warden OLIN G. BLACKWELL had his guards check all of Alcatraz Island, including all buildings and personal contact with the families of all prison employees and a search of their homes for the Escapees. In addition, prison guards were designated around the shore areas of the island to patrol the beach. The prison boat, together with guards in skin diving equipment, checked the beaches and water surrounding the island, as well as the numerous caves. These searches continued through June 17, 1962.

In addition, through the use of telescopes, prison officials continued to check the riptides, which periodically form in the area of Alcatraz, for floating debris. Through this method they sighted one of the homemade life preservers on June 22, 1962, and recovered same. Warden BLACKWELL advises that they will continue to look for debris possibly connected with the Escapees.

#### TIDES AND CURRENTS

On June 12, 1962, information was received that the tide charts of San Francisco Bay for this date reflected that for the six-hour period prior to 3:00 a.m. the tide would be flowing toward the Golden Gate in a westerly direction, and subsequent to 3:00 a.m. would be flowing towards Berkeley, California, and Richmond, California, in an easterly direction.

On June 12, 1962, the following information was received from the U. S. Engineer's Office at Sausalito, California, where there is a mockup of the Bay:

On June 11, 1962, at 10:00 p.m., there was a slack tide which meant the water was moving in neither direction. Shortly after 10:00 p.m. the water started to flow out of the Bay, reaching its peak velocity at midnight and then tapered off to slack tide again at 4:00 a.m. The speed at midnight was approximately 2.7 knots, while at 10:30 to 11:00 p.m. the speed was about two knots. After 4:00 a.m., the tide started to flow back into the Bay. b7c

[REDACTED] advised that a free floating object entering the water after 10:00 p.m. on June 11, 1962, would flow right out to the ocean under the Golden Gate Bridge. The reaching of Angel Island would be fairly difficult because it would be going in a due northerly direction, cutting across the outgoing tide.

On June 15, 1962, **b7c** Coroner, City and County of San Francisco, advised that there are so many variables which affect the ultimate flotation and travel of a drowned body as to preclude an accurate prediction of what will occur. It has been his experience that the bulk of the bodies recovered have been in the water from one to fourteen days, but on occasions bodies have not been sighted for three weeks. He pointed out that in some of these occasions the bodies may well have been surfaced for some time before they were sighted. **b7c** recalled that on the last escape attempt from Alcatraz the body was not recovered until approximately the thirteenth day.

He stated that there are two principal factors which generally govern the rapidity with which bodies return to the surface. The first factor is that of the water temperature (coldness tends to retard the formation of body gases and thus inhibits its buoyancy). The second factor is that the formation of the body gases themselves are dependent upon the food intake of the victim and of the bacterial content of that food intake. **b7c** also stated that in some instances marine life, such as crabs, occasionally attack the body and puncture the body cavity, thus greatly increasing the time required for the body flotation to occur.

**b7c** also recalled instances wherein Golden Gate suicide leapers have hit the water in such a position and with such force that the body cavity was ruptured. In those instances the body has been carried out to sea without ever returning to the surface.

AT OAKLAND, CALIFORNIA **b7c**

On June 15, 1962, **b7c** Alameda County Deputy Coroner, Oakland, advised that he had found it impossible

to predict when, where or if a drowned body might be expected to surface in San Francisco Bay. [redacted] stated that the under-ground snag factor, i.e., debris, vegetation, rock outcroppings, etc., might well hinder the natural flotation of the body and prevent its resurface for an indefinite period of time. b7c

With respect to the frequency and reliability of guard checks, [redacted] stated that each prisoner had to be in front of his cell door at 6:00 p.m., after the meal hour, when the cell door was locked. At 9:00 or 9:30 p.m. the lights were extinguished and the rule required that thereafter the guards check each cell with a flashlight and observe a form in the cell. [redacted] said that he had quite often read in his bed until 1:30 or 2:00 in the morning and had heard the guards call out a prisoner count to the sergeant of the guard, and [redacted] had never seen the guard come by his cell during the evening. b7C b7D

[redacted] described MORRIS as a quiet individual. In [redacted] opinion, he thought that if the three had had a leader in planning the escape, it would have been the older ANGLIN brother who did the planning.

With respect to the use of raincoats to make a raft, which [redacted] said he had observed in a newspaper account, he said that a lot of the prisoners maintain raincoats in their cells and that it would be a simple matter for one prisoner to obtain a raincoat from another inmate. [REDACTED] stated that prior to the escape from Alcatraz on June 11, 1962, by inmates FRANK MORRIS, JOHN ANGLIN and CLARENCE ANGLIN that the four of them had been working in their cells making a six foot by fourteen foot raft. This raft was being made from inmate raincoats. [REDACTED] recalled piecing together some nine three-foot sections of the raft. He advised that the raft was assembled in the cell of one of the escapees. He volunteered that although it had been assembled, no one had ever tested it to see if it were seaworthy. He said that MORRIS had taken his concertina, which he had changed to resemble a bellows, and that it was to be used for inflating the raft.

[REDACTED] advised that only the four of them were in on the escape. He said he is acquainted with inmates [REDACTED] and [REDACTED]

[REDACTED] but that he had never discussed the escape with them, nor had they assisted in the escape.

At the inception of the interview [REDACTED] was advised that he need not furnish any information and if he did, same could be used against him in a court of law. He was told of his right to consult an attorney.

He voluntarily furnished the following information:

About December of 1961 or February of 1962, inmate [REDACTED] had discussed escaping from Alcatraz. At that time [REDACTED] discussed the possibility of making a raft out of inmate raincoats. [REDACTED] stated that from his discussion of the planned escape with the ANGLIN brothers, FRANK MORRIS, [REDACTED] and [REDACTED] all inmates, there had never been any mention of receiving outside help, and it was his belief that if the ANGLIN brothers and FRANK MORRIS escaped, they did so on their own. He volunteered that [REDACTED] was furious when he heard that the ANGLINS and MORRIS had escaped, as they had deserted him.

[REDACTED] stated that when he decided to quit digging the holes in his cell near the ventilator grill, he camouflaged them by putting soap in the holes, cement and then painting over the area. He assumed that [REDACTED] used the same method in camouflaging the holes in his cell.

About March or April of 1962, he asked [REDACTED] who is inmate [REDACTED] to obtain some cement. Shortly thereafter, [REDACTED] brought him some cement in a George Washington tobacco box. [REDACTED] used this cement to patch the holes in his cell wall. [REDACTED] did not ask [REDACTED] why he wanted the cement, nor did [REDACTED] furnish any reason for wanting same. [REDACTED] did not say where he got the cement; however, [REDACTED] stated that same was available at various places in the Penitentiary due to the work being performed in the various areas by inmates.

[REDACTED] stated that he did not believe that either [REDACTED] or [REDACTED] had been told why they were acting as lookouts for [REDACTED] however, he believed that both of them must have heard [REDACTED] digging in his cell and recognized what he, [REDACTED] was trying to do.

EXAMINATION OF CEMENT-APPEARING SUBSTANCE

AT ALCATRAZ, CALIFORNIA

On June 19, 1962, [REDACTED] United States Penitentiary, Alcatraz, made available material which he had dug out of the holes in the cell wall of inmate [REDACTED]

This material was forwarded to the FBI Laboratory by communication dated June 22, 1962, to ascertain, if possible, the length of time that the cement-appearing substance had been in use.

[REDACTED] United States Penitentiary, Alcatraz, advised that the first time white cement paint was ordered by that institution was on October 10, 1961. He made available a sample of the white cement paint together with a sample of the turquoise prison type paint which is used in the cells.

The foregoing material was forwarded to the FBI Laboratory by communication dated June 25, 1962, for analysis.

By communication dated July 3, 1962, information was received from the FBI Laboratory that the material taken out of the holes in the cell wall of inmate [REDACTED] consisted essentially of small lumps and loose particles of neat Portland cement mixed with small particles of lime mortar, sand grain, small wood particles and paint chips. The Portland cement has had some moisture in it but it was not believed to have had enough moisture to form a slurry. The length of time the cement was in use could not be determined. The white cement paint submitted as a known sample utilized by the Penitentiary was determined to be different from the cement taken from the hole.

The particles of blue-green paint which were in the material obtained from the hole in [REDACTED] cell were found to be similar in color, texture and composition to the blue-green paint submitted as a known sample of the paint used in painting the inmates' cells at Alcatraz. The paint chips obtained from the hole in [REDACTED] cell and paint utilized in painting the inmates' cells could have come from the same source.

MISCELLANEOUS INFORMATION RECEIVED  
ALLEGEDLY REFERRING TO ESCAPEES

On June 15, 1962, information was received from the Portland Office that the [REDACTED] had received a report from a service station operator reflecting that on June 12, 1962, between 4:30 and 5:00 p.m. a 1951 gray Ford bearing unknown California license had entered that service station. The occupants, besides the driver, were a boy of 10 or 12 years of age and two men in the back seat who the station operator believed could have been JOHN ANGLIN and FRANK MORRIS.

The driver of the car presented a Mobilgas credit card bearing the name [REDACTED] Modesto, California. The driver of the vehicle mentioned he was going to Sweet Home, Oregon, and then returning to Modesto, California. This station operator saw the pictures of the Alcatraz Escapees on June 13, 1962, and he believed from the pictures that the two men in the back seat of that vehicle were JOHN ANGLIN and MORRIS.

The following inquiries were made by SA

On June 15, 1962, inquiries through recognized sources at Modesto reflected no information concerning a [REDACTED]. There was no record of [REDACTED] at the [REDACTED] [REDACTED] or through telephone or city directories.
