BOMBING OF ALCOHOLICS ANONYMOUS (AA) FAITH CLUB, 2814 CLOVIS ROAD, LUBBOCK TEXAS MAY 818, 1978 EXPLOSIVES AND INCENDIARY DEVICES

On May 18, 1978, at approximately 1:10 AM, an explosive device was detonated at the Alcoholics Anonymous (A.A.), Faith Club, 2814 Clovis Road, Lubbock, Texas, causing an estimated \$2,500 in damages. No injuries were sustained. Immediate investigation by the Lubbock Police Department and Bureau of Alcohol, Tobacco and Firearms (ATF) failed to develop any logical suspects. Lubbock Police -Department and ATF conducted crime scene and evidence submitted to ATF Laboratory, Atlanta, Georgia.

#### UNKNOWN SUBJECTS; BOMBING OF A.A. FAITH CLUP

Detective Lubbock Police Department

on May 22, 1978, advised in the second standard is unknown to him and to the files of his department. He also said, to his knowledge, there are no Mexican American or other terrorist groups in the Lubbock area.

On June 9, 1978, a report from the ATF Laboratory, revealed exhibits gathered from the scene of the explosion at the A.A. Club revealed residues of common ingredients of commercial dynamite detonated by a safety fuse using a knownelectrical cap.

On June 16, 1978, contact with the Lubbock County Sheriff's Department and Texas Rangers revealed they had no suspects concerning the explosion. Further, they had through their respective investigations, failed to identify any group or for that matter, any terrorist group in the Lubbock area. Ranger and Sheriff Choc Blanchard were, of the opinion, that the explosion at the A.A. Club
