[REDACTED] the well known secret "Conversazione Society" (The Apostles), which he described as an ancient discussion society which was "non-conformist" but not political and was somewhat similar in character to a secret fraternity in the United States. This organization held meetings weekly at which papers were presented and various political and cultural topics were discussed. [REDACTED] said although the society was not political he later learned there were Communist Party (CP) members in the organization such as Guy de Moncy Burgess and Professor Anthony Blunt but pointed out the membership also included many distinguished persons such as [REDACTED] and [REDACTED].

[REDACTED] described Professor Anthony Blunt as a young professor of languages [REDACTED] and stated Blunt was also well known as a confirmed homosexual. [REDACTED] said Blunt resided at Cambridge University and taught the French language. Blunt was even then an expert in the field of fine art and today is regarded as a leading expert in this field. For the past ten years or so Blunt has been Director of the Courtauld Institute, a well known gallery of art founded by Samuel Courtauld. Blunt is also "Keeper of the Queens Pictures," including the Richmond Park Collection and now bears the knighted title Sir Anthony Blunt.

Referring to the unidentified associate of Blunt, [REDACTED] recalled that Blunt had mentioned that his friend was not working in the Government but was working against the Germans. [REDACTED] said he had the feeling that Guy Burgess was the individual associated with or directing Blunt and stated he inquired whether Burgess was this individual. He said Blunt declined to give him a straight answer. ✓

[REDACTED] stated from conversations with [REDACTED] and [REDACTED] both students at Cambridge University, he suspected that Anthony Blunt may have attempted recruitment of these young men for underground work. [REDACTED] stated [REDACTED] was his classmate and close friend, and said [REDACTED] was near collapse as result of his experience with Blunt.

bombed during the war. [redacted] stated he felt this little
trip had no political significance and was possibly a
escapade, since both Slunt and [redacted] were homosexuals.

With further reference to Anthony Blunt, [redacted] advised he understood Blunt had met with Guy Burgess in Moscow during Blunt's visit in the Soviet Union. [redacted] said as far as Burgess was spending the summer in Russia and working on a lecture tour. He did not know whether this stay of Burgess had any intelligence significance. [redacted] said he did not see Blunt or Burgess in Moscow.

S. News Report approximately one month ago concerning the activities of BURGESS and MacLEAN, the two British diplomatic employees who defected to the Russians. The article mentioned contained information that BURGESS' roommate, who first furnished the information to British authorities, telephoned ANTHONY BLUNT reporting BURGESS' disappearance. This telephone call was the first indication of the defection on the part of MacLEAN and BURGESS.

On the morning of March 16, 1956, an article appeared on the editorial page of the Louisville Courier-Journal in Louisville, Kentucky, with a Washington byline written by DREW PEARSON, in which reference is made to a certain book in which was found a letter believed to be a communication between Communist Agents. The letter was recovered in the British Embassy in Cairo, Egypt, and was postmarked from Louisville, Kentucky, dated 1951.

[REDACTED] Since the article pinpoints Louisville as having some connection with the BURGESS-MacLEAN case, he attributed some significance to the fact that [REDACTED] is now in Louisville and that BLUNT is appearing as a lecturer. He had information indicating that either BLUNT or [REDACTED] were involved in espionage activities but believed that the fact of BLUNT's appearance should be brought to the attention of proper authorities.

Louisville has no information concerning the letter mentioned in the DREW PEARSON Column and is furnishing the above for information of the Bureau. No further investigation is being conducted at Louisville.

Coded Letter From Louisville Probe of the British Embassy In Cairo

WASHINGTON—The British Secret Service is investigating the entire British Embassy staff in Cairo, in an effort to track down a Russian agent believed to have been collaborating with one of the two British spies, Donald MacLean, who is now behind the Iron Curtain.

The investigation came about as the result of a coded letter from Louisville that slipped out of a book in the Embassy library. The incident is taken so seriously that American intelligence agents have been brought into the case.

What happened was that the British librarian, a girl, and an American visitor in Cairo discovered the strange letter in a copy of one of Lord Cromer's books. The letter fell out when the book was opened for checking some reference material late last November.

The letter, sent from Louisville, was dated June, 1951, and is believed to have been placed in the book by an agent to be picked up from the book by another agent. The letter read in part:

"As I am writing, the news of Donald's disappearance is coming over the air. . . . He must be given a longer breakdown period in the future. . . . Ten days is a long time to howl. . . . Donald is very cautious about David's replacement chap and hasn't decided what he is like. . . . Am sending over for those who understand Runyonese a lot about guys and dolls. . . . Ever hear about a British consular man named Tyrrell? . . . I

bought two shirts and some towels off him in a Cincinnati store."

American agents believe the letter was a coded message between two Communist agents reporting on MacLean. They also believe there have been serious leaks in the British Embassy.

Every book in the library has now been pulled down and searched to see if any more letters can be found. The F.B.I. has been involved in the check, and efforts have been made to locate the person who mailed the letter from Louisville. This, however, is like looking for a needle in a haystack.
