"The FBI had information from intelligence channels as early as November and December, 1979, that Billy Carter was trying both to negotiate a loan from the Libyans and to arrange for a Libyan crude oil contract on behalf of the Charter Oil Company. However, that information was received, incidential to the conduct of a completely separate FBI investigation and was not furnished as received to the Registration Unit of the Department of Justice until late May, early June, 1980. At that time, it was furnished along, and contemporaneously with the first information available to the FBI that Billy Carter had actually received payments from the Libyans."

Footnote indicates the above paragraph was based on classified information and the details as set forth have been cleared by the FBI.


