This is to advise of the threat to bomb seven unidentified plants in High Point, North Carolina, and the fact the Black Panther Party (BPP) may be implicated. Attached teletype sets forth instructions for Charlotte to conduct investigation concerning black extremist activity in the High Point area.

Anonymous telephone call received 10/12/70 at newspaper office High Point, North Carolina, advising that if two Negroes held on armed robbery charges were not released by 10/14 seven unidentified plants in High Point would be bombed. Two Negro males are in custody at High Point on armed robbery charges and one subject has been identified by informant as BPP member and the other subject a close associate of BPP members.

On 10/14, an anonymous caller, believed to be Negro female, telephoned fire department High Point and caller advised her brother is with BPP and had been refused a job at a local plant. Caller said bomb placed in this plant and set to go off on 10/14. Police located no explosives.

Personnel records reviewed and disclosed [REDACTED] had been refused employment at the plant to be bombed. [REDACTED] originally from Detroit, Michigan. Bureau files disclose [REDACTED] was a member of the BPP in Detroit, but was purged from the organization in August, 1969.

This matter was coordinated with General Investigative Division and no active investigation being conducted regarding bombing matter threats.

## ACTION:

Attached for approval is teletype to Charlotte and Detroit setting forth instructions regarding investigation to be conducted to determine the black extremist activity in the High Point area.

On February 10, 1970, a flier was noted on the door of National Committee to Combat Fascism (NCCF) Headquarters, 1240 East 5th Street, Winston-Salem, North Carolina, indicating a birthday rally would be held for BUEY P. NEWTON on February 10, 1970, at the Tower of Power Auditorium, 15th and English Streets, Winston-Salem, North Carolina.

Among other listed speakers was "Brother VERNARD 'BARTZ' SPEASE," who was listed as the Lieutenant of Education for the NCCF.

[REDACTED] advised that in his speech on February 10, 1970, SPEASE, in essence, advised the government was plotting to weaken black activism by encouraging drug traffic in the Negro neighborhoods. Beyond that, he gave a normal yet rather reserved Black Panther type speech.

On March 26, 1970, [REDACTED] picked a photograph of VERNARD SPEASE and advised that individual had been active around NCCF Headquarters at one time but had not been seen there for several weeks.

On April 21, 1970, [REDACTED] advised that the subject had been a member approximately two months ago, but [REDACTED] could not advise at that time whether or not the subject was still active.

On April 29, 1970, [REDACTED] advised that SPEASE had traveled to the New York City, New York, area to visit relatives and was no longer active with the NCCF in Winston-Salem, North Carolina.

Efforts to locate SPEASE on June 17, 1970, revealed he was visiting relatives "up North" and was not active with the NCCF.

It should be noted that, during the time the subject was away from Winston-Salem, North Carolina, the NCCF underwent a traumatic leadership split and most of the founding group with whom SPEASE was associated left the party.

On September 18 and September 30, 1970, [REDACTED] advised that SPEASE was back in Winston-Salem and had been for several weeks but had not been a member of the NCCF "up North" and did not rejoin the group in Winston-Salem and had no plans to do so.

[REDACTED]

Continuing contacts with local law enforcement organizations indicate SPEASE has not been active with the NCCF since he left that group in the early spring.

A characterization of the Black Panther Party is attached as an appendix to this memorandum.

[REDACTED] has previously advised that the Winston-Salem National Committee to Combat Fascism is recognized as an affiliated branch of the Black Panther Party and under the leadership of the Black Panther Party, Berkeley, California.

BLACK PANTHER PARTY.  
Also Known As  
Black Panther Party for Self-Defense

According to its official newspaper, the Black Panther Party (BPP) was started during December, 1966, in Oakland, California, to organize black people so they can take control of the life, politics and the destiny of the black community. It was organized by Bobby Seale, BPP Chairman, and Huey P. Newton, BPP Minister of Defense. Newton was sentenced in 1968 to serve 2 to 15 years after being convicted of manslaughter in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther," which further describes itself as the "Black Community News Service," states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education, George Mason Murray, which ends with the following:

"Black men! Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black power! Use the gun! Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement "...we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman Mao Tse-tung of the People's Republic of China and feature Mao's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.

Referenced Bureau airtel states that "...The Department, in connection with efforts to develop a prosecutive theory against the BPP for the violation of security statutes, has previously requested this Bureau to develop evidence regarding documents of the BPP which urge its revolutionary doctrines and to also develop evidence showing a cohesion or unity between national headquarters of the BPP and its chapters and affiliates.

"Information regarding the shipment of BPP newspapers and other publications falls within the above categories and it is essential that every effort is made to develop full and complete details concerning such shipments. This should include not only the ascertaining of information contained on shipping papers and invoices but; whenever possible through established sources, the confirmation of exactly what is included in the shipment.

"It is anticipated that in the event of prosecution of the BPP, it may be extremely important to be able to conclusively prove that a specific BPP publication containing revolutionary doctrines was in fact shipped by the BPP to various BPP members and/or supporters. Accordingly, it is essential that this Bureau develop evidence of this nature in order to support possible prosecution of the BPP..."

San Francisco does not desire an answer to this communication. Information that is developed concerning instant shipment should be made a matter of record and included in your next BPP report and/or any other appropriate communication.

For the information of the Bureau and as set forth in referenced airtel and its enclosed LHM, investigation has failed to identify an organization known as the Mothers for Black Liberation or Mothers of Black Liberators. The only times this term has been used have been in connection with the activities of LEE FAY MACK, nee MC DONALD. LEE MC DONALD MACK and LEE FAY MACK are identical, it being noted that under NCDMV regulations a married female's maiden name is used on her drivers license as her middle name and a drivers license would have been necessary in the event LEE FAY MACK rented a car, as indicated, on 9/4/70. Investigation has also determined that she is connected with the Winston-Salem Model Neighborhood Committee, which is connected with the Model Cities Program of the U. S. Dept. of Housing and Urban Development (HUD). LEE FAY MACK has been identified as a member of the National Committee to Combat Fascism (NCCF), a BPP affiliate at Winston-Salem, N. C., and investigation is presently being conducted to determine the source of funds for the Winston-Salem Model Neighborhood Committee, noting both federal and local money may be involved.

In a review of the referenced communications, it is noted [redacted] (NY T-63) reported that [redacted] (phonetic), a BPP member functioning out of Winston-Salem, N. C., had recently traveled to seven cities in North Carolina and two cities in South Carolina in an attempt to create interest in establishing community centers and to raise money for the convention. He had also met with officials in Atlanta and lawyers at Charlotte, N. C. Referenced San Francisco communication sets forth information from [redacted] (NY T-18), on 9/25/70, reflecting a conversation with an unidentified individual speaking with [redacted] temporarily at National Headquarters from New York. This indicates the officials he talked to at Atlanta, Ga., concerned getting a train to take people to the RPOC. The unidentified individual also mentioned stopping in Durham, Fayetteville, Raleigh, Charlotte, and Lumberton, N. C., and possible future donations from CARLYLE MARTY (phonetic) and JAMES ROMNEY (phonetic), at Charlotte, N. C. The unidentified caller was also to attend the staff meeting in New York on 9/26/70, if possible.

Contact numbers 919-725-8772, and 919-723-0055, were given.

Previous information [redacted] has identified CODE as JULIUS WHITE CORNELL, JR., the Defense Captain of the Winston-Salem National Committee to Combat Fascism (NCCF), a BPP affiliated group. It is noted also that on 9/30/70, [redacted] was interviewed concerning his desire to accept induction into the Armed Forces, at which time he furnished the information that [redacted] JULIUS WHITE CORNELL, JR., was a Section Leader in the Winston-Salem NCCF and attended a "staff meeting" over the past weekend in New York. It is noted that this would be the weekend of 9/26-27/70.

A review of the Charlotte Indices and information concerning Black Nationalists and security matters, fails to identify a CARLYLE MARTY; however, JAMES ROMNEY may possibly be identical with JAMES MILTON RUNLEY, [redacted]

[REDACTED] approximately 30 individuals from Winston-Salem attended the Revolutionary Peoples Constitutional Convention which started September 5, 1970, in Philadelphia, Pennsylvania. Among these were J. US CORNELL, JR., JAMES FORD, JAMES CATO, LARRY LITTLE and WILLIAM GARY along with LEE FAY MACK, her daughters RUTH and HAZEL MACK and her mother HAZEL LEE MACK. The group departed Winston-Salem on the night of September 4-5, 1970, in a van type truck rented by JULIUS CORNELL, a Ford Torino, rented by LEE FAY MACK and a station wagon (Ford) rented by JULIUS CORNELL. [REDACTED] money which was all used in view of the fact the group left September 4, 1970, and returned on September 8, 1970. They stayed at a church on 7th Avenue near Temple University. In addition to the individuals named as attending, [REDACTED] advised that the rest of the group was made up of members of the community who reside near the Panther Headquarters.

## THE PEOPLE OF WINSTON-SALEM SEIZE THE TIME TOWARDS A BETTER CONSTITUTION

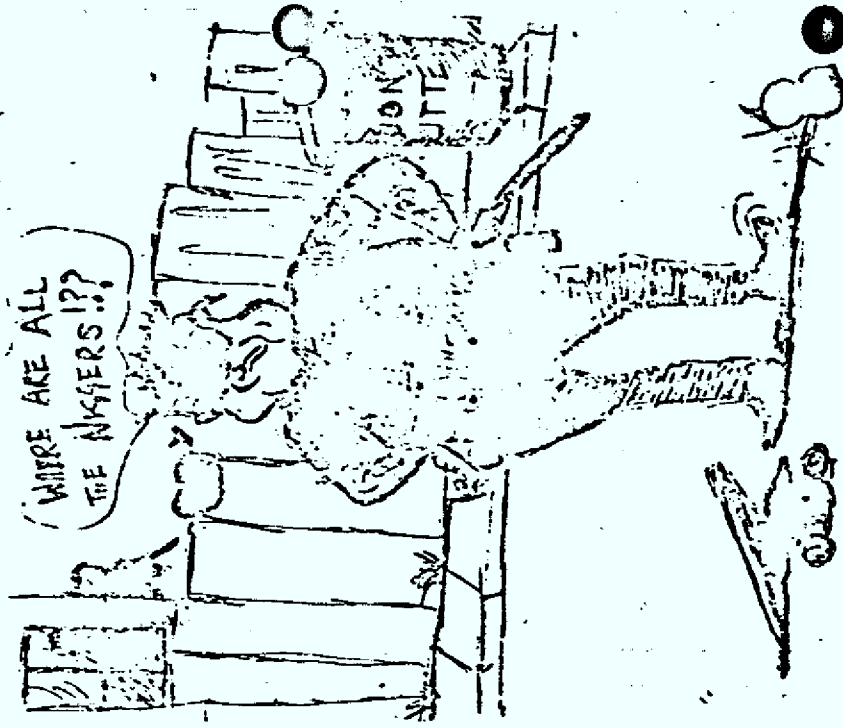
From the very first moment Tucker's Raiders learned that the people of Winston-Salem were going to attend the Revolutionary People's Plenary Session they made an attempt to intimidate. The pigs had informed them bus companies not to charter any buses going to Philadelphia. They feared that when the participating brothers and sisters returned with a higher level of revolutionary consciousness that the people would be even harder to deal with. However, the people of Winston-Salem were confident that they were going to attend at any expense so they traveled on trucks and in cars.

In Philadelphia the brothers and sisters were once again exposed to tactics of the pigs. They saw how Nixon's gasapo forces occupy the community in marked and unmarked cars, plainclothes and

armed to the gills whereas the people attending the Plenary Session were unarmed. They also got a good look at agent provocateurs when several agents tried to get revolutionary minded people to march on City Hall. This is something that Rizzo's blood-thirsty pigs had been waiting for all week. They had hopes of provoking a riot where the unarmed participants of the Plenary Session would suffer heavy losses. The masses were evenhipped to his foul plan. When the pigs learned that they couldn't destroy the Plenary Session they decided to try to hit the bandwagon. In Winston-Salem the press published an article stating that the Panthers and the pigs worked together to make the Plenary Session a success. Even this out-right lie failed because it only exposed the pigs as being fools.

Some of the people from Winston-Salem who attended the Revolutionary People's Plenary have expressed a desire to further educate the masses about their need for a Revolutionary People's Constitutional Convention and the Black Panther Party. The Plenary Session helped the people of Winston-Salem to understand the Black Panther Party's 10 Point Platform and Program better. Especially what Huey P. Newton, the Minister of Defense of the Black Panther Party, ran it down to the masses. The people of Winston-Salem are very proud to have taken part in the making of a new Constitution that would benefit all poor and oppressed people.

BLACK PANTHER PARTY  
Also Known As  
Black Panther Party for Self-Defense

According to its official newspaper, the Black Panther Party (BPP) was started during December, 1966, in Oakland, California, to organize black people so they can take control of the life, politics and the destiny of the black community. It was organized by Bobby Seale BPP Chairman, and Huey P. Newton, BPP Minister of Defense. Newton was sentenced in 1968 to serve 2 to 15 years after being convicted of manslaughter in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther," which further describes itself as the "Black Community News Service," states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education, George Mason Murray, which ends with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement "...we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman Mao Tse-tung of the People's Republic of China and feature Mao's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.

A composite of information from confidential sources and informants of the Charlotte Division [REDACTED] reveals the local chapter of the NCCF (National Committee to Combat Fascism) is barricading its headquarters at 1602 E. 14th St., Winston-Salem, N. C. They have sandbags approximately 2½ feet thick stacked "armpit high" around inside perimeter of first floor. Some windows are boarded up except for what was described as gun ports and all windows are covered with protective-type screen. They have inquired how thick sheet metal must be to stop bullets and apparently plan to cover the inside of the doors with sheet metal. The doors are rigged to be barricaded from the inside if necessary. The NCCF members state they feel a "pig attack" could come at any time.

He noted this letter had been widely distributed in the Negro area but he did not expect any great response. This group has been receiving approximately 2,500 black panther newspapers per week which are sold at \$.25 per copy. All money is returned to Black Panther headquarters

the "Renegade House;" and apparently it is assumed by [REDACTED] that this individual is in sympathy with the renegades. The unnamed individual was not further identified in any manner, nor was the significance of the remark concerning "underground" further clarified.

[REDACTED] added that he is now looking for the renegades. However, he did not further identify the renegades, nor did he indicate why he is looking for them.

In view of the apparent factionalism within the Winston-Salem SPP organization, Charlotte should follow this situation closely, keeping San Francisco and the Bureau advised.

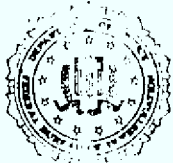

According to its official newspaper, the Black Panther Party (BPP) was started during December, 1966, in Oakland, California, to organize black people so they can take control of the life, politics and the destiny of the black community. It was organized by Bobby Seale, BPP Chairman, and Huey P. Newton, BPP Minister of Defense. Newton was sentenced in 1968 to serve 2 to 15 years after being convicted of manslaughter, in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther," which further describes itself as the "Black Community News Service," states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education George Mason Murray, which ends with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement "We will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman Mao Tse-tung of the People's Republic of China and feature Mao's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.

Referenced Bureau airtel states that "...The Department, in connection with efforts to develop a prosecutive theory against the BPP for the violation of security statutes, has previously requested this Bureau to develop evidence regarding documents of the BPP which urge its revolutionary doctrines and to also develop evidence showing a cohesion or unity between national headquarters of the BPP and its chapters and affiliates.

"Information regarding the shipment of BPP newspapers and other publications falls within the above categories and it is essential that every effort is made to develop full and complete details concerning such shipments. This should include not only the ascertaining of information contained on shipping papers and invoices but; whenever possible through established sources, the confirmation of exactly what is included in the shipment.

"It is anticipated that in the event of prosecution of the BPP, it may be extremely important to be able to conclusively prove that a specific BPP publication containing revolutionary doctrines was in fact shipped by the BPP to various BPP members and/or supporters. Accordingly, it is essential that this Bureau develop evidence of this nature in order to support possible prosecution of the BPP..."

San Francisco does not desire an answer to this communication. Information that is developed concerning instant shipment should be made a matter of record and included in your next BPP report and/or any other appropriate communication.

## II. ACTS IN FURTHERANCE OF THE PROGRAM OR POLICIES

On August 20, 1970, Fire Chief PAUL CRIM, Winston-Salem, North Carolina, advised that early that morning the Police Department Mobile Precinct Trailer located at 1400 Oak Street in the Model Cities area had had a windowglass broken and flammable liquid poured into the trailer. This liquid was ignited and resulted in extensive damage to the trailer.

On August 20, 1970, [REDACTED] Winston-Salem, North Carolina, Police Department, advised that the Police Department Mobile Precinct Trailer, part of the Model Cities Community Services Program, had been heavily damaged and there had been talk in the Negro community for several weeks concerning the possible burning of this trailer.

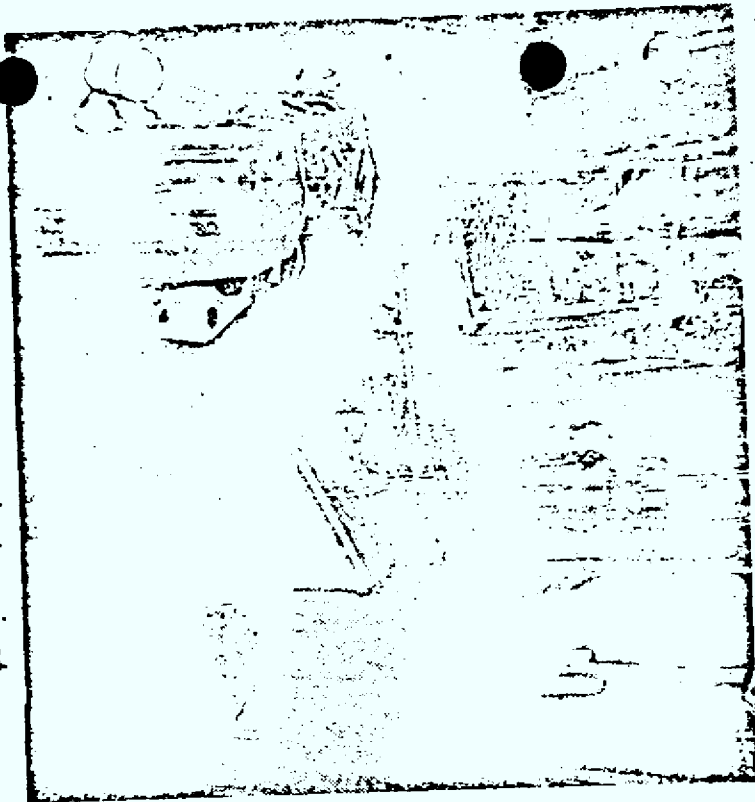
On August 20, 1970, [REDACTED]

[REDACTED] advised that the Black Panthers at Winston-Salem had publicly endorsed burning of the trailer in the past, noting LARRY DONNELL LITTLE, director of the BPP at Winston-Salem, resides at [REDACTED] **1326 OAK STREET.**

It should be noted that the July 18, 1970, issue of the Black Panther Party newspaper contained an article captioned "Figs of the Winston-Salem Model Cities Police Precinct Are Attempting to Win Sympathy of the People," which contained derogatory statements concerning the Model Cities Mobile Unit. . .

The BPP newspaper for August 29, 1970, contained the following article concerning the burning of this mobile trailer:

# COMMUNITY PIG PRECINCT FIRE-BOMBED IN WINSTON, SALEM



## The Winston-Salem pig precinct left shattered after being fire- bombed.

On Wednesday, August 18, the trailer housing a model city pig precinct station was fire-bombed and utterly destroyed by some revolutionary or revolutionaries from the Black community of Winston-

Salem. Earlier during the week the same trailer was shot up. At this time the Winston-Salem pig department has not arrested anyone for a job very well done. The pig department has no evidence

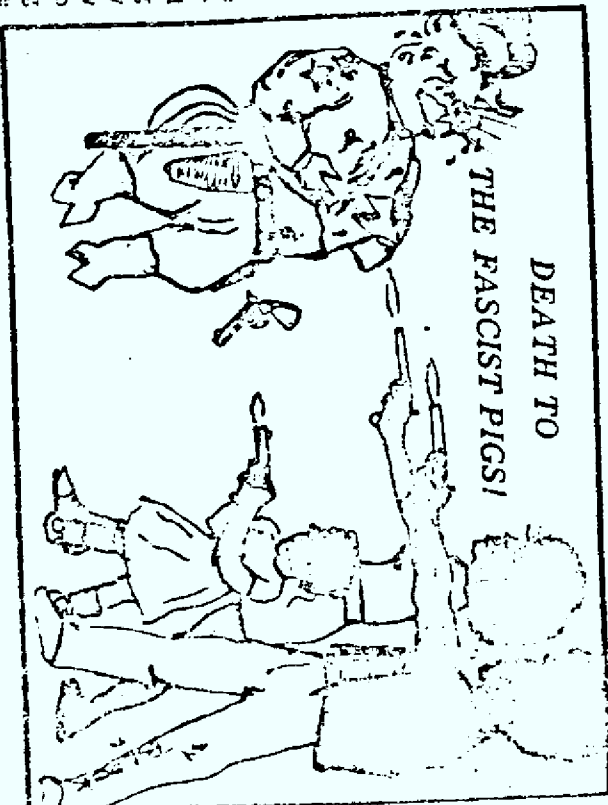
or leads whatsoever as to who committed the revolutionary act, but we know that it is only a matter of time before these foul depraved traders invent some so-called evidence and begin to run amuck and just start snatching niggers off the street to make someone be the scapegoat for this revolutionary act.

Subsequently, two officers were wounded, and their assailant, identified as LAWRENCE HARRIS, a Negro male with a known history of mental instability, was killed. Negro witnesses to the gun battle stated that HARRIS shot first and then officers sought cover and thereafter returned the gunfire. u

asylums. Mr. Harris had been admitted to one such hellhole called Cherry Hill, on a number of occasions. Because the type of society that we live in is designed to dehumanize Black people from the time they fall from their mothers' womb, we can see the affliction that had weighed heavily upon the shoulders of Mr. Harris for so many years. The degradation of a human being in the form Lawrence Harris emerged as the product of this decadent society. On that morning, not fully realizing what had happened to him, Mr. Harris acted like a man possessed with the never ending desire to protect himself against an attacking enemy and free himself from his tormentors.

On numerous occasions, Mr. Harris would walk the streets of the community in which he lived, brandishing a rifle or a shotgun. The people would call the pigs and they would take his weapon away from him and

They were probably hoping the brother would kill a nigger in the community during one of his moments of rage.

On August 20, 1970, Lawrence Harris defended his home against fascist pigs. Between 7:30am and 9:00am, Thursday morning Mr. Harris and Mrs. Douglass another occupant of the house at 2309 Booker St., were wounded along with two pigs, L.A. Stokely and R.U. Lloyd.

Pig Stokely hit the dust and oinked his last oink, lying in the street bleeding from his head and chest. He oinked to the people. "Please call me an ambulance." The people ignored him because they couldn't interpret the oink or relate to it. On the fateful morning 35 cars of pigs converged upon the home of Mr. Harris and tried to arrest him after receiving a complaint. Immediately two pigs were shot as they approached the house. The pigs fired a barrage of shots into the house along with

Shortly after Mr. Harris arrived at the hospital he died. The people believe that the attendants killed him, as they carried him to a hospital 9-10 miles away from the incident. Instead of to the hospital right in the Black Colony, which is only about a mile away.

They called him mentally disturbed, insane, crazy nigger; but we can only see him in the true light of reality - a madman who never forgot who the real enemy is and finally decided to end his misery and kill his tormentor.

Unfortunately, only one pig was killed and the brother is dead. But everyone should take the example set by Mr. Harris, who had nothing more than a single-shot 12 gauge. He dealt righteously using what he had to get what he needed.

The individual contacting BPP Headquarters asked for advice and was told they were to defend themselves; however, no specific instructions were given. U

According to SF T-16, <sup>CAIN</sup> [REDACTED] was recently expelled from the Winston-Salem BPP group after he had been charged with a local burglary. U

On August 18, 1970, Chief of Police JUSTUS TUCKER [REDACTED] North Carolina, Police Department, were both advised that the possibility exists in their attempts to arrest [REDACTED] at BPP headquarters, 1602 East 14th Street, that they would not be allowed to peacefully enter the building and the BPP members would, in all likelihood, defend themselves if officers returned with a search warrant. U

On Monday, July 13, Mr. Haskell McKinney came to the N.C.C.F. He is blind and wanted someone to help him go sign the lease to a house that he wanted. Brother McKinney was told by his caseworker that all he had to do was sign the lease. But when we arrived at Baldwin's Realty Co. we were told that Mr. McKinney couldn't rent a house because he had not established any credit in the city in the last 10 years. Since Mr. McKinney isn't able to work and draws a disability check to take care of his living expenses, so he shouldn't have needed any credit.

I took Mr. McKinney directly to his caseworker. After she called Baldwin he told her to send Mr. McKinney back down to the Realty Office. By the time we got there Baldwin had run off from the office and a racist dog named Foust put us through the same changes about no 'established credit'.

Mr. McKinney is 57 years old. He has been staying any place he could find because, for about the last two weeks since he left the hospital, his caseworker had been giving him the run around. In the hospital, he had an operation on his eye and the sight hasn't returned yet. He has no credit because he has been living with his son ever since he lost his eyesight in 1956, therefore he hasn't worked or rented because there was no need to.

These racist pigs denied the man a place to live although he had rent money for a month in advance.

We went back down to the caseworker, this time she started calling Realty Companies until she got a place for him to stay. Mr. McKinney, who was now in tears said, "I think anybody deserves a place to stay."

This is what happens in a capitalistic system when things that are needed by everyone like food, housing and clothing are controlled by a few low-down lapping hogs like T. W. Baldwin and Son, T. E. Johnson and the rest of the pigs.

It is vitally necessary for the Blacks in Winston-Salem to realize our situation, and organize to do something about it. There is a housing shortage and that's no accident. There aren't enough houses because Baldwin and other realties do not see fit to construct any more. They can control the people as long as they have less housing rather than more housing. They can charge more money as much as they please; the people will have to pay because everybody needs a place to stay.

We must start to move on these beasts of man, by not paying rent for the things that should be guaranteed to every man from the day he is born, because every man, woman and child should be guaranteed the best that technology can offer. Technology can offer every man in this country a decent house, fit for the shelter of human beings.

## PIGS BRUTALIZE BLACK COMMUNITY OF WINSTON SALEM

On Friday July 24th around 3:30 eating his icecream cone 2 pig detective (Crosby and Cader A.R. Rumpie, jumped out of their pig mobile and grabbed George. The brother simply asked these pigs what was this all about, the pigs replied that they wanted George to get into their car. George stated that he hadn't done anything wrong so he didn't see why he should be getting into their mobile. At this time people from the community asked the pigs to show them a warrant and the pigs asked the brother to get into the car again. George also stated that if they showed him a warrant that he would get into the car. The pigs then replied that they didn't need a warrant for a juvenile (a young nigger,) then these 2 dogs just threw George up against the car several times. People from the community along with nearly one hundred little children who witnessed these acts of police brutality began to simply ask the pigs to show them a warrant and they would ask the brother to get in to the car. The pigs simply said later for a warrant and later for the people of the community. At this point the pigs got really restless at their inability to get George into their pig mobile so they just went all out and brutally attempted to drag the brother into the car. The pigs succeeded in getting part of George's body into the car but were unsuccessful in getting the brother's head and arms inside of the car. At this point the pigs showed why the Black Panther Party calls

them low naged beast, and foul depraved traducers. These low lifed dogs attempted to shut the car door on George's head but a brother from the community grabbed one of the pigs by the arm and asked them not to slam the door on the brothers head. These pigs recognizing that the people of the community had had enough of this intolerable madness moved to call for reinforcements, within minutes seven carloads of pigs emerged on the scene and pulled their riot pump shotguns and billy bats on very small children with 2 nigger pigs leading the way, they used the barrels and butts of their guns to push the little children around. Brother George finally subdued, was taken away by by these lowlifed dogs without his mother knowing about his arrest. The pigs also jumped on two other little brothers from the community James Peck 13 years old, and Thomas Thompson. they tried to make the brothers tell about where some money was was ripped off from racist, avaricious White person. With the community uptight, with this act of police brutality with the pigs showing no regard for the life of little children and also with the N.C.C.F. on the scene the pig department, attempted to send their community pig relation workers from the Model "pig" city liaison patrol into the area to calm down the angry niggers and justify the acts of the low lifed dogs. But the people of the community didn't want to hear a word these

pigs had to say no such thing would have even occurred in Buena Vista or Wood Forest because these are White communities.

The people of the Black communities of Winston-Salem should not be fooled by counter revolutionary Hankerchief headed Uncle Toms from the house nigger Poverty programs telling us that the Model city Liaison patrols are a new breed policemen. If they were good pigs they would have arrested or killed those pigs who were inflicting these inhuman in-

justices against our people. No, they didn't do this, so we're in a position where we can only say that the only good pig is a dead pig and we have 400 years to prove it. Later for all pigs whether they be Black, White green yellow or polka dot. Death to all of them for their crimes against the people.

## PIGS OF WINSTON SALEM ARREST TWO N.C.C.F MEMBERS AND A MENTALLY RETARDED BROTHER

We have said many times before and checking out the situation today as we observe the National and International scope and deal with the objective reality of the situation, we find the pigs occupy still the communities of the world reeking murder and brutality and intimidation as they go forth. The Minister of Defense, Huey P. Newton stated clearly that an unarmed people are slaves or subject to slavery at any given moment. The people of Babylon and people in the Black community in particular must take heed to what the Minister of Defense has said and move accordingly. We must begin to arm ourselves and move to the level of Self-Defense Groups.

On July 27, 1970, brothers from the National Committee to Combat Fascism were putting up revolutionary art posters in the community around our headquarters. They were pasting posters on store fronts and telephone poles. It was around 11:30 p.m. when a pig inked that it was against a city statute to put anything on telephone poles.

As the pigs tore the posters down, people began to come out to see what they were doing. The brothers from the N.C.C.F. began to conduct agitation and propaganda. The pigs, not wanting the people to become educated, called for more pigs. Before it was over, 7 carloads of pigs were in the community around our headquarters with M-1 carbines and riot

pump shotguns drawn, and tearing down posters. The brothers continued to educate the masses and the people began to shout, "off the pig". At this time the pigs left but within the next 3 minutes there were 19 pig cars invading the community.

The cars came to a halt and the pigs jumped out brandishing weapons. They rushed in the crowd of people and arrested Larry Little, William Gary (members of the N.C.C.F.) and a mentally retarded brother, Terry Joe Young, who was just sitting on his bicycle. As the pigs moved on the brothers, it was apparent that they were armed to the gills. They jacked off rounds into the riot shotguns as they made their kidnappings.

As we were on our way to the pig pen to get the brothers out, the pigs kidnapped a brother, Sammy Lee Boyd, and a sister, Patricia Ann McNeal on charges of disorderly conduct. All the brothers and sisters were gotten out that same night after continuous threats by the pigs to lock us up. Larry, Gary, and Terry went to trial on the 27th of July and had their cases continue to August 12th. The other cases of the brothers and sister come off in August some time.

## PIG HARRASSMENT OF BROTHER SELLING THE BLACK PANTHER COMMUNITY NEWS SERVICE PAPER

WINSTON SALEM N.C.

On Friday, July 17, 1970, a brother and I were sent out to a shopping center to sell papers. This place is known as North Side Shopping Center, which is located on the north side of Winston. We had been there for about an hour or more, when a couple of avaricious businessmen approached us and told us that we could not sell papers on their property, but that we could sell them if we would go to the Journal and Sentinel (the local pig press) and purchase a paper rack with a coin slot on it. We in turn told the two avaricious pigs that we weren't interested in purchasing a paper rack for our papers and since they allowed the young Whites to sell papers there, we should have that same right. One of the pig businessmen told us that they had a friend (a pig cop) and that we could call him and find out if it was all right for us to sell papers out there. Thinking that we were fools, not knowing if we called this pig; he would have had the whole pig force out there. We told these madfools that we didn't deal with pigs, so they oinked a couple of times and left.

A little while later as we moved along the canopy of the stores, we noticed a pig car, and the pig inside was watching us through the front view mirror as we moved amongst the people. About twenty or thirty minutes later as we turned right under the canopy, we noticed about two cars of pigs parked at the back of the store, we stopped for a while to analyze the situation, and the only solution that we came up with, was that the pig sitting in his car had called in for his gestapo troops.

We started moving out and had gotten about two hundred yards away next to a bowling alley when two more cars arrived, one had a nigger pig inside. Just as we started up the expressway the pigs spotted us and pointed toward us, about that time a sister who stays right across from the headquarters came along and stopped for us. The pigs immediately got into their cars and started following us. We arrived on Liberty St. about fifteen minutes before they arrived. When the pigs saw us surrounded by lunatics buying papers they split the scene. But knowing these mad dogs, they were not to stop at this.

About 11:00 a.m. the next day we were sent down. The same papers, when two of the same mad pigs spotted us. About this time a blood was coming up the

street towards us, since we did not make any irrational move, I guess they decided to vamp on this blood. The blood seemed to be sick and weak, and had been to the drug store to get some prescriptions filled. So these mad dog pigs grabbed this blood and pushed him up against the wall after pushing the brother, they asked him for his identification, which he in turn showed them. They then told the blood that he was drunk. Everybody around knew this blood was not drunk, but the pigs thought they could intimidate us into doing something crazy. Knowing these crazy pigs, we held our cool. So they kidnapped the blood off to jail.

After that the mad pig turned to us and asked if we had permits to sell papers, we ignored him and kept on selling papers. After he found out that we were wise to his madness, he soon left. Like Huey would say, "A newspaper is the voice of a Party, the voice of the Panther must be heard throughout the land." Therefore we should get the paper out by any means necessary, because information is the raw material for new ideas.

## PIG HARASSMENT OF PAPER DISTRIBUTION

On Saturday July 25, another act of pig harassment occurred at the Northside Shopping Center here in Winston Salem. Myself and other brother Gary were getting the people's paper (The Black Panther Newspaper) to the people when we were approached by a uniformed pig accompanied by another pig claiming to be the manager of the shopping center. These fool pigs oloked to us that the property we were distributing the newspapers on was private property and that we could no longer distribute the peoples papers on the grounds. The reason being that no merchandise could be sold on the grounds. But this was clearly proven to be nothing but bull because of the fact that there was concession set up in front of the First National Bank (which was closed) which was selling home made cakes and pastries and was being operated by six White girls.

After telling the pigs that the property we were on was the people's property, and that we were not leaving we proceeded to getting the papers to the people. This was at approximately 12:00 a.m. At approximately 1:00 p.m. three carloads of pigs rolled on myself and brother Gary. I was forced up against the pig car, searched, then taken to the downtown pig pen. A warrant had been taken out for me with another name other than my own.

Being that the pigs had taken all my I.D. as well as other papers,

they were able to get my correct name and corrected the name on the warrant. This was all done at the downtown pig pen where I had been taken. Brother Gary related to me upon my release from the pig pen (which cost \$50 ransom) that the pigs had given him five minutes to get off of the property or he would also be arrested for trespassing.

This attempt by these fool pigs to sabotage the distribution of the people's news papers will not be victorious because the spirit of the people is greater than the man, the pigs and all their technology.

## MEMPHIS, TENNESSEE: CITY OF 300,000 OPPRESSED NIGGERS

Memphis, Tennessee is a city in the south, part of racist Babylon. It is the city where Martin Luther King was murdered. We all know that the assassination of King was nothing more than a C.I.A. plot, planned and carried out by this fascist power structure to eliminate all persons and individuals that are struggling to bring about a change of this decadent American society.

Conditions of racist discrimination, oppression and exploitation along with human degradation have been subjected to even up to this present time. Brothers and sisters that had been kidnapped and railroaded through the racist court system - during the 1968 riots are still confined. Some because neither they, nor their families can raise the ransom demanded by racist judges, others have no ransom at all.

Because of niggers moving in the best way they knew how during the riots of 1968 and destroying a great deal of the avaricious businessman's property, the pigs have

stepped-up their fascist tactics. The pigs have set up pig outposts in the colony where they distribute food stamps to the people, they have what they call a free lunch program, which consists of feeding hungry people, cold sandwiches on day old bread. These activities are there to deceive the people and kill them with sugar coated bullets.

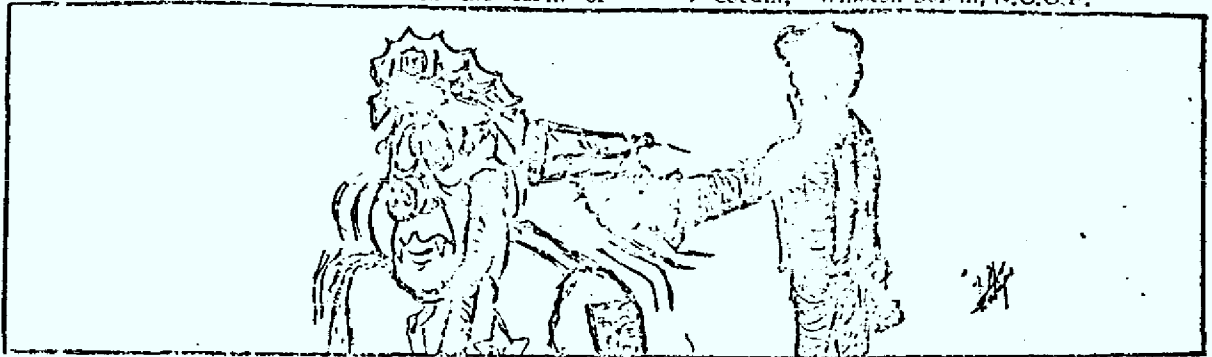
Along with these foul tactics of trickery, the pigs fly over the Black community at night in helicopters. These pigs shine large floodlights down into the colony indiscriminately. They shine their lights into peoples homes and on the brothers as they congregated on the block, shouting through megaphones "O.K. niggers let's break it up." Memphis has more than its share of Black lackeys and nigger rent-a-pigs. In all Black communities across Babylon, the power structure, in an attempt to repress the rising revolutionary spirit of the masses, has flooded the colony with drugs. Pimps and pushers are off in the colony dealing out death to the people in the form of heroin, cocaine,

LSD capsules and Red devils. The same is true of Memphis, Tennessee.

Planned conditions of indecent housing, unemployment and hunger all the basic needs that the people must have to live, are denied Black people of Memphis. Black lackeys constantly rise the people up and then sell them out for their own personal gain. Such is the plight of the Black people of Memphis.

The repression mounts daily, there have been 300 cases of pig brutality since the summer began and 9 brothers were ripped off in the month of June. The chief of pigs, Lux stated on T.V. that he gives his pigs guns for the purpose of "shooting to kill". The people of Memphis must move to deal with these foul pigs and take up arms in defense of our basic human right - the right to determine our destiny.

# WINSTON-SALEM N.C.C.F. STARTS FREE CLOTHING PROGRAM

Necessities such as food, clothing and housing should be provided for every individual from the day he is born. These are things that everybody needs in order to survive. Yet because we live in a society where a few people own the things that everybody needs, some people can't survive. We question, why should a few be overflowing with wealth and others suffer because they don't have. We say that if these necessities are distributed equally then everybody will survive,

everybody can live comfortably. Since we don't live in a society where this is true the N.C.C.F. of Winston-Salem has implemented a Free Clothing Program to provide clothes for those people in the community that don't have. The program started August 1, 1970; on that day 50 to 75 people from the community came to get clothes.

## IN ORDER FOR BLACK PEOPLE TO ACHIEVE THEIR BASIC NEEDS AND DESIRES THEY MUST FIRST RELATE TO THE BASIC RIGHT OF SELF-DEFENSE

The time when Black people sought to acquire their basic needs and desires non-violently are long gone. The murder of Dr. King clearly revealed to Black people that they had no rights which the White man was bound to respect. This fact manifested itself recently with the acquittal of two White racists who had viciously murdered brother Henry D. Marrow, a twenty three year old married father of one in Oxford, N.C. The all White racist jury took less than 24 hours to acquit these yellow racist perverted pigs who had shotgnaed the brother, crippling both of his legs, then shot him through the head at point blank range, killing him instantly. The brother was never at any time armed, clearly showing no justification for his murder.

This cowardly act of wanton murder of our people was carried out in the eyes of dozens of members of the Black community who went to court and testified as to the fact that the brother was shot in the head as he was trying to crawl away from his racist murderers.

Acts of murder and brutality being inflicted upon Black people is nothing new to Black people. An examination of the history of

Black people since our forced migration to this racist infested country has seen over fifty million Black people murdered without justification.

Recently here in Winston-Salem, a fifteen year old brother by the name of George Caldwell was brutally beaten by cowardly pigs who pulled out riot pump shotguns on brothers and sisters who rushed to the brother's aid as he was being beaten. Less than a week later a sixteen year old sister was beaten and maced after being kidnapped by racist pigs itching to murder unarmed Black people who were watching.

Attacks such as these are evidence that in order for Black people to achieve their basic needs and desires they have to first relate to the basic right of all people and that is the right to protect oneself whenever attacked. The Black Panther Party advocates that people should arm themselves for self-defense.

## THE RACIST WINSTON-SALEM SCHOOL BOARD PLAN FOR SCHOOL DESEGREGATION MEANS TERROR FOR BLACK CHILDREN

The racist Winston-Salem school board headed by mad-dog Maready, and backed by the local fascist pig force (Tucker's raiders) has hatched a school desegregation plan, which they have submitted to the State Court. They (the school board) went behind closed doors with those that would profit most from government funds (the tobacco industry) that will come pouring in once a desegregation plan is submitted and implemented, to put this stupid scheme together. The plan they came out with was so disgusting - even they (the school board) say they could not approve it -- but will submit it anyway. LIARS - how could they submit something neither they nor the people of Winston-Salem can approve of anyway if they are serving the best interest of the people.

This plan closes two of the 3 remaining high schools in the Black community (Carver School and Anderson, leaving only one Black high school - Atkins). It (the plan

proposes to bus Black students to the all white high schools, Parkland, East Forsyth and North Forsyth (remember when that racist pulled that shotgun on Blacks last year at North?) We can look for the same and possibly more insane actions this year.

As far as the grammar schools, they will cluster grades 1, 2 and 3 (this clustering process busses our kids out and white kids in - this will be done in such a fashion that in most grammar schools including those in our community, whites would be in the majority and Blacks in the minority. This is very dangerous because our kids at that young age will come to believe give that racist teachers will try to feed them in these schools about them not being able to change their oppressive conditions because they are in the minority. Black people BEWARE of the effect this move will have on our kids!!!

All of this bussing is supposed to take place - tell us Maready

where are these busses coming from? Isn't it true that the County cannot, according to State law, buy busses for your dumb plan? We think you should know Black people DO NOT want Carver and Anderson closed and we ARE NOT going to place our kids lives in jeopardy as we did last year - for those mad KKK's to try to intimidate and murder. If you persist in your mad scheme we will make you see the folly of your stupid plan.

We are saying that we see through all the lies and games; that we are tired of this crap and will not indulge in the madness any longer. Stop this madness now or face chaos in the coming school year. We want Community Control of our schools and we will have this BY ANY MEANS NECESSARY!

# THE PEOPLE OF WINSTON SALEM DEMAND A CONSTITUTION THAT GUARANTEES THE RIGHT TO LIVE

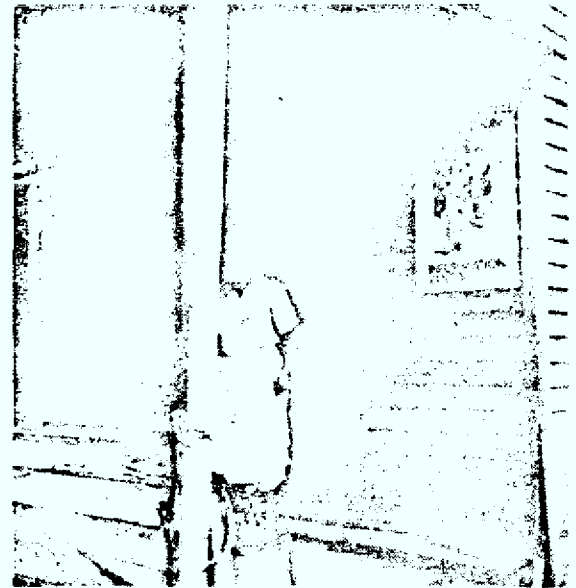
"The Pond" is one of the most dilapidated areas in the City of Winston-Salem, North Carolina. It has certain characteristics of a fish pond, in that the people of this area wonder around from day to day worrying about where their next meal is going to come from, and other basic necessities denied them by this greedy capitalistic system.

Most of the people are unemployed and being welfare recipients have to worry a lot about where their next meal is going to come from when their food stamps run out. A lot of them don't even know how to apply for food stamps - PEOPLE STARVE HERE. This is directly related to the system of exploitation that we now live under. It is related because it is typical of this system that a lot of people should go lacking, while a few have plenty of everything, with those in-between receiving a tiny part of that, which is rightfully theirs.

Education of the children of "The Pond" is not much at all. With the school board's new plan for desegregation it is probable that this year there will be no education at all provided by the system. Education on how to deal with the society is supposed to be provided by the government to every man, woman and child in the society.

Justice according to law is not known here, and therefore peace is a stranger.

It was he and in the immediate area (the Boston area) that the people took to the streets in 1967 to repay pigs. Pigs who thought it their duty to keep niggers in their place by beating a blood to

death on his own front porch. The whole community witnessed this act of aggression and responded by driving the pigs out of their community.

Housing is another area in which the people are denied. Mrs. Louise Ames, a 104 year old resident of "The Pond" has been struggling for all these years. She states that she pays \$55.00 a month to a slumlord (W.F. Baldwin) for this house that doesn't have a bathtub, hot water, sufficient heating or adequate wiring for proper lighting; she is tired but she continues to struggle, and she recognizes the need to change the constitution that allows all these injustices to be perpetrated against her, her family and her people.

The present system of government has failed to provide the basic necessities for survival - land, bread, housing, education, clothing, justice and peace. It (the system) has denied these necessities to Black people throughout Babylon. And so we are now demanding a change in the system that allows these necessities to be denied. We are demanding that the constitution

be rewritten, because it allows the majority of the people to be neglected and without the basic necessities. We are calling for a Constitutional Convention. We recognize that we need a Constitution that guarantees us our most basic human right - the right to live.

We are setting up Constitutional Convention Information Centers (like the one at Mrs. Ames house) where people can come to register for participation in the Plenary Session September 5, 6 and 7\*, and the actual Convention in November. We are gathering together to bring about a change, to let the whole world know that we are determined to have the basic needs for survival - let it be known that we will have our basic human rights, by any means necessary!

# TERRORISM OF THE AVARICIOUS BUSINESSMEN

In the Happy Hills Garden section of Winston-Salem, N.C., the N.C.C.F. has developed a very close relationship with the people. Every day we straighten out contradictions through example. Sometimes these contradictions are others harder to deal with, all of them basically develop out of the terrorists, fascist tactics of the power structure.

On August 5th a problem was brought to the attention of community workers, concerning a pig avarticious businessman named Keith Lowery, and how he was using terrorism to rob black people in the community. The complaint originally came from a Sister Caldwell who lives on Willow Street. She proceeded to tell us how her bill at one time (for furniture) amounted to \$395.00. Diligently she paid the debt, she thought she owed, to this bloodsucking pig until she found her bill down to \$61.00. At that time Sister Caldwell found it difficult to pay \$25.00 every month and informed this stop mouth pig of that fact. It was agreed that Sister Caldwell would only have to pay \$25.00 once every two months instead of monthly.

When the bi-monthly bill day rolled around, the month that Lowery had agreed to let Sister Caldwell pay \$25.00, who did she see coming up her doorstep but this lying pig Lowery. Drinking about what he would do if he didn't receive the \$50.00. This pig vamped on Sister Caldwell like a nazi storm trooper. She reminded him of their agreement, he asked some madness and still demanded \$50 or he would send some of his lackey coons to take the furniture. Sister Caldwell told this pig that he would get \$25 and nothing more. And to get off her property.

He then told Sister Caldwell she had until the next Monday to get the money or else. We found out later that Mrs. Caldwell was not the only victim of this foul pig. Lowery had terrorized four other sisters in the same block. We then made a move to talk to this pig, and all that resulted was a lot of pig madness. So we at the N.C.C.F. and the people in the community see the necessity to move to a higher level in order to deal with this pig.

this pig. This is why it is necessary to form Self-Defense groups, to defend the community from any type of terrorism. Be it from a pig cop, or some avarticious business- man. We must stop them at the outer limits, of the Black community. We must be armed, because "an unarmed people are slaves or subject to slavery at any given moment."

## THE COMMUNITY OF WINSTON SALEM ACTS AGAINST OUTSIDERS

On August 19, off into the East side of Winston-Salem the community inflicted a political consequence upon outsiders. For too long we have let people from other communities come into our community and take over. All we did was sit by idly and let them mess over us and our children. For too long especially in the South, Whites have thought that they can do whatever they wish to us, and nothing should be done; but this time the entire community on 10th and Locust Street decided they were tired of that. They decided they were going to use some of those weapons that they used to use on each other, on the outsiders who were coming off into the community acting a fool.

This is a construction site in the community where urban development or one of those pacification programs are tearing down houses. The workers are mostly white and ever since they have been coming off in the community they have been using it for a race track. There are no sidewalks in this section of town so people walk on the side of the street, there are ditches beside the streets. These white racists would come down the streets as fast as possible, running children off the streets purposely. And when the children went to the fools to inquire why they called them all kinds of names, they said they were going to get rid of all of them (niggers). The first day this happened the people said nothing so I guess they thought they could do what they wanted from then on. But the next day they ran children off the streets, they got a surprise. The children went off telling everybody about what was happening. This time older brothers and sisters came back with the children. They asked the men why they were doing this. Now that they saw the whole community upset they started lying saying they knew nothing about it, but the children were right there to repudiate every word they said. The brothers and sisters let them know they weren't going to be doing what they wanted to in our community any more by giving them a good 11th street beating.

From now on they will know how to act when they come to this side of town. Immediately the pigs came on the set they didn't ask anybody why the fools were beat, they wanted to know who beat the fools. This shows that they have no concern for our community but they care only about the white racists coming off in our community running over us. They know that if niggers here start dealing with racists who come in the community acting insane, that we will be dealing with them when they act insane.

## ERNEST SCALES WAS CLUBBED VICIOUSLY FOR BEING BLACK

On August 18, 1970, in the Black Colony, the pigs of Winston Salem were up to their usual actions, intimidating and brutalizing the inmates therein. About 4:30p.m. on the corner of 8th and Patterson, a corner where the lumpen come together like so many thousands of corners throughout Babylon, a group of bloods were standing around. They were having an argument as most niggers will do while drinking wine. Everything was alright until the pigs came on the scene. The pigs moved on the brothers

with billy clubs and vamped on the most helpless blood they could find.

They clubbed Ernest Scales, age 42, across the arm and head inflicting a wound that required 14 stitches to close. Ernest

tried to defend himself with a small knife, but when the pigs hit him across the arm a number of times, he dropped the knife and then the pigs beat him in the head. Ernest Scales can't walk without the aid of two crutches. In fact, he has been on crutches for two years, due to a fall off the roof of his house. The result of his injury required surgery and four pins had to be placed in his hip to hold the bones in place.

Ernest Scales had spent 15 years of his life in maximum security, off in the prisons of North Carolina. He had been paroled to minimum security (the street) in 1968. Having been on work release, a so called rehabilitation problem of the prison system, Ernest had a little money when he got out, after the exploitative prison system of chattel slavery had gotten all they wanted out of him. With the little that Ernest Scales had, he decided to build a house. Ernest Scales got himself some land and began to build his house.

The pigs have been harassing Ernest for two years, ever since he came off the "Chain Gang." Because the prisons couldn't have a complete victory of the brother the pigs are attempting to drive him back to prison. But what the pigs don't realize is that the "spirit of the people is greater than the man's technology." Nothing in the universe can halt the surge of the people as they step forth in the quest for freedom.

The fools in Washington got a whole new maneuver in mind for us. They have a national perspective on things and these commu-

dogs of the earth see that niggers are getting themselves together all over the country. They see the danger in having an all Black school in the middle of an all Black neighborhood. We just might decide to take it over and give our people an education that exposes the truth of this decadent American society. So these masters of tricknology and deceit, seeing this danger, have decided all of a sudden, after years and years of court suits to let niggers go to school with White folks in the South. Now we will be split up and we will no longer have the stronghold that we would have in our own community. That's one angle of the napes in Washington. This trick started with the traitor Kennedy. Realizing that the world now has its eyes on them the fools in Washington see a necessity to throw up a camouflage. So just like Kennedy did with the Civil Rights Movement, because the eyes of the world were on him, they think that they can use that same trick, not just to pacify some of the bootlicking fools but also to make it seem as if they are dealing with the domestic problems. They try to cover up the fact that they are perpetrating systematic genocide on us.

Let us not be fooled into believing that this man is dealing in our favor. He NEVER has. He NEVER will. We have nothing to gain by leaving our community and going to his racist school each day for the sake of intergration. Let us say here in the South now that we know our strength and we are going to use it. Let us vow that this school year when they bus us to their neighborhood to schools that are miles and miles from the safety of our neighborhoods that those of us who remain in the community will righteously deal with the racism that will be coming to our neighborhoods. Let us move to take our schools back and when the pigs come to our community, NIGGERS pick up your guns.

According to its official newspaper, the Black Panther Party (BPP) was started during December, 1966, in Oakland, California, to organize black people so they can take control of the life, politics and the destiny of the black community. It was organized by Bobby Seale, BPP Chairman, and Huey P. Newton, BPP Minister of Defense. Newton was sentenced in 1968 to serve 2 to 15 years after being convicted of manslaughter in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther," which further describes itself as the "Black Community News Service," states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

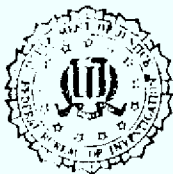
"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education George Mason Murray, which ends with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement "...we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman Mao Tse-tung of the People's Republic of China and feature Mao's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.
