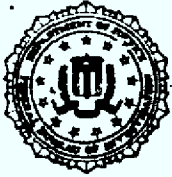

On August 16, 1969, the following information
was received from [REDACTED]

At approximately 3 a.m., August 16, 1969,
OTIS BLACKMON, Negro male, who is the owner and operator
of the Chicken-N-Ribs Drive-In, 1100 Beatties Ford
Road, Charlotte, North Carolina, and his son, OTIS
JAMES BLACKMON who works with his father, noticed JAMES
MICHAEL BLACK, Negro male, age 31, and JAMES EDWARD
PRATHER, Negro male, age 17, prowling around the
restaurant delivery truck. OTIS JAMES BLACKMON
ordered them to leave and an argument ensued between
PRATHER and BLACKMON. Conflicting stories were
furnished [REDACTED] regarding the argument
with BLACKMON stating PRATHER called him an obscene
name. PRATHER stated that BLACKMON choked him and
cut him on the arm with a knife. B. APPROX.

PRATHER has received treatment for superficial
cuts on the arm which required no stitches and has
asked for an assault charge to be filed against OTIS
JAMES BLACKMON. R. 4 PM.

Approximately one hour after the prior
argument, PRATHER and BLACK returned to the restaurant
with an additional group of unidentified Negroes, one

of whom was subsequently determined to be VERONICA HAGENS, Negro female. All were dressed in the black uniform with black berets of the Afro-American Unity Organization (AAUO), Charlotte, North Carolina, which is attempting to affiliate with the Black Panther Party of Oakland, California. BLACK and PRATHER were wearing lieutenant bars on their black berets.

[REDACTED] that the Panther group pointed rifles at them and started shooting. During the shoot-out, the BLACKMONS recovered a .22 Caliber model 120 rifle with the trade name of Revelation, no serial number. The BLACKMONS were in possession of a .38 Caliber pistol and returned the fire of the Panther group and called the police. VERONICA HAGENS attempted to enter the kitchen door of the restaurant and was stabbed by OTIS BLACKMON in the stomach with a butcher knife. HAGENS was transported to Charlotte Memorial Hospital for treatment for the stab wound. No charges have been filed against HAGENS or the BLACKMONS in connection with the incident.

During the shoot-out, OTIS JAMES BLACKMON was shot in the upper arm with a .45 Caliber weapon, [REDACTED]

JAMES MICHAEL BLACK received a minor gunshot wound in the hand and was arrested by the Charlotte Police Department and charged with Assault With a Deadly Weapon With Intent to Kill.

[REDACTED], a Negro male, received minor gunshot wounds and required no medical treatment. He is not being held by the police as he was considered an innocent bystander.

Along with a .22 Caliber rifle recovered by the BLACKMONS, the [REDACTED] from JAMES EDWARD PRATHER who states he obtained the weapon at the clubhouse of the AAUO.

On August 19, 1969, [REDACTED], advised that he has received the following information from [REDACTED]

After JAMES PRATHER, also known as Papa, and JAMES BLACK had their argument with OTIS JAMES BLACKMON at the Chicken-N-Ribs Restaurant, BLACK and PRATHER returned to the Black Panther Party headquarters at 316 Turner Street, where they obtained weapons and their black uniforms. Accompanying PRATHER and BLACK back to the Chicken-N-Ribs Restaurant were [REDACTED] also known as [REDACTED]

[REDACTED] was in charge of the group and ordered the shooting to start. [REDACTED] was using a .45 Caliber Eagle, a semi-automatic weapon which appears similar to a Thompson sub-machine gun and may have been the individual who shot OTIS JAMES BLACKMON in the arm. [REDACTED] has departed Charlotte possibly for Asheville, North Carolina, where he may have entered some type job corps camp due to the fact he is afraid of being arrested for his participation in the shooting.

APPENDIX

BLACK PANTHER PARTY

According to its official newspaper, the Black Panther Party (BPP) was started during December, 1966, in Oakland, California, to organize black people so they can take control of the life, politics, and the destiny of the black community. It was organized by BOBBY GEORGE SEALE, BPP Chairman, and HUEY P. NEWTON, BPP Minister of Defense. NEWTON is presently serving a sentence of 2 to 15 years on a conviction of manslaughter in connection with the killing of an Oakland police officer.

The official newspaper, "The Black Panther," which further describes itself as the "Black Community News Service," states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education, GEORGE MASON HUNLEY, which ends with the following:

"Black man. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worthkeeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement, "... we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman MAO Tse-tung of the People's Republic of China and feature MAO's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3166 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.

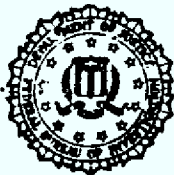

Reference is made to memorandum captioned as above, prepared at Charlotte, North Carolina, on August 23, 1969.

On August 23, 1969, a source who has furnished reliable information in the past advised that the demonstration which had been scheduled for that date to begin at approximately 11:00 A. M. had been postponed and tentatively rescheduled for Saturday, August 30, 1969.

According to the information received by the source, the postponement was occasioned by the fact that Doctor REGINALD A. HAWKINS, a Charlotte, North Carolina, Negro dentist, desired that the demonstration be held in close proximity to the scheduled date of school openings in Charlotte, which would be September 2, 1969. HAWKINS preferred to have the demonstration on Tuesday, September 2, 1969, it being his idea that the demonstration would draw Negro teachers out of the classrooms and Negro students out of the classrooms and thereby emphasize to a greater degree the unity prevalent in the Negro citizens concerning the School Board's decision to bus Negro students to integrated schools.

Reverend ELO HENDERSON, who has been directing the affairs of the Black Solidarity Organization, overruled HAWKINS on the September 2 date; and the August 30 date has now been agreed upon. The demonstration, according to present plans, will probably move from the Second Ward School area on East Independence Boulevard to the Centennial Building in downtown Charlotte, a distance estimated at approximately two and one-half miles. Due to the distance involved, a motorcade may be used to transport the demonstrators from the school to the Centennial Building.

Source advised that members of the Black Solidarity Organization also suggested that attempts be made to secure nationally known Negro personalities to appear at the demonstration. Two of such Negroes suggested were the wife of MARTIN LUTHER KING, JR., and possibly JESSIE JACKSON of Operation Breadbasket. Source advised that plans in regard to the demonstration are still indefinite because of internal bickering and that firm plans will be made during the coming week.

Appropriate representatives of Secret Service, military intelligence, and Charlotte, North Carolina, Police Department are cognizant of the above information.

Attached as an appendix to this memorandum is a characterization of the Black Panther Party.

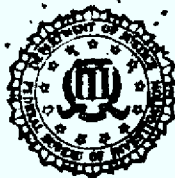

The "Charlotte Observer" in its issue of May 29, 1969, a newspaper of general circulation, Charlotte, North Carolina, in an article concerning a raid at 316 South Turner Avenue which described the place as the residence for the local group seeking affiliation with the Black Panther Party (BPP) meets, quoted one TONY ALFRED as saying that he asked an officer for a warrant and "he just told me 'shut up nigger' and pointed the shotgun at me". The article continued on to quote ALFORD in other statements indicating membership in the group known as the potential BPP.

On June 9, 1969, [REDACTED] made available a list of names and potential members of the potential BPP which he had received from a source.

Included in this list was the name TONY BERNARD ALFORD, [REDACTED] Charlotte.

On June 6, 1969, a complaint and motion for temporary restraining order and preliminary injunction was filed in U. S. District Court, Charlotte, North Carolina, by GEORGE S. DALY, Attorney for American Civil Liberties Union (ACLU). The plaintiffs in the suit allege harassment by representatives of the Charlotte, North Carolina, Police Department; Mecklenburg County, North Carolina, Police Department; State Bureau of Investigation; Alcohol, Tobacco and Firearms Division, U. S. Treasury Department and the FBI.

RE: TONY BERNARD ALFORD

The name TONY ALFORD is listed as a plaintiff in this matter and describes ALFORD as well as the other plaintiffs as Negroes who frequent the "People's House" at 316 South Turner, Charlotte, North Carolina, a voluntary congregation of individuals concerned with improving the lot of the black race who are actively preparing themselves for membership in the BPP.

On June ⁴ [REDACTED] 1969, CE T-1 advised that TONY ALFORD attended a meeting on June [REDACTED] 1969 at 316 South Turner Street. In attendance at this meeting were between 15 and 20 people who allegedly represented various organizations.

TONY ALFORD allegedly represented the Afro American Unity Organization at this meeting. The purpose of this meeting was to form alliances between various organizations and any other organizations in the city. This organization supposedly would alleviate some of the problems that exist in the present system as it stands.

On June 4, 1969, T-1 advised TONY ALFORD attended a meeting of the potential BPP on [REDACTED] May [REDACTED] 1969. ALFORD was one of [REDACTED] people at this meeting.

On June 25, 1969, T-1 identified a photograph of TONY ALFORD who was present at a public rally sponsored by the Afro American Unity Organization in Charlotte, North Carolina on May 24, 1969.

The Afro American Unity Organization, according to [REDACTED] is an organization made up of black membership with no national or state affiliations which has since 1968 been unsuccessfully attempting to affiliate nationally with the BPP.

On June 25, 1969, and again on July 18, 1969, T-1 advised that TONY ALFORD is known [REDACTED] as a member of the Afro American Unity Organization and at one time had been in temporary charge of security at meetings.

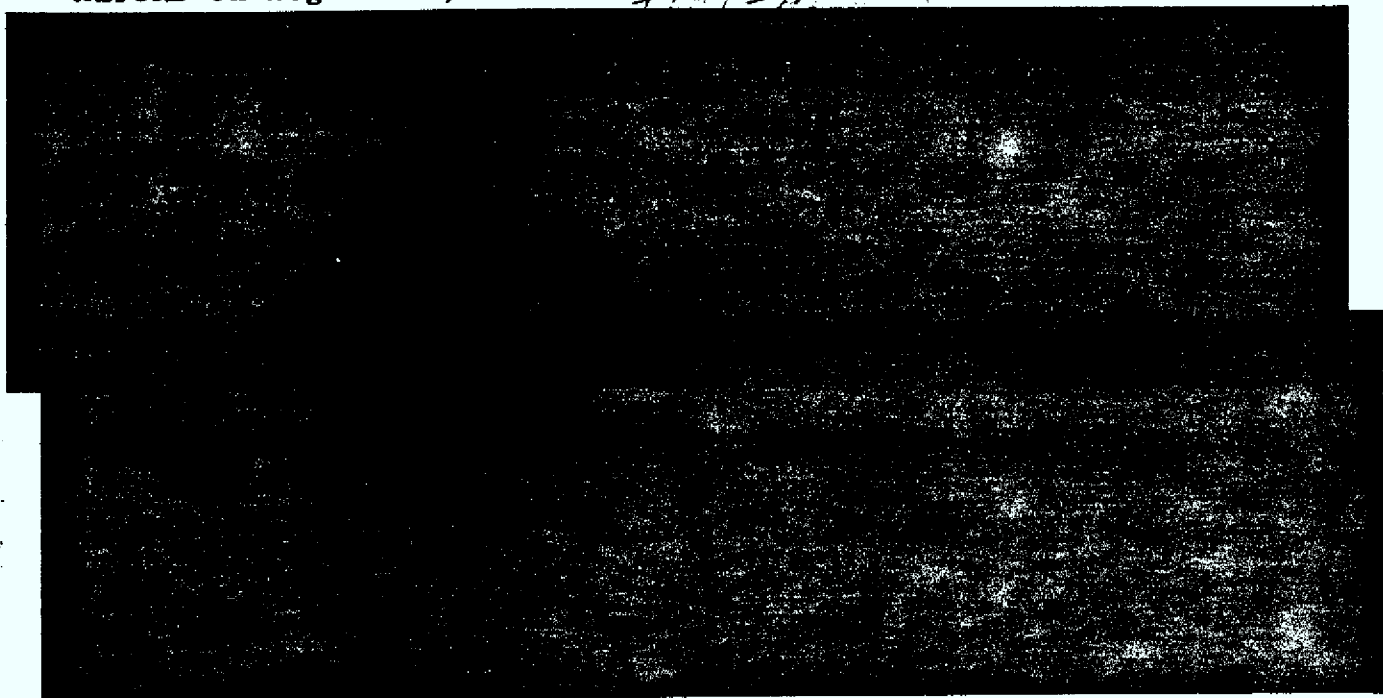

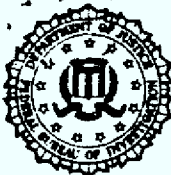

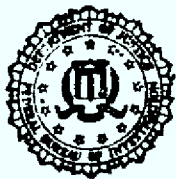

had been downtown during the day drinking and also that [REDACTED] had been arrested for shoplifting and had been released on \$300 bond. [REDACTED] had been with [REDACTED] but had not been caught.

On June 25, 1969, [REDACTED] advised that [REDACTED] also known as [REDACTED] was present at a public rally sponsored by the Afro-American Unity Organization in Charlotte, North Carolina, on May 24, 1969. T-1 advised that [REDACTED] appeared at the rally in the garb of the national Black Panther Party.

On July 16, 1969, [REDACTED] advised that [REDACTED] who is familiar with the activities of the potential BPP in Charlotte, North Carolina. At this meeting persons within the organization were signed to either Central Headquarters or Area 1. [REDACTED] was one of the individuals assigned to Central Headquarters.

On [REDACTED] advised that there was a meeting of the Afro-American Unit Organization which is attempting to become affiliated with the BPP held at [REDACTED] This was a typical educational political meeting with one BEN CHAVIS leading the discussion on the ten-point program of the BPP. Each of the ten points were gone over and discussed individually. Following the discussion of the

ten-point program CHAVIS presented charts which had obviously been prepared beforehand. The charts depicted four areas of the city and it was stated that each area would be governed by an area captain. Each area captain would report directly to a central committee which will be composed of a chairman, a minister of information and education, a treasurer, a minister of defense and a correspondence secretary. Following an examination of the areas and discussion of each of the areas, captain nominations were taken.

[REDACTED] was nominated for the position of central committee chairman but was not elected.

[REDACTED] was next nominated against others for the position of minister of information and education but was not elected.

ADAM STEIN, attorney for the Black Panthers, said his clients' intention is to plead not guilty to all the charges. Each was released on \$250 bond.

[REDACTED] said the incident began at a stop light at Bellhaven and North Hoskins Road when the Panthers pulled up in a rented panel truck, stopping behind the teen-agers. The driver of the car told police that when the light changed the truck began following the car, at times driving 50 miles per hour and as close as six feet from the car's bumper. The driver told [REDACTED] that his car stalled once and then died and that he coasted to a stop in front of a house at 7712 Bellhaven Boulevard. The four occupants of the car, two boys and two girls, ran up into the yard of the house and while they were running about six shots were fired at them. [REDACTED] said the truck continued down Bellhaven about one half of a mile and wrecked. The occupants ran into the woods and were arrested by State Highway patrolmen and County police. The SDS is an association of young people on the left and has a current program of protesting the draft, promoting a campaign for youth to develop a conscientious objector status, discouraging United States intervention in the war in Vietnam, and to "radically transform" the university community, and provide for its complete control by students. Gus Hall, General Secretary, Communist Party, USA, when interviewed by a representative of United Press International in San Francisco, California, on May 14, 1965, described the SDS as a part of the "responsible left" which the Party has "going for us." At the June, 1965, SDS National Convention, an anti-communist proviso was removed from the SDS constitution. In the October 7, 1966, issue of "New Left Notes," the official publication of SDS, an SDS spokesman stated that there are some communists in SDS and they are welcome. 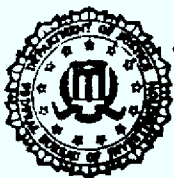

In attendance at this meeting were thirty to thirty-five people from the Charlotte community and approximately seven individuals who were wearing the garb of the BPP, carrying weapons and acting as security forces for the meeting. Included in this group wearing BPP garb was [REDACTED]

[REDACTED] attended a meeting of the Afro-American Unity Organization at [REDACTED] in Charlotte. [REDACTED] the purpose of the meeting was for political indoctrination into the BPP and the ten point program of the BPP was discussed.

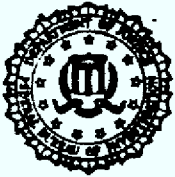

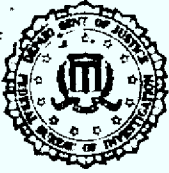

Source advised that the proposed demonstration is scheduled to begin at approximately 11:00 a.m. and will consist of a march of Charlotte, North Carolina, Negro citizens from the Charlotte Post Office to the Charlotte Centennial Building on East Trade Street, a distance of approximately four blocks.

The demonstration will be led by Reverend GEORGE LEAKE, a Negro, who will pose as the acting Black Mayor of the City of Charlotte, North Carolina, and he will be accompanied in the demonstration by Doctor REGINALD A. HAWKINS, a Charlotte Negro dentist, who will pose as the acting Black Governor for the State of North Carolina. HAWKINS has previously been a candidate for Governor of North Carolina.

According to the information received by the source, HAWKINS is attempting to obtain support from the members of the Black Solidarity Organization, a local Charlotte Negro organization whose purposes have been to present Negro problems in an intelligent manner to the city authorities. According to HAWKINS, an estimated 8000 persons will appear for the demonstration and join in the march from the Post Office to the Centennial Building.

The theme of this demonstration will be a "Funeral" for the Queen City of Charlotte, North Carolina, pointing out that for the black man justice is dead, freedom is dead, and it is anticipated that speeches, which will be given by LEAKE and HAWKINS, will stress this theme.

Source stated that it is not anticipated that violence will occur; however, members of the Afro-American Unity Organization will act as parade marshals.

It is also noted that on the morning of 8/16/69 very heavy rainfall occurred in Charlotte which would have made a demonstration difficult if not impossible.

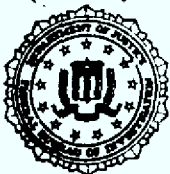

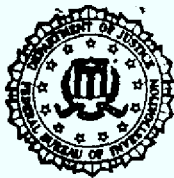

In view of information contained in reNYtels indicating individuals identified as [REDACTED] and a female companion known as [REDACTED] (phonetic) may be in Charlotte representing the New York Black Panther Party (BPP) and unless already done, both Charlotte and New York should immediately institute intensive investigations regarding these individuals for the purpose of establishing complete background information as well as information with respect to their BPP status and specific reasons for travel to Charlotte at this time. Both offices should bear in mind the possibility subjects' presence in the Charlotte area may be in furtherance of BPP organizational activities in that area and that their efforts in this regard, as well as in connection with any violent activities arising out of local school integration policy demonstrations, may constitute violations of Federal laws including the Antiriot statutes.

Inasmuch as data set forth in New York tel 8/9/69 indicates subject [REDACTED] is known to possess a shotgun and rifle at his residence in New York, New York should also be alert to the development of information in his regard to indicate possible violations of existing Federal firearms statutes. Upon establishment of a possible violation in the latter regard, a separate case should be opened on Augustine under appropriate character.

Inasmuch as all subjects are reportedly from the New York area, New York is being considered office of origin in these cases and investigations should be coordinated closely between New York and Charlotte.

These investigations should be handled promptly by recipients and results furnished to the Bureau in form suitable for dissemination at an early date. Cover communications should contain recommendations with respect to additional investigative action concerning the aforementioned individuals and New York should include commentary with respect to their possible inclusion in the Agitator Index or Security Index.

An information copy of this communication is being furnished the San Francisco Office as the office of origin in the BPP investigation and in view of leads set forth to that office in New York tel 8/9/69.

For the information of recipients, Bureau files contain no subversive derogatory information identifiable with individuals listed above on the basis of available data.

[redacted] source in Charlotte advised that members of the BPP from New York had arrived in Charlotte and were in contact with a black group which was participating in demonstrations against school integration policies in Charlotte commencing August 2, 1969. New York identified four of these individuals as [redacted]

[redacted] and a female known only as [redacted] (phonetic). It is noted that while there are several reported BPP groups attempting to organize in the BPP area that none of them are known to be affiliated with the national organization at this time. The BPP is a violence-prone black extremist group. This has been coordinated with Division Six.

[REDACTED] said there were several who were going on trial this week as a result of a shoot-out with white youths. A second trial was scheduled for 8/18/69.

[REDACTED] stated there was what appeared to be a Panther office located at 316 South Turner Street, Charlotte, and another office called "a higher type" on Allen Drive (PH), also, in Charlotte. The girl at Headquarters asked if [REDACTED] had received her letter together with the list of the various BPP offices.
