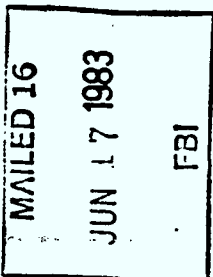

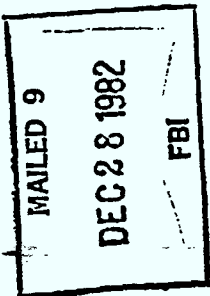

CRIMINAL INVESTIGATIVE DIVISION

On 8/21/80, four members representing the Greenpeace Foundation held an anti-nuclear demonstration at the White House. A 55 gallon barrel containing concrete and allegedly 1-1/2 oz. of Uranium tailings was left, along with a Geiger counter, to emphasize radiation contamination left by these tailings found in the western states of the United States. Tailings are by-products of Uranium processing which can be obtained at abandoned mine sites.

Military ordnance and police explosive ordnance personnel removed the barrel to Kingman Island, near R.F.K. Memorial Stadium.

At 6:45 p.m., the Nuclear Emergency Search Team (NEST), Department of Energy, advised FBIHQ Supervisor telephonically that the device was a hoax.

WFO is submitting a follow-up communication containing scientific analysis of the material contained in the 55 gallon barrel. At no time did this device present a threat to the health of individuals in the vicinity of the White House.

The Nuclear Regulatory Commission, Department of Energy (DOE), Department of Justice (DOJ) and United States Secret Service (USSS) are aware of the above.

SA Jeremy Margolis, Northern District of Illinois, advised on January 29, 1982, that there appears to be no violation of federal extortion statutes in this matter.

DOJ has also been requested to render an opinion.

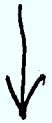

Attached teletype from Chicago advises of receipt on 1/28/82 by various news agencies in the Chicago area of packages containing a letter and video tape concerning the Commonwealth Edison Zion Nuclear Power Plant which is located along Lake Michigan near the Wisconsin border. The Chicago news agencies all reported receipt of such packages from an unidentified white female.

The letter contained in all the packages conveyed the following message:

"Zion Nuclear Power Station, January 27, 1982, this was a warning, the next attack will be real".

The video tapes, all of which appeared to be copies of a single master tape, all lasted two minutes and contained what appeared to be the cooling towers of the nuclear power plant at Zion, although positive identification could be made because the film was shot at night. Near the structure depicted in the film can be seen a series of flashing bursts.

As indicated in retel a group called Green Peace, 3171 North Halsted Street, Chicago, called a press conference on January 29, 1982, at which time the group claimed it had fired flares near the Zion Nuclear Facility in Zion, Illinois, on the evening of January 27, 1982. The flare incident had been videotaped by Green Peace who dropped copies of said tapes at various Chicago news media during the early morning of January 28, 1982. The unclaimed videotapes suggested that someone planned to attack the Zion facility. During the press conference Green Peace representatives claimed that they only fired the flares near the facility to demonstrate the vulnerability of the plant in case of terrorist attack.

As indicated in retel, a review of federal statutes by the Chicago Division and by AUSA Jeremy Margolis, Deputy Chief, Special Prosecutions Section, USA Office, Chicago, failed to reflect a federal violation in this matter insofar as no clear threat had been made against the plant and because no entry into the facility had been attempted.

IN retelcall Supervisor [REDACTED] reported that on May 28, 1982, Department of Justice official [REDACTED] had reviewed the facts in captioned matter and had come to the conclusion that no violation of federal statute had occurred. The Department desired no further investigation on this matter. Supervisor [REDACTED] advised that in view of the lack of federal jurisdiction, and the lack of a crime, no further investigation in captioned matter was desired and that no LHM or other disseminable communication was necessary.

In view of the above Chicago is conducting no further investigation in this matter.
