It had been intended by the prosecuting attorney that Mr. Murphy should present by means of fingerprint identifications evidence of the presence of Vernon C. Miller, Vivian Mathiev and Adam Richetti at the house formerly occupied by Vernon C. Miller under the alias V. C. Moore at 6612 Edgevale Road, Massas City, Missouri. During the course of the trial, however, the prosecution and defence attorneys stipulated the facts alleged in regard to the occupancy of the house. Mr. Murphy was, therefore, excused from further attendance on the court and allowed to return immediately to his official dutics in Mashington.

for the reason that all of their checks are filed numerically and not alphabetically, and more definite information would have to be supplied with reference to the cancelled checks in quastion, such as whether they were for a money order, a travelers evalue or an unlimited check order. Mr. Richer further stated that it might be ascertained whether their files contained any cancelled checks or information as to whether money orders had been mailed to #8 18th Street, Buffalo, N.Y., if the number of a money order or travelers check were supplied, or it was known from what agency the money order or travelers check originated.

Agent was further advised by Mr. Richer that they have approximately 50,000 to 60,000 money order checks, and approximately 75,000 travelers checks, and an unknown number of what is known as unlimited checks arriving every day, and for that reason a detailed search would be impractical.

In connection with the above entitled case, your attention is invited to the report of Special Agent in harge C. C. Spears dated at Portland, Oregon, December 31, 1934 in the case entitled JOHN PAUL CHASE, with aliases, et al -NATIONAL MOTOR VEHICLE THEFT ACT; OBSTRUCTION OF JUSTICE; HARBORING OF FUGITIVES; MURDER OF INSPECTOR S. P. CONLEY AND SPECIAL AGENT H. E. HOLLIS. This report contains a detailed statement by Joseph Raymond Negri, from which it appears that the Dillinger gang was responsible for the above bank robbery.

This statement further indicates that possibly "Pretty Boy" Floyd and Adam Richetti were confederates of the Billinger gang in the robbery at South Bend, Indiana. It is therefore suggested that in the event photographs of "Pretty Boy" Floyd and Adam Richetti have not been exhibited to witnesses of the bank robbery, that this be done.

#### MEMORANDUM FOR THE ATTORNEY GENERAL.

I have just been advised by the Kansas City Office of the Division that the Petit Jury has returned a verdict of guilty in the United States District Court for the Western District of Missouri, against Richard Tallman Galatas, Elizabeth Galatas, Herbert Allen Farmer, Esther Farmer, Frank B. Mulloy and Louis Doc. Stacci, on charges of conspiracy to deliver an escaped Federal prisoner, Frank Nash, which occurred June 17, 1933, at Kansas City, Missouri and resulted in the Steath of four peace officers, including Special Agent Raymond J. Caffrey, of this Division. Vivian Mathis, another defendant mamed in the indictment, entered a plea of guilty on December 51, 1934. No action has been taken against Frances Nash, widow of Frank Nash, inasmuch as she testified for the Government during this trial. It has been indicated that sentences against the above named will be imposed tomorrow morning.

## IN CASE OF UNITED STATES VS. GALATAS, ET AL.

-I make only one comment concerning the credibility of any part of the testimony in this case. That comment is not binding upon you because you are the sole judges of the credibility of the witnesses. Almost never do I make a comment upon the credibility of any witness unless I believe that some honest witness, who has tried to tell the truth, has unjustly been impugned, not by the attorneys necessarily, but perhaps by other witnesses, and then, whether he is high or low, illiterate or intelligent, black or white, I feel that I ought to say a word in his behalf. It is not binding upon the jury.

One of the witnesses who testified in this case, an agent of the Bureau of Investigation of the Department of Justice, testified that certain statements were made to him by certain of the defendants. He testified that they were voluntarily made, that he did not oppress the defendants, that he did not abuse them, that he did not coerce them. I think he told the truth. You may not. Each of us judges the credibility of a witness from our experience and observation in life, and I do that. In many ways the experience of each of you has been greater than mine, but for ten years in this court I have heard witnesses testify, thousands of witnesses, and long before that. Everything that was in the testimony of this witness, in his manner, in his demeanor on the witness stand in this trial convinced me, -- it may not have convinced you, -- that he was a worthy member of that Bureau of Investigation of the Department of Justice which,

as all American citizens know, is made up of a group of young men, most of them young men, led by a gentleman referred to in the testimony, Mr. Edgar Hoover, a young man, known not only for their high intelligence, for their moral and physical courage, for their devotion to duty which too often has required them to lay down their lives, but also for their fairness and integrity. I think that witness upon that matter told you the truth. You may think otherwise, and you are not bound at all by what I say in that regard.



Reference is made to Division letter cated Janua 1935 enclosing a communication from Special Agent S. K. McRee relative to an interview had by him with VivianO athis at Mansas City on January 3, 1935. Reference is also made to letter from this office dated January 10, 1935 relating to the same matter, with which were transmitted copies of a memorandum submitted by Special Agent M. O. Scott.

I am transmitting herewith to the Division and to Fr. Connelly and the St. Paul Office copies of a personal and confidential memorandum submitted by Special Agent W. F. Trainor relative to inquiries which he has made at the Pickwick Hotel. From the information obtained it will be seen that the incident referred to in Agent Scott's memorandum involving change for a 5500.00 bill on December 28, 1934 apparently has no significance in this matter. The alleged meeting referred to by Vivien Mathia in her conversation with Agent McKee occurred, according to Agent McKee's letter on December 29, 1934.

It is noted that Mrs. Brown, the cashier at the Pickwick Hotel, did not see Mr. Milligan in the suite of rooms in question at the time she was there. On the afternoon of December 28, 1934 Fr. Filligan called at this office at, to the best of my recollection, about 2 P.M. He remained in company with some of the Agents of this office during the remainder of that afternoon and evening. On that date there was under consideration the possibility of accepting from the defendant Fritz Dalloy a plea of nolle contendre, and Ur /1'illigan attended a conference in this regard at the martment of Sheriff Thomas B. Bash where there were present Sheriff Bash, Special Agent in Charge Vetterli, Special Agents Andersen and Trainor, the writer, Julloy and his friend June Kathryns. Mr. Wetterli and the writer left Sheriff Bash's apartment about 5 o'clock and Mr. Milligan was in the company of Agents Andersen

and Trainor until about 9:30 that evening, at which time he retired to his apartment at the Pickwick Hotel where Mrs. Milligan and their son and daughter were awaiting him.

As stated in my letter of January 10, 1935 Mr. Milligan was at his office on the afternoon of December 29, 1934, at which time he did not appear to have been drinking. My understanding is that Mr. Milligan proceeded from Kansas City on the evening of December 29, 1934 to his home at Richmond, Missouri, accompanied by members of his family, it being recalled that Mr. Milligan's daughter contemplated being married on or about January 4, 1935, and that there were certain necessary arrangements to be made for the wedding at Richmond.

It is noted that one of the telephone calls made from the suite of rooms at the Pickwick Hotel, previously mentioned, was to Mr. Milligan at Richmond on January 5, 1935 from Mr. Ayres. It is known that Mr. Milligan proceeded from Kansas City to Richmond on the night of January 3, 1934 and I talked to him by telephone on the morning of January 4, 1935 at Richmond. Mr. Ayres, who is a florist in Kansas City, is known to this office to have been an active supporter of former Congressman J. L. Milligan in the race which he made for nomination to the United States Senate during the Summer of 1934. My information is further to the effect that Pat Noonan was likewise an active supporter of Mr. Milligan's brother.

With reference to attorneys Cannon and Reynolds, mentioned in the memorandum of Agent Trainor, it is noted that Cannon was one of the attorneys representing Mr. and Mrs. Galatas at the recent trial, and that Peynolds was one of the attorneys representing defendant Stacci. So far as the information of this office goes both Messrs. Cannon and Peynolds are reputable members of the Kansas City Far and Mr. Cannon is supposed to be friendly to the faction of the Democratic Party with which Mr. Milligan and his brother are allied.

With reference to the instructions contained in the Division letter of January 10, 1935, that this office discreetly ascertain all facts in connection with the meeting which Vivian Mathia alleged was held in the Pickwick Motel, including the identity of all persons present at the conference, the Pivision is advised that it appears there is no way in which this information can be discreetly obtained here. It would seem necessary to approach some person in attendance at the conference in order to obtain this information. It would not seem wise to make a direct approach to either Stacci or Galatas in this regard and these are the only persons definitely named as having been at the conference, with the exception of Mr. Milligan. I con-

sequently hesitate to take this action, particularly in view of possible embarrassment with Mr. Milligan in the event it should be determined that the statements made by Vivian Mathia are not correct. If the alleged meeting took place in the apartment at the Pickwick which has been mentioned, on December 29, 1954, it would seem that Mr. Milligan might have been present without there being anything improper in his actions.

It is noted that the information furnished by Vivian Mathis concerning telephone calls from Sioux Falls, South Dakota to "ashington, D.C. is susceptible of checking from records. In the event the inquiry being rade by the St. Paul Office should not verify her assertions in this regard it would indicate to me that there is a possibility that her statements in regard to the other matters are not accurate. It is thought that the Division might desire to await a report from the St. Paul Office in this respect prior to any further inquiries at Kansas City.

It is further noted that in her interview Vivian Mathis definitely advised Agent McKee as to the alleged connections of the persons present at the Pickwick Hotel but did not give any names except those of Galatas and Stacci. It would seem that she would probably be in possession of more definite information, particularly as to the names of the attorneys in attendance inasmuch as she was present during at least a portion of the trial and saw the attorneys before the Court.

I might call the attention of the Division to the fact that from my observation and that of the other Agents of this office present during the trial of this case, it appeared that Mr. Milligan was vigorous in his efforts to obtain convictions of all the defendants on trial and there was nothing to indicate any desire on his part to favor any defendant. It is observed that prior to the submission of the case to the jury two counts of the indictment were dismissed on motion of the United States Attorney. However, during the discussion of this trial, over a period of several weeks prior to the date of the trial, both Mr. Milligan and his assistant, Mr. Randall Wilson, stated that they did not expect that a sentence would be imposed on more than one count of the indictment inasmich as Judge Otis had expressed his views on similar cases in previous trials. It is also my information that the dismissal of two counts of the indictment was in harmony with the appearent wish of Judge Otis.

## MEMORANDUM FOR SPECIAL AGENT IN CHARGE R. B. NATHAN:

Reference is made to Division letter to this office dated January 10, 1935 and to your letter to the Division of the same date, all under personal and confidential cover, referring to certain allegations on the part of Vivian Mathis and other individuals implying the possibility of a bribe having been offered to some Federal official in connection with the trial of the Kansas City Massacre case. It is noted that Vivian Mathis alleged that United States Attorney Maurice M. Milligan, of Kansas City, Missouri, was in a room at the Pickwick Hotel, accompanied by various other individuals, on December 29, 1934, and that she believed two of those parties were "fixers", two of them local police officers, two of them attorneys for the various defendants in the case in question and that there were other parties. It is noted that she did not mention the names of any of these parties except Louis Stacci, Richard Tallman Galatas, both defendants, whom she stated were present, and United States Attorney Milligan.

Pursuant to your instructions, I had a conversation with Mrs. Brown, the Cashier, at the Pickwick Hotel, with whom I am personally acquainted. I endeavored to secure from her all pertinent information regarding the matter discussed in the memorandum of Special Agent N. O. Scott, copies of which you transmitted to the Division with your letter of January 10, 1935.

It may be noted that in the letter of Special Agent S.K. McKee, copies of which were transmitted to this office with Division letter of January 10, 1935, it is stated, on page 3, that Agent McKee had received information from Special Agent in Charge Nathan relating to an alleged passing of a \$500,00 bribe on the afternoon of December 29, 1934 at the Pickwick Hotel. However, Agent Scott's memorandum does not show that the conversation between Mrs. Brown and him occurred on December 29th and the date is not therein shown. However, the notes of Miss Carr, the stenographer who wrote Agent Scott's memorandum, disclose that he dictated it on December 28, 1934. This is noted in view of the fact that Mrs. Brown has stated to me that the incident which she mentioned to Agent Scott took place on December 28th and not on December 29th, which was the occasion mentioned in Agent l'okee's letter when Vivien Mathis elleges she saw United States Attorney Milligan in the room of certain parties at the Pickwick Hotel.

Mrs. Brown advised me that a suite of rooms, three in number, which are rooms numbers 809, 810 and 811, was occupied from December 26, 1934 to January 6, 1935 by Mr. Pat Moonan, who is a

regular patron of the hotel, a political worker and friend of Senator Bennett Clark and former Congressman Milligan. She stated that during the period in question Bryson Ayres, a florist at Kansas City, and various lawyers, including Messra. Cannon and Reynolds (who were of the defense counsel in the massacre case) frequented the suite. She stated also that a man referred to by the other individuals as "Duke", whose name is Maxie Duco, and who is Sales Agent for Prima beer at Kansas City, frequented the suite. She advised that during the entire period when the suite was occupied there were numerous men there, and that very often one man or another from the room would come to the desk and request some service or another, such as cases of heer, for the suite.

She advised that on December 28, 1934, as the records show, the room rent was paid and that she believes Bryson Ayres or Mr. Noonan, she is not sure which, brought to the desk a \$500.00 bill with which the rental of the suite was paid, and that the change was to be brought to the room as soon as it could be secured since there was not available cash on hand to change the bill. She stated that she sent the change with a bellboy. She is positive that this was in the afternoon of December 28, 1934. She stated that shortly after the money had been sent up she received a telephone call from the room from some of the occupants, who stated there had been a shortage of \$20.00 in the change remitted, and that she went to the room personally and talked with Bryson Ayres and Pat Noonan, at which time Ayres told her that the change had been complete when it had arrived there but that \$20.00 had apparently been misplaced. She noticed that the money was all lying on a bed as though it had been counted over several times. She informed Mr. Ayres and Mr. Noonan that there could be no shortage in the money and thereupon she left, and in a few minutes received a further telephone call from the room stating that the additional \$20.00 had been discovered lying on the floor near the bed. On the occasion in question Mrs. Brown stated that she saw Mr. Noonan, she believes Mr. Ayres, Mr. Reynolds, Attorney and Mr. Cennon, Attorney. She is certain that there was no one else whom she knew at the suite on that occasion. She stated that shortly after the incident above mentioned, on the same day, December 28, 1934, Bryson Avres came from the room to the cashier's desk and left some \$360.00 for deposit with the cashier, saying that it was a part of the change from the \$500.00 bill. She stated also that on other occasions Ayres or Moonan had come to the desk with sums of money and had placed same on deposit, but that credit was not placed on the records for the suite inasmuch as she merely placed the money itself in the safety deposit vault since she knew that on short notice some of the parties from the suite might be later calling for it and she did not desire to run short from her regular cash. For this reason she advised that no permanent records of the hotel were made since she would merely give a receipt for the money when it was deposited and when it was given back the temporary record would be destroyed.

Mrs. Brown stated also that on December 29, 1934, which was the day following the above incident, Mr. Steed, the manager of the hotel, had occasion to go to the suite of rooms in question. Mr. Steed having been present he was requested to advise whom he saw in the suite on the occasion of his visit. He stated that he saw Mr. Noonan, Mr. Ayres and several people whom he did not know and whose names he does not recall. He advised that there were none of the other guests at the hotel in the suite of Mr. Noonen at that time and that he merely went there on invitation from Mr. Noonan. It appears that he went to the room for the purpose of having a social drink and from the account given by Mr. Steed the suite of Mr. Moonan was being used as a rendezvous for a holiday party over New Years. It was stated by Mr. Steed that Pet Noonan is a frequent patron of the hotel and that on each occasion when he comes he occupies a suite of rooms similar to the one occupied on this occasion. Incidentally, Mr. Noonan is now again registered at the hotel in a similar manner. It is stated by Mr. Steed that the regular rate on suite comprising rooms 809, 810 and 811 is \$9.00 per day, but that a reduction is customarily made to Mr. Noonan costing him 26.00 per day, which was the rate enjoyed from December 26, 1934 to January 6, 1935.

which she might have heard in the form of a rumor that there had been a bribe offered to enyone in connection with the Kansas City l'assacre case or any other case. She stated that she had heard no such rumor and that in a jocose manner she had remarked to agent Scott that things didn't look so good and that there would probably be "hell to pay" in Kansas City if Doc Stacci and others who were guests at the hotel were convicted. She stated, however, that she did not in any way wish to infer any discredit on any officials and that she had heard nothing to indicate a suspicion of such.

Both Mr. Steed and Mrs. Brown, at the Pickwick Hotel, were carefully cautioned not to divulge in any manner the fact of the above inquiry and they both promised faithfully that this wish would be respected.

Reference is made to letter from this office dated January 11, 1935 concerning information furnished to this office by the office of the United States Attorney regarding the identification of specimen shell case from one of the guns recovered from Floyd with shell cases recovered at the scene of the massacre by Merle A. Cill.

United States Attorney Milligan advised me today that it is his wish that the guns recovered from Floyd be made available to his office in order that they may be turned over to Gill for appropriate test shots and further comparison. It is his desire to use Gill as a witness in the event Richetti is tried in Federal Court, or to refer this phase of the evidence to the County Prosecutor in the event Richetti is tried on a charge of murder in State Court. He informs me that he expects to communicate with the Department for authority to employ Gill in this regard.

It is noted from the Division's Laboratory Peport dated October 30, 1934, in this case that one of the pistols recovered from Floyd bore number 18001, and that the other pistol had a defaced serial number, which, upon restoration, apparently proved to be C-84197. The Laboratory Report further shows that this latter gun had been converted in its method of operation so that it functioned in the same manner as a machine gun. It appears that it is this gun which has been identified by specimen shell by Gill.

From the Division's letter of Movember 24, 1934, to this office, referring to the request of the Missouri State Highway Patrol for further test shells, it is noted that it had been found desirable to destroy the working mechanism of one of the guns received from Floyd after a number of test specimens were prepared. It is not clear which of the two guns was so destroyed.

In the event the gun in which the working mechanism has been destroyed is the gun from which the test shell was fired and subsequently identified by Gill in connection with this case, it would appear that, in order to comply with the wishes of the United States Attorney, it would be desirable to forward further test shells made prior to the destruction of the working mechanism. The United States Attorney has not been informed that this gun is not in the same condition as when recovered from Floyd.

In accordance with Division instructions this office has not had any dealings or conversations with Mr. Gill concerning this matter. The United States Attorney indicated, during the conference had with him today, that in the event the guns are forwarded in accordance with his request he would desire that any tests and comparisons made by Gill be made in the presence of Division Agents. He has further indicated that he believes it would be desirable to have Gill endeavor to determine the semial number of the machine run recovered from Richetti, Gill having indicated to him that he could obtain this number. The United States Attorney seems to entertain the suspicion that if traced it might be shown that this machine gun was at one time in the possession of the Kansas City, machine gun was at one time in the possession of the Kansas City, which is possession of the Division as Mr. Milligan's thought.

By reference to the report of Special Agent W. F. Trainor, dated March 29, 1934, it will be seen that the shell case fired from a .45 automatic pistol is designated as Exhibit 3 and is mentioned on page six of the report. It is noted that only one such shell case was recovered and that no bullet from a .45 caliber pistol was recovered which could be identified as Exhibit J, shown in that report, had been so worn before its recovery that the markings were not sufficiently distinct. It will, accordingly, be seen that the markings which may have been made from the barrels of the guns are not interfal, the retorial marks being those which would be made by the bolt mechanism and firing pin.

In this situation I will be pleased if the Tivision will inform me as to its wishes. Fr. Filligan is quite interested in 3 - Director. this phase of the evidence and desires it developed to the fullest. In the event the evidence in this case is disclosed by Mr. Pilligan to the County Prosecutor, it is quite likely that he would desire to inform the press concerning the ballistic identification in order to obviate the possibility that the County Prosecutor might disclose this evidence at a later date as having been developed by him. I do not believe, however, that any disclosures would be wade by ir. Filligen until he is definitely convinced that the identification of Gill is accurate and available as testimony.

In advising me as to the Division's wishes I will appreciate further advice as to whether I should advise ?r. Milligan of the fact that the Tivision's experts do not consider !r. Gill's identification in this matter accurate.

An early reply containing the Division's instructions in this metter will be greatly appreciated.

Reference is made to your letters of Jamuary 11 and Jamuary 15, 1935, in connection with the ballistics evidence with regard to the case entitled Charles Arthur Floyd with aliases (Deceased), et al; Conspiresy to Deliver Federal Prisoner.

You are advised that the gum bearing the number 6-34197 has not been put out of service and is available if necessary for use as evidence in the prosocution of the case. You are confidentially advised, however, that certain movel conversions were made on this gum while in the possession of Floyd and the Division is reluctant to make public the method of conversion unless absolutely necessary to the trial of the case. In other words the cum would not be forwarded merely for examination by Merle A. Gill, but will be forwarded if the U. S. Attorney is of the opinion it is necessary evidence.

found at the scene of the Plaza murder reported by Merle A. Gill, you are advised that the Division Laboratory has been unable to consur with the findings of Mr. Gill on the basis of the photographs submitted. It is suggested the U. S. Attorney may care to request that the original shell, found at the scene of the Plaza murder and reported by Gill to have been identified, he submitted to the Division to determine if the Division Laboratory can, from the original evidence, confirm the findings of the expert Gill. In this respect the Division Laboratory would have the further advantage of having available the bolt on the gun itself for comparison with the alleged markings on the shell. Should the findings of the Laboratory be in accord with those of Gill the services of a Laboratory expert might be desired by the U. S. Attorney to collaborate the testimony of Gill regarding the identification. Should the experts of the Laboratory be unable to confirm the findings of Gill the information would undoubtedly be of value to the U. S. Attorney in planning his prosecution.

with regard to the mechine gum recovered from Richetti, upon which the serial number had been obliterated and which Mr. Gill advises he will be able to identify by number, it is suggested the U.S. Attorney be advised as to the present location of this gum and allowed to make his ewn decision as to the desirability of turning it over to Gill with a view to identifying the serial number.



Further reference is made to a letter from this office dated January 11, 1935 in the above case, which contains information given by the office of the United States Attorney, at Mansas City, Missouri, as to his plans in connection with furnishing evidence to the County Prosecutor at Manses City, l'issouri for use in a murder trial of Richetti.

The statement which the United States Attorney gave to the local press appeared in newspapers of Saturday, January 12, 1935, copies of which were forwarded to the Division. Fr. Milligan advised today that he has not had any communication from the County Prosecutor, Mr. W. W. Craves, since that date. He states it is not his intention to further communicate with Graves in an effort to have him prosecute Richetti but that he will proceed with the prosecution in Federal Court if action is not taken in State Court.

It is his plan to indict Richetti in connection with a further violation of the National Motor Vehicle Theft Act in regard to the car abandoned by Richetti and Floyd at Bolivar, Missouri prior to the kidnaping of Sheriff Killingsworth. With reference to the desirability of obtaining an indictment against Richetti charging the substantive offense of procuring the escape of a Federal prisoner, Milligan is doubtful as to the desirability of obtaining such an indictment in view of the wording of the Statute, which apparently does not include attempts to procure such escape. He expects to have a Crand Jury at Kansas City on January 28, 1935. If Richetti is tried in Federal Court, Mr.

Milligen anticipates trying him successively on the three indictments.

There is transmitted herewith a print of a microscopic/comperison photograph made by Merle A. Gill, local ballistician, which was handed to Special Agent Harold E. Andersen of this office by Assistant U.S. Attorney Rendall Wilson of Kansas City today. Mr. Wilson received this photograph from Gill with the information that Gill had made an analysis of a shell case part of which is shown ip the photograph which was received by him from Major L. M. Means of the Lissouri State Highway Patrol; that part of the photograph purports to be a likeness of a shell case fired from .45 calibre automatic pistol, and Mr. Gill informed that he received the information from Major Means that it is a specimen furnished the Highway Patrol by the Division as having been fired from .45 calibre Colt Automatic pistol, Serial No. 84,197, which pistol is said to have been recovered from the body of Charles Arthur Floyd when he was slain upon his capture by Division Agents. It was further stated to Mr. Wilson by Mr. Gill that this shell case has been positively identified by him with one of the evidence shell cases recovered at the scene of the Kansas City Massacre as having been fired from the same pistol.

The photograph as will be seen shows a microscopic comparison of parts of two shell cases, the one in the lower portion purporting to be from the test exhibit received from the Pivigson, end the one in the top of the photograph purporting to be a liceness of part of the evidence shell case. It will be noted, therefore, that Mr. Gill has now positively stated in identification between the shell fired from the Floyd gun and one of the shells found at the of the Massacre.

The Division may retain, if it so desires, this photograph in the files, as Mr. Wilson has advised that he will later secure the copies from Mr. Gill.

The question of prosecution of Adam Richetti in State and Federal Courts was discussed by Agents Andersen and Trainor with United States Attorney Maruice M. Milligen today, and he advised that he has now issued a steement to the press to the effect that he will swait the decision of the County Prosecutor W. W. Graves as to Mr. Graves' desire to prosecute Richetti on murder charges immediately. The press article will state that in the event Mr. Graves desires such action, the United States Attorney's office will fully cooperate by furnishing all aveilable evidence for his use, and it has been stated by Mr. Milligan that he will also submit to the Prosecutor a complete brief of evidence for use in the murder trial and will expect the essistance of the Agents assigned to this case in such procedure. Pursuent to the Division's instructions, Mr. Milligan has been advised that the Division is willing, subject to his desires, to furnish any and all evidence to the Prosecutor. Mr. Milligan has, of course, on a previous occasion made an appointment with Mr. Graves for this purpose, and Mr. Graves has failed to keep the appointment. It is expected now, however, that the County Prosecutor will desire to confer with the United States Attorney, and there is a probability that the murder charges may be brought within a short time.

that Merle A. Gill is in possession of the original evidence of a ballistic nature, he would be compelled to use him as a witness to authenticate the exhibits in court by shoring continuous possession. It was further stated by Mr. Milligan that in view of the fact that Gill has a favorable reputation as a ballistician in this vicinity, he will also desire to use him in that capacity. However, he is not desirous of procuring the assistance of Gill, or further developing the ballistic angles until after he hashad his conference with the County Prosecutor, since it may not be necessary to try Richetti in Federal Court. In the event, however, that the County Prosecutor in discussing this metter with Mr. Milligan should desire the two pistols recovered from Floyd, Mr. Milligan has stated that he will make request on this office that they be furnished to him, and that he will in turn loan them to the Prosecutor for the murder trial. He

also stated that the same procedure would be followed by him with respect to the machine gun and the pistol now in possession of the Kanass City office which were recovered upon the arrest of Adam Richetti.

Assistant U. S. Attorney Wilson has cautioned Mr. Gill to release no information whatever regarding his identification to the press, and he advised that Mr. Gill promised to respect his wishes.

The Division will be kept advised promptly of developments with respect to the trial of Richetti contemplated either in the State or Federal Court at Kansas City.





With reference to your inquiry concerning the date Galatas w considered as being a Federal fugitive, it is noted in the report of Special agent W. F. Trainor, July 15, 1933, Kansas Gity, Missouri, that a werrant was issued for Richard Tallman Galstas, by the United States Commissioner at Kansze City, charging Galatas with violation of Section: 88, Title 18, of the United States Code, in that he conspired with Frances Ince Nash, Herbert Farmer and Esther Farmer at Joplin, Missouri, on or about June 16, 1933, to violate Title 18, Section 55 of the United States code in that they agreed to effect the liberation of Frank Hash, a federal prisoner confined to the sustody of the Attorney General of the United States, and his authorized representatives. The overt act charged against Richard Tallman Galatas is set out as follows: That at Joplin, Missouri in June 16, 1933, he assisted Ers. Frances Inco Rash in transporting borself from the airport to the residence of Herbert A. Farmer at that place. A non est return was made on the warrant as to Richard Tallman Galatan and 1t would therefore appear that he was a Federal fugitive from the date of July 10. 1933.

It was determined by Special Agent in Charge R. B. Nethan from Colonel Marvin B. Casteel of the Missouri State Highway Patrol that the murder charge which the County authorities at Columbia, Missouri, had against Richetti and on which Richetti was being held without bail, was finally developed to be unavailing. It was discovered that two other individuals, not Floyd and Richetti, had actually killed the officers on 6-14-35. These two other parties are now in custody at Columbia, Missourie In view of that discovery Richetti was on 18-1-54 released by the Boone County authorities at Columbia, Missouri, to the Sheriff at Kansas City, Missouri, who brought Richetti to this point on a warrant charging murder in the first degree. Richetti has not however been brought before a Justic of the Peace at Kansas City on the murder, and he was turned over to the U. S. Marshal on 12-3-54 and on 12-5-54 he was brought before Federal Judge M. E. Otis on capiases issued pursuant to indictments returned in the Kansas City massacre case and the indictment charging interstate transportation of stolen Pontiac car from Bolivar, Missouri, to Kansas City, Kansas, which indictments have been heretofore reported. Richetti waived preliminary hearing and plead not guilty. His bond was on 12-5-34 set in the amount of \$20,000.00 on each charge totaling \$40,000.00. The Court stipulated that bonds to be acceptable must be approved by himself and furnished by a surety company or some other similarly solvent organization. Richetti was on 12-5-34 committed to the Jackson County Jail, Kanens City, Missouri, in default of these bonds, where he still remains.

In the report of Special Agent in Charge Dwight Brantley dated at Oklahoma City, Oklahoma, 11-30-34, in this case, it appears that the Pontiac Coupe, motor #898716, abandoned by Floyd and Richetti at Bolivar, Missouri, the morning of 5-16-33 was and is the property of one Joe Hudiburg, who now resides at Wewoka, Oklahoma. It further appears that this car was stolen from Hudiburg's garage near Cromwell, Oklahoma, the night of 6-8-35 by two men. In connection with this car U. S. Attorney Maurice M. Milligan, Kansas City, Missouri, has advised that he will seek to have Richetti indicted during the term of the grand jury which convenes 1-28-35 at Kansas City, Missouri, charging him with a violation of the National Motor Vehicle Theft

U. S. Attorney Maurice M. Milligan advised that he would desire primarily to have Richetti prosecuted in the State Court at Kansas City charged with first degree murder based upon his participation in the Kansas City massacre. It is believed by the U. S. Attorney that sufficient evidence is now available for a successful prosecution on that basis in view of the recent successful outcome of the conspiracy case as to the other defendants in the massacre case and further in view of the fact that there is one eye-

witness to the crime, namely Mrs. Lottie West, who will positively identif Adam Richetti in person as one of the participants of the shootings in addition to certain other strong circumstantial evidence which can be brought forth against Richetti in a murder trial. However, Mr. Milligan has previously made an appointment with W. W. Graves, Jr., County Prosecutor at Kansas City, in order that he might discuss the release by the Federal Government of all available evidence which might be used by Mr. Graves in such a prosecution. Mr. Graves has failed to keep his appointment. Recently Mr. Milligan issued a statement to the press, subsequent to the prosecution of the others in the Kansas City massacre case, to the effect that he is now ready and willing to turn over to the County Prosecutor evidence on the murder case against Richettie The Prosecutor has failed to make further. contact with Mr. Milligan. Accordingly, it has been stated by the U. S. Attorney that he will make no further overtures to the County Prosecutor in this regard and he has so written the Attorney General at Washington, D. C. He will, according to his present intentions, indict Richetti on the additional motor theft charge charging him with transportation of the stolen Pontiac Coupe from Cromwell, Oklahoma, to Bolivar, Missouri, on or about 6-16-33. This will make three Federal charges on which Richetti may be tried, namely the two auto theft charges and the conspiracy to liberate Federal prisoner Frank Nash, involved in the Kansas City massacre case. He expects a possible total sentence in these three Federal cases, if successfully prosecuted, of about seventeen years. In this event Richetti could, of course, be later tried by a County Prosecutor at Kensas City who might see fit to do so on charges of murder, and the U. S. Attorney is preparing a trial brief on the entire case with the thought in mind that it might be usable by a Prosecutor who might try Richetti for murders

In the first report of reference it will be noted that a lead is set out requesting investigation at the General Motors Acceptance Corporation, Kansas City, Missouri, to ascertain the motor number and details of the theft of Hudiburg's Pontiac Coups. Accordingly, the writer interviewed H. H. Hayden, Assistant Manager, General Motors Acceptance Corporation, Medical Arts Building, Kansas City, Missouri, and was advised after a check had been made of the company's records that the car in question is not listed with the Kansas City office. Mr. Hayden however stated that his company at Oklahoma City would undoubtedly have the desired information.

From a perusal of this file it seems desirable to secure definite evidence of the actual recovery of the car at Bolivar, Missouri, to be testified to by a person in position to state the motor number of this car. This might be done by a representative of the General Motors

Acceptance Corporation and in the event that no such record was kept, if the representative of that company actually turned the car over to the owner, Joe Hudiburg, he might testify thereto and Hudiburg, if he could produce his registration papers showing the motor number of the car, could thereby establish the identity of same. The report from the Oklahoma City office indicated a letter from Hudiburg does not reflect what records he has in his possession or whether he still has the car. In the absence of any other identifying records it seems advisable that the car now be inspected by an Agent if it is still in the possession of Hudiburg and that it be determined whether Hudiburg was able to identify the car by marks other than the motor number when it was returned to him. It will be noted that the motor theft charges and the indictment charging conspiracy in the Kensas City massacre case are very important in view of the fact murder prosecution might not be hed due to a peculiar local situation.

W. H. Coen, 4026 Olive Street, Kenses City, Missouri, was interviewed and stated that some time in June of 1933 he had occasion to stop at the home of his brother John A. Coen on the latter's farm located about one-eighth of a mile north of Ourway, Missouri, on highway #13. At that time he was driving a truck which was hauling a house trailer which he lived in. At about 3:45 A.M. on the morning in question some one knocked on the side of his house trailer and at his request opened the door and entered. He identified the photograph of Adam Richetti as a likeness of the individual who approached him. Richetti remarked "Our car has broken down" and asked Coen to tow the mechine to Bolivar, Missouri. Coen told them he would take the nob for \$4.00 and shortly thereafter he went to the car which was narked about one-eighth of a mile away in front of a filling station operated by an individual known as "Doc" Saeger. Richetti had preceded him back to the car. Upon his arrival at the filling station Coen observed a second man whom he identified as Floyd from a photograph exhibited to him-When Coen backed his truck up for the purpose of attaching the towing rope to the damaged car, Richetti end Floyd informed him that they would attach the rope and left him under the impression that they did not want him near their car. Coen described the automobile as a coupe of a rather heavy build. During his initial conversation with Richetti, Coen said he learned from Richetti that the timing chain on Richetti's car was broken. During this conversation Coen stated that he was very close to Richetti and from his observation and association with Richetti he felt certain that Richetti had not been drinking. The car was then towed to near the city limits of Bolivar when he was signaled to stop in order that Richetti might get in his truck with him to point out the direction of the garage they desired to be hauled to. Coen did not remember the name of the garage or the exact direction taken by him in the city of Bolivar. When he arrived at the garage, at around 7:00 A.M., he was paid \$4.00 and immediately departed. Coen stated that he

would attempt to refresh his recollection in order that if wanted as a witness he might be in a position to give more detailed informations. Com left the writer under the impression that he would make an excellent witness.

In the last paragraph on page five of the first report of reference it should be noted that Sheriff Killingsworth of Bolivar, Missouri, while held as a hostage by Floyd and Richetti on 6-16-35 in the Subjects' trip from Bolivar to Kansas City, he conversed with Floyd about the Pontiac Coups which had been abandoned at Bolivar by them that morning. It should be noted that when Floyd was asked if the car was "hot" he remarked that Killingsworth might as well use it as it would take a long time to trace it. It should also be noted that during this conversation Richetti remarked that he would teach some fellows not to lock a man in a garage any more. In connection with the latter statement it should be noted that Joe Hudiburg, owner of the stolen Pontiac Coupe abandoned at Bolivar, wrote the Oklahoma City office to the effect that the car had been stolen from his locked garage and that it was backed through the locked doors.

Adam Richetti was interviewed by Special Agent W. To Trainor and the writer on 11-4-34 at great length, which interviewed lasted several hours. At that time he refused to make any statement whatever except that he did admit having come to Kansas City with the Sheriff of Bolivar, Missouri, and some other man whom he believed to be a salesman, he, Richetti, being accompanied by Floyd on 6-16-33. He stated that they did come in a car which Floyd drove and that the car belonged to the "salesman". At that time he stated that he was intoxicated when the trip was made and that he was so intoxicated when arriving in Kansas City that he did not remember what else happened. He further stated subsequent to that that he and Floyd immediately left Kansas City upon arriving here on the night of 6-16-35 and the next thing he remembered was that Floyd let him out of a car at Texarkana, Arkansas the next day. Richetti has been subsequently interviewed at various times and maintained an attitude of almost total silence the same as before. However, on 12-4-34 after his return to Kansas City he was interviewed by Agent Trainor, in company with Deputy Sheriff John Kelley. Richetti on that occasion made one remark which seemed material in that he was asked regarding the extent to which he was intoxicated upon his arrival in Kansas City on the night of 6-16-33 and he stated that he was certainly not intoxicated at alle This will be seen as inconsistent with his previous statement. He also stated on this latter occasion when asked whether he had been in the habit of smoking marijuana that he had very seldom ever indulged in that habit and that the only time he could recall doing so was when in Oklahoma "the night Floyd and I nicked the car. Floyd had part of a package of cigarettes containing about three cigarettes. Richetti said he showed him, telling him that these were

marijuana cigarettes and that he smoked one on that decasion with Floyde An effort was made to cause him to elaborate on that partisular phase of the matter and he became silent and failed to do so. Subsequently on different occasions Agent Trainor and the writer have talked with Richetti in general, mostly pertaining to the Kansas City massacre case, and Richetti has said on these occasions that he was intoxicated when he and Floyd left Bolivar, Missouri, on the morning of 6-16-55 and that he remained in such a state of intoxication that he does not remember what happened all during the trip which brought him to Kanses Gity as he remembers having been here that night. However, Richetti has admitted to Agent Trainor and the writer that he end Floyd did abandon the Pontiac Coupe at Bolivar, Missouri, on the morning that they kidneped Sheriff Killingsworth and brought him to Kansas City and in discussing the question of Floyd and Richetti having taken the Pontiac Sedan from Mr. Griffity near Despwater, Missouri, en route from Boliver te Kansas City, he has expressed complete knowledge of the trip end admitted being ---present on same although he made no admissions in regard to who it was who forcibly took the car from Griffithe

Welter Griffith, 315 East Ohio Street, Clinton, Missouri, owner of Pontiac Seden, motor #P869269, appeared as a witness before the U. S. grand jury at Kansas City, Missouri, which returned an indictment against Richetti during October, 1934, in this case. While here he was further interviewed by the writer and advised that he is very positive that his car was transported by Floyd and Richetti into the State of Kenses on the trip which he and Sheriff Killingsworth of Bolivar, Missouri, were forced to make with those two individuals on 6-16-33. Griffith is a former resident of Kaneas City, Missouri, and is familiar with the streets of Kansas City, Kenses, and the point at which the state line passes between the two cities. He stated that Richetti and Floyd hailed him near Deepwater, Missouri, about 10:30 A.M., 6-16-33, at which time they were driving a light colored car the make of which he did not notice. They forced him, at the point of a pistol, to stop his Pontiac Seden which he was driving. As he paused he noticed that Sheriff Killingsworth was also present with Floyd and Richetti and at the time he did not know but what Sheriff Killingsworth was also a bandit. Floyd forced Griffith to move over from the driver's seat behind the wheel and Floyd took possession of the car driving it himself. Richetti and Killingsworth remained in the back seat and Richetti held a machine gun guarding/Sheriff Killingsworth and he, Griffith. Richetti on various occasions throughout the trip became rather rough in his treatment and boldly pushed Griffith about in the seet of the car for no apparent reason. Floyd commanded Richetti to desist in these acts. Richetti, according to Griffith, did not seem to be intoxicated and spoke in a normal fashion. At the time that Richetti and Floyd, with Killingsworth, changed from the car that they were originally

driving to the car of Griffith, he recalls that they moved a small trunk of olive drab color which was appearently quite heavy and appeared to be. on the erder of an Army officer's trunk, This was placed in Griffith's car. At the same time Griffith noticed that a glass container which apparently had contained liquor was dropped on the ground and was not picked up. He stated that there was no liquor of any kind or other form of stimulants in evidence on the trip and he did not see Floyd or Richetti partake of any drinking or use of drugs. He stated that it took approximately eleven hours to make the trip from the point where he was accosted near Deepwater, Missouri, to the time of arrival at the final destination in the industrial district of Kanses City, Missouri; that they proceeded by slightly used and unimproved country roads on this trip and that he recalls a stop which lasted about three hours in the rural section somewhere between Paols, Kanses, and Appleton City, Missouri, he could not definitely place that spot. He recalls that thereafter the car was driven to #71 highway which is in the west edge of Missouri, proceeding north and south, and that Floyd drove across #71 highway on to a dirt road for some distance when he turned north and they finally arrived in Kansas City, Kansas. He stated that Floyd drove back and forth on the streets in Kenses City, Kansas, as though he were looking for some one who might have had an appointment to meet him; that at least this was the belief of Griffith at the time. He stated that from Kansas City, Kansas, Floyd drove across the inter-city viaduct which connects Kansas City, Kansas, and Kanses City, Missouri, and that when about half way across this viaduot and at a point which is on the Missouri side, Floyd turned to the right and proceeded down a circuitous viaduct which leads into the industrial section. At the end of this viaduct he turned to the left, drove to a point on Hickory Street where he stopped the care Floyd go out of the car there and proceeded away into the darkness on foot. He returned within about fifteen minutes and at that time commanded Killingsworth and head Griffith, to get out of the car and to stand on the street corner near the car. This they did and Floyd and Richetti then drove the car down Hickory Street for about twoblocks, first advising him before driving away that he should wait about fifteen minutes and that he and Killingsworth might then come to the car and that the lights would be on. He stated that the car was still within his vision when it stopped about two blocks to the south after having been driven there by Floyd, accompanied by Richetti, and that he sew these two men take from the Pontiac Sedan the same small trunk which they had placed in it as heretofore mentioned. He stated that he also saw a dark colored car which appeared to be a Chevrolet Sedan drive up near his car at that point and saw Floyd and Richetti transfer the trunk to the Chevrolet and that thereafter this other car immediately departed. After waiting for the appointed time he and Killingsworth then proceeded to his cer, got into it and drove first to Lees Summit, Missouri,

from which place Killingsworth phoned to his wife at Bolivar, Missouri, telling her that he had been released. He advised that Floyd had instructed Killingsworth and himself not to give any notice to any officers or to any one else for at least three-quarters of an hour after they were released and that these instructions were faithfully respected.

Walter Griffith positively identified Adam Richetti
in person as the man who accompanied Floyd and who kidnaped him as
heretofore mentioned. He also identified a photograph of Charles Arthur
Floyd as the other individual. He could not definitely remember how
Floyd and Richetti were dressed but believed that Richetti wore a cap
and Floyd wore a light colored soft straw hat turned down on the sides.

Sheriff Killingsworth of Bolivar, Missouri, who has been previously interviewed, was again interviewed by the writer and he corroborated the statements of Griffith with reference to the trip in question.

It will be noted that according to Griffith, the owner of the Pontiac car above mentioned, Floyd actually took possession of the car and forced him, the owner, to surrender the control of it to him and Richetti on this tripe

Sturgie relative to securing a copy of the transcript of testimony presented to the corner relative to the death of Subject Flayd near Clarkson, Ohio, on October 22, 1934.

Mr. Sturgis advised Agent that the transcript of this testimony has not, as yet, been completed by his stanographer. He stated that the testimony taken was very complete, consisting of probably 25,000 words and that immuch as his stanographer is also working daily for three other parties, she has only been able to give her attention to this matter in her spare noments. While Agent was present, Mr. Sturgis communicated by long distance telephone with his stanographer in Lisbon, Chio, at which time he was advised that the transcript would be completed in two days.

With reference to the old wounds apparent on the body of Floyd at the time his body was prepared for burial, Mr. Sturgis stated that to the best of his recollection, the only scar was one on Floyd's leg which seemed to indicate that a bullet had grazed his shin at one time. He did not remember any old wound apparent in the shoulder. However, he stated that Dr. Roy/Costello who performed the autopsy would probably know more about this detail.

With the exception of the trial of Adam Richetti, held on charges of murder in connection with the massacre case. presumably this ends this, the most sensational gang outbreak to have occurred near at home, unless new facts might come to light some time implicating other persons. Verne Miller, thought to have been the one who actually fired the fatal thots; is long since dead as the result of the vengeance of his gangster contemporaries. Pretty Boy Floyd, listed as ring leader of the massacre, is dead from the gunfire of federal agents.

So passes another instance of the effectiveness of an aroused public awareness against the outrages of crime. The federal department of justice has responded to this awareness and is acquitting itself in a commendable fashion. Every other agency of the law, state and local as well as national, should show a similar response. Then the war can be won

Reference is made to Division letter of January 18, 1935, replying to communications from this office dated January 11 and 15, 1935, and concerning ballistics evidence with regard to the case entitled: Charles Arthur ("Pretty Boy")OFloyd, with aliases, (deceased), et al, Conspiracy to Deliver Federal Prisoner.

I have discussed with United States Attorney Maurice M. Milligen, and his assistant, Rendall Wilson, the suggestion that the original shell reported by Gill to have been identified be submitted to the Division to determine if the Division Laboratory can confirm the findings of Gill. The United States Attorney is not of the opinion that Gill would relinquish the shell, which is in his possession, for this purpose. He has advised Gill that the two guns recovered from Floyd have been requested by him of the Division for the purpose of turning them over to Gill for necessary examination. I explained to him the Division's position in this regard, and as an alternative suggested that the Division forward by registered mail to this office, or to the United States Attorney, further test shells from each of these guns and made with ammunition similar to that of the shell casings in Gill's possession and properly marked for identification by the individual firing the shells at Washington. This suggestion was made, due to the fact that the cases which Gill has examined and from which he has been reported to have made an identification were handed to him by Major L. M. Means of the Missouri State Highway Patrol, and there appears some question as to which of the shells turned over by Means was the one from which the identification was made. The United States Attorney is agreeable to this proposal, and it is, accordingly, requested that the Division prepare and forward the suggested additional test shells. The shell casing in Gill's possession is designated as 45 A C. P", and the bullets from the shells were, "REM-UMC according to my information, nickel costed. The United States Attorney is desirous of having this action taken at the earliest possible time, and it is, accordingly, requested that it be expedited, if the Division is agreeable to the proposal. With reference to the Division's suggestion that it would be desirable to have the original evidence examined by a Division expert, in order to either corroborate the finding of Gill, or to establish a disagreement with this finding, the United States Attorney appreciates the desirability of such action. However, as stated, he is not of the opinion that the original evidence could be obtained from Gill for this purpose. Merely for the consideration of the Division, in the event Gill, upon further examination of test shells, maintains that there is an identification, the United States Attorney suggests the possibility that arrangements could be made either for Gill to be furnished transportation to Washington for the purpose of taking the original exhibit to the Division's Laboratory, or that a Division expert be sent from Washington to Kansas City to examine the original here.

With regard to the machine-gun and pistol recovered from Richetti, and which are in the possession of this office, the United States Attorney has stated that it is his intention to allow Gill to make an examination of these exhibits.

For the information of the Division, I am transmitting herewith copies of a letter dated January 18, 1935, forwarded by Mr. Milligan to the Attorney General, is connection with his desire to employ the services of Gill as a balligatic expert.

One merlexical, beliestic expert of Henres City, is in possession of all beliestic evidence found in the Union Station Plaze masseare, incident to the attempt to sid in the escape of one Frank Nash, resulting in the sleping of one spent of the Department of Justice and three other officers, together with Mash; this avidence was turned over to him by the police shortly after the massacre occurred and has remained in his possession since that date.

In the solution of said case it developed that three was more the actual participants in the killing of these officers, towit, Varnon C. Miller, Charles (Fretty Boy) Flowd, and Edema Fichetti. ince that time Varnon C. Miller has been killed, and recently Charles (Pretty Boy) Floyd was killed by federal agents, and Adam Richetti captured and is now in the county jail pending trial for conspiracy to aid in the escape of Nesh and with a violation of the Tyer Lot.

In the possession of Floyd and Bichetti were found only m chine cun and three automatid pistols upon the capture of Richetti and the killing of Floyd.

It is the desire of our office that these guns be turned over to Merle Gill with a view that he may make tests and comparisons with the hallistic evidence taken in this Station Plaze matter. From some preliminary examination he has already made relative to one of the shells found in Floyd's pistol we are of the opinion that further investigation will definitely fix the status of this gun as being used in the Disting Plaza killing. On Jamuary 21, 1975, there appeared a man at this office, giving his name as Sam Rosenfeld, 1803 North Vestern Avenue, ipertment 103, phone 4-7307, Oklahoma City, Oklahoma. He said that he has pending in the United 5tates District Court a case against him for violation of the liquor laws. He stated that he is not seeking any favors and does not desire that we do anything for him or make any pleas in his behalf in connection with the case pending against him.

Rosenfeld informed me that he formerly was employed at the Sexton Rotel in Kannas City, Missouri as Superintendent of Service, and that for years there has been going on, on the sixth floor of this hotel, a big pendling game. This cambling game, he stated, is frequented by one Dominik Bennagio, notorious Italian character of Kansas City; and other characters of Kansas City's undersorld.

Resenfeld stated that shortly after Bennagio's return from St. Louis, Missouri, at which time he was taken into sustody by Division Agents, he had becasion to overhear some conversation between Bennagio and one "Puppy Red", whose real name to Rosenfeld is unknown. He said that "Puppy Red" is the "stick men" in the garbling joint on the sixth floor of the Sexton, and is quite friendly with Bennagio. He stated that this conversation between Bennagio and "Puppy Red" related to occurrences which took place during the time that Bennagio was in oustody of Division Agents; that Bennagio went on to relate how he was beaten and abused, and that the Agents were trying to obtain information from him concerning the Kansas City Massacre, but that he told them pothing. Rosenfeld said that during the conversation between these two men, he heard remarks which tended to indicate that "Puppy Red" is the person who drove the mutomobile out of Kansas City, containing Floyd and Richetti, Following the messacre at the Union Station. He said that "Puppy Red" remarked to Bennagio that he, "Puppy Red", should leave town Lamediately, but that Bernagio told him that he had nothing to worty about because nd one knew that he was involved in the affair in any way.

Rosenfeld stated that "Puppy Red" is a tough individual, does a lot of drinking and frequently is armed. Rosenfeld stated that it is generally rumored that John Lassia, deceased, and his gang came late possession of a number of automatic pistols which were stolen from the possession of Armory in Kansas City, Kansas and that he has seen, in the possession of "Puppy Red", a Colt automatic, and he has reason to believe that this automatic is one of those stolen from Kansas City, Kansas. He described "Puppy Red" as follows: igs, 58 of 33; weight, 190 lbs.; stocky build; 5' 10"; sandy red hair; that he is on the inside with the gang in Kansas City and with the Police and he is not sure whether there is any record of him at the Police Headquarters.

Rosenfeld informed me that one Lonnie Affronti, an Italian of Kansas City, who is wanted by the Covernment on a marcotic charge and who killed a Government witness some time ago, is a friend of this gang. He stated that it is his impression that Affronti is still wanted and that if such were the case, he believes he is in a position to confidentially obtain information as to his whereabouts, but that it will take him some time to deso as he will have to make a trip out of Oklahoma City to obtain the information.

The records of this office show that Lonnie Affronti with aliases is the Subject of Division Identification Order No. 1169, issued September 8, 1932, which reflects that this individual is wanted for violation of the Harrison Marcotic Act. Reference is made to your personal and confidential letter of January 18, 1935, which relates to my letter of January 10, 1935, and a memorandum submitted by Special Agent N. O. Scott under date of December 31, 1934.

In accordance with your instructions I am setting out herein my reasons for taking no action regarding Agent Scott's memorandum at the time it was submitted. Agent Scott first verbally reported to me the incident relating to his conversation with the cashier at the Pickwick Hotel and was instructed to submit the entire details of his conversation, as recalled by him, in a memorandum. As stated in my letter of January 10, 1935, this memorandum was then carefully considered by me.

The information concerning the teking of change for the \$500.00 bill to a certain room in the Pickwick Hotel by the cashier, Mrs. Brown, appeared to me to be the only item mentioned in Agent Scott's memorandum concerning which there was any definite knowledge on the part of Mrs. Brown. It is noted that she did not advise Agent Scott that this change was taken to a room occupied by either of the defendants or by any one connected with them, nor did she indicate to Agent Scott that any one in any way connected with this case was present in the room at the time the change was taken there.

The reference made in Agent Scott's memorandum to Mrs. Brown's understanding that a bribe had been offered to some person "not in authority" appeared to me to have no connection with the \$500.00 transpaction and further impressed me as being more in the nature of gossip or rumor. My experience has been that such rumors arise often in connection with trials of important cases and that in the large majority of instances

they are unfounded.

In my consideration of the metter which resulted in the decision that no action was warrented, I endeavored to recall to mind all persons having any official connection with the trial of this case who might possibly have been approached by any one with the view to offering a bribe. I could not conceive that any of such persons could possibly be approached in this manner and the possibility that the sum of \$500.00 cm any portion of it would in any way influence any of such persons, appeared to me to be so remote that it would not warrant further consideration. From the nature of the case and its importance to all persons involved in it, it would seem to me that if any thought were given to the possibility of a bribe, no one would consider an offer of such a small sum.

At the time this matter arose the conspiracy case had gone to trial. The desire uppermost in my mind was that the trial should be successfully concluded to the entire satisfaction of the Division. I felt, perhaps erroneously, that any collateral inquiries made at that time might react unfavorably and jeopardize the success of the trial.

I regret that my actions in connection with this matter do not meet with the approval of the Division and hope that the explanation contained in this letter will clarify to the Division the position which I took.



With regard to the travel in Florida, you are advised that it was performed by Special Agent J.P. Lacour upon instructions from the Division, for the purpose of transporting special firearms and ammunition that were needed during an emergency that arcse during the investigation of the Bremer Kidnapping Case in that vicinity. The fastest possible means of transportation was imperative.

The transportation between Chicago and Kansas City was also of an urgent nature for which the use of a chartered plane was requisite. This travel involved both the Bremer Kidnapping Case and the so-called KansasCity Massacre, a case involving an attempted frustration of Federal justice. 

The writer was astounded at hearing such a declaration from the Jonal science of Folice at Kensas City whose department had lost two of its detectives in the shooting. However, as I was a stranger in Kansas Sity and as both 8,3 Vetterli and 8.3 Harvey had worked with the two officials with whom we were conferring I had very little to any except that I do recall stating in the presence of both Mr. Reppert and Mr. Higgins that while the attempt to liberate ik sh was a fuderal offence murder had been committed wherein two members of the Kanada City Police Department had been killed, and it would cartainly appear to me that the printry came would be a marder case to be prosecuted by the State of Missouri. I do not recall that any answer was made by either Reppert or Higgins to this statement.

Shortly after leaving the Police Station, I rewarked to S.C Vettorli and SkO Harvey that in all my experience I had never heard a more astounding

statement to be made by a Commissioner of Police, especially as he had had two of his own men mardered.

I only not Commissioner Reppert and Chief Higgins on two eccasions after this meeting. One was on the occasion when I accompanied S.C Vetterli to Er. Higgins were furnished confidentially with details of evidence that had been developed at that time by Special Agents of the Division. It the time it was agreed to furnish Mr. Reppert with this information, I strenuously objected feeling that Mr. Reppert had requested this information solely for the purpose of giving it to the newspapers in an attempt to show the people of Kanana City that the Police Department had made some progress in solving the case. Mr. Reppert previously had stated to SEC Vetterli if this information was furnished him the Police Department of Kanana City would clean up the case in 45 hours.

wome two days after the meeting with Mr. Repport in which the evidence developed had been given him and the 48 hour time-limit having expired, I suggested to opecial Agent in Charge Vetterli that he call Mr. Reppert over the telephone as we had heard nothing from him. 5/3 Vetterli called him and by appointment the writer and Sud Yetterli called upon Mr. Reppert at his office in the Police Station. Before talking to us he sent for Shief of Detectives Higgins. Reference is made to a letter from the Kansas City office to the Division, dated December 10, 1934, and to Division letter, dated December 31, 1934, which relates to an alleged grievance Major Wint Smith, head of the Kansas State Highway Patrol, is said to have against certain officials of the Division.

I should like to state in the beginning of this letter that if Major Smith has a grievance against any representative of the Division, it is probably against me. The so-called grievance, if any exixts, is attributable to my refusal to turn over to the Kansas State authorities tributable to my refusal to turn over to the Kansas penitentiary and notorious Frank Delmar, an escaped convict from the Kansas penitentiary and notorious bank robber against whom charges are pending in the Western District of bank robber against whom charges are pending in the Western District of Oklahoma at this time. I have had no personal conversation with Smith concerning the Delmar affair, but it came to my attention through Agents O. G. Hall and Paul Hansen, who effected the apprehension of Delmar, that Smith felt that we should turn Delmar over to him and our refusal to do so piqued him considerably.

I recall distinctly that on Sunday, October 14, 1934, Special Agent in Charge Nathan, of Kansas City Office, called me with respect to the matters outlined in his letter to you of December 10, 1934. I told the matters outlined in his letter to you of December 10, 1934. I told that this office knew Dewey Hutchison and the Brashears referred to in said letter, and that they were wholly unreliable. I further insformed me, Nathan that Agents of this office were familiar with one Brown, an informant of the Kansas State Highway Patrol, and considered him unreliable. I informed Mr. Nathan that none of us here knew Metcalf, referred to in said letter, but that I would make discreet inquiries in an effort to ascertain his identity and whether he was reliable. I, of course, did not disclose to them the reason for the inquiry, nor did I, either directly or indirectly, suggest that any raid be made at any place in an effort to locate Metcalf. Similar inquiries were made of the Oklahoma City Police Department with the same results.

It is observed from the letter of Mr. Ne than to the Division that Major Smith is alleged to have said that a raid was made by Agents of thes office at a point near Tulsa in an effort to effect the apprehension of Charles Chapman, a notorious bank robber. A raid was made at a point near Sand Springs, in which Agents of this office participated, and said raid was made purusant to my instructions after the place had been under surveillance for some time. The raid, of course, was unsuccessful in the apprehension of Chapman or any other individual wanted by this Division or any other law enforcement agency. We were not at the time working with Major Smith or any of his representatives, and I felt then , and feel now, that we do not have to obtain the permission of Major Smith to make raids in any cases under investigation by us. Subsequent developments disclosed that Chapman had not been frequenting the place near Tulse which was raided, There is a person by the name of Brashear in that community who bears a strong resemblance to Chapman.

Subsequent events disclosed that the so-called "hot" information with respect to Floyd's presence in Kenses City on or about October 14, 1934, was misinformation.

Special Agent John B. Little of this office informed me that on January 3, 1935, he contacted Chief of Police Bolton and Chief of Detectives Woolsey of the Muskogee Police Department by telephone and made inquiries as to whether they had made such a raid in an effort to locate one Metcalf, and both of these officers informed him that no such raid had been made.



Special Agent in Charge R. B. Mathen of the Kansas City office, by letter dated December 10, 1914, advised that he had been informed by Special Agent N. O. Scott of his office that Major Wint Smith, head of the Kansas State Mighway Patrol, held a grievance against him and felt that in a recent matter he had failed to play fairly with Mim. According to Agent Scott, Major Smith advised that he had requested Mr. Mathen to take no action in connection with a party purported to be residing at Muskogee, Oklahoma, that would make his place of residence "hot", but that Mr. Nathan did immediately take action, which resulted in a raid being made by the Muskogee, Oklahoma police. Mr. Mathan stated the details as to this information are as follows:

On October 14, 1934 Major Smith, accompanied by one Jim Bracevell, a special efficer connected with the pipe line company in Oklahoma, called at the Kansas City Division office, at which time these gentlemen advised that they had definite information that Floyd was then in Kansas City, that one Brown, who is employed as a special efficer by the Kansas Stating that one Brown, who is employed as a special efficer by the Kansas State Bighway Patrol, was then in Kansas City, in company with one June Brashear and a woman named Kilene Baldwin of Espulpa, Oklahoma. They further advised that on the preceding evening Brown and Brashear saw Floyd, accompanied by an Oklahoma Batlaw named Deway Butchinson, at a might club in Kansas City, at which time Brashear made arrangements to meet Butchinson on the following day. They further furnished information to the effect that Floyd and Butchinson had recently been at Enskoges, Oklahoma, the point of contact there being the residence of an individual named Metcalie.

During the conversation Major Smith requested that no activity be taken by the Division at Muskogee, Whishoma, inassuch as he felt that it would be underirable to make the spot there "hot". He also mentioned at this time that a raid had been staged recently by Agents of the Oklahoma City office at a point near Tules, Oklahoma in an effort to locate one Chapman, wanted as a bank rebber, and that this raid had been prematurely staged. In accordance with the arrengements effected with Major Smith at this time, Epecial Agents Andersen and Trainor of the Kansas City office, accompanied by a Highway Patrolson named Anderson, trailed Brown and his companion at the time they proceeded to make the supposed contact with Floyd. These persons later reported to Major Smith that they had gone to the designated house. However, the Agents and Patrolson Anderson stated that Brown did not go to this house. Further inquiries made by the Kansas City office determined that there was absolutely no basis of truth in Brown's information.

Upon receipt of the information from Major Smith in regard to the spet at Muskegee, Oklahoms, Mr. Bathan called Special Agent in Charge Brentley of the Oklahoma City effice for the purpose of determining the probability of the information being correct. Special Agent in Charge Deight Brantley of the Oklahoma City office, by letter dated January J. 1935, stated that, when he received the telephone call from Mr. Hathen, he advised him that his office knew Dewey Butchingon and the Brashears and that they were wholly unreliable. ### MEMORANDUM FOR MR. TANK

I telephoned Mr. Ladd at the Chicago Office and told him that
I was very much concerned over the complaints which had been coming
in, even before yesterday, from the other Chicago newspapers relative
to the Chicago American and the stories their reporters get the "scoops"
on. I stated that the Chicago American had the wrong "scoop" yesterday;
that the other Chicago papers quote me as saying that there wasn't any
truth in the article in the Chicago American; and that these papers quote
him, Mr. Ladd, as saying he had never heard anything about the matter,
and that Bolton had not been questioned about the St. Valentine's Day
Massacre.

Mr. Ladd advised me that the Chicago papers quoted him as saying that we had no statement, oral or written, from Bolton concerning the Massacre case, which was the statement he, Mr. Ladd, had made to the papers.

I inquired if Bolton had been questioned concerning the Massacre and Mr. Ladd said that he was not questioned directly because they were enxious to get other information from him; that he was only asked if he knew anything about it and he replied that he did not, that he had nothing to do with it.

I remarked that the thing which had been causing me concern for some time was the thought that there might be a "leak" somewhere in the Chicago Office; that I had this morning received some very reliable information, however, that the Chicago American has seven wire tappers who are tapping telephone wires; and that the Chicago American had had our wires tapped. I suggested to Mr. Ladd that he check on this angle immediately through some man in the hicago Office who was efficient along that line. Mr. Ladd stated that Agent J. L. Madala was the only man they had who could handle the matter, but that he was out on an assignment with Mr. Connelley at the present time; that, however, he could get the Telephone Company to check on it for us. 
