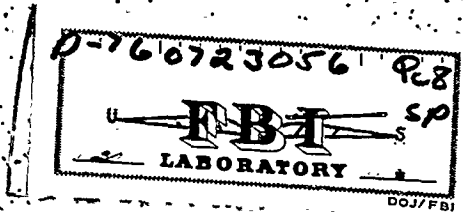

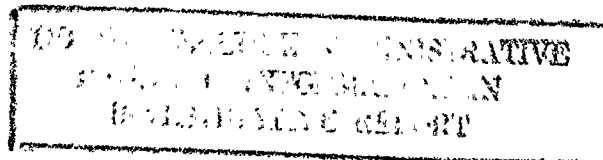

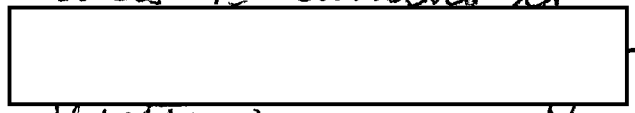

Lab, as indicated in referenced communication on 7/13/76, and file review of USSS C02-69967, Laboratory has established the writer as one in same person who remains unidentified to date.
