BEATRICE MERKEN'S address was listed as 2314 28th Street, Astoria, Long Island, New York, her birth place as Fall River, Massachusetts, and her age as 24 years old. Her parents were listed as ABRAHAM B. MERKEN and PAULINE SCHWARTZ, both born in Russia.

The application for marriage license indicated that LEVISON'S first marriage had been annulled on June 21, 1942 in Westchester County, New York, and that this was the first marriage for BEATRICE MERKEN. The name of LEVISON'S first wife did not appear on these records. The couple were married by Rabbi NA.PHTALI FISHBERG, 25-10 30th Road, Long Island City, New York, and witnesses to the marriage were JEANNETTE KAUFMAN and ESTHER SCHWARTZ.

The Marriage License Bureau records for the Borough of Manhattan, as checked on July 21, 1953 by SE [REDACTED] reflect the following information on certificate number 7160, for the year 1939:

She was described as a medical student, age 26, whose father, LOUIS L. ALTERMAN, was born in Russia and mother, REBECCA (nee COHEN) ALTERMAN was born in the United States. The couple were married by Rabbi ARON L. WEINSTEIN of Jamaica, Long Island. The witnesses were BELLE S. SCHIFFER and ELEANOR HAYDEN.

The records of the Bureau of Vital Statistics, Borough of Manhattan, were checked on June 3, 1953 by SE [REDACTED] and reflect that JANET DOROTHY ALTERMAN was born in Manhattan on May 28, 1913.
