## Cleaning Lady Scrubs Bomb In Music Hall

NEW YORK (UPI) — Mrs. Marie Hurst, an elderly cleaning woman at Radio City Music Hall, found a homemade bomb wired to a battery and watch in a ripped open seat cushion yesterday.

She took the device apart and continued work.

At the end of her shift Mrs. Hurst gave it to her supervisor, who called police.

Members of the bomb squad said the device was an apparently defective bomb which had had been set to go off at 8:50. They said Mrs. Hurst "could have been blown up."

## Explosive Device Found in Theater

NEW YORK (AP) — A cleaning woman found an explosive device under a seat at the famed Radio City Music Hall today and partially dismantled it before notifying the theater's security guard, police reported.

The woman found what appeared to be a full pack of cigarettes. Feeling its weight, she tore off the wrapper and exposed the device.

The police bomb squad said the contraption contained highly explosive powder with a wrist-watch timing apparatus that included intricate wiring and three tiny camera flash bulbs.

Police identified the woman as Marie Hurst.

The Music Hall, seating 6,200 persons, is the largest indoor theater in the world. A part of the Rockefeller Center complex, it shows first-run films and stage spectacles featuring the Rockettes, ballet company, a symphony orchestra and guest artists.

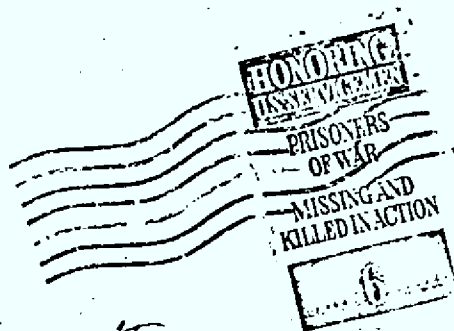

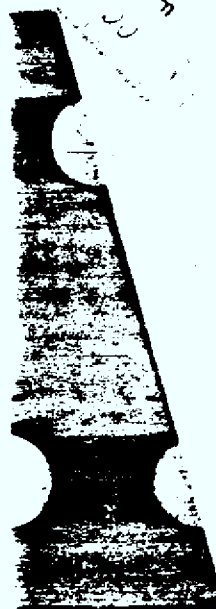

**Result of examination:**

Specimens Q1 through Q5 were not identified with specime in the Anonymous Letter File. A photograph was added to this file for future reference.

It was determined the script handwriting on specimens Q1 through Q5 was written by one person. The hand printing on Q2 and Q3 is not comparable with script handwriting.

Because the questioned handwriting and hand printing may not represent the normal writing habits of the writer, it was not determined whether [REDACTED] did or did not write specimens Q1 through Q5.

No watermark, indented writing, or other indication as to the origin of the envelopes or paper was found. The postage stamps were removed from a sheet or sheets of stamps.
