On 11/27/56 the writer discussed this matter with [REDACTED] of the Bureau. At that time [REDACTED] indicated that he felt that there were some men in the NYO who had had fairly recent training in [REDACTED]. He stated he would check his records and let me know.

On 11/28/56 [REDACTED] telephonically advised that the Bureau's records reflect that in September and October, 1956 SAS [REDACTED] and [REDACTED] attended a special two-weeks school at the Bureau which covered just this phase of training in [REDACTED]. Under the circumstances [REDACTED] felt that before proceeding with any further training we should specifically ascertain whether these men are, in fact, capable of handling the work.

I then discussed with [REDACTED] his reaction to the suggestion that when additional personnel are trained they include a photographer on the theory they were less susceptible to training and on many occasions a photographer would be an adjunct to the [REDACTED] operation. [REDACTED] indicated he would look favorably upon this suggestion in the event the above named three Agents were not capable at the present time to handle [REDACTED] assignments. [REDACTED] did point out that if such were the case it would be an indication that their school was not successful.

NOTE: It is noted that none of the above three men are listed in our Special Book and same should be revised.

Reference is made to my prior memo suggesting a photographic or stenographic personnel be afforded [REDACTED] training.

On 11/15/56, the writer had occasion to require this ability on an emergency basis involving the investigation of the [REDACTED] who fled this country for the Soviet Union in possession of American atomic secrets. Particular incident involved an emergency use of the [REDACTED] technique. I examined a list of those agents who have had this training. Of the six listed, three indicated that they had not had any practice for from five to ten years with this technique. They were willing to make their services available, but expressed doubts as to their ability to do a satisfactory job after so long a period of inactivity.

The remaining three were not available in the office in time to be of assistance in this particular case. The writer does not know whether these remaining three would consider themselves sufficiently experienced to handle the assignment.

The agents who have indicated that lack of recent experience might preclude them from a successful operation are: SAS [REDACTED]

SAS [REDACTED] and [REDACTED] were not available for use on this assignment.

It is again requested that consideration be given to training someone in the photographic laboratory in this technique. It is believed by training such personnel, that the personnel will be available when necessary to utilize this technique. They would combine the technique with photographic ability, which is always a necessary requisite in any [REDACTED] matter.

You are aware that [REDACTED] has been transferred to the Office of the Legal Attache, Bonn, Germany, and is expected to depart this office on or about 12/1/56, for Germany.

[REDACTED] has for many years served this office on [REDACTED] assignments. The writer is aware that agents of the office have received Bureau training in [REDACTED] and these agents are assigned to various squads throughout the office. The writer does not know the degree of proficiency of many of these agents to handle a [REDACTED] assignment.

It is suggested that you may wish to give consideration to having the Bureau train additional office personnel in [REDACTED]. It is further suggested that such training be afforded responsible clerical, stenographic or photographic personnel rather than agent personnel. In every [REDACTED] assignment there is required either photographic ability or stenographic ability to fulfill our responsibilities. If the [REDACTED] training was combined in this type of personnel it would enable the person handling the [REDACTED] assignment to complete the assignment rapidly and efficiently. Time is always of the essence in such assignments.

It is believed that this suggestion has the added merit that our experienced stenographic and photographic personnel have been with us many years and can be expected to be with us many more years, thus the value of the training afforded would not be lost, as it is when agent personnel is trained, by reason of the transfer of the agent personnel.

SA [REDACTED] has advised me that he is interested in being trained in the use of x-ray equipment for possible assignment to this type of duty in the NYO.

As to background, SA [REDACTED] has held a Second Class Radiog. Telegraph and Telephone License. He has served as a monitoring officer for the Bureau in CW radio. He has had a course in General and Modern Physics while in college and has a degree in chemistry. He has also had many years of experience as a Bureau sound man.

Although I feel that he may be qualified for this type of training by the Bureau by reason of his background, as set out above, I should like to point out that his services as a sound man are very urgently needed and in view of the present trend in this type of activity, I feel that assigning him to x-ray training at this time would not serve to benefit the Bureau. Therefore, I do not recommend him for the x-ray equipment training.
