RUMORS OF RACIAL VIOLENCE GROWING OUT OF DOUBLE HOMICIDE INVOLVING RIVAL MOTORCYCLE GROUPS, CLEVELAND, OHIO, FEBRUARY 28, 1968

The Cleveland "Plain Dealer", February 29, 1968, edition, carried an article captioned, "Cycle Gang War Ends in Death of Innocent Victims". This article stated that ROOSEVE BROWN, age 38, a Negro, and JAMES O. TILLETT, age 38, a white, were shot down in the early morning hours of February 28, 1968, at Barto's Cafe, 3344 East 93rd Street, Cleveland, Ohio. The article stated that they were innocent victims of a blossoming gang war between members of the Hell's Angels and God's Children. The article went on to say that the two victims were shot by members of the Hell's Angels gang who were out 'taking for members of the local chapter of God's Children. According to the article the cause of the gang war was the effort of the Hell's Angeles to organize a Cleveland Chapter of the gang, which is headquartered in California, and is supposedly militantly anti-Negro. The God's Children gang, an interracial gang which supposedly claims the Eastern United States as its territory, is violently opposed to the organizing efforts of the Hell's Angels in Cleveland.

The article stated that the Hell's Angels chapter was organized in Cleveland about two or three months ago and they have been attempting to recruit additional local members. Conflict between the Hell's Angels and God's Children reached the boiling point after a fist fight between two representatives of the gangs after a cycle show on February 18, 1968. The Hell's Angels man lost the fight and talk of retribution began immediately, adding fuel to the territorial fight. Both gangs




were out on the night of February 27, 1968, looking for each other, but they never met. Members of both gangs were armed. The Hell's Angels reportedly gathered at Barto's Cafe in the early morning hours of February 28, 1968, after their fruitless search for God's Children. They beat up a Negro B. APPROX piano player, ROBERT WILLIAMS, age 30, at the Cafe but stopped when the barmaid intervened. For a time the 15 or 16 members of the Hell's Angels were orderly, did not cause any trouble, merely played pool and drank beer.

Then a group of the Hell's Angels gathered around ROOSEVERT BROWN and they began to break beer bottles over his head. FAMES O. TILLET attempted to intervene and was shot. PROWN toke away from the group and ran behind the bar, where he was followed by one of the gang who shot him in the back.

Source who are familiar with the racial situation in the Cleveland area were contacted on February 28, 1968, and directed to ascertain whether the gang war between the Hell's Angels and God's Children would result in racial disturbances in this area because of the possible racial overtones involved. These sources advised that they had determined that no unusual racial tensions existed in Cleveland because of the above-described incident.

"The Cleveland Press", February 29, 1968, edition, carried an article captioned, "STOKES Declares War on Motorcycle Gangs". This article stated that Mayor CARL B. STOKES held a meeting on February 29, 1968, with Chief of Police MICHAEL BIACKWELL, Safety Director JOSEPH MC MANAMON, and Homicide Chief DAVID KERR. At this meeting Mayor STOKES announced that outlaw motorcycle gangs will be driven out of town. He declared, "We're not going to let any terrorist gangs take over. We will not let these hoodlums be the cause of plunging our city into a blood bath".

On November 3, 1977, at 12:26 A.M., an explosion of unknown origin occurred at 215 State Street, Binghamton, New York, a four story commercial brick building, the ground floor of which is the local headquarters of the Hells Angels Motorcycle Club.

The building was unoccupied at the time of the explosion and there were no injuries. Property damage is estimated at \$10,000, \$5,000 of that being to the target building and \$5,000 to broken windows in surrounding buildings. Investigation being conducted by BPD Officers with assistance from Eureau of Alcohol, Tobacco and Firearms (BATF), Syracuse, New York. Debris from crime scene forwarded to BATF laboratory, Washington D.C. for analysis.

York, was advised of the bombing by Special Agent BATF, Syracuse, New York on November 3, 1977, who also stated that he had notified U.S. Secret Service, Syracuse, New York was advised that as there is no apparent FBI jurisdiction in the matter, no active investigation by the FBI will be conducted. Both BPD and BATF have been offered the cooperative services of the FBI.
