Winchell said:

General Partridge, Commanding Officer of Army Intelligence, has been called by the Senate Committee tomorrow (September 28, 1953). He has been asked to testify how the Reds got into the United States Army.

Comment:

The Bureau furnishes G-2 with the results of investigations concerning all security subjects who enter the Army.

Winchell said:

The Beria story which has been on the front pages for the past two weeks was finally debunked by Russia's Mr. Vishinsky at the United Nations. He told newspapermen "I refuse to deny or confirm such nonsense." No comment.

Winchell said:

The U. S. Senate Internal Security Committee will go after Communists in show business again starting next December. Certain Hollywood and Broadway people who got a very clean bath after staging some of their very best performances before that Committee will be the major targets.

Comment:

The Bureau has not received any requests for name checks from the Jenner Committee which would tie in with the above Winchell statement as yet.

Winchell said:

The Senator Jenner Committee held two secret sessions this week. A very high Republican Party official will get a subpoena. He will be named as a member of a Communist cell.

Comment:


On the basis of name check requests received from the Jenner Committee this individual cannot be identified.

Winchell said:

Earl I don't say this his very close friends say it. Governor Warren has been notified that he is the new Chief Justice of the United States. I hope it is true.

Comment:

The Bureau has received no request to investigate Governor Warren in connection with this appointment.

Winchell said:

William Remington, a former Government official will appeal a three-year sentence in the Circuit Court of Appeals, New York City, tomorrow. Elizabeth Bentley named him as part of a spy ring.

Comment:

You will recall that Remington was convicted on January 27, 1953, on two counts of a five-count indictment. He was sentenced on February 4, 1953, to serve three years on both counts, sentence to run concurrently. On April 15, 1953, he surrendered to the U. S. Marshal and has been incarcerated since that time. On September 23, last, the Assistant USA, SDNY, filed the Government's brief on Remington's appeal scheduled before the Circuit Court of Appeals, New York City, for October 5, instant.

Winchell said:

A mass picket line is to be staged by a pro-Red outfit which will protest the appointment of Governor James Byrnes to the U. S. Delegation at the UN on October 8.

Comment:

Bureau sources report that the New York Civil Rights Congress will sponsor a picket line at the United Nations from 4 to 7 p.m. on October 8, next, relative to the above appointment of Governor James Byrnes.

Winchell said:

Washington is still shaking its head over the pardon given to Pedro Campos, Chief of the Puerto Rican Communists. Two of his

agents tried to kill ex-President Truman. Campos, who was given 60 years in 1950, is out already.

Comment:

Pedro Albizu Campos, President of the Nationalist Party-- of Puerto Rico, received a pardon from the Governor of Puerto Rico on September 30, last, for reasons of bad health and advanced age. He was imprisoned for participating in the October, 1950, Nationalist uprising in Puerto Rico. You will recall that Oscar Colazzo, who was given a life term, and Grisellio Torresola (killed) were the two Puerto Rican Nationalists who attempted to kill ex-President Truman on November 1, 1950.

Winchell said:

Senator Joseph McCarthy's colleagues have no consideration for a man on his honeymoon. The Senator has been summoned back to preside at the exposure of another big spy ring.

Comment:

The Bureau has not received any requests for name checks nor has any information developed from conferences with members of the McCarthy Committee which would reflect any information on the above statement.

Winchell said:

The FBI, fearful of doing anything to interfere with the missing Kansas City boy, won't give out a description of him, not even to me. Here, however, is the kidnapped child's picture. He was wearing brown-buckled shoes, he is 6 years old, brown eyes, brown hair, 53 pounds, and a front tooth missing. The woman who kidnapped him is stockily built, dark reddish-tinted hair, 35-40, 135 pounds. If you know their whereabouts, call the nearest cop.

Comment:

It is to be noted that the Bureau is following the policy of no comment to the press until the safe return of the child is made.

Winchell said:

When Mr. Secretary of State Dulles flew to India recently and tried to win that Government away from the Russian orbit, he

probably didn't know this. The Press and Radio Attache at our Embassy at New Delhi, an American named Rand Lincoln, was not on his or our team. He wrote a letter to another American in a fat-paying job over here with the Voice of America. This letter says in part, "I saw a copy of the first draft of the Dulles' speech written in his own little hand which made my blood run cold. The most surly, defensive, superior, patronizing, rude, dull, trite, you can imagine." Finally this letter winds up with references to our great Republican President. The last four words about the President were in quotes, a direct insult to the President of the United States, I think. Mr. Lincoln's wife added a PS in her own hand as follows, "Down with the Republicans - burn this." Well, as you can see, somebody forgot to burn it. Here it is on the television cameras - nice people.

Comment:

The Bureau files fail to reflect anything of a derogatory nature identifiable with the name, Rand Lincoln.

Winchell said:

The police on the Arnold Schuster case are about convinced that Mazziotta, the fugitive suspect, is dead. Maybe yes, could be no. Schuster, Sr., however, whose son was slain, still has 24-hour protection.

There have been vague reports from sources that Mazziotta was probably done away with; no confirmation of these, however.

Winchell said:

The most secret meeting in Washington today just broke up. State Department, heads of CIA, that's the Central Intelligence Agency, and agents for Senator McCarthy inspected brand new evidence consisting of information that Russia's Mr. Beria is still at large.

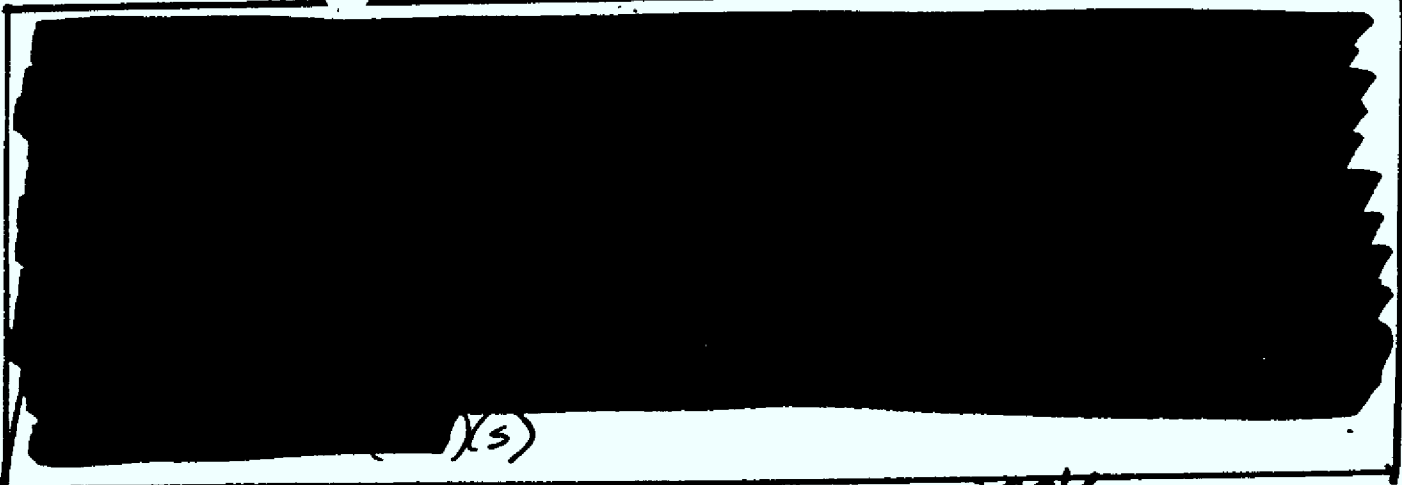

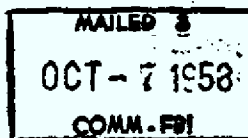

Every time a law enforcement officer makes an arrest  
he places his life in jeopardy.

On September 25, 1959, Special Agents of the FBI attempted  
to arrest John Elgin Johnson - bank robber, former inmate of  
Alcatraz, wanted as a conditional release violator. Johnson was  
located in a telephone booth in a Baltimore, Maryland, theatre.

He refused to submit to arrest and a gun battle developed.  
One Special Agent, J. Brady Murphy, was mortally wounded, another  
critically injured. The criminal was killed.

A few hours later Agent Murphy lay in a Baltimore  
hospital fighting for life. He was in a coma.

Suddenly he regained consciousness. A brother Agent  
was at his bedside. His eyes flickered and he whispered, "What  
happened to the other fellow?"

"He's dead," came the hushed reply.

The dying Agent, hearing these words, muttered with  
deep emotion, "May God have mercy on his soul." He relapsed into

unconsciousness and death.

Today Agent Murphy's name is enshrined on the FBI's roll of service martyrs. He died that others might live. His religious faith was deep. Neither malice nor fear was in his soul. He was at peace with his God.

He is typical of the young men who are willing to die for what they think is right. All right-minded Americans should be thankful to Agent Murphy and all other law enforcement officers who die in line of duty. They gave their lives to protect you.

\*\*\*\*\*

Thirteen Special Agents of the FBI have been killed as a result of criminal gunfire, eleven being killed by criminals who had been given previous probation, parole or clemency in the courts.

\*\*\*\*\*

Last year sixty-three police officers gave their lives in order that society might be protected. Unfortunately, in making up annual budgets the city fathers too frequently forget the hazards and conditions under which police must work. There are few groups so poorly paid in public service as American police officers and none are more deserving.

\*\*\*\*\*

All kinds of clues. In a recent kidnapping the FBI received information concerning the whereabouts of a victim. He was reportedly being held in a farmhouse approximately two miles from a small New York town. A maroon car with Texas license

plates stood nearby. The location of the town was unknown to the informant, but she was absolutely sure of its name - it had been spelled out in longhand in a dream! (Taken from teletype 10-1-53, from Cincinnati in Greenap case. Informant is [REDACTED])

A Special Agent and two deputy sheriffs just before dark approached a Tennessee farmhouse to apprehend a fugitive. The men took their positions. Just then one of the deputies observed a bird dog frozen into position, pointing something in the high weeds. The Agents, taking this clue, flushed the weeds - and up popped the fugitive! (Investigator Material, happened near Gallatin, Tennessee, 8/53)

Law enforcement requires a deep human feeling. Special Agents were questioning a suspect. Suddenly his wife complained of being in pain. The Agents rushed the prisoner to jail, then returned to take the woman to the nearest hospital. Three hours later she was a mother. (Investigator, August, 1950) (Doserter, 1950)

A fraudulent check was recently received in the FBI Laboratory for examination signed H. O. Good. It had been cashed! (Document Section)

A fugitive was badly wanted by the FBI. He was described as being dangerous, always carrying a stag-handled revolver in his belt. The search went on. The fugitive was located by two Agents. He was standing in a small clearing with a long knife in his hand. An Agent started talking to him. The fugitive listened. Quietly the Agent put his hand on the knife

handle.

"Where's the stag-handled gun?" the Agent asked. The surprised fugitive, almost inadvertently answered, "Over in my house."

The gun was found: a toy revolver, whose cylinder revolved when the trigger was pulled! (Personal experience of SA [redacted] San Juan Office)

FBI civil rights investigations have done much to promote respect for civil rights. During the years 1926-1938, a total of 194 lynchings occurred. However, from 1939-1953, there were only 39, with none in 1952. This testifies to greater respect for law, less mob action and greater emphasis on individual rights. (World Almanac, 1953 - Tuskegee Institute)

Many times the work of our Special Agents wins the commendation of prisoners. Here are excerpts from a letter written by the subject of an FBI investigation:

"I wish to take this opportunity on behalf of my Family and I to thank you for the many courtesies extended to us during my recent case...

"I know that I made a mistake and that I must pay my Debt to Society.

"Somehow, Someday soon, and with God's help, I shall make up to them for all the Heartaches I have caused them...

"I have learned that whenever we stray too far from the Teachings of God that there is bound to be Heartaches and broken Homes...

The U. S. Department of Immigration will round up all alien Commies. The first target will be the International Workers Order, the biggest Commie front in the entire nation.

COMMENT:

These observations undoubtedly refer to the Attorney General's Denaturalization and Deportation Program under which action against some of the International Workers Order (IWO) officials will possibly proceed. It is to be noted that the IWO was cited under Executive Order 10450. The Department is presently preparing a case for presentation before the Subversive Activities Control Board to determine whether this organization is required to register under the provisions of the Internal Security Act of 1950.

WINCHELL SAID:

Robert ~~Murphy~~ of the State Department will be the new Under Secretary of State.

COMMENT:

This information was referred to in the press last week. Mr. Murphy is a career diplomat and was the President's Political Advisor during the European Campaign in the last war. Mr. Murphy has held high diplomatic posts and is reportedly replacing Mr. H. Freeman Matthews, Under Secretary for Political Affairs.

The terrible kidnap story at Kansas City this week agonized every family in the nation. The headlines in the papers keep calling the search for the third kidnapper the nation's greatest man hunt, when, of course, what they should call it is a hunt for a beast. The indictment will read that the accused animals committed the crime and the murder of the child against the peace and dignity of the people of this earth. But the fact is that these terrible things brutally slaughtered the soul of an entire family. The two kidnappers now behind bars have shown no remorse --- merely anger and fear. Their only concern is the fury of the people. They asked their lawyer the other day, "What is the emotional situation in Kansas City and Saint Joe?" The newspapers in every city in the nation answered that one on the editorial pages. The people of the 48 states will settle for nothing less than the extreme penalty - the gas chamber. This information was furnished to the Department by memorandum dated October 5, 1953. This organization is presently being considered by the Department as a subversive organization pursuant to Executive Order 10450.

WINCHELL SAID:

Last week I disclosed that the Press and Radio Attache, an American, at our Embassy at New Delhi, India, had written a letter to a friend in New York in which Mr. Dulles and the President of the United States were denounced. A postscript written by the man's wife concluded "Down with the Republicans - burn this." Very peculiar loyalty, I said, coming from Americans working in a country we are trying to win away from Russia. Anyway, that letter appeared over these television cameras last Sunday night. The Jefferson School on 16th Street and Sixth Avenue, New York City, will be hauled before the Department of Justice next month. Federal men will charge that it is the Communist training school for treason.

COMMENT:

The Jefferson School for Social Science is one of twelve organizations against which the Attorney General has filed a petition before the Subversive Activities Control Board to determine whether it is required to register under the Internal Security Act of 1950. It is understood that the Jefferson School is scheduled to be the first organization under consideration by the above Board, which hearing is scheduled for the first part of November, 1953.

WINCHELL SAID:

Milan, Michigan - Frank Costello gets out of Federal prison on the 29th. He is suffering from a circulatory illness. He plans complete retirement and seclusion.

COMMENT:

You will recall that Costello began an 18-month sentence at Milan, Michigan, Federal Penitentiary on August 15, 1952, as a result of the Government's action against him for contempt of Congress. Accordingly, it is possible that he will be released from the above sentence in the immediate future.

WINCHELL SAID:

The Senate Investigating Committee will appeal to the Federal Courts tomorrow for permission to bring David Greenglass, the atomic spy, to testify in the probe of the radar spies. *in known location*

this is true, legal experts tell me there is nothing wrong with Mr. Brownell interceding for the jailed labor leader because at that time Mr. Brownell was apparently speaking for a client. Brownell was then Chief Counsel for a big hotel association in the east.

Comment:

Although it is possible for the Attorney General to have contacted Fay as above indicated prior to his appointment as Attorney General, there is no information to reflect that he did so. You will recall that the Bureau did investigate Richard Gray under the Atomic Energy program. In this connection it is reported that Gray was considered by the Administration to fill the recently vacated post as Secretary of Labor; however, because there are at present two New Yorkers in the Cabinet (Messrs. Brownell and Dulles) further consideration of Gray was reportedly discontinued. Gray is an American Federation of Labor leader in New York and is reported to have interceded in behalf of Fay for his parole.

Winchell said:

On Friday, last, the U. S. Senate Investigating Committee urged the newspapers not to reveal the name of a radar spy suspect who promised to tell the Committee everything. Yesterday, however, they had to cite him for contempt for clamming up. His name is Carl Greenblum, former roommate of atomic spy Julius Rosenberg.

The exclusive of last June 28 is one I wish I never had to tell you but it had to be told, if only to convince some very stupid enemies of mine who keep lulling you into inaction. C., and Mr. Ansel Lurford, former Assistant General Counsel, Treasury, now a member of the law firm of Pehle, Lesser, Mann, Riemer, and Lurford, Washington, D. C. With regard to the money plates, considerable publicity has appeared in the past. A separate Bureau memorandum is being prepared to determine if any Bureau interest exists in this matter.

Winchell said:

The Department of Justice will shortly astonish the American people with Government charges against one of America's best-known Washington commentators.

Comment:

It is possible that Mr. Winchell is referring to Drew Pearson. You will recall that the Bureau has conducted numerous investigations on Pearson at the request of the Department. Also, it is known that the Department has been considering action against Pearson; however, no official confirmation of such action has come to the Bureau's attention.

The U. S. Senate Investigating Committee has served subpoenas on three top radar scientists. They will be heard in closed session in New York next Thursday morning.

Jack Carley called. Lyle Stewart, Editor of Expose Magazine, has now written a book entitled, "The Secret Life of Walter Winchell," which is being published by Seven Sirens Press, Inc., 110 LaFayette Street, New York. The book is to be released on October 26th. Carley stated that the book really tears Winchell apart and on pages 70 and 71 it refers to the Director; that Winchell met the Director during the Hauptman case; that a friendship developed; that on one occasion Winchell was in Chicago and was being guarded by individuals connected with the Fischetti gang and was also being guarded by FBI Agents. At another point in the book, Stewart refers to the Director as having stated that Winchell has no pipeline into the Bureau and then Stewart states that the Director's friendship with Winchell has caused the Director embarrassment. He then cites an incident which allegedly occurred at the Stork Club wherein Tony Reilly, a notorious gunman, was present; that somebody wanted to take a picture of the Director and Reilly and Winchell did not open his mouth but Reilly got scared and left.

I told Carley that this was originally published in the New York Post and the Director knew nothing about such an incident. Carley stated that Stewart really wrapped Winchell up in a devastating manner and that there will probably be repercussions somewhere along the line in the book.

Confidential sources at Leavenworth Penitentiary have advised that Kelly has been quite concerned over his chances in the Oklahoma City robbery charge in view of the public sentiment built up over the recent Greenlease kidnapping case. You will recall that Kelly's wife has appealed for a parole on numerous occasions from her present incarceration at the Women's Federal Reformatory, Alderson, West Virginia.

Winchell said:

The White House is reviewing the list of names of officials who visited Joey Fay at Sing Sing Prison. This list does not include Attorney General Brownell or ~~Dewey~~ WARREN.

Comment:

You will recall that during the week various allegations were made that Attorney General Brownell, now Chief Justice Warren, and a Mr. Hagerty interceded for Fay while at Sing Sing. Initial observations were that the Hagerty mentioned was the President's Press Secretary; however, this Hagerty was later alleged to be Cornelius J. Hagerty, a west coast labor leader. During the past week Governor Dewey's Administrative Assistant volunteered to Bureau representatives that neither Mr. Brownell nor Mr. Warren had written any letters to Governor Dewey concerning Fay. It was, however, reported this past week by a former Assistant U. S. Attorney in the Southern District of New York that the national figure who is alleged to have interceded in the Fay case is Senator Styles Bridges. This information is presently being checked by the New York Office.

Winchell said:

Attention Detroit police - the Washington Investigating Committee will soon begin hearings in your city. It will look into the Commie activities of one policeman and about a dozen other individuals.

Comment:

Recent publicity reflects that the House Committee on Un-American Activities is making every effort to begin hearings in Detroit during the latter part of October. Winchell said:

The House Committee for Un-American Activities will begin hearings in Los Angeles. They will direct their efforts into the Hollywood small fry.

Comment:

The House Committee on Un-American Activities is scheduling hearings in San Francisco rather than Los Angeles. One group of individuals has been subpoenaed for December 1, next, while another group has been scheduled for December 15, next. The hearings will concentrate on individuals in the San Francisco area; however, they will possibly include individuals from the Hollywood section who were missed in previous hearings by the Committee. The Bureau knows the identities of the individuals to be subpoenaed and up-to-date reports are being submitted by the Field on these individuals.

Winchell said:

Robert Thompson, one of the convicted Communist leaders, is reported near death as a result of the lead pipe beating he received in the Federal jail, New York City, this week. G-Men will not discuss the incident.

Comment:

You will recall that the Bureau is actively conducting an investigation into this matter as a crime on a Government Reservation - Assault. Also, Thompson is in a very critical condition as a result of this beating.

Winchell said:

The Fort Monmouth investigation will reveal the names of top scientists who have vouched for the individuals involved in the D.C. hearings. Some of the scientists are identified as J. Robert Oppenheimer and QuinCY Howe.

Comment:

The Bureau's investigation reflects that hundreds of individual have given J. Robert Oppenheimer's name as a reference in applications for various positions. This is probably due to Oppenheimer's reputation as a foremost scientist. However, a review of the testimony of the

The kidnappers of the Greenlease boy go to trial tomorrow. They've already pleaded guilty. The trial is mainly to let the jury decide their fate - life in prison or death in the gas chamber.

The Greenlease kidnappers were scheduled to go on trial at 10:00 a.m., Central Standard Time, United States District Court, Kansas City, Missouri. They have entered guilty pleas.

The New York Post last Friday announced that Mr. Eisenhower was the father of the Morgenthau Plan to starve Germany. It said that the general discussed it in the British camp overseas with red spy Harry Dexter White in August, 1944. This newspaper reprinted part of an article by a man named Fred Smith. The Editorial Board of the publication has had numerous members with pro-Communist backgrounds. Smith was a member of the Editorial Board in 1947. Dolivet has been barred from the United States.

Winchell said:

Many newspapers reported that a Federal Grand Jury refused to indict Harry Dexter White as a Russian spy. The assumption by the readers is that Mr. White was innocent. Here is why the Grand Jury did not indict. The only evidence was Whittaker Chambers' statement and Chambers said he could not be sure that White carried a Party card. But the documented evidence that White was a Russian spy was not produced until November, 1948, six weeks after White was dead. Mr. and Mrs. United States. The following are some of the things the people have not yet been told about White and I doubt that Truman will mention them tomorrow night. This top red spy was first discovered by an intercept by British Intelligence. It happened right after Pearl Harbor. A special messenger flew from London with the information for Franklin D. Oddly enough this spy, White, gave our country more secret news than he got because our intelligence departments were able to go after his contacts right into the Kremlin. We knew for example that Japan had requested Russia to arrange a peace for Japan as early as February, 1945, and that Russia did not communicate that peace offer to the United States. We found out by covering White that Alger Hiss was part of that spy ring. In fact, as certainly as White fooled Morgenthau, his boss, Hiss fooled General Marshal and Dean Acheson. Governor Byrnes knows all this but he hasn't said so. Governor Byrnes knows this because the file was handed to him by both the FBI and his own security officer, Joseph Panuch. Mr. Acheson, for example, was so completely fooled by Alger Hiss that Acheson

fired Panuch from the State Department after Mr. Byrnes left that post because Panuch had accused Hiss, the traitor, his friend. Mr. Truman knew all about it because a deadly fight practically raged up and down the grand staircase of the White House. The Democrats could not have made any of this public at the time because White and the other traitors became political dynamite. If the people knew it they would have voted them all out in the 1948 elections. There can be no question of Truman's loyalty and no American suggests that his cabinet were Benedict Arnolds. The tragedy is that they were "Simple Simons" and "Rip Van Winkles."

Comment:

There is no information in FBI files indicating that White's activities were brought to the attention of President Roosevelt by the British just after Pearl Harbor nor that "our intelligence departments were able to go after his contacts right into the Kremlin."

Winchell said:

The next City College professor to be subpoenaed was one of the loudest defenders of the Rosenbergs at their funeral.

SYNOPSIS

This is a repulsive book written by a character who appears to scrounge in the gutter for nauseous detail. Lyle Stuart does a job on Winchell by using the tactics which Lowenthal used in "The Federal Bureau of Investigation" and which the authors of "McCarthy - The Man, The Senator, The 'Isa'" also utilized. Fact is so obscured by innuendo and smear that one cannot tell where truth begins and ends. There are references to the Director and the FBI. One has to do with Winchell's meeting with Lepke. Another with an alleged incident in the Stork Club in which Winchell kept silent when someone urged that one Terry Riley, notorious gunman, and the Director (unaware of Riley's identity) pose for a picture. A third reference is to Winchell's alleged proposal that Mr. Hoover, "that cloak and dagger man," be considered a Presidential candidate for the Democrats. None of the references are complimentary. There are several casual references to the FBI. Bufiles indicate that the author was born Lionel Simon on August 11, 1922.

Inducted into the U. S. Army in 1943, Stuart was honorably discharged as a corporal from Fort Dix, New Jersey, on November 29, 1944. Stuart is presently editor of the publication "Expose" which has been described in Bufiles as "anti-Catholic, anti-Jewish, anti-Religion and antieverything." One issue of the magazine "Expose" attempted to tie the Bureau's investigation of Stuart into the controversy involving Dr. J. B. Matthews and Senator McCarthy's Committee. REFERENCES TO THE DIRECTOR AND THE FBI:

Pages 70 through 71:

This reference deals with Winchell's meeting with Lepke and the meeting thereafter with Director Hoover. Page 70 indicates that "In later years Winchell would meet J. Edgar Hoover during the trial of Bruno Hauptmann, the man convicted of kidnaping the Lindbergh baby. He developed a friendship with the FBI Director while maintaining his chummy relationship with the old-time mobsters."

Page 71 reflects that on the occasion of a Winchell visit to Chicago, he was "guarded by two cousins of Al Capone, the Fiaschetti brothers of recent Kefauver Committee fame. Two G-men were also part of his bodyguard at the same time . . . making for a unique and somewhat embarrassing situation for all."

"To this day, Hoover assures all callers that despite what people believe, 'Winchell has no pipeline to me or my office. He gets no information from me that isn't given to all other newspapermen at the same time.'"

"Hoover's 'friendship' with Winchell has caused Hoover occasional embarrassment."

"There was a night at the Stern Club when J. Edgar Hoover, King of the G-Men, was playing with a toy machine gun while Walter Winchell, King of the Columnists, looked on approvingly. Photographers took pictures."

"Terry Riley, a notorious gunman was also a Cub Room patron at the time."

"Winchell didn't open his mouth when somebody suggested Hoover and Riley pose for pictures together."

"Riley showed reluctance. He became ill at ease, the more so as Hoover in a jovial mood encouraged him.

"It became obvious to Riley, as it must have been to Winchell, that Hoover didn't know who he was. He became more and more uncomfortable, refused to pose for the photographers and finally left the place.

"Riley was on parole at the time for extortion and impersonating an FBI man."

Page 123:

This reference to the Director was: "Winchell developed his friendship with FBI Director J. Edgar Hoover, and seriously proposed that cloak and dagger man as a Presidential candidate for the Democrats."

Page 124:

In reference to Winchell, the author says "he was a friend of the President of the United States, of the Director of the Federal Bureau of Investigation, of the top gang leaders in America."

Page 167:

Stuart refers to the FBI in the following paragraph:

"If he wrote that twenty-two persons, many of them 'high Government officials' had been trapped by the FBI in a plot to spread false news in wartime, he could be forgiven. His theme was patriotism. (The FBI denied all knowledge of the coup. Army Intelligence told a Herald-Tribune reporter: 'Since Mr. Winchell is a Commodore of some sort, you'd better contact the Navy.' The Navy denied all knowledge of the story . . . )."

Page 170:

In a chapter in which Stuart is attempting to prove Winchell's past pre-Communist record, a reference is made to the FBI. This appears in a Winchell quotation from the Richmond

Times Dispatch: "A typical example of Dies' technique was his charge in 1942 that 1,121 persons in the Federal services were guilty of subversive activity. The FBI accordingly spent \$100,000 investigating half those on the list. . . two dismissals and one disciplinary action were the total results."

He was inducted into the U. S. Army in 1943, and was honorably discharged as a corporal from Fort Dix, New Jersey, on November 29, 1944. He had meanwhile had his name legally changed to Lyle Stuart effective March 6, 1944.

Stuart is married and as of September 9, 1953, resided at 1420 Twenty-sixth Street, North Bergen, New Jersey. He is editor of the publication "Expose" located at 55 West Forty-second Street, New York City. This magazine was previously published by Stuart Publications, Incorporated, in which the principals were Lyle Stuart, Mrs. Lyle Stuart and Joseph Whelan, Managing Editor. This sheet is presently published by "Expose" Incorporated. It has been described in Bufiles as a "rag sheet" which is "anti-Catholic, anti-Jewish, anti-Religion and antieverything." As a result of the type of material contained in "Expose" an investigation was conducted in 1952 and 1953 to determine whether the newspaper [REDACTED] was engaged in any subversive activity.

[REDACTED] also indicates that the December, 1951, issue of "Expose" carried an extremely derogatory article on Walter Winchell. This article incorporated the incident which allegedly took place at the Stork Club in New York in which Director Hoover reportedly played a part. The Director noted that the statement regarding the Club incident was entirely untrue.

On October 22, 1951, Stuart wrote the Director inquiring as to whether there was any truth to an alleged quotation by the Director that 75,000 parochial school teachers were investigated without any instance of subversive activity being found.

Stuart's source of the quotation appeared to be an article written in 1944 by Dr. John A. O'Brien of Notre Dame University in the "Ave Maria." Dr. O'Brien and the Director were both quoted. Both quotations were later erroneously attributed to the Director. By letter of November 1, 1951, Stuart was advised that the Director had not made such a statement (62-87760-48)

Immediately, thereafter, "Expose" carried a story headed "J. Edgar Hoover Explodes A Lie About The FBI." A memorandum of M. A. Jones dated December 17, 1951, carried the recommendation that no communication be had with Stuart in the future in view of his, Stuart's scandal sheet operations and since he seems prone to quote statements of prominent people and had quoted the reply which the Bureau sent him on November 1, 1951. The Director noted on this memorandum "I concur."

The August, 1953, issue of "Expose" carried an article captioned "FBI Investigates 'Expose' After J. B. Matthews Bites The Dust." In this article "Expose" attempts to tie the Bureau's investigation of Stuart into the controversy involving Dr. J. B. Matthews and McCarthy's Committee. This was not the case.

The article also attempted to give the impression that the Agents conducting the interview requested by Stuart in the course of the investigation apologized for the investigation. The latter was absolutely untrue. [REDACTED]

BOOK REVIEW OF "THE SECRET LIFE OF WALTER WINCHELL":

The source of the material in this book would appear to be articles on Walter Winchell which were carried in "Expose" and the "New York Post."

The first page titled "Epilogue in Advance" reflects that the author was set upon by three men who attempted to beat him into unconsciousness with a blackjack and their fists. This attack occurred on August 11, 1953, a few days after the book was completed. The author notes that the beating was similar to two other such incidents involving a New York radio commentator who had been consistently critical of Walter Winchell.

The only possible inference which could be drawn by the reader is that Walter Winchell is the instigator of the attack on Stuart.

"The Secret Life of Walter Winchell" begins with a review of Winchell's alleged background. According to the author Winchell's father, "Jacob Laine, alias Jake Lipsky, alias Jacob Winchell, was a sex pervert who molested small girls." Winchell's home life was allegedly sordid and unhappy. His parents were

divorced. The author indicates that Winchell's mother later committed suicide as Walter forbade her to visit her grandchildren.

Incident after sordid incident of Winchell's childhood is discussed. His entry into show business in his early teens, together with George Jessel and Jack Weiner is mentioned. The author indicates that Winchell got his first attack of "girl trouble" when at fourteen he moved in with a 17-year-old girl whom he met backstage at one of the theaters. Winchell's life as a vaudevillian is covered in an extremely derogatory manner as is his service in the Navy.

Winchell's marriage to Rita Green, a former partner of his former partner, George Jessel, is mentioned. This marriage broke up in 1920.

The author implies that the \$75 a week "living expenses" which he alleges Winchell pays his former wife is simply to keep her from publishing an "autobiography dealing mostly with her life with Winchell." In short, he infers blackmail, though he doesn't use the word. He gives a snide account of Winchell's beginnings as a columnist and of his second marriage to June Hayes Aster. This latter courtship, according to Stuart, "continued past where acquaintances said Winchell would cool off and be on another girlie chase."

"A few months later found them living in bliss. June had worn one wedding band and wasn't particularly anxious for another.

"In 1923 they were legally married.

"So began the marriage which soon leveled off into one of convenience."

In the next breath Stuart has Winchell helping one Gertrude "keep house" while his wife "kept house all by herself."

Stuart credits Fulton Oursler, "a prominent attorney of the 1920's" with responsibility for Winchell as the latter directed him to a spot on the "Graphic" where he became a gossip columnist. Stuart says "Bishop Fulton J. Sheen has never revealed whether Fulton Oursler, at his deathbed confession, apologized to his God for giving Winchell to the world."

In a chapter entitled "Winchell and the Law," the columnist is portrayed as "a sycephant who fawned upon the gang

leaders, who flattered them with favorable mentions in his column, who tried in every conceivable manner to cajole some measure of friendship from them."

Winchell's move from the "Graphic" to the "Mirror" is discussed. His personal and professional feuds as a columnist are aired, always to his discredit. Winchell is always fear-stricken, cowardly, running; his adversaries, contemptuous of him. His neglect of his mother, it is implied, was the cause of her suicide. "The funeral is a quiet affair. Winchell doesn't attend."

One chapter is devoted to the inaccuracies in Winchell's column. The columnist is described as "fabulously successful in a worldly sense, abysmally unsuccessful as a human being."

Stuart says that Winchell's "news" is supplied to him daily by press agents. Much is not news. "Names were substituted for other names. Gags were lifted and given a twist. Facts were given so much 'treatment' that they became fantasy."

One chapter is devoted to Winchell's ability to make or break people. "For fifteen years, when Winchell put someone on his 'drop dead' list, they were often better off dead." And, "Long before the age of the red-hunt, Winchell made guilt by association a crime."

"His real power (the broadcast and the column) combined with his mythical power (the mobs, the other important people he knew) made him a figure few men wished to tussle with."

In order to illustrate that Winchell's word was law at the Stark Club, Stuart describes an alleged incident in which Winchell threw pieces of bread on the floor while a waiter dutifully picked up each piece. When onlookers stared, Winchell threatened to have them "thrown the hell out of here."

In "The Political Winchell," Stuart gives his version of the columnist's entry into the political arena. Winchell was a Roosevelt man. Stuart adds that he became a merciless scourger and denouncer of race hate in low places and high places. He was encouraged by "a clique of Communists who were at that time in high places in the Anti-Defamation League and also by Abraham Fastenberg who was assuming the name Arnold Forster and was also trying to assume command of the A.D.L."

With regard to one incident, page 160, Stuart remarks that "Winchell's girl friend of the moment was also known to be a Communist."

Several pages are devoted to Winchell's approach to the world situation prior to Pearl Harbor. After that, as a Lieutenant Commander, "Winchell is making the highest sacrifice for the war effort," one of his critics wrote. "He is giving up olive in his martini for the duration."

The chapter entitled "Quagmire" deals with Winchell's alleged pro-Communist activities. In 1953, Stuart says, Winchell admitted he had been "used" by the Communists on occasion. "It was during the second examination (1953 pre-trial libel suit examination) that pages and pages of pro-Communist material written by Walter Winchell was flung back at Walter Winchell."

The Martin Dies-Walter Winchell feud is described on page 169. Stuart credits J. B. Matthews with changing Winchell's attitude toward Communism. On page 203, Stuart calls Matthews "a national scandal" condemned by President Eisenhower.

Because the Hearst press cut large chunks from Winchell's column, Winchell, Stuart says, "gave full rein to his sentiments under a pseudonym." He wrote for PM, left-wing New York daily, according to Stuart, under the name "Paul Revere II."

The author says Winchell gradually drifted to the right, but he was consistent on the matter of unions. He was against them. And, "One year after World War II ended, he was crying for war with Russia."

"Amusingly enough, the Communist-lines were also able to snuggle even closer to him. One press agent who had worked diligently to elect Communist candidates to the New York City council, now fed Winchell make-believe items 'against' Communists. These always skirted actual Communists and damaged their arch-enemies, the liberals." (Page 174) Stuart has Winchell trying desperately to keep pace with the professional anti-Communists to prove that he was a 100 per cent loyal American; making a deal with Senator McCarthy to keep from being victim of a headline hunt; and using pre-McCarthy items, failing to rise to the defense of his "radio colleague," Drew Pearson. Worst of all in Stuart's opinion, "He has plugged McCarthy's favorite reading matter, a publication called Counterattack." This latter, Stuart says, "is filled with almost as many errors of fact as Winchell's own column."

The chapter entitled "Private Women" is devoted to Winchell's alleged extra-marital conquests, which, according to Stuart, are numerous. "He would have a girl rent a private

apartment, only to abandon it (and her) after a month or two. Or he would sneak them into the St. Moritz by entering quietly through the servants' entrance on Fifty-Eighth Street."

A show girl from Texas, one Mary Lou Bently, was "Winchell's sweetheart during the height of his glory in the early forties." Jane Kean, of the Betty and Jane Kean sister act, is named as Winchell's most recent amour in detailed passages.

A chapter is devoted to Winchell and his daughter Walda, who is known as "Toni Eden" on the stage. Their allegedly "strange father-daughter relationship" is described. Winchell is charged with breaking up his daughter's first marriage and destroying her "friendship" with William Cahn. The latter is described as a "pleasant, ambitious young man." When Winchell found that his daughter was fond of Cahn, he "got the dirt." Cahn had pleaded guilty to a misdemeanor in 1935, and on another occasion had spent six days in a Florida jail. One charge was vagrancy, the other is not named. Winchell allegedly did everything to wreck Cahn's life. Stuart alleges that the columnist pulled a gun and threatened to kill his daughter on one occasion. Cahn urged her to return to her home. "Toni was adamant, and then confided to Bill other reasons, all logical, for not wanting to be left alone with her father."

Stuart gives a melodramatic description of what he infers was an attempt by Winchell to railroad his daughter Walda into a mental institution. He says that after Walda was released she resumed her friendship with Cahn, but after "nearly five years of keeping company, the pair finally did call it quits." Cahn married another woman in 1953, and when the threat that Cahn would maybe be his son-in-law was out, "Winchell took his revenge."

"Cahn's name was mentioned in the Jelke trial."

Winchell demanded that he be locked up, and consistently attacked Cahn thereafter.

Stuart says that the beginning of the end for Winchell dates to the night of October 10, 1951, and the Josephine Baker-Stork Club incident. He charges Winchell with being a hypocrite on the matter of race prejudice, and says that an anti-Negro joke in Winchell's column caused the editors of "Expose" (Stuart and one Joseph Thalen) to expose Winchell. (They even postponed an "Expose of J. E. Matthews" in order to carry the Winchell story.)

Once the "Expose" story was out, the New York Post and other newspapers carried anti-Winchell stories getting much material from "Expose." After the Post series was in its fourth week, Winchell had a "heart attack."

Stuart states that Winchell is now finished, washed up. The president of American Broadcasting Company who had signed Winchell to a fabulous lifetime contract before the Josephine Baker incident, "listened to friends tell him that he had made a mistake."

Stuart is mildly critical (page 213) of the New York Post articles - "Frequently in its series, the 'Post' was as inaccurate as Winchell. At other times, it was as knowingly hypocritical."

Winchell's feuds with James Hechler, the New York Post, Ed Sullivan, and disk jockey Barry Gray are aired. He was, says Stuart, feuding with the New York Times, his old editor Emil Gureanu, the New York Post, Leonard Lyons, Earl Wilson, Ed Sullivan, Harry Truman, Drew Pearson, Elmer Davis, Arthur Schlesinger, Jr., Max Lowenthal, Bennett Cerf, and a hundred others.

"He had turned against the New Deal. He hated the Democrats. He opposed Adlai Stevenson, I..." etc.

With regard to the Damon Runyon Cancer Fund, Stuart says "(This fund was a promotional scheme administered by a race track tout, an ex-bootlegger, and Winchell, among others. It has collected and spent seven million dollars and its contribution toward relief or cure of cancer is nil to date.)"

"(It was typical of Winchell that he failed to do what a healthy commentator with an interest in cancer research might have done with a multi-million audience. He could have appealed for public support for a giant Congressional appropriation for cancer research. This might have stepped up a solution to cancer by years. But Winchell's ego couldn't conceive of doing anything for anybody unless there was plenty for Winchell in it; in this case, publicity and control of the funds.)"

More space is devoted to the Jelke case (Page 230), Comedian Joey Adams, (divorced from Winchell's wife's sister), and political figures in connection with the case.

The final chapters entitled "Decline," "And Fall," and "Requiem" have to do with Winchell's alleged declining

prestige and power in the newspaper and television fields.

"The scarecrow had begun to come apart. First a sleeve, then the shirt, then the straw filling."

The Washington Post, "a dignified newspaper," junked one out of three columns. Other papers, according to Stuart, dropped the Winchell column. The concluding note--Winchell is a failure doomed to the limbo of oblivion.

Comment:

There are several bills pending to permit wire-tap evidence to be used in espionage cases. While the President is not known to have expressed an official opinion, the above would be in line with recent comments by the Attorney General in favor of such legislation.

Winchell said:

Nutley, New Jersey. The Senate Investigating Committee Hearings on the Army Signal Corps will make brand new headlines next week. A top Communist, they will charge, worked at the radar lab in Nutley, New Jersey, during 1953. The man who got him the job years ago was the atomic spy, Julius Rosenberg.

Comment:

Winchell is believed to refer to [REDACTED] subject of a pending espionage investigation. [REDACTED]

The Jenner Committee is looking into the status of a certain Ambassador, a Republican.

Comment:

The above facts are insufficient to permit identification of the individual to whom Winchell refers.

Winchell said:

Byron Price, the American ace in the United Nations Secretariat, did not resign for the reasons given in the newspapers. Mr. Price could no longer

tolerate the way American subversives are protected. He will make a very sensational announcement about January third.

Comment:

b-6 Price [REDACTED] held the post of Assistant Secretary General of the United Nations.

Winchell said:

LaCross, Wisconsin. Evelyn Hartley is still missing. This is the baby sitter authorities believe was abducted and perhaps murdered by a lunatic. She was last seen by her parents four weeks ago. She would have been sixteen yesterday. The abduction evidence is her shoes and eyeglasses found in the room where she was baby sitting. If you have any information of Evelyn Hartley, notify the nearest cop.

Comment:

There has been no evidence to date which would place this case within the FBI's investigative jurisdiction. It is being followed through contact with the local police and the Hartley family.

Winchell said:

Lakeview, South Carolina. After an 18-month investigation the FBI arrested fourteen cowards charged with flogging a woman and her brother while hiding behind masks of the Ku Klux Klan. The stupidity of these bums was demonstrated when they transported their victims over a state line. That put their crime under the Lindberg law. These arrests debunk the bunk in some newspapers that the G-men have entered politics in support of American reactionaries. The FBI has proved that it is as opposed to the whites under a sheet in South Carolina as it is to the Harry Dexter White's posing under false colors in Washington, D. C.

Comment:

Winchell is apparently referring to the case entitled, [REDACTED] was., et al." The arrests referred to occurred 11/16/53.

Winchell said:

Washington Post. The Velde Committee investigators are working on an H-bomb spy ring as dangerous as the Harry Dexter White gang. One of the Americans to be named by Velde works in the Soviet Embassy, Washington, D. C.

Winchell said:

The Professor at City College I recently mentioned by the initials J. B. was John Bridge. He resigned after getting a subpoena, as I said he would.

Comment:

In his broadcast of November 8, 1953, Winchell mentioned a J. B. who, he stated, "suddenly quit after getting a Government subpoena." As was mentioned in my memorandum to you of November 9, 1953, Bridge [REDACTED] had resigned Friday, November 6, 1953.

Winchell said:

The red underground in Pittsburgh has the jitters since the FBI arrested three of their leaders last November fourth. Others in Pittsburgh are planning to escape. It is too late.

Comment:

Winchell refers, of course, to the Smith Act arrests of [REDACTED] and [REDACTED]. There has been no indication that other leaders in Pittsburgh "are planning to escape."

Winchell said:

Ottawa. The Canadian Government's refusal to permit Russian agent Gouzenko to come here to help the Jenner Investigating Committee may embarrass the famous Canadian holding it up. Senator Jenner may be forced to make public sworn testimony involving Canada's representative to the United Nations, Lester Pearson.

Comment:

[REDACTED]  
Pearson has held the position of President of the General Assembly of the United Nations.

Winchell said:

The left wings blatant campaign is to oust J. Edgar Hoover and grab control of the FBI. The Communists have launched a drive to limit the term of Mr. Hoover to five years. If such a move succeeds G-man Hoover would be fired on his 30th anniversary next May.

Comment:

While it has long been the objective of the Communist Party and certain left wing elements to effect the removal of the Director, no such specific campaign as that mentioned by Winchell has come to the attention of the Bureau.

Winchell said:

The next headlines in the Harry Dexter White case, will break on next Wednesday. William Ludwig Ullman was promoted despite the objection of the FBI.

Comment:

Ullman was employed in the Treasury Department as a principal Economic Analyst, Grade P-6, working under Harry Dexter White prior to Ullman's induction into the U. S. Army on October 12, 1942. He was released from active military duty as a Major effective November 23, 1945, to return to his treasury position at Grade P-7. He actually began work in the Treasury while on terminal leave from the Army October 14, 1945. Ullman resigned from the Government effective April 29, 1947. It is not immediately known whether he received a promotion between October 14, 1945, and April 29, 1947. The FBI, of course, has not made objections with reference to possible promotion of Ullman. However, he was mentioned in the memorandum arising out of Elizabeth Bentley's revelations which was directed to General Harry Vaughn dated November 8, 1945.

The Investigating Committee from Washington will link a prominent instructor from Cooper Union College in New York with the Julius Rosenberg spy ring. His initials are E. P.

Comment:

Winchell is apparently referring to [redacted] formerly employed at the Federal Telecommunication Laboratories, Nutley, New Jersey, who was at the time of the Rosenberg arrests in July, 1950, the boy friend of [redacted] a close associate of both Julius and Ethel Rosenberg. [redacted] subject of a pending FBI investigation, has since married [redacted]

Winchell said:

Alger Hiss will be out of prison in one more year. He plans living in Mexico or Switzerland. He automatically gets the parole for good behavior. U

Comment:

The Hiss request for parole was rejected November 21, 1953. However, the matter will be considered again in November, 1954. With time off for good behavior, it is believed that he will be released at that time. U

Winchell said:

Igor Gouzenko, the ex-Russian Code Clerk in the Soviet Embassy at Ottawa, gave Canada and our Government the first news about red agents in Washington, as you all know. Gouzenko is now quoted by Canadian officials as saying that he has nothing new to tell us. Now this is very strange because Mr. Gouzenko was the original source and he can tell us at least the following three things: U

Who was the Secretary on the staff of Secretary of State Stettinius who Mr. Gouzenko said was a Soviet Agent? Was he Alger Hiss, or was he not Alger Hiss? Number two - the U. S. knows that the Russians planted a top secret agent during war-time in the office of Admiral Ernest King. (A memorandum dealing with this matter is currently being prepared for the Director.) Our Government also knows his name but we need Mr. Gouzenko, the source for that news, to say so under oath to make it stick. Number three - we also need him to help the FBI trap the red agents in our atomic set-up. U

Comment:

The most logical suspect is, of course, Alger Hiss who occupied such a position. Neither the FBI nor the State Department has been able to identify this individual positively by name. As is mentioned above, a memorandum dealing with the subject matter of question two is currently being prepared. The third question needs no comment. X

Winchell said:

Here is a very important and ironical fact in the Gouzenko case. He wrote a book after he broke from the Russians. He claimed a \$7,500. tax rebate in the manner of Eisenhower, Truman and the girl who wrote "Forever Amber," all of whom cleaned up hefty money on a neat tax trick. But Mr. Gouzenko was turned down by our tax department. The Treasury official who signed that turn-down letter was Harry Dexter White. When Gouzenko was shown the letter he denounced White as a red spy, which has since been proved. ✓

Comment:

The Bureau has not received information which would verify the accuracy of this allegation. However, an inquiry through liaison is being instituted regarding White's part in the alleged letter. ✓

Winchell said:

Attorney General Brownell's committee studying anti-trust laws will recommend that reasonable price fixing agreements be allowed. ✓

Comment:

The Attorney General's Committee to Study the Anti-Trust Laws is known to be analyzing the various problems in this field. The exact nature of their contemplated recommendations is not known by the Bureau. ✓
