In his broadcast of Sunday, February 28, 1954, Walter Winchell stated: "Attention J. Edgar Hoover: I have just turned over to your Agents in Los Angeles the biggest scoop in my thirty-two years on newspapers. Hundreds of names of Americans who have given money to the Communists here." On the same day the SAC in Los Angeles advised the Bureau that Mr. Winchell had turned over to an Agent of that Office, twelve names which Winchell stated were on cards furnished by a confidential source who obtained them surreptitiously from [redacted] is on the Security Index and is the subject of a closed Bureau Security Matter - C investigation [redacted]

On a memorandum dated March 1, 1954, recording a telephone call from the SAC, Los Angeles concerning the receipt of the twelve names from Walter Winchell, the Director stated "See that we get all the cards & promptly analyze them. H." The SAC, Los Angeles has secured the cards from Walter Winchell and they have been photographed and copies have been received at the Bureau.

A review of [redacted] main file reflects that he was employed from [redacted]

[redacted] were the subject of a security-type investigation by the Bureau which was initiated in March, 1945, which investigation showed that many of the leaders of these organizations had been active in Communist front groups. The investigation was closed in August, 1947. During the investigation the Bureau received from confidential sources information concerning members of the organization, which was practically identical with the information appearing on the cards furnished by Walter Winchell.

From a review of the cards furnished by Walter Winchell, some 350 in number, it appears that they are cards which were used by: [REDACTED] They contain a name, address and business connection in most instances and in many cases had an amount of money listed on the card such as \$25, \$100, \$250 and so forth. In some instances the cards contain names only. With only this information it would be difficult to identify any of these individuals with information in Bureau files.

After analyzing these cards it is believed that they are cards of members of or contributors to [REDACTED] and have no particular value to the Bureau nor do they contain any pertinent information which we might use.

RECOMMENDATION:

It is recommended that these cards be placed in the files of [REDACTED] and that no further action be taken.

ACTOR JOHN IRELAND, INFORMATION CONCERNING. AT THREE PM ON MARCH THREE INSTANT, IRELAND CALLED FROM PHOENIX, ARIZ., AND STATED THAT A STORY CONCERNING HIM BROKE IN NEWSPAPERS TODAY. IRELAND FILED SUIT FOR BREACH OF CONTRACT AND SLANDER DAMAGES, COMPLAINING THAT HE WAS FALSELY IDENTIFIED AS A COMMUNIST SYMPATHIZER. I ADVISED IRELAND I KNEW NOTHING ABOUT THE MATTER. IRELAND ASKED FOR AN APPOINTMENT TO SEE ME AT THREE PM ON MONDAY, MARCH EIGHT NEXT, WHEN HE RETURNED TO L.A. AT FOUR FORTYFIVE PM, SAME DATE, WALTER WINCHELL CALLED AND STATED THAT HE HAD JUST RECEIVED A CALL FROM JOHN IRELAND IN REGARD TO ABOVE-MENTIONED MATTER. HE STATED THAT HE WOULD LIKE TO GIVE IRELAND A FAVORABLE PLUG. HE ADDED THAT IRELAND TOLD HIM THAT HE /IRELAND/ WAS IN CONTACT WITH ME AND THAT HE WAS GOING TO HAVE THE FBI INVESTIGATE HIS CASE. WINCHELL COMMENTED THAT IT SHOWED GOOD INTENT ON IRELAND'S PART WHEN HE WENT TO THE FBI, AND THAT HE WOULD PROBABLY SAY SOMETHING TO THIS EFFECT IN HIS SUNDAY NIGHT PROGRAM UPON WHICH HE ASKED IRELAND TO APPEAR. MR. WINCHELL WAS ADVISED THAT IRELAND CALLED ME, ASKED FOR AND WAS GRANTED AN APPOINTMENT JUST AS ANY OTHER CITIZEN.

WINCHELL SAID:

Top Military Brass are meeting very quietly, discussing mass resignations as a result of the McCarthy-Cohn-Schine Fight.

COMMENT:

We have received no information from the Armed Forces concerning this. The March 15, 1954, column, "The Washington Merry-Go-Round" by Drew Pearson, indicates that Brigadier General Ralph Zwicker ^{of the} recently threatened to resign because of the insults he said he had received from the McCarthy Committee.

WINCHELL SAID:

George Sokolsky, Hearst columnist, made a radio speech on Senator McCarthy on 3-14-54. The girls on the network telephone switchboard received more than 500 telephone calls, nearly all of which were pro-McCarthy.

COMMENT:

WINCHELL SAID:

When the hearings on alleged Communism in the Armed Services start next Thursday, insiders say that Senator Saltonstall, Chairman of the Committee, may wish to disqualify himself, because a very close relative is said to be embarrassingly involved.

COMMENT:

Senator Leverett Saltonstall is Chairman of the Senate Armed Services Committee which was recently reported to be starting investigations into the procedures of the Army concerning discharges of security risks.

WINCHELL SAID:

Last month he proposed a boycott on all products from Red Dominated Guatemala. The State Department said it would not be good for our Good-will Policy. Last Friday, Guatemala made it a crime to import American food into Guatemala.

COMMENT:

None.

WINCHELL SAID:

Roy Cohn, the Chief Counsel of the McCarthy Committee, gave a convincing and lucid account of himself on tonight's "Meet the Press." Secretary of the Army Stevens, was invited, refused to appear.

COMMENT:

Cohn, on the "Meet the Press" telecast on 3/14/54, reiterated his previous denials that he had attempted to exert pressure on the Army to obtain special favors for Private G. David Schine, who was formerly a Consultant on the staff of the McCarthy Committee.

WINCHELL SAID:

Nothing could be more destructive to the security of this nation than Senator Fulbright's statement that he will no longer furnish information to the FBI because he suspects that G-man Hoover has leaked inside information to the McCarthy Committee. Since the Senator says he suspects it, but really doesn't know it, I wonder?

COMMENT:

None.

WINCHELL SAID:

Attention, Postmaster General - - The ~~Guatemalan~~ Embassy at Washington, D. C., is using our mail, at the taxpayers' expense, under diplomatic immunity, to attack United States Senators. This is the worst diplomatic outrage since FDR closed the Nazi and Italian Consulates for doing the same thing.

COMMENT:

None.

WINCHELL SAID:

The argument about Senator McCarthy appears to be only on the way he allegedly conducts his investigations. Truman said there are only a few Communists in the country. That's Truman's way of saying it is still a "Red Herring." Of course, there were only a few Communists in the Truman Administration, but look at the big jobs they had. To name two: Harry Dexter White, a Red spy, who controlled the Treasury; Alger Hiss, by indirection, controlled the Department of State. Beware of the phony cry now being raised that there are too many Congressional Committees.

COMMENT:

None.

WINCHELL SAID:

A very secret session of a Congressional Committee has named an official of United States Customs as a "Red." His initials are I. K.

COMMENT:

On 3/15/54, Chester A. Emrich, Deputy Commissioner of Customs, Washington, D. C., advised that the Bureau of Customs had received no information concerning this matter. He said that the Bureau of Customs has no officials with the initials "I. K." and only 4 employees with those initials; [REDACTED]

Mr. Emrich said there is no disloyal data known to Customs on any of those four individuals, but is of the opinion that Winchell is referring to [REDACTED] since there is disloyal data on another person by that name.

In October, 1950, a Loyalty of Government Employees Investigation was conducted on [redacted]

[redacted] at Washington, D. C., on the basis of an allegation that a person by that name had been a member of the International Workers Order. The investigation was discontinued the same month when it was ascertained that the disloyal data referred to another individual by the same name. [redacted]

Information. She married John Vincent Hall ^{MRS} Desilva, a journalist who is a native of Ceylon. According to a press report on January 16, 1954, she was ousted from the Communist Party in Ceylon on ideological grounds. She was blamed for a split in the Communist Party there and was accused of being a United States agent.

WINCHELL SAID:

Sometime ago a Government witness named Matusow testified before a Congressional Committee that the "New York Times" had "the largest Communist cell of all American newspapers."

That Government witness has now recanted his sworn testimony. He did it in a letter to Gladwin Hill of that newspaper.

COMMENT:

Roosevelt and lived for a time at the White House. Lash was recently employed as the United Nations correspondent for the "New York Post."

According to a Washington City News Service release dated March 20, 1954, Crouch [redacted] an employee of INS, testified before the Senate Internal Security Subcommittee at New Orleans on March 20, 1954, that one of the persons who had operated an espionage ring at the White House was Joseph Lash. The files concerning this matter are being reviewed in the Espionage Section to determine if this information has been previously furnished to the Bureau [redacted]

WINCHELL SAID:

One of the biggest islands in the Pacific Ocean, which we recently tested the "H-Bomb," has completely disappeared.

During the above-indicated broadcast, WALTER WINCHELL mentioned that JOAN CRAWFORD now goes with one CHARLES BARON, to whom he referred as one of the richest Ford dealers in Chicago.

I thought perhaps you would be interested to know that the CHARLES BARON mentioned by Mr. WINCHELL is identical with one BABE BARON, mentioned on page 137 of the book entitled "Chicago Confidential" by JACK LAIT and LEE MORTIMER. In this book the authors refer to the premises at 215 North La Salle Street, Chicago, where, they maintain, is operated one of the biggest betting clubs in the midwest. Its owners, according to the book, are associated with BABE BARON, a friend of Democratic leader JAKE ARVEY. BARON, a former athlete and one-time Lieutenant Colonel, killed JIMMY WALSH in front of Henrici's Restaurant on December 3, 1929. In 1934, when arrested as a suspect in the GUS WINKLER murder, he was carrying a loaded gun. He also owns an auto agency and has a contract to repair Chicago police cars. He is also reputed to be head of a syndicate which in January 1950 purchased the Chez Paree in Chicago.

The above information is all taken from "Chicago Confidential." It may be of further interest to know that during the past year, when JACK LAIT substituted for WALTER WINCHELL's column, he mentioned the above information on the occasion of one of BARON's visits to Los Angeles.

In 1953, BARON made an unsuccessful bid to handle the repairs on Bureau cars in Chicago. The Bureau was advised of his background at that time.

General Lawton is Commanding Officer at Fort Monmouth, New Jersey, and according to press comments, has favored the position taken by Senator McCarthy with respect to the investigation at Fort Monmouth, New Jersey.

WINCHELL SAID:

A seditious letter-writing campaign will be conducted against Ray Jenkins - - directed by Reds and some members of a democratic action outfit aided and abetted by a notoriously pink New York newspaper. Their plan is to interrupt at the hearings by applause. Jenkins is Special Committee Counsel in current McCarthy-Army hearings.

COMMENT:

The democratic action outfit referred to is probably the Americans for Democratic Action, and the newspaper, no doubt, refers to the "New York Post."

WINCHELL SAID:

Gregory Peck, movie star, has received threatening letters which he has turned over to the FBI.

COMMENT:

No information has been received at the Bureau regarding this, and the New York Office has advised that no information has been received by that office concerning this matter.

WINCHELL SAID:

Myra ~~Myra~~ Harry Bridges, the union leader, and his wife will get a legal separation.

COMMENT:

None.

WINCHELL SAID:

Dr. Condon's connection with the Oppenheimer case will take a very serious turn. Five atomic scientists linked with subversive

activities were virtually sheltered at Condon's Washington home and coached on the Fifth Amendment.

COMMENT:

When Oppenheimer testified before a Congressional Committee in 1949, he stated that Bernard Peters had been a member of the Communist Party in Germany. Peters is another atomic scientist. Oppenheimer's testimony was later published and Condon wrote two letters, one to Oppenheimer and the other to his (Condon's) wife, in which Condon indicated he was astounded that Oppenheimer would do such a thing to his (Oppenheimer's) friend, Peters. Oppenheimer later publicly retracted his statement regarding Peters. Copies of the Condon letters came into our possession in 1952 through Congressional Committees. The identities of the five atomic scientists referred to by Winchell are not known at this time.

WINCHELL SAID:

Samuel Roth, publisher of obscene magazine and books, has been indicted by a Federal Grand Jury in New York. He used the mails. He once served three years at Lewisburg Penitentiary for the very same thing. If convicted again, he faced 40 years plus \$40,000 fine. His photograph appears on page 26 of the next issue of "Confidential" magazine. One of its authors, Lyle Stewart, whose real name is Lyle Simon, also has a criminal record - extortion.

COMMENT:

This is a violation of postal regulations and is handled by the United States Post Office Inspectors.

WINCHELL SAID:

The "New York Post" newspaper building was the object of vandalism. Five bottles of red paint were smashed against its walls.

COMMENT:

The "New York Post" newspaper is edited by James Wechsler, an admitted member of the Young Communist League in the 1930s.

WINCHELL SAID:

Westbrook Pegler has requested permission to speak at West Point, New York, to answer Edward R. Murrow's speech at West Point. Pegler's request may be granted in the Fall.

COMMENT:

None.

WINCHELL SAID:

The Communists are assured of the cooperation of a well known columnist in another smear campaign against J. Edgar Hoover and the FBI.

COMMENT:

It is not known to what newspaper columnist Winchell is referring.

WINCHELL SAID:

Harrison, New Jersey - - Benedicto Macri, wanted for murder a few years ago who gave himself up to me and was later acquitted. His brother, Vincent, was murdered this week. Benny didn't show up at brother's funeral - - Is he alive? His car stained with blood was found near here one hundred feet from a river. The police have a new tip on the murder of Macri - a garment union in and near Wilkes-Barre, Pa. It may be vengeance for the murder of Lurye, the New York union organizer, a few years ago.

COMMENT:

William Lurye, who was an American Federation of Labor union organizer in New York, New York, was murdered on May 9, 1949, in New York City. [redacted] was tried for this murder and was acquitted. He has not amassed any monetary awards to show for three decades of public service; in fact, Mr. Hoover is practically poor. Not long ago, he paid for the mortgage on his home, the one his mother gave him. That mortgage is the badge of John Edgar Hoover's integrity - - More so than the gold badge he carries in his pocket. John Edgar Hoover has amassed no loot for his thirty-seven years of public service, but he does have the nation's admiration and respect and the President's handshake and salute. So I'm sure I speak for all Americans and say, "Here, John Edgar Hoover, is our affectionate embrace."

COMMENT:

For your information.

WINCHELL SAID:

Last week I said the Army-McCarthy hearings should be continued out in the open - - but since the President has begged for unity because our country is in deadly peril, I believe the hearings should be brought to a prompt conclusion.

COMMENT:

The FBI has just captured the five men wanted for the Detroit bank job of last Friday. Half of the \$30,000 loot has been recovered.

Therefore, if, in this man's sole judgment, his conscience required him to furnish Senator McCarthy information involving the security of our country, under the Constitution, he commits no crime. The precedent was set in the fight over Navy Captain John Cromelin, a great hero in the last war. He gave Congressmen data marked "Confidential" by the Secretary of the Navy. He was reprimanded and then later promoted to Rear Admiral.

Havana, Cuba: The number one alert is for a mysterious submarine openly operating in Caribbean waters. It was last spotted near Nicaragua.

COMMENT:

According to press reports of the past week, the Nicaragua Government announced there had been discovered buried on the Nicaragua coast a small cache of arms which allegedly bore the hammer and sickle trademark. The arms consisted of approximately forty rifles, two or three automatic weapons and several dozen hand grenades. The rifles and the automatic weapons were manufactured in 1936-1937, but the grenades are of more recent manufacture. Photographs of these arms have been sent to appropriate U. S. officials for examination. Nicaragua officials have surmised that since a Soviet submarine has been reported seen off the coast of Nicaragua, it is assumed that the arms were brought by this submarine in order to assist Nicaragua Communists.

WINCHELL SAID:

Senator McCarthy, legal experts tell me, did not have to take the stand and waive immunity. Section 6, paragraph 1, of the U. S. Constitution prohibits any quizzing of a U. S. Senator any place except in the U. S. Senate.



It is noted that the Walter Winchell broadcast of May 30, 1954, indicated that international society, especially in Florida, would be astonished when the FBI and New York Police arrested an individual long suspected of fingering jewel and fur robberies over the entire United States involving millions of dollars. Winchell did not name the individual in question.

ASAC McCabe of the New York Office, in response to the Bureau's inquiry, has advised that the New York Office is unable to identify any individual with the information in the Winchell broadcast and has no knowledge of any such matter. SA [redacted] of the Miami Office, during the course of a telephone conversation on other matters, was also questioned regarding this item in Winchell's broadcast and stated that no information regarding it was known to the Miami Division.

No such incident is known to the Investigative Division and the above is set out solely for your additional information and for record purposes.

ITEM:

The majority of Pearson's program was devoted to what he termed a most important story of 133 racketeers and leaders of the underworld who were listed a year and a half ago for deportation but who have not yet been deported. He said they were listed for deportation by Attorney General James McGranery and when Pearson checked last week only six had been sent back to Europe. Pearson observed that there was legitimate reason for delay in some cases but on the other hand many of these persons have powerful friends.

Pearson said one of the racketeers listed for deportation is Frankie Costello who he said was not being favored as he was convicted last week of income tax evasion. Pearson said, however, it took seven years in Costello's case and that his case illustrates the political pull and facility of the underworld to escape punishment. Pearson said he was rather acquainted with the Costello case and felt he may have had a part in sending Costello to jail.

Pearson related that as far as he was concerned the case began in 1946 when he met Jimmy Regan, "Crown Prince" of the gambling world. Pearson said Regan told him all the secrets of the underworld and urged him to tell the Justice Department. Pearson said he gave the information to Attorney General Tom Clark who sent 12 FBI men to Chicago and they brought back an astonishing report of bars, taverns, hotels, restaurants, etc., all controlled by the underworld. Pearson said that about that time an attempt was made on Regan's life which was unsuccessful but later someone slipped into the hospital and placed a tube of mercury in Regan's stomach, killing him. Pearson said that Regan's death caused him to write a series of articles exposing the underworld and Frankie Costello.

Pearson said Regan told him Costello was one of the most powerful leaders of the underworld. Pearson said that he (Pearson) eventually dug out the fact that when Costello took out his citizenship papers in 1925 he had perjured himself by concealing the fact he had once served a term in jail.

Pearson said that on July 21, 1947, he wrote an article showing that Costello, having committed perjury could be deported. Pearson noted that this was seven years ago and that as yet Costello has not been deported for he has friends in very high places. Pearson said one of his friends was Jimmy Hines, former head of Tammany Hall, New York, who was later jailed as part of Dutch Schultz's police racket. Another friend Pearson said was Walter Winchell who always seemed to write nice things about Costello and according to Pearson because Costello contributed to Winchell's cancer fund. Another mentioned was Charlie Fischetti, cousin of Al Capone and ruler of the mob in Chicago.

Pearson said he had several conversations with Attorney General Clark and Commissioner of Narcotics Anslinger, both of whom he said were sincerely out to get Costello. However, he said there were others in high places who were apparently dragging their feet. Pearson related that the most important phase of the underworld empire was the teamwork between the gang leaders in different cities. He said Costello was largely responsible for this and invited the gang leaders to a racketeers convention in Atlantic City where they agreed to divide the United States between them and not infringe on each others territory. Pearson said thus, Joe Adonis ruled New Jersey, Jack Dragna was a ruler of this same Mafia underworld in Los Angeles and that the ruler in Chicago is Jake Gousic (phonetic) who replaced Capone and Charlie Fischetti. Pearson said that persons mentioned above represented the Mafia and that that was how the Mafia operated.

Pearson said that four years ago he wrote a series of columns about this great underworld network and showed them to Senator Keafauver and it was about that time that Senator Keafauver together with his committee became active and according to Pearson did more than any one single person or group of persons to send its king to jail. Pearson said that Costello has served one term for contempt, faces another long sentence for income tax evasion and that after that he hoped would face deportation as a result of the charges brought by Pearson seven years ago.

Pearson said that in the past President Eisenhower has tended to appease Senator McCarthy on the theory that he would be a good campaigner for the Republicans and for this reason Attorney General Brownell may have left the Senate report on McCarthy's finances gather dust. Pearson predicted that since McCarthy in effect called President Eisenhower a "fifth amendment president" and has castigated the army where Eisenhower spent 40 years of his life that at long last the Justice Department will dust off the Senate report regarding McCarthy's finances and will review it in dead earnest.

Earl Browder in 1939 when Browder was head man in the Communist Party here. Browder, under oath, testified that it was a Communist transmission belt. A Congressional group cited it as a Communist front in 1944. Another Congressional committee, in 1950, reported that the "National Lawyers Guild is the foremost legal bulwark of the Communist Party." The National Lawyers Guild (NLG) on November 30, 1953, filed a complaint before the U. S. District Court, Washington, D. C., asking for a permanent injunction and for a declaration that Executive Order 10450 be declared unconstitutional. On December 4, 1953, the NLG filed a petition for a temporary injunction to restrain the Attorney General from proceeding under Executive Order 10450. On December 30, 1953, the District Court denied the NLG motion for a temporary injunction. On May 4, 1954, the Court of Appeals reversed the order of the District Court denying the temporary injunction and ordered that the Attorney General's administrative action be stayed until such time as the U. S. District Court passes on the NLG petition for permanent injunction.

He was found guilty by the court and sentenced on November 5, 1953, to one year in prison, the eight months already served to be counted in the year sentence. District Court, San Francisco, California, to serve a term of six months in prison and to pay a fine of \$10,000 on the charges of failing to submit for induction on April 13, 1951, at Fort Ord, California, in violation of the Selective Service Act of 1948 [REDACTED]

WINCHELL SAID:

A Red-controlled outfit on the Attorney General's subversive list will stage a meeting in Detroit on June 8th, 1951, in the Metropolitan Building, Detroit, Michigan.

COMMENT:

Contact with appropriate supervisors in the Internal Security Section failed to identify above organization and its scheduled meeting. An examination of incoming teletypes and air-tels from the Detroit Division for the past month also met with negative results. Inquiry is being made of the Detroit Office.

WINCHELL SAID:

The Jenner Investigating Committee has subpoenaed Gilbert Parks, one-time magazine executive. He will testify against former Red comrades.

WINCHELL SAID:

The "New York Times," this week reported that Dr. P. A. Dirac was refused a visa to the United States. Dr. Dirac is a Polish physicist and an intimate friend of Dr. J. Robert Oppenheimer. The reason for Dirac's visit here was to discuss with Oppenheimer an invitation from Cambridge University, England to accept an offer as a professor. Dr. Oppenheimer, bitter over the 2-1 vote against him, will accept that British offer whether or not he is cleared by the Atomic Energy Commission.

COMMENT:

The Bureau has conducted no investigation concerning Dr. Paul Adrien Maurice Dirac, Physicist and Nobel Prize winner. On 9-5-51, [REDACTED]
