At that time Chambers furnished the names of several persons, who had been employed by "Time" in the past, who were members of the Communist Cell mentioned by him.

WINCHELL SAID:

Philadelphia. The FBI has exposed virtual slavery among working people at a labor camp in the State of Pennsylvania. A Federal Grand Jury in Philadelphia will get it next.

COMMENT:

This probably refers to the situation investigated by the Bureau in the case captioned [redacted] et al; [redacted] et al - Victims, Involuntary Servitude and Slavery" Bufile 50-2570, Philadelphia, origin. This case involves recruitment of laborers from the Southern states, transporting them to a migratory labor camp at Ulysses, Pa., and keeping them in enforced labor against their will. Subjects reportedly kept workers in debt through excessive charges for food and lodging; prevented their leaving camp until accounts were settled. Subjects allegedly posted armed guards and engaged in mistreatment of some debtor-victims to prevent their leaving. Memorandum from Mr. Price to Mr. Rosen dated October 28, 1954, reflects that the U. S. Attorney, Scranton, Pa., who originally planned to present this case to a Grand Jury at Scranton in October 1954 had postponed presenting case to a later date, not yet set.

Davies was subject of an extensive investigation under Executive Orders 9835 and 10450. Congress on next Wednesday will start hearings in Cincinnati on liquor, insurance and welfare fund scandals in the Army. The first witness will be reporter Michael Stern of "Argosy" magazine. He exposed 'em in that magazine.

Winchell may refer to the situation described in November 1954 issue of "Argosy" magazine in a feature by Mike Stern captioned "How to steal \$8,000,000 a year." WINCHELL SAID:

One of the most important decisions in our history was reached last week and I do not mean the election. The Department of State has decided definitely to pull out from Nationalist China and permit gradual trading with Red China. Now the only reason it isn't being done immediately is that, as of tonight, American public opinion simply won't stand for it. So I am reporting advance news when I reveal the plan.

A huge, expensive and very clumsy program will shortly be started pointing out the advantages of peace in the Orient. Now no one, of course, will mention that the so-called peace in Korea brought a new war and a disastrous defeat in Indo-China. The advantages of international trade will be heavily emphasized, though no one will remind you that Russia's principal export is Communist packaged revolutions. The dreary, the dirty and the deadly policy of "business as usual" has been given a new coat of paint to make it very attractive. An agreement on peace would be wonderful, I know, if you didn't remember that the Communists have broken more than 72 peace treaties. I know that cooperation sounds fine if you could just forget that the fourteen governments that tried cooperation with Russia are no longer in power. So don't be fooled. Trade with Red China will not bring you peace any more than sending scrap iron to Japan avoided Pearl Harbor. Communists intend to rule the world and the only reason they want trade is that they need your machines to take your life.

Madrid. The French Government has agreed to discipline Spanish refugees in France in return for commercial privileges. Franco insisted and Paris consented to "regulate" them. That's the diplomatic word, "regulate," for "sell out."

Recent newspaper accounts have indicated both the Jenner Committee and the Velde Committee have been considering calling Hiss as reflected in the memorandum from F. L. Jones to Mr. Branigan dated November 23, 1954.

WINCHELL SAID:

Louisville. The same investigating committee will blow the lid off a Red conspiracy in Louisville. Many local names will be involved.

COMMENT:

Winchell may be referring to the matter being followed by the Bureau under the caption "Unknown Subjects, [REDACTED] - Victim, Civil Rights," Bureau file 44-7530. A Velde Committee representative was at Louisville, Kentucky, during October, 1954, checking into this situation with local authorities. For your information, in June, 1954, the victim's house, purchased in a white section of Jefferson County, Kentucky, was bombed. Investigation of the bombing led to the indictments on October 1, 1954, and November 4, 1954, of seven Communists by local County authorities. The indictments charged them with criminal syndicalism and sedition, though no specific actions were cited in the indictments. It appeared the seven Communists became involved in the bombing in an effort to stir up racial hatreds. The local case goes to trial today. No active investigation has been conducted with respect to the civil rights aspect of this incident. All seven indicted Communists are on the Security Index.

This group reportedly approaches employers having connections with the Teamsters Union and states that

for a fee it will assure that the employer will have no trouble with the Teamsters Union. In addition to a group of hoodlums, [REDACTED] is associated in this enterprise with James R. Hoffa, a vice president of the International Teamsters Union, who is located at Detroit, Michigan. New York is endeavoring to verify this report through a reliable source, after which the case is to be discussed with the United States Attorney.

WINCHELL SAID:

Mr. and Mrs. United States. What you haven't been told about the Americans imprisoned in Red China is even more outrageous than the headline which shocked the nation this week. Very highly informed sources believe that the number of Americans held in anonymous slavery is nearer 1,300 than 13. Our Government had good reason to think so also and at the shameful Geneva Conference Bedell Smith, then our Under-Secretary of State, furnished very exact figures to Anthony Eden with the request that the status of these Americans be cleared with Mr. Eden's very good friends, the Red Chinese. Mr. Eden took up the matter with the Red Chief, Chou En-lai, who denied he had any Americans in prison. General Smith pressed Mr. Eden who became very angry and said he, Eden, had good reason to believe that the Red leader was telling him the truth. Very reluctantly, Washington relied on London and truce with Indochina was agreed upon. Without Red China's confession our so-called allies would have continued to insist that Red China holds no Americans, but the bitter fact is that cynical Anthony Eden is now no longer in a position to deny it. The reason the Chinese Reds revealed it, and their attacks on the Nationalist islands have the same objective, they have decided to test Mr. Dulles' statement of two weeks ago; that attack on Formosa would mean war; or to see if we would back down again. Our treaty with Chiang Kai Shek is still being drafted and Red China is putting the heat on before both parties have signed. Great Britain and France have a very big plan for all of this crisis. They will conclude the London-Paris military agreement with the West and then announce --- We are strong enough to appease in the East. A few Americans will be returned and trade with Red China will start, if, that is, Eden and Mendes-France have their way. In other words, business as usual, except for the many American families whose men work out their lives in Red slave camps. To these families I can only offer this; there are words to describe the dirty, diplomatic doublecross of your loved ones, but they cannot be used over this microphone.

Last evening the Attorney General called me at my home and inquired whether I had heard the Walter Winchell broadcast of last Sunday. I told the Attorney General I had not heard the broadcast. The Attorney General stated he had been informed that Mr. Winchell had made a statement to the effect that there were eight Russian spies now working for the Government in Washington. The Attorney General stated that he was quite concerned about such a statement as it placed the Department of Justice in the position of not knowing what was going on or if it did, not seeing that appropriate action had been taken. The Attorney General inquired of me as to whether I thought some action should be taken to call upon Mr. Winchell to produce the facts upon which he predicated his statement.

I told the Attorney General that I thought the best way to approach it would be to contact Winchell if he could be reached and to ascertain from him where he had obtained the information and upon what facts he predicated the statement he made. The Attorney General thought this would be desirable and asked that I take steps accordingly. I called Mr. Tolson and outlined to him what the Attorney General had had to say and asked him to take hold of the situation and try to reach Mr. Winchell. The subsequent memoranda which have come through today set forth the subsequent developments following my original conversation with the Attorney General.

I stated none were American citizens and none worked for the U. S. Government. I told the Attorney General that we had been assured Mr. Winchell will make a correction.

Today I called the Attorney General to give him a report on the Walter Winchell matter. I advised him we had been unable to get in touch with Winchell as he left for the Coast to join his family last night, but we are presently trying to locate him to find out exactly what the picture might be concerning his broadcast Sunday night.

I stated the sum and substance seems to be that Winchell said a former Russian Intelligence Agent testified before a Senate Committee that eight spies are now working for the Government. I stated in checking into our files, we find a man by the name of [REDACTED] who has been writing articles for the Saturday Evening Post.

[REDACTED] I stated [REDACTED] incidentally, [REDACTED] testified before the Jenner Committee and, merely putting two and two together, it is possible that someone like Roy Cohn, having this information of his testimony before the Jenner Committee, may have passed it on to Winchell. I stated I would get in touch with Winchell to straighten him out and see whether it is what I suspect because it presents an entirely different picture than what he said in his broadcast.

The Attorney General asked if I thought Winchell would be willing to correct the statement and I added that he was very temperamental and highly emotional and while a letter could be written to Winchell officially, he probably would not like it and would make a great commotion over it. The Attorney General stated he didn't want to stir up anything and I stated I would prefer to get over to Winchell the fact that somebody has imposed upon him and given him wrong information, which I knew would agitate him more than anything else. I stated if Winchell took it in that light he would probably on his own initiative make the correction, which is the way I planned to approach it as soon as we can.

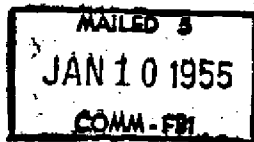

Merling North Reviews the Books

THE RED CARPET: 10,000
miles through Russia on a
Vladimir Khrushchev. By
Marshall MacDuffie. Norton.
320 pp. \$4.50.

As any good boxer knows, split-second anticipation of the opponent's next move is essential. Our ponderous and often static policies toward Russia and China may pamper our prejudices, but they do not necessarily insure our survival.

For instance two new and objective studies of our mortal enemies seem to prove that Red China, if hampered in every possible way short of war, may wither on the vine; while recent Russian progress should give us real cause for present concern.

The Prospects for Communist China, by W. W. Rostow. Technology Press and Wiley. 379 pp. \$5.00.

A New Look At Red Russia while far too dry, statistical and technical for the general reader, has a payoff to top any thriller; a possible "happy ending" for America. By cold calculation the Chinese within the predictable future will never be able to produce the extra food to nourish an industrial revolution or even to mechanize their agriculture. Lagging more than half a century behind us in both fields, even the "massive control capabilities" of the Communist state cannot squeeze from a peasantry just above the starvation level the farm products needed to pay for imported machinery to feed the elite cadres, the military and

the urban workers. The author predicts an eventual "political crisis on the mainland and in Sino-Soviet relations."

A very different and more disturbing situation is reported by Marshall MacDuffie, (who, through a mysterious dispensation, obtained a visa which allowed a relatively unchaperoned 10,000-mile tour through the heart of Russia.)

Marshall MacDuffie, American lawyer and ex-chief of an UNRRA mission in the Ukraine in 1946, could scarcely credit his good luck when in response to a cable to N. S. Khrushchev, chief of the Soviet Communist party, whom he had known while in the Ukraine, he was given a virtual carte blanche to tour Russia with notebook and camera.

He visited courtrooms, collective farms, theaters, private homes, great factories and power plants, talked to managers, engineers, workers, farmers, professors, officers and soldiers. He was given a surprising amount of information on industrial production, farm production, wages, salaries, hours, cost of rent, food, clothing and the increasingly available luxuries. He reports many new skyscrapers going up in Moscow and massive reconstruction in some of the areas overrun by the Germans. Life is more endurable though still very far short of our standard of living.

But Mr. MacDuffie was startled by the enormous number of men he saw in uniform.

And any illusions he may have had previously concerning the ability of the Soviet engineers to produce intricate, ingenious and effective machinery and machine tools was rudely shattered. However, the average Russian still finds whatever machinery is put in his hands of use.

While Mr. MacDuffie found the American Embassy living in a virtual state of siege, he himself encountered no enmity or even rudeness from the Russian people. The pointed questions, which they invariably asked, however, showed that the Kremlin's vicious anti-American propaganda has evoked an evil caricature of us in many minds.

The Russian people seem to want peace, they sing and write of peace. They believe that their government is dedicated to peace, while for some reason we are the "war-mongers." Why do we threaten them? Why do we starve our workers? Why do we resist the gentle North Koreans who only wish to recover their homeland? And how can one man, even one as bright, patriotic and willing as Mr. MacDuffie, counteract years of such governmental lying.

The author came out with 2100 pages of notes and hundreds of rolls of film. What he tells in his objective way is both heartening and frightening. Here is a book on which your life and mine may depend. It is worthy of our closest possible attention. I think that it proves that Russia is a far greater menace at the moment than is Communist China.

This is a reporters report to the people: Ladies and Gentlemen! About two months ago the State Department declared that any attack on Formosa and its islands would mean war with us.
