

As of yesterday, by the way, Griffin still did not have a local outlet for his program after this week. Channel 5 offered a morning hour that will open up in the near future, but the guess here now is that channel 20 (WDCA) will pick it up at its regular time.

With Griffin due in Washington next month, hopefully to do several programs with government officials and other area guests, the lack of a local outlet would present embar-rassing problems.



Investigation was predicated upon the receipt of information that Richard Bononzi, 18 Bryn Mar Street, Worcester, Massachusetts, had been in contact with Black Fanther Headquarters, San Francisco, California, with request for copies of "Seize the Times" "Dig" and three dozen cards.

#### concerning Richard F. Dovenzi:

Bovenzi was born at Worcester, Massachusetts, on December 3, 1935 and his home address is 19 Brun Mar Street, Worcester, Massachusetts.

he would attempt to develop background information concerning Bovenzi.

ovenzi had in May, 1969, assisted in the formation of the group known as Americans for Self-Help (Ash). This organization was for the purpose of helping the underprivileged in the Worcester area. Bovenzi returned to Worcester allegedly in the spring of 1969 from California, where he supposedly worked as an actor. Bovenzi then began a fund raising drive for Ash

Moffman allegedly told him to return to Worcester and make a name for himself.

In November, 1969, Bovenzi took a trip to California for the purpose of obtaining Minister's credentials, which would enable him to start a church of his own. He returned from California just prior to Thanksgiving and at this time appeared to have lost his interest in Ash, which organization appears to have become defunct.

that Bovense has participated in a picket of one of the Thom McAn stores in Worcester during March, 1970, which picket alleged this company was discriminating against the hiring of minority peoples. That he learned that Bovenzi allegedly at one time was connected with Core in New York City.





Abbie kioffman and Jerry Rubin Live in two worlds. There's the world of the streets—of Chicago, the Pentagon, of Uncle Sam hats, American flag shirts, Brillo hair—the media manipolative put-on world of the Yippies.

Figt less visable, there's another world of literary agents, regally checks, sales percentages, because fees, book and more contracts.

For Hellman, 32, and Rubin, 31, are leading examples of a new discovery by book publishers and movie producers: There's big money in revolution.

Holiman's two books already have sold 191,000 copies, have carned more than \$50,000 in advances, royalties and resale rights. As an added honus, his book "Revolution for the Holl of A" was bought by Metro-Goldwyn-Mayer to be made into a movie. Holiman's share in the complicated deal is at least \$25,000, with another payment still pending. The Yippie leader also has a piece of the net profits.

Hoffman and Rubin, flumbowant radicals with more than 30 arrests between them, are a bit rejuctant to talks about

about their business side.

Are you a good businessman, Hoffman was asked? "Maybe," he replied after a long pause. "But I'm a better pool hastler."

"He talks about advances. He talks about percentages of things. He knows what he's doing," says Christopher.

Cerf, the Ramoon Hours editor who worked on Holfman's second book, "Woodstock Nation."

Rubin's book "Do R" has sold 175,000 copies since it appeared last year. "Us going to soil a million," he predicts, Rubin has carned at least \$13,000 from the paperbook so far.

Sphered by the saccess of the two Yappe leaders and Black Partler Editing Charact before them (Cleaver's both "Soil on hee" sold nore to be 1.2 million copiest, some purporpublishers have assigned editors to keep an eye on the new left, to watch the specis for potentially hot library properties.

The latest entry. Fancher Party Chairman Bobby Seale's book which was sold by fellow Panthers during a raily on his behalf in New Heven, Genn. last month.

"There's a reclaim composition among publisher: for who has the best radical going," says Carl Brandt, Rubin's agent, who also represents more traitional writers such as Marquis Childs and Stephen Birmargham.

In a large sense, it's the latest twist—with today's royalties added—to a pre-iometion that started with Tom Paine revolutionary pumpulateering. Publishers, themselves, may not agree with the centiments, but they feel the public has the right to know.

The books clearly are aimed at youth. Hoffman and Rubin sell well at college book stores. Hollywood's decision

The literary success of Hoffman and Rubin mixes both Marxes, Karl and Groucho, with a lot of show biz.

A key person in the beginning was Joyce Johnson, Hoffman's first editor at the Dial Press.

"I lived in the Fast Village on St Marks Place. One could not help become aware of Abbie," ahe said. "Just on the off-chance he might be interested in doing a book, I dropped him a note."

Hoffman collected a \$2000 advance from Dial. But the book really didn't take shape until just after the Demoeratic National Convention in

"He called me up and said. Two got the book." It was right after Chicago. It suddenly jelled," she recalled. "He wrote very quickly. He's very facile, very clever. It just pours out of him."

Hoffman did most of the writing on his second book in Christopher Cert's office. Often he lay on the floor, shirt off, scribbling in longhand. A parade of mini-skirted editor-lal assistants filtered in and out, staring.

One day Christopher's father, Bennett Cerf, head of Random House, toured company with a matron. They opened the door and there was Hoffman, barechested, working on the book in his usual position. "He's not my son," Cerf exclaimed.

Ili, Dad'

"Hi, dad," Hoffman answered with a blg grin.

Brandt recalls he first met Rubin in Central Park while he was watching a Yippie "love-in." Those were the days when the Youth International Party, founded by Hoffman and Rubin, was trying to recruit members so protests could be organized in the streets at the Demogratic Convention.

Rubin later arrived at Brandt's Park Av. office with the outline for his book. "Do It," was turned down by 15 publishers before Simon and Schuster accepted It.

Hoffman and Rubin are supreme self-publicists.

"Terry's & maryclous pro-

moter," says "Brand: "The trial itself was great promotion."

During his Chicago trial on charges of conspiring to cross state lines with intent to incite riot, Rubin gave federal Judge Julius Hoffman pages from the book. Since then, Rubin has appeared on ABC's late night Dick Cavett show. Rubin didn't plug the book, but he tore up and stepped on a judge's robes. Letters to Cavett generally damned Rubin but praised the program for having him on.

"Just being Abbie is publisty in itself," says a spokesman for the Dial Press.
"He makes news. In our office he's courteous. "He's trying to figure out ways to promote the book...he knows what he's here for. We know what he's here for."

Sometimes, when traveling around the country on revolutionary missions, Hoffman will tuck a list of bookstores to be visited into his suitcase. During a recess at the Chicago trial, he hosted a fingermint party—instead of the traditional autograph party—at a Chicago bookstore.

"He's better at publicity; than anyone else I've met," Cerf says. Hoffman's lawyer and business agent, Jerry Lofcourt, says: He'd probably be worth \$250,000 on Madison Av."

All the hoopia tends to obscure the business side, which includes the business of revolution. The books are

designed to bring down inhibitions and institutions. America. Hoffman's wife,

A sample from Hoffman:

"One good way to protect the security of your gang is to all turn on together with LSD. A cop would smoke pot but he sure as hell would never drop acid. Also I've never seen an undercover cop with long hair and I've seen a lot of undercover cops."

And one from Rubin:

"When planning a demonstration, always include a role for the cops. Most people don't get excited until the cops come in. Nothing radicalizes like a cop. Copsure perfectly dressed for the ole of 'Bad Guy.'"

Where has all the money none? Certainly some of it has gone for bail. Hoffman and Rubin vehemently deny having sold out to capitalism in the slightest degree. They say, and their agents claim, almost every penny of their carnings flow back into the movement. Lefcourt says that Hoffman's lifestyle has not changed—and that the Yippie leader now has to worry about his income taxes.

"He isn't rich," adds Lefcourt.

#### More Books

"I was not co-opted," Rubin says. "I didn't do the book for money. I did the book tecause t wanted to spread the fire. We're using the system to destroy it."

But Rubin praises Simon and Schuster. "Even a good Communist can respect a good capitalist," he says. "They have distributed the book well."

What of the future? Hoffman is writing two more books. One is called "Steal This Book" and is a manual of how to get things free in America. Hoffman's wife, Anita also is writing a book. Rubin says he is planning another book this summer. There are also plans to revive the Yippies as a political party this fall. Rubin and Hoffman want to start their own publishing house.

The two revolutionaries paused the other day amid all the activities to reflect on themselves as authors.

"A book is like a chocolate bar. You experience it. It's not just debat'ng intellectual ideas," said R fbin.

BLACK PANTHER PARTY Also Known As Black Panther Party for Self-Defense

According to its official newspaper, the Black Panther Party (BPP) was started during December, 1966, in Oakland, California, to organize black people so they can take control of the life, politics and the destiny of the black community. It was organized by BOBBY SEALE, BPP Chairman, and HUEY P. NEWTON, BPP Minister of Defense, NEWTON was sentenced in 1968 to serve 2 to 15 years after being convicted of manslaughter in connection with the killing of an Gikland police officer.

The official newspaper, "The Black Panther", which further describes itself as the "Black Community News Service", states that the BPP advocates the use of gubs and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to in the publication as "pigs" who should be killed.

"The Black Panther" issue of September 7, 1968, contains an editorial by BPP Minister of Education, GEORGE MASON MURRAY which ends with the following:

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement, "...we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman MAO Tse-tung of the People's Republic of China and feature MAO's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.

NATIONAL EMERGENCY CIVIL LIBERTIES COMMITTEE, Formerly Known As Emergency Civil Liberties Committee

The "Guide to Subversive Organizations and Publications" of December 1, 1961, by the Committee on Un-American Activities, United States House of Representatives, Washington, D.C., describes the Emergency Civil Liberties Committee (ECLC) as an organization whose avowed purpose is to abolish the House Committee on Un-American Activities. It stated the ECLC was established in 1951, and "although representing itself as a non-Communist group, actually operates as a front for the Communist Party."

"The New York Times" issue of April 1, 1968, contained an article reflecting the ECLC was changing its name to the National ECLC (NECLC) "to reflect our determination to develop a vital national civil liberties organization in all 50 states as rapidly as possible."

The "Newark Sunday News" of Newark, New Jersey, issue of April 20, 1969, contained an article showing the NECLC, of 25 East 26th Street, New York, New York, operates from its office an anti-war legal help organization for draft-age men, reservists and those on active duty.



#### Abbott Howard Hoffman

A review of the records of the Criminal Court of the City of New York, Part 2B, Room 415, 100 Centre Street, New York City, on July 16, 1970, disclosed that Abbott Hoffman, with his attorney Gerald Lefcourt, appeared before Judge Arthur Braun in the Criminal Court of the City of New York on July 15, 1970, in connection with Hoffman's arrest at Columbia University on April 30, 1968 by the New York City Police Department (NYCPD) on charges of criminal trespassing and resisting arrest. Hoffman pled guilty to criminal trespass and was sentenced to a \$50 fine or five days imprisonment by Judge Braun. Hoffman was continued on \$50 bond and was given until August 17, 1970 to pay the fine or be jailed.

The records of the Criminal Court of the City of New York also disclosed that Abbott Hoffman, with his attorney Gerald Lefcourt, appeared before Judge Arthur Braun on July 15, 1970, in connection with his arrest by the NYCPD on April 11, 1969, on charges of simple assault and disorderly conduct, resisting arrest, harrassment and obstructing governmental administration.

On a motion of the District Attorney the charge of simple assault was dismissed.

Abbott Hoffman pled guilty to resisting arrest and was sentenced to \$1,000 fine or one year imprisonment by Judge Arthur Braun. Hoffman was continued on \$500 bond and was given until August 17, 1970 to pay the fine or be jailed.

On February 18, 1970, Abbott Howard Hoffman was found guilty in the United States District Court, Northern District of Illinois, Chicago, Illinois for violating the Federal Anti-Riot Law Statute for traveling in interstate commerce from outside the State of Illinois with intent to incite riots in Chicago, Illinois during the Democratic National Convention in August, 1968. On February 20, 1970, he was sentenced to five years imprisonment and fined \$5,000. On February 28, 1970, the USCA, Chicago, Illinois ordered Hoffman released on \$25,000 bond pending appeal of his conviction.


