Clarence Farris-wife, Irma, residence Wheeling, Missouri.
Vern Farris, single, residence 419 N. 7th St., Kansas City, Missouri.
Oren Farris, single, residence Gale St., Chillicothe, Missouri.
Lon/Farris - wife, Constance, mother and father of Lucille. (Constance with Lucille and Lyle her children, supposed to be living in Coffeyville, Kansas. Whereabouts of Lon unknown).

Ion Farris married Constance Campbell of Sumner, Missouri January 1, 1917; of this marriage there are two children Lucille now approximately 18 years of age and Lyle now approximately 15 years of age. The parents of Constance are deceased and she has one sister Eva Hooper, approximately 55 years of age and the last known address of Eva Hooper was St. Joseph, Missouri where she lived two years ago with her husband, name unknown, who worked for the railroad, branch unknown.

Bernice Elliston stated she saw Vern Farris and Addie Murrain last Decoration Day and they did not know whether Lucille was married and they did not hear from Constance. On July 4th, Bermice saw Hazel Hopper, Oren Farris and Clarence Farris and they did not know that Lucille was married and they had not heard from Constance. The conversation among the brothers and sisters centered around Lon whom they had not heard from since he left Constance and the children in Meadville, Missouri two years ago. Constance does not communicate with members of the family and has not visited them since she left Meadville, Missouri. Bernice Elliston stated the movements of Lon and Constance since their marriage were as follows: -- Married January 1, 1917 and stayed five years at Summer, Missouri; moved to Meadville, Missouri and operated a restaurant for two years; moved to Chillicothe, Missouri and lived ca a farm for three years; moved to Tina, Missouri and lived on a farm for five years; moved to Edina, Missouri and operated a feed business for two years; moved to Fountain Grove, Missouri and lived on a farm for. one year; moved to Brookfield, Missouri and lived in town operating a trucking business for one Summer; moved to Meadville, Missouri where Lon left Constance and the children and that is the last the Farris family has heard of Lon and of Constance and her children as she moved to Coffeyville, Kansas. Bernice Elliston stated that the members of her family did not have any photograph of Lucille as the only photograph she remembers of Lucille was taken when Lucille was a baby. ...

## AT WHEELING, MISSOURI

Agent interviewed Clarence and Irms Farris and the father of Clarence, Andrew Farris, who resides with them, and was informed that they had not heard from Constance Farris, the wife of Lon Farris, since

was married and stated that the family did not communicate with one another. During their recent visit at Bernice Elliston's home, Meadville, Missouri, the brothers and sisters spoke about Lon and Constance and no one had heard from them and they believed Constance and the children were living at Coffeyville, Kansas, but they did not know where Lon Farris was. Irma Farris stated that P. Farris, great grandmother of Lucille (Andrew Farris' mother) had received a letter from her brother George Holt, Coffeyville, Kansas in April, 1936 stating that he had seen Lucille and Lyle Farris on the streets of Coffeyville, Kansas but did not speak to them then. P. Farris is living at Brookfield, Missouri.

Investigation was conducted at Wheeling, Missouri by reporting agent as it was within a point of five miles of Meadville, Missouri where investigation from the St. Louis Office was started and
although Wheeling, Missouri lies within the Kansas City, Missouri office district, it was deemed expedient to cover same at this time and
furnish the Kansas City, Missouri office with a copy of this report.

## AT BROOKFIELD, MISSOURI

Investigation at Brockfield, Missouri disclosed that Parilee Farris, widow, mother of Andrew Farris, resides at 224 West Sedgwick Street and at the present time was visiting a son, John Farris at St. Catherine, Missouri. Parilee Farris is 89 years of age and is receiving an old age pension from the State of Missouri.

## AT ST. CATHERINE, MISSOURI

At the home of John and Lillie Farris, agent interviewed Parilee Farris who stated that she never heard from Lon Farris' wife Constance or their children and it was two years since she saw them. Parilee Farris' brother George Holt, 801 Minnesota St., Coffeyville, Kansas wrote her in April last about seeing Lucille and Lyle Farris on the streets in Coffeyville, Kansas but did not mention that Lucille Farris was married. The last letter George Holt sent was in June, 1936 at which time he did not mention smything about Constance Farris or the children. Poffarris stated that she would write her brother George Holt and inquire regarding Lucille Farris. Upon receipt of any information concerning Lucille Farris and her present wheredouts, P. Farris will forward this information to the St. Louis Bureau Office. A self-addressed franked envelope was left with Parilee Farris for this purposee

UNDEVELOPED LEADS: KANSAS CITY OFFICE at Coffeyville, Kansas will interview George Holt, 801 Minnesota Street for information he may have concerning Lucille Farris Lett, wife of Milton Lett. George Holt communicates with his sister Parilee Farris, Brookfield, Missouri, a great grandmother

of Lucille Farris Lett and in his letter of April, 1936 he mentioned seeing Incille and Lyle Farris on the streets of Coffeyville, Kansas. The present whereabouts of Lucille Farris Lett is desired in an effort to locate Milton Lett. No additional information is being set forth regarding this lead as the Kansas City Office has received copy of the report of reference.



## Res BREXID

Agents working in Toledo, Ohio, have been intervioying all of the persons who were in any way associated with the Sesino during the sugger of 1934, when members of the Karpis-Barker gang were frequenting that rendervous. Information thus far obtained indicates that there was a close friendship between members of this gong and Ted lingua. Hone of the persons thus far interviewed have indicated that anyone et the Casino Club had any positive knowledge as to the true identity of these individuals. It is strongly indicated, however, that / rembers of the Englis-Enrice gang were brought to the Casino Club by Rilliam J. Marrison, who, many years earlier, had been interested in a saloon with Ted Angus in Humand, Indiana.

Information obtained also indicates that George Tisiney, formerly in charge of the Vice Squid of the Toledo, Ohio, Tolice Department, visited the Carino Club on nuserous occasions when members of the Karpis-Barker gang were there. Tisiney was very friendly with Millie Gerrison and on one occasion Timiney and Ted Angus concocted a sphere by which some of Tiriney's men would go to the Alger Motal in Toledo and errest Willie Herrison, who was at that hotel with Bynons Burdette and Edna Murray. This was during February or March, 1934, shortly after the reason money had been paid.

Mrs. Edith Warks is the sides of one Chat Markey an underworld character in Toledo, Ohio, who was killed in gengland fashion on August 9, 1931. Chat Harks was interested in a billiard room and also a dance pavilion. Likewise, be was interested in the Oreen Mill Might Club, and later took over certain gasbling concessions in Toledo and vicinity. After the death of Marks, and in March, 1932, Tlainey moved

into the home of Edith Mirks at 2650 Broadway, Toledo, and lived with her until only recently. They have now separated and thore appears to be a certain amount of enmity existing between them. Mrs. Marks informed that not long ago Timiney called her and asked her if she had been questioned by Federal Agents, at which time she advised him that she had been questioned by them, but, in fact, she had not, up to that moment, been questioned by Special Agents. She stated that Timiney asked her if she had told anything and she told him she had furnished no information. When eaked why she told Timiney that she had talked with Agents, Mrs. Marks stated that she just wanted to worry him. She likewise advised that at the time of the capture of Alvin Karpis, Timiney had called on her, at which time she inquired as to why he was so worried and further asked him if he were afraid of the G-Ken, to which Timiney replied that he had nothing to worry about.

Mrs. Marks has further admitted that on numerous occasions she and Timiney attended the Casino operated by Tad Angus. She has cited instances in which it was shown that Timiney was very friendly and well acqueinted with Millie Herrison. Timincy she elleged was likewise very friendly with Ted and Bert Angus. Mrs. Merks has identified numerous members of the Karpis-Barker gang as having been in attendance at the Casino Club during the times she and Timiney visited the same. Mrs. Marks has alleged that Addison Q. Thatcher, formerly Mayor of Toledo and non City Councilman in Toledo, was a personal friend of George Timiney and was Timiney's backer in the Police Depertment. She further alleged that Ted Angus was the pay-off man at the time Thatcher was Mayor, and it is her understanding that this arrangement commenced during the incumbency of Mayor Fickson. She elleges that during 1932 and 1933 on occasions when she visited the Casino, several times she observed women come into the Club to telk to Ted Angus. She alleged that these women were operating houses of prostitution. She further stated that Timiney has always been a free spender and has expended sums of money considerably in excess of his salary; that she would estimate that he had spent sums runging from \$10.00 to \$15.00 a day.

You will recall that Eymona Rurdetie was confined in the St. Vincent's Hospital in Toledo on two occarions during the summer of 1934. Investigation has disclosed that after the gang was "flushed" out of Toledo, Ohio, on September 5, 1934, there was an unpoid belence at the said hospital of \$300.00. Inquiry has now been made of Ruth Wells, the former paramour of Ted Angus. Buth Wells commenced living with Ted Angus about Thanksgiving Day 1931 and because of differences left him about June 1, 1936. She has informed that neither she nor Ted Angus knew the identity of the gang until the arrest of Synoma Burdette, Gladya Samyar and Paula Harmon in Toledo, Ohio, on September 5, 1934. She has alleged that she discussed this matter with Ted Angus and that they were both surprised upon learning the identity of the gang. She recalled, however, that some time after September 5, 1934, Tod Angus gave her \$100.00,

telling her that on the night previous Harry Campbell had given him the money to be paid to Dr. Nouglass who attended Mynone Burdette. Accordingly, Buth Bells actually paid this money to Dr. Douglass. Examination of the records of the hospital discloses that Buth Wells actually paid \$200.00 on account on Gatober 12, 1934. It is, therefore, reasonable to assume that Harry Campbell appeared at Ted Angus place between the dates September 5, and October 12, 1934, and that Ted Angus received this money from Campbell with knowledge of his fugitive character.

DET LILS:

This is a joint report of Special Agents J. B. ritzgerald and Clyde E. Smith.

Mr. mliot Ness, Director of Public Safety was interviewed relative to the police matron on duty in the city jail on September 5, 1934, during the time Gladys Sawyer, Wynona Durdette, and Paula Hermon were incarcerated in the Cleveland Cith Jail, and he furnished Agents with a report dated June 24, 1936, which was submitted by Rama S. Schuller. Sergeant, Women's Bureau, Cleveland Police Department, to George J. Matowitz. Chief of Police. The report sets forth in chronological order the activities of the verious police officials who conducted any investigation relative to Gladys Sawyer, Wynona Burdette, and Paula Harmon, as well as the names and addresses of the women arrested and in jail at the time the above named women were taken into custody. Following is the memorandum:

The second section is a second On September 5, 1934 at 6:15 PM Gladys Sawyer, Ethel A atterson and Wynone malcott were admitted to Central Station by Matron Mollie Bartelheim, who was working from 3-11PM. Women held for investigation. Ruth Ross admitted at 7:25 PM charge Intox - Rel.

On September 8, 1934 three women in question were turned over to Federal authorities and their case in police court was nolled.

The following is Women's Bureau record on Ethel Matterson, alias Faula, alias Marion Bradford, alias Ethel Marsh, 30, 10515 Farkhurst Avenue, also 4419 W. 171st Street., Wynona Wolcott, 22, 2831 - 131st St., Toledo, Ohio, also 4419 W. 171st Street., Gladys Sawyer, 38, Dayton Bluff Sta., St. Paul, Minn., also 4419 W. 171st St. 9-5-34 (Mildred Wilcox)

Received call from Hotel Cleveland requesting that three intoxicated women who had a child with them be removed from their Grill Room.

At Hotel. Interviewed manager, who reported that women had paid their bill but had done considerable damage in the Grill Room and were in such an intoxicated condition that the management did not feel women should have child with them.

At Hotel. Attempted to question women who were too intoxicated to answer coherently; women became abusive and attempted to get away. Called for assistance. With officer in district and two traffic men brought women to Central Station for investigation. Detective Bureau notified.

9-6-34 ( C. Heidinger)
Questioned all three women, who told conflicting stories as to why they
came downtown. Wynone said that they were shopping in the verious stores
downtown for a hat for herself. Mrs. Sawyer said that she had purchased
a suit at Halle Bros., and Mrs. Matterson drove her downtown to get the
suit. Mrs. Matterson said they drove downtown to get a dress for Mrs.
Sawyer's little girl. They all agreed that they stopped at the Hotel

Cleveland for high balls before shopping.

Interviewed Wynona Walcott who said that she has been separated from her husband for the past two months and about a week ago came to Cleveland. She went to the home of Ethel Matterson and has been staying with her. Wynona said that it was she that had the knife and that she threw it when she heard the officers coming. She also stated that she met Ethel in Toledo about six months ago.

Questioned Gladys who said that she had been in Cleveland for about a month and that she came here from St. Paul, Minn. She knew nothing about the knife or how it was thrown away. She said that after mixing her drinks she became so intoxicated that she did not know what she was doing. She said that she was staying with Ethel and that she met Ethel in St. Paul in 1929 and they have kept up a correspondence since then.

Interviewed Ethel Matterson who said she met Wynone Walcott and Gladys Sawyer downtown and went into the Cleveland Hotel where she bought them some drinks. Questioned as to whether the other two momen were staying with her, she was emphatic in her denial. Alson questioned Ethel where she had met Wynone and Gladys and she said she met them in a gambling place in Cleveland just recently. She denied that she had ever been in St. Paul and though she said she had been in Toledo several times, she did not meet Wynone there. Questioned her about the knife and she denied that she saw it and said that she never owned one.

Again questioned Wynona about the knife and told her that Ethel denied giving it to her and then she said she fished it out of a five cent machine. When told that Ethel said she did not stay with her Wynona said she only arrived in Cleveland yesterday and went to Ethel's home.

All three women changed their stories considerably and seemed to be covering up each other. At the Detention Home interviewed Francine Sawyer, age 5 years. Child said that she has been staying with her mother at the home of a lady named Paula. Brought child to Central Station where she identified Ethel Matterson as Paula.

At Juvenile Court re: above case but Miss Lucht felt there was not sufficient evidence to file on the mother, and also said as long as the child is not a resident of Cleveland, the entire case should be heard in police court.

9-7-34 (C. Heidinger)
Again at Juvenile Court, Miss Lucht filed on Francine as a dependent.
No action taken against child's mother.

Received telegram from Children's Bureau in Minnesota, requesting that we refer the case to Children's Bureau in Cleveland.

Contacted C. B. (Miss Sawhill) who said that inasmuch as W. B. had filed on girl they will not come into case unless requested by Juvenile Ct. to do so. At Juvenile Ct. and talked to Judge Eastman, who felt that it would not be nevessary for C. B. to come into case.

9-8-34 (C. Heidinger)

Received second communication from Minn. stating that Francine's correct name is Faughnan, and giving the child's parents' names. Called Juvenile Ct. and gave them that information. Mr. Wachtell of Juvenile Ct. requested that I make out a new affidavit, giving the child's correct name, etc.

9-10-34 (C. Heidinger)
At Juvenile Ct. filed new affidavit. No date for the hearing set, as child is to be returned to Minnesota Children's Bureau, directly who will accept the responsibility for her. Conferred with Inspector Cody of the Detective Bureau re the disposition of the cases of the three women. Learned that S. P. warrants had been issued against the women and bond set at \$5,000.

Inspector Peters of the Dept. of Justice called and said that they are interested in this case, as one of the women was from St. Paul, it was presumed that she might be one of the Dillinger gang. Also learned that the photo of man believed to be Mr. Matterson, was positively identified as one of the Bremer kidnapers of St. Paul and known on the police records as Fred Barker. He is also wanted for the killing of the Sheriff at Lima, Ohio.

The S. P. charge in P. C. was nolled and the women turned over to the Federal Agents, who will continue on the case.

9-26-34 (C. Pictrowski)

Ethel Marsh, alias Matterson was brought to City Hospital after being treated at Lakeside Hospital, into which place she walked. Detectives wanted her for further questioning, so transferred her to city hospital and at city hospital refused to accept her, assisted in transferring her to county jail, Probate Ward, and detectives were to file on her in Probate Court.

9-27-34 (C. Piotrowski)
Ethel filed on in Probate Court and sent to city hospital for observation.
9-27-34 (C.L.H.O.)

Received call from Mrs. Gaehr of the YMCA that a woman by name of Ethel Charmon was at YMCA and acting in peculiar manner.

Called at the YWCA and interviewed the woman who was Ethel Matterson. She said that she returned from Chicago this morning to get her clothing and furniture that she has in her apartment on W. 171st Street. Mr. Peters, Federal Agent has her keys. Mrs. Gaehr of the YWCA called Mr. Peters (before calling W.B.) and while I was there he returned the call and said that he would follow on the case.

No further action as Federal Agents are handling the case.

9-28-34 (E. Harwood)
Learned that Ethel was taken to Women's Hospital and then transferred to
Lakeside. Later police were called and Ethel was transferred to county
jail. Charge - Insanity.

On 9-30-34 she was probated by Detective Bureau and sent to City Hospital 10-2-34 (E. Harwood) with Inspector Cody, Went to City Hospital/and questioned Ethel, whose real name is Paula Harmon, and she comes from Texas.

She was married at the age of 17 to Harry woods whom she divorced. Later she married a man named Hiermon who was shot and killed in a stickup. She then drifted to Minnescta, where she became acquainted with Fred Berker, alias Doc, alias Henry Matterson, a notorious criminal. They came to Cleveland, Ohio, where they established a home.

Regardless of our constant questioning regarding their activities since their arrival in Cleveland, Paula refused to give us any information. She did state, however, that Harry Barker, Fred's brother, Harry Campbell, and Alvin Karpis, all criminals from other states, but whom, as far as we know, have not committed any depradations in Cleveland, were frequent visitors in her home here.

10-5-34 (E. Harwood) At City Hospital but Paula would give no additional information, stating that she could not remember.

10-8-34 (E. Harwood)
With Captain Story and Inspector Cody at City Hospital to question Paula.
She stated that she had nothing to say as she felt that she would be in trouble regardless of what she said or did. When we left, Inspector Cody said that it was useless to go back again as he felt Paula would not tell us anything.

11-12-34 (E. Harwood)
Called City Hospital and learned that Paula was released by Promte Court
to her attorney.

This report is being retained in the files of the Cleveland Bureau office.

It will be noted that Ruth Ross was also admitted at 7:25 P. II. on September 5, 1934, on a charge of intoxication, and later released. No address appears for Ruth Ross, and inasmuch as Mr. Ress had previously advised Agent that he had heard a rumor that one of the women had given a prostitute a diamond bracelet upon her release, Mr. Ness will again be contacted in order to secure the address of Ruth Ross and the names and addresses of all women who were in jail prior to 5:15 P. M. on September 5, 1934.

Deputy Inspector Frank/Story, Cleveland, Ohio Police Department, in charge of the third and fifth precincts, with headquarters at the fifth precinct station, corner of 79th Street and Woodland Avenues, stated that about 5:30 o'clock on the evening of September 5. 1934, as he was about to leave the central police station in company with Inspector Cody, a man from Florian Avenue, this city, came in, said he was a private detective having something to do with The May Company, and that he suspected certain occupants of a west side residence of being members of the Dillinger garg. This man was sent to George Koestle. Superintendent of Identification, to look at photographs of known members of this gang, and other gangsters. Inspector Story related that a little later the Cleveland Hotel called police headquarters and reported that three women were creating a disturbance at said hotel and that a policewoman and.some traffic officers brought these women to headquarters. It leter developed that these women were Gladys Sawyer, Wynona Burdette, and Paula Harmon.

It is noted that the May Company detective is Archie S. Allen, 10515 Parkhurst Avenue, who was interviewed by Agents, as set forth in report of Special Agent C. E. Smith, dated at Cleveland, Ohio, December 20, 1935.

Agents questioned the Inspector relative to the tip off that
these women were in custody and he related that he had learned that
Detective Joe Jacobs, now deceased, had called some one at the Harvard
Club on the telephone and advised that these women were in jail, but he
did not know to whom Jacobs talked at the Harvard Club. He stated that
as he recollected, one of these women mentioned something about knowing
someone at the Harvard Club; that her husband worked there, or had a
slip of paper in her possession with the name of the Harvard Club written
thereon. At this point the inspector was asked relative to the piece of
jewelry that is alleged to have passed from one of these women to an
officer and he stated that he had heard the rumor that a diamond bracelet
was given by one of these women to semeone, but he has been unable to run
down the rumos and knows nothing definite about it.

The following morning Attorney Edward Stanton, former county presecutor, appeared at the jail and advised that he represented these women, but refused to state who employed him, or how he learned the women were in jail.

Inspector Story stated that he has since learned that the day following the arrest of these women a telephone call came to police headquarters for a certain police officer, who was requested to meet a contact man at Franklin Circle (West 14th and Stark Ave.), which meeting was had and at which time and place this officer was advised of the identities of the women and their associates, at which time the officer was warned to lay off that they were bad paper. The Inspector said he feels sure he knows the identity of this police officer, but does not know the identity of the person who called, but that the call came from the Harvard Club. Agents requested the name of this police officer, but Inspector Story said he would rather not divulge the name at the present time, saying he would contact this officer and endeavor to get him to tell his story to Agents, or come in and lay his cards on the table, as the Inspector put it. Agents will again contact the Inspector after he has had time to contact this other officer.

Reference is made to Bureau letter dated July 1, 1936, file #7-576, wherein it calls attention to the report of Special Agent R. J. Abbaticchio, Jr., dated at Omeha, Nebraska, June 24, 1936, which reflects on page six, that Gladys Sawyer states she was visited by an attorney whose name she believes to have been Scott, who is likewise believed to be a former city prosecutor in Cleveland. Ohio, with offices on the sixth floor of the Terminal Tower.

It will be here noted that Edward Stanton, former county prosecutor with offices at 606 Terminal Tower Building, did, according to Deputy Inspector Frank Story, contact Gladys Sawyer at the city jail, for the purpose of representing her, however. Inspector Story, whose interview iw set forth in more detail in the report, stated he had no knowledge as to who retained Stanton for the women. Gladys Sayer is undoubtedly referring to Stanton, rather than Scott. Agent was unable to locate any attorney by the name of Scott, who has offices on the sixth floor of the Terminal Tower Building.

Charles J. McNamee, First Assistant Prosecuting Attorney,
Cuyahoga County, Cleveland, Ohio, was interviewed at his office relative
to an item in the Cleveland Plain Dealer of July 16, 1936, to the effect that "Alvin Karpis may have been behind one of the machine guns
that menaced county prosecutors on January 10, 1936, when they raided
Shimmy Patton's Harvard Club," and he stated that this article was
based upon rumors and he did not know the origin of the rumor. He said
he had no information that the Karpis mob was there at the time but he heard they
had been at this place on various occasions.

He stated that on the evening of the day of the raid he, in company with about ten private detectives, attempted to raid the Harvard Club, to stop gambling, but were met at the door by Shimmy Patton, manager of the club, who refused them admission, and as about twenty-five hoodlums gathered around to assist Patton, nothing of a raiding nature was done until reinforcements arrived from the Cleveland Police Department. He said he saw no guns of any kind displayed by either side; that only one of his men was armed and he with a pistol which was not drawn.

He related that while awaiting reinforcements, the gembling equipment of the Harvard Club was removed and when admission was finally gained, no gambling was in evidence. Mr. McNamee further stated he had represented Shimmy Patton in legal matters before becoming assistant prosecutor, and considers Patton to be a very tough guy, although a man of his word, therefore, when Patton told him if he went in the club with these officers, "he might get hurt" he did not go in. Later Patton asked

McNamee if he had any "papers" and when McNamee answered, "No," Patton volunteered to take him in alone to see the club. McNamee said he went in with Patton and was amazed at the size of the place, its equipment and the crowd present; about two thousand people.

Mr. McNamee said he was told by a person who ought to know and in whom he has great faith, that Karpis and his gang had frequented this place. He declined to give the name of this person, but agreed to again contact him relative to this matter and learn what he could as to the Karpis gang being at the Harvard Club and will later convey what information he gathers to Agents.

Mr. McNamee will be again contacted in regard to this matter.

A check of the city directory discloses that Olive Barwing is listed as a bookkeeper for the Bonne Bell, Inc., rairview Village, Ohio. The city directory also reflects the Bonne Bell, Inc. to be a cosmetic concern located at 13616 Detroit Avenue, its president being Jesse G. Bell, 19715 Rocky River, Ohio.

The directory lists Frank W. Smith's address as 3543 Silsby Road, which corresponds with the address appearing in the articles of incorporation. Mr. Smith's occupation is given as Deputy County Treasurer, New Court House, Cuyahoga County.

The following investigation was conducted by Special Agent J. B. Fitzgerald:

Mr. George Niggle, 3847 Silsby Road, Lakewood, Cleveland, Ohio, stated that he is and has been for the past fifteen years a merchant policeman in the 17th precinct of Cleveland and is a next door neighbor of Frank W. Smith, who resides at 3843 Silsby Road. He stated that Smith and his family moved into this address about two years ago and are apparently nice people, but he is not well acquainted with Smith because of the fact that he works all night and sleeps most of the day. He stated that Mr. Smith is a county employee of some kind and he believes that Smith works out of the Treasurer's office; that Smith goes to work about nine o'clock in the morning, is home for lunch, home for dinner, and usually home several times during the day, which leads Mr. Niggle to believe that Smith does some kind of outside work for Cuyahoga County, perhaps in regard to real estate valuations. Mr. Niggle also has the impression that Smith is in some kind of real estate business for himself.

Lir. D. C. Reindon, superintendent of mails, West Park Station, Cleveland, Ohio, stated that Frank W. Smith resides at 3843 Silsby Road, but he knows nothing about him except that he receives much mail from a company known as the Service Lubricants Company, which leads the superintendent to believe that Smith might have something to do with the sale of lubricants.

Lieutenant J. Gideon, 17th precinct station, Cleveland police department, discreetly was questioned relative to Frank W. Smith, who lives about one-half block from said station. He stated he had never heard of Smith and knows nothing about him.

continuing stated that the Cleveland Press, a local newspaper, carried an article on February 7, 1930, which stated that Art Hebebrand had pleaded guilty to a charge of manslaughter arising out of an automobile accident, however, prior to receiving sentence, Hebebrand was permitted to withdraw his plea of guilty, by Judge Frederick P. Walther, Court of Cormon Pleas, and Hebebrand was later discharged by the jury.

Clayton Hall called at the Cleveland Bureau office and was questioned by the writer relative to any information he might have regarding the 1933 Ford coupe, probably purchased by Campbell using the name Charles Miller, from the Pollock Davis Ford Company at Cleveland, Ohio, on February 4, 1935, and he stated that it was his impression that a car of that description had been turned in to the Manning-Marino Company at Youngstown on trade for a new Terraplane coupe. Hall was unable to give any further information relative to this automobile.

Hall was questioned generally about his associations with Karpis and Hunter and he related that on one occasion, while he and Karpis were driving around, the conversation turned to the scars on Karpis' face, and Karpis stated that no one had to worry about the guy who did the job as he was dead. Hall was questioned very closely relative to anything Karpis may have said about where or how the body was disposed of, or who killed the man who caused the scars, however, Hall advised he had gone no further into the subject, as Karpis had let it drop.

\*\*\*\*\*\*

Detective Norman Kandell of the Canton, Ohio Police
Department, advised that Eddie Seaman and Jake Cilmore may possibly
be in contact with "Slim Martin in Toledo, Ohio, if so they will
be in close contact with George Green, paramour of Mabel Green. In
view of the close contact supposedly existing between Joe Rich,
Seaman and Gilmore, an endeavor will be made to locate Seaman and
Gilmore for the purpose of questioning them relative to Joe Rich's
activities. Both men are also wanted by the Canton, Ohio Police Department for grand larceny.

## AT AKRON, OHIO

Ed Ley, Identification Officer, Akron, Ohio Police Department, was interviewed relative to the presence in the city of one Dolly Rogers, a prostitute, who was said to have been an inmate of the

house of prostitution operated by Edna Haney, during part of the period of time under investigation. He searched his records under the name, and also under the fingerprint classification of Dolly Rogers, but stated he had no record of her. He then made inquiry of other detectives of the vice squad concerning this girl, but none of them knew of her.

Agents also contacted Special Agent R. C. Connell, who has made some investigation relative to vice conditions in Akron, relative to this girl, but her name had not come to his attention. He was requested to keep this girl in mind and attempt to locate her while going about his usual work in Akron.

Officer Ley stated that he had no record or knowledge of the number of houses of ill fame, or prostitutes in Akron, Ohio, and could suggest no way to locate a certain prostitute if known to be practicing her profession in that city. Agent Connell at Akron, Ohio, will be again contacted in regard to this girl.

### UNDEVELOPED LEADS

The CLEVELAND OFFICE at Cleveland, Ohio, will reinterview Mr. Eliot Ness, Director of Public Safety and secure from him the names and addresses of all women in jail on September 5, 1934, prior to 6:15 P. M., at which time Gladys Sawyer, Wynona Burdette, and Paula Harmon were inparcerated.

Will, when deemed advisable, interview the various matrons on duty during the time Sawyer, Burdette and Harmon were in jail at Cleveland, Ohio.

Will continue its investigation into the identity and associates of Olive Ewing, Fairview Village, and Frank Smith, 3843 Silsby Road.

Will, when deemed advisable, interview Edward Stanton, attorney, 606 Terminal Tower Building, for the purpose of ascertaining who retained him to represent Sawyer, Burdette, and Harmon.

Will contact such of the persons incarcemted in the Cleveland City Jail between September 5, 1934 and September 7, 1934, as is deemed advisable relative to the tip off of the presence of the Sawyer, Burdette and Harmon women in that jail and in regard to the rumored gift of a diamond brooch or bracelet to some person by one of the women.

Will obtain the facts relative to a manslaughter charge alleged to have been filed against Art Hebebrand in Cleveland, Ohio, in February, 1930.

at the County Courts Building for the purpose of escertaining the identity of the individual who made the statement that Karpis was at the Hervard Club on January 10, 1936, the day it was raided, and also secure any additional information he may have secured relative to Karpis presence at the Harvard Club.

At the Fifth Precinct Police Station, 79th and Woodland Avenues, will again contact Inspector Frank Story, for the purpose of securing the name of the Officer who met a representative of the Harvard Club at Franklin Circle on September 6, 1934.

At Toledo, Ohio, will endeavor to locate George Green, paramour of Mabel Green, madam of a house of prostitution, and through him locate Eddie Seamen and Jake Gilmore and question them relative to Joe Rich's activities and associates.

Dear Sir:

Confidential Informant Clayton Hall, who is now employed by the Holland Furnace Company at Youngstown, Ohio, called at this office on ody-Saturday, July 18, 1936, for the alleged purpose of advising this office that in the event that it was necessary to communicate with him in the future, he could be reached by placing a telephone call to the office of the said Furnace Company, or by addressing a letter to him in care of General Delivery, Youngstown, Ohio.

During the course of the conversation with Informant Hall, he indicated that it was his desire to secure possession of a Ford car which is the property of Fred Hunter and is stored in/Marino's Garage at Youngstown, Ohio. He requested that a letter be written to the said Garage Company, directing the said Company to turn the said car over to him. Mr. Hall was informed that such action, of course, could not be taken and then he made inquiry as to the possibility of his initiating some sort of a legal action to secure title to the said car, he, Hall, explaining that he did at one time have the title papers to the said car in his possession, but that he has long since destroyed them by burning them in a fire. Mr. Hall was advised that this office could give him no assistance in the matter of advising him as to what, if any, legal action he could take to secure custody of the said car, it being mentioned to him that Fred Hunter would have to authorize the delivery of the car to whomever he, Hunter, desired to have the same, as the car apparently is the property of Fred Hunter.

RECORDED & INDEXED According to Clayton Hall, about six weeks ago Post Office Inspectors Sylvester Hettrick and J.T. Cordrey came to see him and endeavored to have him, Hall, accompany the said Post Office Inspectors. to Washington, D.C., for the purpose of making a statement concerning the agreement he, Hall, entered into with Bureau representatives and Post Office Inspectors. Mr. Hall stated that he told the Post Office Inspectors that it was his understanding when he was interviewed by Special Agent in Charge Connelley and Post Office-Inspectors at Youngstown, Ohio, that any information which he, Hall, furnished was to be for the joint use of both services. He stated that the Post Office Inspectors apparently were interviewing him with the objective of endeavoring to secure credit for the apprehension of Karpis and 'Campbell. While Hall would not say so positively, he intimated that the said Post Office Inspectors felt that they were double crossed by

S.A.C. Connelley in connection with the handling of the Brekid investigation. It was Clayton Hall's belief that the said Post Office Inspectors were endeavoring to secure information with the objective of embarrassing S.A.C. Connelley.

Hall further stated that the said Post Office Inspectors made inquiry as to why he, Hall, could not be reached when he, Hall, was in Hot Springs and Little Rock, Arkansas. Hall stated that he told the Inspectors the entire truth, that is, that he was not hid away and that he did not receive instructions from any Bureau representative not to cooperate with the Post Office Inspectors. He stated that he did not tell the Post Office Inspectors that he was in New Orleans and related that he advised the Inspectors, just as he was advising the writer, that he did not want to become involved in any fight that might occur between the Bureau and the Post Office Inspection Service.

He stated that he would not talk or make a statement to anyone in regard to the matter of his conference with the Post Office Inspectors other than S.A.C. Connelley or Special Agents Madala and McNulty, with whom he was in close contact during the period immediately preceding the apprehension of Subjects Campbell and Karpis. He stated that if Mr. Connelley interviewed him, he would furnish Mr. Connelley with all information, but that if Mr. Hoover or anybody else wanted to get information concerning the statement he made to the Post Office Inspectors, he would refuse to give such a statement.

To the writer's inquiry as to whom in Washington he was to make the statement, Informant Hall related that he could not recall and suggested that the writer name some people in Washington, that he might be able to recognize the name. Accordingly the writer mentioned the names of Aldrich, Moran, Anslinger, and he, Hall, stated that he thought the name of Moran was familiar. The writer, however, is inclined to believe that Hall's intimation that Moran was the person, whoever Moran might be, that he was to make the statement to, is merely a guess on his part.

Clayton Hall advised the writer that Bureau representatives had talked to him first and that on the following day the Post Office Inspection Service placed him under arrest. He stated to the writer that he would not have talked to the Post Office Inspectors in that he knew that the Post Office Inspectors had nothing on him and that the only thing he feared was a possible prosecution by the Bureau of him on harboring charges.

Hall stated that the last time that he saw any Government representative was about six weeks ago, on the occasion when Inspectors Hettrick and Cordrey called on him to secure a statement from him concerning the promises that were made to him, Hall, to induce him, Hall, to act as informant to effect the apprehension of Karpis and Campbell.

Hall stated that he was fairly treated by the Bureau and indicated that he has very high regard for S.A.C. Connelley. He stated that for some unknown reason he was placed on the black list at the steel mill in Youngstown and he has been unable to ascertain who was responsible for having him black listed. Hall stated that the only money he received from the Post Office Inspectors was \$25.00 or \$30.00 on the night that he left for Hot Springs, accompanied by Bureau Agents.

It seemed as though the primary objective being sought by Informant Hall in calling at this office was to secure the Bureau's aid in the matter of acquiring title to the automobile of Fred Hunter which is now in Marino's Garage at Youngstown.

I have noted considerable activity by the Agents on the special acust working at Toledo on regular investigative work of the Cleveland office.

I confe red with Acting Special Agent in Charge Ross as to there agents helping him out on one particular extortion case which I agreed could be done without interfering with the investigation at Tolodo as to the harboring cases. In the future it is requested that the agents assigned to the special squad be allowed to continue on their activities unless some unusual emergancy should arise, and if possible then it is desired that you communicate with me before assigning these agents to any work other than the harboring cases.

I thought I would fall out of the chair laughing. I often wonder what is inside her head. I sure hope the weather changes here in the next few days. How would you like to be out at Long Beach tonight? I certainly would enjoy a swim this evening. I am not going to write a long letter this time but will try to find more to write about this coming Sat. you know I write to you every Sat. But as I said I delayed writing this one. In compliance with Bureau letter of July 1, 1936 in the above entitled matter in which the Bureau requested that various specimens in handwriting and handprinting be secured from Jess Doyle at the Nebraska State Penitentiary, Special Agent J. R. Green of this Office on July 14th interviewed Jess Doyle at the aforesaid institution at Lincoln, Nebraska.

Agent Green advises that JESS DOYLE absolutely refused to furnish any such specimens, informing this Agent that he had been caught napping before and didn't propose to let the Bureau catch him off guard again; that he (Doyle) couldn't see what good could come to him from it and took a very obstinate and defiant attitude; that he indicated he had a special grievance against some of the Bureau agents, but would not go into detail concerning same, and stated he was giving out no information to anyone, and that he had requested the prison officials not to bring him up for interview with law enforcement officers or agents no matter who they were with; that if he could see some special advantage to him he might be induced to furnish the requested handwriting specimens but would not do so at this time.

Frank Weigant, Deputy Warden, State Penitentiary, Lincoln, Nebraska had, prior to this Agent's interview with Doyle, informed Agent Green that Doyle was of a very obstinate and obstreperous type; that because of his infractions of the rules a glort time since had been placed in solitary for a period of three months; that various law enforcement officers from different states had come to the Penitentiary to interview Doyle in an effort to secure information relative to investigations they were making, but that Doyle had refused to furnish any of them with information of any kind, and on previous occasions had requested him (Weigant) not to call him up to the Warden's Office for interview when law

enforcement officers in the future desired to interview him; that he had informed Doyle that whenever law enforcement officials requested to confer with him he would be compelled to come to the Warden's Office for such interview. Deputy Weigant stated that it was not within his power to compel prisoners to furnish information to outside law enforcement agencies, but that as long as he was Deputy Warden, prisoners would be compelled to come to his office for requested interviews of this nature.

Mr. Weigant further informed Agent Green that Jess Doyle frequently corresponded with persons on the outside, all of which mail went through their office, which was in charge of a civilian clerk, and that within the next three weeks they would furnish the Omaha Bureau Office with certain letters written by Doyle which they did not care to reach the party to whom addressed.

In accordance with the above arrangement Deputy Warden Weigant mailed to this office a letter written by Jess Doyle, their Number 12369, under date of July 16, 1936, addressed to Miss Viola Shea, Station D., Cudahy, Wisconsin, care of Ers. D. Welbes, consisting of two pages, and same is being enclosed to the Bureau. When similar letters are received in the future they will be forwarded to the Bureau.

Dear Mr. Carville:

I wish to acknowledge receipt of your letter dated July 24, 1936, to which was attached an editorial entitled "Reno Figures Again", which appeared in The Review Journal, Las Vegas, Nevada, on July 20, 1956.

My attention has previously been directed to the splendid cooperation which you extended to epresentatives of this Burrau, and I was particularly pleased to receive your communication of the 24th again expressing your willingness to be of assistance in matters of mutual interest.

On the basis of information previously obtained, an investigation was conducted in Reno, Nevada and vicinity to determine whether any of the Hama ransom money was exchanged through the underworld element at that point, The information disclosed was not of such a nature as would permit of prosecution in Nevada. Investigations in several of the major cases being handled by this Bureau have disclosed that numerous persons whose whereabouts have been sought took up residence in Feno. There has been no showing, however, that any process of arrest was outstanding in Federal Court for those persons implicated in the Hama and Bremer abductions at the time of their residence in Heno. I am confident that you have been fully advised of all matters pertaining to the prosecution of those persons in Reno, Nevada who were in any way involved in the John Paul Chase and Lester Joseph Gillis matters.

Special Agent J. T. McLaughlin has been the Bureau's Resilent Agent in Reno, Nevada for a considerable time. He has been instructed to cooperate closely with your office and to make full disclosures to you of those matters which are of mutual interest. Please be assured that the results of investigations in which you have an interest will be brought to your attention by Mr. McLaughlin.

Again permit me to thank you for the interest which prompted you in directing to me your letter of July 24, 1936.

Wynona Burdette advises that photograph of Charles K. Bowman with aliases is not a photograph of the individual she knew as "Dutch" at whose place Campbell stopped near Joplin, Mo.

DETAILS:

With reference to Clevelard letter to the Detroit Office dated 5/19/36 in which they givise that the Cleveland Office

had received a letter dated May 12, 1936 from the Bureau (7-576) advising that the following telegram was received by the Bureau from Lloyd Kennedy mailed at the Air Port, Cleveland, Ohio, May 2, 1936:

"Suggest you contact Dr. Schwab and Cobb on Karpis. Schwab at Boston Psychopathic has new surgical technique on brain photography. Cobb at Massachusetts General now repeating Pavlov and needs humans instead of dogs for a change."

Investigation at the Air Port by the Cleveland Office disclosed that the Pennsylvania Air Lines on May 2, 1936 had a reservation made at Detroit, Michigan for a passenger named Kennedy from Detroit, Michigan to New York via Cleveland, however, this reservation was cancelled and passenger Kennedy did not make the trip. The Pennsylvania Air Lines advised that passenger, Kennedy may have made the trip from Detroit to Cleveland on May 2, 1936 and if such was the case, his address would be on the records of the Pennsylvania Air Lines in the Detroit Office and had he arrived about noon on May 2, 1936 in Cleveland, he would have been a passenger on Pennsylvania Air Lines Trip #8.

The writer contacted W. C. Wilson, Ticket Agent,
Pennsylvania Air Lines, Detroit, who ascertained from the records
of the Pennsylvania Air Lines that one L. W. Kennedy who gave his
address as Erie Trust Building, Erie, Pennsylvania, left Detroit,
Michigan on Pennsylvania Air Lines Trip #8 enroute to Cleveland,
Ohio leaving Detroit 11:10 A.M. on May 2, 1936 and arriving at
Cleveland, Ohio, shortly after 12 noon, same day - Kennedy traveling
on return portion of a ticket issued at some point beyond Cleveland,
Ohio - ticket used being form 24, No. 1631.

Mr. Wilson stated from the records, he could determine the place at which the ticket was issued or the ultimate destination of Kennedy. He stated the stub of the ticket taken up by the Pennsylvania Air Lines for the passage of Kennedy from Detroit to Cleveland would be on file at the Auditor's Office, Pennsylvania Air Lines, Pittsburgh, Pennsylvania.

He stated the records showed Kennedy's personal weight as 170 lbs. and Kennedy carried two pieces of luggage weighing a total of 33 lbs. He stated Kennedy gave as his local address "Lenox 9000 - Apartment 369". From a cross index of telephone

numbers on file at the Detroit Office of the City of Detroit it was ascertained that Lenox 9000 is the telephone number of the Whittier Apartments, 415 Burns Drive, Detroit. Lenox 9000 is also listed to 10 other individuals, however, none are under the name of Kennedy. These individuals are evidently tenants of the Whittier Apartments which is one of the largest apartment buildings in Detroit.

Agent contacted R. Andrew, Room Clerk, Whittier Apartments, Detroit, who made an examination of the guest record and advised that no one by the name of Lloyd W. Kennedy had rented an apartment but apartment No. 369 was occupied by a Mr. Hamilton and family.

Efforts to locate Mr. Hamilton or any of his family at the time of Agent's visit at the Whittier Apartments were unsuccessful, however, subsequently Agent telephonically contacted the occupants of Apartment 369 and was advised that Lloyd W. Kennedy had visited there around the 1st of May, 1936 but they did not know Kennedy's exact present whereabouts but thought Kennedy could be located either in Belding, Michigan or Erie, Pennsylvania.

W. S. Wilson, Assistant Postmaster, Belding, Michigan advised that Lloyd W. Kennedy was a transient in Belding, Michigan but was employed by the Metal Glass Products Company, Belding, Michigan as a stock salesman promoter.

At the Metal Glass Products Company, Belding, Michigan, Agent was only able to contact the foreman of the factory who called the Office Manager, a Mr. Calvin, who talked to Agent advising that L. W. Kennedy was enroute to Erie, Pennsylvania via Cleveland, Ohio and would arrive at Erie, Pennsylvania on July 14, 1936.

Mr. Calvin was unable to give Kennedy's address in Erie, Pennsylvania but called Mrs. Lloyd W. Kennedy on the telephone who advised that her husband, Lloyd W. Kennedy's address in Erie, Pennsylvania would be 1313 Erie Trust Building or 429 Shimley Street and that her husband would be in Erie, Pennsylvania for from 1 to 3 days. She did not know when he would return to Belding, Michigan.

Agent's identity or the reason for desiring to contact Kennedy was not discharacted to Mr. Calvin, the foremen of the Metal Glass Products or Mrs. Kennedy.

A teletype was sent to the Pittsburgh Office on July 14, 1936 requesting Pittsburgh Office to locate and interview Lloyd Mennedy, upon Kennedy's arrival in Erie, Fennsylvania.

With reference to Cleveland's letter to Detroit dated
June 4, 1936 in regards to Ford coupe, 1933 Model and otor
#18-429014, 1935 Ohio license HM-54 issued to Charlestillen,
6604 Pearl Road, Cleveland, Ohio, said car purchased on February 4,
1935 from Pollock-Davis Motor Car Company, 11628 Euclid Avenue,
Cleveland, now out of business - it having been ascertained by the
Cleveland Office that Harry Campbell using the alias, Charles Miller,
had in his possession above automobile some time during the year
1935; this Agent contacted R. D. Pollock, owner and operator of a
Mobile Service Station located about two miles North of Algonac,
Michigan.

Mr. Pollock stated he had operated a Ford automobile agency in Cleveland, Ohio for about 25 years, the firm being known as Pollard. Davis Motor Car Company but that Davis had not been connected with the firm for over ten years. He stated his brother, D.M. Pollock and himself had operated the firm since. He stated the Ford Motor Company cancelled their contract about June, 1935 and as a result they had been forced out of business and during the course of liquidation of assets which had taken about two months, all of the records of the firm had been lost — evidently, taken away by some purchaser of fixtures. He stated he had no idea which purchaser might have taken their records, however, it is possible his brother, D. M. Pollock, might know.

He stated his brother when last heard from, had been living with his father-in-law whose last name is Wardell and who lives at Wardell's summer home located on Lake Shore Boulevard and who also has a home located on 115th Street, Cleveland, Ohio.

He stated he does not recall anyone by the name of Charles Miller or the sale of instant auto to anyone and upon being shown the photographs of Harry Campbell, Alvin Karpis, Fred Hunter, Doc and Fred Barber and other subjects of this case, Pollock failed to identify them as anyone he knew or had seen.

Pollock stated Walter Stickel, Route 3, Madison, Ohio and who is presently employed at the Stanton Motors, Painesville, Ohio had been in charge of the Used Car Department of the Pollock-Davis Motor Car Company in Cleveland and that Stickel might recall the sale of the Ford coupe, Motor #18-429014 to Charles Miller, Cleveland, Ohio on February 4, 1935 and that Stickel might also have a record of the deal in a personal book which Stickel kept. Pollock also stated that Stickel's nephew whose name he doesn't remember, might recall the instant sale of Ford coupe.

In connection with the mimeographed letter to all Field

Offices from Cleveland, Ohio dated 6/17/36, a letter has been written to the Secretary of State, Lansing, Michigan, requesting a flash card be filed against 1933 Standard Ford Coupe, Motor #18-429014 and that if this car is registered in the State of Michigan, the Detroit Bureau Office be advised.

With reference to a teletype from the Indianapolis Office to Detroit Office dated 7/12/36 requesting that Leila Armstrong be interviewed at Frankfort, Michigan where she was visiting at the home of Mrs. O. A. Rogers for a few days, the purpose being to secure information as to the present whereabouts of her brother Walter R. Armstrong, alias Dr. Ormiston, in accordance with the above request, Leila Armstrong was interviewed on July 13, 1936 at Frankfort, Michigan. She stated she had not seen or heard from her brother for the last three years; that Walter Armstrong was the black sheep of her family, having been arrested several times and having served a sentence in the Michigan State Penitentiary at Jackson, Michigan on a charge of forgery, being originally arrested in Lansing, Michigan in the year 1928 and paroled in the year 1932 or 1933.

She stated at the time of Walter Armstrong's arrest in Lansing, Michigan, Armstrong had forged a doctor's signature to a check and stated she could not recall the name of the doctor. She stated that on a number of other occasions her brother had posed as a doctor. She stated that about 8 years ago her brother had been a patient at the Veterans' Hospital in Kinneapolis, Minn. being treated for the drug habit and at that time she had visited her brother at the Veterans' Hospital.

She stated her brother was involved in some kind of an automobile accident at that time and was employed by a finance company and as she remembers, it was either the Associated Investment Company or Merchants Credit Company and that Armstrong embezzled a considerable sum of money from this company and she and her brother, Ralph Armstrong (now deceased), had made good with the investment company.

She stated her youngest brother, Paul Armstrong, who resided at 2840 Ewald Circle, Detroit, and who was Assistant Superintendent of the Lincoln Park High School, Lincoln Park, Nich. might be able to advise the present whereabouts of her brother Walter Armstrong.

She stated her brother's full name is Walter Raymond


Armstrong. Upon being shown the photograph of Dr. Joseph P. Moran, subject in this case, she stated it was not her brother.

Miss Armstrong furnished considerably more information in regards to her brother, Walter Armstrong, which is being omitted from this report as report of Special Agent, J. L. Fallon, Philadelphia, Pa. dated 7/11/36, shows that Walter Armstrong had been located and interviewed - Walter Armstrong admitting he used the name of Dr. Robert Carville Crmiston and that it has been definitely established Armstrong is not identical with Dr. Joseph P. Moran.

Lieutenant William Cleeves, Police Department, Lansing, Michigan, arresting officer of Walter R. Armstrong on 8/7/28 at Lansing, Michigan, stated he was unable to recall Armstrong, however, he located in the records of the Identification Bureau of the Lansing Police Department the criminal record of Armstrong. The following information is being taken from copy of a letter addressed "PD Milwaukee, Wisconsin" dated 10/11/35 from Bureau of Criminal Identification, Lansing, Michigan, being their file #44353 and is oted as follows:

The following description was taken from the fingerprint card on file with the Police Department, Lansing, Michigan:



Lieutenant William Cleeves 1 aned Agent a photograph of Walter R. Armstrong, being Michigan State Penitentiary #23858 with the request that this photograph be returned to the Lansing Police Department as soon as it has served its purpose. The photograph is being returned to the Lansing PD as requested by Lieutenant Cleeves.

D. B. Parent, Assistant Parole Officer, Michigan State Perdon & Parole Board, 308 Transportation Building, Detroit, was contacted and allowed Agent to examine the parole records of Walter R. Armstrong. The information obtained is being omitted from this page.

Farent was unable to advise if the apprehension of Armstrong was still desired by them. Mr. Parent was telephonically advised as to the location of Armstrong as reflected by the report of J. L. Follan dated 7/11/36 so that in the event the State authorities desire to file a detainer against Armstrong, they could do so.

Paul Armstrong, brother of Walter R. Armstrong, was located at the Y.M.C.A., Highland Park, Michigan, where Paul Armstrong has charge of the young boys of the Y.M.C.A. during the summer vacation. However, the information obtained from Paul Armstrong in regards to his brother, Walter R. Armstrong, is now of no value and is being omitted from this report. It is mentioned however, that upon being shown photograph of Walter R. Armstrong, Michigan State Penitentiary #23858, Paul Armstrong immediately identified it as a photograph of his brother, Walter R. Armstrong.

With reference to Bureau letter to the Detroit Office dated June 9, 1936 (Bureau #7-576) in which the Bureau stated that before returning to Wynona Burdette the two small tapestries and one bath mat which are presently in the Detroit Office and having been obtained by Special Agents in the apartment formerly occupied by Wynona Burdette and Harry Campbell of Cleveland, Chio, the matter be referred to the United States Attorney having jurisdiction and be guided by his advice in the premises.

In accordance therewith Agent contacted Assistant United States Attorney, William G. Comb, Detroit, Michigan, who stated that the two small tapestries and bath mat referred to having been properly identified by Wynona Burdette as her property (and as the tapestries and bath mat had no value as evidence in this case) they should be returned to Wynona Burdette and appropriate receipt obtained, incorporating in the receipt a clause releasing the government from any liability in holding the property of Wynona Burdette.

On July 10, 1936 Agent returned to Wynona Burdette at the United States Detention Farm, Milan, Michigan, the two tapestries and bath mat referred to and obtained from Wynona Burdette an appropriate receipt in which a clause was incorporated releasing the government and Bureau Agents from any responsibilities in the holding of the tapestries and the bath mat. The receipt is being retained in the Detroit files.

With reference to report of Special Agent John B. Little,

Oklahoma City, Oklahoma dated 4/24/36 which set out a lead to the Detroit Office to interview Mynona Burdette at the U.S. Detention Farm, Milan, Michigan, exhibiting to her a photograph of Charles E. Bowman with aliases to determine whether or not Bowman is the party at whose place Wynona Burdette said Campbell stopped near Joplin, Missouri; a letter from the Chicago office dated May 1, 1936 requested this interview be not conducted until after Wynona Burdette had testified in the case against Duke Randall and Joseph Adems.

Superintendent John Ryan, U. S. Detention Farm, Milan, Michigan, advised the Detroit Office on 5/28/36 that Wynona Burdette had been subpoensed as a witness in the Southern District of Florida and was to leave on May 29, 1936. It appeared to the writer that she had testified against the individuals mentioned and when Agent returned to Wynona Burdette the two tapestries and bath mat mentioned previously in this report on 7/10/36, several photographs were shown to Wynona Burdette including one of Charles E. Bowman with aliases mentioned in John B. Little's report of April 24, 1936. Wynona Burdette was unable to identify any of the photographs as anyone she had seen or knew and when asked if she recalled anyone by the name of "Dutch", she stated she did - Dutch being the name of an individual at whose place Campbell had stopped near Joplin, Missouri. Winona Burdette's attention was called to the photograph of Charles E. Bowman and she stated the photograph did not resemble Dutch in the least.

Reference is made to a copy of a letter addressed to the Cincinnati Office from the Chicago Office dated 5/13/36, a copy of which was furnished the Detroit Office, in which it was suggested each field office review its file and advise the Chicago Office the number of stop notices still outstanding on auto believed to have been in the possession of subjects in this case. A thorough examination of the Detroit Bureau file by Special Agent W.B. Matney revealed that the Detroit Office has the following stop notices still outstanding in connection with instant case:

J. Connelley, Chicago Office, St. Paul, Cincinnati and Cleveland Offices, and therefore is being omitted from this report.

DETAILS:

On July 7th, 1936, Mr. K. R. McIntire of the Bureau at Washington, D.C., advised the writer he had been instructed by Mr. E. A. Tamm to inform the writer that Agent V. E. Criss, of the Chicago Office, was leaving Chicago at 6:25 P.M., via Chicago, North Western Railroad, in company with Informant Charles O. Long, and they would arrive in Omaha at 7:20 A.M. on July 8th, 1936; that at Omaha, Long would meet William Elmer Mead at the Fontenelle Hotel. Mr. McIntire further advised that in the event Mead was apprehended, all press releases would come from the Bureau in Washington, in accordance with the established rule governing such matters; further, that Mead was to be taken into custody quietly and without any unnecessary display of firearms, and that the Informant was to be arrested as well as Mead.

Shortly after the writer talked to Mr. McIntire, Special Agent A. H. Johnson, Chicago Bureau Office, telephoned the writer, advising that if possible arrangements should be made for the Informant to go to the Omaha Bureau Office, so the Agents who were going to shadow him could become acquainted with him. Agent Johnson further advised that the proposed meeting between Long and Mead was to take place at the Fontenelle Hotel, Cmeha, between 10:00 A.M. and 12:00 noon, on July 8th, 1936, where Mead was registered under the name of Dr. Niles; that in all probability the meeting would not take place at the Fontenelle, but Long would likely receive a telephone call instructing him to proceed to some other hotel at Cmaha for the actual meeting; therefore, it appeared necessary to have Agents continually keep Long under surveillance.

It was believed desirable to have Agents J. N. Franz and R. J. Abbaticchio, Jr., of the Omaha Bureau Office, board the train on which Agent Criss and Long were riding, and discreetly contact Agent Criss and render him any assistance possible, and it was thought that possibly Mead would meet the train at Omaha, or have an associate meet Long, so in order to properly cover the situation it was important that two Agents be able to identify Long so he could be easily shadowed. Accordingly, Special Agents Abbaticchio and Franz were driven to Denison, Iowa, by Special Agent Kenneth Logan, where the Agents spent the night. Agents Abbaticchio and Franz boarded the train at Denison, Iowa, at 4:50 A.M. Agent Criss had previously telegraphed from Clinton, Iowa, that his ac modations were Lower 10, Car 51, on Chicago and North Western train scheduled to arrive at Omaha at 7:20 A.M. Agent Logan returned to the Omaha Bureau Office. At 6:30 A.M.

Agent Abbaticchio discreetly contacted Agent Criss, who explained that Informant Long had talked to Mead from Chicago and had arranged to meet Mead in the lobby of the Fontenelle Hotel, as indicated in the telephone call from Special Agent Johnson; that the Informant was working with the Bureau and that he, Criss, was not openly contacting him on the train, but upon arrival at Omaha the Informant would register at the Paxton Fotel under the name of C. O. Loftis and would, at 9:45 A.M., proceed on foot to the Fontenelle Hotel, where he would inquire at the desk for Dr. Niles, the alias used by Mead; that the Informant did not know whether Mead was to be registered at the hotel or whether he would receive a message as to where to meet him.

Agents Abbaticchio and Franz observed the Informant on the train and it was arranged among Agents Criss, Abbaticchio and Franz, that upon arrival at Omaha Agent Criss would proceed directly to the Omaha Office, and that Agent Franz would take a taxicab and endeavor to arrive at the Paxton Hotel prior to the Informant and observe him register and keep him under observation; that Agent Abbaticchio would contact the writer at the Union Station, Omaha, and these two Agents would follow the Informant to the Paxton Hotel.

The Chicago and North Western Train arrived at 7:20 A.M. at the Union Station. Agent Flood went down to the train shed and met Agent Abbaticchio, who pointed out Long. Agent Logan was at the Station, as previously instructed, so as to have two cars if necessary to trail Long and associates of Mead if they appeared at the Station. Plans were formulated by the writer at the Omaha Office whereby two Bureau cars would be available at the Paxton Hotel and three Agents to keep Long under surveillance and trail him when he left the hotel to meet Mead at the Fontenelle Hotel.

The writer and Agent Abbaticchic proceeded to the Fontenelle Hotel on July 8th, 1936, around 7:30 A.M., to effect arrangements with the Manager, Karl Heumann, whereby Agents could be placed in advantageous positions to observe Mead and cause his apprehension. The clerk at the desk informed Agents that Mr. Heumann was expected to arrive in his office within fifteen minutes. No inquiries were made of the clerk as to whether Dr. Niles was registered at the hotel, as Mr. Heumann has, in the past, cooperated with the writer on several metters and he is the proper person to contact.

Mrs. Minnie Koch, who is in charge of the several telephone booths maintained at the Fontenelle Hotel by the Northwestern Bell Tele-

phone Company, is considered by Federal investigative officials working in Omaha as very reliable and dependable. Anyone making an outgoing call gives the number to Mrs. Koch, who dials same and assigns a booth to the client. She was shown a photograph of Mead and instructed if such an individual made a telephone call to make a note of same.

Agents Abbaticchio and Flood subsequently took a seat near the Manager's Office to await his arrival. Around 8:00 A.M. Agents
Abbaticchio and Flood observed a man who bore a striking resemblance to
Mead, both in his features and physical proportions, walking nervously
around the hotel lobby. This individual set in a chair, the back of
which rested against the left side pillar as one enters the hotel. This
chair is segregated from the rest of the chairs. The mair in question
faces the entrance. It seemed evident to Agents this individual, who
later proved to be Mead, planned to meet Long just as the latter entered
the hotel and thereby preclude Long from asking for him at the desk.
There was no question in the minds of Agents Abbaticchio and Flood but
what this individual was Mead, so it was decided to pick him up immediately, which was done in less than two minutes from the time Mead was firstobserved.

Agents Flood and Abbaticchio, from different sides, approached the individual seated in the chair and stooped down to question him.

Agent Flood asked him as to what his name was, to which question he responded, "Dr. Niles". Agent Abbaticchio then asked him if his name wasn't Mead and after hesitating a few seconds, he admitted his identity. Agents imformed Mead they were Special Agents of the Federal Bursau of Investigation, U. S. Department of Justice, and requested him to accompany them to the Bursau Office. Agents did not disclose their identities until Mead gave the name of Niles and later admitted his identity, as it was thought Mead would more quickly respond, as he would think Agents were associates of Long and the latter had sent them to contact him. It seems, probably for this reason, Mead without hesitation first said his name was Niles.

While Mead was still seated in the chair he was quickly but thoroughly searched for firearms. Mead was unarmed and offered no resistance. Agents did not display any firearms and Mead was taken into custody, without anyone in the hotel being aware of what was happening. Mead accompanied agents to the car in front of the Hotel Fontenelle and when he was seated in the car, he was again searched.

Upon the arrival of Agents Abbaticchic and Flood at the Omaha Bureau Office, Mead was taken through a doorway from which he could not see Agent Criss.

Agent Franz called the writer to advise that Long arrived at the Paxton Hotel at 7:30 A.M. and registered as C. O. Loftis, and was assigned to Room 826. Agent Franz was instructed to await the arrival of Agent Criss at the Paxton Hotel and then return to the office. It is to be noted that the only Agent to personally contact Long was Agent Criss. Agent Criss left Long at the Paxton Hotel and had him go through the arrangements, but none of Mead's associates appeared at the Fontenelle Hotel.

The writer telephonically advised Mr. Tamm of the Bureau of Mead's apprehension. Mr. Tamm instructed the writer to notify the Post Office Inspectors at Omaha of Mead's apprehension and permit them to question thim, but no information concerning the circumstances under which Mead was apprehended was to be furnished.

The writer ordered Mead to remove his clothing and his body was examined by Agents Abbaticchio and Flood and Logan, in places where he could secret small capsules of poison and other articles of a contraband nature. His clothing and shoes were also searched. Mead was then given his underwear and trousers and a pair of slippers purchased at a nearby department store. As it was said that Mead had attempted to commit suicide when arrested by New Scotland Yard, London, England, in 1930, and the records show he escaped on August 15th, 1896, from his guard while emroute to San Quentin, California, where he was being taken to serve a three year sentence, the utmost precautions were taken during his confinement at the Omaha Office to prevent any such occurrences. At periods when Mead was not being questioned, Agents were assigned to stay in the detention room with him; however, at 9:00 P.M. on July 8th, 1936, this procedure was discontinued and an Agent remained on duty directly in front of the iron door to the detention room throughout the night and until Mead was turned over to the U.S. Marshal at 2:30 P.M. on July 9th, 1936.

Postal Inspector Vernon Batie, Post Office Building, Omaha, was informed of Mead's apprehension and location. Mr. Batie, who is about to be retired from Government service and who is very cooperative with Agents of this office, came to the Bureau Office around noon on July 8th, 1936. Mr. Batie said that he did not have any information in his files concerning Mead's activities; likewise, he knew nothing of the charge on

which Mead was indicted on December 15th, 1922, at Jacksonville, Florida, so he did not desire to question him. Mr. Patie was told he would be afforded the opportunity of questioning Mead at any time he desired. Mr. Batie did not ask any questions relative to the circumstances surrounding the arrest of Mead and, of course, was not given any information relative thereto.

Agents Abbaticchio and Franz interviewed W. E. Antrim, Assistant Manager of the Fontenelle Hotel, for the purpose of checking Mead's registration at that hotel, procuring his baggage and searching his room. These Agents noted the registration card revealed that Mead registered at the hotel as H. Nyles, San Antonio, Texas, and was assigned to Room 1028. He registered at 9:45 P.M. on July 7th, 1936. The Registration Card was Number 4505 and the Account Card was Number 8933. Mead made no telephone calls, received none and had no room service. William Donnelley, Doorman, Fontenelle Hotel, stated that he could not recall that Mead had a car when he arrived at the hotel; however, a check of the Fontenelle and Medical Arts Garages, the only garages where the Fontenelle Hotel sends cars, revealed that neither garage had a car belonging to a Mr. Nyles, nor one registered for Room 1028 of the hotel.

Agents Abbatic chio and Franz, accompanied by Mr. Antrim, went to Room 1028 and searched it thoroughly, but found nothing other than what was in Mead's bag and the toilet articles which were in the bedroom. Mr. Antrim permitted Agents Abbatic chio and Franz to take Mead's belongings. Agent Franz gave Mr. Antrim a receipt for Mead's personal effects. The articles, wearing apparel and papers found in the traveling bag of Mead were listed by Agents Franz and J. C. Sloans.

Immediately after the arrest of Mead, he was fingerprinted by Agent Abbaticchio and three sets thereof were forwarded to the Bureau. The following day, July 9th, 1936, it was believed advisable to again finger print Mead, which was done by Agent Logan, as his fingers were badly mutilated, and four sets were forwarded to the Bureau so they could be studied by fingerprint experts. Mead was photographed in standing and sitting positions by Agent Logan with the Recommar Camera, and the twelve exposures which turned out good are being forwarded to the Bureau with copies of this report.

After Meed had removed his clothes, they were searched by Agents Abbaticohio and Flood. In the right, inside seam, near the watch pocket of his trousers, Agents found eight \$20.00 bills and also a \$5.00 bill,

four \$1.00 bills and 44 cents in coins. This search was conducted in the presence of Mead and when he was asked how much money he had in his possession, he said either seven or eight \$20.00 bills and in addition \$9.55, making a total of \$169.44; however, when Agents Franz and Sloane searched Mead's clothing in his bag, a \$1.00 bill was discovered, which Mead advised he did not know he had, so the total amounted to \$170.44. The \$20.00 bills and \$5.00 bill were searched against the Lindbergh, Weynap, Stollnap, Brekid and Urschel ransom lists, without identification.

On July 9th, 1936, the writer was telephonically advised by Mr. Tamm that when Agents were through questioning Mead, to deliver him to the office of the United States Marshal at Omaha and accordingly advise the Bureau. At 2:30 P.M. on July 9th, 1936, Mead was handcuffed and taken to the office of the United States Commissioner, Mary Mullen, Omaha, by Agents Flood, Franz, Logan and Sloane. Through prior arrangements Chief Deputy United States Marshal Henry Meyers and Deputy United States Marshal Earl Young were at the Commissioner's Office and Mead was turned over to them. Also present were United States Attorney Joseph T. Votava, Assistant United States Attorney Ambrose C. Epperson, and Postal Inspector Batie. Deputy United States Marshal Young served the warrant on Mead and he was immediately arraigned and entered a plea of not guilty, and in default of \$50,000.00 bond, was confined in the Douglas County Jail, pending hearing set for July 11th, 1936. A complaint filed by Inspector Batic recited in substance that Mead, prior to February 6th, 1921, devised a scheme to defraud by depositing circulars and letters in the United States Mails, in violation of the Criminal Code of the United States.

The Bureau was advised by teletype on July 9th, 1936, of the above action of Agents delivering Mead to the office of the United States Commissioner and the results of his arraignment.

Mead was arraigned for Hearing on July 11th, 1936, before United States Commissioner Mullen. Mrs. Mead was present at the Hearing. She had employed Bernie Boyle, Attorney, Omaha, Nebraska, to represent her husband. United States Attorney Votava had subpoensed Agent Flood as a witness at the Commissioner's Hearing. Mr. Votava learned that Mrs. Mead was endeavoring to raise the \$50,000.00 bond, so he made a motion before the United States Commissioner to have the bond set at \$200,000.00, as suggested by the Attorney General at Washington, D. C., which motion was granted, whereupon Mead's attorney waived Hearing. Federal Judge J. A. Donohoe signed the papers of removal. United States Marshal J. C. Byrnes and Deputy United States Marshals Joseph O'Grady and Earl Young left with Mead at 8:30 P.M., July 11th, 1936, for Jacksonville, Florida.

When Agents delivered Mead to the Office of the United States Commissioner, Agent Flood turned over to Mead, in the presence of Chief Deputy United States Marshal Meyers, all of his money, watch, wearing apparel, etc., a list of which was described in six typewritten pages. Mead was asked to check the list against his property, which he did and he thereafter signed his name, acknowledging receipt of same. Chief Deputy United States Marshal Meyers then took possession of Mead's property and he affixed his signature to the list. Mr. Meyers turned \$170.44 over to Mead's wife, who thereafter signed her name as Marie Mead to the list as receiving the money.

The writer examined a notebook found in Mead's possession, in which were written the following notations:

"Mrs. Louise Schoepflin, 2618 Dewey, Omaha, Jackson 7744."

"Sam House, Omaha, Nebraaka."

Mrs. Schoepflin was interviewed at the above address, at which place she operates a rooming house. She advised that Mead was unknown to her. Mrs. Schoepflin was shown a photograph of Mead, whereupon she recognized this individual as a man calling on her about five weeks ago, endeavoring to sell some sort of stock, but as she was not interested she closed the door in his face and he did not gain entrance to her house. In the interview with Mrs. Schoepflin it was learned that in 1920 a man named Charles Corman and his partner, a Mr. Murphy, who claimed they were from Sioux Falls, South Dakota, sold her \$300.00 worth of oil stock and they claimed the oil wells at some point in South Dakota were producing several hundred barrels a day. This stock proved to be worthless and it is quite likely she was placed on a sucker list which was sold to various crooked stock salesmen, and in this manner Mead probably secured her name.

Sam House is a gambler at Omaha and was at one time a lieutenant of Tom Dennison, a former political boss in Omaha who is now deceased. Mr. House has never been known to furnish any information to law enforcement officers. At the present time House operates the Diamond Cigar Store, 516 South 16th Street, Omaha, in the rear of which is located a large gembling room where nearly all forms of gambling are going on, including horse racing bets. In the rooming house on the second floor of his gambling

house, House has a telegraph room where he receives information on races, which service he sells to the various horse racing establishments in Omaha. Mr. House is known to be the contact men in Omaha through whom various out of town racketeers keep in touch with each other.

Agent Flood interviewed Mr. House at the above address. He advised that he had never met Mead, nor had any correspondence with him; that being a widely known gambler, evidently someone must have given Mead his name. Mr. House said that a few days after Mead was arrested, the latter's wife came to see him to ask his advice about the proper attorney to employ; that is, one who had the right political contact with Federal officials. He advised her to either see Bernie Boyle, who represents racketeers, or John Mullen, the latter a brother of Arthur Mullen, who until recently was Democratic National Committeeman from the State of Nebraska. Mr. House further advised that in his talk with Mrs. Mead she informed him Mead was a big time confidence man; that he worked in Chicago under the "payoff system" and said that certain police officers in Chicago, not naming them, always got a cut out of the profits when a "sucker was trimmed".

There was another notation in the notebook, "C. Hoffman, Room 1038, 190 North State Street, Chicago, Illinois". Mead, when asked about this, claimed Hoffman was a friend of his. The name of Allen K. Brevard, 146 Court Street, Confection Vending Machine Co., Seattle, Washington, was also written in the notebook. Mead claimed he was going to invest some money in this organization.

The following description of Mead was secured by Agent Flood through personal observation and questioning of Mead:







The following notations appearing on Mead's criminal record, are unsupported by fingerprints:





Mead was intermittently questioned by Agents Flood and Abbaticchio. He firmly refused to execute a signed statement, and at the beginning of the questioning he at first declined to execute a signed statement, and at the beginning of the questioning he at first declined to answer any questions, claiming such information as he might furnish would be used as evidence against him in the prosecution of the mail fraud case pending in Federal Court at Jacksonville.

Mead said that he was born near Springfield, Illinois, on July 1st, 1873, his father being A. T. Mead. The last address of his father was 123 North San Pedro Street, Los Angeles, California. Mead claimed that his father died while he was incarcerated in the Colorado State Peni-

tentiary at Canon City, Colorado in 1924, but declined to say where his father died or submit proof of his death. His mother, whose maiden name he claimed was Mary Adams, died when he was about two years of age. There were no other children in the family. Mead stated he has no living relatives. He claimed to never have attended school. He was placed in an orphan asylum, the name of which he does not recall, at Council Bluffs, Iowa, at the age of five, and a few years later a Mr. and Mrs. George Harrison, farmers living near Des Moines, Iowa, adopted him. He remained with these people until he was about fourteen years of age, when he ran away and he has never seen nor heard from them since. Mead advised that he does not have membership in any organization or society, with the exception that in 1928, when he and his wife were attending a Catholic Church at 64th Street and Woodlawn, Chicago, Illinois, he gave \$100.00 for a life membership in the Shrine of the Little Flower.

Continuing, Mead advised that when he was around twenty-one years of age he met a card player named Lijah Tones, at Moberly, Missouri, who taught him to play a square game of cards; that he acquired an expert knowledge of cards, poker, dice and the more skilful games of cards; such as Seven Up, Casino and Pinocle; that he became well known at the gambling houses he frequented in Goldfield and Reno, Nevada, Los Angeles and San Francisco, California; Butte, Montana; Kansas City, Missouri, and in many other States; that he was known as a \*\*stake player", which means the house furnishes him with sufficient funds to sit in a game and he is permitted... to keep half his winnings. Mead stated he considers himself one of the best card players in the United States and on a par with Wick the Greek. who is well known in Chicago but travels extensively to towns where gambling flourishes. Mead advised he finally drifted into the confidence game and selling stocks; however, he declined to discuss these angles of his activities. When asked how much his share totaled in confidence games in which he has participated, Mead declined to answer.

In reference to his first wife, Georgia Burke, Mead said he met her in Kansas City, Missouri, in 1898 or 1899, and they were married by a Justice of the Peace at San Francisco, California. They had no children. She came from some small town in Missouri. He lived with his first wife in San Francisco for about four years and supported her by gambling and playing cards. His wife was granted a divorce from him in San Francisco in 1902; however, he was not served any notice of the filing of the petition and the divorce proceedings, and secured his information from some gambler whose name he has forgotten. He stated that he never knew the parents or any relatives of his first wife, and does not know whether she is living or dead.

Meed advised he met his present wife, Katherine Schmitt, at Oakland, California, where he married her in 1914 under his true name. He never had any children by her.

Mead mentioned that he never carries small firearms on his person. He likes to hunt and has hunted for the most part in Montana and Wyoming. He would not disclose the names of his hunting companions or the places he frequents.

Mead advised that he arrived in Omaha around 7:30 P.M. on July 7th, 1936, from Chicago, but was reductant to inform Agents what transportation he used, but indicated he came in by plane, using an alias which he would not furnish. He advised that he had no associates in Omaha and was not driving a car.

Mead further advised that he received a patent on some land located near Prineville, Oregon, where he and his wife resided intermittently from 1913 to 1920, and that this property was finally sold to a Fred Grines.

Mead advised Agents that he never could see anything irregular in the confidence racket, as the sucker always knew the game was crooked and expected to beat the confidence man; that the sucker entered into the crooked transaction and in the end was ultimately swindled. He said that he never worked in any town unless there was a "pay off system", meaning police protection; that several years ago Denver, Colorado, Jacksonville, Florida and Chicago, Illinois, were towns favored by confidence men because of the police protection, but he declined to name any police officers to whom he had ever paid any money or heard other confidence men had split their profits with.

Mead denied ever having any association with gangsters, especially Dillinger, Karpis, the Barkers, Homer Van Weter, etc., claiming that confidence men do not associate with gangsters, kidnepers and bank robbers, as these individuals would just as soon hold up the confidence men and take his money as they would anyone else, and the confidence men hold a contempt for gangsters; that Cassius AcDonald, Detroit, Michigan, who is known to Mead although he claims never to have met him, is a smart confidence man, a good gambler and card player and considered one of the best in the United States and has always made a good living, and the confidence men were sur-

prised that he would associate with a kidnaping gang and change "hot" money for them. Mead stoutly denied that he ever participated as finger man, or in any other capacity, in the Brekid Case. He said it must sound reasonable, even to Police Officers, and it was their code that after they swindle a man, certainly they would not advise gangsters he was "easy picking", as it would put the confidence man on the spot and more than likely the gangsters would hold up the confidence man. Mead would not admit that he participated in swindling Martin/Wunderlich, Contractor at St. Paul, or any of the other victims indicated in the Summary Report of Special Agent R. C. Surem, Chicago, dated January 6th, 1936.

The writer, on July 11th, 1936, at the County Jail, Omaha, further questioned Mead. At this time Mead advised that he was introduced to Dr. Wilhelm-Loeser by his attorney, Louis Piquett, and Artxo Leary, Investigator for Piquett, at Elgin, Illinois; that Piquett said Dr. Loeser could change fingerprints. He talked to Dr. Loeser for a few moments and the latter said that he made a specialty of changing fingerprints, but did not mention anyone whose prints he had changed; that the agreed price was \$2,000.00; that as previously arranged, he met Dr. Loeser in the Louisville Hotel at Louisville, Kentucky, and there Dr. Loeser operated on his fingers in an attempt to change his fingerprints. Mead said that Dr. Loeser put a solution on his finger tips, one of the ingredients of which Loeser said was acid, and after leaving it on for several minutes, he scraped it off with an instrument, and repeated this procedure several times; that his fingers blistered but the operation was not painful and in six months his fingers healed. Mead advised that he gave Dr. Loeser \$200.00, which, it is noted, does not correspond with the statement Dr. Loeser made that Mrs. Mead paid him \$500.00. Mead said that he did not make any further payments to Dr. Loeser, as the latter was arrested shortly after performing this' operation.

Mead said that Postal Inspector Herbert Graham, New York City, formerly had a stool pigeon named Bert Donaldson, who usually went around to confidence men and "shook them down", claiming that he was doing it in beatalf of Graham; that in October, 1925, Donaldson came to him and said that for \$1,500.00 he could arrange it so Mead, by entering a plea of guilty, would receive a suspended sentence, or be placed on probation, and in any event would not serve any time in a County Jail or Prison; that Donaldson said he was authorized by Graham to contact Mead and his, Donaldson's, share was \$500.00 and Graham was to receive \$1,000.00; that he paid Donaldson \$500.00 at the first meeting and a few months later he met him in Atlanta,

Georgia, at the Georgian Courts, and paid him \$1,000.00. Mead claims that Joseph B. Ewing, an Attorney at Atlanta, has considerable influence with Graham and it is understood among confidence men who are arrested in Florida that they should see Ewing to get their cases fixed; however, he could not cite any specific case or give any definite information regarding cases that had been fixed. Mead said Bert Donaldson is now dead, having been killed at Atlanta, Georgia, a few years ago at a time when he had several thousand dollars in Liberty Bonds in hispossession. Mead said it was generally understood among confidence men that John Boykin, Solicitor General at Atlanta, Georgia, wielded considerable influence over Graham and Boykin is contacted by confidence men who desire to get their cases fixed, which have been investigated by Graham.

Mead was questioned about the case in which he was indicted by the Federal Grand Jury at Jacksonville, Florida, and he advised that in his opinion his chances to beat this case were good, as Graham has never been able to place him in Jacksonville prior to the time Parker C. Morton, the Victim, was alleged to have been swimiled. Mead confidentially advised Agent that Morton only saw him once and that was when he Wisited the latter's room and showed him some money and stocks in a bag; that he had no other contact with Morton and he feels the evidence in possession of the United States Attorney at Jacksonville is insufficient to obtain a convic-

Mead still declined to furnish the names of his associates in the confidence racket, principally because he claimed such information could be used as evidence against him in the case at Jacksonville.

The major cases investigated by the Bureau, and particularly the kidnaping and bank robbery cases, were again discussed with Mead, and he denied knowing any of the perpetrators of these crimes and said he could not be of any assistance in furnishing any information whatsoever concerning these matters.

Attached to the Bureau copies of this report, are the photographs of Mead, taken with the Recomer Camera at the Omaha Bureau Office.

Attached to the Bureau and Cincinnati Bureau Office copies of this report, is a copy of the list, comprising six pages, upon which is listed all of the articles taken from Mead at the time of his arrest; also, attached to the Bureau and Cincinnati Office copies of this report, are photostatic copies of the following papers found in Mead's possession, which he claims were fictitious and used in the confidence racket: Circular letter of Credit.

Admittance Card International Exchange, New York City.

Guaranty Trust & Bonding Co. Certificate, purporting to bond Franklin K. Joyce and James Stanley Boyd as Principals, and C. E. Blake, in the amount of \$100,000.00.
