EACH TITLE SHOULD CARRY THE NAME EL RUKN FOLLOWING IDENTITIES OF SUBJECTS TO IDENTIFY THE INVESTIGATION AGAINST A NON-TRADITIONAL ORGANIZED CRIME GANG, AS DESIRED WITHIN THE B CLASSIFICATION.
