Rerep requests that San Francisco should check indices and conduct a credit and criminal check at the place of residence of RICHARD THORNE.

The only reference to THORNE in the San Francisco indices reflected that the "Berkeley Daily Gazette", a local newspaper, ^{CARRIES} edited an article in the issue of 6/20/61, which reflected that RICHARD THORNE, 24 of 1862 Fairview Street, a student, was one of the local Freedom Riders who had been arrested in Mississippi.

Enclosed herewith are 8 copies of a letterhead memorandum suitable for dissemination. An additional copy of this letterhead is being forwarded to New Orleans for their information.



B. APPROX.

Records of the Jackson Police Department, Jackson, Mississippi, reflect that [REDACTED] Berkeley, California, was arrested at Jackson, Mississippi, on June 25, 1961, and charged with breach of the peace.

On August 7, 1961, records of the Berkeley Police Department, Berkeley, California, were checked but failed to reflect any information concerning [REDACTED]

On August 7, 1961, [REDACTED] Registrar's Office, University of California, Berkeley, California, advised that she could locate no record of [REDACTED] having attended the University of California at Berkeley.

On August 8, 1961, [REDACTED] made available the files of the Credit Bureau of the Greater East Bay, and it was noted that a file was being maintained for [REDACTED]. The last entry in this file was on September 29, 1959, at which time he resided at [REDACTED] Berkeley, and listed a previous residence as [REDACTED] Berkeley. At that time he indicated his employment as working for [REDACTED].

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

The file reflected that on June 18, 1959, [redacted] indicated that he was working for [redacted]. However, a check by the credit bureau failed to verify this employment.

The file reflected that on July 15, 1959, [redacted] indicated that he worked as a [redacted] for the [redacted].

In conjunction with [redacted] credit record, there was maintained a [redacted] Credit Card with an entry dated January 27, 1960, which indicated that [redacted] had been [redacted].

The "Berkeley Daily Gazette," a daily newspaper at Berkeley, California, in the issue of June 20, 1961, carried an article which listed a number of local "Freedom Riders" who had been arrested in Mississippi and among these was listed RICHARD THORNE, 24, 1862 Fairview Street, a student.



Twelve freedom riders from California arrived Houston, Texas, 9:55 AM, 8/11/61, via Southern Pacific Railroad. Railroad conductor and various passengers reported this group was very noisy and walked throughout train bragging that they would "break the Union Station Restaurant at Houston wide open." There are no facilities at Southern Pacific Station where group arrived. This group was met by six Houston members of Progressive Youth Association (PYA), a local group which also engages in attempts to integrate various facilities.

Entire group from California spent approximately one hour in offices of Houston Attorneys [redacted] who regularly furnish legal assistance and guidance to PYA. At 11:55 AM, several members of this group proceeded to Union Station and purchased seven one way

tickets by Missouri Pacific Railroad to DeQuincy, Louisiana, which represents cheapest tickets which can be purchased at Houston for interstate travel. This group later made short trip to Southern Pacific Station, possibly for similar purpose.

At 1:48 PM, twelve freedom riders from California accompanied by four individuals from Houston believed to be PYA members entered the restaurant at Union Station and took seats. Manager of restaurant declined to serve these persons, and they refused to leave restaurant. Manager proceeded directly to Houston Police Department and attempted to obtain arrest warrants through Corporation Court but Houston Police Chief CARL L. SHUPTRINE refused to approve warrants or furnish any assistance to restaurant owner. Restaurant owner then proceeded to Harris County Court House and obtained warrants against above 16 individuals charging them with unlawful assembly.

After restaurant owner returned to restaurant uniformed police officers arrived at the scene and obtained identities of each freedom rider and observed railroad ticket in possession of each rider. All 16 individuals were then placed under arrest and at 3:35 PM were placed in police vehicles and left for Harris County Jail to be photographed, fingerprinted, and booked in.

During above period, there was no threat of violence or any incidents other than routine activities normal for this railroad station at this period. Arrested persons left quietly until actually leaving station when they began singing.

It is not known at this time whether arrested persons will seek release on bond or will remain in jail. It is noted information developed by Los Angeles indicated California group might continue to Jackson, Mississippi, if not arrested at Houston.





This group arrived at Nashville, Tennessee, via Greyhound bus number M5494. They were met by a Negro youth, a white youth and a white girl who were riding in a 1958 Dodge. 1961 Tennessee license [redacted] This car is registered to [redacted] Nashville, Tennessee. The group talked at the bus for approximately ten minutes. During this time the Negro youth was observed to go to a public telephone in the bus station and make two telephone calls, these calls being made at approximately 12:20 to 12:25 p.m. The local group left the bus station, leaving the five named freedom riders who entered the bus station at approximately 12:30 p.m. They went to the lunch counter where they obtained service eating sandwiches. They experienced no difficulty.

The group left Nashville by Greyhound bus number M5446 en route to Memphis, Tennessee.

The bus station was covered by two plain clothesmen from the Nashville Police Department and a Special Agent of the Tennessee Bureau of Criminal Investigation, the state investigative organization. Also observed at the bus station were a newspaper reporter from The Nashville Banner and a newspaper reporter from United Press International. There was also a news photographer from The Nashville Banner. The

photographer took no photographs and none of the reporters made any attempt to interview the freedom riders.

Two unidentified white youths who apparently were curiosity seekers were observed attempting to make photographs of the group. These individuals were surveilled to the YMCA, Nashville, Tennessee, and subsequently to their automobile which bore a 1961 Oklahoma license number [redacted]. This car was a black and white 1957 two-door Ford hardtop. Observed inside the automobile were some bibles printed by the Southwestern Company, a company located in Nashville, Tennessee, which prints and sells bibles by the use of door-to-door salesmen.

[redacted] the Southwestern Company, Nashville, advised that one of the individuals who was taking pictures is a [redacted] from the State of Oklahoma who is presently in Nashville training as a salesman for the Southwestern Company. [redacted] stated that he questioned [redacted] concerning taking the pictures and was advised that [redacted] had read of the freedom riders in the paper and that he was taking the pictures merely as a matter of curiosity. He stated that the other individual who was with him was a man whom he had met at the YMCA and who was a casual acquaintance. [redacted] was unable to furnish his name. [redacted] stated that there was no connection between [redacted] and the freedom rider movement or a segregationist movement. *Tenn*

On July 19, 1961, Inspector [redacted] Nashville, Tennessee Police Department, advised that at approximately 12:20 p.m. two calls from an anonymous caller were received at the Nashville Police Department stating that there was an explosion at the bus station. The Police Department because it had men on duty at the bus station took no action on these calls other than to send a sergeant of the uniformed patrol by the bus station to be sure that the men on duty had not been incapacitated and therefore to be sure that there was no explosion.

On the evening of July 19, 1961, two Special Agents of the FBI observed the five individuals named above arriving at the Greyhound Bus Depot in Memphis, Tennessee, at 6:25 p.m. The group immediately went into the Post House Restaurant at the bus station depot. There they sat together at the counter

and were served without incident by white waitresses. They were interviewed by [redacted] of the United Press International and by an unidentified white female reporter.

The Commercial Appeal and Press Scimitar reporters were present but made no effort to interview the group. Both of these are newspapers published locally at Memphis, Tennessee.

At approximately 6:50 p.m. the group entered a United Cab Company taxi number 36 (Negro) driven by [redacted] They were followed by white Memphis Police Department officers, Lieutenants [redacted] and by Negro Police Department officers [redacted] *1811*

They proceeded to Owen College in Memphis, Tennessee, and went into Roger Williams Hall, a dormitory. It will be noted that Owen College is a Negro institution. At approximately 7:00 p.m. on July 19, 1961, [redacted] contacted the Special Agent in Charge of the Memphis Division and volunteered information that the group would remain at Owen College all night and would depart Memphis at 12:40 p.m. on July 20, 1961, via Greyhound bus en route to Little Rock, Arkansas. He also volunteered that he would advise the Memphis Division if there were any changes in the group's plans. It was noted that there was no local delegation or group of people to meet this group of freedom riders on their arrival. One of the group did approach one of the Negro detectives of the Memphis Police Department and asked if he might be [redacted] the NAACP in Memphis. This detective who happened to be named [redacted] replied in the negative, and when asked if he knew [redacted] address also advised that he did not.

At approximately 10:20 a.m. on July 20, 1961, an individual identifying himself as [redacted] one of the freedom riders, telephonically contacted the Memphis Division and advised that he and his associates would leave Memphis at 12:40 p.m. via Greyhound bus en route to Little Rock, Arkansas. He indicated that he would contact the Little Rock Office of the FBI upon arrival.

At 12:15 p.m. on July 20, 1961, Agents of the FBI observed the group eating lunch in the Post House Restaurant at the Greyhound Depot. This was formerly reserved for whites

only. No incidents occurred. They appeared to be alone.

Shortly prior to 12:40 p.m. all five individuals boarded the above described bus with no incidents occurring. The two Negroes were observed sitting in the front of the bus. The bus left the Memphis depot at 12:45 p.m. en route to Little Rock.

On July 21, 1961, Special Agents of the FBI were at the Memphis airport, at which time they observed that [redacted] [redacted] arrived in Memphis on American Airlines Flight No. 414. They arrived at 3:03 p.m. [redacted] remained on the plane which departed Memphis at 3:45 p.m. [redacted] scheduled to arrive in Washington, D. C. at 8:00 p.m. He had reservations confirmed through to LaGuardia Field in New York City to arrive at 9:30 p.m. [redacted] departed Memphis on American Airlines Flight No. 509 scheduled to arrive in Nashville, Tennessee, at 6:24 p.m. He was confirmed only to Nashville.

On the evening of July 21, 1961, an Agent of the FBI observed [redacted] arrive on American Airlines Flight 590 at Berry Field, the municipal airport at Nashville, Tennessee. He was not met by anyone and appeared to be expecting someone to meet him. ~~After~~ After a period of time when no one appeared, he got his luggage and took a taxicab to 1905 Jefferson Street, Nashville, Tennessee, the headquarters of the Nashville Christian Leadership Council Student Central Committee. The cab driver who transported him advised that [redacted] had the address when he got in his cab. The driver was unaware of the type of facility located at 1905 Jefferson Street.

It will be noted that [redacted] subsequently departed Nashville, Tennessee, via Greyhound bus en route to Jackson, Mississippi, with another group of freedom riders and there was arrested by the Jackson Police Department for violation of a local ordinance.



DETAILS:

Investigation in this case was predicated upon receipt of information from [redacted] Congress of Racial Equality, Jackson, Mississippi, on July 6, 1961. He telephonically advised that in about thirty minutes a group of Negro male Freedom Riders from Jackson would enter the white waiting room of the Illinois Central Railroad Depot at Jackson and attempt to purchase train tickets.

On July 6, 1961, Captain [redacted] Police Department, Jackson, Mississippi, was telephonically advised of the above information.

The following observations were made at the Illinois Central Railroad Depot, Jackson, Mississippi, on July 6, 1961:

At 10:46 AM, six Negro males entered the main entrance of the white waiting room and walked as a group approximately 20 feet into the waiting room. They were approached by Captain [redacted] Jackson Police Department, who was observed speaking to them. A short time later, the six were escorted from the waiting room to a police patrol wagon parked near the depot.

There were no incidents in connection with the above matter.







On August 9, 1961, a confidential source who has furnished reliable information in the past advised that a group of twelve "Freedom Riders" sponsored by the Congress of Racial Equality had arranged to depart from Los Angeles, California, at 9:00 PM on August 9, 1961, via Southern Pacific Railroad en route Houston, Texas. Source stated this group would be traveling on Coach Car Number 205. Source stated the announced intention of this group was to test the segregation laws at Houston, Texas. The group was scheduled to arrive at Houston, Texas, at approximately 9:20 AM on August 11, 1961.

On August 11, 1961, Detective [redacted] Special Investigator for Office of Chief of Police, Houston, Texas, advised that the above Southern Pacific train actually arrived at Houston, Texas, at 9:55 AM on that date. [redacted] reported a group of six individuals met this train and he was able to identify these individuals as members of the Progressive Youth Association (PYA), a group which has been very active in recent months in Houston, Texas. Bass pointed out the PYA has staged a number of sit-in demonstrations at various restaurants in Houston, including the Union Station Restaurant where several of them were previously arrested.

[] related a group of approximately twelve individuals were observed to disembark from Coach Number 205 on this train and they were warmly embraced by the Houston, Texas, group mentioned above. [] stated the group arriving on this train consisted of individuals of both sexes and of both the white and Negro races, and they appeared to be between 18 and 25 years of age.

On August 11, 1961 [] Investigator, Texas Department of Public Safety (DPS), advised the above group had been observed to arrive at the Southern Pacific Railway Station in Houston and that they were met by a group of individuals whom he identified as members of the PYA at Houston. [] stated he talked to the conductor of this train and to several passengers, all of whom were aware of the identities of this group as a group of California "Freedom Riders." The conductor and several passengers reported to [] that the "Freedom Riders" were very loud and boastful during the trip from California to Texas and they walked throughout this train telling the other passengers they were going to Houston, Texas, and that they would "break the Union Station restaurant at Houston wide open."

Detective [] mentioned above, pointed out on August 11, 1961, that there were no eating facilities at the Southern Pacific Railroad Station at Houston. [] was able to determine the California group, after leaving the train at the Southern Pacific Station, entered several private automobiles provided by the Houston PYA members and the entire party then left this station. [] learned that this entire group went directly to the offices of Houston Attorneys [] [] who regularly furnish legal assistance and guidance to members of the PYA at Houston. [] stated this group spent approximately one hour in the offices of these attorneys, and that several members of the group later visited the offices of the PYA located in the 2200 block of Dowling Street.

[redacted] mentioned above, advised on August 11, 1961, that three members of the above group, including two Negro members of the PYA at Houston, proceeded to the Union Station at 11:55 AM on August 11, 1961, and purchased seven one way tickets for travel by Missouri Pacific Railroad from Houston, Texas, to DeQuincy, Louisiana. [redacted] was informed that these were the cheapest tickets which could be purchased at Houston, Texas, for interstate rail travel.

Detective [redacted] mentioned above, advised on August 11, 1961, that a group of Negro and white persons arrived at the Union Station at 1:48 PM on August 11, 1961, and entered the restaurant at the Union Station where they took seats. [redacted] stated there was considerable confusion resulting from various members of this group entering and leaving the restaurant to make purchases in the lobby, but it appeared to him that this group consisted of approximately twelve "Freedom Riders" from California and four or more individuals from Houston who were members of the PYA. [redacted] stated that [redacted] of the Union Station Restaurant, declined to serve this group and requested that they leave. When this group refused to leave the restaurant [redacted] left the restaurant and announced he was going to the Houston Police Department and attempt to obtain arrest warrants.

[redacted] mentioned above, reported on August 11, 1961, that [redacted] later returned to this restaurant and stated he had been unable to obtain arrest warrants through the Houston Police Department or the Corporation Court but that he had proceeded to the Harris County Court House and had obtained warrants from the office of a Justice of the Peace, charging the sit-in demonstrators with unlawful assembly.

[redacted] reported two uniformed police officers arrived at this restaurant at approximately 3:00 PM on August 11, 1961, and talked briefly with each of the

sit-in demonstrators, obtaining their identities, and observed railway tickets in their possession. All of these demonstrators were then placed under arrest, were escorted to police vehicles and left the Union Station at approximately 3:35 PM.

[redacted] stated that during the entire time this group of demonstrators was in the Union Station there appeared to be no threat of violence or any disturbance of any sort and the activities in the station appeared to be normal for that time of day. The arrested persons left the station quietly but began singing as they were driven away from the station.

On August 12, 1961, Detective [redacted] reported that an examination of Identification Bureau records at the Houston Police Department on August 12, 1961, disclosed that a total of 18 persons were actually arrested at Union Station, Houston, Texas, on August 11, 1961. He stated that eleven of these individuals were "Freedom Riders" from California and seven were Houston members of the PYA. [redacted] pointed out the seven railway tickets which had been purchased for travel between Houston and DeQuincy, Louisiana, mentioned above, were apparently for use of the seven Houston members of this group inasmuch as the travelers from California reportedly held return tickets from Houston to Los Angeles.

[REDACTED] pointed out that a review of the above data disclosed the California group consisted of four white males, three white females, three Negro males, and one Negro female, while the Houston group consisted of four Negro males and three Negro females. He stated that all members of the Houston group had been identified previously through their activities as members of PYA.

On August 12, 1961, an article appeared in "The Houston Post" captioned "Eleven Freedom Riders Arrested at Station." This article identified the spokesman for the California group as Robert Kaufman, 23, of Berkeley, California. Kaufman was reported to have stated his group was sponsored by the Congress of Racial Equality and the activities of his group were "a definite attempt to test integration in Houston." Kaufman stated his California group held round trip tickets from Los Angeles to Houston and return. This article further reported that all 18 of these arrested persons went to jail rather than post bonds of \$500.00 each. Kaufman stated that his group would not post bonds and would serve out any sentence. All of the demonstrators were identified in this article as students. Kaufman related that his group had visited the PYA before going to the Union Station restaurant.

The above article further reported that two weeks previously Mayor Lewis Cutrer of Houston had met with Negro attorneys and announced that no legitimate travelers would be arrested in the Union Station Restaurant unless warrants were sworn out against them. This article reported that the Houston City Attorney had held that the restaurant

could not legally refuse service to any interstate traveler. This article also reported Assistant Police Chief [] had stated that his officers were only executing warrants in arresting the above travelers and that the police department at Houston would not file charges on people in interstate travel.

On August 14, 1961, "The Houston Post" carried an article captioned "Four Riders Out on Bond After Fight." This article reported that four white California "Freedom Riders" who were part of the 18 persons arrested for Unlawful Assembly on August 11, 1961, were released on bond from Harris County Jail on the evening of August 13, 1961. These four individuals stated they had been beaten by other jail prisoners and desired their release to prevent further beatings.

This article reported the "Freedom Riders" were visited at the jail on August 13, 1961, by George Washington, Jr., one of their attorneys. After learning of the alleged beatings, Washington arranged for bonds of \$500.00 each to be posted for the following four individuals:

Robert Kaufman, 23, Berkeley, California, described as the spokesman for the group; Steven E. McNichols, 22, Los Angeles, California; Joseph M. Stevenson, 18, Hollywood, California; and Stephen H. Sanfield, 24, Hollywood, California.

This article pointed out the four who were released on bond were the only white men in the group from California. It was reported that none of the 14 persons who remained in jail had complained of trouble with other prisoners. The three white women from California reportedly stated that they had been treated well.

This article further reported that Captain W. L. Bond, Jailer, had observed a cut on Kaufman's head and was advised by Kaufman this had resulted from a fall against a table. Kaufman acknowledged that he had made this explanation to the jailer.

On August 14, 1961, Detective [redacted] Special Investigator for Office of Chief of Police, Houston, Texas, stated that no date for the trial of persons arrested in connection with this matter had been set, but that the Harris County Courts were very crowded and he expected there would be an appreciable delay before they were tried.

On August 15, 1961, "The Houston Post" carried an article captioned "Two Sides Agree Case of Four Freedom Riders Closed." This article reported that Attorney George Washington, Jr., had agreed with officers of the Sheriff's Department on August 14, 1961, that the alleged beating of four California "Freedom Riders" in the County Jail was a closed case. Washington reportedly made inquiries among the 14 remaining prisoners in the jail on Monday, August 14, 1961, and stated none of these individuals had any complaints. Washington was quoted as follows: "We are not disturbed and we are not trying to embarrass the Sheriff's Office. So far as I am concerned the incident is closed."

This article further reported that District Attorney Frank Briscoe stated his office was checking on the legality of the Californians' arrest for unlawful assembly. Briscoe stated he expected to know within about three days whether the charges could be prosecuted.

On July 2, 1961, Chief of Detectives M.B. PIERCE, Police Department, Jackson, Mississippi, advised that [REDACTED] California, [REDACTED] was arrested with four other individuals on a charge of breach of the peace at the Continental Trailways Bus Terminal, Jackson, Mississippi.

According to Chief PIERCE, [REDACTED] and the other individuals were arrested by Captain [REDACTED] Jackson, Mississippi Police Department, following their arrival on a Trailways Bus, and after entering the white waiting room at the bus terminal. On July 11, 1961, Sheriff J. RALPH GILFOY, Hinds County, Jackson, Mississippi, advised that [redacted] had been transferred to the Mississippi State Penitentiary, Parchman, Mississippi, from Jackson, Mississippi, on July 11, 1961.

The 1955 Report of the California Committee on Un-American Activities, page 46, stated, "The Independent Progressive Party in California was quickly captured by the communists, and by the time the Wallace for President campaign had swung into high gear was being operated lock, stock, and barrel by the Communist Party of California. Time after time the committee in questioning witnesses throughout the State discovered that the leaders of the Communist Parties in various localities were identical with the leaders of the Independent Progressive Party in the same area. It is true, of course, that in the Independent Progressive Party there were many sincere liberals who, because of dissatisfaction with the two major political organizations registered as Independent Progressives and continued their affiliation until the true control of the I. P. P. became obvious. These people invariably resigned, many of them having given the benefit of their experience to various official agencies interested in the exposure of subversive activities."

The Communist Party, USA, has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

Records of the Police Department at Jackson, Mississippi, show that on July 29, 1961 one [redacted] a Freedom Rider, was arrested for breach of the peace after arriving in Jackson by bus from Nashville, Tennessee.

The police records identified [redacted] as having been born [redacted] New York and as living at [redacted] New York.

The records further spoke of her as a [redacted] [redacted] tall, weighing [redacted] pounds, as having [redacted] eyes, [redacted] hair, a [redacted] complexion and as currently a student at the University of Wisconsin (UW) in Madison, Wisconsin. She was said to be a former member of the National Association of Colored People. She claimed to have participated in an integration march in Washington, D.C. in 1958-1959, picketed in New York in 1959, and a demonstration for disarmament walk from New Rochelle to New York.

MI T-1 advised on November 28, 1960 that one [redacted] Wisconsin, was then a subscriber to a publication called "Studies on the Left".

A documentation of "Studies on the Left" appears below.

MI T-2 advised on May 21 and 22, 1961 that the name of [redacted] Wisconsin, appeared on an addressograph plate currently in the offices of the [redacted] New York City.

A documentation of the FPCC appears below.

STUDIES ON THE LEFT (SOTL)

The "Wisconsin State Journal," a daily newspaper published at Madison, Wisconsin, on November 26, 1959 announced that a new scholarly magazine, "Studies on the Left," a historical review dedicated to the leftist point of view, edited by present and former graduate students at the University of Wisconsin (UW), but having no connection with the UW itself, would begin publication soon.

Records of the Wisconsin Secretary of State reflect SOTL was incorporated under laws of Wisconsin July 16, 1959 as a non-stock, non-profit corporation with headquarters P.O. Box 2121, Madison, Wisconsin. Three issues were published during the period December, 1959 to November, 1960. The first issue contained a policy statement of the editors stating SOTL was primarily a magazine for national circulation designed to give younger men with radical views a place to voice their opinions.

Publicly listed members of SOTL's Editorial Board [redacted]

[redacted] have been identified by sources previously as having participated in the activities of the Labor Youth League (LYL); while Editorial Board members [redacted] [redacted] have been identified as active members of the Communist Party (CP). Another source has identified [redacted] as handling the finance and business affairs of SOTL.

The Communist Party, USA, and the Labor Youth League have been designated by the Attorney General of the United States pursuant to Executive Order 10450.

At 6:40 AM, Greyhound Bus #4447 was observed to arrive at the terminal and the passengers on board began to leave the bus. Among the passengers a group of seven began to separate themselves from the others; this group, consisting of four white males, two white females and one other male, whose race was not immediately ascertainable, waited on the passenger loading platform for several minutes while awaiting the unloading of baggage belonging to some of their number.

These seven individuals then proceeded to enter the colored waiting room at the terminal and were followed therein by Captain [redacted] and several other uniformed officers of the Jackson Police Department.

Some of the seven took seats at the waiting room lunch counter while the remaining stood beside them. Captain [redacted] approached this group, asked them if they would move on, then ordered them to move from the waiting room and finally asked them if they heard his order. When several members of the group acknowledged they had heard [redacted] but declined to leave as ordered, all seven were placed under arrest and were escorted from the waiting room by a side door.

At 6:55 AM, these seven individuals were observed to enter a police patrol wagon parked in front of the terminal. No incidents occurred during the arrest, no handcuffs or other restraining device observed to have been used, and the arrests were quietly carried out.





PIERCE stated that all of the above individuals were tried for violation of Section 2087.5, Mississippi Code. All entered pleas of not guilty through their attorney. All were convicted and sentenced to four months in jail and fined \$200.

According to PIERCE, some of the defendant^s would be transferred to the Hinds County Jail to serve out their fines and sentences and some would be housed in the Jackson City Jail to assist the Sheriff in overcoming crowded conditions at the County Jail.

PIERCE advised there were no incidents during the course of the above trial.

On July 26, 1961, Deputy [redacted] advised that [redacted] was released on \$500 cash appeal bond the night of July 25, 1961, and indicated she would travel to Atlanta, Georgia.
