B. "National Guardian" (NG)

The characterization of the "National Guardian" is contained in the appendix pages.

On November 21, 1968, the Subject attended a public meeting at California Hall, Polk and Turk Streets, San Francisco, California, sponsored by the "National Guardian". JESSICA TREUHAFTH spoke on American capitalism, which exploits the Black people and other minorities. DECCA TREUHAFTH was also mistress of ceremonies. (u)

All speakers stated themes along the line that members of the Black Panthers were political prisoners and would be incarcerated for political views and activities. The purpose of the gathering was announced as an attempt to get the affluent together to educate them regarding the Black Panthers' cause and to raise money for Panthers defense. (u)

C. MORTON SOBELL's Freedom Celebration

The characterization of the Committee to Free MORTON SOBELL is contained in the appendix pages.

On April 11, 1969, JESSICA TREUHAFTH attended a party at the Jack Tar Hotel in San Francisco to celebrate the release of MORTON SOBELL from Federal prison. JESSICA TREUHAFTH was chairman of the meeting.

A tape of MORTON SOBELL and his wife was played in which they thanked everyone for their help to gain his freedom.

DECCA asked an attorney to take up a collection, and \$500 was collected.

D. Association With The Black Panther Party

The Black Panther Party (BPP) is a Black extremist organization started in Oakland, California, in December, 1966. It advocates the use of guns and guerrilla tactics to bring about the overthrow of the United States Government.

On November 21, 1968, the Subject was mistress of ceremonies at a meeting with the Defense Committee for ELDRIDGE CLEAVER, a Black Panther, at California Hall, Polk Street, San Francisco, California. There were various speakers all criticizing the system of justice in the United States.

On March 20, 1970, JESSICA TREUHART and members of the Black Panther Party planned a fund raising affair for the Black Panther Party.

Weekly Guardian Associates, Incorporated

The "Guide to Subversive Organizations and Publications," revised and published as of December 1, 1961, prepared and released by the Committee on Un-American Activities, United States House of Representatives, Washington, D.C., contains the following concerning the "National Guardian":

"1....'established by the American Labor Party in 1947 as a "progressive" weekly... it has manifested itself from the beginning as a virtual official propaganda arm of Soviet Russia.'"

Beginning with the February 10, 1968, issue, the "National Guardian" became the "Guardian."

The May 9, 1970, issue of the "Guardian" is self-described as an "independent radical newsweekly."

The December, 1968, issue of "The New York Times" carried an interview with the editors of the "Guardian." One of the editors stated: "Our job is to build a radical movement. To quote the Cuban Revolutionaries, we are not only to write about it, but also to move along with it... we are movement people acting as journalists."

"The 'Guardian' takes a strong left position, but it is not identified with any organized group because it believes that an American left ideology is still in the making. One of its purposes is to break away from the cliches of the left ideology of the past."

A source advised in May, 1970, that the "Guardian" is located at 32 West 22nd Street, New York, New York.

AMERICAN LABOR PARTY

The Guide to Subversive Organizations and Publications, revised and published December 1, 1961, prepared and released by the Committee on Un-American Activities, United States House of Representatives, contains the following on Page 22 concerning the American Labor Party:

- "1. 'For years, the Communists have put forth the greatest efforts to capture the entire American Labor Party throughout New York State. They succeeded in capturing the Manhattan and Brooklyn sections of the American Labor Party but outside of New York City they have been unable to win control'.
(Special Committee on Un-American Activities, House Report 1311 on the CIO Political Action Committee, March 29, 1944, p. 78.)
- "2. 'Communist dissimulation extends into the field of political parties forming political front organizations such as the *** American Labor Party. The Communists are thus enabled to present their candidates for elective office under other than a straight Communist label'.
(Internal Security Subcommittee of the Senate Judiciary Committee, Handbook for Americans, S. Doc. 117, April 23, 1956, p. 91.)"

On October 7, 1956, Peter Hawley, New York State Chairman, American Labor Party, publicly announced the American Labor Party State Committee unanimously approved a resolution dissolving the organization and ordering the liquidation of its assets.

COMMITTEE TO FREE MORTON SOBELL

"Following the execution of atomic spies Ethel and Julius Rosenberg in June, 1953, the 'Communist campaign assumed a different emphasis. Its major effort centered upon Morton Sobell,' the Rosenbergs' co-defendant. The National Committee to Secure Justice in the Rosenberg Case - a Communist front which had been conducting a campaign in the United States - was reconstituted as the National Rosenberg - Sobell Committee at a conference in Chicago in October, 1953, and 'then the National Committee to Secure Justice for Morton Sobell in the Rosenberg Case'..."

("Guide to Subversive Organizations and Publications", dated December 1, 1961, issued by the House Committee on Un-American Activities, page 116.)

In September, 1954, the name "National Committee to Secure Justice for Morton Sobell" appeared on literature issued by the Committee. In March, 1955, the name, "Committee to Secure Justice for Morton Sobell", first appeared on literature issued by the Committee. In August, 1966, the name "Committee to Free Morton Sobell" first appeared on literature issued by the Committee.

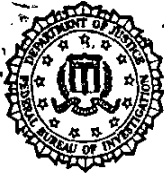

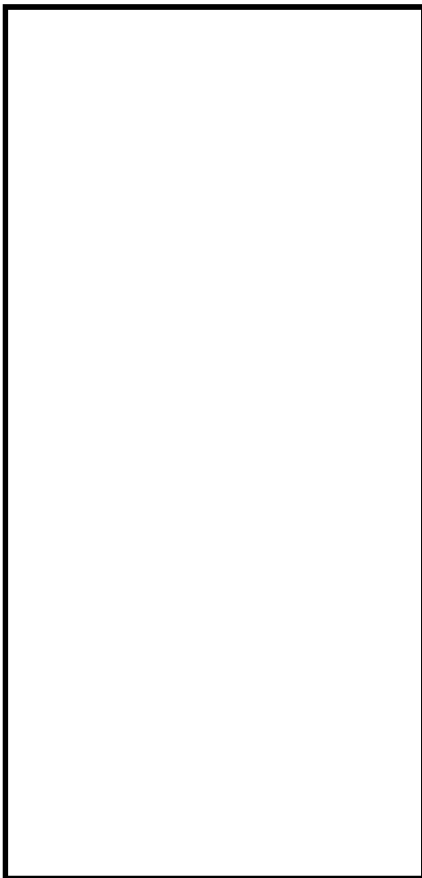



In January 1944 [redacted] advised Jessica Treuhaft had become a member of the CP Club in San Francisco. According to [redacted] Jessica had previously been active in CP affairs but waited until January, 1944 to join the Party due to the fact that she had just prior to this received her citizenship papers. [redacted] also stated that Jessica has been known to recruit new members into the party.

Jessica and her husband, Robert, are listed in a CP publication as outstanding workers in the Twin Peaks branch of the CP in securing subscriptions to the "People's World" (PW) a West Coast Communist newspaper.

The "San Francisco Chronicle," a daily San Francisco publication, issue of February 16, 1959, page five, column one, contains an article entitled: "8 BAY AREA LAWYERS LABELED AS 'REDS.'" This article, datelined February 15, 1959, states, "The House Committee on un-American Activities charged today that an 'elite corps' of Communist lawyers was promoting the Party's cause in the Courts, Congress, and Government agencies." The article referred to a report issued by the Committee which dealt with activities of thirty-nine out of more than one hundred lawyers identified in sworn testimony before the Committee in the last decade. Among the Bay Area attorneys named, was ROBERT E. TREUHAFI.

A report by the Committee on un-American Activities, House of Representatives, 85th Congress, First Session, dated February 16, 1959, entitled, "Communist Legal Subversion -- The Role of the Communist Lawyer," pages 68 and 69, identified ROBERT TREUHAFI as a member of the Communist Party.

The "New York Guild Lawyer", official publication of the New York City Chapter, National Lawyers Guild issue of December, 1958, reflects that ROBERT E. TREUHAFI, San Francisco, was elected a member of the National Executive Board of the National Lawyers Guild at the 1958 convention.

Robert and Jessica Treuhaft have been active in supporting the PW.

On February 27, 1962, [redacted] advised that Robert Edward Treuhaft was a member of the Executive Board of the National Lawyers Guild from San Francisco.

The San Francisco Chapter of the National Lawyers Guild (NLG), which is affiliated with the NLG and follows its policies and directives was organized in the summer of 1937.

NLG is a communist front organization of lawyers and law students dedicated to CP, USA and New Left ideals for radical change of the social, economic, and judicial systems in the United States.

On October 1, 1963 the name of Jessica ^{For}Mitford of Oakland, California, author, was included on the list of sponsors of the NCAHUAU.

Jessica Treuhaft and her husband, Robert, were present at a reception sponsored by the San Francisco Chapter of the NLG on August 17, 1963 at which time Robert Treuhaft made a speech to raise funds to help Southern lawyers sympathetic to the NLG.

[redacted] advised on April 16, 1964 that Jessica Treuhaft had maintained contact with members of the CP and officers of the PW newspaper.

Jessica was present at a meeting of the Citizens Committee To Preserve American Freedoms (CCPAF) in San Francisco, California on April 11, 1964 at which time those present were all thanked for their financial assistance in helping to abolish the NCAHUA.

Jessica Treuhaft was one of the adult endorsers of the founding convention of the New Socialist Youth Organization (which later became known as the W.E.B. Du Bois Clubs of America) (DCA).

The DCA was a CP, USA front organization for youth, which functioned for several years before becoming defunct in 1970.

The San Francisco "Chronicle" and the Oakland, California "Tribune", both daily newspapers of general circulation, carried articles on April 12, 1962 revealing that Oakland attorney Robert Treuhaft had been expelled from Portugal after attempting to investigate the plight of political prisoners in Portugal.

Jessica and Robert Treuhaft were among those present at a forum discussion held on November 5, 1965 in San Francisco for the purpose of raising funds to be used to send PW subscriptions to editors of college newspapers.



Inspiracy Law Attacked By Author

By George Murphy

The current conspiracy law is "a weapon to stifle dissent," author Jessica Mitford Treuhaft told the San Francisco Barristers Club yesterday.

Mrs. Treuhaft, whose new book, "The Trial of Dr. Spock," came out this week, discussed that case and its ramifications at a luncheon meeting of the club at the San Francisco Bar Association in the Mills Tower.

Spock, the famous pediatrician, and four other defendants were found guilty in Massachusetts of conspiracy of aiding young men to avoid the draft.

Mrs. Treuhaft covered the case from its inception, and said yesterday a Department of Justice prosecutor told her the trial came about "to placate General (Lewis) Hershey (head of Selective Service)."

LINKED

Spock and his co-defendants "had never met either in person or by phone, and were only linked because they stood up against the (Vietnam) war," she said.

"But the government used the conspiracy charge against them. It is a made-to-order tool for frameups."

Mrs. Treuhaft suggested that "perhaps defense attorneys would urge that jurors vote their own consciences, and disregard the instructions of judges."

She said she had spoken to three jurors in the Spock case who felt all five defend-

ants were innocent, but said they had to vote for conviction because of the instructions they were given.

OVERTURNED

(An appellate court later overturned the convictions because of the judge's instructions.)

She also said a Department of Justice prosecutor told her the names of 100 veniremen were "checked out" by the FBI, and that the jury finally was all-male and all-white.

"The prosecution excused two women, one black, and a young man who was seen to be carrying a book," she said.

Mrs. Treuhaft noted the Spock jury was sequestered from the day it was finally selected.

"Juror No. 6 had to be replaced within two days," she recalled. "His wife, who apparently read about it in the papers, looked up the word 'sequestered' and then immediately ran off with her lover."

Author Jessica Mitford Called Pro-Communist

NEW YORK, Oct. 18 (AP). They named their first son A California Congressman Tito but changed the boy's ys Jessica Mitford, author of name to Nicholas, for the late "The American Way of Death," Communist leader Nikolai is, "pro-Communist, anti- Lenin, after Yugoslavia split American" and a foe of the Christian religion. with Moscow.

Miss Mitford called the accusation a "Red herring."

In a statement entered in the appendix of the Congressional Record last Tuesday, Representative Utt, a Republican, listed what he called Communist-linked activities of Miss Mitford and her husband, Robert Treuhart.

Her book, said Mr. Utt, strikes "another blow at the Christian religion."

The book criticizes the American undertaking industry, alleging that funeral directors over-commercialize and charge too much.

Miss Mitford, in Denver, Colo., replied:

"The whole thing is so beneath comment that I'd rather not comment. I'm longing to meet any and all questions and criticism about it (the book). So far the undertakers seem to have come off with nothing except this kind of thing.

"This is rather a Red herring. It seems impossible to go into any extended comment on it."

Simon & Schuster, publishers of Miss Mitford's book, said booksellers had received letters accusing them of fostering the Communist line by selling the book.

"Because the funeral industry has not been able to refute the case Miss Mitford had documented in her book, it is now trying to discredit the book by attacking her personally," said a company statement.

Miss Mitford's married name is Mrs. Jessica Mitford Romilly Treuhart. She is one of eight daughters of the late Lord Redesdale, an English friend of Adolf Hitler. At 18 she eloped with Esmond Romilly, a nephew of Sir Winston Churchill. Her first husband was killed in World War II.

Miss Mitford married Mr. Treuhart, a Hungarian, and they now live in California.

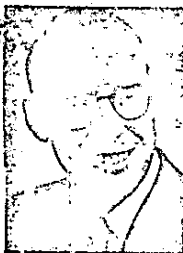

'Laboring To Prepare Suicide'

J. Edgar Hoover, in his 1963 Annual Report, says that "A new trend is evolving within the (U.S. Communist) Party." He explains, "A number of Party leaders believe they now are safe from arrests for some time. They contend there will

be no more charges filed against them under the Internal Security Act of 1950 until the cases against (Gus) Hall and (Ben) Davis (top party members in this country) are settled finally by the Supreme Court".

Hoover goes on to relate that the communists are expanding their drive for public support. "Speaking engagements, press interviews, radio and television appearances are openly sought." The F.B.I. Chief explains. "Their major aim is to convey the impression that communists are loyal citizens of the U. S. who merely hold political views which differ from those currently prevailing."

Recently the communists experienced tremendous success in getting one of their own on nationwide TV. She was Jessica Mitford Truehaft, author of "The American Way of Death," a book which constitutes a tirade against American funeral parlor practices. She appeared on "CBS Reports," the night of October 2.

It wasn't as if CBS didn't

know of Mitford's background. A letter from CIC on September 26 outlined the Communist activities of this woman and suggested that CBS might want to re-evaluate giving her a national forum.

The CBS reply was to the effect that her background wasn't important and she would go on as scheduled.

A second letter to the network brought a similar response. But record where it received national distribution. Edgar Hoover says "Any action taken by the CPUSA is aimed at perpetuating the Party and weakening the governmental, economic, social and moral structure of the U.S. - all in the interest of advancing world Communism. Regrettably, many noncommunists have been duped into helping." Indeed they have Mr. Hoover. Indeed they have.
