In fact I think that the old saysing "piercing the . corporate veil" meaning -- it really is the same organization under a differ guise --would be the case here .--- ( I feel that same way about what we did down south and that it why I think my past changes were only good to keep our people from finding the funds but virtually ineffective in keeping the government out if they really go hot on the case). Anyway perhaps there is some merit to it so we will check that out carefully. Chaiken has wanted us to drop off our tal materials with a tax attorney to check out our satuation before the IRS came outfront on our case. Cahiken said that he , doesn't feel that he understands the field that well and at the same time would like some expert advice on it. He said that it would take a tax attoreny about three days time to work on our case at a price of about 300.008 a day. W Cahiken felt that it was worth it in that he wasn't well versedin the area and thought that it could be a trouble spot at later on. In that I don't know what you communications are with him at this point I thought that I should stress to you what he stressed to me so that In any case--- we can live wi you could make your desicion on the matter.

without Chaikn so don't worry about us ---- Garry said that he understands and we are working on some of our more piddely legal problem with James Herndon in the office who is a conscientious lawyer thoough not what you would call a charasmatic occurtroom figure --- but in ome ways I like his follow through better than Garrys. I would not underestimate Garry's feelings towards you. I have to both Pat and Garry about our perspective and they can see it --- (at the time he did have a problem with it but ne so were pupportive now

Angels called hery numberous times and so did Kindra Alexandra and Fanis somehow heard about it and offered support anyway that she could. I cannot say that they all agreed or understood even if they said so to our faces I don't know that they really did so that is just something that we have to live with at this Ty point that everyone is not going to understend us. Dennis seemed to be the most understanding --- he has been in the postion of fighting for his "camp" and your situation was almost a ditto of his so his support came without reservation and so did Leigh Brightmans. When Dennia heard what was going on he said that there was going to be a metting of the United Bations Conference where it would be the first time in the history of 300 years of the American Indian opression that they have had a choice to voice their genocide internationally-Russal Means was going and since Dennis cannot travel Bill Wapshalps was going in Dennis's place to talk. Dennis gave up his statement on the Indiana opression and reworte his speach for you and what is happening to you in Guyana. I can assure you from what I have read and heard that next to the fact that Dennis could well have been harmed for the statement he made gainst the treasury department this move in Geneve was the greatest secrifice that the AIM movement could make for anyone because it is the first time that they have ever had an international voice. I called Dennis this morning and told him that the arrest order had been recinded and he was very happy --- he said that he would get hold of Bill who was leaving for Switzerland today and have him put inhis origionel statement for the AIM movement --- I seid that you had said that you did not went him or the AIM movement to make that sacrificie for you. I hope that that was ok to # Dennis's loyalty was nothing for show. I know that Kamook was worried sick but supportive of you but worried abou Dennis and how this whole thing would affect his extridiction. She has helfd up through this thing too and has repeatedly said that had it not been for you that she would not have seen have baby again atc. Leigh Brightman called me two mights ago and ha

said that he had never sean the like in his life. That since he had come on TV in support of you that he had people calling him from all over esking him why he got sucked in with us. He said it was like the whole public believed the media smear and that we didn't max need to go to court becuase we had already been tried end convicted in the public mind. The media made no big deal of it wix either --- you would think that they wou be either they ere scared or paid off---- Carolyn Craven at channel 9 hates us and refuses to write on us. ---- I talked to Jeff at the Church of Scientology today and apologized for ingoroning all of his calls and explained that until we can out in the public stamtnet about the Treasury de; men that I ouldn't see giving him a bunch of BS when I couldn't talk about the case. Jeff said that he would send some books over about it and alos some stuff about some of the tihgsn that they have found out through the Freedom of Infomration act. ThenMike gets on the redio end reminds me not to be jovial at the press wax conference which I had no intentionof going to becuase I didn't feel that I could hold together to go that and I thought that it was cruel and crass for Mika to project that we might be jovial when practically everyone of us was taking tranquilizers to maintain to put together this confernes that you wanted to do. press practically gave you a white-out when the banks thing happened and we kenw that no one in the left or establish ment press would interpret this thing fairly .--- we were doing the leg work but didn't feel that

When you gave us two and one half mexex hours to find Doctrr reid before you killed yourslef Debbie and I took turns on the phones calling everything under the eum trying to find him. One would talk while the other one was pulling themselves back together. I don't know if you know the horror I falt when you eaid you would be dead in two and a hald' hours and I wkwxx leared that Reid had just left the hotel and the ecoonest the next person would see him would be four hours later. We had police in three cities working on it. Indiana., Weshington, and Chicago refused. It was the most horrible ultimatum I have ever been given in my life. I did n't tell Irene about it until after the time limit was up and you Please know that I wee wifh you all the had done nothing about it. way --- it was shattering to think about 600 people with no plave to go and no one outside of a few of us who would ever usnderetand. would try to explain to the press but it would be futile. furious that people won't get off their duffs and make Guayana econiomically dependent on us and work on that rather than always going crazy or demanding you/attention on every little matter. I think that it is time that our people grow up. He never told me that he thought you were insane but I did think that he thought that and I should have reported it immediatelybut I was afried to say anything because of the last time that I reported such an issue it was a horrible hasel and I was hoping thatthis thing wouldblow over once he got down to you. I should heve eaid something. 4. I for one pushed Chaiken further than he was capable of being puehed and he didn'tlike the preseure---- I checked virually all decisions withhim and before when there were more people here I didn't do that so much --- I would just find three sound opinions. Chaiken found himslef in the midet axexof everything. 5. I jumped Cheiken last week hard for chenging the dete of the press conference with Dennis Banke from Thursday to Monday and ran him down for doing that without consulting but I was pissed and he saw probably more anger than logical thinking. However we did get the conference when we wanted it. I know that I did alot of things wrong but I NEVER THOUGHT THAT YOU WERE CRAZY SO I NEVER SAID THAT AND I DON'T KNOW WHERE HE GOT THAT. When he called me from Georgetown that one night I was not talking onthe phone to him becuase I didn't think that in my position that I was supposed to get in a dialogue with an attorney who was in a TOS position so I just told

him that he could talk but that I wasn'tgetting into a dialogue. I asked him his reasoning and ended it by saying that that was his opinion and that he should talk to you before reaching such conculddons on his own.

Perhaps he interpreted that as agreement basizally my philosophy is not te get into dilogue with traitors because 'don; t know if I will centiduct what you have said-- I dn'tknow your position and I don't knew if it is wise for me to have anything to dowith a layer who is hostile who happens to be aware of my particular legaleituation so well. So I seid very little--Sandy heard the tape you can ask her.

Another place where I didn't handle situations well is when I was told to get the message to anyone that unless Reid got to you that you would be dead in 2 and one half hours. I took that quite seriously and although I agree with the last stand philosophy Reid was in an airplane when I got the message and I cried not because I disagreed with you but rather becuase I felt like scmething that I was physically unable to accomplish would couse a last stand. My postion from there on in was to do all and anything possible to provide alternatives for you given that if you were tehave a last stand that it wound; t be because of us not finding a place. I frankly remember quite clearly two weeks ago when you told me on the radio that my not relaying a message would cause you all to be be dead. That was when you had wanted me to find Garry to tell him that you were all willing to die if this wasn'; t done and Garry was out of town. I have never cired around Garry but during that brief period of Reid in an airplane and us calking police inthe various cities and Pat was helping us Pet.was en the phone once while I was in tears and I am sorry and I t wasnit out of disagreement but rather because I FELT That it was my fault that I couldn't reach reid and I was fruetrated. I wasn'tdealing even with your strategy because your strategy was so sort timed that there was not time to do anything but take it as true. ----methodoology in getting action probably contributed ro the lack of good PR here as a

result. We had to page Garry out of a conference that he was giving s speach at--- we had to call Dennis back up from LA to Davis--Angles was up well into the night calling people in New York etc ---Dynally was called and called and called -- and Heury and Garry and it was relayed to all of them as a life and death matter. It did get results and the order was recidneded but Thoneslty feel now that we are really going to have to pay for it in PR somehow because I thhink that with the exception of Deniss that people helped to stop you fromfighting not because they felt that you were right. Anyway --- I think that it is good that these people were able to call in and I am glad that the government now realizes what a stink that we can make. Ido hips we can patch up some of our contacts here before anything breaks loose again." I am corry that we fucked it with Chaiken this time. You were so very right when you eaid that I shouldnt talk problems with chaiken or worry him until the time really came for real. PLEASE DON-T SEND CHAIKEN BACK HERE HOWEVER\_ I BINCERELY THINK THAT HE WILL UNDERWINE WITH GARRY.

(Not doing the job you could do if you were here—— but in your absense a leader is needed.). She took estrogen the other day so hopefully her moods will improve. Marcie is ok except between 8-10 in the morning and then it is tears and all the old tunes that you have heard before how she has to take a back seat in your life—only a wife in name for 12 years now, —— how she had to sacrific all for the cause) I am not cirtical —— knowing her background—— but sometimes—— that kind of manic-expect depressive stuff gets me down. I mean I don't know how to deal with someone 51 pears old talking about dying and all. I have deep respect for what Marcie can do and I know she is totally committed and you can trust her more than anyone here— whithout a showdow of a doubt she will never walk —— so I gues it is just selfish of me not to want to hear her complains. B t is is irritating—— because I know people who have suffered more.

SANDY: Non-functional. I Mon; t know how she can live with herslef. She detests marcie -- maybe as much as she detests me ( hard to say on that) She feels that she has to wait on MJ and feels that MJ is weak etc. However-- MJ has done more here in 3 weeks than SB has done in a solid year--- so I would not criticize if I were SB. I couldn't do anything about it before the trip because the trip is sometimes rough in having to carry things etc. and I thought that physically I would do worse than if I waited until I got home. So one the trlp I decided that I better change how I was identifying with you and decided that when I was around you I would just pretend that I was one of your soms rather than getting caught up in giamorizing the trust that you and Carolyn have with each other and more at least that way I could feel acceptance without thining that you have to be in Carolyn's situation to be accepted. So wahen we got back I made it a point each night to show up and x up at dinner Prentend I was tim Wipper and was able in my own wierd way to begin rationalizing a new kind of acceptance. I know this sounds very sick wat at the time I was so hormonally flippy and oger-paranoid BB-7-5,

thar I serimusly thought that the only way that I was going to be able to function with any type of sanity was to just take a few minutes daily outside of working and makex play the role of playing one of your sons so I chose dinner time to do that in. I seel like a fool to know that was the one time that I would be interfering. Anyway knowing that I don't mind at all not comming down during that time. I do think, however, for a few weeks there, that if I hadn't done that that I would have had a much harder time emotionally holding up. I know this is all counter-productive and that I shouldn't be hung up on any kind of acceptance. I know that you would prefer and I wish I were that way to that I follow and work purely out of dedicatin to principle etc. and of course I don't think I would have followed you had I not thought that you were good and right but this is probably wrong but there is a dependance suck of some w ierd variety theomeux there and quite frankly I don't know what to do with it or where to put it. I am only telling you this for background becuase although I know we that all hese feelings are wrong that it may explain why I act the way that I do sometimes. The only thing that gives me any piece of mlnd is knowing that I tink that Carolyn is probably as emptionally involved inx another way as I am in my way. Some of the reasons for my reacti ns and upseted ness except for the fact for the last three days I have been wiped out--- but I have an irrational over-dose of fear of being thrown out. It is not second same or rational feeling at all but I know like some people are ciostrophobic I have an over-insande fear of rejection. The background I think being that with my dad's careeer by the time I was in 9th grade I had attended 15 different schools la 15 different cities or countries. When I \square 16 I moved out. Worked two jobs and w finished high school. After my fist year if college I got really tired of all the hassei, all the drugs, the disorganization and decided to move beck home---I lasted three days before I was absex aksed to leave and live somewhere eise. That was probably the best thing that ever happend to me as it made me BB-7-52 realize that you really are fighting alone. Inever got attached to much after that

I just drifted from place to place for a year. I lieved from time to time with much older men mowed in for a couple months with one man about 40, another about 50 etc. --finially in with some guy la LA who was only about 10 years older but who managed to beat the shit out of me/ throw me out of the house and called stay there for the night but that was a whole sick enviormemnt too. Finially p anhandled enough money to take a bus part way and hitchhike the rest of the way to redwod vallay -- not to see the church -] but because I knew Ben and that he had money and that exactly he would leave me alone. Anyway when you showed me so much love and accretance I not only leaned on it but I feel into it head over heals. . I know that it is wrong and incane and everything else. I guess it boils down to the # fact that I worry cometimes that you and Carolyn and Kimo and the boys and Maria and John and maybe Marcy are all going to move eway someday just because of the pressure of the building etc and I know that that is right and it shouldn't bother me and I know that I will stick if you do it--but I know elso that I now am afreid of that for some stupid I am eure un socialist reason. I know that ideally that all this stuff I am talking about is wrong and I feel gully as hell even having dependencies and hangup and fears and I am surs that if you all left I would be made into a much stronger person. I promise you that I will always work hard whether you are herear here or not. I don't mind being cent away for whatever reasons that doesn't being c bother me. I don't, despite what has been said, think that you and Meria and Carolyn plot aginet me but I guess as I sew Cerolyn and Maria becumeing very close that I felt that it wouldn't be long before you all moved out. It was not paranola over being talked about but just fear that it is just a matter of time before you all move z out. I think in all fairness that you should, that it would be a much better inviornemnt f or all of you with less criticalness and pressuress. And I assure you that I would

What ever the decision is for future planning I'm willing to do as told However I think it would be beautiful of this whole group would make a nonviolent death stand against this government and the murder in Chile of Christman day. The whole county and half the world would be forced to look at the situation and would make hundreds of adults, children and amimalsydie. I am concerned that if we continue just barely surviving in this hostile country that someone will get us on some silly charge and then no one will listen to our socialists stand.
