something about DEWEY which was inaudible to the informant.
After a minute of silence HUMPHREYS stated, "I don't think so.
Two A couldn't make (obscene) with DEWEY. DEWEY was a smart
operator. And DEWEY was surrounded with about one or ten guys
who were all sharp. You know what those guys did when they
left office? They had everything in New York in their hands.
Did you know that? When they left office--when DEWEY moved up--

HUMPHREYS then advised [redacted] on what he should reply to questions put to him by the FBI and following this conversation HUMPHREYS said, "What did [redacted] say, that's my business to talk to everybody. Right there is your opening anytime. What did MARCANTONIO say. My office is open to anybody. And I got four offices. They were all Commies you know. I went up to meet him at his house. He had a junky old house and everything and he says to me: TOMMY BROWN was with me and he was talking to me. He said I live like a Commie and everybody thinks like a Commie, but that's how I got my vote." Then HUMPHREYS stated, [redacted] you look good. Soon be time for Florida, hey boy?" [redacted] said, [redacted] HUMPHREYS replied, "Oh, in a day or so. I go back and forth and then come in for a day or so and then go back and forth, go to Back and forth." [redacted] then said, [redacted] HUMPHREYS said, "My leg is bothering me though." (b)(7)(c)

HUMPHREYS commented, "Yeah, he's a smart operator, this Mayor. He's been nice to us." [redacted] added, [redacted] Then HUMPHREYS said, "Yeah, of course, we've (b)(7)(c)

been nice to him too." [REDACTED] stated, [REDACTED] (F)(7)(C)
[REDACTED] HUMPHREYS then said, "Hey, did you see where we're

second. Eighty-eighth on HOOVER's list." [REDACTED] asked,

when he starts out, you know, about my daughter, is your
daughter nuts, I could have up and powdered the guy, I said no
does yours. Well, who was the head of that Committee that time."
[REDACTED] asked, [REDACTED] HUMPHREYS replied, "No, the Senator,
the other guy. I said I can answer that, if that will be all you
want to hear at the hearings. He said OK. Anyhow we went over
it 99 times, then hoping I'd make a mistake. When it was all
over, this lawyer they have there said: 'Let me ask you one more
question, Mr. HUMPHREYS.' He had my income figures. I said
I answered that question and that's all. Because that was the
agreement." This discussion then ended and the unknown person
left.

HUMPHREYS again took up the Fifth Amendment, and
said, "See, if you're in before the grand jury, if you answer
one question you open the door to a lot of things. Now, if
you would maybe testify there, try to be friendly, you know,
I could talk about narcotics to you, if that's all. But if

you're gonna use that as a stepping stone or to broaden the scope of this inquiry and so forth. Then if he says all right answer that, say I don't know nothing about that, say we're all against it, I'm sorry for the addicts, you know, we're all prejudiced against it. Then if he tries to go a little further on the scope of inquiry, and you don't go any further, it's in the record that he agreed, you understand. You understand? For the judges, you got it right there in black and white. Course, the lawyer tells you when you go in the grand jury room that you can't answer one question. Because if you do, one leads to another. This opens the door to something and you refuse to answer the question that leads to something else. So you've got to be careful. You refused once before, didn't you [REDACTED] An unknown individual responded, [REDACTED] HUMPHREYS added, "Well the best thing for you to do is to do the same thing again. You've already done that, they expect that from you. Why do you think you'd be called in?"

"HUMPHREYS then said, "I've known him for 40 years." The unknown person stated,

"HUMPHREYS replied, "Can't get a change of venue. Once he's taken jurisdiction, once the witness is there to testify, you're dead. You can't change it." then said,

"At this point there are five or six individuals in the room and all are talking. HUMPHREYS answered, "But they got to on it." stated,

"The unknown individual said, "HUMPHREYS then stated, just got it yesterday." The unknown individual then said,

HUMPHREYS stated, "He sure told that Polack off today." The unknown person replied, "."

HUMPHREYS stated, "You know what he did to me. One day he walked up to me and shook hands and said Hi ya Pal and all this and that. When he first started to run. Real friendly. Then he walked away and a guy came up to him and said you know who that was and he said no. He said MURRAY HUMPHREYS. He said (obscene) what did I do that for, I didn't even know him." While other persons present were laughing at foregoing statements, the unknown individual said something about somebody named (phonetic), and then stated, "HUMPHREYS said, "Yeah, he's an man. [redacted] advised that on October 15, 1959, MURRAY (b)(7)(c) HUMPHREYS was in conference with FRANK FERRARO, a prominent figure in the Chicago Crime Syndicate. FERRARO told HUMPHREYS that "He's having BUDDY meet at 22nd and Washington, and he's gonna have [redacted] with him. How can he have [redacted] with him when.... This fella here knows MURRAY. Now [redacted] JACOBSON [redacted] they sat down. Made a deal. You know all that. You should get those two guys, and pinpoint them, and find out what the (obscene) is all this (obscene). Could be [redacted] He's bitter. Wants a job, and they won't give it to him. The County Commissioner." HUMPHREYS said, "Must be an angle there." FERRARO stated, "This is just the beginning. I would say. That guy running back and forth, [redacted] he's learned a lot. He's learned who you were, who I am,.... I don't know how you can get them, [redacted] I gave it to them double barrels." HUMPHREYS then said, "The way we found out, that, he give them tickets for the ball game, and he got tickets from...." Then FERRARO commented, "That could be exaggerated too, uh, [redacted] told me, it could be exaggerated, not through [redacted] but through a guy who told him. Say I give a ticket to [redacted] or somebody. Would that make me nearer him than it would have? Did you hear about the [redacted] calls [redacted]"

HUMPHREYS stated, "The Mayor,.... won't let [redacted] he won't let [redacted] or none, and he does that. FERRARO advised, "(Obscene) knocked out of the box, and ain't got nobody to pick from. See what I mean, [redacted] I'm talking about knocking [redacted] out of the box. [redacted] asked him, and he didn't want it, but since the Mayor asked him, he's gonna take it. I told [redacted] maybe he still won't take it. So maybe with the phone call earlier, he's all right. [redacted] was the best we ever had. [redacted] only, had to go to him only twice in five years."

At this point FERRARO made a phone call, and the (b)(7)(c) following conversation ensued, "Hello, is [redacted] there? Let me talk to [redacted] Yeah, BUDDY, Where's [redacted] I just want to

[REDACTED] advised that on October 19, 1959, MURRAY (b)(2) HUMPHREYS was quite critical of his bodyguard and "runner" HY GODFREY, as follows. "HY, you shouldn't carry a big pad like this. You should carry small stuff you can throw away. You see, you got your copy on here, you see they can read that. You got to be careful of that stuff, HY, don't get careless!"

Following this [REDACTED] (b)(2) advised that HUMPHREYS said to FERRARO, "Listen, don't you think we ought to have [REDACTED] (b)(7)(c) FERRARO answered, "Yeah, I think so." HUMPHREYS stated, "I was gonna go over there this morning but I think I better get rollin' home." Then FERRARO asked, "Did you find out what PAUL wanted? He made a trip to Terre Haute."

HUMPHREYS then made a telephone call to the office of [REDACTED] and as the phone was ringing, the informant advised that he made the following comment aside to FERRARO, "I don't like to call like this," and then stated, "Good morning, Miss [REDACTED] how are you? Fine, fine. Um, hum. Is the bossin? Is he? Well, tell him I'll call him back for lunch. All right." HUMPHREYS then hung up, and asked, "How come you got all these thousand dollar bills here?" FERRARO answered, "That (obscene) EDDY VOGEL." HUMPHREYS replied, "What does he let him do it for? We got to stop that (obscene). You know, that's all right for a little while. He can send that to Las Vegas." FERRARO stated, "That's what I told him." HUMPHREYS then stated, "All of us guys got to run around unloadin' it. I gave some of it to [REDACTED] and I said, [REDACTED] you don't have to do this right away, just one at a time. But that (obscene) can't be givin' it to us every month. Tell him, you (obscene), send it out to Las Vegas and get rid of it. He keeps givin' it to us, and that makes four or five of us doin' the same thing. He's having us errand boys for us, that (obscene). He's been doin' it every month. You tell him, you (obscene), you want to get rid of that, you send it out there all at one time, no (obscene) around. Or twice or three times."

On October 27, 1959, [REDACTED] advised that HUMPHREYS talked to an unknown individual for approximately ten or fifteen minutes on that day and while he was talking to the individual he made a phone call. The informant advised that the following conversation took place. HUMPHREYS asked, "What was the name of that stuff?" An unknown individual answered, "[REDACTED] and [REDACTED] (phonetic)." HUMPHREYS stated, "You were dealin' with that [REDACTED] and [REDACTED] (phonetic), weren't you?" While still talking on the phone to a third party he continued, "On some stuff to buy? No, did a guy die or somethin'? Well, you know they got

over a million dollars worth of that stuff. And, ah, if you could make more money on it than you're makin' now, would you take it? Too high? You did, huh? Yeah, but he's dead, isn't he? What were they askin' for it. Well, there's a fellow with me now, that's why I was callin' you. Couple a hundred a case? Yeah. Ah, he says you're talkin' about some other stuff. Wait a minute, I'll let you talk to him. But don't forget, I'm still thinkin' of you and (obscene) it, you keep me, that's what you used to tell me over the phone. I can't help it about the other guys, I can't help it about your debts. I'm broke. Wait a minute. Here. You know, you may get in trouble, you better think that over."

On October 30, 1959, [REDACTED] advised that HUMPHREYS had a very long conversation on that date with HY GODFREY. HUMPHREYS asked GODFREY, "What are you giving me this for?" GODFREY answered, "I'm gonna show you the outline." Speaking in a low voice he mentioned something about a [REDACTED]

HUMPHREYS then said, "When you go by there sometime, look at the door." GODFREY stated, "And this is [REDACTED] (phonetic), 3327." HUMPHREYS said, "This could be the stool pigeon." GODFREY asked, [REDACTED] HUMPHREYS answered, "Yeah. There was some guy on Sheridan Road was a (obscene) of a crap shooter, I understand. Just look over the building." GODFREY said, [REDACTED] is northwest." Then HUMPHREYS said, "Well, look it over anyway." GODFREY stated, "Thirty-three, ah, that might be the building that [REDACTED] is in." HUMPHREYS replied, "That could be some connection to the thing. Ask [REDACTED] and these guys, they may know a (obscene) like that." GODFREY stated, "Here's one here. [REDACTED] Irving Park and Harlem."

HUMPHREYS then said, "LES and them may make some of these guys." GODFREY stated, "Now I didn't get nothin' on Oak Park. We got three Oak Park numbers." HUMPHREYS replied, "See, if you go by it. There has to be some (obscene) who that's stool pigeonin'. That guy on Sheridan Road, what would be connectin' up there with the guy on Sheridan. It might be that the guy is a crap shooter or somethin' and givin' them information. At this point in their conversation it seems HUMPHREYS apparently is concerned with the source of [REDACTED] information as basis for his recent gambling raids. HUMPHREYS continued, "It could be a relative, or any (obscene) thing. But why would he call there, where he lives at. And he's a fireman isn't he? Let me see that thing a minute. The guy that guy that called. This is the relative of the fireman, see? He has no business up there." GODFREY then said, "I think FRANKIE has got [REDACTED] workin' on it."

HUMPHREYS then asked, "When is [redacted] comin' over?" GODFREY replied, "Should be here shortly. I think around noon. Oh, here he is now." HUMPHREYS said, "Hello, Little Fat Man, how are you? Listen, did you see [redacted]" [redacted] answered, "[redacted]" HUMPHREYS said, "That's all right. You have to give him the money. Have him, these are unlisted numbers, get the names and addresses. Tell him to work on it now." [redacted] replied, "[redacted]" HUMPHREYS asked, "Why?" [redacted] answered in an inaudible tone. HUMPHREYS then said, "He got me a list of numbers in two hours." [redacted] asked, "[redacted]" HUMPHREYS answered, "Yesterday." [redacted] replied, "[redacted]"

[redacted] HUMPHREYS said, "That's the place you have to pay too (obscene) much. You got a (obscene) of a big book. You can use these guys to knock this (obscene) off." There followed a period of whispering.

A little later [redacted] stated, "[redacted]" HUMPHREYS stated, "Bring it back and you keep a copy." [redacted] replied, "[redacted]" HUMPHREYS then stated, "You can handle it. They got a copy. Give it to FRANK." [redacted] then made comments about "[redacted]" and about "[redacted]"

Again there followed whispers. HUMPHREYS continued, "I won't be back here for seven or eight days. I'm gonna take some baths. Listen, don't forget to see that guy."

The names mentioned by GODFREY and HUMPHREYS in the initial part of the conversation are apparently two crap shooters and gamblers who frequent Chicago Crime Syndicate gambling spots and who, therefore, would be in a position to furnish information concerning these locations to the Chicago Police Department or the State's Attorney's office. Apparently the significance of this is that HUMPHREYS is very concerned over the raids conducted recently by the Chicago Police Department and the State's Attorney's office on Syndicate gambling spots even though as far as is known he has no financial interest in these spots. Apparently the object of their discussion is to find the "stool pigeon" who has been tipping off law enforcement agencies concerning these gambling spots."

FERRARO said, "Yeah, every once in awhile. He's hot about the newspapers picking on Italians, and all that. He wants to get on At Random with IRV KUPCINET. When he gets on there, he ain't gonna stop. He's gonna cut loose at them; the press, the police department, tactics, and all that. He's a guy that [REDACTED] said had a small newspaper here at one time that [REDACTED] and these guys were supporting a long time ago."

HUMPHREYS talked in a voice which was inaudible to the informant concerning something about SAM GIANCANA, Chicago top hoodlum, and then FERRARO asked, "What about LES and ROCKY?" HUMPHREYS replied, "Well they must of went to work. Make sure they report everything in. No calls though." (b)(7)(c)
Then FERRARO stated, "I told them to open a nigger crap game over there too." HUMPHREYS said, "Oh yeah, by all means." FERRARO added, "I'm talking about out there, in Joliet." HUMPHREYS stated, "Keep moving it around, one week end here, one week end here, one week end here. See that's where [REDACTED] know all that. I don't. I don't understand the bookies and the gamblin' too well. I never handled it see. Never in 25 years. See, if we get that going, you clean up the First Ward for the [REDACTED] see?" FERRARO replied, "Already he says if worse comes to worse, I got enough. How long is he in, 8,9 months?" HUMPHREYS answered, "We got to get all these guys, that (obscene) State's Attorney's office." At this point in the conversation an unknown individual stated, [REDACTED]

FERRARO said, "He told me to get ready to go to [REDACTED] and he didn't go." The unknown person then said, [REDACTED]

[REDACTED] HUMPHREYS, in a low voice, stated, "The main thing is to find their source. That's what I'm lookin' for now. [REDACTED] is on TV representing the Republican Party. I agree with you, I think

it's him." FERRARO stated, [REDACTED] says to the guy, I'm doin' somethin' I can't tell you about. I think the barrel guy knows what it's about." HUMPHREYS then said, "When we first heard of the barrel guy, we heard he was no good. Remember the muscle was put on him that time, remember?" FERRARO replied, "Truth of the matter is, we've got 2 1/2 years in with him." HUMPHREYS then said, "They raided Michigan, understand? Big deal." HUMPHREYS continued by stating something about downstate New York, and then said, "How come the (obscene) has all those G guys?" FERRARO stated, "When they got the tip off that they were down in Cicero they were furious. [REDACTED] and [REDACTED] were pacin' up and down, wonderin' where the (obscene) we came from."

HUMPHREYS then said, "I think that you're forgettin' that Cicero is Republican." FERRARO said, "That doesn't make no difference, they were after us."

Later during the conversation, that same day, (b)(7)(c) HUMPHREYS stated, "This guy [REDACTED] (phonetic) would be a good man in regard..... FERRARO asked, "Who?" HUMPHREYS answered, "The guy from, where is he from, Michigan?" FERRARO again asked, "Who, [REDACTED]" HUMPHREYS answered, "Yeah." FERRARO replied, "Grand Rapids." HUMPHREYS asked, "Did he shoot craps last night? Did he, up at the hotel?" FERRARO answered, "Yeah." HUMPHREYS commented, "That game should be getting bigger and bigger." FERRARO then said, "I talked to LES about that Monday." HUMPHREYS said, "He says there are only four or five." FERRARO stated, "There's more than four or five." The unknown person replied, "They all are." HUMPHREYS asked,

stayin' in, ah-----. You know there is an investigation
statin' there. It's not a good thing to move into now. Grand
Jury going there. We could go in, but how can we say OK when

VII. MEETING PLACES OF MURRAY HUMPHREYS

[redacted] has advised that MURRAY HUMPHREYS meets (b)(2)
almost daily, when he is present in the City of Chicago, (b)(7)(D)
at Celano's Custom Tailors, 620 North Michigan, Chicago.
It has been established through the use of pretext phone
calls and through the information supplied by [redacted] that,
without exception, whenever MURRAY HUMPHREYS is in Chicago

he spends part of his day at Celano's Custom Tailors.

[redacted] advised that MURRAY HUMPHREYS had a (b)(2) conversation on September 22, 1959, with an unknown person who was discussing the fact that an officer of the Chicago Police Department had apparently become aware of the fact that RALPH PIERCE, former Chicago top hoodlum, was frequenting the St. Clair Hotel, located on the near north side of Chicago. It is noted that this hotel has been known to be controlled financially by the Chicago Crime Syndicate and it has also been observed that many top hoodlums and their associates in the Chicago Crime Syndicate frequent this hotel. As a matter of fact, two surveillances conducted by Agents of this Office during the winter of 1958-1959 placed HUMPHREYS at this locale. It is believed that a suite maintained on [redacted] (b)(7)(c) of this hotel by [redacted]

[redacted] is utilized by the hoodlums for their conferences.

The unknown individual, after telling HUMPHREYS that the Chicago Police Department was aware of the fact that RALPH PIERCE was frequenting the St. Clair Hotel, made the suggestion that [redacted] (b)(7)(c) HUMPHREYS objected to this, saying, "We can go in the back door. If we find a new spot we won't be protected there. You go to that new spot you haven't got protection, see. Like here you're in good. Got protection."

VIII. HUMPHREYS' FIX OF HIS TRIAL IN 1940
FOR CONSPIRACY TO EMBEZZLE BARTENDER
UNION FUNDS

[redacted] advised that on October 30, 1959, MURRAY (b)(7)(c) HUMPHREYS held a lengthy conference with [redacted]

[redacted] and HUMPHREYS discussed this situation in detail, as is reported hereinafter under the caption, "HUMPHREYS' Interest in Fixing the Trial of [redacted]"

Later in that conversation HUMPHREYS and [REDACTED] were discussing the fact that an individual named [REDACTED] had turned state's evidence in the case and was intending to testify against [REDACTED] during the trial. As is reported hereinafter, HUMPHREYS and [REDACTED] feel that they can influence this witness to change his testimony and refuse to testify against HUMPHREYS. At this point in the conversation, [REDACTED] advised that HUMPHREYS gave the following advice to [REDACTED]: "Wait! That's what he can do. He can take and get on that stand. Do you remember when what you call it of the Bartenders did that to us? Remember, he's squawkin' and I got him straightened out? And I said when you take the stand you just answer your name and address. When they ask you do you know so and so, just refuse to answer. Well, he did that. Now listen to me, you got to be careful what I'm tellin' you. That put the case in jurisdiction, do you see what I mean. Now if he refuses to answer that means they have to dismiss the defendants right there. See? They can't bring that up again, ever. See because you're already in jurisdiction of the court. But if he does this before time, then they don't bring it up in the court so they can resurrect it. It doesn't make any difference what he tells them, as long as he doesn't say it in court. Do you understand?"

HUMPHREYS continued, "Listen, I went out to MC LANE himself, and give him money and he says OK. And when they put him on the stand, the State did, and they thought they had a (obscene) of a witness. And they put him on the stand. And I had everybody in that case, I had the jury and everybody, I wasn't gonna depend on him. When he took the stand and they asked him his name and address. I'll never forget that. And when he refused to answer that, the prosecutor went after him a little bit, and then he knew I had him. CRAWFORD knew I had him then. But I had CRAWFORD on that case too. So he just went back and sat down. But CROWLEY jumped up and said I'll beat the (obscene) out of that guy! Order him to answer! Order that man to answer that question! The judge said I can't

order him to answer. And he looked at that guy, right in the eye, and said; why you dirty (obscene), you dirty (obscene)! And he kept on hollerin' for a half hour! And he turned around and looked at us and said if those fellows are innocent, I want them to say they're innocent. He said this man should be ordered to talk. The judge ordered the bailiff over to bring the papers, and the jury never even left the box, they just signed the papers not guilty. And then they brought MC LANE down to the office and they said who talked to you and he wouldn't even talk to them. So they had to let him go. So even if the judge puts him in jail for six months that's worst he can do to you."

It is obvious that what HUMPHREYS is talking about above concerns his trial in October, 1940, when he was indicted for conspiracy with FRANK NITTI, FRED EVANS, and others, based on his alleged embezzlement of \$350,000 from Local 278 of the Bartenders and Waiters Union in Chicago. He and his co-defendants were found not guilty when GEORGE MC LANE, the business agent of the Bartenders Union who had instigated the prosecution, refused to identify the defendants as the individuals responsible for the Chicago Crime Syndicate which took over the Bartenders Union in Chicago, according to MC LANE's allegations. FRANK NITTI was the immediate successor to AL CAPONE when AL CAPONE went to prison for evasion of income taxes in the early 1930s. FRED EVANS was a Chicago top hoodlum who was murdered in gangland fashion in August of this year. CROWLEY, referred to above, was the State's Attorney in office at the time of the attempted prosecution of HUMPHREYS. CRAWFORD apparently was the Assistant State's Attorney who actually handled the prosecution's case.

It is not believed that the JOSEPH FISCHETTI referred to by [REDACTED] is the prominent Chicago and Miami hoodlum. FREDDY is apparently FRED EVANS a former Chicago top hoodlum who was murdered in gangland fashion in August, 1959. It is believed possible that the other names mentioned above by HUMPHREYS and [REDACTED] are officers of locals of the International Laundry Workers Union throughout the country and that the object of the conversation was to take some of these officers out of office and place others in office.

XIV. HUMPHREYS INTENTION TO SURRENDER TO THE CHICAGO POLICE DEPARTMENT FOR QUESTIONING IN THE FRED EVANS MURDER CASE (b)(2) (b)(7)(c)

[REDACTED] advised that on October 27, 1959, MURRAY HUMPHREYS made a phone call to an unknown person and advised this person first of all to get a hold of the FBI and find out what the (obscene) they want. This information has been reported in detail hereinabove under the caption "HUMPHREYS Concern With the FBI Investigation of Him". Inasmuch as it was [REDACTED] who contacted the FBI Office on October 28, 1959, concerning HUMPHREYS request, it is believed that it is obvious that it is [REDACTED] who HUMPHREYS was talking to. Following HUMPHREYS instructions to [REDACTED], if that is who it was, to get in touch with the FBI, HUMPHREYS then gave the following instructions, "So, ah, yeah, and then, ah, who was that Captain out there where FREDDY EVANS

 got killed? Well, whoever's in charge of that case. He must be. He was, I know, [redacted] went in there, or ah, [redacted] or [redacted] or someone went in there, and he interviewed him and let him go and I understand I'm wanted by that, by Scotland Yard. All right."

And [REDACTED] We got together, and we're working it out." HUMPHREY then replied, "Poor [REDACTED] We got him into so much trouble. I'll never be able to repay that guy, for the things he's done. You know, one time I was in Florida with his brother, what's the name of the place anyhow they have ribs, we were drinking there, and in come [REDACTED] brother, and the Auditor, and he brought this guy past my table, so I said uh, he said, uh, I object to that kind of language and uh, (obscene) I didn't see PAUL when he come back, near the end there, we were trying to help him get out, you know."

It is noted that this notariety caused the [REDACTED] and [REDACTED] considerable concern. The PAUL referred to by HUMPHREYS is believed to be PAUL RICCA. VOGEL then said, "No, that's a (obscene) good place for a guy to go that wants to get lost." HUMPHREYS then commented, "don't forget that when I was sick, I lived there. When I was real sick, that's where I went. Then I got pneumonia, and I had to leave there. You know, I'm not going to tell anyone what I'm doing. I gave them a bum story." (b)(2)

In view of the information furnished by [REDACTED] (H)(7)(C) concerning the regular commercial airline flights of HUMPHREYS and in view of the above investigation it is not believed that HUMPHREYS owns a beachcraft airplane nor does he utilize the services of a pilot named [REDACTED]. Although it is noted above that HUMPHREYS chartered an Apache airplane out of Hot Springs, Arkansas, on his return on November 15, 1959 to Chicago, it is believed that the only reason he chartered this private plane rather than fly on a regular commercial airline as he ordinarily does, was due to the reason that he was transporting RALPH PIERCE, former Chicago top hoodlum who was in serious condition with numerous broken bones, back to Chicago, and that it was in deference to the physical condition of PIERCE that he used this mode of travel. It is noted that details concerning HUMPHREYS chartering of the airplane from Hot Springs is set out under the caption above, "Associates" and the sub-caption "RALPH PIERCE".

For the information of the Miami Office, this airtel instructed the Chicago Office to promptly set forth leads for the Miami Office to determine the location of HUMPHREYS place of residence in Florida and the extent of his activities there. Re Bureau airtel noted that the Chicago Office has previously requested limited inquiry on the part of Miami in view of the possibility of exposing Bureau's source [REDACTED] but instructed that "immediate consideration" should be given to further efforts to develop information concerning this phase of HUMPHREYS activities. Re Bureau letter also instructed that the Bureau should be advised of the leads set forth for Miami.

In consonance with re Bureau airtel the following leads are being set forth for the Miami Office:

The Miami Office has previously been advised concerning all information obtained by [REDACTED] from HUMPHREYS concerning his residence in Florida and is aware that HUMPHREYS left Chicago for Florida on 12/15/59 and intended to remain there until 1/6 or 7/60. However, the Chicago newspapers have been full of the desire of the Chicago Police Department and of the States Attorney's Office in Cook County to locate HUMPHREYS for questioning in regard.

2. Attention is drawn to the fact that HUMPHREYS has indicated in conversation in the past that he is (b)(2) residing in a hotel in the Miami area but in a hotel which is not located in Miami Beach. He has advised (b)(7)(D) that he is paying \$305.80 a month for the pent house in this hotel; that the "head manager" there knows who he is and that "the son of the contractor who owns the Empire State Building" is in on it. He also has indicated that he stays away from Miami Beach except on rare occasions. It, therefore, would appear that HUMPHREYS must maintain his residence either in Miami proper, Coral Gables, Hollywood or one of the other close suburbs of Miami. The Miami Office is requested, therefore, to use its discretion as to what hotels HUMPHREYS is possibly residing in and that after a determination is made of the possibilities in this regard, to make a canvass of these hotels. It is noted that HUMPHREYS reference to "the son of the contractor who owns the Empire State Building" is obviously a reference to [REDACTED]

It is not expected that HUMPHREYS would be using his true name at the hotel and he has used so many aliases that speculation as to a pseudonym utilized in this regard by HUMPHREYS is impossible of speculation. He used the name [REDACTED] in December while traveling from Hot Springs to Chicago. It is also noted that HUMPHREYS has indicated that he hopes that the FBI does not contact the hotel officials where he resides due to the fact that it would frighten them substantially. It is, therefore, not known whether these officials would cooperate with the Bureau, but it would seem that the contact at the hotels should be made with "the head managers" since it would be logical to feel that if HUMPHREYS is residing under an alias they might be the only ones to know his true identity. The Miami Office has previously been furnished photographs of HUMPHREYS.

3. Appropriate coverage at the restaurant of SONNY CAPONE should be effected. It is noted that the Miami Office has previously been advised concerning HUMPHREYS discussion of this restaurant but in summary it is noted that [REDACTED] has advised that HUMPHREYS indicated to SAM BATTAGLIA that he tries to help SONNY CAPONE out by frequenting his restaurant in Miami Beach and that he has instructed the remnants of the CAPONE mob, specifically JOE FISCHETTI, to patronize SONNY's restaurant. The Chicago Office will continue to endeavor to keep the Miami Office advised when HUMPHREYS is in Chicago and when he is in Florida. As of this date [REDACTED] has indicated that HUMPHREYS remains in Florida. This office will also continue to attempt to surveil HUMPHREYS and determine his travel plans when it is learned that he is contemplating leaving Chicago, similar to the efforts of the Chicago Office on the occasions when it was known that HUMPHREYS was traveling to Hot Springs and when he left (H)(2) (F)(7)(D)

Chicago for Florida on 12/15/59. However, HUMPHREYS is extremely conscious of the FBI investigation of him, as set out in recent reports, and exercised great caution including counter-surveillance measures when leaving town, going to meets with other hoodlums and on other such occasions. However, Chicago will be as much assistance as is possible to the Miami Office in this regard.

The Miami Office should keep in mind that HUMPHREYS wife, the former JEAN STACY, apparently spends 90 per cent of her time in HUMPHREYS Florida residence and investigation by Miami should be conducted on that basis. [REDACTED] (b)(7)(c)

The photograph of HUMPHREYS previously furnished to Miami is an extremely good likeness of him. It is noted that HUMPHREYS never wears a hat. HUMPHREYS:

"Hello. How's business? You get a lot of paying clients. That's what I called you about. I'm calling in regards to your bill at Celano's. He needs it very bad. I'm a collector now. Will you take care of it for me? Fine. You try to take care of that, [REDACTED]". (b)(7)(c)

HUMPHREYS hangs up the phone and said to [REDACTED]

Following this conversation an individual believed to be SAM "TEETS" BATTAGLIA, a highly placed member of the Chicago Crime Syndicate, came into the room. The following conversation between HUMPHREYS and the individual believed to be BATTAGLIA ensued:

HUMPHREYS: "Did you see this letter that come in? We took a vote on it yesterday. Go ahead and read it. That other letter is from RALPH CAPONE. What do you think?"

BATTAGLIA: This other letter from RALPH. It more or less lets you know.

HUMPHREYS: When he talked to me, I says, listen, I think it's his place to give you a hand. I think you should go to him. We've got a big enough family. You're not the only one. This letter is a copy of it. Now, I've got that in Florida. We took this up yesterday, I don't think you sat in on it. Of course, it's only my place, I can't pass judgement. I have to go to everybody else, you know, of course I have my own opinion, but I don't have any right to render it without going into it. If PAUL was here, I don't know what he would say. At one time he was fooling around down there, got a girl across the street. I don't know, how serious it was, I wouldn't be able to judge. When I brought it up yesterday, they told me he bought the girl a fur coat and such as that. I know that PAUL went after him about fooling around with the girls. I'm broad minded on a thing like that.

BATTAGLIA: I go myself, so don't

HUMPHREYS: Well, I mean, you got to be broad minded; using a thing like that to reject him, so, PAUL always handled that, but when PAUL went away, he said we used to give them each so much money you know. And she'd drive [REDACTED] crazy, because she's borrow on her money ahead of time. And I think it's on

I just wrote him a letter back. It'd be better for us to give him just so much a week. So, he met me here, and one thing I didn't like about it he was in the hospital I went over and talked to him and he had that ear operation. He's very outspoken, what he wants. His wife talked to me, she knew all the story. She is a nice woman, though, but I didn't like it. So then I told them I would take it up, and then, so, uh, he started telling me he talkedso what could I say. There are a lot of our people in trouble, there are a lot of widows to take care of, and I said we got a big overhead, and we don't feel responsible for the sons. We do

on their character, but not in their finances. I figured I better hit them why talk, although I hated to say it. So now I'm writing them a letter and telling them.

BATTAGLIA:

Supposing let's say, we give him the money, you think it's going towards the business? It's a bad business, isn't it.

HUMPHREYS:

Well, he said last year, when it was cold there, there was no business. I always go in there. I don't know if you guys know it or not, but I always watch our guys anyhow. I always tell the guys, if you don't like the food, go there and spend some money. So like JOE FISH and other Italians I say, hey, JOE, don't you forget SONNY, you know, he's part of the family. He says, well these other guys screw off, but I says, but they don't come first. And I didn't order him to do it, I just tried to remind him.

You want my opinion? What does it run, do you know?

If it was me, and speaking for myself, now, I would give ten. In other words, you're taking him off the book, so he can operate. Now, if he's gonna have a good year, he's in good shape. If he's gonna have a bad one, whatever you give him, he might accumulate another debt. He's back where he started from.

Yeah, but here's an ear operation. No ear operation costs 5 thousand dollars. Then he names all these debts, and it's an unreasonable request.

I know. I was there one night. I went with BOOTSIE. Then the kid got me to one side, and said, SAM, I don't want you to hear this, but I'll tell you.

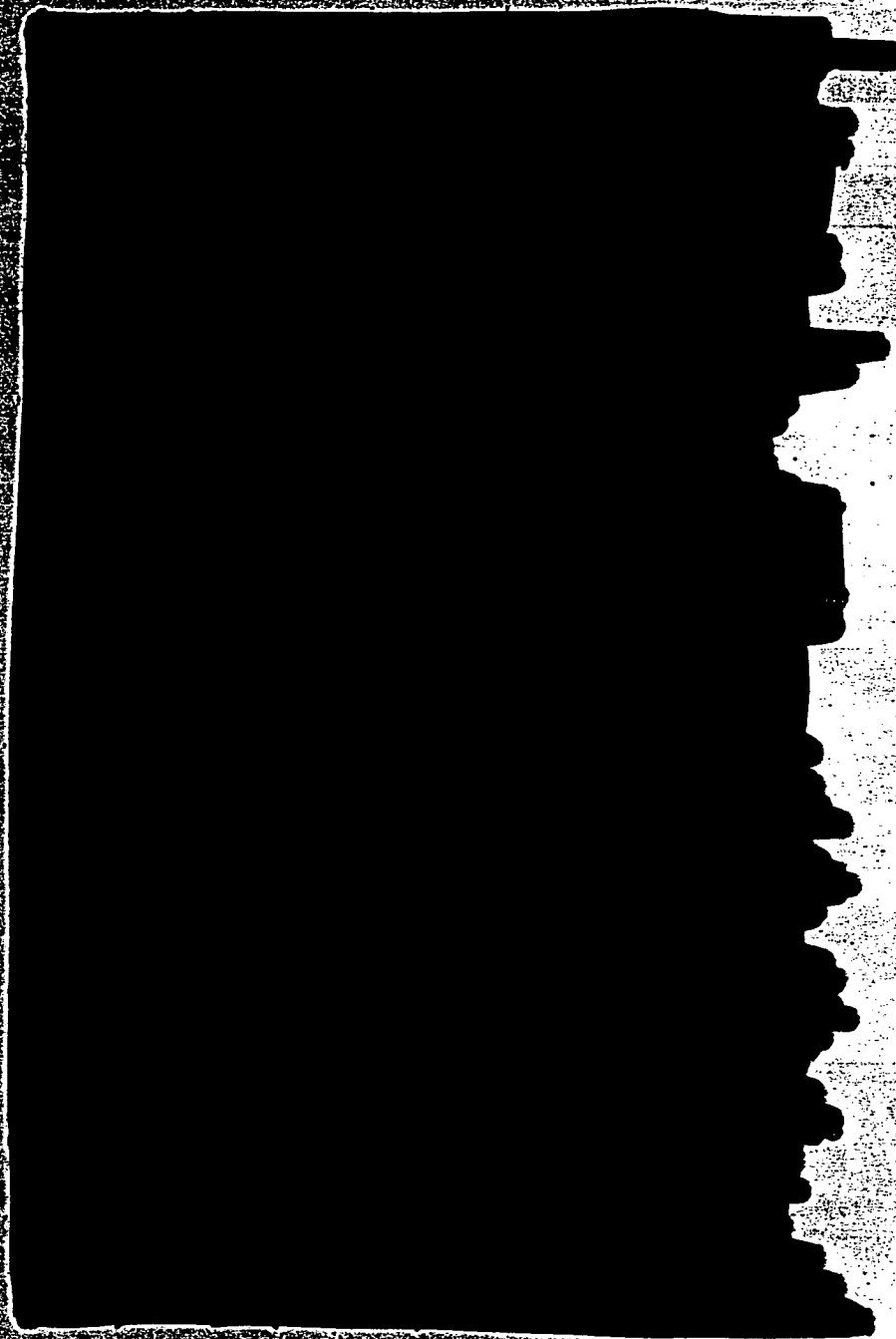

At the outset of the conversation, it is obvious that [REDACTED] is speaking concerning his heart attack, which occurred in October, 1959, while he was visiting Miami, Florida.

The main topic of the conversation between HUMPHREYS and [REDACTED] concerns a contemplated attempt on HUMPHREYS' part to obtain an interest in the Riviera Hotel and gambling casino in Las Vegas, Nevada. It is obvious that HUMPHREYS desires at least five points at \$20,000 a point.

The conversation which took place between [REDACTED] and HUMPHREYS at the end of their conversation concerned the attempts by [REDACTED]

On December 11, 1959, MURRAY HUMPHREYS had a conference with FRANK FERRARO, Chicago top hoodlum. HUMPHREYS asked FERRARO if he could, "reach out and see if you can get him. He was supposed to be here by 11:30." It was obvious that he was speaking about SAM GIANCANA, Chicago top hoodlum.

HUMPHREYS then had a conversation with an individual who was believed to be SAM BATTAGLIA, a prominent leader of the Chicago crime syndicate on the West Side of Chicago.

Apparently BATTAGLIA and HUMPHREYS did not desire their conversation to be overheard by anyone else who was either in the room with them, such as FERRARO, or by anyone directly outside the room. As a result, their conversation was mostly inaudible, but the following was noted by the informant:

HUMPHREYS: Well, if he moves every day, how are ya gonna chase him down?

BATTAGLIA's answer was inaudible but he was heard to whisper something about 19 E.

HUMPHREYS: No, they couldn't put them in 19 E because there are guys next door they don't know.

BATTAGLIA: Yeah, but they could be there unbeknown to.....

HUMPHREYS: Sure, but that's far fetched.

BATTAGLIA: Far fetched, yeah, but.....

HUMPHREYS: Don't be an alarmist about it. [REDACTED] keeps talking about the phone all the time. I know they are there but let's say we went someplace else, where would we have the protection we've got there?

BATTAGLIA: Nowhere.

HUMPHREYS: All right, so at least we've got everybody, even the owner, see.

BATTAGLIA: You've got something going, no question about it.

HUMPHREYS: The danger in the spot is putting too much confidence in the operators. FRANKIE is the one that does that. I talked to him the other day. He only gives the operators five a month. I said, FRANKIE, you'll never get by that way. You'll have to give them money. You want people on your side, you'll have to give them something. Sure, the boss tells them to go along, but if someone offers them one hundred dollars, what do you think they're gonna do? So, I said, you oughta raise those girls a hundred dollars for a Christmas present, and he said, okay, I think I will. That's up to him. You can't give them too much, but if you give them twenty dollars a month, see, that's cheap for you to protect yourself. What's the use of kidding. If you give them too much, they depend on it. But then if you get an important call, then you gotta get off your ass and go out and call. You know because

any conversation goes out on the telephone, now SAM, say you should talk to me, then I'd know you right away. Just say hi, or what is it. I'll see you over at [REDACTED] with a bum name, and that's all the conversation. Now, they'd have to figure out that conversation. All right, the next time you call, you say hi, you understand, I won't be..... They don't know who the hell it is, do they? They don't know, but then they may get your voice after a while, see. You have to give them credit for something. Of course, the Government is famous for breaking down codes. That's nothing for them to break down codes. If you use a code on them, in a little while they'll work it out. But it may take them sometime. Now, take..... He's a lazy (obscene). He's out in Cicero. He says this guy was over today and says this and says that, or [REDACTED] did this or that, and then he's putting the finger right on you, see? Because he's lazy and didn't come down. All he has to say is I want to see you, where can I see you? All he has to say is the tailor's. Everybody knows about the tailor. At one time we used to have one, two and three and four and we'd change back and forth, but that was amongst ourselves. A check made of the records of the United States District Court for the District of Columbia, by SA [REDACTED] on November 16, 1959, reflected that in the case of the United States vs. MURRAY L. HUMPHREYS, 7710 Burnett Avenue, Chicago, Illinois; that HUMPHREYS had been indicated on July 1, 1952, by a Federal Grand Jury, Washington, D.C., for violation of Section 192, Title 2, United States Code.

The indictment charged that on May 28, 1951, HUMPHREYS appeared as a witness before a Subcommittee of the Senate Special Committee to investigate organized crime in interstate commerce and unlawfully refused to answer pertinent questions regarding his activities.

The above records reflected that HUMPHREYS' pled not guilty to the above charge on July 11, 1952, and waived a trial by jury.

On October 30, 1952, HUMPHREYS was acquitted by the Judge of the above charge.

The "Chicago Sunday Tribune" on page one, column 8, part 1, in its issue of December 20, 1959, carried an article entitled: "Police Seek Humphreys For Grilling". This article, which was subcaptioned: "Believe He Had Most to Fear", is quoted below in its entirety.

"Roger Touhy's enemy, Murray (The Camel) Humphreys, has become a prime suspect of police who are investigating Touhy's murder, THE TRIBUNE learned Saturday.

In exploring the hatred that existed between the two prohibition era gangsters, police have found that of all Touhy's enemies, Humphreys, an elder statesman of the Chicago crime syndicate, had the most to lose if Touhy stayed alive.

Worries Syndicate

Detectives told THE TRIBUNE they are convinced that Touhy made no move to return to the rackets in the 23 days he lived after his release from Stateville prison after serving 25 years for kidnapping John (Jake the Barber) Factor, a crime denied by Touhy.

But the syndicate's knowledge of what he did in the 47 hours of freedom he had in 1954, after his release by a federal court, may have prompted Humphreys and others of the crime syndicate high command to take no further chances with Touhy, police said.

The story of what Touhy accomplished in those 47 hours, when he supposedly was resting in rural northern Illinois, has been uncovered by THE TRIBUNE.

Contacts Old Pals

During that period, Touhy was in contact with some of his old gang pals, some of the hoodlums he led back in the 1920s and 1930s when he was boss of the underworld in the northwest segment of Cook County.

These hoodlums urged him to come back to the rackets in opposition to the successors of the old Chicago Capone gang - and Humphreys, who then was a leader among organized criminals.

In addition, a few labor leaders, desperate because of the domination of Humphreys, Joey Glimco, and other men who succeeded Capone, offered money from their treasuries to Touhy, plus whatever political connections they might command.

Offer Touhy Backing

Back in the 1920s, Touhy had enjoyed considerable influence among the teamsters and other unions who saw in Touhy a lesser evil than in the Chicago Capone gangsters.

The backing offered to Touhy, which ultimately became known to the crime syndicate, did nothing to increase Humphreys' peace of mind or decrease his hatred for Touhy.

The threat of Touhy's renewed resistance to the syndicate collapsed when Touhy was returned to prison soon after he had been ordered released by the late Judge Jehn P. Barnes of federal District court. Barnes had ruled Touhy was framed on perjured testimony in the 1933 kidnaping of Factor, who then was an internationally known swindler. A higher court reversed Barnes.

Angers Humphreys

There is no doubt, investigators said, that Touhy's tentative moves to regain power in 1934 angered Humphreys.

As a result of the new developments, Police Commissioner Timothy J. O'Connor ordered detectives to question Humphreys, who is reported taking life easily either in Tucson, Ariz., or New Orleans.

O'Connor also ordered a roundup of the crime syndicate's 'young bleeds'. A detective bureau squad commanded by Sgt. George Durcovic headed for hoodlum haunts to arrest them.

Ambushed Wednesday

The 'young bleeds' include Sam (Mooney) Giancana, Gus (Slim) Alex, Sam (Teetz) Battaglia, Charles (Chuck) English, Joseph (Crackers) Mendino, William (Potatoes) Daddano, Albert (Obbie) Frabotta, and Felix (Milwaukee Phil) Alderisio.

The police activity followed by one day Touhy's burial in a family plot in Mount Carmel cemetery. Touhy was cut down by shotgun blasts from two, or possibly three, gunmen who ambushed him and a companion Wednesday night in front of his sister's home at 125 N. Lotus Av.

Touhy died an hour later in St. Anne's hospital.

His companion, Walter Miller, an ex-police sergeant, was reported in good condition Saturday in Loretto hospital, where the last of five shotgun pellets was removed from his body.

Old Time Enemies

The enmity between Touhy, a tough young Irish-American, and Humphreys, who sometimes uses his middle name Llewellyn, started in prohibition days when Humphreys joined the Capone gang.

When Humphreys took over as chief of Capone's labor rackets division, he and Touhy fought over who would control Chicago unions, among the richest prizes of the underworld.

Then, in 1934, Touhy was convicted of the kidnaping a year earlier of Factor, who was wanted for a 7 million dollar stock swindle in England.

Touhy Denied Guilt

Touhy always contended he didn't commit the crime. He said he was framed so that the crime syndicate hoodlums could get him out of the way and gain domination of the labor unions.

In the years before Touhy went to prison, Humphreys and Touhy tangled many times. Once, Touhy said, Humphreys tried to set him up for a Capone gang assassination. Touhy frustrated the plot.

Another reason for Humphreys' fear of Touhy was the possibility of Touhy reawakening a lot of memories which were stilled while Touhy spent 25 years in prison.

Achieves Obscurity

In that period, Humphreys attained a certain amount of obscurity. Few policemen today, except old hands, know him by sight.

Humphreys now is 56. His hair, once black, is now gray. When in Chicago, he lives in a Lake Shore Drive penthouse. His banking and shopping are done on Michigan Avenue. He sometimes visits Rush Street taverns.

By spreading the fiction that he has retired from the rackets, Humphreys escapes official notice. As a matter of fact, he is one of the most powerful of crime syndicate bosses. He acts as a contactman and lobbyist for the syndicate.

Murray the Actor

Humphreys' last public appearance of newsworthy significance took place in April, 1958. He was subpoenaed then to appear before a federal grand jury investigating organized crime. He appeared at the federal building wearing a frayed coat and a patch over one of his eyes. He hobbled into the courthouse on a cane, and announced that he was a crippled old man.

He fooled just about everyone - reporters, federal marshals, and a few jurors.

Later he left the federal building, discarded his raincoat, and toured Rush Street, laughing with friends, over his prank at the courthouse.

Police said it was possible that Touhy may have been in contact with Humphreys during his 23 days of freedom. A check of long distance calls to and from Touhy's sister's home was begun by detectives.

Witnesses Hear Car

In addition, detectives checking the neighborhood of Touhy's fatal wounding, turned up two witnesses who reported hearing the sound of a car speeding off Wednesday night, shortly after they heard what they thought was the backfire of an auto.

The witnesses, Miss Agnes Hoy, 131 N. Pine Av., and Mrs. John Casey, 115 N. Pine Av. told police they heard the car going down the alley between Pine and Lotus Avenues. This is the alley into which the killers apparently fled after they cut down Touhy and Miller.

Capt. Russell Corcoran of the Austin police district said he had been in contact with federal agents Saturday and expected to receive pictures taken of professional crime syndicate killers taken throughout the country in recent years.

The pictures will be shown to residents of the neighborhood.

Find Basement Lookout

Lt. Daniel Dragel of the police crime laboratory said that his men had been unable to obtain fingerprints from the window of a flat building basement across the street from Touhy's home where a mysterious man reportedly watched 10 days before the murder.

Dragel said there was no doubt that the basement had been used as a lookout by the killers but that they apparently wore gloves. All that was found on the window were a few smudges, he said.

The "Chicago Daily News", on page 6, column 1, of its issue of December 18, 1959, carried an article entitled: "Was Touhy Blackmailing 'The Camel'?" This article is quoted below in its entirety:

"The theory that Roger Touhy was killed because he tried to blackmail syndicate labor racketeer Murray 'The Camel' Humphreys was under study by Chicago detectives Friday.

Police have been informed that the tough-talking Touhy had given Humphreys, an aging Capone syndicate bigwig, this ultimatum:

'Cut me in or you'll be in trouble. I'll talk.'

Detectives said they were told Touhy had already had one chat with a federal investigative agency, possibly concerning Humphreys.

The information reached police more than a week before Touhy's murder Thursday night.

Touhy reportedly had scheduled a second similar conference soon.

Detectives were told that if Humphreys failed to meet Touhy's demands before that second meeting, Touhy warned he would 'really open some of the G-men's ears'.

Two agents of the federal Alcohol Tax Unit conferred Thursday with Capt. Russell Coreoran of the Austin district.

It was in Coreoran's district - at 125 N. Lotus - that two gunmen fired six shotgun blasts Wednesday night.

The fusillade ripped a fistsized hole in Touhy's left leg, mortally wounding him, and critically injured retired police Sgt. Walter Miller, Touhy's bodyguard.

After talking with the federal agents, Coreoran conceded:

'Yes, I'd like very much to talk to Murray Humphreys. But we don't know where to put our hands on him.'

Humphreys usually hangs out, when in Chicago, around 67th St. and Stony Island.

He appeared before a special federal racket grand jury in the spring, and was never released from his subpoena, so that he can be recalled, said Richard B. Ogilvie, special assistant U.S. attorney general.

U.S. Attorney Robert Tieken professed ignorance of the role played in the investigation by the federal agents.

He said they might have been checking the possibility that the gunmen used sawed-off shotguns. Federal law limits their use to police agencies.

Detectives were reluctant to be quoted by name as to action being taken to locate Humphreys.

They said the reaction of top police officials to the slaying has made it 'dangerous' for detectives openly to discuss the syndicate implications in Touhy's assassination.

After the gang-style slaying Mayor Daley commented, 'This is just another murder'.

Commissioner O'Connor said it wasn't a syndicate job because 'there is no syndicate in Chicago.'

Bitterness between Humphreys and Touhy dates back to the days when Touhy bossed some of the most feared guns on the North Side and Humphreys was a rising star with the rival Capone mob.

Touhy always said Capone men helped local and federal officials in what Touhy called the phony kidnaping of John 'Jake the Barber' Factor.

He contended the 1933 gang-style 'snatch' of Factor was trumped up strictly to railroad him into prison.

And he contended it was Murray Humphreys who squired Factor around in Lake County, Illinois, helping him keep out of sight during the time Factor was supposed to be kidnaped."
