

[REDACTED] (b)(2) advised on February 17, 1960, that MURRAY (b)(7)(D) HUMPHREYS made a reference to "our" hotel in a manner which led the informant to believe that he was speaking about the St. Clair..

[REDACTED] (b)(2) advised on February 22, 1960, that on (b)(7)(D): (C) that date, MURRAY HUMPHREYS had a conference with [REDACTED] of Local 134 of the International Brotherhood of Electrical Workers whose identity was unknown to the informant. The purpose of the conference was for HUMPHREYS to request [REDACTED] of Local 134 to contact [REDACTED] of Local 134, in order that a friend of the manager of the St. Clair Hotel might receive a permit from Local 134 to work as an electrician. HUMPHREYS explained his interest in the manager of the St. Clair Hotel as follows:

"But you see, those people around that hotel have always been close to me. The manager is a guy like us guys. Been around for 30 years. He's a guy you can talk to. You can talk to him for anything".

It is noted that HUMPHREYS apparently refers to (b)(7)(C) [REDACTED] of the St. Clair who has been known to be an associate of hoodlums in the Chicago area and in the Miami area for several years.

Informant also advised that on that date, HUMPHREYS (b)(7)(C) made a telephone call and asked to talk to [REDACTED]

[REDACTED] (b)(2) advised on March 3, 1960, that on that date, an individual who apparently was a hoodlum from out of town, contacted [REDACTED], an associate of Chicago top hoodlums (b)(7)(C): (D) and asked him for the telephone number of the hotel. [REDACTED] gave him the number Superior 7-4660 which is the number of the St. Clair Hotel. This unknown hoodlum then made a telephone call to that number. It was not clear who he asked for but he advised that [REDACTED] It would appear that this hoodlum felt that inasmuch as the individual whom he intended to meet was not where he expected him to be, he might possibly be at the St. Clair Hotel.

[REDACTED] advised that on March 8, 1960, FRANK FERRARO went over the expenses which were incurred during the month of February by his bodyguard and runner, HY GODFREY. During the course of the conversation, it became apparent that GODFREY was given a "thousand dollar bank roll" every month in order to meet the expenses incurred by him in running errands and making telephone calls for the Chicago top hoodlums.

In tallying the bills submitted by GODFREY in explanation for his expenses, FERRARO was heard to comment, "St. Clair, cab, \$85.00".

GODFREY apparently was used to meeting FERRARO in the lobby and in order to confirm FERRARO expected to meet him in the usual place, he then asked "the St. Clair?" and FERRARO replied "Better make it second floor". GODFREY then asked "What do you want to do if he doesn't show? Now if he's in there at 3:30 that means I gotta meet you and see you tonight". Informant advised that it was apparent to him that FERRARO and GODFREY intended to meet someone at the St. Clair Hotel at 3:30 p.m.

It is noted that GODFREY referred to a news special which was on CBS television network on the evening of January 19, 1960, concerning the activities of top hoodlums in the United States. The activities of MURRAY HUMPHREYS were prominently referred to during this program.

[REDACTED] advised on February 17, 1960 that on that date MURRAY HUMPHREYS had a conversation with HY GODFREY and referred to the fact that he used to work out at a YMCA where he would "always take and bring my waist down about an inch, then I'd swim hard or anything like that, you know, but I haven't got the wind anymore." [REDACTED] advised on January 26, 1960, that on that date MURRAY HUMPHREYS that a conversation with [REDACTED], and that during this conversation HUMPHREYS made the following remarks: (b)(2) (b)(7)(C):1

"Do like I used to do when I was young, when they'd whack me like that, I'd wait a little bit and when the guy wasn't looking I'd whack him one, then I'd get killed but I'd make sure I'd get that one good punch... One time when I was down at the station, I got my foot up against the wall and boy I hit the guy and boy did I have bumps all over me."

This deed was given subject to a mortgage made by HAROLD OLSON and RUTH ELIZABETH OLSON, to the Chase Federal Savings and Loan Association, dated September 2, 1958, filed September 3, 1958, recorded under Clerk's File Number 58R135036, security the original indebtedness of \$30,000.

The document was signed by HAROLD OLSON and RUTH ELIZABETH OLSON. It was witnessed by CLAIRE DOUCET, and W. B. WHITMAN, and filed April 27, 1959. It bore \$83.00 in Florida State Stamps, indicating it cost \$41,500.

The deed was witnessed by DOLORES HANLEY and ANNETTE JUSTAK, and notarized at Chicago, Illinois, May 25, 1959, by MARY ANNE THOMAS.

The document was filed June 8, 1959. It bore \$60 in Florida State Stamps, indicating it cost \$30,000. The address for this piece of property is 353 NE 26th Street, Miami, Florida.

II. CRIMINAL ACTIVITIES

SAMUEL M. GIANCANA

The "Chicago Daily Tribune" in its issue of March 11, 1960, carried an article on Page 3, Column 1, Part 2, entitled "Link Murder to Dope Ring in Seizing Trio" and sub-captioned "Claim Skally Vouched For G-Man Buyer". This article is quoted below in its entirety.

"The County grand jury will being an investigation of the murder of William Skally, master counterfeiter and hoodlum, it was learned Thursday in the wake of the arrest of three crime syndicate hoodlums engaged in the narcotics traffic.

"Skally, 50, of 1300 N. Laramie Av., was shot to death Jan. 6 in the parking lot of Concordia Teachers' college in River Forest.

"Federal investigators who rounded up the three hoodlums charges Thursday that Skally was the liaison agent between the dope ring and Sam (Mooney) Giancana, operating boss of the crime syndicate in Chicago. They said he was killed because he vouched for an undercover agent who made a big purchase of heroin.

"Dope Bought From Gang

"Arrested by federal narcotics agents Wednesday night were Anthony DiChiarinte, known as 'Tony D.,' of 6455 Longmeadow dr., Lincolnwood; Salvatore Pisano, 5417 Jackson Blvd.; and Spartico Mastro, 834 N. Harlem av., River Forest. DiChiarinte, an ex-convict, was named by the agents as the leader of the dope ring. They reported that undercover men

had purchased \$15,000 worth of pure heroin from the gang since last summer.

"The three defendants appeared before Judge Joseph SamPerry in federal District court and entered not guilty pleas. Judge Perry set Mastro's bond at \$1,000 and continued bonds for the other two at \$25,000 each. He ordered trial of the case March 16 before Judge Walter J. LaBuy.

"Skally, the federal agents said, was a close friend of the three defendants and also of two other runners now under indictment. They are Carl Fiorito, 37, of 8248 N. Ozark av., Niles, and Theodore De Rose, 52, of 18 E. Elm st., said to have sold \$6,000 worth of heroin to undercover agents.

"The federal agents said Thursday that all of these men were part of a general narcotics operation conducted by the crime syndicate under Giancanna's direction. The drop ring operated directly for Giancanna, the agents said, and federal men are pursuing other links to the narcotics traffic in Kansas City, Los Angeles, Cleveland, and Detroit.

"Since 1953, agents said, there have been three murders within the dope ring.

#### "Link Skally To Fiorito"

"Skally vouched for a government agent who made a large 'buy' of heroin from Fiorito and others in the ring, the narcotics agents asserted. He told his wife on the night of his death that he was going to meet Fiorito, they added.



"Skally told members of the gang that the undercover agent was a hoodlum whom he has known for many years, and that was his fatal mistake, the agents said. Skally had been 'working both ends toward the middle,' they added, informing for the government and at the same time doing chores for Giancana as liaison man.

"Joseph (Joey) Iacullo, 35, of 725 S. Loomis st., now serving a five year sentence in prison for the possession and sale of narcotics, headed the dope ring when he was seized, the agents asserted. He was succeeded by Joseph Bruno, 47, now serving eight years in Leavenworth penitentiary for the same offenses."

It has been determined that ANTHONY DE GRAZIO, a Lieutenant with the Chicago Police Department, and his wife accompanied ANTHONY and CLARICE ACCARDO during their visit in Europe, returning to the United States on November 21, 1959. As a result of this trip DE GRAZIO was suspended from the police department and afforded a Civil Service hearing to determine whether he had violated police regulations by associating with a known hoodlum.

The January 27, 1960 edition of the "Chicago Daily News", Page 1, Column 7, contains an article entitled "Trial Board Unanimous". This article reflected a Civil Service trial board found DE GRAZIO guilty of conduct unbecoming an officer and disobeying orders by associating with a known criminal.

Resultant from this finding, DE GRAZIO was fired from the Chicago Police Department.

The February 27, 1960, edition of the "Chicago American", Page 3, Column 4, contained an article captioned "De Grazio Sues For Job". The article indicates that DE GRAZIO filed a suit in Circuit Court on February 26, 1960, for reinstatement as a Lieutenant on the Chicago Police Department contending that the Civil Service rule forbidding policemen from fraternizing with hoodlums is unconstitutional.

The article further reflected that if DE GRAZIO, who joined the police force in 1922, fails to win reinstatement, he will still be eligible for a police pension.



A physical surveillance conducted at O'Hare Field at Chicago by SA [REDACTED] on April 20, 1960, revealed that an (b)(7)(C) individual named G. LOGAN of 6801 South Jeffrey held reservations on this flight. MURRAY HUMPHREYS was personally observed as he confirmed his reservation under that name on flight 83.

The information contained under this caption will show in large detail the large scope of operations of Chicago hoodlums in criminal and quasi-criminal activities of these individuals, not only in the Chicago area but in other geographical locations in the United States. Indictment of ANTHONY J. ACCARDO

As a preface to the information set out herein, it should be noted that on April 26, 1960, ANTHONY JOSEPH ACCARDO was taken into custody by Deputy United States Marshals and was charged with a three-count indictment of violation of Section 7206 (I), Title 26, United States Code. This, in ACCARDO's case, pertains to fraudulent entries ACCARDO made on his income tax returns for 1956 - 1958, whereby he deducted the expense of his automobile for business ventures, namely Premium Beer Sales. The Government is attempting to prove that ACCARDO did not in fact use his automobile in connection with this business in that he did not in actuality perform real duties in connection with Premium Beer Sales.

I know them real well, I know what he does. I'm getting these points, ROSS, because when I first talked to JOE B, I looked at him, and the way you talked, I said, you didn't see anybody. What the hell kind of talk is that? He had me befuddled, and I started to dig in on everybody, and I started to find a little different picture. JOE could have met him in a million places. Now you, you become an A star witness for the defense.

There's one thing we can do here, see? I've already questioned the lawyer. We're gonna have good lawyers in this. We're not gonna (obscene) around. We're going after these guys in a different way. We're not gonna go the same way each time. So, you see, when you take the stand, and you testify to that, if the lawyers coach you just in the one channel, they can't drift from that. They can hold him so they can't say this and this and that. The government can't say, are you connected with so and so, are you in this and that, they hold them right, there, that this is what happened. That's as far as the DA will go. He can say, where did you first meet JOE? How did you first meet him?

Right. I've known him for years and years. We'll have to set that up for you. I've known him for so long, I don't remember where I first met him.

We won't tell them not to, and we won't tell them to... and then that won't show a conspiracy, like we were running and conspiring, let them do it on their own. Now take [REDACTED] over here. [REDACTED] says no, and this and that, see, and the two bartenders said no, I never saw him. Now, that becomes a question. So I go and get ahold of his brother [REDACTED] and his brother said well, I'll testify. Now I got his brother. Now they've got an offset on you when you step up there, haven't they? How the hell does his brother know. He never did the guying there. [REDACTED] did all the buying. He could have bought it through anything. The main thing is, if you saw him in his car, the selling of the thing doesn't mean anything. That you saw him in his car, and he met you, in his Mercedes Benz.

It appears that [REDACTED] will be a witness in ACCARDO's defense whereby it can be pointed out that ACCARDO actually met with [REDACTED] on numerous occasions for the purpose of selling beer. To substantiate these claims of [REDACTED] it appears that they will attempt to claim as customers, as a result of these meetings, the Chez Paree night club in Chicago and Fritzel's Restaurant in Chicago, among other spots. It is to be noted that when ACCARDO is referred to by these individuals he is referred to as JOE or JOE B.

It is further apparent that HUMPHREYS is determined to see that this case is handled in a first class manner and has conferred with the defense attorneys as to the tactics to be used in the trial, stressing general points rather than infinite details that can be easily traced. The [REDACTED] referred to above is believed to be [REDACTED] who also was employed as a salesman for Premium Beer.

The conversation then continues as follows:

HUMPHREYS

Well, that's only one guy. We need, here's what you're gonna have. They claim they have two hundred witnesses. You understand? That they didn't know JOE B. And they told (obscene) stories. You're the only guy that had your bartenders stand up. Didn't any of the saloon keepers say they didn't know who they got the stuff off of, or did they say, they got it off of you.

HUMPHREYS:

That's right, because remember, I was a guy holding a piece there. JOE says, kept hollering, and I said, now listen, JOE, were not gonna knock the guy out of the box, he's on the payroll there.

That's what I told him.

When you got these orders, where did you call them into?

VOLPE referred to above is DOMINICK VOLPE, former owner of the West Side Beer Distributing Company who appeared as a witness before a Federal Grand Jury and following his appearance was shot and subsequently died from the wounds inflicted.

The conversation continues as follows:

HUMPHREYS: That's all right, he can say that.

HUMPHREYS: Oh.

HUMPHREYS: All you know about is the stops. You don't know about the rest.

You call these saloon keepers, and you see how many you can get. Here's what we have to do. They'll have a lot of people there, you understand? When they pull in their witnesses, what'll we use, we'll have a hundred (obscene) saloon keepers standing out in hall, and they're gonna (obscene). That's gonna kill them.

HUMPHREYS: After you put seven or eight witnesses, and we want to make it different years, if you can, like for three years, like to show if you have two or three accounts, or one account, even, the next year. From 1956 to 1958. If

Go on the basis, of anybody that we can find, ROSS, you understand, that we can get those they haven't been to, where we can put JOE with the Mercedes. Now, he doesn't have to go. They don't have to see the Mercedes. He could have left the Mercedes in the parking lot. He could have done anything. You don't bring a car into a bar.

PRIO: I think it would be better to keep JOE out of these places, otherwise, in the District, I don't think they passed up one spot. That they didn't show the picture of JOE and [REDACTED]. This is the actual truth. We used to give him the orders. I used to step on them a little bit, and say, give us some orders, JOE is bawling the (obscene) out of me because we haven't given him an order for a month, or something like that. Then he'd go out and get these orders, and get the names, and I used to call them into [REDACTED]. Now if the company will advertise and get a demand for that then he's gonna make money with that. Now if the company doesn't he's gonna let it go by the wayside, he's not gonna give the second order, don't you see? So there's nothin wrong about it just so long as he was seen in his car, that's all.

Apparently, [redacted] lost most of this money at the Riviera Hotel in Las Vegas. [redacted] advised FERRARO that ROCCO FISCHETTI and [redacted] were in Las Vegas recently and helped [redacted]. According to the information, [redacted] borrowed \$100,000.00 from someone and is working out this debt. FERRARO advised [redacted] that he has left instructions with [redacted] not to allow [redacted] a marker over \$5,000.00.

[redacted] and is an admitted close associate with [redacted], former Chicago top hoodlum. ROCCO FISCHETTI is a former Chicago top hoodlum.

[redacted] and is closely aligned with Chicago hoodlums, and according to [redacted] represents the Chicago group in Las Vegas.

FRANK FERRARO and SAM GIANCANA, according to [redacted] held a conference on April 4, 1960, which was as follows: (b)(2)

GIANCANA: I want to talk to you just a minute FRANK. (b)(7)(D)

FERRARO: OK.

GIANCANA: I went to Las Vegas and made all those arrangements with [redacted]. He said he didn't want to be disturbed so I got hot and said to WILLIE "POTATOES" let's go back they won't allow no hoods there. (b)(7)(C)

FERRARO: No hoods?

GIANCANA: None at all. No no hoods.

FERRARO: I ain't a known hood.

Apparently, GIANCANA received no satisfaction there, and coupled with the fact that Las Vegas has recently had a drive on hoodlums in that area, GIANCANA and party returned to Chicago.

On April 15, 1960, FRANK FERRARO, MURRAY HUMPHREYS, (b)(2) (b)(7)(c) (D) and [REDACTED] had a meeting, according to [REDACTED], and the following discussion took place:

FERRARO: Oh, here he is. (everybody greets [REDACTED]). (b)(2)

HUMPHREYS: Never on time. We waited two hours for you. ↓

Listen, sit down. You know, I had it out with him. I told him, listen, don't you butt into any of our (obscene) stuff. You just keep out of it, cause everything we get into he's in. was opposed to and in conflict with the interests of the Chicago group. HUMPHREYS was apparently setting straight as to who was responsible for [REDACTED]'s position and concerning the group who owns or has a controlling interest in Las Vegas, Nevada. (b)(7)(c) ↓

It is noted that [REDACTED] are close friends of [REDACTED] well known entertainer, and that [REDACTED] is a client of [REDACTED]. It would further appear that [REDACTED] had become involved in a financial transaction with JOHN "Jake The Barber" FACTOR and had apparently come out second best.

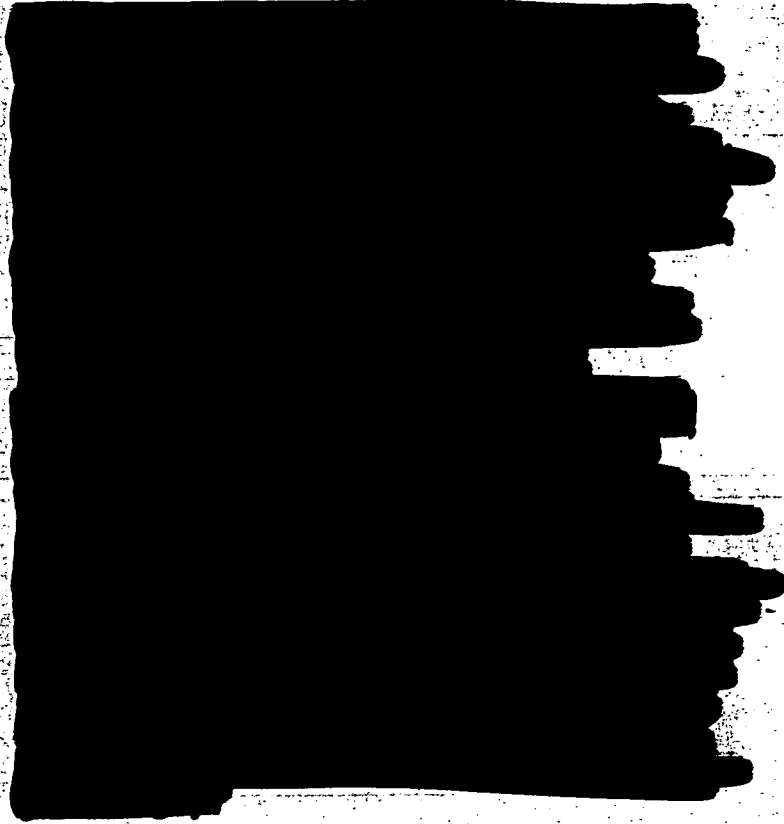

He is not a city employee, he is brought in on a special, on a \$30,000 guarantee by an insurance company. In other words, if he's fired within six months, they'll have to give him his three years. The city pays his insurance policy. They you would hack them, and stop them from paying, then you got him in a hell of a spot. Now the insurance company will have to put up another bond. Say you're asking 500 thousand, the insurance company will have to put a bond for so much money in order to release his salary. They have to put up something on the law suit in order to withdraw his release. In other words, you put the insurance company as part of the law suit. Then you sue everybody down the line but the mayor. So he can't get into the fund. So we got another guy brought from out of town, from California, he's an expert on this special, and you charge him with it, this was the stretch they made to get this fund together, and the Aldermen ok'd it, because they can't do nothing, they got patronage in there. If you challenge every one of these votes, then they're gonna have trouble. See, it's just like the Statute now. Giving the Police authority to do certain things, the new Commissioner, see. They got a body of 19 men turned over there, which is a policy, to [REDACTED]. No, 90 men, starting now, then he's got his, uh, inspector of police, uniformed inspector of police, he's got it set up like the

██████████ advised on April 22, 1960, that HY GODFREY and ██████████ lieutenants of FERRARO, ██████████ and HUMPHREYS, discussed GODFREY's tentative attendance at an unknown reception to be held at an unknown place on April 23, 1960, commencing at 1:00 PM

On April 23, 1960, a physical surveillance was instituted and spot checks were made at the known hoodlum habitats. At Meo's Villa Venice on Milwaukee Avenue, near Wheeling, Illinois, a large wedding reception was noted to be in progress. It was ascertained by pretext inquiry that this was the wedding of the daughter of SAM BATTAGLIA. There were approximately 300 automobiles parked in the adjoining lots and among those were the vehicles of ANTHONY ACCARDO, WILLIAM DADDANO (Lieutenant of SAM GIANCANA) and FIORE "Fifi" BUCCIERO.

## II. CRIMINAL ACTIVITIES

**ANTHONY J. ACCARDO**

According to the April 26, 1960, issue of the "Chicago Daily News", page 1, column 8, ACCARDO was arrested in his River Forest mansion by Deputy United States Marshal on a charge of making false entries on his income tax returns. ACCARDO was incarcerated in the United States Marshal's detention cell until \$25,000 bond was posted by LOUIS VOLIN and IRVIN WEINER, representing

the Summit Fidelity and Surety Company, Akron, Ohio. Page 4, column 5 of the May 3, 1960, issue of the "Chicago American" contained an article indicating that ACCARDO appeared before United States District Court, Chicago, JULIUS J. HOFFMAN presiding. A continuance was granted until May 6, 1960.

Page 4, column 5 of the May 5, 1960, edition of the "Chicago American" contained an article indicating that STANFORD CLINTON, ACCARDO's Attorney, will seek a change of venue wherein he will ask that this case be assigned to another Federal Judge since Judge HOFFMAN sent ACCARDO's brother, MARTIN, to jail on a similar charge in 1954.

The May 6, 1960, edition of the "Chicago American", page 3, column 7, contains an article reflecting the arraignment of ACCARDO on that date and his plea of not guilty. ACCARDO's Attorney had waived reading of the indictment prior to the plea entered by ACCARDO.

The January, 1959, Grand Jury convened at Chicago, Illinois, issued a suppressed indictment charging ANTHONY JOSEPH ACCARDO with three counts of a violation of Internal Revenue laws, namely Section 7206 (I), Title 26, United States Code. The indictment charges the following:

VI. MISCELLANEOUSSAMUEL M. GIANCANA

An article appearing in the "Chicago Daily Tribune," April 23, 1960 edition, page 9, reveals that "Sam Giancan a, the top man in the crime syndicate, admitted through an attorney that in 1956 he had \$200 in cash, \$600 worth of household effects and \$600 worth of personal effects. He contended that he did not own a car, nor a boat or a plane, which were the principal items in a personal property tax bill of \$636.60 which he got for 1956. Anthony V. Champagne, Giancan a's attorney, contended the assessor erred in contending ownership of a car, a boat and a plane to his client, who lives at 1147 South Wenonah Avenue, Oak Park. — Circuit Judge William V. Brothers struck out the assessments for the items Giancanna claimed he had not owned and entered a judgment for \$72.52 in delinquent taxes and \$12.32 interest against Giancan a. If Giancan a fails to pay this judgment in 30 days, the prosecutor's office can get an execution of the judgment, put it in the hands of the sheriff and sit back and wait for the law to seize Giancanna's furniture and clothes."
