

The reason for the consolidation is to eliminate duplication and repetition in reporting the closely related activities of these five hoodlums who are considered the five most important members of the Chicago Crime Syndicate and whose activities in directing the Chicago Crime Syndicate are closely dove tailed.

They discussed the fact that on the following Sunday evening they intended to have dinner and take in the floor show at Mangum's Chateau, a night club and restaurant located on Ogden Avenue in Lyons, Illinois, just west of Chicago.

It is noted that information has been developed previously that HUMPHREYS and the other Chicago top hoodlums frequently meet at the St. Clair and have conferences therein. It has also been developed that concerning whom information is set out hereinbelow under the caption "Associates", maintains a permanent room, 14E, at the St. Clair Hotel under the name of

has advised that on three occasions HUMPHREYS has discussed with other Chicago top hoodlums the fact that they are "protected, from the owner on down" at the St. Clair Hotel.

210 Harbor Drive Key Biscayne, Florida

on January 26, 1960, advised that on that date HUMPHRKYS engaged in a short conversation with his associate had just returned from a short

vacation in Miami, Florida and upon returning and talking to HUMPHREYS he found that HUMPHREYS had also been in the Miami area during his visit there. He thereupon asked HUMPHREYS where he was staying in Florida and HUMPHREYS replied: "I went over by my brother-in-laws house".

'. To this HUMPHREYS stated "But I don't give everybody that number. I hid. You can't find me "

On February 25, 1960, advised that on that date HUMPHREYS had a conversation with SAM GIANCANA (P(2) and with HY GODFREY. This informant advised that during the conversation it became apparent that HUMPHREYS was (P(2)) leaving within the hour by airline for Niami International airport. advised that HUMPHREYS was taking a helicopter from Meigs Airport, located just south of Chicago's loop, to O'Hare Airport, located northwest of Chicago, and that he was leaving from O'Hare for Miami International Airport.

Based on the above information a surveillance was instituted by Chicago agents at O'Hare Airport and HUMPHREYS was observed by SAS and and debarking from a Chicago Helicopter Service helicopter at 10:52 AM. After approximately 20 minutes of evasive movements on the part of HUMPHREYS, obviously designed to determine whether he was under surveillance, he then went to the ticket counter of Delta Airlines and confirmed a reservation he had obviously previously made on Delta flight 805 departing Chicago at 12:25 AM enroute to Miami International Airport.

Details of HUMPHREYS' physical and clothing description were then telephoned to Miami and Miami agents picked up the surveillance of HUMPHREYS when he arrived at 5:05 PM at International Airport in Miami. Miami agents observed HUMPHREYS enter a Yellow Cab which drove him to a private residence at 210 Harbor Drive, Key Biscayne, Florida. This residence appeared to be in the \$70,000 class.

As set out in further detail in the report enclosed herewith under the caption "Residence of MURRAY HUMPHREYS", the records of the Recorder of Deeds for Dade County, Florida, show that the property at 210 Harbor Drive in Key Biscayne, Florida is held subject to two mortgages totaling \$55,000 by one BETTY JEANNE NEIBERT. It is felt that BETTY JEANNE NEIBERT is obviously the wife of MURRAY HUMPHREYS, in view of the fact that it is known that HUMPHREYS callshis wife "JEANNIE"

moved to Miami and the Miami Office has interviewed concerning HUMPHREYS. denied that he knew anyone named HUMPHREYS.

In view of the above, it would seem apparent that HUMPHREYS maintains a private residence at 210 Harbor Drive in Key Biscayne, Florida, even though the property is ostensibly owned by BETTY JEANNE NEIBERT.

B. Status of Health

on January 18, 1960, advised that on that date HUMPHREYS and GIANCANA had a conversation during which HUMPHREYS made the following comments: "You know, the older I get, the better I get. You guys better not put me on the (obscene) farm". GIANCANA laughed at HUMPHREYS remark and HUMPHREYS then continued by saying "What with saying that they're gonna put him on the (obscene) farm you better keep me around".

It would appear that HUMPHREYS referred to the health of in view of the fact that information has previously been developed that during the past nine months or so has been extremely concerned with his health and has been virtually "retired" from activities involving the Chicago Crime Syndicate as is set out elsewhere in the cover pages of this report under the caption "Travel". It is noted that has spent very little time in Chicago during recent months.

MURRAY HUMPHREYS

Concerning the status of HUMPHREYS health, reference is made to the comment of HUMPHREYS reported immediately above concerning his remarks to GIANCANA that "the older I get the better I get".

asked HUMPHREYS and HUMPHREYS told him that he felt pretty good. I have that trouble at night. Keeps me up half the night. They give me some medicine that works pretty good."

On January 28, 1960, HUMPHREYS told (6)(7)(6)(5) according to that he "had a bad night last night".

C. Marital Status

As has been set out above under the caption "Residence" in reference to HUMPHREYS residence in Key Biscayne, Florida, information has been developed by the Miami Office indicating that HUMPHREYS is residing in Key Biscayne, in a house which may value \$70,000. This house is owned ostensibly by one BETTY JEANNE NEIBERT, who is believed to be the present wife of MURRAY HUMPHREYS, although it is not known that HUMPHREYS had benefit of a civil or religious ceremony to bind their (1)(3)(4) relationship. Information appearing under this caption is set out herein in order to show the interests of ACCARDO, FERRARO, GIANCANA and HUMPHREYS not only in criminal activities but in other activities of interest to the Chicago Crime Syndicate. It is believed that this information will show that these five hoodlums have many interests which interlock and which thereby show the existence of the Chicago Crime Syndicate and the activities of these individuals in support of the Chicago Crime Syndicate.

VOGEL: VOLPE from here?

VOGEL's reference to VOLPE is obviously to DOMINICK VOLPE, President of Premium Beer Sales, Incorporated, Chicago.

who was recently indicted for income tax evasion.





IV. TIE-IN WITH POLICE

THOMAS HARRISON, Undersheriff, Cook County Sheriff's Office

advised on January 19, 1960, that on (1)(7)(5) that date FRANK FERRARO and MURRAY HUMPHREYS had a conversation which was mostly inaudible to the informant. FERRARO apparently indicated to HUMPHREYS that he had contacted Captain HARRISON the night before. Later in the conversation the informant overheard HUMPHREYS say something about HARRISON being in the hospital.

It was noted that Captain THOMAS HARRISON, Undersheriff, Cook County Sheriff's Office was formerly Captain of the 35th District of the Chicago Police Department. His career in the Chicago Police Department was stormy in that he was suspended from duty on approximately three occasions due to the fact that he admitted accepting money from gamblers in Chicago for services rendered.
