WEINSTEIN qualifies for inclusion in the "B" section of the Reserve Index by his own admission to Bureau agents on 10/23/59 that he did not withdraw from CP and LVL activity until approximately 1956. He stated he joined the LVL in about 1950 and at one time held the position of Organizational Secretary of the NY County LVL. Weinstein also admitted joining the CP in about 1953 and advised he attended club meetings on the Lower East side on practically a monthly basis. (U)

The subject is not being considered for interview inasmuch as on 1/12/60 he told Bureau agents he would not disclose the political activities of other individuals and that if he received any information of value to the FBI in the execution of its duties with regard to the internal security of the United States he would report same to the FBI. (U)

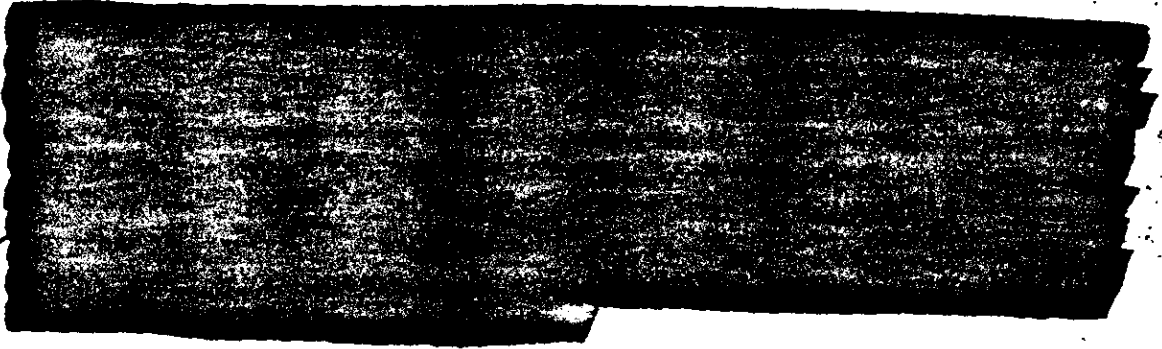
