I called Mr. BILL CLEVELAND of the Bureau at 11:35 AM. this morning, relative to the letter we received dated 7/29/53. from the Director, in connection with captioned case, wherein the Director instructed that we personally deliver to Mr. FRANK GORDON, Chief Attorney for the Grievance Committee of the New York City Bar Association, the Director's letter, at which time we should tell Mr. GORDON that the Director has no objection to the contents of the letter being made a matter of record in the minutes of the Grievance Committee. I told Mr. CLEVELAND that we made a telephone call to Mr. GORDON'S office this morning to ascertain whether or not he was in, and we were referred to JAMES T. GALLAGHER, who is Assistant Attorney for the Grievance Committee of the Association of the Bar of New York City. Mr. GALLAGHER advised us that Mr. GORDON was away on leave in the state of New Hampshire, at his summer place, and would not return until September 7 or 8, sometime after Labor Day. Mr. GALLAGHER advised us that prior to Mr. GORDON leaving on vacation, he had been briefed by Mr. GORDON relative to the BLOCK matter and that he knew of the past activities and action taken by Mr. GORDON in connection therewith. That Mr. GORDON advised him that he had written to the Director and that he would be receiving a letter from the Director. Further, that Mr. GALLAGHER was authorized: to discuss the matter with the agents of this office.

I told Mr. CLEVELAND that the Director's letter had gone directly to Mr. GORDON'S office, since Mr. GALLAGHER advised us hehad the letter from the Director, and that therefore, we would be unable to deliver it, since, no doubt, there was a slip in the I told Mr. CLEVELAND that we had the attached memorandum noted in the Director's letter of 7/29/53, to this office, the content of which we were to discuss with Mr. GORDON.

I told Mr. CLEVELAND I was calling him for the following reasons:

- That we did not receive the Director's letter; that it went directly to Mr. GORDON'S office.
- Whether or not we should discuss the content of the attached memorandum setting forth the background of BLOCK with Mr. GALLAGHER.

An allegation that he had not cooperated with the Senate Internal Security Subcommittee by refusing to give a specimen signature at a bearing was dismissed.

ture at a hearing was dismissed.

The prosecution dropped the charge in view of a recent ruling by the Court of Military Appeals in the trial of a United States soldier in Germany that under the Fifth Amendment to the Constitution a witness had the privilege of refusing to give a sample of his handwriting. This amendment protects witnesses against self-incrimination.

Maj, William L. Whalen, court law officer, denied a defense motion for a directed verdict of not guilty on charges of perjury an obtaining a commission fraudulently by concealing membership in, the Communist party.

In his closing argument, Emanuel Bloch, civilian defense counsel, declared:

"These paper patriots like Senator O'Conor Iformer Senator
Herbert O'Conor, Democrat of
Maryland, ex-chairman of the
Internal Security Subcommittee],
and Arens [Richard Arens, committee counsel] thought it would
be a marvelous spot to get some
publicity and put the Army on the
spot." "You must say, we are no
going to take one of our own and
throw him to the wolves because
one or two phony politicians are
publicity mad."

At 11:55 a.m., instant date, I telephonically advised Assistant Director BELMONT that we had completed a review of nineteen newspapers and publications in the New York area from June 12 1953 through June 22, 1953, and had been unable to locate any reference to an alleged wager made by MR. HOOVER and MR. BROWNELL. I pointed out specifically to him that we had reviewed the "Parade Magazine" on the Sunday of the funeral, the Sunday before, and the Sunday thereafter, and there was no reference there about such a statement. I pointed out to him that "Parade Magazine" was in the Long Island Sunday Press" rather than the "New York Herald Tibune."

MR. DELMONT vanted to know if the nineteen papers included the major newspapers in New York City and I told him that they did and he advised me to hold on to the identity of the papers we checked but it would not be necessary to report that to the Bureau at this time.

Brooklyn Lieutenant Accused of Concealing Communist Ties Is Acquitted

Energy to The New York Tower FORT DEVENS, Mass., Aug. 5 -An Army court-martial today acquitted First Lieut. Sheppard Carl Thierman of charges of perjury and obtaining a commission fraudulently by concealing membership in the Communist party. It took the nine officers comprising the trial board three hours to return the verdict.

Yesterday a third charge, failure to cooperate with the Senate Internal Security subcommittee, was dropped.

The 31-year-old Brooklyn, N. Y. Army physician was placed on trial April 27. The twenty-four days devoted to arguments and taking of testimony were punctu-

ated by several long recesses. The court, in reaching the decision, returned once for additional instruction from the law officer, Maj. William L. Whalen. A twothirds vote is necessary for conviction. Major Whalen, in his charge, zaid:

"You are not sitting here as a member of the court to take part in any struggle against communism, but you must be impartial and decide upon the evidence."

Lieutenant Thierman expressed gratification at the verdict.

"My honor as a loyal American has been vindicated," he said. "I received a fair trial in the American tradition, in which all par-ties performed their duties according to law. ### THE THIERMAN ACQUITTAL

Sheppard Carl Thierman of perjury charges for allegedly concealing Communist Party membership, is a crack in the wall of reaction. The popular revulsion against the fascist-like drive to jail Americans for their avowed or alleged views and affiliations has penetrated even the panel of nine army officers who returned the not-guilty verdict.

As Attorney Emanuel Bloch who defended Thierman said, the verdict was "a setback for those who would like to stifle the thoughts of those with whom they do not agree and, indeed, to put into jak those holding unorthodox views."

The verdict also showed, said Bloch, that "justice can prevail in America if people stand up to fight injustice."

The Thierman trial was significant in other respects. The law officer, Maj. William L. Whalen charged the court:

"You are not sitting here as a member of the court to take part in any struggle against communism, but you must be impartial and decide upon the evidence."

Also, the star witness of the government was Mary Markward, the stoolpigeon most responsible for fingering the five working class leaders convicted in Baltimore on Smith Act charges. Apparently the word of a planted political stoolpigeon doesn't hold as much weight in a court as it did a year or two back.

However, such small cracks in the wall of reaction that has been built in recent years should not lead us to overlook the fact that the drive to jail and stifle on the basis of the Smith, McCarran, McCarran-Walter and Taft-Hartley Laws is still on the ascendency.

Such sparks of justice as do appear, as in the Thierman case, should encourage us to step up the counterdrive for amnesty and for an end of persecutions under America's "Hitler Laws."

court political trials sank almost to zero. a Fort Devens, Mass., Army tribunal came up this month with a blow to the witch-hunters when it acquitted Lt. Sheppard Carl Thierman after a court-martial lasting over three months. The attorney who moved the tribunal to acquit Thierman, after, Washington "paper patriots" had sought "to get some publicity" out of the lieutenant's progressive record, was Emanuel H. Bloch, the man who defended Ethel and Julius Rosenberg.

This was Thierman's story: He joined the Army at 21, served honorably from 1942 to the end of World War II; scored top grades in mental and aptitude tests. Under the Army's special training program, he studied at Princeton, then at George Washington U. where he took a pre-medical course. After his discharge in 1946 he went to N. Y. University where he obtained a medical degree in 1949.

BUDAPEST TO KOREA: Following his graduation and after interning in a Brooklyn hospital, he attended the Intl. Youth Festival in Budapest as co-chairman of the U.S. delegation. During this period he was an active leader of an organization of internes. On Oct. 20, 1950, he registered with his Selective Sevice Board under the Doctor's Draw Law The last question on the Defense Dept. application form for an officer's commission was:

separation. But on Nov. 13 he was subpenaed by the Senate Internal Security succommittee, then headed by Sen. Pat McCarran (D-Nev.), Former Sen. Her bert O'Conor (D-Md.) presided Thierman's hearing. Committee counsel Richard Arens grilled him mercilessly for nearly five hours, brushed aside his perfect record in Korea, implied that he had used his post here for "espionage". He was badgered about his "no" answer to the question of ever belonging to a subversive organization. He invoked the Fifth Amendment in refusing to answer several questions, used the same ground to refuse to give the committee a sample of his signature.

Two days before his separation from the Army, Thierman was charged with obtaining his commission by fraud by specifically denying membership in the Communist Party. He was ordered to stand trial by court-martial. Four months later another charge was added: that he had sworn falsely before the committee. Finally came a third charge that he had violated the military code by refusing to submit his signature to the committee.

the trial: On April 27, the courtthe court; a two-thirds vote was enough to convict. The senior prosecutor, a lieutenant-colonel, was promoted during the trial. Thierman was defended by Bloch and an Army officer assigned as co-counsel.

Chester, Assistant Manager of the Chase National Bank, Morth St. Branch, advised that the circumstances surrounding the opening of the "National Committee to Secure Justice in the Rosenberg Case" account were as follows: BLOCH called him early in November 1951 to say that he was sending a woman to him to open an account for the NCSJRC. Chester stated that inasmucha as BLOCh and his father both had banked there for years that he opened the account on Bloch's reccommendation alone and did not require the usual "verification" procedure;... which would involve signiture cards and what amounts to a sponser. The account was opened on 11/8/51 and the address of record was shown as c/o William A. Reuben, 17 Murray Street, NYC (The address of the National Guardian). The fund was transferred to the Madison Square Branch (26th St.) on 6/2/52. SA John A. Harrington has advised that the account has since been transferred to the Times Square Branch.

Mr William C. Henchy, Vice-President of the Chase National Bank, Worth Street Branch, advised on 10/7/53 that the "ROSENBERG CHILBREN'S TRUST FUND"account was opened on 9/17/53 by Subject. The address of record is c/o Emanuel H. Bloch, 401 Broadway, NYC, and the balance as of 1C/7/53 was \$ 6908.73. Trustees of the fund are SHIRLEY GRAHAM, YURI SUHL, JAMES ARONSON, AND MAICOMB SHARP, And EMANUEL H. BLOCH.

On 10/15/53 Mr Henchy again made the files available to the writer for examination. The Trust Fund brogchure contained the following pertinent information: Related accounts were shown as "EMANUEL II. Enclosed herewith are five copies of a summary reflecting a search of the files of the NYO on captioned subject. For the purpose of clarity, information obtained is being set forth under each of the four points designated in rebulet.

The Bureau is advised that the review of the NY files included a complete review of the cases of JULIUS ROSENBERG, National Committee to Secure Justice in the Rosenberg Case (NCSJ) and related cases. All newspaper articles of the "Daily Worker", "National Guardian" and NY daily newspapers covering the period from March 1951 to date were also reviewed.

The Bureau's attention is invited to the enclosed summary containing information secured from and informants of other offices who have in particular reported the activities of the NCSJ. The Bureau is advised that the information secured from the aforementioned sources has been set forth(b)(2) not with the intention of exposing or utilizing these informants, but for the purpose of furnishing the Bureau a comprehensive picture of the activities of EMANUEL BLOCH.

It is recommended that no informant be exposed or utilized in this matter but as much of the information as possible secured from these sources be furnished to the Bar Association. It is believed that this information would be of great value to the Bar Association in the examination of BLOCH. For example, questioning BLOCH concerning the proposed publication "Retort"; the presence of WILLIAM A. REUBEN in BLOCH'S home and REUBEN reading the trial record and conferring with BLOCH concerning articles in the "National Guardian".

The possibility exists that BLOCH, confronted with information of this nature while under oath and not knowing the source of the Bar Association's information, might be placed in a compromising position.





The New York Office by teletype to the Bureau dated 100-15348-2172 February 14, 1953, advised EMANUEL BLOCK in open court on that date asked for an informal hearing to discuss the date that Judge KAUFMAN would fix as a new date of execution. During this discussion Judge KAUFMAN made remarks about the NCSJRC, stating that as if on signal he had been flooded with telephone calls and telegrams. He reminded BLOCK that he was an officer of the court and had a duty to the court, and wanted to know -1f the half-truths and untruths that the committee was publishing had been approved or considered by BLOCH. Judge KAUFMAN admonished BLOCH that he had an obligation to tell the committee when it was in error. BLOCH stated that he had made it his business to call to the committee's attention any errors he had noted in their statements, and that he could not control people who took a certain side on a problem of world interest as in this case. BLOCH remarked that the paper carried an article "today" that His Holiness, Pope Pius had come out for clemency and (HLOCH) stated that it was obvious that he had no association with the Pops. BLOCH admitted that he had received money from the committee in part payment of his fee for services to the ROSENBERGS. Judge KAUPMAN told him that it was his duty as an officer of the court to know the source of his fees. The tenor of Judge KAUFMAN's remarks was that the ROSENBEROS had received every opportunity to present their case in court but that the administration of justice required that the remaining steps should proceed with dispatch. He told BLOCH that he should proceed with his remaining steps with diligence and dispatch. (It is to be noted that information concerning payment of fees to BLOCH by the MCSJRC will be set out under Point II.)



Mr. MAT BAHN, manager of Rossoff's Restaurant, 115 West light Street, New York City. 

## A. INFORMATION PIGARDING THE ROSEMBERG OND DIRECTOR THUSE FIRE AND JUNG FUBLISHING COMPANY

Street Granch, adviced on Detober 7, 1953, that an account entitled, "Rosenberg Children's Trust Fund", was opened on September 17, 1953, by EMANUEL H. BLOCH, and the address of record was shown as EVACUEL H. BLOCH, 401 Broadway, New York City, and the trustees of the fund were shown as BURRLEY GRAMAK, TUBL SUME, JAHES AROMETH, PALCEES STAPP and EMANUEL H. BLOCH. The trust fund broadure indicated that related accounts were, among others, the Joro Publishing Company, Incorporated, and the National Committee to Secure Justice in the Rosenberg Case.

Records of the County Clerk's Office, New York City, reflect that a Certificate of Incorporation was filed with the feartary of State on April 6, 1953, and with the County Clerk's Office on April 29, 1953, for the Jero Publishing Company by EMANUEL H. BLOCK, LOI Broadway, New York City. The address of this company was shown as LOI Broadway, New York City, and its directors were listed as MORTON FOITHMAN (NY 100-102967, law partner of MICCH), YO FUJII (female Chinese secretary to BLOCK) and ORA LEAK. New York indices contain numerous references to both FUJII and LEAK.

III. INFORMATION TENDING TO INDICATE THAT PRESS RELEASES PURPORTEDLY MADE BY THE ROSENEGROS PRIOR TO THEIR EXECUTION WERE IN FACT MADE BY BLOCK.

A review of all newspapers including the "Daily Worker" and the "National Guardian" covering the period of the Rosenberg case was made and no information was located reflecting that press releases purportedly made by the ROSENBERGS were in fact made by BLOCH.

Visits by RIOCH to Sing Sing in 1953 were compared with news articles published around the dates of trees visits and no pertinent information was developed.

It is pointed out that numerous press releases were made by the ROSENBERGS through BLOCH; however, these were openly attributed to them and no information was developed which would prove that BLOCH prepared or helped to prepare these releases.

This publication, according to the Informant, was to be organised by JULIUS ROSENBERG, ABRAHAM BROTHMAN with EMANUEL BLUCH as legal counsel. (DV)

The order of events, as reported by Informant, in connection with "Retort", is set forth as follows:

- April 7, 1951 BLOCH was to be organiser and legal advisor.
- April 13, 1951 BLOCH was to furnish \$6,000.00 worth of stamps to be used in distributing "Retort". Also BLOCH was at that time writing a legal paper which would be included in the publication.
- April 16, 1951 BLOCH was due to receive thesis from EROTHMAN for publication in "Retort".
- April 20, 1951 BLOCH was having difficulty in finding someone to take over the work on "Retort".
- April 27, 1951 BLOCH was very anxious to have Informant work on "Retort"
- May 4, 1951 RIOCH sent a message to ROSENBERG through his sister that two domnittees had been organised to work on the case.
- July 1, 1951 BLOCH advised Informant that "Retort" had not yet been published.
- August 15, 1951- BLOCH advised Informant that the "National Guardian" would write a series of articles and he, BLOCH, had read the draft of the first article. BLOCH told Informant that "they" will definitely form a committee by the end of September to handle the ROSENBERG case along the lines of the SACCO VANZETTI Case.

Informant advised that the original plan to distribute "Retort" had been to do so surreptitiously to a number of major cities.

It is to be noted that the August 15, 1951 issue of the "Mational Guardian" contained an article announcing that WILLIAM REUREN would begin an "expose" of the ROSENBERG case in the next issue.

On September 28, 1951, BLOCH advised Informant that "Retort" would definitely not be published and that articles in the "National Guardian" would be utilised instead.


MOPRIS GLEICHER then gave a short speech on the integrity and courage of ISSDORE STARR. He spoke of the chances of a re-trial for MORTEN SOBELL but did not think there was much of a chance for any re-trial. He stated the Fastists' worst weapon is fear and that patriotic .mericans must stand up and fight for the America we love. A man and woman then stood up and read the ROSENBERG letters which were written to EMINUEL BLOCH asking him to carefor their sons.

EMINUEL BLOCH was then the next speaker. He spoke of the courage of the ROSENBERGs and quoted a remark made by JULIUS ROSENBERG. "JULIUS summed it all up in a few words. It had to be us, the United States had to have a reason for a war in Korea and to step up their production, and it was a direct thrust at the left." Ho said the names of the ROSEYRERGs must be cleared and that those who helped clear their name will be called Reds and will be ostracized by society. He then spoke of the trust fund for the ROSENBERG children and said that a fund of \$75,000 was planned. Approximately \$600 was taken in at this meeting for this fund.







Informant advised that from 75 to 100 delegates from New York, New Jersey, Pennsylvania, Washington, D. C., Massachusetts, California, Ohio, and Wisconsin attended the Conference and about 300 people attended the ROSENBERG Dedication Meeting (Public Session) at 8:00 pm, 10/10/53. Informant based the attendance at the Dedication Meeting on DAVID ALMAN's remark that he collected about \$1,200 or \$4.00 per capita.



DAVID ALMAN, according to informant, was the speaker at the 10/10/53 afternoon session which began at 2:00 pm. ALMAN told how MORTON SOBELL was arrested in Mexico City where he had gone to vacation with his family. ALMAN stated that instead of taking SOBELL to the police station, they took him to the border and delivered him to FBI Agents. ALMAN pointed out that in the quick trial which followed SOBELL's arrest, SOBELL was convicted on the testimony of MAX ELITCHER, an admitted perjurer. ALMAN said ELITCHER must have been paid by the FBI inasmuch as just after the trial, ELITCHER received a high salaried position in private industry which ALMAN feels was obtained with the aid of the FBI. Informant advised that ALMAN read from the court record of the United States vs. MORTON SOBELL and commented on it, but informant did not recall what ALMAN's comments were.

Informant advised that after ALMAN's speech, the delegates discussed a pre-conference paper and the sentence, "It (Committee) will work for a reduction of the tortuous 30 year sentence as alien to American concepts of justice and equality under law." This sentence was heatedly discussed and was deleted after the Sunday (10/11/53) report of the Policy Committee and a pledge was added to the pre-conference paper pledging support for the well-being of the ROSENBERG children and accepting full legal responsibility for MORTON SOBELL.

The discussion continued on the theme of how to get



SOBELL free. The delegates felt that the best way to do this was to get the support of labor and community leaders.

Informant said there were quite a few delegates from unions and a lady named HUGGINS (ph), a rank and file member of a Detroit union, told how she approached some of her co-workers during the heat of the campaign. The co-workers asked if she were a Communist. She replied no, but thought it a shame for the ROSENBERGs to die so young. She pointed out that regardless of whether the ROSENBERGs remained in jail or were electrocuted, the ROSENBERGS would still cost the people more taxes. She said she finally won the workers and the Detroit ROSENBERG Committee became one of the strongest.

CEORGE BROWN, Philadelphia, according to informant, suggested that there should be a youth branch as well as a senior branch of the ROSENBERG-SOBELL Committee. IRV SCHREIBMAN, Philadelphia, agreed that youth could play a tremendous part in helping SOBELL. SARAH LITTENBERG, New York or New Jersey, stated that a youth group was in the organizational stage in New York and that every city should organize youth councils. The afternoon session adjourned about 5:30 pm.

The ROSENBERG Dedication Meeting began at 8:30 pm, 10/10/53, according to informant, with Dr. MALCOLM SHARP of the University of Chicago Law School giving some of the high-lights and legal points of the ROSENBERG case. Then EDITH SEGEL read three of her poems on the ROSENBERGs which will appear in a booklet soon. Two of them were entitled "I Hear the Rosenbergs" and "I Call Across the Continent." Mrs. SOBELL read a letter from her husband in which he said he welcomed the Committee and the work they were doing for him. Mrs. SOBELL said that her husband has renewed his energy since "those two gallant heros were cruelly put to death." Informant said that Mrs. SOBELL's remarks stirred the delegates emotionally.

DAVID ALMAN said there was still a chance for SOBELL's release from prison, but to get the finest legal staff available, they would need money.

Informant advised that the San Francisco chapter was

the first to contribute \$100. The Philadelphia Committee advised they had already left a check for \$100 at the Chicago Committee's office. Informant stated that a donation of \$100 was the largest requested and then a \$50.00 donation, \$30.00 donation, "a dollar for each year of SOBELL's sentence" and smaller amounts were requested.

Informant reported that on 10/11/53 at 9:30 am, the Eastern Region of the National Committee to Secure Justice in the ROSENBERG-SOBELL Case held a caucus in Room 1371, Congress Hotel, 510 South Michigan Avenue, Chicago.


The last session of the Conference began in Room 602, Fine Arts Building, 410 South Michigan Avenue, Chicago. at 12:00 Noon on 10/11/53, according to informant, who further advised that REID ROBINSON, Los Angeles labor leader, was chosen Chairman of this session. ROBINSON called for the report of the committees. Dr. TUSHNET reported the following program and policy.

1. The Committee should circulate an Amicus Brief appealing for a new trial for SOBELL.



3. Acquire the names of the U.S. Senate Judiciary Committee and have constituents write letters to members homes and offices.

DON ROTHENBERG, Cleveland, gave a detailed report about Washington, D. C. during the ROSENBERG appeals. He stated that no Congressmen had the nerve to make a public statement on the ROSENBERG Case. He said he called on an unidentified Senator who said he would do what he could. Later, the Senator told ROTHENBERG that there was nothing to worry about since he had contacted the Justice Department, and they said a representative from their Department would call on the ROSENBERGS. ROTHENBERG



said he then read in a newspaper where the representative of the Justice Department had called on the ROSENBERGs and told them "either you talk or you die." ROTHENBERG said he showed the newspaper to the Senator who became furious after reading it. ROTHENBERG urged the contacting of members of the U.S. Senate and House of Representatives by their constituents on behalf of SOBELL.

DAN MARSHALL, Los Angeles attorney, was elected to lead the Committee, and the following were elected to assist him:

JOE BRAININ, Eastern Region Co-Director, and EMILY ALMAN, Secretary. LEONARD TUSHNET was nominated Treasurer, but not elected because TUSHNET felt the position of Treasurer required more discussion.

The following were elected to the Executive Committee:

JEAN FRANTJIS, Philadelphia; HERBERT TAMPSKY (PH), Boston; SYLVIA BERNSTEIN, Washington, D. C.; and W. E. B. DuBOIS, DAVID ALMAN, YURI SEWELL (PH), and NORMA AARONSON, New York. Baltimore, New Jersey, Western Pennsylvania, the midwest and west coast were expected to submit their nominations for the Executive Committee in two weeks or as soon as possible. A \$60,000 budget for a six month period was approved by unanimous vote.

The ROSENBERG Trust Fund was then discussed by YURI SEWELL, who said that the trustees, Professor MALCOLM SHARP, Chairman; EMANUEL BLOCH, Secretary; W.E.B. DuBOIS, and himself are striving for a \$75,000 fund which would be soundly invested.


The last point was a detailed report by SARAH LITTENBERG on the sale of the book entitled "ROSENBERG Death House Letters."







"On Tuesday, September 22, 1953, the writer attended a meeting at the Parkside Hall on Fenkell Avenue, Detroit, Michigan, to listen to Mr. BLOCH and speakers of lesser note speak on the responsibility of caring for the ROSENBERG children.

"The meeting did not begin until approximately 9:00 p.m. At this time, a man, not identified other than a worker of some official note on the Detroit Rosenberg Committee, acted as M.C. This gentleman lacked preparation and poise in fulfilling his obligations as M.C. and merely rambled about the ROSENBERG case without gaining the attention of the audience. At one time, the M.C. was stuck for words and spent a good fifteen or thirty seconds groping for a thought. Evidently it came to him for he introduced Reverend CHIRLES ... HILL who gave the invocation.

"Reverend CH RLES A. HILL asked forgiveness for the crime committed by this nation against the innocent ROSENBERG family and asked that strength be given to all people such as gathered in this hall this night so that they may have the courage and stamina for militant action to correct all injustices such as this case most certainly has shown, and to make this nation a truly progressive, liberal, and free nation as it was founded to be. Reverend HILL asked that this gathering be given the undying generosity of time, patience, and energies in pursuing a course where all peoples of this nation will have full freedom everywhere in this country and not the kind of justice that is dealt out against the Negro race in the South and the many minority races in the North. Reverend HILL asked that all efforts should be taken by rightcous people in establishing the vindication of the ROSENBERG Reverend HILL closed with saying that liberalism and progressiveism must not be surrendered in this country.

"The M.C. then introduced Mr. ISADOR" STIRR, an attorney, who began by saying h apologized for being thrusted time and time again upon this gathering. However, to be fair to himself and his convictions, he knew he must do every little bit to assist in clearing the ROSENBERG name and in refusing the now thirty year sentence of MORTON SOBELL. From here on, Mr. STARR related the decision of the Lawyers! Guild in taking its stand on the Communist witch-hunt conducted by McCARTHY and men of his kind and, how by taking this stand, the abuse, slander, and villification and hardships that such a stand brought on, and that we, as individuals, are at the cross roads and must make up our minds to undergo all the vile name calling and inconveniences any stand for full equality is bound to forment under our present suppressors in this nation. Mr. ST.RR then stated that as freedom loving pro-Americans that we (the group) are, he knew no sacrifice would be too extreme if we steel ourselves to the condition that returns, though they may be slim, at least history will show that our stand did much to keep this country in this hour of darkness from going under by the avalanche of the special-interest group in the McCarthyites now in control of our government.

"From this point on, Mr. ST RR confined his remarks to MORT SOBELL with statements concerning the injustice of his conviction and how the attorney for SOBELL could not even get from the United States Attorney or the FBI the charge against his client until the trial was well under way. Also, how the SOBELLs had planned a Mexico visit in 1948, but due to the press of work had to postpone this vacation until 1950, and how they were attempting to return to this country when one night men who claimed they were Mexican police forced their way into the SOBELL home in Mexico City and kidnopped SOBELL and took him to the border where he was turned over to FBI agents. The FBI then intimidated and trightened the man to such a degree that he could not fulfil his right to testify under oath, the full an

righteous story of his life's doings. The witch-hunt had created such an oppression that our own Bill of Rights was no longer a beckoning light to all liberal minded peoples of the world.

"Mr. STARR ended that we must give generously of time and money to bring complete vindication of MORT SOBELL and though it may never in our time become known the complete, true history of the ROSENBERG case, we must continue our righteous fight. We owe it to the ROSENBERGs, SOBELL, the nation, and most certainl to ourselves to continue this struggle.

"After Mr. STERR's talk, a man and lady came upon the platform and read from the letters of ETHEL and JULIUS ROSENBERG. The readings were dramatic to the point of almost uncontrollable sobbing by the lady in the reading of ETHEL's last letter. Emotionally the crowd responded to the readings as had been anticipated by the Committee in charge. From 180 to 200 guests were there with few not surprisably affected by the readings.



"After a short introduction by the M.C., Mr. BLOCH was introduced. The audience was captivated by this time, and Mr. BLOCH used this to great advantage. With hands in his coat pocket, he paced back and forth and spoke in a very quiet and low tone. He gave a little history on how ETHEL's mother, now being made to be a figure of fine motherhood by BEN LYOMS and writers of this type, was actually a woman who abandoned her daughter on death's door and from the time that ETHEL was detained under \$100,000 band until she was murdered by this nation, ETHEL's mother visited her only four times. On each of these occasions, the visits were for the sole purpose of making ETHEL confess her crimes. The ROSENBERG children were abandoned by ETHEL's mother and spent a year in a State institution until proper arrangements could be made by BLOCH to care for the boys.

"Mr. BLOCH related the first meeting between JULIUS and himself. From the short talk, BLOCH felt he had known JULIUS for a lifetime because he personified so many qualities that are good and wholesome politically. JULIUS impressed Mr. BLOCH as a liberal, progressive, intelligent man who, as the trial progressed, remarked that under existing conditions in this nation this trial had to be and that the deat's sentence had to be and that he (JULIUS) and ETHEL were resigned that they must die





for the cause of all liberal, progressive peoples of this world and die they will but not as cowardly dogs but only as true dignified human beings should die under existing circumstances. Mr. BLOCH related that as the DREYFUS case divided France, so the ROSENBERG case united France and in reality, all the world. Not a place on the face of this world was left unaffected and all were visibly shaken by the hideous crime against these two wonderful people. One room in Mr. BLOCH's office is entirely filled with correspondence from the four corners of this world, all in sympathy with ETHEL and JULIUS.

"Mr. BLOCH stated, 'The Rosenbergs will that I should see that the children are given a chance to lead a good life and be spared further hurt against them by : . uninformed society, but in reality the guardianship was not entrusted to me (BLOCH); but only to me as a representative of people like you. That is the sole purpose of my visit.' A five person trusteeship has been established to see that every cent collected is used solely for the children. There will never be one cent used for administration of the trusteeship. 'Our intentions are to see that these two fine boys get the love of a home, the education granted to all who desire it, and the opportunity to open a small office of their own if that is their wishes. We do not want to raise them as people of money, but rather as they were accustomed to when the family was intact, a modest, average, good American family.! Mr. BLOCH stated that the entire estate of the ROSENBERGs amounted to no more than \$15.00 and this came mostly from the sale of books. The ROSENBERGs had nothing except for good books and records that the entire family enjoyed. Nover in the two visits of the children to the death house would anyone believe seeing this family laughing and planning together but that this was a visit to the ROSENBERG home. ETHEL and JULIUS were determined to spare their children the anguish of the cruelty imposed on them.







On this date the writer was advised by Mr Frank Gordon of the NYC Bar Association that the Executive Committee of the NY Bar would meet on 12/2/53 and definitely take up the BLOCH matter as unfinished business. If the matter is not approxed by the Committee then it will be dropped then and there. If it is approved then it will be presented to the Appellate Division of New York in the form of a petition setting out the allegations. It was indicated that a copy of the petition would be served on BLOCH. The case will then be called out in open court on a scheduled motion day. Gordon stated that there are no motion days scheduled in December therefore the case in any event would not reach trial before January or February.

Mr Gordon stated that a reporter has called him for a stroy on the case but he had advised that a story would not be timely now and further that he would give no press releases anyway. He said that the news reporters were aware that the case would be called out in open court and thus if a reporter was present at the time the matter would then become public knowledge. He said that up to that time he will make no press release and that he would advise the writer a fews days in advance of any publicity given the case.

GORDON stated off the record that apparently the matter is of considerable concern to the Committee and there is some retiscence in deciding it specifically. New York Telephone Directory reflects a current listing to Dr. ARTHUR WEIN, 56 7th Avenue and a number disclosed that he is the husband of AUGUSTA WEIN, same address. A search of the New York indices reflect that AUGUSTA LIPSCHITZ WEIN, the wife of ARTHUR WEIN, is the subject of a Am-C case, NY File 100-63650. Concerning DINA BLOCH, NY files indicate only that she contributed to the Civil Rights 57E Congress Bail Fund on behalf of the eleven top Communists.

New York has no information which would indicate that DINA BLOCH is hostile toward the subject to the extent that she would be willing to disclose to the Bureau her knowledge of the subject's activities, notwithstanding her divorce from the subject. New York also has no assurance that DINA BLOCH would not disclose to the subject any attempt by Bureau Agents to interview her regarding him. This exentually could be a source of embarrassment to the Bureau. Accordingly, it is recommended that DINA BLOCH not be interviewed in this matter at this time.

Bloch, who was the attorney for Ethel and Julius Rosenberg, and is now legal guardian of the children by the Rosenbergs, accepted the check at a dinner held at Prince Hall Masonic Temple.

The money was presented to Bloch by the New Jersey Rosenberg-Sobell Committee, to which the contributions for the children were made. The dinner was sponsored by the committee.

The \$5,000 will go into a Trust Fund established for the children, who are now living at Toms River. New Jersey. The goal for the Trust Fund has been set at \$75,000, to be collected throughout the country. Chairman of the Fund is Professor Malculm Sharp, professor of Law at the University of Chicago.

### PRO-RED LAWYERS CHARGE U. S. CURBS

Dulles' Standon Rights Scored at Vienna Meeting—200 From 25 Lands Attend

VIENNA, Jan. 7—About 200 lawyers from twenty-five countries concluded tonight a three-day meeting of the International Lawyers Conference for Defense of Democratic Rights with a resolution endorsing democratic rights, freedom and peace.

The agenda of this Communistfront organization included items described as a critical analysis of problems caused by discrimination in the application of law, especially with regard to the exercise of constitutional civil rights, and a critical analysis of encroachments on personal freedom and legal guarantees for this freedom.

E. L. Zeidin, vice president of the Soviet Supreme Court, compared alleged discrimination in Western countries with the "atrict observance" of democratic rights in the Soviet Union. He criticized John Foster Dulles, Secretary of State, for having declared that the United States would sign no documents guaranteeing the rights of man.

[Mr. Dulles told Congress April 6 that the Eisenhower Administration would sign no treaty on human rights drafted under United Nations auspices, or the already-drafted convention of political rights of women. He explained that he did not believe treaties should "circumvent the constitutional procedures established in relation to what are essentially matters of domestic concern."]

#### Persecution Is Cited

A Canadian lawyer deplored the alleged persecution of the National Lawyers Guild by the United States Government. Other delegates supported his statement, holding that Emanuel Bloch, attorney for Ethel and Julius Rosenberg, executed atomic spies, had been refused a United States exit visa to attend the conference.

[Mr. Bloch said in New York that this statement was incorrect. He said he had applied during Christmas week for a passport to attend the Vienna meeting, but had been told by the State Department before New Year's that it would be impossible to pass on the application in time for him to attend. Mr. Bloch said he had written to the State Department this week withdrawing the application.

[Attorney General Herbert Brownell Jr. has declared the National Lawyers Guild subversive and has required it to show cause why it should not be placed on hit list of subversive organizations.]

Prof. Gerard Lyon-Caen, honorary president of the French to Court of Cassation, complained of "methods used to suppress trade unions in African, Asiatic and Latin-American countries." r. He also denounced the practice of some countries of preventing trade unions from dealing with political problems which, he said, m. condemned them to impotence.

". . . America today is living under the heels of a military dictatorship dressed in civilian garb. These people have no hearts.

". . . The Rosenbergs were not executed according to law. A Supreme Court Justice said the court had not read the record in this case; was that 'due process of law?"

The Rosenbergs were executed at Sing Sing Prison on June 19. 1953, more than 26 months after they were convicted of war time atomic espionage for the Soviet Union. During those 26 months. lengthy and complicated legal battles were fought in the Federal courts.

### Act to disbar Bloch

EMANUEL H. BLOCH, defense attorney and "a brother who had lost a brother and a sister" with the execution of Julius and Ethel Rosenberg, said at their funeral last June (GUARDIAN, 6/29/53):

"The American people should know, as the rest of the world knows, that America today, by virtue of the execution of the Rosenbergs, is living under the heel of a military dictatorship garbed in civilian attire. The men who are running our country have no hearts. They have stones for hearts. They have the souls, of murderers. This was an act of cold, deliberate murder. When I requested in Washington that these executions be put off sc that they would not occur on the Jewish Sabbath, the request was granted by a barbarian who, instead of postponing the hour of their death, pushed it up so they could be done away with before the beginning of the Sabbath. . . . I place the murder of the Rosenbergs at the door of President Eisenhower, Atty. Gen. Brownell and J. Edgar Hoover. This was not the American tradition, not American justice and not American fair play."

Last week the Bar Assn. of N. Y. City asked the Appellate Divn. of the State Supreme Court to take action to discipline Bloch for his statement (the court can censure, suspend or disbar an attorney). Under the law such proceedings her required to be kept secret while they are still before the court; the story had, however, been "leaked" (but not by Bloch's office) to news-



EMANUEL BLOCH Defended Rosenbergs who died yesterday, was born in New York City May 12, 1901—the same calendar day on which his client, Julius Rosenberg, was born 20 years later.

Their lives were to become entwined in one of the most publicized court cases in history.

The 52-year-old lawyer was found dead by a friend in the bathroom of his apartment, 7 W. 16th st. Death was due to apparently natural causes, police said.

Volatile, gray-haired Bloch defended Rosenberg and his wife, Ethel, throughout the more than two years of court litigation preceeding their execution in Sing Sing's electric chair last June,

#### PRESSED COURT FIGHT.

He pressed the fight through every vallable court as worldwide "sympathy" for the atom spies was ground out by left-wing organizations.

On the day of the execution, he said "I feel ashamed I am an American today."

A few days later, standing over the coffins of the spies, Bloch said:

"I place the murder of the Rosenbergs at the door of President Eisenhower, Mr. (Atty. Gen.) Brownell, and (FBI director) J. Edgar Hoover.

"They did not pull the switch, true, but they directed the one who did pull the switch."

Disbarment proceedings were launched Jan. 19 by the New York City Bar Association as a result of the grave-side remarks. The next day Bloch announced his intention to fight the action.

Recently he fought an attempt to remove the two young sons of the Rosenbergs from a New Jersey school they had been attending. He was the boys' guardian.

Bloch was divorced and lived alone.

Survivors include his father, Alexander, who also had represented the Rosenbergs, and his brother, Milton.

Funeral services will be held Tuesday at 11:30 a, m, in Riverside Chapel, 77th st. and Amsterdam ave. Burial will be in Mount Jauan Cemetery, Queens,

Only 11 days ago, the city's Bar Assn, brought disbarment proceedings against Bloch for his charges, made in the Rosenberg funeral oration, that President Eisenhower, Attorney-General Brownell and KBL Chief J. Edgar Hoover were "murderers" of his clients, who were executed for giving U.S. atom secrets to the Russians.

The court turned Bloch down every time without ever reviewing the case. Bloch also asked for Presidential clemency, which was denied by Mr. Eisenhower.

Bloch was born here March 12, 1901. He was graduated from the City College of New York and the Columbia Univer-Aty school of law and admitted to the bar in 1924.

He is survived by his father, Alexander E., and a brother, Milton, Oleanville, N. Y.

Bloch's brother said the funeral will be held at 11:30 a.m. Tuesday, Interment will be in Mount Judah Cemetery, Queens.

When BLOCH arrived about 9:30 PM, accompanied by MINNA BERLOW and her husband (MAX BERLOW), he was introduced by ROSE ROSENBERG as one of the outstanding advocates in this country. BLOCH told of Julius and Ethel Rosenberg having been born in a New York ghetto, discussed their early life and briefly discussed their arrest, trial and subsequent confinement. He discussed the Rosenberg children and stated they had been ousted from school in New Jersey, which created resentment by people of that town. He also stated the children had experienced incidents and trouble from schoolmates because their parents had been electrocuted as spies and stated that if they cannot be reared without suffering and agony, he will remove them from the country.





On December 4, 1953, a meeting sponsored by the Rosenberg Children's Trust Fund was held at the Embassy Auditorium, 84.7 South Grand Street, Los Angeles, at which meeting EMANUEL BLOCH, who had been the attorney for the ROSENBERGS in their trial, was the main speaker.

Informant also stated that an individual had gotten out of an automobile with California license #1827934 and had entered the meeting.

Records of the Department of Motor Vehicles, Los Angeles, California, reflected that the car with California license 1827934 was a 1953 Plymouth coupe and was registered to NAOMI C. BLAIR, 1138 Court Street, Los Angeles, California.

Informant stated that EMANUEL BLOCH in his speech lashed out at everything in America with the exception of the CP. She stated that BLOCH then stated he was not in Los Angeles to make a political speech but that he was here to tell of the arrest of the ROSENBERGS and their children's plight.

Informant stated that EMANUEL BLOCH spoke at length concerning the many hardships encountered by the ROSENBERG children and he stated that efforts to adjust the children to a life without their parents would take much money and much hard work.

Informant stated that in answer to a plea for money that somewhere in the neighborhood of  $\psi 2,000.00$  was collected from those present.

On 12/5/53, the informant attended a rally at the "mbassy Auditorium, Los angeles, sponsored by the Trust Fund Committee for the Rosenberg Children, at which Makuth BLOCK spoke. JCHN CLAYBET acted as chairman. (JOHN CLEWE)

CLAYREI complimented the Audience on their courage in coming in spite of the spies present. MINA BERLO. was interviewed as organizer and head of the Los neeles group for Funds for the Rosenberg Children. Mrs. M.RLC spoke briefly, then read numerous letters of greetings and commendations. Among those were letters from CHARLOTTY BASE; Fastor of the Christian Church at Long Beach: BORCUGHS, probably REUBER BUROUGH; ____ IALEY; JOHN FURTER; and F. PRICE COBES.

ARTHUR ATKINS, accompanied by WALLY HILLS, sang two songs written for this fund-raising campaign. "The Rosenbergs March On" was sung to the tune of the "Battle Hymn of the Republic." with the audience joining in the chorus. The "Letters to Per Sons" by ETH I ROJ IBI G was set to music chosen as best in a big contest. It was sung as a solo by ATAINS.

boys began with the refusal of ETHIL's nother "to care for the brats." They were then placed in a home for a year, after which the paternal grand-rother accepted them. He are trying to preserve a democratic government, free from fears-fears brought about by hcCARTHY, VOLDA, and the Un-American activities Committee.

The students of the campuses are the ones to be united, to fight, to be strong. They will soon be ready. The are getting stronger day by day, and it will not be long. One question asked BLOCK was, "What can we students do to prevent a Farcist state?" BLOCK laughed the question off. Another question was, "Did the judge talk with you when he handed you the envelope? Why did you not ask for a new trial?" Answer: "Not discussing the case."

Other questions asked were as follows:

Answer: "Only if the political climate here makes it necessary. They were born here."

There were remarks made concerning the American Legion, Judge KAUFFMAN, WALFR MINCHILL, about the hysteria in our country, our political climate, and the police state. Fascism was often eluded.

The audience consisted of about 1,200 people. The speaker said the fears that the audience would not be large were not justified. In fact, their growth was shown by the fact that several meetings were held simultaneously—the bizarre at Park Manor and an ASP meeting at Channing Hall.

There was a fairly large turnout for the affair. Mr. BLOCH gave a brief resume of the Rosenberg Case and told of the difficulty he was having in trying to place the children in a school. The children were recently in attendance at a school in Toms River, New Jersey but due to the interference by law and educational agencies, the children were ordered out of the school. Mr. BLOCH contacted various schools in the New York area and no school there would accept the children for enrollment. He finally made contact with the American Friends (Quakers) Organization in Philadelphia, Pennsylvania and they agreed to do the very best they could to find a school for the children. Mr. BLOCH is also attempting to find a permanent home for the children in which they will be allowed to grow up in a normal, happy atmosphere.

The main purpose of Mr. BLOCH's tour is to also collect funds from various persons interested in helping the children. These funds will enter a national trust fund already set up for the children to pay their expenses and if possible insure them of a college education. Mr. BLOCH was introduced to the group present by MINNA BERLOW, who is an executive officer of the Southern California Committee raising funds for the Rosenberg children.

furnished SA MACLIN F. MORRISON a report on December 7, 1953 regarding a meeting sponsored by the Southern California Committee for the Rosenberg Children on December 4, 1953 at the Embassy Auditorium, 9th and Grand Streets, Los Angeles. Original report located

Approximately 800 were in attendance. JOHN CLEVY (CLEWE.) Chairman and Treasurer of the Committee, announced that the purpose of the meeting was to collect funds for the bringing up, education, and welfare of ROBBIE and MICHAEL ROSENBERG. He stated that he was speaking for ROBERT MORRIS, IR., Chairman of the Committee, who was unable to attend.

ARTHUR ATKINS and Mr. HEALY provided entertainment. A Mrs. MARGARET BURLLY (MINNA BERLOW) was introduced as a person who knew more, has done more, and contributed more than anyone else toward the success of the campaign. She explained her interest in the campaign and read letters and testimonials addressed to BLOCH by groups and individuals, praising his work in defense of the Rosenbergs. She read a letter dated June 18, 1953 from the Rosenbergs to BLOCH, which was a last will and testament appointing him as trustee and guardian of their two sons.

MANUEL BLOCH stated he was attending this mosting on behalf of the Rosenberg children and that he was not trying to revive the Rosenberg case or make a political pitch. bitterly attacked the present administration as being undemocratic, anti-labor, capitalistic, and anti-foreign born in pursuing a policy of oppression of minorities through the Walter-McCarran Act, suppression of freedom of thought and speech through the HCUA. He referred to the Rosenbergs as innocent victims of hysteria, the first victims of American Fascism. He condomned Judge KAUFMAN and all other Governmental higher-ups from the President on down who were instrumental in the perpetration of this horrible crime. BLOCH spoke on the Rosenbergs' lives, their struggles and so forth.

### Did Lawyer Bloch Know?

By BOB CONSIDINE -

THE death of Emanuel H. Bloch, lawyer for Julius and Ethel Rosenberg, makes more difficult—if not impossible—this reporter's search for the person or persons who gave the word to Russia that the Rosenbergs were "safe"...that they would go to their deaths without a word of confession, without naming a single accomplice.

Bloch, a brilliant and articulate man in the courtroom, died under the cloud of disbarment proceedings brought against him for the tone of his funeral oration over the coffins of his clients. In that inflamed speech he charged that President Eisenhower, Attorney-General Brownell and J. Edgar Hoover were "murderers" of the Rosenbergs. A day or two before he had cried, "Today I am ashamed I am an American."

Those last minute fireworks were in curious contrast to his earnest statement to Judge Irving Kaufman, the jury, U. S. Attorney (now judge) Irving Saypol and Saypol's staff immediately after the death verdict had been handed down. He said then in effect that he and his clients had been treated fairly by all concerned.

#### "Word" Was Passed

But some days later, with the Rosenbergs now in the death house at Sing Sing, "the word" was passed. By whom we may never know. On signal, the Communist press of the world set up a cry of "Save the Rosenbergs." That same press had not deemed the couple worthy enough or "safe" enough to cover their trial.

The wheels of a colossal propaganda machine had begun to turn. One can hardly hazard a guess as to what it cost that section of the Kremlin which handles such world-wide programs. Suffice it to say that its scope was such that in time the White House heard expressions of concern from spiritual leaders as militantly anti-Communist as Pius XII. More than 700,000 French workers signed petitions in the Rosenbergs' behalf. There were demonstrations in African jungles.

This tremendous propaganda effort

would have boomeranged thunderously if the Rosenbergs had talked. If they had turned to the handful of us who sat in the death chamber that evening at Sing Sing and saw them strapped into the ghastly chair, and had blurted acknowledgment of their role in the Soviet spying apparatus, it would have been the most disastrous propaganda setback Russia ever suffered. It might have been one from which Russia would never have recovered, for in the eyes of the wavering world it could never be believed again.

### **Reds Demanded Death**

There was an additional danger in this huge propaganda gamble with the Rosenbergs. If Bloch was successful and did win a reversal of Judge Kaufman's decision, or persuade the judge himself to make his sentence less severe, the Rosenbergs would now be serving the first of perhaps 30 years in jail. Plainly, that would have been risky. They were bitterly cold people, these two, but the constant rub of children and relatives from the outside world might in time have coaxed them to admit the crushing weight of evidence produced against them, and identify co-conspirators, in the hope of easing the sentence.

It was plain, it seemed to me, that Russia wanted (yes, demanded) that the Rosenbergs die, but die as dramatically as martyrs. But, more important, it was absolutely necessary that they die silent. Who gave that assurance? Why was the Communist world silent about them one day and confidently raucous the next? What conceivably were the guarantees against a sudden, human collapse of their fron will as the arms of the electric chair reached out? Did anyone hold them in line?

Bloch, who saw much more of them than anybody else during their long stay in prison, was not there at the end. Now he, too, is gone, and with him what could have been light to shed upon a baffing case of domination of two human beings by self-will or outside forces beyond comprehension in a democracy.
