Subject: FUNERAL OF EMANUEL BLOCH, ATTORNEY FOR THE ROSENBERGS,  
FROM RIVERSIDE CHAPEL, 76th ST. & AMSTERDAM AVE., N.Y.C.

1. On February 2, 1954, at 11:30 A.M., funeral services for Emanuel Bloch, attorney for the deceased atom spies Julius and Ethel Rosenberg, were held at Riverside Chapel, 76th St. & Amsterdam Ave., N.Y. City. Approximately 500 persons were crowded into the chapel, with an overflow of persons remaining on the street. Services were conducted by Rabbi S. Phillips, who stated he had not known the deceased and quoting from Scripture that "his thoughts were not my thoughts", prayed for his soul and forgiveness.
2. Cedric Belfrage of the National Guardian was the opening speaker, stating "The Rosenberg case was the first act, and the death of Manny Bloch the second act in this tragedy - the American tragedy". "But the third act is still to be written and it is to be written by us". He said that Bloch was paying the price for choosing truth and justice and that his choice was natural and inevitable for him. He cited how Bloch had begun the uphill fight to proclaim the innocence of Ethel and Julius Rosenberg in the earliest days of the case, stating that Bloch's intense affection for the Rosenbergs carried an irresistible conviction. He concluded by quoting from poetry of Ralph Chapin, jailed during World War I for opposing the war "Pity those who will not speak".
3. Dr. W.E.B. DuBois traced Bloch's career through the defense of Willie McGee and the Trenton Six, stating that the deceased had had a profound faith in justice "My people are not surprised when that justice miscarries. We have suffered too many wrongs and insults. He concluded by reading a poem from Whittier which asked if America would endure to see its liberty destroyed, and ended with an emphatic "No".
4. Alice Citron, co-worker in the Rosenberg case, told of how all France loved Bloch, stating "This morning some of the leading lawyers of France placed a flowery wreath at the steps of the Palace of Justice in Paris to honor Manny's memory. She quoted a French leader by stating "To us, Manny Bloch was Washington and Lincoln, and we believe that an America that can produce a Manny Bloch is an America that will save itself".
5. Joseph Brainerd, speaking for the Rosenberg-Sobell Committee, expressed confidence that Bloch's struggle for the truth in the Rosenberg case would be vindicated. "That day of triumph will be his and ours".
6. John Finerty, attorney who served in the Mooney and Sacco-Vanzetti cases and who had worked with Bloch in the final days of the Rosenberg case before the Supreme Court, emphasized Bloch's contribution to American legal tradition. He called the Rosenberg case the "most shameful maladministration of law that our country has ever

seen", stating that "the persecution of the Rosenbergs and of their attorney and defender, Emanuel Bloch, was not hysteria but coldly calculated". He stated that Bloch had a "selfless compassion and an honest indignation which made him an example to the Bar, an example which is sorely needed today. Finerty spoke of the hostile Bar committee which had just presented charges against Bloch to the Bar because of the latter's bitter denunciation of the White House and Supreme Court's refusal to reconsider the Rosenberg case, after new facts were presented proving perjury in the government's case against the Rosenbergs. Finerty believed that Bloch had "in pain and tears" spoken thoughtlessly when he denounced the government as "murderers", but he said that even the grievance committee passing on the charges to the bar could not propose any such thing as disbarment, though it was known that a reactionary group in the Bar was trying to hound Bloch out of the legal profession.

7. James Gerfinkel of the Canadian Rosenberg-Sobell Committee, declared "When Bloch's name was mentioned at the recent Vienna conference of world lawyers, including many judges and supreme court justices, his name was greeted with a standing ovation".

8. Prof. Malcolm Shary of the University of Chicago Law school, associated with the Rosenberg defense during the appeals, declared that Bloch was an outstanding American lawyer with "devotion to justice and a deep affection for people". He cited Supreme Court Justice Jackson's tribute to the deceased, for the "wisdom and skill" of his legal fight to save the Rosenbergs", adding that "He made a permanent contribution to American life".

9. Gloria Agrin, attorney, who worked with Bloch on the Rosenberg case and who has now been elected to fill Bloch's place as a trustee of the Rosenberg Children's Trust Fund, said "for three and a half years, hour by hour and minute by minute I worked with Manny and loved him. The steel of his strength was compounded of sweetness and a response to the sufferings of others. He taught us we must be unafraid and not to live on our knees". She quoted as Bloch's epitaph the last poem written by Ethel Rosenberg for her children, "It is his too, spoken too soon".

10. Abraham Under, attorney, stated that of the "300,000 members of the American Bar, Bloch was best known and loved throughout the world". He cited Bloch's long legal career, pointing out that the deceased always chose cases in which he defended victims of wrong, and in which basic issues facing the nation were intimately involved. "The Rosenberg case was a battlefield where shot and shell rained on all sides, and at first Bloch stood alone - but he was indomitable and kept on fighting for justice".

11. Yuri Suhl and Bernard Jaffee of the National Lawyers Guild also paid tribute in similar vein. Services were concluded with Paul Robeson who stated "I dedicate this song to Emanuel Bloch and to the brave people he defended", singing "A Mighty Fortress Is Our God" and terminating with "song of his fathers", the Chassidic chant.

## Bloch's death mourned

**M**ESSAGES of condolence, admiration and love were pouring in from around the world last week following the death of Emanuel Bloch, attorney for the executed Ethel and Julius Rosenberg. They came especially from lawyers in W. European countries whose respect for Bloch contrasted with the action of the New York Bar Assn. to discipline or disbar him. In Paris, hundreds of lawyers in their robes gathered Feb. 1 to pay Bloch homage before the monument to the dead at the Palais de Justice, where they laid a wreath. In behalf of the French Natl. Comm. to vindicate the Rosenbergs, this message was sent to Emanuel Bloch's father, Alexander, by lawyers Andre Haas, Paul Villard and Charles Owezarek:

"Millions of Frenchmen who protested against the execution of Ethel and Julius Rosenberg admired the magnificent courage of 'Manny,' who will live in history as the symbol of the defense and as a true citizen of a nation which remains in our hearts the land of George Washington and Abraham Lincoln."

"HE WAS IN THE WAY": These were some comments in French newspapers, most of which featured Bloch's death on page 1:

**COMIT** (anti-Communist Left): ". . . After the Rosenbergs were dead, a well-orchestrated propaganda campaign attributed to them crimes with which the prosecution had never even charged them. In face of the emptiness of the dossier, something better had to be invented. They had stolen the hydrogen bomb before it even existed. They had, according to the miserable McCarthy and his henchman David Greenglass, directed a spy network at Fort Monmouth more than three years after their arrest. But that was not enough: the crusaders of McCarthyism were thinking about the two children, Michael and Robby, whom the Rosenbergs had entrusted in their last wishes to Maitre Emanuel Bloch. It was apparently necessary to tear the children away from his influence and put them in a 'right-thinking' public institution, in order to bring them up in hatred of their parents. But the defender of Ethel and Julius Rosenberg was on his feet, fighting. He had faced almost alone the unleashing of passions. He was superfluous, he was in the way. . . . (Proceedings to disbar him were brought on) a protest which is not even valid under American law. . . . In the U.S., the President is not only the chief executive but the head of government and his actions can on that basis be freely criticized by all citizens. . . ."

**LE MONDE** (liberal): ". . . For three years Maitre Bloch had given himself body and soul to the defense of the Rosenbergs. Because of this passionate defense pro-

certainty had been brought to exclude him from the New York bar. Without any doubt this final threat had profoundly affected him. Nevertheless he had stated a few days ago his intention to continue the fight . . . He had already sacrificed all to this defense of the Rosenbergs; his professional future, his personal fortune, his peace of mind. Whatever may have been the immediate cause of his death, it was certainly a consequence of the efforts he had expended. With him the Rosenberg children lose more than their legal guardian."

LIBERATION (progressive): " . . . It is impossible to forget the incredible campaign waged in the U.S. against the man who insisted on continuing to defend the memory of the 'Lovers of liberty.' . . . He was threatened with disbarment from his profession for having honored it perhaps more than anyone. . . ."

"WE MUST PRESS ON": In New York, this eulogy was read Feb. 3 by lawyer Charles Rothenberg and adopted as an expression of its feeling by the directors of the N. Y. C. Chapter, Natl. Lawyers Guild:

"The same words of homage that are being paid to his memory were said of him while he lived. Only now we miss him; he shall no longer share with us our pride in the addeduster that he brought to our calling. He will be remembered for his gentleness, his courage and tenacity, his everlasting dedication to duty. This he leaves us, this and a sense of debt. For we owe it to him, as to all the brave host among his colleagues that in every time have put principle before favor, to press on where he left off. We stand charged by his example with a high trust, to continue with every resource in the defense of this precious freedom to advocate. To that purpose we commit ourselves. It is our pledge and our covenant."

## Court Assumes Care Of Rosenberg Boys

By EDITH EVANS ASBURY

Robert and Michael, 6 and 10-year-old sons of Julius and Ethel Rosenberg, executed atom spies, were taken into the guardianship of Children's Court yesterday. A hearing will be held Tuesday on charges that they have been improperly cared for and exploited for fund-raising purposes.

The complaint, filed by the Society for the Prevention of Cruelty to Children, was based on an investigation made by the Department of Welfare, according to Justice Jacob Panken of Domestic Relations Court.

At 10 o'clock last night, Supreme Court Justice James B. M. McNally signed a writ of habeas corpus directing that the children be brought before him at 3 P. M. today at the County Courthouse.

The writ was obtained by counsel for Mr. and Mrs. Abel Meeropol of 720 Riverside Drive, with

whom the two boys have been living. It asked that the boys be returned to the Meeropolis pending the hearing on Tuesday.

It was disclosed publicly for the first time yesterday that the boys had been at the Meeropolis home since early January and had been attending public school under the name of Meeropol. They were taken from the Meeropolis home yesterday to an undisclosed place that is under court supervision.

Mr. Meeropol, writing as "Lewis Allan," is a composer and writer for stage, screen, radio and television. He wrote the lyrics for the score of "The House I Live In," a motion-picture short that

won the Academy Award in 1945. He is a graduate of City College and has a Master of Arts degree from Harvard.

Justice Panken said the society's petition alleged that the Rosenberg youngsters had been "moved about from home to home." Both the society and the Welfare Department refused to comment.

Before going to live with the Meeropolis, the two orphans had been living with Mr. and Mrs. Bernard Bach in Toms River, N. J., for a year and a half. They were ordered withdrawn from the elementary school they attended there on the ground that they were not legal residents of Toms River and therefore could not be accommodated in the overcrowded school.

Mr. Bach, a chicken hatchery salesman, had informed a reporter at the time of the Rosenbergs' execution last June that the children had been accepted by the community and that Michael was president of his class in the fifth grade.

In a handwritten will they

made at Sing Sing the day of their execution, the boys' parents named Emanuel Bloch, their attorney, guardian of their sons.

Mr. Bloch, who placed the boys with the Meeropolis, died of a heart attack Jan. 30. His father, Alexander Bloch; Miss Gloria Agrin, attorney and friend of Emanuel Bloch, and Prof. Malcolm Sharp of the University of Chicago law faculty represented the Rosenberg children at yesterday's hearing.

Justice Panken said that a guardian designated in a will by a parent could not legally assume guardianship without approval of the Surrogate's Court. He said that so far as he knew the will had not been submitted to the Surrogate's Court.

Emphasizing that "I have not found the children neglected yet," Justice Panken admitted that their removal from the Meeropolis home would have "very serious impact" on the boys, but said it was the court's obligation to assume their "supervision and pro-

tection" pending investigation of the petition's allegations.

"I am not concerned with one single thing except the welfare of these children," he said.

Angry supporters of the Rosenbergs, who crowded the hearing room floor, asserted that officers of the society and the Welfare Department had attempted to "seize" the two boys Wednesday night at the Meeropolis home and had been fended off after a telephone call to Justice Panken.

The boys were brought to the Domestic Relations Court yesterday but did not appear at the hearing. Justice Panken refused to say where they would be cared for while they are in the court's custody.

Mr. and Mrs. Meeropol, Mr. Bloch, Miss Agrin, Professor Sharp and Philip Sokol, Welfare Department attorney, were the only principals present at the hearing, which was held privately. The decision to adjourn the hearing to next Tuesday was made to give counsel for the Meeropolis time to prepare their case, Justice Panken said.

# Court Takes Over 2 Rosenberg Boys.

By ARA PIASTRO

The two young sons of executed atom spies Julius and Ethel Rosenberg were taken from their foster parents Thursday and placed under temporary care of the Children's Court after the Welfare Dept. charged the boys were being neglected and "exploited."

Domestic Relations Justice Panken sent the boys, Michael, 11, and Robert, 6, to a shelter pending a final determination of their guardianship next Tuesday.

The boys have been living since last Christmas with songwriter Abel Meeropol, whose pen-name is Lewis Allan, and his wife Anne, of 720 Riverside Dr. They have not had a legal guardian since electrocution of their parents last June, the court revealed.

At 10 p. m., hours after the hearing ended, counsel for the Rosenberg estate obtained from Supreme Court Justice McNally a writ of habeas corpus, directing the boys be brought before him at 3 p. m. today (Friday), to determine their immediate custody.

JUSTICE PANKEN, after a closed hearing, told reporters the action was initiated by the Society for the Prevention of Cruelty to Children on information supplied by the Welfare Department, which charged the children were being "exploited for fund-raising activities."

Alexander Bloch, an attorney and father of the late Emanuel Bloch, who was defense counsel for the older Rosenbergs, pleaded with Panken to let the boys stay with Meeropols, describing the writer as a successful lyricist with a comfortable home.

"These people are in no way related to the Rosenbergs," Panken said he told Bloch. "They are no part of the children's family. This is certainly a strange case where someone comes in and takes over children without guidance and care."

Panken said the petition filed with him alleged the boys were "taken from place to place, home to home, without a guardian having been appointed."

EMANUEL BLOCH, who died of a heart attack recently, was named as the boys' guardian in their parents' will, but the will never was probated.



Dooley) that although he does not know BLOCH personally, he has come into contact with him a number of times in the past two years and from BLOCH's speech and attitude, T-1 stated that there is no question that he is a Communist. T-1 added that members of the CP generally regard BLOCH as a CP member.
