



letter which had been sent to him by WIDGE NEWMAN. "for
the committee", and bearing the heading "The Sobell
Committee" and which carried the title, "The Legacy".
The letter spoke of the work and sacrifice necessary to
make the freedom of MORTON SOBELL a reality. It urged
those receiving the letter to remember the ROSENBERGS
on this fifth anniversary (June 19, 1953) "of the faith
they kept in us ... by your deep concern for life of
MORTON SOBELL". b7d

The accompanying envelope was self-addressed to the Los Angeles Sobell Committee (LASC), 462 North Western Avenue, Suite Three, Los Angeles 4, California, a characterization of which is contained in the appendix hereto. Under the flap was a picture of MORTON SOBELL together with the following statements:

- Enclosed is my contribution and signature for freedom.
- I would like -- Petitions to the President on behalf of MORTON SOBELL.
- I will join the Sobell Committee in my area.

Below this was space for name, address, and phone.

MORTON SOBELL was convicted in United States District Court, Southern District of New York, on March 29, 1951 for conspiracy to commit espionage in behalf of the Soviet Union. He was sentenced to 30 years imprisonment in a federal penitentiary.

The AYD has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

On [REDACTED] made available an announcement of a program to be held July 25, 1958 at 4561 North Avenue, San Diego, California, which is headquarters for the Community Unitarian Fellowship (CUF), a characterization of which is contained in the appendix hereto. The announcement stated the program was to be sponsored by the San Diego Sobell Committee (SDSC), a characterization of which is contained in the appendix hereto. The front of the folded announcement contained a picture of HELEN SOBELL with the statement on the next page, "JOHN WINGATE interviews HELEN SOBELL", a sound film TV interview. Also on the program was a tape recording of a debate on the SOBELL case.

Participants were ROY COHN, formerly of "Mc Carthy Senate Committee", versus Professor SHARP of the University of Chicago Law School. Admission was free; donations welcomed. The announcement appeared to be expensively printed by a union printer.

[REDACTED] identified HELEN GUREWITZ (HELEN SOBELL, Mrs. MORTON SOBELL) as a member of the Education and Literature Committee of the Communist Party in Washington, D. C., [REDACTED] b7d

The CP and CPA have been designated by the Attorney General of the United States pursuant to Executive Order 10450.

Professor MALCOLM SHARP, Professor of Law at the University of Chicago, was advisor to the University Communist Club - HCUA Report dated August 25, 1956, entitled "Trial by Treason", the National Committee to Secure Justice for the Rosenbergs and Morton Sobell, Page 52.

On June 19, 1953, ETHEL and JULIUS ROSENBERG were executed, having been found guilty of conspiracy to commit espionage in behalf of the Soviet Union in United States District Court, Southern District of New York, March 29, 1951.

On [REDACTED] made available a summer vacation CUP Newsletter (August, 1958) which reflected that on August 24, 1958 at 9:30 A.M. a breakfast deluxe jointly sponsored by the Unitarian Fellowship for Social Justice (UFSJ) and the San Diego Committee for Justice for Morton Sobell would be held. b7d

[REDACTED] members of the CUP have organized the UFSJ in San Diego for the purpose of using that name when presenting "controversial" speakers. [REDACTED] b7d

On November 25, 1958 [REDACTED] made available for examination a check number 2102 drawn on Superior Fabrics Company, 4421 Park Boulevard, San Diego, which is solely owned by MILTON LESSNER. Instant check was dated November 4, 1958 and was payable to "Sobell Committee" in the amount of \$25.00. On the description part of the check was the following: "Contributions from San Diego Sobell Committee". The endorsement read "Los Angeles Sobell Committee, 462 North Western Avenue, Suite Three, Los Angeles." b7d

The above information should not be made public without issuance of a subpoena duces tecum.

On [REDACTED] made available a flyer entitled "Our Gift to You ... The Clarions", which announced a concert to be held at the Oneira Club, 4649 Holly Boulevard, San Diego on Sunday December 7, 1958 from three to five P.M. and which would be sponsored by the "Sobell Committee" It requested a donation of \$1.00, but stated children would be admitted free and refreshments would be served. b7d

In November, 1958, informants who are conversant with subversive activities in the San Diego area advised they had no current knowledge of SDSC activity.

On [REDACTED] advised that he has no knowledge of the SDSC except that it consists of a small group of individuals which at times is engaged in work for the Sobell Committee and at other times lends assistance to other CP front groups. b7d

COMMUNITY UNITARIAN FELLOWSHIP

(OF SAN DIEGO COUNTY)

"* * * when the Communists were expelled from the San Diego First Unitarian Church by the pastor, PETER SAMSON, they set up a competitive organization, the Community Unitarian Fellowship. This was designed to operate as a 'non-religious' front organization * * *. The Communist group was refused recognition both by the San Diego Unitarian Church and by the American Unitarian Association, the parent body of Unitarian churches in America."

LOS ANGELES SOBELL COMMITTEE

The Los Angeles Sobell Committee is known as the Los Angeles Committee to Secure Justice for Morton Sobell. It was formerly known as the Los Angeles Committee to Secure Justice in the Rosenberg Case and was also referred to as the Los Angeles Rosenberg - Sobell Committee.

The Los Angeles Committee to Secure Justice in the Rosenberg Case was cited by the Committee on Un-American Activities report dated August 25, 1956, pages 66 and 67 as "a local auxiliary of the National Committee to Secure Justice in the Rosenberg Case. 'Next to New York and Washington the area of greatest focus in the Rosenberg campaign was Los Angeles ... the Los Angeles campaign was under the direction of SOPHIE DAVIDSON, Chairman of the Los Angeles Committee ...'".

A source advised that [REDACTED] SOPHIE DAVIDSON was a Communist Party (CP) member. **b7D**

The CP, USA, has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

A Confidential Source advised on May 1, 1957, the San Diego Sobell Committee (SDSC), Aka., Morton Sobell Defense Committee, Sobell Defense Committee, San Diego Committee to Secure Justice for Morton Sobell, was organized on April 8, 1956, at San Diego, California to help obtain a new trial for MORTON SOBELL, convicted in 1951 for conspiracy to commit espionage on behalf of the Soviet Union. Source further advised that the SDSC is an adjunct of the National Committee to Secure Justice for Morton Sobell in the Rosenberg Case, Aka., National Sobell Committee, New York, New York, which directs activities, policy and obtains financial support from the various Sobell committees throughout the country.

Another Source [redacted] advised that [redacted] MILTON HENRY LESSNER was chairman of the SDSC. **b7D**

A third Source [redacted] advised that [redacted] MILTON HENRY LESSNER was literature director of the San Diego County Communist Party. **b7D**

Following the execution of atomic spies ETHEL and JULIUS ROSENBERG in June, 1953, the "Communist campaign assumed a different emphasis, its major effort centered upon MORTON SOBELL", the ROSENBERG's co-defendant. The National Committee to Secure Justice in the Rosenberg Case - a Communist front which had been conducting the campaign in the United States - was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October, 1953, and "then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg Case". National Headquarters remained at 1050 Sixth Avenue, New York City. Co-chairmen of the newest organization were DANIEL MARSHALL and JOSEPH BRAININ. (Committee on Un-American Activities, report, "Trial by Treason: The National Committee to Secure Justice for the Rosenbergs and Morton Sobell", August 25, 1956, pp 118 and 120).

PERKINS advised that he is no longer connected with the Sobell organization, regionally or nationally. PERKINS said he "most amicably" separated himself from Sobell activity because of "tactical differences" among some of the Sobell people at Chicago. PERKINS said that DAVID SOLTNER should be consulted regarding Sobell business.

On January 8, 1959, [REDACTED] Mrs. DAVID SOLTNER advised that DAVID SOLTNER is one of a group of volunteers who do Sobell fund raising and programming at Chicago. She said that none of the Chicago Sobell volunteers "have national positions of titles" and that HELEN SOBELL and TED JACOBSON of New York direct National Sobell work. Mrs. SOLTNER said that the Chicago Sobell Committee maintains an office but has no full-time employees. **b7E**

[REDACTED] will continue, using discretion, to determine who, if anyone at Chicago, is a member of the National Committee of the Sobell organization. **b7D**

Chicago will give this matter continuing attention as instructed in relet.



Information furnished by NY 2434-S* regarding the first two days of the plenum, 11/27 and 28/58, have been set forth by separate communication:

The proceedings of the plenum of 11/29/58, are being set forth in instant letter with copies designated for the Bureau and appropriate files in NY and other offices.

Page numbers are set forth following the name of a subject in the list of copies of instant letter in cases where that individual or organization is mentioned infrequently.

It should be noted that in some cases NY 2434-S* was unable to furnish the full true name of a particular subject and in these cases identification has been made through prior information on a subject's alias.

According to NY 2434-S*, the plenum was called to order on 11/29/58, at 10:06 a.m., with the announcement that although behind schedule it was desired that the plenum be finished up on that date. A request was made that all discussions be held to the minimum.

It was then announced that discussion would continue (on the SWP youth movement).

The first speaker could not be identified by NY 2434-S*, but is believed to be ALLEN TAPLIN.

TAPLIN discussed the development of the "IEN" groups (Independent, Broad, Militant), which he said were formed to attract people from the CP periphery, the independents and social democrats. He said that the situation changed since that period, however, and it has now become possible to work with smaller groups which he described as cadres of the revolutionary socialist groupings around the "Young Socialist."

TAPLIN stated that it was not fair to say that the orientation of the SWP youth program had been toward the petty bourgeois rather than the proletariat. He said that work in this line was done where the opportunities were and in these times it was on college campuses and in movements of the Negro people, such as the March on Washington.

TAPLIN continued that it was a working class ideology that was presented to the college group and once they were recruited that meant they had been won over to a working class policy. He emphasized that the editorial statements of the "Young Socialist" were revolutionary socialist in policy and were Trotskyist although admittedly not Trotsky's whole program. TAPLIN said that the "Young Socialist" put forward those things believed to best serve the building of a revolutionary socialist movement in this period.

TAPLIN was followed by an unidentified female speaker who attacked the speech given by MIKE KOVACS the previous evening. She said that he represented very little in the youth movement, just two people in NYC, who were overcome by pessimism. She cited the disagreement of the majority of the Young Socialist Alliance (YSA) with KOVACS. The speaker continued that the dispute between the majority and minority faction in the SWP was not going to be carried over into the youth movement and would not be discussed in the youth movement.

She stated further that KOVACS was wrong in thinking that just because a person was in college he was of the petty bourgeois element. She said that the type of opposition varied on different campuses in that on some it was easy to get into discussion groups and in some it was not.

The speaker concluded by saying that if nothing else was accomplished in the past two years, at least there had been a start on building and consolidating leadership in the revolutionary youth movement and a major role had been played in blocking any nationwide formation of a Stalinist youth group.

NY 2434-S* was unable to furnish the name of the next speaker, but [REDACTED] it can be determined that he was CARL FEINGOLD. b7D

Continuing the discussion on youth, FEINGOLD said that the "Young Socialist" would in the future clearly establish its line as a revolutionary socialist paper in coordination with its regroupment line.

He further said that there had been a number of changes in the past year, one being that the CP had pulled their youth out of the Broad Independent youth organizations and created their own underground secret discussion groups. A second change was the fusion of the social democrats with the Snaertmanite groups (YSL-WPSL), who were now attempting to challenge the authority that "we" have had in the youth field for the past year.

FEINGOLD said this made it necessary to tighten up the youth movement and for the "Young Socialist" supporters to come out with a stronger line against social democracy and against the Stalinists who have come out into the open.

This battle would have to be fought on the college campuses, according to the speaker.

NY 2434-S* was unable to furnish the name of the next speaker, but [REDACTED] it can be determined that he was WINSTON COPELAND. b7D

COPELAND spoke briefly in rebuttal to Comrade ALLEN in regard to the tactic of going into colleges to rescue the students from the bourgeoisie.

The following speaker, who could not be identified by NY 2434-S*, was DAN ROBERTS, [REDACTED]

Also speaking on the orientation of the youth movement towards college campuses. ROBERTS said that entire unions had been taken over by the CP in the upsurge of their movement by virtue of the fact that they had a large student representation. He said that the CP had taken all they could out of the student movement to use as cadres in the building of influence in the trade unions.

That, according to ROBERTS, is what the SWP youth program was proposing. He praised the tour of TIM WOLFGARTH, which he saw as an opportunity for the SWP to pick up from 100 to 300 candidates, who at some future date could be deployed where the party wished to use them.

NY 2434-C* could not furnish the name of the next speaker, but [REDACTED] this was JOSEPH HANSEN. b7D

HANSEN criticized the Marcyste minority position, saying that their line did not work out in the youth field whereas the regroupment line of the majority had. He pointed out that circumstances had changed which had not been recognized by the minority. HANSEN stated that tactical adjustments were made according to the prevailing situation but the policy remained the same, which was the attempt to recruit people moving in the left direction, in our direction."

He continued that if the program advocated by MARCY was followed it would result in the handing over of the campus youth to the social democrats and the Stalinists. HANSEN said that it was on the campus that the challenge was and that in the estimation of the SWP majority there were a lot of proletarian youth there at this time. He said that he was one once himself.

NY 2434-C* could not furnish the identity of the next speaker, but [REDACTED] he was JAMES F. CANNON. b7D

CANNON emphasized that youth work on the campus was more important today than ever because there was a far greater percentage of youth of proletariat and lower petty bourgeoisie there than ever before. CANNON concluded by praising the SWP regroupment policy.

The next speaker was a woman whose name could not be furnished by NY 2434-S*, but [REDACTED] can be determined to be COLE COOLEY. b7D

COOLEY said she agreed with the comments of 'Comrade CANNON' on youth work. She then cited an example which occurred in the NY Local of the SWP at a time when she was chairman of its Youth Committee. She said that Comrade DAVE MILLES had submitted a memorandum on youth work to the Political Committee in November or December, at a time prior to the 20th Congress. COOLEY said she later wrote to FARRELL DOBBS, asking what the evaluation of the Political Committee had been, but had received no answer. When she was finally able to discuss this with DOBBS, she said that the 20th Congress had taken place and implied that the value of the MILLES memorandum had been lost.

COOLEY claimed that the youth of this country felt that they were an exploited community. She decried the attitude of the press toward youth in that the impression was created that all the youth were juvenile delinquents. COOLEY claimed that several students in Brooklyn high schools had been threatened in the past with the withholding of their graduation certificates because they refused to sign loyalty oaths. She said that if the Party had an active youth group they could have gotten in touch with these youngsters. Another issue cited by COOLEY concerned a proposal by MEC that there be a curfew for everybody under the age of 18. She said that in her daughter's high school the CP got out a leaflet protesting the curfew, which was so successful that her daughter was hardly able to get a copy to take home.

COOLEY said that there were opportunities for the SWP in the youth field because the threat of being drafted and economic discrimination made youth feel insecure.

COWLEY further stated that while she agreed work on college campuses was important, the SWP should also consider working in high schools and vocational schools of big cities and in neighborhoods where there are issues to be exploited.

According to NY 2434-S* the next speaker was SAM MARCY, who began his talk by referring to the point made by "Comrade CANNON" concerning the change in the character of campuses. MARCY agreed that there were more working class youth on college campuses, but questioned whether their orientation was toward the working class.

MARCY then said he wanted to speak of youth work in the Buffalo branch, beginning with the "great class struggle" which took place in 1950 (?). He said that at that time 17,000 workers were in the midst of a witch hunt which was well known throughout the US. He said that the majority group of the SWP had never given due credit to the way the Buffalo SWP branch conducted itself during this period.

MARCY said that it was the youth who had carried on the struggle in Buffalo, trying to win the Negro people to some cause. He said it was a few young people with imagination in Buffalo who were able to engineer a school strike on behalf of the mothers of Little Rock, Arkansas. MARCY claimed that mass demonstrations, initiated by the SWP in Buffalo, had been recorded in every Negro newspaper in the country and had received the least publicity in the SWP newspaper, "The Militant." At this point, MARCY cried out "Shame on you DAN ROBERTS, and the others." (ROBERTS is Editor of "The Militant.")

MARCY said that thanks to the work of the Buffalo youth, for the first time there is a Negro organization of mothers who are trained to talk to city officials and able to organize brigades to take care of their interests.

Concluding, MARCY said, "What does the you'd propose to do? To do what TROTSKY says to do - to aid in the class struggle of the adults."

The next speaker cannot be identified from information furnished by NY 2434-S*, but is known to be TOM KERRY, [REDACTED]

KERRY took exception to MARCY's report, saying that Buffalo had some wonderful youth comrades, but they did not have a youth group and had not even tried. He said he had never met any of the few Buffalo youngsters who took the SWP youth policy seriously, which he did not like at all. He said that his contacts in this regard demonstrated that some of the youth in the party had been misled.

The next speaker, according to NY 2434-S*, was "Comrade DEB from Chicago (CLAUDE DE BRUCE).

In Chicago, according to DE BRUCE, the SWP branch was very much interested in the youth question. He said that some years ago they had lost six of their youth to the social democrats, but had already won back three and were in the process of winning a fourth through the regroupment policy.

He said that two good youths had been recruited and two more had been attracted, who were now attending classes regularly.

He said the basic idea of the SWP should be to reach people at their own level and orient them in the right direction. He said, further, that it was not a question of what you have been, but what you are today and what you are going to do in the revolutionary movement.

The next speaker could not be identified by NY 2434-S*, but [REDACTED] was DAVID WEISS. b7D

WEISS said that the youth movement in Philadelphia was led by two young comrades, one of whom had been in the Party less than one year and the other less than six months.

WEISS then referred to a talk previously given by MIKE KOVACS and advised him to follow a policy of Party loyalty and to take the time to learn and to keep an open mind. He suggested that KOVACS follow the leadership of the majority.

According to NY 2484-S*, the next speaker was LONNIE (CROSS).

CROSS supported the minority position, saying that there was no truth in the claim that the minority group had turned their back on the youth movement. He said that there had been a youth group in Buffalo, but this group was destroyed by the FBI and other "agents of intimidation" in the Buffalo community. He said that he believed that the SWP should concentrate their attention on the youth and on the workers who would listen to the SWP line and work as vigorously for it as they could.

CROSS then told of a young student in mathematics in Atlanta, Georgia, who had joined the Party about one year ago. He said this unnamed individual had also worked for the Sobell Committee. He said that the Party must be built wherever possible and colleges and universities in the South had given the SWP a chance to get to some people. He predicted that while recruitment was in the one's and two's today, it would be in the thousands in the future. CROSS said that it was to be expected that the work started in the South was modest now, but the great tragedy was that the SWP did not have the forces to go to all the areas where they had contacts. He said that the Party wanted to reach out and bring in to the revolutionary Party all those interested.

The next speaker could not be identified by NY 2484-S*, but [REDACTED] it was TIM WOLFORTH, giving the summary on the youth report. b7D

Referring to Denver, WOLFORTH said that a socialist youth movement had been started there which was broken up by the FBI. He said that a nucleus remained, however, which could be the beginning of an SWP group in Denver.

WONLFORTH said that if the CP wanted to build their youth group they would have to seal out the SWP youth and if that were done the CP would be sealing out all other socialist youth.

WONLFORTH said that the long range perspective was to build a youth cadre largely on the campus. He said that a good Bolshevik would do what "Comrade LOHME" had done, stay on the campus if he had political opportunities there. WONLFORTH then launched into an attack on MIKE KOVACS who he said acted in a politically irresponsible manner when he left the campus of College of the City of NY (CCNY). WONLFORTH described this as the most important political campus in the country in view of the fact that it was controlled by the Stalinists, lock, stock and barrel. He said that KOVACS had left CCNY without consulting the other comrades. WONLFORTH said, further, "He lasted two weeks and he calls himself a Bolshevik! We are proud of those who stay on the campus and do political work for us."

According to NY 2434-S*, following WONLFORTH's summary, the chairman called for a vote to approve the general line of either the youth report of WONLFORTH (the majority position) or the MAPCY report on youth work (the minority position).

Following the roll call, according to NY 2434-S*, it was voted to recess and reconvene at 2:00 p.m.

When the plenum reconvened the chairman announced the result of the vote on the youth report as follows:

For the majority - 12 regular and 15 consultative for a total of 27.

For the minority - 3 regular and 2 consultative for a total of 5.

It was then announced that the next point on the agenda would be a report by FARMILL DOBBS on the international situation.

DOBBS' report has previously been set forth in the form of a letterhead memorandum and submitted to the Bureau and appropriate files with IS' letter dated 12/29/58.

A motion was unanimously passed at the conclusion of DOBBS' talk to adopt the line of his report.

An individual who could not be identified by NY 2434-S* then commented that a number of comrades on the West Coast had joined the SWP since the split of 1953, and were not clear as to the origin of the split and the problems that were involved. He said these comrades found it difficult to grasp what had taken place and suggested that the background to the split should be set forth for these people so there would be no questions in their minds as to what was involved at the time of the split.

The chairman announced that following a five minute recess the next item on the agenda would be the organizational report of Comrade TOM KERRY.

KERRY began by saying that he would have criticism to make in the course of his report and assumed that there would be criticism made in return of the SWP National Office, which was only natural following the new experience and complicated tactical problems that the Party had gone through in the past year. He said he wanted the comrades to feel free to criticize or comment as they pleased.

KERRY then said he wished to deal with the charge made by the minority faction against the majority that the SWP was being liquidated. KERRY said that at the time of the party split in 1953, the present minority and majority factions had fought liquidationism together and at that time a different situation had prevailed than at present. The minority of that period, according to KERRY, had concentrated an attack upon the theoretical foundation of Trotskyism in America the application of the Trotskyist program as formulated in "The American Theses." KERRY said the American Theses dealt with what kind of a party the SWP was aiming to build in this country and quoted from the first paragraph of Chapter 5 of the American Theses as follows:

"The decisive instrument of the proletarian revolution is the party of the class-conscious vanguard. Failing the leadership of such a party, the most favorable revolutionary situation which arises from objective circumstances cannot be carried through to the final victory of the proletariat and the beginnings of a planned organization of society on a socialist foundation."

KERRY said this principle was demonstrated in the 1917 Russian Revolution as well as from the world experience of wars, revolutions and colonial uprisings, which began with the outbreak of the First World War in 1914. He said that this concept was the basic strategic line of the Trotskyist movement in the US. The SWP, he said, opposed the concept that somehow or other the CP would develop a revolutionary orientation and that through their leadership a victory was going to be achieved as it was claimed had happened in Eastern Europe and China. KERRY continued, "He said, 'In this country as in every industrial country it will not be led to a successful conclusion unless it is led by a Leninist party, a combat party, a Trotskyist party.'"

KERRY said that while that was the strategic line, there was still the question of tactics, which involved the method of building the above described party. He continued that in the minority opposition of 1953, it was boiled down to this group advocating a propaganda orientation for the SWP instead of a party of action. This proposal, according to KERRY, was evidence of the 1953 minority's intention to liquidate the revolutionary party. This intention, he said, was specifically manifested by their opposition to election campaigns. The 1953 minority claimed it was preposterous for the SWP to undertake election campaigns with its own small group and advocated instead joining up with the ALP. They did not, however, according to KERRY, want to go into the ALP in order to build a revolutionary socialist party; they wanted to liquidate the SWP, and that is why they were opposed by the SWP majority.

It is within the framework of this background that the present question of the SWP regroupment tactic should be understood. He said there had been no retreat from the American Thesis and the SWP still aimed to "build the Leninist combat party, the party that will lead ... the American working class to a successful outcome of the proletariat revolution."

KERRY said that the regroupment policy of the SWP was intended to accomplish the above and that was what the dispute between the majority and minority factions was about.

KERRY then took up the electoral activities of the SWP. He said that during 1956, the party, with branches in only 12 states, had conducted election campaigns in nine of them. He said that the National Office had urged each of its branches to engage in electoral activity wherever possible. KERRY said it was a period when practically every other radical tendency had abandoned the electoral arena and that in cases where a branch could not enter electoral activities under its own resources the National Office had offered help. He said this was in line with the whole regroupment policy, to gather together in an electoral coalition wherever viable forces were available.

This coalition tactic was only possible in California, Illinois, Washington, and New York, according to KERRY. He cited Pennsylvania as an area where forces were sent in to help the comrades there in their electoral activities because the branch did not have the personnel or finances to handle it. KERRY said that the National Office had also sent money and people into Michigan in order to permit the comrades there to engage in their election campaign.

The SWP also put about \$2,000 into the United Socialist ticket in NY State, he said, and claimed it was \$2,000 well spent.

At the time of the 20th Congress of the CPSU, KERRY stated, the problem confronting the SWP was that of establishing some degree of fraternization with the ranks of the CP. He said that contact with this sealed-off CP membership was not for the purpose of conciliation or liquidation but a struggle to present the Trotskyist point of view in discussion with the ranks of the CP. He said that it had been so long since the SWP had confronted Stalinists in face to face contact that it was difficult for many comrades to make this turn toward the CP, to avoid confirming by their actions the charge by the CP leadership that Trotskyists were impossible people to talk to.

KERRY said that it was here that he wished to come to the defence of the American Forum for Socialist Education (AFSE). He said that the SWP leadership had never presented the AFSE as an organization to be maintained in perpetuity.. He said that the role of the AFSE was to help break down the barriers that kept the Party from getting at the Stalinists. KERRY went on that at the very first meeting of the American Forum attended by the SWP, a differentiation took place in the whole regroupment struggle. He said that (MAX) SHACHTMAN and other social democrats were there and attempted to impose upon the AFSE a policy of excluding the CP. KERRY said that the only reason "we" were there was to get at the CP and, therefore, they fought for and won out on the non-exclusion policy. Not, he said, because the SWP had more people there but because they were able to convince A. J. MUSTE and others

that they were sincerely interested in promoting a discussion. KERRY commented in this regard that nobody had any illusion that the SMP was going to recruit MUSTE out of this, they had gone through that once before. The same went for SIDNEY LENS, according to KERRY. He said the comrades knew LENS' history and evolution and would have no truck with anybody who did not subscribe 100 per cent to the theses of the first, second and third Communist Internationals.

KERRY said that the AFSE had opened up contact with the Stalinists but by now it had outlived its usefulness.

KERRY said that a new stage had been reached in the regroupment process following the AFSE experience and the SMP was able to break into the Sobell Committee, the American Committee for the Protection of Foreign Born (ACFPB) and others because, despite CP opposition, they could not be kept out.

Later, KERRY said, contact was made with the "National Guardian" and the first opening in this regard came at a meeting of the AFSE, attended by JOHN T. MC MANUS. KERRY stated that some questions were discussed informally with MC MANUS and because the "National Guardian" was then in the process of breaking from Stalinism it was a chance to utilize his influence to have meetings, discussions and finally joint action.

When the SMP reached the stage where they could establish united socialist political action groups, they found the previous forms utilized to accomplish the original purpose no longer useful. In this new stage, KERRY said that enough minimum agreement had been reached so that developments could move from the discussion phase into the combination of action with discussion.

The problem no longer exists of breaking down barriers in order to get at the Stalinists. KERRY said that, in fact, it was reported from Cleveland in regard to their forthcoming conference that the CP was appealing for permission to get into the conference and asking whether or not the Trotskyite could let them speak and present their point of view.

KERRY stated that in 1959, there is no national action on the electoral arena or any big issue around which the SWP could unite the forces working with them. Thus it was proposed to continue discussions on a higher stage. He said that in all of the Party publications their tone had been adapted to the changes that had taken place in elements previously considered hostile and unreachable. KERRY commented that in the arsenal of Marxism a rapier was sometimes more effective than a meat cleaver.

KERRY pointed out that the regroupment development had not been even throughout the country. While in Los Angeles and NY a stage of united socialist political action had been reached, in Seattle it was found still expedient to use the front of the AFSE. In other places, he said, it was found expedient to increase contacts by use of "National Guardian" clubs and in still other areas the party was still immersed in Sobell and other committees. He commented in this regard that there are so many opportunities over now and the party had such limited forces that it was essential to drop any form which had outlived its purpose in the period of development of the regroupment process.

KERRY requested that all the SWP branches send copies of their minutes to the National Office in order that the Party headquarters would be aware of what the branches were doing in the regroupment field. He said that he noted in a recent copy of the minutes of the Los Angeles Executive Committee that this branch had decided to devote the major part of its forces to the United Committee for Socialist Political Action because this appeared to be the most promising group at this stage.

KERRY then pointed out that because of the various regroupment efforts there had been an unavoidable neglect in carrying forward the work of the institutions of the Party. He said that it was understandable, after the SWP's long isolation, to plunge wholeheartedly toward the new faces turning up at forums and meetings and to pay less attention to Party institutions.

One of the most important of these, according to KERRY, was the SWP press and publication program which he described as "the main instrument we have for effective intervention into this whole process of clarification of these important questions that have arisen in the course of our activities." In regard to Pioneer Publishers, KERRY said there had been a tremendous increase in sales in 1957 over 1956. There had been a decrease in 1958 as compared to 1957, although still better than 1956. KERRY said he believed one of the reasons for the 1958 figure is the fact that many new publications, which provisions had been made for with "our comrades over in Great Britain," had not been delivered. He said that the British Trotskyites had their own problems and the books and pamphlets ordered by the SWP had made great demands upon their forces and resources. KERRY also stated that the SWP had advanced the British \$3,000 to finance socialist publications. Further, he understood that the British were in the process now of enlarging their printing plant in order to take care of their own expanded demand as well as commitments made to the SWP.

KERRY said that he had in his possession a copy of the book, "The Notebook of an Agitator" (by JAMES P. CANNON) and, depending upon the customs officials, there would soon be a quantity large enough to distribute throughout the entire country. He said that when material such as this became available the figures for Pioneer Publishers would show a great improvement.

Now in preparation in the SWP's own print shop is a pamphlet written by (WILLIAM) WATDE entitled, according to KERRY, "The Long View of History." KERRY commented that the print shop had been reorganized with the entire responsibility turned over to BOB (CHESTER) and help would be given him when available.

KERRY said that Comrade (ART) PREIS was now in the process of writing a book which KERRY felt would be an historic landmark in the literature of the US on the labor movement. He said this was based on a series of articles written by PREIS in "The Militant" during 1955, on the history of the CIO. He continued that PREIS had become ill and so he had been relieved from the responsibility of putting out "The Militant" in order that he could devote all available time to finishing his book, "Labor's Giant Step - The History of the CIO." KERRY said this publication would be a powerful weapon in "our" hands when the young workers could be furnished with a "genuine Marxist analysis" of the development of the CIO. KERRY said that PREIS had promised the book would be finished by February (1959).

Continuing, KERRY said that another important SWP publication, "In Defense of Marxism," was out of print and that one of the comrades who had received a settlement on a case had loaned \$2,000 at no interest over a long period of time to finance a new edition.

KERRY said that an assist had been given the SWP by the University of Michigan, which published "The History" (of the Russian Revolution); by RUSSELL, who published "Literature and Revolution", and by HARVARD, who published "Trotsky's Diary." KERRY said that January, 1959, would be the first anniversary of the death of LAURA GREY and that the project of publishing a book of her cartoons had not been followed through due to financial reasons. He said that \$400.00 had, however, been set aside in a separate account and that in January the SWP would call upon its branches to hold special memorial affairs for the purpose of raising funds to publish the LAURA GREY book. He said that such a book would be a rich contribution to the literature of the Trotskyist movement in this country.

Turning to the SWP newspaper, "The Militant," KERRY emphasized the important role it played in the regroupment struggle taking place throughout the entire world. He said that the paper received communications from throughout the world citing the value of "The Militant" to these people. KERRY read, as an example, a letter received from an unnamed individual in Australia who said that distribution of "The Militant" had been a stimulant to attempts at building a revolutionary Marxist group.

KERRY then gave figures on the circulation of "The Militant" in foreign countries as follows:

In Canada - 24 subscribers plus a bundle order of 35.
In South America - 20 subscribers plus a bundle order
of 35
Total foreign - 123 subscribers - with a total of
225 copies distributed each week.

KERRY pointed out that most of this foreign distribution was financed by the SWP because of exchange difficulties. He described this as a subsidy that had to be carried on as part of our obligation and contribution to the development of the world movement of Trotskyism.

KERRY said that "The Militant" would, during 1959, have to carry on a big political offensive to deal with the problems confronting the American working class movement. He said that plans were being made to intervene more effectively on the elements already developed as part of the SWP periphery in the regroupment process and to make the paper more effective for spreading the program and ideas of the Party.

KERRY said that there were subscribers to "The Militant" in 30 states in the country where there were no SWP branches, which meant that "The Militant" went to subscribers in 42 states, and if Alaska was counted there was one additional subscriber there.

KERRY stated that the SWP had demonstrated its combat character by accepting the tremendous load during 1978 of intervening in the electoral arena and sending FARRELL DOBBS abroad for six months. Yet, KERRY said, he felt that sufficient attention had not been paid to the circulation of "The Militant" during this period. He said there was a total of 735 subscribers to the paper in this country, which was a very small number. Of the 735, KERRY pointed out that 254 have been acquired since the beginning of the Party's recent subscription campaign.

He said that every branch in the party should put sales of "The Militant" on the agenda of every branch meeting whether or not there was a campaign going on. KERRY continued that the expansion of the paper was an absolute prerequisite to the "effective intervention in the regroupment process and in building a revolutionary party in this country." KERRY said that the quotas accepted by the branches in the subscription campaign were too small, totaling about 800, with Los Angeles taking 300 and NY 150.

In regard to the SWP theoretical magazine, "International Socialist Review," KERRY said that this was a special problem inasmuch as it has been too much of a one man operation. He said that JOE (HANSEN) had been editor, promotion manager, etc., and it would be necessary to develop promotion efforts and ways and means of working with the branches in expanding the magazine.

KERRY next took up the question of SWP recruitment, saying that in 1954, after the split in the party, a re-registration showed that 137 members were lost in the split. In the ten month period from January to November, 1957, KERRY said that the SWP counted 72 new recruits, 34 of them from the CP. In the ten month period from January to November, 1958, he said that there had been recorded 52 recruits, while 18 had dropped from the Party. KERRY pointed out that the figure of 52, however, represented only a partial figure because many

branches had submitted reports only up to the month of July. He said he felt safe in saying that there were at least 75 recruits made in the ten month period from January to November, 1958.

KERRY said that Los Angeles was now the largest branch in the country with 102 members, which was three more than the NY Local had. He said that Los Angeles in 1957, over a ten month period recruited 17 new members, which means that they were able to start earlier in taking advantage of recruiting possibilities open to the SWP. From the period January through July, 1958, he said that Los Angeles reported 12 recruits and undoubtedly the following months would show an additional number.

In comparison, KERRY said that NY, during the first ten months of 1957, had gained ten recruits and through September, 1958, had acquired 12 recruits.

KERRY stated that the most phenomenal growth, however, had been in the Oakland branch. He said that a recent footnote to a letter he got from Oakland stated as follows:

"P.S. To add to the statistics of my last letter, another recruit last night from (unintelligible). Membership 21 now. Increase over August, 1957, 143 per cent. Recruitment proceeds in a peculiar way here; they join up."

KERRY said this actually was not peculiar because in the course of the regroupment campaign there were discovered individuals who came to the stage of being in favor of a concept of regroupment into a revolutionary socialist party and realized that in order to do something about it they had to join the SWP. He predicted that many more would make this decision, which was a natural process of the regroupment policy. KERRY said that these people were not assured that the new group would not be the SWP, but it was asked if these individuals wanted to work toward the goal of regroupment. If this was the case they were convinced that the best way to do it was to join the SWP.

Returning to the Oakland situation, KERRY said that he remembered in 1950 there were only six or seven people in this branch and that some of the new recruits were very fine people. One, JEFF WHITE, KERRY said he had never met but through reading his communications he knew him to be a workers leader. He said that WHITE was capable of making political analyses. He went on to say that he had been trying to find out what was taking place at a conference in San Francisco, after becoming disturbed about the press releases being issued. KERRY said he got more information through reading copies of JEFF WHITE's letters, which were forwarded on to him, that he did from the whole San Francisco branch.

KERRY then said that he'd like to comment on GOGATCH (ph.) and read a report that LARRY (TRAINOR) had sent down a year ago. KERRY said this was a report on the CP of New England and the crisis of 1956, which the SWP had in turn sent out to its National Committee members. At the time of the report, TRAINOR told KERRY that the individual who wrote the report was already interested enough to read SWP material and to discuss things with Party members but was not ready to join the Party. The individual then went to California, spend a year around the San Francisco Bay area and joined the SWP at the San Francisco Conference. After he became a member of the Party, TRAINOR said that he felt this individual, judging from his writings, would be a first class worker for the SWP. KERRY quoted an observation made by this recruit in January, 1956, as follows, "I feel that in dealing with CP'ers and ex-CP'ers, the greatest assets of the SWP are its unquestionable integrity and, when not treated as divine revelation, the works of LEON TROTSKY. Its greatest weakness is the heritage of its own isolation." KERRY said that this type of individual was symptomatic of the kind of element the SWP was recruiting through its regroupment policy. He continued, "People like that could go build a revolutionary party, the Leninist party, the combat party that will make this revolution."

In addition to the established SWP branches, KERRY pointed out that there were new groups. He said there were three young comrades in the Denver group who had amazed HAROLD DAVIES, when this individual was on tour, by their activities. KERRY said these three youngsters organized a big meeting, got attention from the "Denver Rocky Mountain News," radio and television stations, and had DAVIES running around like mad to a big meeting of the Denver Labor Alliance as well as a meeting of their own group. DAVIES, according to KERRY, said that if Denver, his first stop, was like the rest of the country, he'd never make the end of his tour.

In San Diego, according to KERRY, "we" now have a group of nine, who were not formally constituted as a party. He said that comrades were sent down from Los Angeles as well as BILL KIRT and his wife, former Buffalo SWP members. KERRY said he gathered that San Diego had a lively branch inasmuch as they had made a pledge of \$100 to the party fund drive, had formed a "National Guardian" Club and had entered into "The Militant" subscription campaign. He commented that it was just a matter of formality to establish a branch of the party in San Diego.

"In Connecticut," KERRY said, "we have several comrades, one who came from California and one other who was reactivated, who have now assembled a whole circle of people in that area." He continued that two youngsters in Connecticut had been signed up for the party but were coming back to NY to become a part of the NY local.

KERRY then discussed work being done by LONNIE (CROSS) among the comrades in the South, first in Montgomery at Tuskegee and now in Georgia. He described this as magnificent work, praising a comrade who would go into that area to do political work, make contacts and talk to people about socialism in these times. He predicted that the political effect of this would spread because CROSS was associated with teachers and students, who, whether they left school or stayed there, would carry on a good work. KERRY said further that a \$200 pledge from these people to the SWP fund was somewhat to emulate.

KERRY said that the process of slow bleeding, when the SWP lost its periphery and "carried on in splendid isolation, had now ended.

Turning to SWP financing, KERRY said that he realized what the huge financial burden, two \$20,000 fund drives, would mean on such a small party, but when this was projected for 1958 it was felt that extra sacrifices would be warranted by the great political opportunities opening up. He went on to say that many contacts were made and the Party had developed a periphery, but unfortunately a large portion of that periphery had prior financial obligations to such institutions as "National Guardian," the Sobell Committee and the ACPFB.

Thus, said KERRY, the general problem still remains, that the Party ran at a deficit of around \$35,000 per year. This was the problem that the SWP leadership was attempting to solve through its special fund drives.

KERRY said that an additional financial obligation had developed which was helping out the youth group and in view of this and other factors it was going to become necessary for the Party to retrench as much as possible without sacrificing opportunities open to it. He urged those present to see to it when they returned to their branches that the branch quota on the fund drive was completed in full and on time. He pointed out that because this fund drive was several thousand dollars less than the previous \$20,000 fund drive, additional budgetary problems would occur. KERRY again urged all the branches to complete their quotas of the fund drive and have the money into national headquarters by December 18, to keep the Party from being in serious trouble.

According to NY 24,4-S*, KERRY ended his speech on this point and the floor was turned over to discussion, with the first speaker being SAM MARCY.

MARCY claimed that the reason that LONNIE CROSS had been successful in the South stemmed from proposals made by MARCY in regard to the Negro question a year or two ago when he spoke in favor of emphasis on working with Negroes rather than the regroupment program. He said that in the long run one of the acid tests of a revolutionary party was its answer on the Negro question and if any credit was claimed by the SWP in this regard it should be shared equally between the majority and MARCY minority faction.

Referring to the "American Theses," discussed by KERRY, MARCY claimed that this had not united the SWP, on the contrary it had divided the party.

MARCY said he would recommend to his minority supporters not to vote for KERRY's organizational report because it was political in character. He went on to say that he was in the process of studying Bolshevik parties to ascertain what the political issues were that caused splits in parties. In referring to the position of the minority faction, MARCY said, one, "we want to stay in the party" and two, "we want to have a Bolshevik Democratic centralist right to fight for our points of view. A Bolshevik cannot live unless he fights for his views." He said that although there were two competing tendencies in the SWP, the majority had the responsibility of maintaining the Bolshevik party. He said that the majority should allow "competitive coexistence ideologically" within the Party.

The next speaker, according to NY 2434-S*, WAS referred to as a chartered member of the SWP who WAS PRESENT at the plenum. (This was HENRY SCHULTZ, [REDACTED] 67D

SCHULTZ spoke in favor of the organizational report given by TOM KERRY and in favor of the regroupment policy in general. He said that in Minneapolis they had been successful in having a CP leader, CARL ROSS, participate in a symposium in Minneapolis, which had been the biggest gathering of the left in Minneapolis in over a decade.

SCHWITZ then discussed the visit of HAROLD DAVIES to Minneapolis, saying this had resulted in the greatest radical turnout in 20 years with over 700 people attending. SCHWITZ said that DAVIES also spoke on the radio for three hours and did a job that the SWP could not do.

The next speaker, according to NY 2434-S*, was JOYCE COWLEY, who criticized the SWP regroupment policy because of what she described as a lack of programmatic clarity.

COWLEY was followed by DOROTHY MARCY, according to NY 2434-S*.

DOROTHY MARCY said that Comrade MIKE (SOVACS), a youth group member, had heard from SWP members before he joined the youth group that the Buffalo branch membership was a "screwy group" and that SAM MARCY was "a louse from Buffalo." DOROTHY MARCY criticized this procedure and called for party discipline in regard to youth matters.

An unknown male speaker at this time urged the individual speaking to stick to the points on the agenda.

The next speaker, according to NY 2434-S*, WAS DICK GARZA, who spoke of the effect on the SWP FROM THE regroupment campaign.

GARZA said the NY Local of the SWP had been completely transformed in the past year. GARZA said the ELECTORAL petition campaign had resulted in picking up MANY NEW PEOPLE and furnishing a good source for new members.

The following speaker, according to NY 2434-S*, was SOREN TOROJAN of St. Louis, who said that in his SECOND year in the party he was impressed by its democratic processes. The speaker then went on to discuss the activities of the SWP in the St. Louis area.

The next speaker could not be identified by NY 2434-S*, but [REDACTED] is known to be TED DOSTAL. **b7D**

DOSTAL spoke of unemployment conditions in Youngstown, Ohio, saying that the depression had started there over 18 months ago and that the crisis of capitalism had begun. He advocated that every moment be spent in thinking and working on how to develop the mass movement.

DOSTAL said there was no youth group or socialist group at Youngstown University and advocated working within labor unions.

DOSTAL described the "Militant Steel Worker" as being mailed regularly to all the steel centers in the country. DOSTAL said there was an area 50 miles south of Youngstown where "we" have a group of six steel workers who are working closely with "us" in the left-wing faction of a large steel local of over 6,000 members. DOSTAL said that the "Militant Steel Worker" had considerable influence in that area and in the Youngstown area and had been a counterweight to publications of the CP in those areas.

With the conclusion of the discussion period, according to NY 2434-S*, the chairman of the plenum proposed that we consider the plenum as the opening of the pre-convention discussion . . . The convention date will be set tentatively for the latter part of May (1959). This proposal was approved by the plenum.

The final speaker of the plenum could not be identified by NY 2434-S*, but, [REDACTED] can be determined to be TOI KERRY. **b7D**

KERRY criticized the minority faction for their charges of liquidationism against the leadership of the SWP. He spoke of the conflicts in the various SWP branches and called for unity.

Referring to the HAROLD DAVIES tour KERRY said that when the SWP invited dignitaries to this country to speak on behalf of the party, that the branches should take full advantage of this by charging admission to the talks to assure that the operation would not lose money.

The plenum adjourned at 6:00 p.m., according to NY 2534-S*, with the delegates present joining in the singing of the "Internationale."

"TO MEN & WOMEN OF GOOD WILL - CHRISTMAS AMNESTY FOR
"MORTON SOBELL
"A PETITION TO THE PRESIDENT OF THE UNITED STATES . .

"TEXT OF STATEMENT ON THE MORTON SOBELL CASE BY
CARLTON BEALS, author, lecturer, authority on
Mexico and the Carribean area, and former consultant
to the U.S. government on Mexican affairs. Mr.
BEALS calls SOBELL's conviction a 'brazen denial
of elementary rights' and 'so absurd it is incredible'
in the following letter to Mrs. MORTON SOBELL,
dated 8/25/58.

"Thank you for sending me the transcript of
the 'conspiracy' trial which resulted in your
husband being sentenced to thirty years in prison
and the transcript of the arguments on appeal.

"I have read every word of the 1715 pages with
care. Only a relatively few pages deal with
testimony concerning SOBELL, and they contain the
testimony of only one witness, DAN ELITCHER. Other-
wise no evidence whatever was presented against
your husband.

"Another brief action deals with the trip of
SOBELL and his wife and two children to Mexico,
in an effort to prove that he was fleeing from
justice.

"The indictment itself contains not one mention
of overt acts by SOBELL, as is required by law.
His attorneys were forced to enter the courtroom
wholly unprepared, almost as spectators, without
any knowledge of the specific charges or what
evidence they might have to refute.

"As a result the prosecution, by distortion, falsification and suppression, was able to give his trip to Mexico the appearance of flight. There is no doubt SOBELL was laboring under considerable fear, but even had he fled to Mexico illegally, which he did not, this under law does not constitute guilt of any crime. Thus it was not brought out at the trial:

"(1) That he went to Mexico under his own name and reported to American authorities before leaving.

"(2) That he was not under indictment and was not charged with any crime when he left, only when he returned.

"(3) That he had gone legally to Mexico. In court it was stated that he had no visa, which was technically correct, thus implying he had entered Mexico illegally.

"Actually he had a legal tourist card, all that is required, and went through the Mexican immigration offices and customs at the border in the usual legal manner.

"(4) That he was never deported from Mexico, although an American immigration official presented evidence, wholly erroneous, to that effect.

"(5) That actually he was kidnapped with the connivance of U.S. Federal agents, was brutally beaten until unconscious, that he was taken to the border in violation of Mexican and U.S. Laws and treaties.

"(6) That he was taken across the border and spirited across in the dead of night, his abductors being joined by prearrangement by a Federal Marshall. That his entire family was similarly kidnapped and whisked across the border at night.

"(7) That this act was protested by the head of Mexican Immigration.

"(8) That investigations by the Mexican Consul in Laredo confirmed these criminal acts.

"(9) That the Mexican Department of Immigration and the Department of Gobernacion both provided documentary evidence, not presented at the trial, that SOBELL had never been deported.

"The single witness produced by the State against SOBELL, MAX ELITCHER, was a self-confessed 'perjurer' and 'liar'. At various times he had also been under psychoanalytical treatment.


"During his testimony only two sentences remotely suggest, and these are purely hearsay, that SOBELL had any connection with any alleged conspiracy. Also, ELITCHER testified that one evening he accompanied SOBELL on a ten minute ride to the vicinity of the accused JULIUS ROSENBERG's New York apartment to deliver a can (contents unknown) presumably to ROSENBERG. No direct evidence, either oral or material, was given at the trial that SOBELL even knew any atomic secrets, or that he gave any atomic or any other secrets to ROSENBERG or anybody else. His crime, as presented at the trial, seemed to consist of having been possibly a Communist and fellow-traveler, that he had been a fellow engineering student at New York City College, that over a period of ten years he had seen ROSENBERG half a dozen times. He knew none of the others involved in the trial and no other witness except ELITCHER. His name was not mentioned by any other witness.

"In short, no oral, material or even remotely circumstantial evidence was ever presented in court to warrant his conviction or his sentencing. It is so absurd it is incredible. I know of no other instance of miscarriage of justice, or more brazen denial of elementary human rights, in the history of jurisprudence in this or any other country.

"Frankly, and this may sound harsh to you given your personal interest in the matter, I started reading this transcript with the hope that I would discover evidence beyond a reasonable doubt, that he was guilty, for I was anxious to preserve my illusions concerning the noble processes of American justice."

"The above statement speaks for itself. Justice is long overdue. Please add your name. Ask your friends and neighbors to do the same. Return the list below before December 15, so they may be presented together with hundreds of others to the President.

The Philadelphia Jewish Cultural Clubs (PJCC), aka Jewish Cultural Clubs of Philadelphia, were formed [REDACTED]. Actually the basis for the formation of the PJCC was laid [REDACTED] when it appeared certain that the International Workers Order (IWO) would be dissolved pursuant to an order of liquidation by the New York state courts.

SOL ROTENBERG, former Executive Director, Philadelphia Jewish People's Fraternal Order (JFFO), IWO, in late 1953 laid the groundwork for the formation of the PJCC, using as a nucleus former JFFO, IWO members. In early 1954, he provided leadership in the establishment of the PJCC, and also set up the Coordinating Committee, PJCC, composed of delegates from the Culture Clubs of the PJCC. The purpose of this committee was to provide leadership, long-range planning and coordination of the activities of the various culture clubs.

A second confidential informant [REDACTED] advised that SOL ROTENBERG was a member of [REDACTED] Communist Party of Eastern Pennsylvania and Delaware (CPEPD) [REDACTED] this informant advised that [REDACTED] ROTENBERG was a member of the District Committee, CPEPD. **b7D**

A third confidential informant advised [REDACTED] that the PJCC continues to be active in Philadelphia, with the Sholem Aleichem Club being the largest, most active and aggressive in the PJCC. **b7D**

A confidential informant [redacted] advised that he learned [redacted] that TA was an enlarged broad-type group which contained several LYL members. This informant [redacted] advised the Philadelphia LYL was dissolved on 10/21/56.



[REDACTED] stated that the persons thus selected would form a national committee to work in behalf of MORTON SOBELL, which committee would determine the over-all policy of the organization. [REDACTED] further stated that from the framework of the National Committee would be picked an Executive Board, which would be charged with the implementation of the over-all policy established by the National Committee, a characterization of which is contained in the appendix hereto.

"It has occurred to me, who enjoys the privileges of American life and society, how dangerously close we are at various times to destroying those things we value most. While I do not profess knowing all the details of the ROSENBERGS' and the SOBELL'S intentions and wishes - I couldn't even if I tried to do so - I am concerned about what the courts of America sometimes do. Certainly I know as you do that the courts are seeking justice, but I cherish as you do the right never to take for granted or to assume that judgments of a court are beyond analysis, recall, and correction.

"The SOBELL case is one of those troublesome affairs in our history that ought to give us pause. One more man in jail may not seem so much to anyone of us; but a little inquiry will show you, I believe, that the SOBELL case is more important than just another jail sentence. This kind of case brings us to the very roots of human rights. SOBELL's case is of importance to everyone who wants to be sure that evidence against men is clear, unequivocal, and not a function of hysteria and political persuasion.

"For reasons like these, I commend the interest of MORTON SOBELL to you. I suspect that it lies in your interest and mine to be concerned early and late with such questions. If justice is to be done in our land, everyone must be concerned not only with the cases where there is not doubt, but above all, with the cases where there is uncertainty and where political pressures tend always to operate.

To remedy the injustice of the case of MORTON SOBELL will take the same courage, the same devotion to right, and justice in the face of prejudice and emotionalism.

"We feel deeply that this case is a blot on the conscience of America. Because we believe that you have the necessary courage and devotion to justice, we urge you to receive ROSE SOBELL, MORTON'S mother. Mrs SOBELL is now in Washington seeking justice for Her son. Please see and talk to her, and study the facts of this case. We feel sure you will then do everything in your power to hold her and others to right this wrong.

"We have within the past year learned the facts in the MORTON SOBELL Case. There is overwhelming evidence that MORTON SOBELL is innocent and that a great injustice has been done. Not only do we feel a great concern for this man who has suffered so much unjustly, but how can any of us feel secure in our freedom while he is in prison!

"Many eminent people in the United States have given time and attention to the SOBELL Case. It certainly should have the attention and consideration of our law makers.

"Mrs. ROSE SOBELL, MORTON's mother, is in Washington this month seeing members of the Senate and Congress. I am sending her a copy of this letter and asking her to call on you.

"Will you please give the MORTON SOBELL Case your careful attention.

"Thank you.

"We are writing you now because we want you to know that we believe a great injustice has been done to MORTON SOBELL. There is overwhelming evidence that...left to rot in jail, how can any of us feel secure in our freedom?"

This letter was then concluded with the identical last two paragraphs as set forth above and was signed by JULIA E. ZUBAY and RALPH A. ZUBAY.

Also made available was a letter addressed to Mrs. ROSE SOBELL, Park Central Apartments, from ARTHUR W. HOPKINS, 513 West 25th Street, Minneapolis 5, Minnesota, and postmarked June 16, 1958. This letter contained a copy of a letter written to WALTER JUDD, House Office Building, Washington, D. C., as follows:

"Dear Congressman JUDD:

"I have been informed by the Minnesota Committee for Justice for MORTON SOBELL that Mrs. ROSE SOBELL, mother of MORTON, is striving to meet as many Congressmen as possible in order to acquaint them with the facts in the case of her son who is imprisoned at Leavenworth as a result of false testimony and mass hysteria during the ROSENBERG, Atom Spy trial.

"There are very many persons including this writer, who feel that the imprisonment of MORTON SOBELL is as great an act of injustice as was that of ALFRED DREYFUSS in France. It was proved in the Dreyfuss Case that his imprisonment was a coldly calculated political move inspired by his political enemies, and in the case of MORTON SOBELL there is a great mass of proof that his imprisonment is also politically inspired by the Reactionaries of this day.

LE SUEUR had testified at the trial of JOHN HELLMAN, Communist Party functionary in Montana, who was convicted in June, 1958, for violation of the Smith Act of 1940.

XI. APPENDIX

AMERICAN CIVIL LIBERTIES UNION

The FBI has never conducted an investigation of the American Civil Liberties Union. It is noted that the Fifth Report of the California Senate Fact-Finding Committee on Un-American Activities (1949) notes the following: "American Civil Liberties Union: Cited as heavily infiltrated with Communists and fellow travelers and frequently following the Communist Party line and defending Communists, particularly in its Los Angeles unit. (California Committee on Un-American Activities Report, 1948, pages 108-12.)"

In connection with the foregoing citation the following is noted: In January, 1955, an official of the California Senate Fact-Finding Committee on Un-American Activities advised that a representative of the American Civil Liberties Union contacted the Committee to discuss the above citation. At that time this individual advised that two members of the American Civil Liberties Union in Los Angeles had been expelled because of their pro-Communist sympathies. On May 27, 1955, a representative of the California Senate Fact-Finding Committee on Un-American Activities advised that the status of the American Civil Liberties Union, insofar as the Committee's evaluation is concerned, has not been changed and that the Committee's past characterizations of the American Civil Liberties Union remain the same.

In connection with the above, it is noted that the 34th Annual Report of the American Civil Liberties Union (for the year 1954) re-affirms the anti-Communist and anti-Fascist policy of the American Civil Liberties Union and maintains also that it will defend the civil liberties of all persons regardless of any political party, organization, denomination, race or nationality to which a person may belong.

NATIONAL LAWYERS' GUILD

The Congressional Committee on Un-American Activities Report on the National Lawyers' Guild, House Report No. 3123, dated September 21, 1950, cited the National Lawyers' Guild as a Communist front which "is the foremost legal bulwark of the Communist party, its front organizations, and controlled unions" and which "since its inception has never failed to rally to the legal defense of the Communist party and individual members thereof, including known espionage agents."

The "People's World," a West Coast Communist newspaper, on April 21, 1952, page 6, column 5, published an article entitled "Rosenberg case expert due in San Francisco," which reflected that WILLIAM A. REUBEN, identified in the article as a former public relations director for the American Civil Liberties Union and in April, 1952, a reporter for the "National Guardian," would speak in San Francisco on April 27, 1952, under the auspices of the recently organized San Francisco Provisional Committee to Secure Justice for Ethel and

Julius Rosenberg. The headquarters of the Provisional San Francisco Committee was set out as 760 Hayes Street, San Francisco..

On page 6, columns 4 and 5 of this issue, the "People's World" also printed an article which reflected that a proposition would be made at the meeting on April 27, 1952, to make the provisional committee a permanent San Francisco Committee to Secure Justice for Ethel and Julius Rosenberg.

The "People's World" on April 25, 1952, page 3, column 5, published an article which reflected that the Rosenberg Committee in New York had made an emergency appeal for funds from the San Francisco Committee, and stated that contributions and loans should be sent to the Rosenberg Committee, 246 Fifth Avenue, New York City.

A second confidential source on March 27, 1956, furnished the November, 1955 issue of the Sobell Newsletter issued by the Bay Area Council of the Sobell Committees, which published an article which stated that the BACSC would coordinate the work of the several Sobell Committees in the San Francisco area.

A third confidential source advised on September 20, 1956 that the BACSC was an integral part of the National Sobell Committee and received instructions and literature from the National Sobell Committee.

A fourth confidential source advised on January 4, 1957, that the Chairman of the East Bay Sobell Committee, one of the groups in the BACSC, stated in 1956, that there was no difference between the Northern California Council of Sobell Committees (NCCSC) and the BACSC, and that the NCCSC had been formed to focus attention on the Morton Sobell case, and, as outlying Sobell Committees were formed they would send representatives to the meetings in San Francisco.

A fifth confidential source advised on May 12, 1958, that the BACSC is continuing to function and is planning BACSC affairs for the coming summer months.

DETAILS:

The "Guide to Subversive Organizations and Publications," revised and published as of January 2, 1957, prepared and released by the Committee on Un-American Activities, United States House of Representatives, Washington, D.C., contains the following on page 60 concerning the National Committee to Secure Justice For Morton Sobell In The Rosenberg Case:

- "1. Following the execution of atomic spies Ethel and Julius Rosenberg in June 1953, the 'Communist campaign assumed a different emphasis. Its major effort centered upon Morton Sobell,' the Rosenbergs' code-fendant. The National Committee to Secure Justice in the Rosenberg Case-a Communist front which had been conducting the campaign in the United States-was reconstituted as the National Rosenberg-Sobell Committee at a conference in Chicago in October 1953 and 'then as the National Committee to Secure Justice for Morton Sobell in the Rosenberg Case.' National headquarters remained at 1050 6th Avenue, New York City. Co-chairmen of the newest organization were Daniel Marshall and Joseph Brainin.

[REDACTED] advised on February 11, 1959, that there was no National Committee of the CSJMS as such, but that a loosely knit group of VIP's (Very Important Persons) acted to form and coordinate policy. [REDACTED] said that various State and City Sobell Committees were autonomous in that they were self-supporting and carried out the policy set forth by the National Committee as they saw fit. [REDACTED] said that the National Committee was more concerned with the legal aspects of the case. [REDACTED] said that the National Committee at present has representatives from the various City and State Committees, but that the motivating force is the New York Committee, which is centered around the activities of: TED JACOBS, LEAH SCHNEIDER, JUDY SWETSKY and AARON KATZ.

"The last month has seen a sharp increase in
comment on the Rosenberg-Sobell case in the press and over
the airways. The NEW REPUBLIC, noted liberal magazine,
published a significant editorial on June 30 surveying the
Rosenberg case after five years and asserted that the case
'can never be finished' because of the manner in which it
ended. While the magazine contends there is little doubt

"that the Rosenbergs were guilty, the editorial hits the ferocity of the punishment, the brutish objective in the final days before the execution; in short, the atmosphere of the tumbril rolling to the guillotine and the heads being shown to the mob." The magazine ranks the case as one of the three that 'rest uneasily on the conscience,' the other two being the Hiss and Oppenheimer cases...

"Estimates are that more than one million people in nine states heard the case of Morton Sobell, and that of the Rosenbergs, discussed over two June radio programs on station WNEW in New York. Professor William Kunstler of New York University devoted one week of his 'Counterpoint' program to questioning Roy Cohn as to the prosecution's position. The following week he presented Professor Malcolm Sharp of the University of Chicago to be interviewed on why he thought an injustice had been done.... Rose Sobell Morton's mother, was interviewed on a leading radio program in Washington, D.C. She appeared on the Steve Allison show on station WWDC, which has a wide listening audience... An interview with Helen Sobell was broadcast on the CBS radio affiliate in Detroit... A Cleveland station broadcast an interview with Sobell Committee representative Haven Perkins... In Minneapolis, the Sobell case was discussed on the 'Open Mike' program...

"CONCENTRATION IN WASHINGTON--As a result of letters being written to Senators and Congressmen from many parts of the country, there has been increasing success in getting lawmakers in Washington to look into the Sobell case....

"SEARCH FOR NEW EVIDENCE--Morton Sobell's wife, Helen, and our attorneys are now in Mexico City following up possible leads on new evidence in the case....
