

2) ON SUBJECT

Subject was Secretary of Local 236, UWA, and a charter member of the U.S. Club.

According to ANDREW J. KILD, on 9/7/50 it was reliably reported that subject had supplied photographs or photocopies of certain information to the ROSSBERG-SCHILL-GREENGLASS combination, and that this took place after her employment was terminated in SCHL. KILD also commented that subject was very active in the UWA meetings and was secretary of the UWA and, further, that it had been reported she was an active Communist organizer and sympathizer.

All other derogatory information in the CIC file was furnished by the FBI.

3) ON RELATIVES

SADIE RAUCH GLASSMAN, Mother

Registered in the ALP in 1946 in New York City, under the name, SALLY GLASSMAN.

OLADYS GLASSMAN, Sister

Supervisor for a club of the AID in Los Angeles, Calif. She also lived at the residence of ELLEN and LEO CHARLES LUKE in Los Angeles, both of whom are active members in the Echo Park CPA Club.

VIVIAN GLASSMAN, Sister

In addition to information furnished by the FBI, the CIC file for subject reflects VIVIAN GLASSMAN was present at a meeting of the UPWA in Long Branch, N. J., on 8/28/43, and that she was an associate of LEONARD BELLER.

DEROGATORY INFORMATION IN NEWARK FILES

1) ON SUBJECT

VIVIAN GLASSMAN is the subject of an ESPIONAGE - R, 181-50 investigation of which the New York Division is the office of origin. New York, therefore, will report the derogatory information in FBI files on subject and her relatives, references and associates. There is no derogatory information in the Newark files which is not in the possession of New York.

2) ON ASSOCIATES

JOEL BARN

Was a member of the Soviet espionage apparatus in which JULIUS ROSENBERG functioned.

JUDITH GROLLMAN

Alleged to have been in 1943 a CP member or engaged in activities strongly evidencing CP membership. GROLLMAN was a shop steward in the Communist-dominated Monmouth County Chapter of UPWA in 1936.

ESTHER LUTTAK

Subject of an SH-C investigation instituted in the Newark Division in 1943 on the basis of her suspected membership in the Shore Branch of the CP from March to August, 1943. New York was designated as office of origin on 7/19/44.

ALICE KAPF

Member of the Executive Committee and Chairman of the Educational Committee of the Monmouth County Chapter of the UPWA. New York is office of origin.

LEONARD BELLER

Member UPWA. Read "In Fact", which was cited by HCUA as a Communist publication. While cable editor of "This Week" shared an office with the

"Committee of Anti-Nazi Literature"; "This Week" identified as British publication suppressed by British Government because its editor associated with British Daily Worker. NCUA cited the "Committee of Anti-Nazi Literature as a Communist Front organization.

VIVIAN FRUCHTBACH

Interviewed by SIS on 9/13/53. Declined to furnish any information regarding individuals she had known and who were employed at Ft. Monmouth during period she worked there. Indicated she could not furnish any information regarding VIVIAN GLASSMAN because it had been too long ago that she had been associated with her. Investigation disclosed VIVIAN GLASSMAN had spent the day at FRUCHTBACH's home on 10/14/52.

DAVID GREENGLASS

On 6/13/50 DAVID GREENGLASS gave a signed statement to FBI Agents at NYC admitting that he was recruited for Soviet espionage by his wife, RUTH GREENGLASS, about 11/29/44, at the request of his brother-in-law, JULIUS ROSENBERG. GREENGLASS stated he gave HARRY GOLD, in the summer of 1945, a sketch of a high explosive experimental lens mold then being used for experiments in arriving at critical uranium mass at Los Alamos atom bomb project and information regarding personnel at Los Alamos. GREENGLASS was indicted by USCI, SDNY, on 10/10/50 for conspiracy to violate the War-time Espionage Statute, Sub Section A, Section 2, Title 50, USC. JULIUS ROSENBERG, ETHEL ROSENBERG, ANATOLI A. YAKOVLEV and MORTON SOBELL were named as co-defendants. HARRY GOLD and RUTH GREENGLASS were named as co-conspirators. GREENGLASS plead guilty on 10/18/50 in the USDC, SDNY. He was sentenced to 15 years imprisonment on 4/6/51.

STEPHEN L. JAVKA

JAVKA and his wife, CARLA SMALL JAVKA, are the subjects of a pending investigation, ASPIOMAGE - 2, of which Newark is the office of origin. This investigation was based upon information that JAVKA and his wife were associates of subject and BLEINOR GLASSMAN. JAVKA was a classmate of JULIUS ROSENBERG at CCNY. From 1946 to 1948 JAVKA had business dealings with the G & R Engineering Co., ROSENBERG's and DAVID GREENGLASS' firm. The name "JAVKA" appeared in the address book of ALFRED SARANT. JAVKA was interviewed 8/13/53 by FBI Agents and advised he had a CP membership card under the name, STEPHEN LOUIS, and had attended a few open CP meetings. JAVKA insisted he is not and never has been a Communist or a CP member, except as related above.

LEONARD B. BOUDIN

BOUDIN is a CP functionary in the New York City area. The only information in the Newark files which does not appear to be in the possession

of New York is that Mr. HENRY J. BENDER, Jr., a Union City, N. J. attorney, advised agents of the Newark Office that he represented the CIO in an action against the UOPWA. BENDER stated that BOUDIN represented the UOPWA and described him as "a most dangerous Communist".

WILLIAM PERL

Was an associate of JULIUS ROSENBERG and of many of the individuals included in the ROSENBERG Soviet espionage apparatus. PERL was indicted on four counts of perjury in connection with his denials of knowing MORTON SOBELL, HELEN SLITCHER, JULIUS ROSENBERG, MICHAEL and ANNE SIDOROVICH. He is presently serving a prison term following his conviction upon two of the counts of the indictment, in that he knew MORTON SOBELL and JULIUS ROSENBERG.

MILDRED BLOCK

Was an active member of the Communist-dominated Monmouth County Chapter of UFWA and resided with several officers of this organization who were reputed to be members of the CP.

JULIUS and ETHEL ROSENBERG

On 10/10/50 a Federal Grand Jury, SDNY, indicted JULIUS ROSENBERG, ETHEL ROSENBERG, ANATOLI A. YAKOVLEV, MORTON SOBELL and DAVID GREENGLASS for conspiracy to violate the Wartime Espionage Statute, Sub Section A, Section 32, Title 50, USC. On 3/29/51 MORTON SOBELL, JULIUS and ETHEL ROSENBERG were found guilty by a Federal Jury in SDNY. On 6/19/53 the ROSENBERGS were executed in accordance with their sentence.

2) ON RELATIVES

ERNEST J. PATAKI, Husband (Subject of blind memo)

PATAKI has denied CP membership. However, a permissive search of his apartment revealed a quantity of CP literature in his possession. An informant of known reliability advised PATAKI was a member and leader in Local 231, UOPWA, at PTL, and was, in informant's opinion, a CP member or Communist sympathizer.

ELEANOR GLASSMAN, Sister (Subject of blind memo)

ELEANOR GLASSMAN is the subject of an SK-C investigation in which New York is the office of origin, NY 100-23572.

GLADYS GLASSMAN, Sister (Subject of blind memo)

Same information as set out above under CIC heading.

INFORMATION DISSEMINATED TO ARMY AND DATE OF DISSEMINATION

VIVIAN GLASSMAN is mentioned in report of SA HENRY WOODS, at Newark, dated 1/18/44, captioned "COMMUNIST INFILTRATION OF THE UNITED FEDERAL WORKERS OF AMERICA, CIO; IS-6" on pages 4, 11, 29.

She is also mentioned in report of SA CHARLES D. EWART, at Newark, dated 9/25/44, same caption as above, at page 50.

Copies of both these reports were disseminated to C-2, First Army.

In connection with the Semontol Project, the Bureau has issued instructions that the Newark Office was to submit blind memos on all persons brought to their attention by CIC. In turn, these were forwarded to the NYO where blind memos were prepared setting forth all derogatory information on the individuals named in the Newark blind memos. Subsequently, those memoranda were sent to the Bureau where Bureau files were reviewed, and then transmitted to the Newark Office, which office in turn had the responsibility of recommending whether or not a case should be opened and the type of case that should be opened. At the present time the Newark Office is forwarding these recommendations to the NYO.

In view of the fact that practically all of the cases opened to date have been in the Security Matter - C category, the writer on 10/13/53 telephonically communicated with Inspector HENNRICH to obtain a clarification as to what material should be reported in those SM - C cases. It was pointed out to Mr. HENNRICH that the file reviews conducted by the NYO and the Newark Office and the Bureau had turned up information on relatives and associates and other individuals that would normally not be reported in a regular SM - C report.

Mr. HENNRICH stated that in view of the current status of the Senator McCARTHY probe into individuals formerly or presently employed at Fort Monmouth, the Bureau was going to follow very closely any cases opened as a result of the Semontol review. He stated that one Bureau supervisor would be responsible for reviewing and following all cases opened as a result of the Semontol Project. He requested that in writing reports on those individuals that all information obtained as a result of the file review should be reported and that those cases should be given a very high priority as he felt that the Bureau would probably within the next few days issue instructions that all cases opened as a result of the Semontol review would have to be completed within a period of thirty days.

Of the original five cases that were opened as a result of Newark's recommendations, this office was in possession of closed case files on those individuals. These have been reopened.

With each case file the agent to whom this case is assigned will receive (1) a copy of the New York blind memo incorporating a summary of the derogatory information in the CIC file as well as derogatory information obtained from the Newark Office; (2) a copy of a blind memo prepared by the NYO setting forth all derogatory information found in the NY files that had not been previously reported in the Newark memo; (3) a blind memo from the Bureau; (4) all of the indices search slips that were utilized in checking names of the subject and his associates, relatives, and references. All of the above should be made a part of the reopened file.

Particular care should be taken to attribute derogatory information to the necessary T symbols when this information has been set forth in report form. The blind memo contains all of the informants who should be referred to as T symbols. Particular emphasis should be placed on having these reports completed as expeditiously as possible.

In the event that any question arises concerning the contents of the blind memos prepared in the Semontel investigation, inquiries should be made of SA LAWRENCE H. BRACKEN and the writer who are familiar with all of the ramifications of this project.

When any of these investigations originating out of a Newark recommendation in the Semontel investigation is completed, a brief memo should be directed to the Semontel file. It is not necessary that a copy of a report be designated for this file. If such copies are designated, they will be returned to the main case file.

Tag Rosenberg As Mastermind Of Radar Spies

By Norma Abrams and Neal Patterson

The late atom traitor Julius Rosenberg master-minded the radar espionage ring at Fort Monmouth, N. J., and set it up so strongly that it was still in being after Rosenberg's electrocution at Sing Sing last June 19, Senate probers said here yesterday.

Even now, despite numerous recent suspensions, some members of a Rosenberg-recruited ring may still be functioning in the highly sensitive Signal Corps research center at Monmouth, Chairman Joseph R. McCarthy of the Senate Permanent Investigations Subcommittee indicated.

Last night the probers heard a witness who formerly roomed with Morton Sobell, a co-defendant in the Rosenberg espionage trial. The witness, whose name was not divulged, said he had worked for the Signal Corps, and still was

doing classified work for Fort Monmouth. He is an electronics engineer.

Never Red, He Insists

Denying that he ever was a Red, the witness conceded that his room-mates at one time or another included not only Sobell but a man who later became a Communist agent in Cincinnati and another man in whose room secret documents from the Evans laboratory at Fort Monmouth were recovered. The witness insisted that he never passed secret documents to Sobell.

The proba announced these earlier developments during the day:

1. A teacher at Morris High School, Bronx, was threatened with prosecution for perjury because of allegedly conflicting testimony.

Wanted Young Engineers

2. A former friend and City College classmate of Rosenberg testified that Rosenberg and Sobell, who drew a 30-year term at the Rosenberg espionage trial, had attempted vainly to recruit him into a spy ring.

The witness said that Rosen-

berg and Sobell wanted him to help line up young engineers and technicians for the Fort Monmouth radar project—persons who would be good prospects for espionage,” McCarthy said.

“It was the belief of the witness that Rosenberg and Sobell through their contacts had free access to all secret material there.”

Mystery Woman Heard

The investigators will ask the appearance here of the German radar scientist who fled from the Red zone of Germany and told U. S. intelligence officers that while working in a radar lab for the Soviets, he had seen microfilm copies of secret documents stolen from Fort Monmouth.

A report from U. S. Army headquarters in Heidelberg yesterday quoted a spokesman as saying that the Army knew nothing about the German scientist.

Know Nothing About It

And a U. S. Air Force spokesman at Wiesbaden said: “I just spoke to some people at G-2 (intelligence). They don’t know anything about the case.” McCarthy’s account concerning the German scientist “baffles” the Air Force in Germany, the spokesman said.

Two women were among yesterday’s witnesses. They were Vivian Glassman, who held a mystery role in the testimony of William Pearl, aerodynamics expert, at his perjury trial, and her sister, Mrs. Eleanor Hulner. The Glassman woman also figured in the Rosenberg case as the sweetheart of Joel East, former Signal Corps

employee believed to be behind the Iron Curtain at this time.

2. Seeking further light on Rosenberg's activities at Monmouth, where Rosenberg worked as an electronics inspector during the war, McCarthy planned to go to the federal penitentiary at Lewisburg, Pa., possibly tomorrow, to question Rosenberg's brother-in-law, David Greenglass.

Greenglass, who confessed his role in the theft of atom secrets, is serving 15 years. His testimony

played a leading part in sending to the chair his sister, Ethel, and her husband, Julius.

"The evidence before us today has definitely convinced us that it will be absolutely necessary to interview Greenglass and perhaps call him as a witness," the Senator said. "There is a strong indication that he can give valuable information."

Call Two Generals

4. Announcement was made that Maj. Gen. George E. Back, chief of the Signal Corps, and Maj. Gen. Kinde A. Lawton, commandant at Fort Monmouth, will be called as witnesses today. They will be interrogated about the German scientist's report.

According to Perl's testimony,

Mrs. Glassman called unexpectedly at his apartment in Cleveland in July, 1950, with money and instructions on how to flee to Mexico. This was while the FBI was pressing its probe of the Rosenberg case.

Perl told the jurors he had explained to Miss Glassman that her call was a "mistake" and that he thought it was an effort to "trap" him into fleeing.

Worked as Inspector

Senator McCarthy said Miss Glaseman had worked for the Signal Corps in 1942 and 1943 as an instructor of plant supervisors on employee relations. She also had worked as an inspector.

When questioned yesterday, the woman refused to answer a lengthy list of questions on grounds of possible self-incrimination. According to McCarthy, she refused to say:

Whether she was part of the Rosenberg spy clique.

Whether Rosenberg "planted" her in the Signal Corps.

Whether she delivered secret material to him.

Whether she had stolen documents for the spy ring.

What she knew about the 10 scientists and technicians recently suspended since the McCarthy probe began.

She also declined to say whether she carried money from Rosenberg to Perl in an effort to assist Perl's flight and whether she knew if any members of the Rosenberg ring are still active at Fort Monmouth.

Denies Acting as Spy

Mrs. Hutzler worked at Monmouth during the war. She resigned last week as an employee of the Board of Education's child guidance division after being subpoenaed in the present probe.

She denied ever engaging in espionage, but refused to say if she is a Communist, if she knew the Rosenbergs or visited their home while in the Signal Corps, or if her sister was an espionage agent.

This witness' husband, Eugene, a teacher at Morris High School, was called in the afternoon and interred the committee by his replies. McCarthy said a transcript of the teacher's testimony would be sent at once to the Department of Justice, with a recommendation of prosecution for perjury.

She advised that during the war, her sister and GLASSMAN worked at Fort Monmouth, New Jersey, and lived together. She would meet GLASSMAN when she visited

her sister. She stated she did not get to know GLASSMAN very well, and has not seen her for over ten years.

In response to an inquiry whether she knew if GLASSMAN was a Communist, she stated it was a ridiculous question as she would have no way of knowing GLASSMAN's political beliefs. She was also asked whether her sister, VIVIAN FRUCHTEAU was a Communist. She stated that this also was a ridiculous question as her sister entertained no Communist beliefs whatsoever, and no one was in a better position to know this than she.

She further stated that neither her sister nor VIVIAN GLASSMAN knew JUDITH COPLOW. It was pointed out that they could be friends of COPLOW without her knowledge, but she scoffed at this and stated that it would be extremely unlikely.

She stated that she and her former husband had an apartment on West 21st Street, New York City. She did not know whether GLASSMAN had an apartment on West 23rd Street, nor did she know GLASSMAN's sister.

JUDITH COPLOW was found guilty June 30, 1949, in District of Columbia of violating Section 793 and 2071, Title 18, United States Code.

The Court of Appeals for the District of Columbia on June 1, 1951, remanded the case for a hearing on whether there had been an interception of telephone calls between COPLOW and her attorney. This hearing has not been held.

JUDITH COPLOW was convicted in the Southern District of New York on March 7, 1950, and was sentenced March 9, 1950, for violating Section 794, Title 18, United States Code and conspiracy to violate Section 793, 794 and 2071, Title 18, United States Code. These convictions involved espionage activities for Soviet Russia.

With regard to the above conviction, the Circuit Court of Appeals for the Second Circuit reversed the conviction on December 5, 1950, and remanded the case for a new trial.

The United States Supreme Court on January 28, 1952, refused to review either decision on writs of Certiorari. JUDITH COPLOW has not been retried.

The "Guide to Subversive Organizations and Publications" dated May 14, 1951, prepared and released by the House Committee on Un-American Activities, House of Representatives, Washington, D. C., contains the following concerning the Stockholm Peace Petition:

"Stockholm Peace Petition

"1. Cited as Communist.

(Congressional Committee on Un-American Activities, interim statement issued on the Communist 'Peace Petition' Campaign, July 13, 1950.)"

On March 9, 1951, DAVID GREENGLASS, an admitted Soviet espionage agent, was interviewed by SA ROBERT F. ROYAL and RICHARD T. HRADSKY at City Prison, New York City. GREENGLASS advised the Agents that on one occasion he had asked JULIUS ROSENBERG, executed Soviet espionage agent, sometime in 1947 if JOEL BARR and VIVIAN GLASSMAN were in the espionage network. ROSENBERG answered sharply "no." However, a short time later, ROSENBERG told GREENGLASS that JOEL BARR was active in the espionage network. GREENGLASS stated that when ROSENBERG answered "no" to this question concerning JOEL BARR and VIVIAN GLASSMAN in the manner in which he did, he meant that BARR and GLASSMAN were involved, but that he did not want to talk about it.

On August 3, 1950, VIVIAN GLASSMAN advised SAs ROBERT F. ROYAL and RICHARD T. HRADSKY that on July 22, 1950, she made an airplane trip to Cleveland, Ohio, under the fictitious name Mrs. S. GOLDKIND and

offered WILLIAM PERL \$2000 to flee to Mexico. GLASSMAN advised that the money was received from an unknown man who called at her apartment on July 21, 1950, but she refused to assist in identifying this individual.

JULIUS and ETHEL ROSENBERG were convicted of conspiracy to commit espionage against the United States and were executed at Sing Sing Prison, Ossining, New York, on June 19, 1953.

WILLIAM PERL is incarcerated in United States Penitentiary, Terre Haute, Indiana, serving a five year sentence for having committed perjury before a United States Federal Grand Jury, Southern District of New York, in that he denied knowing JULIUS ROSENBERG and MORTON SOBELL.

MORTON SOBELL is incarcerated in Alcatraz Penitentiary, California, serving a 30 year sentence after conviction on a charge of conspiracy to commit espionage with JULIUS and ETHEL ROSENBERG on behalf of the Soviet Union.
