2 UNIDENTIFIED MALE SPEAKER: I guess, well,

3 there's someone right that wants to talk --

4 JOHN: Go ahead.

5 UNIDENTIFIED MALE SPEAKER: -- that's willing

6 to talk about it.

7 JOHN: Who's that?

8 UNIDENTIFIED MALE SPEAKER: Her name is Jean.

9 She'll give you her whole name or whatever you want.

10 JOHN: Okay.

11 UNIDENTIFIED MALE SPEAKER: Yeah.

12 JOHN: Go ahead.

13 UNIDENTIFIED MALE SPEAKER: All right, just a

14 minute.

15 MS. BORST: Hi, John.

16 JOHN: Hey, how are you?

17 MS. BORST: Fine.

18 JOHN: And who are you?

19 MS. BORST: Mary Jean Borst.

20 JOHN: Okay. Great. Listen, I had -- there

21 was a Darren Lane Borst --

22 MS. BORST: Yes.

23 JOHN: -- called in, who I presume is your

24 son, huh?

25 MS. BORST: Yes, he's my son.

JOHN: Okay. And several people have called

1 in and have not talked to me in particular, but they
2 have --

3 MS. BORST: Pardon? I didn't hear you.

4 JOHN: I said several people have called in
5 and have not talked to me in particular, but they have
6 talked to people at the office and they were trying to
7 look into the welfare of people, you know.

8 MS. BORST: Um-hum.

9 JOHN: Family members, loved ones that they
10 knew were inside the Mt. Carmel and, and so I mentioned
11 to both David and Steve that, that Darren had called
12 and I'd like to be able to at least talk to you and say
13 have someone talk to Darren afterwards and say we
14 talked to his mother and everything's fine, you know,
15 she sounded good, and anything that you'd like to, to
16 pass on to him.

17 MS. BORST: Well, just tell him I'm fine and
18 I just want to stay in here until God says to come out.

19 JOHN: Okay. Now, I do not have -- I've got
20 a name of him, I, but I don't have a phone number. Do
21 you, do you know what his phone number is?

22 MS. BORST: Now who's that? Darren?

23 JOHN: Darren's.

24 MS. BORST: No, I don't have it right now.

25 JOHN: That's all right. You know what, what
city he lives in?

1 MS. BORST: Oh, yes, he's in Ames, Iowa.
2 He's at the college there. The university in Ames,
3 Iowa.

4 JOHN: Okay. But all I had was that he
5 called in and, and he called in regarding you, and
6 Steve told me earlier that, you know, yeah, you were in
7 good shape, and I said look, let me talk to her so at
8 least somebody from our organization can contact him.

9 MS. BORST: Right.

10 JOHN: And say, hey, we talked to your mom
11 and everything's fine. She loves you and, and
12 everything and she'll see you when --

13 MS. BORST: Okay.

14 JOHN: -- when the Lord determines that you
15 all are coming out, huh?

16 MS. BORST: Yes, that's what I'd like you to
17 tell him.

18 JOHN: And, and -- well, that's what we'll
19 tell him, too.

20 MS. BORST: Okay.

21 JOHN: And do you -- there are a couple
22 things I wanted to pass by you.

23 MS. BORST: Um-hum.

24 JOHN: In talking with Steve and talking with
25 David --

MS. BORST: Um-hum.

1 JOHN: He said that all of you, the women,
2 the children and all the adults, everybody, were
3 totally free to leave Mt. Carmel at any time they
4 wanted to.

5 MS. BORST: That's right.

6 JOHN: And, and you understand that?

7 MS. BORST: Yes, I understand.

8 JOHN: And that if, if you all are staying in
9 there, it's of your own volition, your own accord.

10 MS. BORST: Yes, that's right.

11 JOHN: And, and nobody's pressuring you to do
12 anything. And I just want to let you know that, that
13 nothing is going to happen to you staying in there.
14 We're certainly not going to do anything, and, and we
15 want to resolve this through talk.

16 MS. BORST: Right.

17 JOHN: That's -- and, you know, in a peaceful
18 means. And, and if you desire to leave and, and walk
19 down that road, you'll be greeted with open arms,
20 believe me. And, and if you have any medical problems
21 or anything else, it'll be taken care of. Do you have
22 any children that have, that have already been released
23 or anything like that?

24 MS. BORST: No, I don't have any children in
25 here.

JOHN: Oh, okay.

1 MS. BORST: Didn't have any in here, right.

2 JOHN: You have any other family members in
3 there with you?

4 MS. BORST: No, I don't.

5 JOHN: Okay. All alone in there, huh?

6 MS. BORST: Right.

7 JOHN: Okay. Do, do you think the, the
8 people in there are -- oh, I don't know how to describe
9 it -- are fearful that we're going to come charging in
10 there and hurt them or something like that? Because
11 if, if you do, I want to allay those feels -- fears
12 that it's not going to happen. I told them that one
13 thing we are is patient. And we will, we will sit out
14 here and wait and wait and wait, because we want to
15 talk, we want to make it peaceful, we want people to
16 get back with their loved ones and their family members
17 and, and that's exactly the way we're going to handle
18 it, you know.

19 MS. BORST: Um-hum.

20 JOHN: And I am with the FBI and if you have
21 any questions as to what would happen when you come
22 out, I'll be happy to answer them for you, you know.

23 MS. BORST: Okay.

24 JOHN: Or, you know, if you, if you have any
25 questions, any fears, any concerns, feel free to ask
them. I'll be happy to answer them.

1 MS. BORST: Okay.

2 JOHN: Anything I can answer for you?

3 MS. BORST: No, I don't believe so.

4 JOHN: Okay. Okay. Well, you sound all
5 right.

6 MS. BORST: Yes, I'm fine.

7 JOHN: That's good. That's good. And we'll
8 certainly get the message to your son in Ames, Iowa.
9 Boy, that's in the middle of the state, huh?

10 MS. BORST: Yes.

11 JOHN: Got to be some cold area up there
12 right now.

13 MS. BORST: Yeah, I'm sure it is.

14 JOHN: Okay. Do you have any other children
15 or, you know, a husband or anyone like that that you'd
16 like us to contact?

17 MS. BORST: Well, I have other relatives out
18 there, but if you'd just, you know, give the message to
19 Darren --

20 JOHN: Okay.

21 MS. BORST: -- he will, he will get in touch
22 with all of them, I know.

23 JOHN: Okay.

24 MS. BORST: So that would be fine.

25 JOHN: Do you know if anybody else has any
messages?

1 MS. BORST: Yes, I think there's someone else
2 here that would like to talk with you.

3 JOHN: Great. Great.

4 MS. BORST: Okay. Thank you.

5 JOHN: Listen, you take care, huh, and I'll
6 see you when you come, come out of there.

7 MS. BORST: Okay.

8 JOHN: All right.

9 MS. BORST: Thanks, John.

10 JOHN: Bye-bye.

11 (pause)

12 GRAEME: Hello, John?

13 JOHN: Yes.

14 GRAEME: My name is Graeme.

15 JOHN: Hey, Graeme Leonard Craddock.

16 GRAEME: That's correct.

17 JOHN: Okay. Let me tell you what we got.
18 My name's John Cox and I'm with the FBI, Graeme. We
19 had a Barry Craddock --

20 GRAEME: Yes, that's my brother.

21 JOHN: -- telephone. Okay. Let me just make
22 a little note here, so I make sure -- I've got
23 G-R-A-E-M-E as your first name, is that correct?

24 GRAEME: That's how it's spelled, yes.

25 JOHN: A-E-M-E. You've got a little cockney
accent there, do you?

1 GRAEME: I don't know about that.

2 JOHN: From down under?

3 GRAEME: Yeah.

4 JOHN: Okay. And it's C-R-A-D-D-O-C-K.

5 GRAEME: That's correct.

6 JOHN: Okay. And, and he lives in

7 Townsville, Australia.

8 GRAEME: Townsville, Queensland, Australia.

9 JOHN: Australia. Okay.

10 GRAEME: That's right.

11 JOHN: And he called, he was interested in
12 your, your well-being, and as, as I said to several of
13 the people of I've talked to, when people call in, I
14 talked to David, I've talked to Steve, and I said, I'd
15 love to talk to these people so we can go back and, and
16 say hey, we talked to your, talked to your brother, we
17 talked to your father, your, you know, mother, sister,
18 whatever the case may be. And in this case, we'll give
19 your brother a call and let him know that we spoke to
20 you and that you're healthy, I hope.

21 GRAEME: Yeah, I'm very well, thank you.

22 JOHN: Okay. How long have you been in
23 there?

24 GRAEME: I, I came here, it was about 11
25 months ago.

JOHN: Okay. Had a lot of excitement in the

1 last week, huh?

2 GRAEME: Very much so.

3 JOHN: I'm sure you --

4 GRAEME: More than what I --

5 JOHN: Sure you didn't expect that 11 months
6 ago. That's a, that's a tragedy for both sides, you
7 know, it's just a terrible, terrible thing. Let me,
8 let me ask you something, and, just to reinforce
9 something here, to make sure that you're, you're
10 totally aware of it. In talking with David and talking
11 with, with Steve, they both said that everybody in
12 there, you know, men, women, children, are all free to
13 leave any time they want, it's up to them. There's no
14 pressure, there's no coercion, there's, you know,
15 nothing that would preclude them to leave if they want
16 to leave.

17 GRAEME: That's correct, yes.

18 JOHN: And that's the impression that you
19 have?

20 GRAEME: Yeah.

21 JOHN: That's true?

22 GRAEME: Yeah. Well, he's made the statement
23 numerous times at least in past months that anyone who
24 wants to leave can leave.

25 JOHN: Okay. What about in the past week?
Since the incident last Sunday?

1 GRAEME: Well, I, I can only, only assume
2 that he's never -- put it this way, he's never, I've
3 never had any caution to stay, for me to stay here.

4 JOHN: Okay. Okay. So you're in there, you
5 know, as a result of your own volition, your own free
6 will.

7 GRAEME: This is my free will.

8 JOHN: Good. Good. Well, that, I just want
9 to make it clear that should you want to leave, should
10 you, you know, have that opportunity and the desire,
11 whatever it might be, all you have to do is walk down
12 the road and, and you'll be greeted with open arms.
13 And, and I pointed out to Mary Jean Borst who I just
14 spoke to and Rachel and all the others that I've talked
15 to this evening, Jeff Little and David Thibodeau that
16 hey, we have, we have a lot of patience. We, we are
17 not going to come, come charging up there. We are
18 going to sit out here and wait and wait and wait as
19 long as it takes, Because we're going to resolve this
20 through reason and we're going to resolve this through
21 communications, through talking. So that it's a very
22 peaceful resolution and nobody gets hurt, because too
23 many people have been hurt already, you know. Are you
24 there?

25 GRAEME: Yes, sir, someone just --

 JOHN: Somebody stepped on a wire, huh.

1 GRAEME: Yeah.

2 JOHN: I know they said if you look at that
3 phone it'll click sometimes, I think.

4 GRAEME: Yeah.

5 JOHN: But I, but I hope you understand that.
6 You'll pass that on to others that they should not have
7 any fear of us coming in there. It's not going to
8 happen. They may look out and see vehicles and they
9 may see people and other things, but nobody is coming
10 in there. I mean, that's the way we operate. That's
11 the way we are. There are a lot of media people out
12 there and we have the responsibility to ensure that
13 nothing happens to these people, you know. Is there,
14 is there anything I could tell your brother?

15 GRAEME: Oh, you can just, well, the only
16 thing I, I can possibly tell him is, is that I'm doing
17 fine.

18 JOHN: Okay.

19 GRAEME: I managed to get through the
20 incident last Sunday totally unscathed, so.

21 JOHN: Weren't hurt at all, huh?

22 GRAEME: Not, not at all.

23 JOHN: Good. Now, I understand they're going
24 to have a, a burial service tomorrow morning for Peter
25 Ghent. I, I didn't know if you're aware of it or not,
but either David or -- no, I guess Steven told me that

1 | they were going to have a burial service for him.

2 | GRAEME: Yeah.

3 | JOHN: Out across the road and I don't know
4 | if they, if they were having any other burial services
5 | out there or not, but --

6 | GRAEME: Um-hum.

7 | JOHN: I told them if, if they had some
8 | other, other individuals that they wanted us to work
9 | with them on, to just let me know, you know. But you,
10 | you were not injured --

11 | GRAEME: Yeah.

12 | JOHN: -- in any way. Do you have any other
13 | relatives that, that you'd want me to -- I, I don't
14 | mean me as an individual but you'd want us to contact?

15 | GRAEME: Well, I'd, I'd assume my brother
16 | would contact everyone else in, all my relatives back
17 | in Australia.

18 | JOHN: Okay, all your relatives are in
19 | Australia?

20 | GRAEME: That's correct, yes.

21 | JOHN: Okay. You married?

22 | GRAEME: No, I was, I've never been married.

23 | JOHN: How'd you dodge that bullet, huh?
24 | How'd you avoid that?

25 | GRAEME: Oh, luck.

 JOHN: (Laughs.) So no children then, huh?

1 GRAEME: That's true.

2 JOHN: Lord, Lord. Are you interested in
3 leaving the compound at all?

4 GRAEME: Not at the moment, no.

5 JOHN: But if the, if, if the Lord's Word
6 comes through --

7 GRAEME: We'll be --

8 JOHN: -- you'll be, you'll be leaving, huh?

9 GRAEME: Yeah.

10 JOHN: Well, like David told me, he said hey,
11 I'm ready to leave any time. And he said it's just I'm
12 waiting for the word. And we all are.

13 GRAEME: Yeah.

14 JOHN: We all are, because we don't want to
15 see any more agony and any more anguish and any more
16 tears shed. They were shed in there, they were shed
17 out here.

18 GRAEME: Yeah.

19 JOHN: But, and it, and it just doesn't have
20 to happen, you know.

21 GRAEME: Yeah, I, I can certainly, I'm into
22 that too.

23 JOHN: Yeah. Do you, do you know of anything
24 besides the word that would, that would help move this
25 process along? Besides everybody packing up and going
home. You know, that's just not going to happen, is

1 it?

2 GRAEME: No, not just at the moment.

3 JOHN: Any suggestions? Any ideas?

4 GRAEME: Well, I just hope everyone sort of
5 stays cool on the outsides of the thing.

6 JOHN: Well, you, you got some, you got some
7 pretty cool heads out here, you really do. I mean,
8 some people may have said some crazy things had been
9 done before and some, oh, some juvenile activities, and
10 you know, 'cause I heard some guys were giving the bird
11 and mooning and, you know, things like that. But a lot
12 of that comes from frustration and anguish.

13 GRAEME: Yeah.

14 JOHN: And where I am, I hope, cooler heads
15 prevail. And I hope they do where you are too, because
16 I heard we got a report earlier this evening that there
17 was somebody up in the upper window on the front side
18 of the -- or on the end of building where the
19 construction is, up on the third floor, with a long-
20 barreled weapon, sticking it out the window there and
21 --

22 GRAEME: Yeah, well, I was not too far from
23 that particular place, and you know, I'd just come
24 down, I think only a few minutes before, and there was
25 certainly nobody up there with any weapon of any, any
sort.

1 JOHN: Nothing that you saw, huh?

2 (Electronic music in background.)

3 GRAEME: We've been cut off again.

4 JOHN: Hello?

5 GRAEME: Hello?

6 JOHN: Hello? Hello?

7 GRAEME: Just a minute.

8 JOHN: Okay.

9 GRAEME: Have you got it?

10 JOHN: I'm there.

11 GRAEME: Someone stepped on our cord again.

12 Sorry about this.

13 JOHN: But then David came back and just said
14 somebody was taking a leak out the window or something,
15 you know, but it was just a smart comment. I said hey,
16 give me a break, you know.

17 GRAEME: Yeah, well, I don't --

18 JOHN: Some racial overtone there.

19 GRAEME: I just think someone was just
20 looking out the window and some --

21 JOHN: Probab-- could be.

22 GRAEME: Somebody out there was watching us,
23 got a little, little bit excited.

24 JOHN: It could have been. Hey. You got
25 jumpy people on both sides, and we're trying to use
some reason and trying to keep it as calm as it be, you

1 know.

2 GRAEME: That's very true.

3 JOHN: And I hope it'll, and I hope it'll be
4 resolved soon and, and I know it'll be resolved
5 peacefully. Like I, like I told David, I said I know
6 you're coming out of there, and I know you're going to
7 lead your flock out of there. It's not a question of
8 if, it's a question of when. And, and I think we all
9 know that.

10 GRAEME: Um-hum.

11 JOHN: Listen, is there anything else that
12 you'd want me to pass on to anyone, huh?

13 GRAEME: Well, there's probably many things
14 I'd, I'd probably like to --

15 JOHN: Well, if there's something --

16 GRAEME: But I can't think of anything at the
17 moment.

18 JOHN: If there's something that you can
19 think of, all you have to do is come up, pick up the
20 phone and, and myself or someone else will be on the
21 other end of the phone and, and we'll talk, we'll
22 reason.

23 GRAEME: Okay.

24 JOHN: We just don't want anything other than
25 a nice peaceful resolution here.

GRAEME: Okay, then.

1 JOHN: Okay, is Steven there or --

2 GRAEME: Yes, I could hand you back on to
3 Steve if you like.

4 JOHN: Or anybody else that wants to talk to
5 me.

6 GRAEME: All right, just hang on a second.

7 JOHN: You bet. Good talking to you.

8 SHERRI: Hello?

9 JOHN: Hi.

10 SHERRI: Hi.

11 JOHN: Who's this?

12 SHERRI: This is Sherri.

13 JOHN: Sherri Jewell.

14 SHERRI: You already knew.

15 JOHN: Is that correct?

16 SHERRI: That's correct.

17 JOHN: Well, the only reason I knew is that
18 somebody called and I don't know if it was a Mr. Mosher
19 or a Mrs. Mosher.

20 SHERRI: Probably Mrs. Mosher.

21 JOHN: I, I just don't know. What would her
22 first name be?

23 SHERRI: Ruth.

24 JOHN: Ruth, okay, 'cause the reason I ask is
25 all I have is a last name. Called and said her
daughter Sherri Jewell, and, and all we, and all I have

1 | is a phonetic S-H-E-R-R-I-E J-E-W-E-L-L. Is that
2 | correct?

3 | SHERRI: Well, that's close enough.

4 | JOHN: Is it accurate.

5 | SHERRI: Well, it's close enough.

6 | JOHN: Okay. That is inside. And she was
7 | concerned. And as I told David and as I told --

8 | SHERRI: Well, if you ever get -- are you
9 | going to be talking with her again?

10 | JOHN: Someone will.

11 | SHERRI: Okay.

12 | JOHN: I won't tell you that I am, because --

13 | SHERRI: Well, whoever --

14 | JOHN: But someone will.

15 | SHERRI: Whoever does, just give her this
16 | message.

17 | JOHN: Okay.

18 | SHERRI: Matthew 24.

19 | JOHN: Okay.

20 | SHERRI: And that's it.

21 | JOHN: That's it?

22 | SHERRI: That's it.

23 | JOHN: And she will know what that means?

24 | SHERRI: She will understand.

25 | JOHN: Well, are you okay?

 SHERRI: I am terrific.

1 JOHN: Okay.

2 SHERRI: As far as terrific can be.

3 JOHN: Well, under the existing conditions,
4 huh?

5 SHERRI: Absolutely. Yeah.

6 JOHN: Okay.

7 SHERRI: Listen, what, what kind of job do
8 you have there? What's your title?

9 JOHN: What's my title?

10 SHERRI: Yeah, what, what's, what are you?

11 JOHN: I'm an FBI agent.

12 SHERRI: Okay, that's your title?

13 JOHN: Yeah. Special agent with the FBI.

14 SHERRI: Oh, special agent. What, what --
15 you're married?

16 JOHN: You bet.

17 SHERRI: How many kids do you have?

18 JOHN: Three.

19 SHERRI: Three!

20 JOHN: Yeah.

21 SHERRI: How old are they?

22 JOHN: How many kids do you have?

23 SHERRI: Enough to keep me busy.

24 JOHN: Do you have more --

25 SHERRI: So you have three, so you have three
kids.

1 JOHN: Do you have more than three?

2 SHERRI: Well, you answer my questions first.

3 JOHN: Okay.

4 SHERRI: You have three kids.

5 JOHN: Yes, I do.

6 SHERRI: How old are they?

7 JOHN: Uh-oh, you're going to make me think
8 now, aren't you, huh, put me on the --

9 SHERRI: Hey, listen, you're talking to a
10 school teacher here, and I'm real interested in --

11 JOHN: You're going to put me on the spot,
12 okay.

13 SHERRI: Okay.

14 JOHN: Hang on.

15 SHERRI: Is there a 20 and 25, something like
16 that, or 15? I don't know.

17 JOHN: Be, be patient, I'm get, I'm going to
18 give you answer, I'm --

19 SHERRI: Oh, I'm real patient.

20 JOHN: I'm scratching the little hair that's
21 left up here.

22 SHERRI: Oh, you have little hair on your
23 head?

24 JOHN: No, I got plenty.

25 SHERRI: Oh, I see.

JOHN: It just gets thin after awhile.

1 SHERRI: Okay.

2 JOHN: 18.

3 SHERRI: 18.

4 JOHN: 23 in a week.

5 SHERRI: 23 in a week.

6 JOHN: And 26.

7 SHERRI: You mean you could, you can't hardly
8 remember.

9 JOHN: Hey, what can I say.

10 SHERRI: Now, John, that's not too, too cool.
11 Well, see, I was pretty close --

12 JOHN: They say the mind's the first thing to
13 go, right?

14 SHERRI: Uh-huh, yeah.

15 JOHN: Huh?

16 SHERRI: Yeah. Yes, it sure is.

17 JOHN: (Laughs.)

18 SHERRI: Yeah, I was pretty right. You had
19 two kids in the 20's and one in the teens, right?

20 JOHN: You've got it.

21 SHERRI: See, I thought so. So what do these
22 -- they're in college?

23 SHERRI:

24 JOHN: You're, you're a psychic, huh?

25 SHERRI: No, I'm just -- I can tell by your
voice.

1 JOHN: You can? Why?

2 SHERRI: Yeah.

3 JOHN: How old did you think I was?

4 SHERRI: Well, you're probably in your, I
5 don't know, late --

6 JOHN: Yeah?

7 SHERRI: Late 40's? 50's? (Laughs.)

8 JOHN: Oh, wait a minute now. Wait a minute.
9 Late --

10 SHERRI: Anyway, so you're, you're -- do they
11 go to college?

12 JOHN: I'm, I'm mature.

13 SHERRI: That's for sure.

14 JOHN: There you go.

15 SHERRI: Okay. They go to college?

16 JOHN: No, none of them.

17 SHERRI: None of them!

18 JOHN: One's graduated from college.

19 SHERRI: Okay, the 25-year-old.

20 JOHN: The, yeah, 26. He's 27, yeah.

21 SHERRI: I was, I'm pretty close. 26, okay.

22 JOHN: And then one of them is in the service
23 and one's of them's in high school.

24 SHERRI: And the -- okay, so the 18 is just
25 barely, almost out of high school.

JOHN: Almost.

1 SHERRI: And the one that's -- almost.
2 JOHN: Almost.
3 SHERRI: Barely.
4 JOHN: What's, what grade did you teach?
5 SHERRI: I taught -- well, I've taught K
6 through college.
7 JOHN: Have you really?
8 SHERRI: I sure have. I was a --
9 JOHN: The, the K's, the one's, and the two's
10 are more fun than the others though, aren't they?
11 SHERRI: No, actually I like college the
12 best.
13 JOHN: Do you?
14 SHERRI: Yeah. Actually I really do. I was,
15 I was in Hawaii. Well, I'm, I'm from Hawaii
16 originally.
17 JOHN: Aloha.
18 SHERRI: And I was dean of students and
19 faculty.
20 JOHN: Really?
21 SHERRI: Um-hum.
22 JOHN: That's great.
23 SHERRI: And I really didn't like it too --
24 oops, are you still there?
25 JOHN: Yeah, somebody just stepped on the
wire, huh.

1 SHERRI: You got it.

2 JOHN: Where were you dean of students?

3 SHERRI: In Hawaii. In one of the colleges
4 there.

5 JOHN: Really? 'Cause I had a, I had a
6 neighbor's son that got a basketball scholarship to the
7 University of Hawaii at Hilo.

8 SHERRI: Oh, uh-huh.

9 JOHN: Loved it.

10 SHERRI: Oh, of course. Anybody that goes
11 there does.

12 JOHN: I'm surprised it didn't take him ten
13 years to get through college, huh?

14 SHERRI: Oh, yeah.

15 JOHN: At the, at a location like that.

16 SHERRI: Professional, professional college
17 person, huh?

18 JOHN: Hey. Well now he's, he's graduated
19 but that had to be a great way to go through college.

20 SHERRI: Hum.

21 JOHN: In an environment like that.

22 SHERRI: So your 18-year-old --

23 JOHN: Yeah.

24 SHERRI: What school does he go to?

25 JOHN: Well, he goes to a public high school.

SHERRI: A public high school.

1 JOHN: Yeah.

2 SHERRI: Do you like it? I mean, you know.

3 JOHN: Fine. Excellent.

4 SHERRI: Really?

5 JOHN: Yeah.

6 SHERRI: Okay, so it -- does he, has he done

7 any --

8 JOHN: What is this, 20 questions on John?
9 We're going to get John's background tonight here, huh?

10 SHERRI: No, I would, I would like to --
11 yeah, I mean, you, you've been asking other people
12 questions and I'm the one that likes to ask questions.

13 JOHN: Well, go ahead.

14 SHERRI: Okay. Okay, so your 18-year-old,
15 does he like computers?

16 JOHN: To a limited amount, I guess.

17 SHERRI: Come on, Dad, you mean you never,
18 you don't know these things?

19 JOHN: To a limited amount. You know, he's
20 not the, a computer whiz. You know, that's not, I
21 would say, his biggest interest. But he, he is
22 computer-literate, yeah.

23 SHERRI: Oh, that's good. Yeah, 'cause
24 they're starting them real young.

25 JOHN: Hey, it's tough if you're not, isn't
it?

1 SHERRI: It sure is. Sure is. Well, that's
2 good.

3 JOHN: So --

4 SHERRI: So how long you been married?

5 JOHN: Longer than you, if I've got --

6 SHERRI: Well, that's true. I mean, you're a
7 lot older than I am.

8 JOHN: If I've got one that's 26 years old,
9 I've married for a while, haven't I?

10 SHERRI: Yeah, probably -- one woman?

11 JOHN: You bet, is there any other way?

12 SHERRI: Oh, 20, 20, 24 years. 25 years.

13 JOHN: You better keep going.

14 SHERRI: To 30 years.

15 JOHN: Almost, almost.

16 SHERRI: Oh, yeah, it would have to be.

17 Yeah, let's see, 25, 25 --

18 JOHN: Hey, the way I look at it, you're only
19 supposed to be married to one.

20 SHERRI: Well, I don't know, King David had
21 quite a lot of wives.

22 JOHN: Yeah, the --

23 SHERRI: And look at Solomon, a thousand
24 wives?

25 JOHN: -- King David I've been talking to for
the last several nights had a few too, huh?

1 SHERRI: Solomon. Well, if you knew the
2 prophecies, you would understand a little bit more.

3 JOHN: Well, it's interpretation there,
4 that's all.

5 SHERRI: But I understand -- well, if you're
6 a good listener, you'll learn something.

7 JOHN: I --

8 SHERRI: Did you learn about the first seal?

9 JOHN: I have been learning about the first
10 seal.

11 SHERRI: That's good. Where's it found?

12 JOHN: The second seal.

13 SHERRI: Well, where, wait a minute, where's
14 it found?

15 JOHN: The third seal.

16 SHERRI: Where's it found?

17 JOHN: The fourth seal.

18 SHERRI: Well, where's the first seal found?

19 JOHN: Where is it found?

20 SHERRI: Yeah.

21 JOHN: In the, in Psalm 45.

22 SHERRI: And all the psalms. So how many
23 psalms are there?

24 JOHN: Uh-huh, what is this, a quiz, a little
25 test in theology tonight?

(Laughter in background.)

1 SHERRI: No. But if you, you know, if you --

2 JOHN: I don't profess to be a theologian,
3 believe me.

4 SHERRI: Oh, I don't either, let me tell you,
5 I'm far from it.

6 JOHN: Yeah, but how long have you been with
7 David?

8 SHERRI: Well, I've been studying anyway for
9 --

10 JOHN: For how many years?

11 SHERRI: Let me think now? Six? About six
12 years.

13 JOHN: Well, see, I've been studying for
14 about three or four days.

15 SHERRI: And I bet you're learning a lot,
16 aren't you? More than you've ever learned with anybody
17 else.

18 JOHN: Well, I can't say that.

19 SHERRI: -- I can --

20 JOHN: But, but it's been a learning
21 experience, because it's been something totally new to
22 me.

23 SHERRI: Well, I know. The, it's really,
24 it's extremely, extremely important.

25 JOHN: Oh, I know, I know. And it's --

SHERRI: Okay, so there's, there's -- I'll

1 | tell you. There's 150 psalms.
2 | JOHN: Uh-huh.
3 | SHERRI: And each of those psalms are really
4 | important. 'Cause that's --
5 | JOHN: Hey, I'm sure they are, the whole
6 | book's important.
7 | SHERRI: Well, so that, that covers the first
8 | seal. Where's the second seal found?
9 | JOHN: Revelation.
10 | SHERRI: No. Well --
11 | JOHN: No?
12 | SHERRI: No, you got to, it's found --
13 | JOHN: Revelation Chapter 6, verse 3 to 4.
14 | SHERRI: Very good. Now, where is it found
15 | in the Prophets?
16 | JOHN: Oh, you're going to put the pressure
17 | on now, huh?
18 | SHERRI: No, but it's, you know, you -- if
19 | you were shown where these, these seals are, you need
20 | to know where they are in the prophecies. I mean,
21 | that's what, that's what Revelation 10 says. In the
22 | days of the voice of the seventh angel, when he begins
23 | to sound, the mystery of God will be finished, as it
24 | hath been declared by the servants, the prophets. I
25 | mean, has been already.
 JOHN: Yes.

1 SHERRI: So if all these prophets saw
2 something --
3 JOHN: Uh-huh.
4 SHERRI: And if you know what the prophets
5 saw.
6 JOHN: Uh-huh.
7 SHERRI: It's already been declared. God
8 declared it.
9 JOHN: Okay.
10 SHERRI: So where's the second seal found?
11 JOHN: I'm going to draw a blank here.
12 SHERRI: No, don't draw a blank.
13 JOHN: Why?
14 SHERRI: I can hear you turning those pages.
15 JOHN: No, I'm not.
16 SHERRI: No?
17 JOHN: I might be turning some wheels slowly.
18 SHERRI: Um-hum. Got your Bible there?
19 JOHN: You bet.
20 SHERRI: Okay. There better be --
21 JOHN: Then I could tell you I'm turning
22 pages, huh?
23 SHERRI: Yeah, you better, yeah. I'll give
24 you a hint, it starts with a Z.
25 JOHN: Zechariah.
SHERRI: Very good.

1 JOHN: How's that?

2 SHERRI: So what's --

3 JOHN: I'm learning a lot this week, aren't
4 I?

5 SHERRI: Yeah.

6 JOHN: This is, this is -- David doesn't have
7 time to give John a Bible lesson tonight, so somebody
8 else will, huh, Sherri?

9 SHERRI: (Laughs.) Well --

10 JOHN: Yes?

11 SHERRI: Okay, so you have -- did you find
12 Zechariah?

13 JOHN: Well, sure.

14 SHERRI: So what did you learn from the
15 second seal?

16 JOHN: That there was a red horse.

17 SHERRI: That there was -- right.

18 JOHN: And a rider.

19 SHERRI: Okay.

20 JOHN: And the power was given to him to take
21 peace from the earth.

22 SHERRI: Well, so --

23 JOHN: And they should --

24 SHERRI: What was the reaction of all --

25 JOHN: And they should kill one another, and
he was given --

1 SHERRI: Well, no.

2 JOHN: -- a great sword.

3 SHERRI: Yeah. But in Zechariah what does it
4 say?

5 JOHN: I don't know, what's it say?

6 SHERRI: Well, what was the reaction of the
7 whole earth when the horses went to and fro throughout
8 the whole earth? What was the reaction of the people?

9 JOHN: Tell me.

10 SHERRI: No, you got to find that.

11 JOHN: I do?

12 SHERRI: You said you knew the first seal and
13 "I was shown the second seal," and now you were going
14 on to the third --

15 JOHN: Well, I was.

16 SHERRI: I know, but you got to back up.

17 JOHN: I mean, we were going a mile a minute.

18 SHERRI: I know you were.

19 JOHN: Lord.

20 SHERRI: But we don't have that much time.

21 JOHN: It, it took you how --

22 SHERRI: This is time no longer.

23 JOHN: It took you how many years for this?

24 SHERRI: I know, it took a long time. But
25 some people have come here and learned it --

JOHN: And, and --

1 SHERRI: -- in less time than you have.

2 JOHN: I doubt it.

3 SHERRI: No.

4 JOHN: I doubt it. They didn't come in --

5 SHERRI: How about a day-and-a-half?

6 JOHN: -- totally, you know, new.

7 SHERRI: Well, Robert --

8 JOHN: -- in a day-and-a-half.

9 SHERRI: Robert got it all. Well, not all, I
10 wouldn't say all.

11 JOHN: I don't think so.

12 SHERRI: But he got a lot.

13 JOHN: And not in a day-and-a-half, either.

14 SHERRI: Well, he got at one Sabbath, boy, he
15 got a lot.

16 JOHN: Huh?

17 SHERRI: He got it at one Sabbath when he was
18 here.

19 JOHN: He did.

20 SHERRI: Oh, yeah.

21 JOHN: Huh.

22 SHERRI: So clear. And by the way, did you
23 ever find him?

24 JOHN: Did I ever find him?

25 SHERRI: Yeah. He was supposed to call here.

JOHN: Who was?

1 SHERRI: Robert Gonzales.
2 JOHN: He's not calling there.
3 SHERRI: How come?
4 JOHN: Because, as I explained to David, and
5 I'll, I'll be happy to explain to you, if you're --
6 SHERRI: Well --
7 JOHN: -- if you had some interest in it.
8 SHERRI: Well, I'm kind of --
9 JOHN: That Robert is no longer in this area,
10 that Robert --
11 SHERRI: Fled --
12 JOHN: -- has -- pardon me?
13 SHERRI: Fled --
14 JOHN: No, he didn't, he didn't flee, he had
15 some difficulties about this entire situation, and that
16 it was best that he not be around.
17 SHERRI: He really could see something, huh?
18 JOHN: He what?
19 SHERRI: Could he see something in what was
20 being taught?
21 JOHN: It had nothing to do with religion
22 that he had difficulties with.
23 SHERRI: Hum.
24 JOHN: It was difficulties with what happened
25 last Sunday.
SHERRI: Well, what happened last Sunday? I

1 | mean as far --

2 | JOHN: Where were you?

3 | SHERRI: As far as his difficulty is

4 | concerned.

5 | JOHN: Where were you? You don't have any

6 | feelings?

7 | SHERRI: I was standing right there.

8 | Actually I went, I was right there in the front porch

9 | when he came here --

10 | JOHN: Uh-huh.

11 | SHERRI: -- and handed me that paper.

12 | JOHN: Uh-huh.

13 | SHERRI: So I was really surprised that he

14 | came over.

15 | JOHN: Uh-huh.

16 | SHERRI: And he sat down and we had a little

17 | study.

18 | JOHN: Uh-huh.

19 | SHERRI: And then he was real anxious to

20 | leave.

21 | JOHN: Yeah.

22 | SHERRI: Then all of a sudden when he went

23 | out the door, the, his alarm on his car went off and it

24 | sounded just like a police alarm --

25 | JOHN: Uh-huh.

 SHERRI: -- siren.

1 JOHN: Uh-huh.

2 SHERRI: And, you know, all the time I was, I
3 was thinking to myself this guy is no student. I know
4 a student.

5 JOHN: Uh-huh.

6 SHERRI: I go, this guy is an undercover
7 agent. (Laughs.)

8 JOHN: Uh-huh.

9 SHERRI: The first time I saw him, and I, but
10 David's just, you know, he invites, or he will talk to
11 anybody who has an ear to listen.

12 JOHN: I think he will.

13 SHERRI: He, he does. He doesn't care if, if
14 you know, who the person may be. So he invited,
15 invited him in.

16 JOHN: Excuse me.

17 SHERRI: Gave him a study, and all the time I
18 was thinking, man, I wouldn't trust this guy with a
19 ten-foot pole, no way, no way.

20 JOHN: Uh-huh.

21 SHERRI: But yet he came in, he was, you
22 know, had a lot of study, I mean, you know, the times
23 he was here.

24 JOHN: Um-hum.

25 SHERRI: And -- but this morning or that
Sunday morning, he was really antsy to, to leave. And

1 I couldn't figure it out in a way, because --

2 JOHN: I guess you know why now, don't you?

3 SHERRI: Well, yeah, it was kind of a real,
4 it was a real bad set-up. Why didn't he just arrest
5 him right there? Why didn't he just serve him a
6 warrant right there?

7 JOHN: 'Cause he wasn't supposed to.

8 SHERRI: He was supposed to wait for us to be
9 slaughtered?

10 JOHN: He was supposed to leave.

11 SHERRI: He was supposed to leave and then
12 let us be slaughtered?

13 JOHN: No. Uh-uh.

14 SHERRI: Well, I'll tell you what --

15 JOHN: No one was, no one was, no one's was
16 supposed to even be harmed.

17 SHERRI: Well, how come they fired first,
18 because I saw it.

19 JOHN: Well, guess what.

20 SHERRI: And why did they --

21 JOHN: You will get your opportunity --

22 SHERRI: Why did they have --

23 JOHN: -- some day to testify to that.

24 SHERRI: -- so much foul language? I was
25 appalled.

JOHN: What can I tell you. What's done is

1 done, isn't it?

2 SHERRI: Yeah, it sure is. It's too bad.

3 JOHN: You know, I'm not privy to, I'm not
4 privy to any plans and I'm not privy to why things
5 happened, and, and I'm sorry that they did.

6 SHERRI: Yeah, me too.

7 JOHN: And I'm sorry for, for you and for the
8 people in there and I'm sorry for all of those ATF
9 people.

10 SHERRI: Yeah.

11 JOHN: And their families as well. And, and
12 you ask why was David concerned, David had a large role
13 to play in that and he should have been concerned, and
14 he should have had some feelings.

15 SHERRI: Well, it was just a, you guys did
16 wrong, that's all I got to say. Anyway --

17 JOHN: He did wrong?

18 SHERRI: You guys.

19 JOHN: Well, that's your opinion.

20 SHERRI: Well, the ATL -- ATF.

21 JOHN: You know, that's your --

22 SHERRI: They should not have -- well,
23 anyway.

24 JOHN: That's your opinion. Let me ask you
25 something.

SHERRI: (Indiscernible.) Well, wait, I'm

1 not --

2 JOHN: Let me ask you something, Sherri. You
3 were asking me a lot of questions.

4 SHERRI: Wait a minute, we have not finished
5 my conversation. You have an unbelievable way --

6 JOHN: What do you mean you, we haven't?

7 SHERRI: I, we were still on the second seal
8 and I didn't get it completely answered from you.
9 Remember, I asked you well, what was the, what was the
10 feeling of the people? Remember when the horses went
11 to and fro throughout the earth, what was the reaction
12 of the people?

13 JOHN: Uh-huh.

14 SHERRI: And you forgot to answer. 'Cause I,
15 I --

16 JOHN: Why, why is it so important that I
17 understand this?

18 SHERRI: Well, because if you don't
19 understand these seals --

20 JOHN: Yeah, yeah.

21 SHERRI: -- aye, woe to you. You will find
22 out. You will --

23 JOHN: Well, what am I going to find out?

24 SHERRI: You will -- you just don't know who
25 you're fighting against. Have you read Psalms 18?

JOHN: Well, if I didn't --

1 SHERRI: I'll tell you what.

2 JOHN: -- David read it to me.

3 SHERRI: I would be, I would be shaking in my
4 boots if I were you.

5 JOHN: Why?

6 SHERRI: Because -- do -- you don't believe
7 this book then, huh?

8 JOHN: I didn't say that.

9 SHERRI: God's word? That -- when you said
10 that --

11 JOHN: Are you saying I don't, I'm not a God-
12 fearing person, don't believe in the Bible?

13 SHERRI: No, well you said why. And I'm
14 saying because, if I -- I would be shaking in my boots
15 if I was you, because --

16 JOHN: Well, tell me what you want to tell
17 me.

18 SHERRI: -- what God said, what God says is
19 going to happen.

20 JOHN: What? I mean, tell me, you're in a --

21 SHERRI: No, you tell me --

22 JOHN: You're a school teacher, a learned
23 person. Speak to me.

24 SHERRI: Psalms 18. Open your Bible. I'm
25 not going to say it. I want the book to say it.
Because that's the only reason why I'm here. It's

1 'cause I, I'm waiting for God to do something.
2 JOHN: You are?
3 SHERRI: Yes, I am.
4 JOHN: You've been waiting for six years?
5 SHERRI: I -- no. I've been waiting since
6 Sunday now. When God says wait --
7 JOHN: Well, what, what happened before
8 Sunday?
9 SHERRI: Before Sunday we were preparing for
10 this event. We knew it was going to happen.
11 JOHN: You were?
12 SHERRI: Oh, yeah.
13 JOHN: Well, why did you let it happen?
14 SHERRI: Why?
15 JOHN: Yeah.
16 SHERRI: We were prepared --
17 JOHN: Uh-huh.
18 SHERRI: Because we can't control what you
19 guys do. Anyway, the reaction of --
20 JOHN: Let, let me, let me ask you something.
21 SHERRI: The reaction --
22 JOHN: Let me ask you something, okay? Just
23 want to ask a couple questions.
24 SHERRI: Yeah, but we did.
25 JOHN: I'm sorry, what?
SHERRI: Well, the reaction of the people,

1 Zechariah, remember that first question? What the
2 reaction of the people were? When the horses went to
3 and fro throughout the earth?

4 JOHN: I'm listening to you.

5 SHERRI: They don't care. They were at ease.
6 No one cares about the horses. No one cares about the
7 seals. That's the --

8 JOHN: Well, I know there's no interest in
9 the horses.

10 SHERRI: Yes.

11 JOHN: Uh-huh.

12 SHERRI: Of the, of Revelations. No one
13 cares about those horses in Revelations, those seals.
14 That was the reaction, that's the second seal.

15 JOHN: Uh-huh.

16 SHERRI: In a nutshell. So the third seal,
17 you said that you went over.

18 JOHN: Uh-huh.

19 SHERRI: Where's that found?

20 JOHN: Try the Book of Revelation.

21 SHERRI: Well, that's where it's introduced,
22 but where is it found in the prophecies?

23 JOHN: You won't accept the Book of
24 Revelation --

25 SHERRI: Yeah, because --

JOHN: -- about a black horse and a rider.

1 They had --

2 SHERRI: It's a black horse --

3 JOHN: -- a pair of horses --

4 SHERRI: Yes.

5 JOHN: -- and the balance between the wheat

6 --

7 SHERRI: But you got to know where in the

8 prophecies.

9 JOHN: -- the penny and the measures and the

10 barley and --

11 SHERRI: That's right, but where is it found?

12 JOHN: It was a balance of deceit, right?

13 SHERRI: Yeah, a balance of deceit is in his

14 head, okay, so --

15 JOHN: You got it. All right.

16 SHERRI: So is that a characteristic of

17 Christ?

18 JOHN: Is it in the book?

19 SHERRI: Well, that's --

20 JOHN: That's a clue, isn't it?

21 SHERRI: That's a clue, that sure is. All of

22 these are revelations of Christ.

23 JOHN: I'm not going to dispute them.

24 SHERRI: And there's time no longer.

25 Remember Revelations 10?

JOHN: Um-hum.

1 SHERRI: Time no longer.

2 JOHN: For who?

3 SHERRI: For people of this earth. There's
4 going to be --

5 JOHN: Are, are you trying to tell me
6 something?

7 SHERRI: I'm just telling you what the book
8 says, that's all.

9 JOHN: Yeah, but did the book say when?

10 SHERRI: The book says when it's, when the
11 voice of the seventh angel begins to sound.

12 JOHN: Uh-huh.

13 SHERRI: When these books are opened and
14 understood from cover to cover --

15 JOHN: Yes.

16 SHERRI: -- and harmonized, completely
17 harmonized --

18 JOHN: Where does it say that? Completely
19 harmonized.

20 SHERRI: When you start understanding the
21 Bible -- do you even understand Revelations? No.

22 JOHN: Not -- no, I don't.

23 SHERRI: But when you do start understanding
24 --

25 JOHN: Uh-huh.

SHERRI: -- in light of all of the prophets

1 --

2 JOHN: Yes.

3 SHERRI: -- that's what 10:7 is talking
4 about. When the voice of the seventh angel begins to
5 sound, the mystery of God -- that book is a mystery.
6 Revelations is a mystery, don't you think? Of
7 understanding?

8 JOHN: It's a little deep.

9 SHERRI: Yeah, it is a little deep. The
10 mystery of God will be finished as it has already been
11 declared to the servants, the prophets. So if you have
12 an understanding of what Isaiah saw, Josiah, Jeremiah,
13 all of the Old Testament prophets, if you understand
14 what they all saw and then understand the Book of
15 Revelations, in light of what all they saw, don't you
16 think it's time no longer at that time? Things are
17 going to be finished?

18 JOHN: I can't answer that.

19 SHERRI: Well, that's what the book says,
20 anyway.

21 JOHN: You know. And, and you may be talking

22 --

23 SHERRI: So where's the third seal found?

24 JOHN: -- a very strict interpretation of the
25 book.

SHERRI: Well, I'm just saying word for word,

1 | didn't -- when he gave you the study, didn't he give
2 | you it word for word?

3 | JOHN: Well, it's like saying that, you know,
4 | Christ made the, the earth in seven days. Did it
5 | happen in seven days --

6 | SHERRI: Well, that's what it said.

7 | JOHN: -- did it happen in seven months, in
8 | seven years, in seven centuries.

9 | SHERRI: It didn't say years and months and
10 | years, uh-uh. It said in seven days it was created.

11 | JOHN: Well, that's a strict interpretation.

12 | SHERRI: Well, no. No private
13 | interpretation, that's just, you know --

14 | JOHN: I didn't say private interpretation, I
15 | said it's a strict interpretation.

16 | SHERRI: Okay. A strict interpretation.

17 | JOHN: Yeah.

18 | SHERRI: Okay. But it didn't say years, it
19 | says days. So as we know days, that's how we take it.

20 | JOHN: Yeah, but we take other things out of
21 | context --

22 | SHERRI: Okay, so where's the third seal --

23 | JOHN: -- in there, don't we?

24 | SHERRI: Where's the third, where's the third
25 | seal found?

 JOHN: I say we take other parts of it out of

1 | context, don't we?

2 | SHERRI: I don't think so.

3 | JOHN: Yeah? Well, what happens when there
4 | was --

5 | SHERRI: You tell me where we take it out.

6 | JOHN: What happens when there was no sun out
7 | in the Old Testament?

8 | SHERRI: What do you mean, when there's no
9 | sun out?

10 | JOHN: Huh?

11 | SHERRI: When there's no sun out.

12 | JOHN: Yeah.

13 | SHERRI: You mean when? In one of the seals?

14 | JOHN: The sun hadn't been created and
15 | they're talking about days.

16 | SHERRI: Oh, you mean the, oh, you mean when
17 | the sun was not created?

18 | JOHN: Yeah. And how do you count days then?

19 | SHERRI: Now, that was on the fourth day.

20 | JOHN: Okay.

21 | SHERRI: So what are, what are you -- did I
22 | answer it?

23 | JOHN: You're going -- did it happen in a
24 | day?

25 | SHERRI: Well, that's what it said. Sun,
moon and stars --

1 JOHN: But, but what happened before the
2 fourth day?

3 SHERRI: What happened before the fourth day?

4 JOHN: Uh-huh.

5 SHERRI: There was a third day. And then
6 there was a second day. And a first day. And then
7 there was, let there be light. And then there was
8 light.

9 JOHN: Uh-huh.

10 SHERRI: Hum. But it didn't say years that
11 these things were created, it said a day. So we know
12 --

13 JOHN: What about, what about taking other
14 things out of context in there?

15 SHERRI: Well, for instance.

16 JOHN: What?

17 SHERRI: For instance. Give me an example.
18 Taking things out of context. Like?

19 JOHN: When you apply things that were
20 written back then --

21 SHERRI: Like --

22 JOHN: -- under today's times.

23 SHERRI: I'll tell you what the Hebrew --

24 JOHN: Whether it be the verbiage --

25 SHERRI: The Hebrews signify --

JOHN: You know, are we gonna, are we gonna

1 | hear thunder or are we gonna hear something else?

2 | SHERRI: Well, you know it as thunder.

3 | JOHN: Are we gonna talk about a bow and crow
4 | or something --

5 | SHERRI: I think you're gonna --

6 | JOHN: -- or are we gonna talk about
7 | something else.

8 | SHERRI: I think you're gonna, think you're
9 | see, I think you're gonna be, excuse the language, but
10 | I think you're gonna be shitting in your pants, sir.

11 | JOHN: Well.

12 | SHERRI: Excuse me, but, you know.

13 | JOHN: That really wasn't kind coming fr--

14 | SHERRI: Well, that's why I said excuse me.

15 | JOHN: -- coming from an educated person, was
16 | it?

17 | SHERRI: Well, there's many educated people
18 | that have more foul language than me, and I did, I did
19 | warn you ahead of time..

20 | JOHN: You did.

21 | SHERRI: I did, and those --

22 | JOHN: But is, is there something to tell me
23 | that Waco, Texas is Babylon?

24 | SHERRI: Hey, the world is Babylon.

25 | JOHN: Huh?

 SHERRI: The word Babylon just means

1 | confusion. And you know, there's so many cases that --

2 | JOHN: Yeah, but not the way it's been told
3 | to me in the last three nights by, by David. Okay?

4 | (Unidentified male voice in background not
5 | discernible.)

6 | SHERRI: Yeah.

7 | JOHN: You getting prompted by somebody else
8 | there?

9 | SHERRI: No, he, he said, he just, he was
10 | just, I was just -- he says you should have heard the
11 | federal agents out here talking, and I'd already you
12 | about that.

13 | JOHN: Hey. You're just interpreting this
14 | thing too, you know?

15 | SHERRI: I'm not interpreting.

16 | JOHN: Sure you are.

17 | SHERRI: What am I interpreting?

18 | JOHN: Sure you are.

19 | SHERRI: What am I interpreting?

20 | JOHN: Hey, the book was written and
21 | interpreted by who? A man. Right?

22 | SHERRI: Wait a minute, say that again?

23 | JOHN: The book was written and interpreted
24 | by a man, right? Many men.

25 | SHERRI: Well, not according to one of the
apostles, what he says about it.

1 JOHN: Was he a man?

2 SHERRI: He was a man. But what he says, he
3 says no scripture is just interpreted by a man.

4 JOHN: Hey, you open up the front page of
5 your book, and it was written by someone.

6 SHERRI: It's not private interpretation.

7 JOHN: Huh?

8 SHERRI: It was all given by spirit.

9 JOHN: Now, whether you want to go to the
10 King James Version or you want to go another version --

11 SHERRI: Anyway. Anyway.

12 JOHN: Let me ask you a couple of questions.

13 SHERRI: I'm, I'm --

14 JOHN: Let me -- hey, wait a minute.

15 SHERRI: I want to teach you, I want to teach
16 you a Hawaiian word.

17 JOHN: Aloha?

18 SHERRI: No, it's tau, T-A-U.

19 JOHN: T-A-U?

20 SHERRI: Uh-huh.

21 JOHN: Let me ask you something.

22 SHERRI: That means, I'm finished.

23 JOHN: Hey.

24 SHERRI: Yes.

25 JOHN: Don't be that way now.

SHERRI: What do you mean, don't be that way?

1 | You don't --

2 | JOHN: I've been listening to you, don't you

3 | want to listen to me?

4 | SHERRI: Well, I've listened, I've listened

5 | on the TV and the radio.

6 | JOHN: No, no, no, no.

7 | SHERRI: I've listened a lot.

8 | JOHN: Hey. Let's be fair now.

9 | SHERRI: Let's be fair now?

10 | JOHN: I've listened to you.

11 | SHERRI: You're talking about let's be --

12 | JOHN: I've listened to you, now --

13 | SHERRI: -- fair? Whoa.

14 | JOHN: Now how about letting me ask you a

15 | couple of questions?

16 | SHERRI: Whoa, whoa. Whoa, now, I think --

17 | JOHN: You just want to be verbose, and you

18 | don't want to let anybody else say anything.

19 | SHERRI: -- you've asked, I think you've

20 | asked a lot of questions, and --

21 | JOHN: Huh?

22 | SHERRI: I think I'm done.

23 | JOHN: You're being kind of rude.

24 | SHERRI: I'm sorry. But I'm, I'm done.

25 | JOHN: Hey.

 SHERRI: Yes.

1 JOHN: Can I ask you a couple of things? I
2 want to ask you just a couple of questions, okay?

3 SHERRI: I don't think so.

4 JOHN: Are, do you --

5 SHERRI: I actually didn't even want to talk
6 tonight, and I was --

7 JOHN: Why not?

8 SHERRI: -- and I was asked to.

9 JOHN: Let, let me ask you something.

10 SHERRI: Do you know that I have --

11 JOHN: I want to tell your, I want to tell
12 your mom something, all right, and I'm gonna tell her
13 more than just look at Matthew 24.

14 SHERRI: No, I want you to give that message
15 exactly the way I gave it.

16 JOHN: Well, I'm gonna tell her --

17 SHERRI: I want you to tell her Matthew 24,
18 she'll understand.

19 JOHN: No, I'm gonna -- somebody's gonna tell
20 her that we spoke to you.

21 SHERRI: Good. And tell her that we went
22 over the first, second, and third seal, somewhat.

23 JOHN: Probably do -- somewhat, huh.

24 SHERRI: Somewhat.

25 JOHN: Let, let me ask you something, Sherri.

SHERRI: You know what, she used to say --

1 JOHN: Sherri, answer, answer something.

2 SHERRI: She used to say --

3 JOHN: You love to talk.

4 SHERRI: I think that --

5 JOHN: You know, you learn more from

6 listening, you know.

7 SHERRI: I think that --

8 JOHN: Is that what you tell your students?

9 SHERRI: No, and you know I used to teach
10 some rotten students.

11 JOHN: You tell them you learn more from
12 listening than from talking though, don't you.

13 SHERRI: I'm telling you, I'm telling you,
14 they were pretty bad. In fact, my principal was, just
15 before I, I left this last time, he goes --

16 JOHN: Where was that?

17 SHERRI: He goes --

18 JOHN: Huh?

19 SHERRI: He says, you know, we used to be
20 afraid, not afraid, but we used to be fighting off
21 students with spit wads, you know --

22 JOHN: You're kidding me.

23 SHERRI: -- years ago, years ago. Now we
24 fight them off with guns and knives.

25 JOHN: Not in schools.

SHERRI: That's -- oh, yes. Oh, yes.

1 JOHN: You got to be kidding.

2 SHERRI: No. I worked with the at-risk kids
3 with, you know, the druggies --

4 JOHN: Uh-huh.

5 SHERRI: -- the ones that were kicked out of
6 school --

7 JOHN: Uh-huh.

8 SHERRI: -- the failures, the ones that, that
9 had the guns and the knives and --

10 JOHN: You just don't hear about those
11 problems out there.

12 SHERRI: Oh, man. I had a, I had a kid that
13 -- 'cause I taught computers.

14 JOHN: Uh-huh.

15 SHERRI: And he came in, he says oh, well,
16 you know, I can't type today because I got shot in the
17 hand because I stole this car and, and the cops, when
18 they got me, you know, I, I just got in a mess of
19 trouble. And I go okay, that's cool, you know.

20 JOHN: Yeah.

21 SHERRI: I said, well, let me look at it, so
22 I looked at it and I said, well, you do what you can,
23 and I wanted him to just, just do what he could.
24 Anyway, but --

25 JOHN: Hey, there's, there's some, there's
some redeeming value in all of them, though, isn't

1 | there?

2 | SHERRI: Oh, they're terrific, I don't care

3 | --

4 | JOHN: Hey, look at David.

5 | SHERRI: Da-- yeah. What about him? He was

6 | a --

7 | JOHN: He was a dropout.

8 | SHERRI: He was a dropout and he had perfect
9 | citizenship. He was no trouble.

10 | JOHN: Sure.

11 | SHERRI: You know, that's, that's --

12 | JOHN: You know, and that's great, isn't it?

13 | SHERRI: Oh, you know what, there's somebody
14 | right here. Oh --

15 | JOHN: Hey, wait a minute, don't run off.

16 | SHERRI: Wait, she just wants to talk to you

17 | --

18 | JOHN: Don't run off.

19 | SHERRI: -- for one second.

20 | JOHN: Let me ask you something.

21 | SHERRI: What?

22 | JOHN: I mentioned to you that, that David
23 | and Steve both told me --

24 | SHERRI: Um-hum.

25 | JOHN: -- that all of the adults and women
and children are, are free to leave there, right?

1 SHERRI: Oh, absolutely.

2 JOHN: And they're there on their own
3 volition.

4 SHERRI: Absolutely.

5 JOHN: Okay. And that you're there because
6 you want to be there, is that correct?

7 SHERRI: Totally.

8 JOHN: Now, do you have any -- I mean, you
9 got a husband there, children there, anything like
10 that?

11 SHERRI: Yeah.

12 JOHN: Okay. And so the only person on the
13 outside that you want that message passed to is your
14 mom, huh?

15 SHERRI: For, at this moment.

16 JOHN: What, she'll pass on to other people?

17 SHERRI: If she wants to.

18 JOHN: No, I just want to make sure that I'm
19 not missing out on somebody for you.

20 SHERRI: I just -- I, no. You know, they
21 know where I stand, and they know that that Bible is,
22 is -- I'm testing it, to tell you the truth.

23 JOHN: Hey, how many children do you have?

24 SHERRI: I think I'll keep that to myself.
25 You'll find out.

JOHN: Well, I told you.

1 SHERRI: I have, I have several. Anyway --

2 JOHN: Why are you reluctant to tell me?

3 SHERRI: Because this person is nudging on my
4 arm and wanting to talk to you. Just a minute.

5 JOHN: Would you stay right there and come
6 back to me.

7 SHERRI: Listen, it's been lovely, it's been
8 lovely discussing the seals with you. I hope you will
9 have another study with David if, if you can, because
10 you can benefit from getting into the fifth seal.

11 JOHN: Can't we all, huh.

12 SHERRI: Yeah. I mean take it to heart.
13 Truly.

14 JOHN: I do.

15 SHERRI: Yeah. (Laughs.)

16 JOHN: I do.

17 SHERRI: Well, good.

18 JOHN: It's something new for me.

19 SHERRI: Good. I hope so.

20 JOHN: So it's, it's, it's just kind of hard
21 to take it.

22 SHERRI: Yeah.

23 JOHN: Just answer me one question before you
24 run off because somebody's tugging at your arm.

25 SHERRI: I, I answered it already.

JOHN: Why do you have all those weapons in

1 | there?

2 | SHERRI: Why?

3 | JOHN: Yeah.

4 | SHERRI: If we didn't we would have been
5 | slaughtered. Why, how --

6 | JOHN: Well, no, no, no.

7 | SHERRI: Let me -- oh, well, you know what?

8 | JOHN: Why do you have them? I've been in
9 | Baptist church and Catholic church and synagogues and
10 | all these places, and I don't see weapons.

11 | SHERRI: Hey, you just stepped on the phone
12 | again. There.

13 | JOHN: And I, I don't see weapons there.

14 | SHERRI: You don't see weapons there?

15 | JOHN: No.

16 | SHERRI: Well, you know, Christ said if my
17 | kingdom was of this world, my servants would fight.

18 | JOHN: Uh-huh.

19 | SHERRI: Well. Did you know that he asked --

20 | JOHN: Let me know the last time you go into
21 | a Catholic church or a Baptist church or a
22 | Presbyterian, Lutheran, Episcopalian --

23 | SHERRI: Well, I'll tell you what.

24 | JOHN: -- and you find all the weapons.

25 | SHERRI: How come nothing has been said about
the three choppers that came over and just started

1 whaling on this building.

2 JOHN: Don't know anything about it.

3 SHERRI: With machine guns. Oh, ho, ho.

4 That's how --

5 JOHN: Huh?

6 SHERRI: That's how I believe --

7 JOHN: From what I understand and from what

8 I've been told --

9 SHERRI: Well, I know.

10 JOHN: And I can only tell you what I've been

11 told, is that no rounds were fired out of helicopters.

12 SHERRI: No rounds --

13 JOHN: That's right.

14 SHERRI: -- were fired out of helicopters.

15 JOHN: That's the only thing I was told.

16 SHERRI: You -- that is, excuse me, but this

17 is --

18 JOHN: Don't use any profanity now.

19 SHERRI: Excuse me, I am warning you, that's

20 bullshit, I am sorry.

21 JOHN: Well, all I'm telling you --

22 SHERRI: I am sorry, we have --

23 JOHN: -- is what I was told.

24 SHERRI: We have proof. I mean, you don't

25 get bullets from coming down from the ceiling down.

JOHN: Uh-huh.

1 SHERRI: From no -- three helicopters --
2 JOHN: Uh-huh.
3 SHERRI: -- with machine guns on them.
4 JOHN: Uh-huh.
5 SHERRI: Now, come on. We have a dead
6 person, I think because of that.
7 JOHN: Well, you may have had more.
8 SHERRI: Which you not even come get, which
9 we're gonna bury tomorrow out in front.
10 JOHN: Yeah, well.
11 SHERRI: I am, I am --
12 JOHN: It seems like a righteous thing to do.
13 SHERRI: If you did not have -- oh, yeah.
14 But not on your part.
15 JOHN: Why?
16 SHERRI: Why?
17 JOHN: Yeah, why do you say that?
18 SHERRI: Maybe you're not understanding, I
19 said it was not righteous of you guys to have three
20 helicopters coming over. I mean, you have these people
21 coming --
22 JOHN: Those guys didn't have three
23 helicopters.
24 SHERRI: Well look at -- you did have three
25 helicopters. You did. If I had a camera in my hand I
would have taken it.

1 JOHN: Hey, you're talking to the, you're
2 talking to an FBI agent, all right?

3 SHERRI: I know. Well, I'm telling whoever,
4 'cause I can't talk to anybody else.

5 JOHN: You're right.

6 SHERRI: The ATF people, then. Those people.

7 JOHN: Right.

8 SHERRI: You have them coming in the front
9 with these two, two, you know, cattle -- I don't know
10 what you call them -- trucks, like.

11 JOHN: Trailers.

12 SHERRI: Filled with men, coming out
13 shooting. I mean, and then, in the back of our
14 property you have three choppers coming in on us.

15 JOHN: Uh-huh.

16 SHERRI: I mean, come on. We're talking
17 slaughter here. And the only reason those, those
18 choppers took off was because we were firing at them.
19 Now, we --

20 JOHN: That doesn't tell me why you had the
21 weapons there, though, does it.

22 SHERRI: I'm telling you. Self-defense.

23 JOHN: Hey, that's not what the Constitution
24 says.

25 SHERRI: The Constitution says bear arms,
okay --

1 JOHN: But --

23 scripture?

24 JOHN: Who's this?

25 SHERRI: Me. This is Sherri.

JOHN: Oh, I thought you were running off on

1 me.

2 SHERRI: You know, it's just that I'm real
3 concerned that you don't seem to fear, that's all, and,
4 you know, you're talking --

5 JOHN: Do I fear death? Is that --

6 SHERRI: Do you fear God?

7 JOHN: -- what you're asking?

8 SHERRI: I'm asking if you fear God.

9 JOHN: Sure, I love God.

10 SHERRI: The beginning of wisdom is fearing
11 God.

12 JOHN: Hey.

13 SHERRI: You know, fearing God?

14 JOHN: You know, some people fear God, other
15 people love God.

16 SHERRI: Well, you don't fear God.

17 JOHN: And, and it's like being a pessimist
18 and being an --

19 SHERRI: Do you want to know any more
20 scripture about this?

21 JOHN: It's like being a pessimist and an
22 optimist.

23 SHERRI: John, do you want to know some more
24 scripture about this?

25 JOHN: Is it half full or half empty, kid.

Huh?

1 SHERRI: Do you want to know any more
2 scripture about this?

3 JOHN: Where are we going with this?

4 SHERRI: Huh?

5 JOHN: Where are we going with this?

6 SHERRI: What do you mean, where are we
7 going? For your understanding.

8 JOHN: Well, you just wanted to be
9 belligerent --

10 SHERRI: For your salvation, that's my --

11 JOHN: -- and, and raising your voice and
12 getting crude and all of this kind of stuff.

13 SHERRI: I'm not getting crude, I said excuse
14 me ahead of time. And it was not as crude as your men
15 were, not your men but, you know, the other guys.

16 JOHN: I'm not talking about what happened
17 last Sunday.

18 SHERRI: You're all the same, you're all the
19 same company, government. I mean, I don't talk like
20 those guys.

21 JOHN: Well, I'm sorry you feel that way.

22 SHERRI: You know, they talk a lot cruder and
23 they didn't say, you know, excuse me ahead of time.

24 JOHN: Well --

25 SHERRI: Anyway, did you want to know some
more scripture on this?

1 JOHN: Like what?

2 SHERRI: About, about anything from David?

3 JOHN: What do you want to tell me?

4 SHERRI: No, I want to know, do you want to
5 study?

6 JOHN: Do I want to study scripture tonight?

7 SHERRI: Um-hum.

8 JOHN: No. What I asked David is to speak to
9 some people tonight. And he said that he would make
10 them all available for me to speak to them.

11 SHERRI: Yeah, well, most of them went to
12 bed.

13 JOHN: I wonder why?

14 SHERRI: Because. I was in bed. I didn't
15 want to get up. I said I'd talk to him tomorrow. And
16 then he says, well, why don't you talk to him.

17 JOHN: Oh, you, you couldn't give up the
18 opportunity though, could you, huh?

19 SHERRI: Hey, I'm sorry, but a lot of these
20 people really don't want to speak to you, because it's
21 all the same sh-- stuff.

22 JOHN: What? What same stuff?

23 SHERRI: You know, the questioning, the --

24 JOHN: You think I'm being antagonistic in my
25 dialogue with you or something?

SHERRI: No, it's just that --

1 JOHN: I'm really not.

2 SHERRI: -- you know, it's like senseless.
3 Our whole point is the book, the Bible. You don't
4 really --

5 JOHN: People call in here and they care
6 about people, and so I tell them, I tell David and I
7 tell Steve look, all I want to do is talk to the person
8 and to ensure that they're all right, to ensure they're
9 in there.

10 SHERRI: We are all fine here.

11 JOHN: And ensure that they're in there at
12 their own free will.

13 SHERRI: We are here in our own free will,
14 and that garbage that --

15 JOHN: Well, you can speak for yourself.

16 SHERRI: That garbage that you had on the TV,
17 I was about ready to throw something at it.

18 JOHN: What, what's that?

19 SHERRI: Because when you, when the guy said
20 that we, we were not here on our own free will, that's
21 not, that is like so far from the truth.

22 JOHN: Well, who said that?

23 SHERRI: That, that guy that was on the TV.
24 I don't know what his name was, name was. I mean, I
25 took notes on the whole thing.

JOHN: Uh-huh.

1 SHERRI: It was bad. It was, it put us in a
2 real bad light.

3 JOHN: Well, there's no question in my mind
4 that you're there on your own free will, and I'm not
5 going to argue that. But people call in and they want
6 to know if their loved ones are, are safe, if they've
7 been injured.

8 SHERRI: I have lived with these people for a
9 long time, and I don't know --

10 JOHN: Do what?

11 SHERRI: I have lived with these people for a
12 long time.

13 JOHN: Uh-huh.

14 SHERRI: This is a family here.

15 JOHN: Uh-huh.

16 SHERRI: And I don't see anybody who wants to
17 leave. Nobody. And you know --

18 JOHN: But you're not, you're not there to
19 speak for other people though, are you?

20 SHERRI: No, I'm not.

21 JOHN: You know, no more than I am either.

22 SHERRI: Hey, you know what? They would --

23 JOHN: Hey, David's son told me he wanted to
24 leave.

25 SHERRI: David's son told you he wanted to
leave. You know why? Probably 'cause cartoons or

1 something.

2 JOHN: I didn't bring up why.

3 SHERRI: Well, I didn't --

4 JOHN: And you, it's pure speculation --

5 SHERRI: I didn't know either.

6 JOHN: -- on your part why, isn't it?

7 SHERRI: Speculation.

8 JOHN: Isn't it?

9 SHERRI: Because, you know, this is real

10 senseless. And here's this person that would like to

11 speak to you.

12 JOHN: God bless you, kid.

13 SHERRI: God bless me?

14 JOHN: Yeah, stay in there.

15 SHERRI: I think you better start hoping he

16 blesses something else there, too, 'cause I'd be

17 shaking in your boots.

18 JOHN: Hey. Just take care of yourself,

19 everything will work out fine. And I'll see you when

20 you come out.

21 SHERRI: (Laughs.)

22 JOHN: Because David said you are coming out.

23 SHERRI: Oh, we definitely are coming out.

24 JOHN: He says it's just a matter of time.

25 So I'll see you when you come out.

SHERRI: You definitely will see us when we

1 | come out.

2 | JOHN: Okay.

3 | SHERRI: Okay. (Unidentified voices in
4 | background not discernible.) Jean left again.

5 | JOHN: Pardon me?

6 | SHERRI: Where's Jean? She was wanting to --
7 | (Unidentified male voice in background not
8 | discernible.) Do you want to speak or not?
9 | (Indiscernible) or not, yes or no?

10 | MS. BORST: Hi, this Mary Jean Borst again.
11 | I just wanted to --

12 | JOHN: Hey, Mary Jean, how are you?

13 | MS. BORST: Fine. I just wanted to say one
14 | thing.

15 | JOHN: Yes, ma'am.

16 | MS. BORST: I used to work for the FBI --

17 | JOHN: Did you really?

18 | MS. BORST: -- years ago, yes.

19 | JOHN: Where?

20 | MS. BORST: Many years ago in Washington,
21 | D.C.

22 | JOHN: No, kidding, whereabouts?

23 | MS. BORST: Well, I was, for a little while I
24 | was in the Ident, Identification Building.

25 | JOHN: Don't tell me that, what year?

 MS. BORST: Well, I started in '62.

1 JOHN: So was I.

2 MS. BORST: Really?

3 JOHN: Second and D Street, S.W.

4 MS. BORST: And then I went to the -- oh, I
5 can't remember the name of that building right now, it
6 starts with an R?

7 JOHN: Where?

8 MS. BORST: At that time it was the, the name
9 of the building that I went -- first I was in the
10 Identification Building.

11 JOHN: Uh-huh.

12 MS. BORST: Then I went to the -- I can't
13 remember the name of the building right now. But I,
14 anyway I went --

15 JOHN: Was it the Washington field office?

16 MS. BORST: Oh, I don't think so.

17 JOHN: Or the main building, the main Justice
18 building?

19 MS. BORST: No, I went, it was a smaller
20 building. I went into a steno pool anyway.

21 JOHN: Yeah.

22 MS. BORST: First I was in the Ident Building
23 as a, you know, fingerprint, and then I went to --

24 JOHN: You were in the fingerprint section?

25 MS. BORST: Yes, just for a short time, and
then I went --

1 JOHN: You got to be kidding me.

2 MS. BORST: No.

3 JOHN: In 1962?

4 MS. BORST: Right.

5 JOHN: That means two of us were there,
6 doesn't it?

7 MS. BORST: Really?

8 JOHN: Yeah.

9 MS. BORST: Well anyway, I just wanted to
10 say, I mean, I remember a lot of the people that I
11 worked with back then and I'm sure some are still
12 working there.

13 JOHN: Who was your supervisor back then?

14 MS. BORST: In the Identification Building?

15 JOHN: Yeah.

16 MS. BORST: I don't really remember, see,
17 'cause I was only in the Identification Building for
18 three months. I went there because --

19 JOHN: Uh-huh.

20 MS. BORST: -- there was no opening at the
21 time in the steno pool, and then I --

22 JOHN: I bet you were happy to get out, huh?

23 MS. BORST: And -- well, I enjoyed it but I
24 loved it in the steno pool.

25 JOHN: Yeah.

MS. BORST: And then, but, and I just wanted

1 | to mention there was this, I had a good friend back
2 | then --

3 | JOHN: Uh-huh.

4 | MS. BORST: -- who later became an agent.

5 | JOHN: Oh, no kidding, who?

6 | MS. BORST: I was just -- Gary Stone. And I
7 | was just wondering if there's any way I could --

8 | JOHN: Jerry or Gary?

9 | MS. BORST: Gary, Gary, with a G. And I was
10 | just wondering if there's any way I could ever talk to
11 | him or at least just tell him hi for me? I heard --

12 | JOHN: Gary Stone. Do you know where he may
13 | have gone?

14 | MS. BORST: Well, I heard several years back,
15 | it's quite a few years ago, that he was stationed in
16 | Texas, but then that was, you know, quite a few years
17 | ago --

18 | JOHN: Like how many years ago?

19 | MS. BORST: Oh, that's probably, it's
20 | probably been ten years or so ago now, that I heard
21 | that. So --

22 | JOHN: Now, was he an agent when you were
23 | with him up there or was he clerk?

24 | MS. BORST: No, no, no. He came in as a
25 | messenger, right?

 JOHN: Uh-huh.

1 MS. BORST: He was a clerk in that same
2 building I was in the steno pool. And then he --

3 JOHN: And it wasn't Washington field office,
4 huh? The Old Post Office Building?

5 MS. BORST: No. It was, it's, the building,
6 the name of the building started with an R.

7 JOHN: Like the Ryder Building or something?

8 MS. BORST: Something like that. Well, I
9 don't think it was Ryder but I'm sure it started with
10 an R.

11 JOHN: Whereabouts was it, do you recall?

12 MS. BORST: I don't know, but it was a ways
13 away from the Identification Building. It wasn't right
14 there, you know.

15 JOHN: It wasn't up near the Library of
16 Congress, huh?

17 MS. BORST: I think it was just like Raleigh,
18 the -- no, not Raleigh.

19 JOHN: What, it wasn't --

20 MS. BORST: Rydell, the Rydell Building.

21 JOHN: Rydell Building?

22 MS. BORST: That was it, Rydell Building.

23 JOHN: That was the old, what, Domestic
24 Intelligence Division, Rydell Building?

25 MS. BORST: It was in the Rydell Building, so
it was like--

1 JOHN: And he was a messenger there?

2 MS. BORST: He was a messenger there. And
3 then he, you know, later he, he studied, he, you know,
4 went on to become an agent and --

5 JOHN: Um-hum.

6 MS. BORST: So it was several years later,
7 probably before he became an agent.

8 JOHN: Um-hum.

9 MS. BORST: But, but he became an agent.
10 Last I heard, I believe he was stationed in Texas and
11 that's --

12 JOHN: Well, let me tell you, we'll try to
13 round him up.

14 MS. BORST: Oh, I would love that. And his
15 wife. He got married back then when he was still a, a
16 messenger and --

17 JOHN: Uh-huh.

18 MS. BORST: -- she was a very good friend of
19 mine who worked in the steno pool with me, and I would
20 love it if you could get a message to them, 'cause they
21 were great people. And you know, so many people back
22 then -- my, my supervisor in the steno pool was Sylvia
23 Wahler, and I'm --

24 JOHN: I bet you she's retired by now.

25 MS. BORST: She's what?

JOHN: I bet she's retired by now, huh?

1 MS. BORST: Well, I don't know. She was,
2 back then she was like her late 20's. So --

3 JOHN: And she was a supervisor?

4 MS. BORST: She was a supervisor in the steno
5 pool and --

6 JOHN: That's young.

7 MS. BORST: And she's someone I'm sure that
8 would stay with the FBI until she retired, so she's
9 probably still there.

10 JOHN: Let, let me --

11 MS. BORST: And I really liked her and I
12 would love it if you could tell her hi for me.

13 JOHN: Give me, give me her name again.

14 MS. BORST: Sylvia Wahler. W -- I think it's
15 W-A-H-L-E-R, I'm not sure. But her husband's name is
16 Richard Wahler, Dick. His name is Dick.

17 JOHN: I knew a fellow that --

18 MS. BORST: But he didn't work for the FBI,
19 he was --

20 JOHN: -- that was an agent with that name.
21 But he did not, huh?

22 MS. BORST: No, he, he worked for someone
23 else, but.

24 JOHN: Yeah. How long did you work for the
25 Bureau?

MS. BORST: I only worked there for 2½ years.

1 JOHN: Yeah.

2 MS. BORST: Then I went back to Minnesota.

3 JOHN: Well, you know something about the
4 Bureau then, huh?

5 MS. BORST: Yes, somewhat, you know. I mean
6 that was years ago.

7 JOHN: And you, and you know we're pretty
8 decent people, don't you.

9 MS. BORST: I know that there are a lot of
10 people that I really loved, you know. Good people all
11 over.

12 JOHN: Some, some good folks, huh.

13 MS. BORST: Right. That's very true.

14 JOHN: Well, well, you can do me a big favor,
15 because we are good people and we are family, and we
16 don't want to mistreat anyone or hurt anyone, and, and
17 if you can plant that seed in there, that, that I'm
18 being as truthful as I can be when I tell you that,
19 that I, I have patience and everybody else out here has
20 an awful lot of patience that this thing will be
21 resolved peacefully and that's, that's our fondest
22 wish. And you know the way the Bureau is, that we like
23 to do things the right way, huh?

24 MS. BORST: Well, I believe you. I mean, and
25 I just have one thing I would like to ask of you.

JOHN: You bet.

1 MS. BORST: Please, besides, you know, if you
2 could contact those people I used to know, I would love
3 that, but --

4 JOHN: Uh-huh.

5 MS. BORST: -- just please keep letting David
6 show you the seals, have an open mind and, and study,
7 because this is the truth.

8 JOHN: Okay.

9 MS. BORST: It would never be here if it
10 wasn't the truth. Okay? And, and all we want is for
11 everyone to know the truth and that was all.

12 JOHN: Well, do you think the seals' gonna
13 let you come out of there shortly?

14 MS. BORST: Well, like I said, all I'm
15 waiting is for God to say come out --

16 JOHN: Okay.

17 MS. BORST: -- and I'm out.

18 JOHN: Okay.

19 MS. BORST: Okay?

20 JOHN: I'll see you when you come out, huh?

21 MS. BORST: Okay.

22 JOHN: All right.

23 MS. BORST: I sure appreciate it.

24 JOHN: You be good, huh?

25 MS. BORST: You too. Did you want to talk to
David or --

1 JOHN: Sure, I'll to anybody that's there.
2 MS. BORST: He says anybody that's here.
3 JOHN: I'll even talk to Sherri if she wants
4 to talk.
5 MS. BORST: Okay, let me check, okay? Okay,
6 bye-bye.
7 JOHN: Okay.
8 [gap]
9 (Unidentified male voice in background not
10 discernible.)
11 JOHN: Hello. Hello. Hello.
12 OLIVER: Hello.
13 JOHN: Hello.
14 OLIVER: This is an Aussie from down under,
15 mate. Good day.
16 JOHN: Hey, how are you?
17 OLIVER: I'm all right.
18 JOHN: What's your name?
19 OLIVER: My name's Oliver Gyarfas.
20 JOHN: Oliver --
21 OLIVER: G-Y-A-R-F-A-S.
22 JOHN: G-Y -- G-Y, give it, give it to me
23 again. G-Y --
24 OLIVER: G-Y-A-R-F-A-S.
25 JOHN: Okay.
OLIVER: I just wanted to tell you about my

1 | experience.

2 | JOHN: Go ahead.

3 | OLIVER: Okay.

4 | JOHN: Your wife's -- Elizabeth's your wife,
5 | huh?

6 | OLIVER: No, my -- Elizabeth's my mother.

7 | JOHN: Oh, I'm sorry.

8 | OLIVER: Yeah. They, they -- I don't where
9 | they are at the moment, they're probably pretty worried
10 | about me. Anyway, I'd like to tell you about my
11 | experience, is that all right?

12 | JOHN: Go ahead.

13 | OLIVER: Okay. I heard, I heard gunfire, all
14 | right, so we -- you know, as you know, we've got a
15 | bunker.

16 | JOHN: You've got a what?

17 | OLIVER: We've got a bunker. You know what
18 | that is?

19 | JOHN: Well, I know what a bunker should be,
20 | yeah.

21 | OLIVER: Well, anyway, it's a tornado
22 | shelter, something like that.

23 | JOHN: Uh-huh.

24 | OLIVER: So I went down in there and I walked
25 | over to the tunnel entrance, and I see one of your guys
 | in a, in the, in a puddle. I could see his reflection

1 | above.

2 | JOHN: Uh-huh.

3 | OLIVER: He must have seen us, because, you

4 | know, he, he screamed out, he said, "Come out you

5 | mother-f'ers" --

6 | JOHN: Uh-huh.

7 | OLIVER: -- you know? I'm, I'm sure you

8 | probably know about this. But I couldn't shoot the guy

9 | because he was behind the cement, you know? So he was

10 | lucky.

11 | JOHN: Why would you want to shoot him?

12 | OLIVER: Well, he was shooting at us, you

13 | know, so self-defense, you know.

14 | JOHN: Uh-huh.

15 | OLIVER: That's the only reason I'd shoot

16 | anyone. Self-defense.

17 | JOHN: Let me, let me --

18 | OLIVER: I wouldn't go out to kill anyone

19 | purposely --

20 | JOHN: Let me ask you something, Oliver.

21 | OLIVER: Go ahead.

22 | JOHN: You're there -- do you have any other

23 | relatives in there with you?

24 | OLIVER: Yeah.

25 | JOHN: Who do you, who else do you have in

there with you that are your relatives?

1 OLIVER: I've got a sister, her name's Aisha
2 Gyarfas.

3 JOHN: Okay, I talked to her earlier, I
4 guess, Aisha.

5 OLIVER: Yeah.

6 JOHN: And we, and we were having some
7 confusion as to the spelling of her first name. 'Cause
8 she said there were several spellings for her first
9 name.

10 OLIVER: Um-hum.

11 JOHN: What is the correct spelling of her
12 first name?

13 OLIVER: The correct spelling is A-I-S-H-A.

14 JOHN: Okay.

15 OLIVER: That's the correct spelling.

16 JOHN: And, and that's it, just you and your
17 sister are in there?

18 OLIVER: Yeah.

19 JOHN: As far as relatives are concerned.

20 OLIVER: Yeah.

21 JOHN: Do you understand, David and Steve and
22 I have both discussed several nights now, that everyone
23 in there is free to leave if they care to leave, all
24 the men, all the women, all the, all the youngsters.
25 And that's your understanding? That should you care to
leave, you're certainly free to leave?

1 OLIVER: Oh, yeah.

2 JOHN: And no, and nobody's trying to exert
3 any pressure upon you to leave, so that, that you are
4 in fact staying in there on your own free will, is that
5 correct?

6 OLIVER: That is correct, yes.

7 JOHN: And that David has told me that he has
8 every intention of leaving and he wants to leave and
9 he's just waiting to hear the word and that everybody
10 then will come out, and he will bring his flock out
11 with him, and --

12 OLIVER: Yeah, he --

13 JOHN: -- is that your impression?

14 OLIVER: Yeah, he's waiting on Big Daddy to
15 give him the word.

16 JOHN: On who?

17 OLIVER: Big Daddy. God.

18 JOHN: Well, I guess that's one way to
19 address him. I haven't really addressed him that way
20 before.

21 OLIVER: Well, that's just my little nickname
22 for him, that's all.

23 JOHN: Yeah. But you, you are, you are aware
24 that, you know, you're free to leave, all you got to do
25 is walk down the road and --

OLIVER: That is true.

1 JOHN: -- that's the way it'll be. How long
2 have you been down there?

3 OLIVER: I think it's been about 11, 12
4 months from now.

5 JOHN: Has it really.

6 OLIVER: Yeah. (Indiscernible)

7 JOHN: Having a tough week, huh? Difficult
8 week --

9 OLIVER: Right.

10 JOHN: -- for all involved. Let me, let me
11 ask you something else.

12 OLIVER: Go ahead.

13 JOHN: How come you have all those weapons in
14 there? And, and I'm just asking for your own opinion,
15 you know.

16 OLIVER: Well, we, you know, we, we know the
17 prophecies and we know, we know what God --

18 JOHN: Uh-huh.

19 OLIVER: -- God, we know what the dragon's
20 gonna do. We know.

21 JOHN: Um-hum.

22 OLIVER: So we, we, we were prepared for
23 that, you know.

24 JOHN: And the, the only reason I ask is that
25 I've never been in a, in a church or a religious
community before that, that had the volume of weapons

1 | that you obviously have in there.

2 | OLIVER: Um-hum.

3 | JOHN: And I understand the Constitution, and
4 | I, and I don't want you to, to think that I don't
5 | understand about the right to bear arms and that, that
6 | it's a right that we, we hold very dearly in this
7 | country.

8 | OLIVER: Um-hum.

9 | JOHN: But I've just never been in a
10 | religious setting that --

11 | OLIVER: You probably think we've abused that
12 | right, don't you?

13 | JOHN: Huh?

14 | OLIVER: You probably think we've abused that
15 | right.

16 | JOHN: Well, I'm not here to judge, you know.

17 | OLIVER: Okay. Well, that's good, I'm --

18 | JOHN: You, you've got different, you've got
19 | different branches of the government. You got the
20 | executive branch and the, the judicial branch and the
21 | legislative branch, and it's up to the judicial branch
22 | in our system to judge, not, not the executive branch
23 | from which I'm a member, you know.

24 | OLIVER: Um-hum.

25 | JOHN: All I, my only hope is that it's all
resolved peacefully. And I presume that's your hope.

1 OLIVER: Oh, for sure.

2 JOHN: You know, 'cause things have happened,
3 they've happened, right? And we, we can't turn that
4 clock around, can we? But we, but we can communicate,
5 we can talk, and hopefully everything will be resolved
6 successfully. And I believe it and I hope you believe
7 it.

8 OLIVER: Yeah.

9 JOHN: Well, that's great.

10 OLIVER: Something like that.

11 JOHN: Do you have some message that you want
12 me to --

13 OLIVER: To pass on to my parents?

14 JOHN: -- to pass on to your folks?

15 OLIVER: Tell them I love them.

16 JOHN: Okay.

17 OLIVER: That's about it, I guess.

18 JOHN: And you're all right?

19 OLIVER: I'm all right, I'm fine, I'm
20 healthy, I'm strong, you know.

21 JOHN: Okay, and your sister's doing okay
22 too?

23 OLIVER: I'm ready, I'm ready for any action
24 you guys give out. That, that's all I want --

25 JOHN: Well, I think you're kind of
preempting something, because I told Sherri and I told

1 | Graeme and I told Jean and, and everybody that I've
2 | talked to in there, that we're very patient people, and
3 | that --

4 | OLIVER: Oh, we are too. We won't, you know
5 | --

6 | JOHN: -- and that we have no intention and
7 | absolutely no intention to come into that facility.
8 | We, we are gonna stay out here and we're gonna wait
9 | till God gives David the word and when God gives --

10 | OLIVER: Well, but --

11 | JOHN: When God gives David the word that
12 | he's coming out, which I know he will, it's not if he
13 | will, I know he will, it's when he will --

14 | OLIVER: That's it.

15 | JOHN: -- and you all come out of there,
16 | everybody will be safe and sound. And if there are
17 | people that have been injured they'll be cared for.

18 | OLIVER: Oh, yeah.

19 | JOHN: And mothers will be able to get back
20 | with their children, and families will be reunited.
21 | And that's what it's all about, isn't it.

22 | OLIVER: That's it.

23 | JOHN: We're talking peace. We're not
24 | talking --

25 | OLIVER: Well, God talks about war a lot, you
know. And it's all throughout the Bible.

1 JOHN: Yeah.

2 OLIVER: We all hope for the best, I'm sure

3 --

4 JOHN: But, you know, you can be a pessimist,
5 you can be an optimist, can't you?

6 OLIVER: That is correct.

7 JOHN: Sure. The glass is half full, it's
8 half empty, but I'm hoping that it'll all be resolved
9 well. And I think David does and I think you do, don't
10 you?

11 OLIVER: Oh, yeah.

12 JOHN: We don't want to see people hurt,
13 people, people injured. Anything else you want me to
14 discuss with somebody for you?

15 OLIVER: No, I've said about everything I
16 want to say.

17 JOHN: Well, listen, you take care of
18 yourself, huh?

19 OLIVER: Same to you, buddy.

20 JOHN: Okay.

21 OLIVER: Okay.

22 JOHN: I'll see you when you come out.

23 OLIVER: All right.

24 JOHN: All right.

25 OLIVER: I'll see you too.

JOHN: Okay.

1 OLIVER: Okay. Bye.

2 JOHN: Bye-bye.

3 OLIVER: I think he got kind of tired of
4 talking.

5 * * * * *

6 OLIVER: Hello? Hello?

7 JOHN: Hello.

8 OLIVER: Yes.

9 JOHN: Who's this?

10 OLIVER: This is Oliver.

11 JOHN: Hey, you hung up on me, pal. Is, is
12 David still there, or is Steve there?

13 OLIVER: Sure, you want to speak to him?

14 JOHN: Either one.

15 OLIVER: Yeah. I'm sorry about that, I
16 didn't think you wanted to speak to anyone.

17 JOHN: Well, I'm not --

18 OLIVER: He's right here.

19 JOHN: I'm not ready to go to bed yet.

20 * * * * *

21 JOHN: Hey.

22 DAVID: I'm sorry. John?

23 JOHN: Yeah.

24 DAVID: Yeah, it was the phone again, they
25 moved it and stuff and --

JOHN: If you look at it it goes bonkers,

1 | huh?

2 | DAVID: It's, it's weird. It's the lines for
3 | some reason, I don't know what it is.

4 | JOHN: Yeah. How are you feeling?

5 | DAVID: Anyway --

6 | JOHN: How are you feeling?

7 | DAVID: What have you, what have you found
8 | out so far, talking with certain people?

9 | JOHN: You got some good folks in there, huh?

10 | DAVID: Well, I, I like to think that I've
11 | chosen the best around the world.

12 | JOHN: Well, I, I got a good lecture from
13 | Sherri. I, I know she was proud of herself.

14 | DAVID: Well, I don't, know, Sherri --

15 | JOHN: She's a, she's a good person.

16 | DAVID: Sherri's the kind of girl who'd do
17 | anything for a person.

18 | JOHN: She got kind of pumped up.

19 | DAVID: Well, now.

20 | JOHN: Huh?

21 | DAVID: Well, now.

22 | JOHN: Hey.

23 | DAVID: It's an eventful event these days,
24 | you know.

25 | JOHN: Yeah, I know, I know.

 DAVID: Little Ali --

1 JOHN: A lot of people, a lot of people are
2 under a lot of stress, huh?

3 DAVID: Little Ali, I have to --

4 JOHN: He's just a little guy?

5 DAVID: No, he's a pretty big guy, he's into
6 martial arts and all that.

7 JOHN: Yeah, uh-huh.

8 DAVID: He, he was wanting to jump out there
9 and whomp one of your ATF agents.

10 JOHN: Uh-huh.

11 DAVID: But he's, we have to keep him kind of
12 under control a bit, 'cause he's, he's got, holds a lot
13 of grudges, and we have to kind of watch him.

14 JOHN: Well, he sounded fine on the phone.

15 DAVID: He's --

16 JOHN: You know, and --

17 DAVID: He's the kind of character I have to
18 tell him, you know, exhibitioning that makes yourself
19 no better than the others. You know.

20 JOHN: How are you feeling?

21 DAVID: Oh, I feel pretty good.

22 JOHN: You getting around a little more?

23 DAVID: Well, you know, it's very, it's
24 minimal, you know. If I, if I walk say --

25 JOHN: Uh-huh.

DAVID: You know, if I walk say 30, 40 yards

1 | and walk back, it's like I ran a 100-yard dash. I
2 | mean, it's -- the old body, you know, it's, it's gone
3 | through a dramatic experience.

4 | JOHN: Yeah. I listened to kind of an
5 | interesting tape this evening. It was, I guess your
6 | call to 911 last Sunday.

7 | DAVID: Well, what does it say? Was it my
8 | call or was it, it was Steve's and Wayne, I guess.

9 | JOHN: I think it was, I think -- no, it was
10 | yours, because there was an early call from Wayne, and
11 | I listened to that one, and then, then there was your
12 | call on there.

13 | DAVID: Is that that guy named Lynch?

14 | JOHN: It could have been, yeah.

15 | DAVID: Yeah, Larry, Harry Lynch, something
16 | like that?

17 | JOHN: There were --

18 | DAVID: Yeah.

19 | JOHN: There were a couple of people. There
20 | was, Lynch answered the phone and then someone else was
21 | on the phone also.

22 | DAVID: Yeah.

23 | JOHN: And it sounded like just a terrible,
24 | terrible situation, huh?

25 | DAVID: Oh, it was.

 JOHN: Yeah.

1 DAVID: What can you do?

2 JOHN: But you sounded, you sounded pretty
3 healthy at that point.

4 DAVID: I wasn't shot yet.

5 JOHN: Oh, really?

6 DAVID: Really.

7 JOHN: God, I was wondering how in the world
8 somebody that had gone through what you had gone
9 through could sound that way.

10 DAVID: No, that was, they --

11 JOHN: That was early on?

12 DAVID: When that conversation was taking
13 place --

14 JOHN: Early on?

15 DAVID: Yeah. When Steve --

16 JOHN: Yeah.

17 DAVID: When Lynch was called -- when was it
18 I talked to him? (Unidentified male voice in
19 background not discernible.) Yeah, I remember talking
20 to, or you ran and gave the phone to me and I talked to
21 somebody real quick? (Unidentified male voice in
22 background not discernible.) Okay, and then that's
23 when I left. Then afterwards I got shot.

24 JOHN: Yeah, I heard that, and I said man,
25 how could, how could he have been shot. And in a lot
of excruciating pain, so it obviously happened first,

1 | huh?

2 | DAVID: Yeah. I would -- like I said, I'd
3 | show you some pictures, but you, you boneheads, you
4 | always, okay, sure we'll have some pictures. Now send
5 | out some kids.

6 | JOHN: Well, I'm waiting to see the pictures.
7 | You know that. I, I told you last night when you said
8 | you were gonna send them out that I'd welcome them.
9 | Send them on out. Listen, Steve said that -- excuse
10 | me. It's not the company. Steve said that you're
11 | going to have a, a service tomorrow between 10 and 11,
12 | huh?

13 | DAVID: No. The, the worship, the daily is
14 | between 8 and 9.

15 | JOHN: Pardon me?

16 | DAVID: Between 8 and 9 and 2 and 3. That's
17 | the daily.

18 | JOHN: Oh, no, I don't mean prayer. I mean a
19 | service outside.

20 | DAVID: Oh, right, the burial.

21 | JOHN: Yeah, yeah, between 10 and 11.

22 | DAVID: Yeah.

23 | JOHN: Yeah, okay. I just wanted to make
24 | sure everything was squared away, that there aren't any
25 | time changes. And, and you could do me a big favor if,
if one of you would call in the morning and, and talk

1 to somebody in here about, before you go out.

2 DAVID: You know, it really, it really blows
3 me away that you guys have such a rotten attitude on
4 this.

5 JOHN: I don't think we do.

6 DAVID: You know, if -- I wish I'd had some
7 hindsight and seen exactly how really --

8 JOHN: Some what?

9 DAVID: -- really cynical you guys really
10 are.

11 JOHN: Some what?

12 DAVID: It might have been my, in my, in my
13 -- I wish I had some hindsight, you know, to where I
14 could have actually seen, you know, how really cynical
15 you guys really are. You know, while you're, while
16 your wounded and dead are laying around here, you're so
17 interested and all that. And then, you know, while we
18 find, when we find our people, you know, then all of a
19 sudden you just don't give a damn.

20 JOHN: Well, we are, we do care and we told
21 you that --

22 DAVID: Oh, yeah, your conditions are very
23 stupid, too.

24 JOHN: -- how, how it could be worked out.
25 And hey, you've chosen it --

DAVID: It's gonna, it's gonna, it's gonna be

1 | worked out.

2 | JOHN: You, you've chosen to do something
3 | else and that's fine.

4 | DAVID: Like I say, you're gonna be, you're
5 | gonna be punished. You know, you're gonna be punished.
6 | Your reasoning, your controlled oratation (sic), you
7 | know, your discerment (Phonetic) unconcernment (sic)
8 | for the situation. You're a cold heart. You know,
9 | you're just a freezer, you know what I'm saying? Like
10 | I said, you know, you remind me of, like my dad, my
11 | stepdad. All talk, you know, like, it's like someone
12 | puts their quarter in a slot --

13 | JOHN: Hey, you didn't say he was such a --

14 | DAVID: -- you know, and you operate.

15 | JOHN: You didn't say he was such a bad guy,
16 | though.

17 | DAVID: Oh, I told you. I said we never
18 | really knew him.

19 | JOHN: Yeah.

20 | DAVID: Well?

21 | JOHN: Well, that doesn't mean he was bad,
22 | huh?

23 | DAVID: Oh, yeah he was bad. He was a
24 | gangster.

25 | JOHN: He finally, he finally came around,
 | didn't he?

1 DAVID: But, but one of your, but one of
2 your, one of your assistants, one of your assistants
3 let him go because you all liked each other.

4 JOHN: Let, let me ask you something. I want
5 to --

6 DAVID: That's what I was gonna teach you.

7 JOHN: I want to, I want to get some, some
8 details as to what you all intend to do, you know,
9 between 9 and 10 tomorrow with Peter, so, and, and
10 exactly where so I can let our, our folks know.

11 DAVID: Hey, they'll --

12 JOHN: You'll be right out across from the
13 flag pole there?

14 DAVID: Yeah, they'll know. They'll see us.

15 JOHN: Well, just, just don't, just don't go
16 indiscriminately wondering out some place, huh? Do you
17 understand what I'm saying?

18 DAVID: Yeah, I hear what you're saying.

19 JOHN: And, and somebody, we've got to have
20 communications and we got to maintain communications.

21 DAVID: I communicated with that. I told you
22 what I was gonna do.

23 JOHN: But I don't want any surprises
24 tomorrow, somebody come bouncing out of there. I want
25 somebody to communicate before it happens and if people
are going to carrying shovels, I want to know if people

1 | are carrying shovels.

2 | DAVID: So what are you gonna, what, are you
3 | gonna try to shoot somebody, is that what you're gonna
4 | do?

5 | JOHN: Of course not. Of course not. But we
6 | want to be reasonable and we want to be sensible about
7 | this, huh? Other, otherwise --

8 | DAVID: Hey, listen.

9 | JOHN: -- I wouldn't be talking to you, would
10 | I.

11 | DAVID: Listen. Listen. I wouldn't be
12 | talking to you if I wasn't trying to give you guys a
13 | half a chance. Bringing that many law enforcement
14 | agencies, three helicopters, two trucks with the
15 | gooseneck trailers loaded down with ATF agents is not
16 | very sensible in my book. And if it's in your book, I
17 | think you better throw your book away.

18 | JOHN: What, what's done is done, huh?

19 | DAVID: Yeah. And I think someone's gonna
20 | pay.

21 | JOHN: I can't turn that around. You can't
22 | turn it around.

23 | DAVID: Somebody's gonna -- oh, yeah, well,
24 | we'll see. Someone's gonna pay.

25 | JOHN: I can't turn it around and you can't
turn it around. You know, and all we can try to do is

1 | communicate and try to use some common sense, huh?

2 | DAVID: Common --

3 | JOHN: And try to --

4 | DAVID: Common sense?

5 | JOHN: -- try to work this thing out
6 | peacefully.

7 | DAVID: Common sense? No.

8 | JOHN: Yeah.

9 | DAVID: Boy, I think you need to get a
10 | dictionary and before you talk, you need to go and
11 | reference all the words you're fixing to use. Common
12 | sense.

13 | JOHN: Remember what apparently the --

14 | DAVID: Hey, where's the milk?

15 | JOHN: Huh?

16 | DAVID: Where's the milk?

17 | JOHN: What, what did we say?

18 | DAVID: What did we say before?

19 | JOHN: What did we say before when?

20 | DAVID: So, you're, you're gonna keep lying
21 | to us and like I say, it's gonna come down to the draw.

22 | JOHN: No, it isn't. It's all gonna work out
23 | fine. But remember, you agreed that no one was gonna
24 | exit the building with a weapon. And that there would
25 | be communications before anybody exited any buildings,
 | right? Just live up to that, huh?

1 DAVID: Yeah, we told you --

2 JOHN: I don't want anything to happen, you
3 don't want anything to happen either.

4 DAVID: Well, the news wants something to
5 happen. The news wants to see some firecrackers.

6 JOHN: Well, why do people go to the
7 Indianapolis 500?

8 DAVID: Why do they go see movies all the
9 time?

10 JOHN: Sure.

11 DAVID: Terminator and Destroyer and all that
12 kind of stuff. They like it. They dig it.

13 JOHN: Huh.

14 DAVID: This is the way, this is the way your
15 country is.

16 JOHN: What, what were you watching on the
17 tube tonight? Huh?

18 DAVID: What did you watch?

19 JOHN: No, I said what were you watching
20 tonight.

21 DAVID: Nothing, only --

22 JOHN: You --

23 DAVID: I only have, I don't have an antenna,
24 I only got one channel.

25 JOHN: You don't have an antenna?

DAVID: No.

1 JOHN: I thought you had a big dish over
2 there.

3 DAVID: It doesn't work. You all shot it up.

4 JOHN: No.

5 DAVID: You did.

6 JOHN: Not really. Huh?

7 DAVID: You did.

8 JOHN: You're kidding me.

9 DAVID: I told you that --

10 JOHN: You only have one channel?

11 DAVID: We got one TV.

12 JOHN: Well, you must have some videotapes
13 you can watch, huh?

14 DAVID: The VCR was shot up too. Now, we got
15 a VCR, but it's not hooked up to this TV.

16 JOHN: Uh-huh.

17 DAVID: They hooked it up to the other TV,
18 which doesn't have an antenna which was connected to
19 the satellite, and the T -- and the videotape you
20 brought, it was, it was blank.

21 JOHN: Well, hey, before, before anybody does
22 any moving around tomorrow, please give somebody a call
23 here, huh?

24 DAVID: Want a Bible study?

25 JOHN: I don't know if I'm ready for one
tonight. I may let you have a good night's sleep --

1 DAVID: Well, you --

2 JOHN: -- we get into a lot of -- I had a
3 Bible study talking to Sylvia.

4 DAVID: Sylvia?

5 JOHN: I don't mean Sylvia, Sherri.

6 DAVID: Sherri?

7 JOHN: Sherri. Boy, she was pumped up, huh?

8 DAVID: Oh, boy, she was a, she was a hard
9 person in the beginning, though.

10 JOHN: You're kidding.

11 DAVID: Oh, a lot of these people were.

12 JOHN: That's hard to believe.

13 DAVID: That's why I keep talking with you.

14 JOHN: She -- (Laughs.)

15 DAVID: Maybe, maybe you might see the light.

16 JOHN: She didn't say, she didn't seem to
17 think it was too difficult to grasp.

18 DAVID: Oh, in the beginning they were, you
19 know, they already had their beliefs and things like
20 that, and you know, yeah, they didn't mind hearing
21 about Jesus, but, you know, what, "What are you trying
22 to say?" they kept saying. "What's your point? What's
23 your point? What are you trying to say?" So you know,
24 I had to work real slow with them.

25 JOHN: Yeah.

DAVID: Most people don't realize there's a

1 | New Testament that revolves around Christ, the
2 | sanctuary and truth that's supposed to come in the
3 | latter days.

4 | JOHN: What, what do you think the intentions
5 | are tomorrow? You just gonna go across and have a
6 | little, a little service there?

7 | DAVID: Got to go dig --

8 | JOHN: Are you going to be able to make it?
9 | Are you going to be able to get across there?

10 | DAVID: No, I'm not going to be able to get
11 | across.

12 | JOHN: You're not? You don't feel that well,
13 | huh?

14 | DAVID: Well, I mean, that's a big, pretty
15 | big step there, you know, stepping off on the front
16 | there.

17 | JOHN: I don't know, I, you know, I haven't
18 | been there. I haven't seen it. I just don't know
19 | what's over there. All I've seen is a picture and, and
20 | I know that there's a building there and there's a flag
21 | pole and what, a walkway or something. Or no walkway?

22 | DAVID: No, there's a walkway in the front,
23 | yeah.

24 | JOHN: Yeah. And I, I didn't know how
25 | difficult it would be. And, but I understand that
Steve says they were just going to go across the road

1 | there and, from the flag pole and, and have their ser--
2 | burial service there. And I'm sure you'll have a
3 | service inside before, I guess, huh? That you can
4 | participate in.

5 | DAVID: Man, you guys are really funny.

6 | JOHN: Why? We're funny, yeah, I know. The
7 | five kids?

8 | DAVID: Yeah, I'm looking right at you right
9 | now.

10 | JOHN: I know. You think. How long do you
11 | think this is take tomorrow?

12 | DAVID: I don't know.

13 | JOHN: About an hour?

14 | DAVID: Oh, it may take an hour to dig the
15 | hole.

16 | JOHN: I mean, do you intend to send a couple
17 | of people out early to do that and then have the
18 | service afterwards?

19 | DAVID: Yeah, probably.

20 | JOHN: Okay.

21 | DAVID: Be sure and tell his mom and dad;
22 | though.

23 | JOHN: You bet. You bet. Does he have any
24 | relatives in there at all?

25 | DAVID: Yeah.

 JOHN: I mean, that are still inside there?

1 DAVID: Oh, yeah.

2 JOHN: Okay.

3 DAVID: Yeah, he's got, he's got about, let's
4 see, one, two, three, four, four relatives.

5 JOHN: Have anybody else that you have to
6 handle the same way?

7 DAVID: Nope.

8 JOHN: That's good. I'm glad to hear that,
9 because there was some concern that there was, you
10 know, and I'm glad to hear that you don't.

11 DAVID: Well, when you all said, when they
12 were saying we had 14 or 15 wounded, you all was asking
13 the kids, the kids were probably repeating what was
14 said about the ATF agents over the TV.

15 JOHN: It could be.

16 DAVID: Over the radio.

17 JOHN: It could be.

18 DAVID: So it blew me away, I thought man,
19 for kids that are so unstable that don't know anything,
20 boy, you all -- (Laughs.) Oh, boy.

21 JOHN: Hey, they're good kids. They've been
22 through a lot, though.

23 DAVID: Oh, we know they're good kids.

24 JOHN: Yeah.

25 DAVID: They're the best in the world.
They've had the best training.

1 JOHN: And they've been through a traumatic
2 experience, you know, and, and it was tough on all of
3 them, I'm sure, you know, as it was on, on the adults.
4 They don't expect to go through something like that
5 either, do they?

6 DAVID: Well, like Ali was telling you about
7 war all through the scriptures. Like, well, like I
8 say, you don't believe, why should I waste our time.

9 JOHN: I enjoy listening though, sometimes.
10 Just not into -- I don't like to get into a debate like
11 with Sherri. And then Sherri wanted to, she wanted to
12 get kind of offensive there. It's not my style.

13 DAVID: Where did you learn your, where did
14 -- did you go to Jesuit's College also?

15 JOHN: (Laughs.) Why? No, I didn't.

16 DAVID: You didn't.

17 JOHN: No. Where did you get your --

18 JOHN: I was Augustinian-trained.

19 JOHN: What's that?

20 DAVID: That's an order of priests.

21 JOHN: I see. How many other guys out there
22 of those, of those five kids, how many of them were
23 also Augustinian-trained?

24 JOHN: Well, I don't, I don't know what their
25 religious backgrounds are. I, I have no idea.

 DAVID: Oh, so, so most of them so far is

1 Catholic, the one I've talked to.

2 JOHN: Is that, is that a good trait or a bad
3 trait, huh?

4 DAVID: Well, it depends. Depends on how
5 much you know about it. If you don't know that much
6 about it, yeah, we can have grace. If you know a lot
7 about it, we're dead-set enemies, aren't we.

8 JOHN: Well, I don't think we are, are we.

9 DAVID: Yeah, I think so.

10 JOHN: I think we both want to resolve this
11 thing the same way, don't we.

12 DAVID: Well --

13 JOHN: Peacefully.

14 DAVID: Some say peace, and yet their hearts
15 are full of war, you know how the scriptures go.

16 JOHN: Well, you know how my heart is. I've
17 tried to explain it many times. I haven't, I haven't
18 talked in riddles and I haven't talked in, in any other
19 manner.

20 DAVID: Well, let's call it parables. You
21 know, Christ spake in parables so that the wicked, you
22 know, wouldn't understand him. Of course the simple,
23 the childlike, those who, that opens their heart and
24 mind, they understand what's being said. It's funny
25 how God does things like that. Catch the wicked in
their pride, bring down all their arrogancy and pride.

1 Final warnings, none heeded. Then executive judgement.

2 Got an investigative, judicial, --

3 JOHN: And a legislative.

4 DAVID: -- and an executive. Yeah, God's got
5 a system like that.

6 JOHN: He does, doesn't He?

7 DAVID: Yeah. He sends the truth into the
8 world. When you hear it, you investigate it. If you
9 don't, then you're being judged. And then all of a
10 sudden the penalties God pronounces the ungodly who
11 reject His truth will be executed.

12 JOHN: Yeah.

13 DAVID: And the rewards that God has
14 pronounced for the righteous who have listened will be
15 executed. Anyway, I guess I'll let you get some sleep.

16 JOHN: Let me ask you a couple, couple things
17 that we, that we kicked around earlier today, huh?

18 DAVID: Sure, go ahead.

19 JOHN: The, I -- first of all, I appreciate
20 your putting those people on the line with me, I really
21 do.

22 DAVID: Well, that's their right. That's
23 their God-given and American right.

24 JOHN: Well, I know some were probably
25 reluctant to do it and maybe you give them a little
prodding.

1 DAVID: Well, there's freedom -- well, I keep
2 telling them, I say, you know, there's nothing that's
3 gonna harm them.

4 JOHN: No.

5 DAVID: It's their freedom of speech.

6 JOHN: You sound tired.

7 DAVID: Oh, a little.

8 JOHN: You got a good night's sleep last
9 night.

10 DAVID: No, I didn't.

11 JOHN: How come?

12 DAVID: Remember I'm praying for you.

13 JOHN: (Laughs.) God, I guess you were up
14 all night, huh?

15 DAVID: All the time.

16 JOHN: But I, I want to thank you for, for
17 having those people talk to us, and --

18 DAVID: Got to also remember, I lost over
19 three pints of blood, too.

20 JOHN: Yeah, but you sure sounded --

21 DAVID: I'm a strong person --

22 JOHN: You sounded chipper two nights ago.

23 JOHN: Well, it comes and goes, it comes and
24 goes. Depends on what time you catch me.

25 JOHN: You really sounded good.

 DAVID: Well, I appreciate that.

1 JOHN: You know, you were, you were on a roll
2 and, and I really hope, you know, that you get some
3 rest and get some soup and other things in you.

4 DAVID: Got to build some blood back up.

5 JOHN: You bet. Build up your strength,
6 'cause I want to be there waiting for you when you come
7 walking out.

8 DAVID: Okey-doke.

9 JOHN: There's, there's a couple of people
10 that I didn't get to talk to, and --

11 DAVID: Which people is that?

12 JOHN: It was Wayne Martin's wife, I guess,
13 Sheila.

14 DAVID: Uh-huh.

15 JOHN: The Fatta's, Paul Fatta, Kalani Fatta.

16 DAVID: Uh-huh.

17 JOHN: And Perry Jones, who was Rachel's -- I
18 think she said her dad.

19 DAVID: Oh, boy, she's teed at you.

20 JOHN: Why?

21 DAVID: Why?

22 JOHN: I thought Rachel and I had a, had a
23 nice talk and that --

24 DAVID: You are --

25 JOHN: -- and we had a nice chat with the
kids.

1 DAVID: He's an older man.

2 JOHN: Uh-huh.

3 DAVID: Anyway, we'll work that out tomorrow.

4 JOHN: Let me ask you two things. Then we'll
5 call it a night, huh? Okay?

6 DAVID: Okay, two more things, go ahead.

7 JOHN: 'Cause you sure sound tired.

8 DAVID: Well, go ahead.

9 JOHN: How are we gonna resolve this thing?
10 That's one. What are you gonna tell me now? That's
11 one.

12 DAVID: I've already told you.

13 JOHN: When you get the word?

14 DAVID: When you get the word I'll come out.

15 JOHN: No, when you get the word, right?

16 DAVID: When I get the word --

17 JOHN: Uh-huh.

18 DAVID: -- I'll be out.

19 JOHN: You got any ideas how close we're
20 getting? Whether things are getting better or that
21 things aren't getting better.

22 DAVID: Well, I mean, sh-- the things are not
23 gonna get any better or any worse.

24 JOHN: Huh? Well, yeah, some things will get
25 better.

DAVID: (Laughs.)

1 JOHN: I hope.

2 DAVID: Oh, boy.

3 JOHN: I hope you get better, huh?

4 DAVID: Yeah, I want to get better.

5 JOHN: Just don't laugh too much, now, don't
6 sneeze, don't cough.

7 DAVID: Yeah, well, it's not, it's not --

8 JOHN: Don't look at, don't look at those
9 five kids.

10 DAVID: Oh, boy, that really -- I enjoyed
11 every, every pain when I laughed on that one.

12 JOHN: (Laughs.) I bet you did, huh? And,
13 and I, I was asked to ask you that at the press
14 conference tomorrow, you know, they have these daily
15 press conferences. Usually I'm sleeping, so I don't
16 get to see the press conferences. But I was asked as
17 to whether or not you wanted to be addressed as the
18 Lamb, as David, as Christ, or as the Lord.

19 DAVID: My name is David Koresh.

20 JOHN: Uh-huh.

21 DAVID: And that's what you need to call me
22 by.

23 JOHN: Okay.

24 DAVID: Because you don't know if I'm the
25 Lamb or Christ.

JOHN: Well, I know what you told me.

1 DAVID: Or the Lord. Well, it's like this.

2 JOHN: You told me, what, at least five
3 times.

4 DAVID: I showed you something and you were
5 looking at it.

6 JOHN: Uh-huh.

7 DAVID: But you refused to see. so I'm going
8 to show you something --

9 JOHN: Well, I'm trying.

10 DAVID: I'm going to show you something in
11 the future where you will not be able to deny.

12 JOHN: Okay.

13 DAVID: Okay?

14 JOHN: You would like to be continued to be
15 addressed as David.

16 DAVID: That's what people should know me as,
17 David Koresh.

18 JOHN: Okay.

19 DAVID: My name. It's my legal name.

20 JOHN: Listen, you have a good night's rest,
21 huh?

22 DAVID: Okey-doke.

23 JOHN: And take care of yourself. And maybe
24 in the morning, I can talk to Perry if he's not upset,
25 to Sheila, to Paul, and Kalani.

DAVID: Okey-doke.

1 JOHN: Okay.

2 DAVID: Lylatov.

3 JOHN: Shalom.

4 DAVID: Bye.

5 (A brief conversation ensued between
6 negotiator and another federal employee who called in
7 and was directed to use another telephone line.)

2 STEVE: Hello. Hello.

3 JOHN-2: Hello.

4 STEVE: Hello.

5 JOHN-2: Steve?

6 STEVE: Yeah.

7 JOHN-2: Good morning. This is John.

8 STEVE: Hello, John.

9 JOHN-2: How are you this morning?

10 STEVE: A little tired.

11 JOHN-2: A little tired?

12 STEVE: Um-hum.

13 JOHN-2: Well, it's another day. How are you

14 feeling?

15 STEVE: The same, tired.

16 JOHN-2: Tired? You just got up. How's

17 David doing?

18 STEVE: Everybody seems to be, the majority

19 of them that I can tell are all sleeping.

20 JOHN-2: All sleeping? How's, how's his

21 wounds doing?

22 STEVE: They seem to be doing okay from,

23 they're looking at him carefully of course, keeping an

24 eye on it, --

25 JOHN-2: Um-hum.

STEVE: -- and, seems to be okay, but, you

1 | know, it's something that I haven't seen before.

2 | JOHN-2: Yeah, no change in the color?

3 | STEVE: No, I guess not. Well, I don't think
4 | so anyway. I don't know that for sure.

5 | JOHN-2: We just, I know you're sleepy, and I
6 | know you don't know what's going on there. We just got
7 | a report from one of those guys around outside that
8 | they saw a weapon in, I guess as you're looking at the
9 | front door it would be on the construction side of the
10 | building, supposedly --

11 | STEVE: I wonder if that's the same report
12 | that they gave me about sometime early in the evening.
13 | It sounds like the same one.

14 | JOHN-2: It supposedly is a muzzle of a gun
15 | out of a window.

16 | STEVE: I don't see it. Someone on the
17 | construction side of the building or something, with
18 | what did they have or what?

19 | JOHN-2: It's a muzzle. It was described to
20 | me --

21 | STEVE: As a muzzle?

22 | JOHN-2: Muzzle of a weapon. Out of, you
23 | know on the construction side of the building?

24 | STEVE: I wonder if they were seeing things
25 | 'cause I went and checked, you know, everywhere and
everybody, in fact there was no truth to it.

1 JOHN-2: No truth to it? Everybody up there
2 is aware of the rules and the safety and all that
3 stuff, right?

4 STEVE: Well, you know, I don't know if, who
5 am I speaking to by the way?

6 JOHN-2: This is John. Yeah, I'm not the
7 John that's on the night shift.

8 STEVE: No, I realize that.

9 JOHN-2: This is John-2. New John.

10 STEVE: New John.

11 JOHN-2: New John, new day. So, would it be
12 possible, is there --

13 STEVE: -- is a new John.

14 JOHN-2: New John, right. Is there anybody
15 around there, Steve, that could take --

16 STEVE: A look?

17 JOHN-2: Take a look up there?

18 STEVE: Well right now there isn't, but let
19 me look around and see what I can get going --

20 JOHN-2: Okay, yeah, would you mind doing
21 that and give us a buzz back?

22 STEVE: John, let me --

23 JOHN-2: Let me give you a little idea of
24 where it is though, just so you have some kind of idea.

25 STEVE: John, tell 'em not to worry about it.
Who's ever out there in those bath tubs or whatever,

1 | tell 'em not to worry 'cause, you know, they're safe
2 | and after we left out all the wounded and all those
3 | that got hurt a week ago Sunday, I mean, that's our
4 | attitude and spirit.

5 | JOHN-2: Okay. I was just trying to, trying
6 | to give you, give you some better idea of it myself,
7 | but all I just know is that it's on the construction
8 | side, --

9 | STEVE: John.

10 | JOHN-2: Yeah.

11 | STEVE: You're a new guy --

12 | JOHN-2: I'm new.

13 | STEVE: I hope we can do things better now
14 | and, here's what it's like. I mean, here are these,
15 | okay, you've heard the tapes, I'm sure you've been
16 | briefed by all these guys before you, but just real
17 | quickly, just one thing here. Sunday night, we had an
18 | agreement with Jim. It was very plain and clear that
19 | three of these Bradley's would be coming to the
20 | perimeter of the property, but they would not come onto
21 | the property. It's never happened that way. They've
22 | been on the property, they've moved all over at night
23 | and at different times. They've run over the cemetery,
24 | the guard shacks, they've moved our motorcycles out of
25 | the back garage. They've put up sandpiles, they've
 | been into our automobiles. They've pointed .25

1 millimeter guns at us, -- continually, -- can you hear
2 me? John?

3 JOHN-2: Yes, I'm listening.

4 STEVE: Okay. They've pointed these guns at
5 us. In fact, there's once I looked out the window
6 myself just to see what kind of a day it was and I
7 happened to look down at one and it had a, some muzzle
8 pointed at me, and yesterday I get this report from
9 Dick about somebody with a muzzle pointed out a window.

10 JOHN-2: Okay, I just got another note on
11 that. Maybe I can clarify it for you.

12 STEVE: All right.

13 JOHN-2: It's not a window itself, but
14 apparently Steve, somebody's knocked a hole in the
15 outer stucco or outer frame and the weapon or the
16 muzzle is protruding through that hole in the, next to
17 the window. Like a porthole.

18 STEVE: Well, I don't know anything about it.
19 I, I would tell them not to worry about it because no
20 one's going to do anything without, --

21 JOHN-2: Yeah, well --

22 STEVE: -- some kind of --

23 JOHN-2: I know you're groggy. Is there any
24 chance you could get up and take a look at that
25 yourself and give me a buzz back?

STEVE: Why don't we, why don't we leave that

1 go right now because, unless, see, if you look into the
2 back, if you came over here right now or you were --

3 JOHN-2: No, they --

4 STEVE: If you were flying over in a
5 helicopter or something, you would notice that out by
6 the back garage or out in the front, there are .25
7 millimeter guns pointed at the building, and pointed at
8 people inside. If they want to turn --

9 JOHN-2: No, that's, that's not true now.
10 You can take a look out there and you won't see --

11 STEVE: Is that right?

12 JOHN-2: Yes, yeah, yeah. But do me a favor,
13 would you --?

14 STEVE: Okay, just, just a moment here.

15 JOHN-2: Okay, I appreciate it.

16 STEVE: I'm looking around here. I would
17 have to get up and go down there because there's nobody
18 even near me.

19 JOHN-2: Okay. That would be great. How
20 about doing that and giving us a buzz back. That's
21 actually a hole next to a window. Like a porthole.
22 Okay, on the construction side, on the north end.

23 STEVE: What level?

24 JOHN-2: What level? The upstairs. The top
25 uppermost level, level 2.

STEVE: Level 2.

1 JOHN-2: And it's a hole next to a window.
2 Not a window itself.
3 STEVE: Let me go take a look.
4 JOHN-2: Great. Thank you.
5 STEVE: Sure. Bye.
6 {gap}
7 STEVE: Hello.
8 JOHN-2: Steve?
9 STEVE: Yeah.
10 JOHN-2: John.
11 STEVE: Yeah.
12 JOHN-2: How's it going?
13 STEVE: Still tired.
14 JOHN-2: Okay. Did you check on that barrel?
15 STEVE: Yes, I did.
16 JOHN-2: Okay. And --
17 STEVE: There's nothing there.
18 JOHN-2: Nothing there?
19 STEVE: Somebody's got a very awesome
20 imagination out there.
21 JOHN-2: Okay. Hey --
22 STEVE: Two, that's two reports on the same
23 thing. A third report, how, okay, look, yesterday, it
24 was after four o'clock sometime, I got a call from Dick
25 and he was so extremely excited about someone wearing a
camouflage jacket and he said something about a

1 | balaclava, I never had heard of it before so I says,
2 | what are you talking about, slow down, don't get so
3 | excited. Come to find out some girl that had darker
4 | skin was looking out the window and apparently these
5 | guys were nervous, -- I'm wondering if these guys
6 | aren't seeing, maybe angels or something.

7 | JOHN-2: As far as you were mentioning that
8 | the Bradley's had guns on them and cannons, I wanted to
9 | make a, one thing that's probably somehow gotten
10 | distorted over the days. Those vehicles do not, do not
11 | have guns on them. If you'll take a look at them, they
12 | have like a socket where a gun could be mounted into
13 | the socket, however, there are no weapons on the
14 | Bradley's. In other words, you can mount a barrel into
15 | that socket, but as they stand now, they do not have a
16 | weapon on them. It's just a giant socket. So they're
17 | basically personnel carriers. But that socket is meant
18 | to carry a weapon, but at the present time, there is no
19 | weapon on it.

20 | STEVE: I must be going senile then, because
21 | I looked out the window and I saw --

22 | JOHN-2: Yeah, well, if you --

23 | STEVE: I saw a barrel pointed at me.

24 | JOHN-2: No, yeah, I tell you what. Not a
25 | scope, but just a regular old pair of binoculars will
do it. Just take a look at where that socket is on

1 | that turret, and you can look at it and there is no
2 | barrel in the socket.

3 | STEVE: But John, now, now think of the
4 | insanity of it all. When that happened Sunday, a week
5 | ago Sunday, --

6 | JOHN-2: It's been a week.

7 | STEVE: We were the first ones that made a
8 | phone call to whoever, a 911, the fir -- in fact, it
9 | was me on the phone, Wayne Martin and myself, --

10 | JOHN-2: I know that.

11 | STEVE: We were screaming as to what is going
12 | on here, I mean, people were being dropped and wounded.
13 | We had no idea from anybody. Anyway, in the process,
14 | it was us that said they could get the wounded and take
15 | off all -- So now, what do you think? Do you think
16 | we're going to sit up here and aggravate and point
17 | weapons at someone because we want to take lives and,
18 | -- Let's be real, okay?

19 | JOHN-2: Yeah. No, I, like I said --

20 | STEVE: So all these kind of reports, it's
21 | such foolishness. I mean, yesterday, two reports like,
22 | same thing, and there was nothing to it again. What is
23 | going on? Is this some kind of a new psychology or
24 | something?

25 | JOHN-2: No, no, no. It's not new
psychology.

1 STEVE: Okay, --

2 JOHN-2: But I just wanted, I wanted --

3 STEVE: -- if they're sitting in such thick,
4 thick armament and moving around, running over
5 cemeteries, guard shacks, moving -- tell them to worry
6 more about that. Say a word was given, and of course,
7 you guys are in control of that. You guys are the
8 commando's, so, --

9 JOHN-2: No, I'm not a commando.

10 STEVE: Look, you know, the truth of the
11 matter is, people are getting tired of that sort of
12 thing here. They really are. I'm talking to you
13 because you, okay, you're a new guy. I'm trying to be
14 decent with you, but it's not going to last long if
15 that kind of thing continues to be the program.

16 JOHN-2: Well, we just want to move on from
17 this point, you know? I think we --

18 STEVE: Well, no, no, no. You guys, it's
19 like you have no ears at all.

20 JOHN-2: I'm listening.

21 STEVE: You give, and you tell me that. You
22 give me the time to speak, but then you keep on
23 repeating the same statements. This was the way Dick
24 was. This is the way the majority have been.

25 JOHN-2: No, I think --

STEVE: It's like that there's no ears to

1 | hear.

2 | JOHN-2: Well, I think Jim, Jim listened real
3 | carefully to you and that's, we want to move on from
4 | wherever the points that were left off with were good
5 | things --

6 | STEVE: What time do you have there John?

7 | JOHN-2: I've got 7:26.

8 | STEVE: It's a little bit early for me yet
9 | because a lot of us, we, there's, the majority of us
10 | stay awake and watch and look through the night than at
11 | any other times, so --

12 | JOHN-2: What's David doing?

13 | STEVE: He's sleeping.

14 | JOHN-2: He's sleeping now?

15 | STEVE: Exactly.

16 | JOHN-2: Okay. When do you expect him --

17 | STEVE: Try me at 9:00 or thereabouts.

18 | JOHN-2: I'll talk to you a little later.

19 | STEVE: Okay.

20 | JOHN-2: Bye-bye.

21 | STEVE: Bye.

22 | [gap]

23 | STEVE: Hello.

24 | JOHN-2: Steve?

25 | STEVE: Yes.

 JOHN-2: Are you awake?

1 STEVE: Who am I speaking with?

2 JOHN-2: John again.

3 STEVE: What's up?

4 JOHN-2: Yeah, okay. Here's, here's what I'd
5 like to talk to you about. The people outside are
6 seeing what they believe to be a fifty -- 5-0 --
7 caliber barrel from that hole, and the barrel is facing
8 back to the rear of the house from the hole on the
9 northside, on the construction side there.

10 STEVE: Believe me they're seeing things. I,
11 I checked it out. It's not so.

12 JOHN-2: Okay, what, what they're saying to
13 us is that --

14 BACKGROUND VOICE: -- pointing to the
15 northeast. Whatever it is --

16 JOHN-2: Pointing to the northeast, so --

17 BACKGROUND VOICE: It has to be moved.

18 STEVE: Pointing to the --

19 JOHN-2: To the northeast from a hole in the
20 wall.

21 STEVE: I went up there and looked around and
22 I, there was no such thing.

23 JOHN-2: Okay. Did you see that hole in the
24 wall?

25 STEVE: No, I didn't.

JOHN-2: Okay, what is, what's sticking out

1 | then?

2 | STEVE: Nothing. From what I was told, you
3 | told me at the end of the building, I looked around
4 | there --

5 | JOHN-2: You personally looked around
6 | yourself?

7 | STEVE: Yes, I did.

8 | JOHN-2: Yeah, and --

9 | STEVE: And then I asked another person to
10 | check just to make sure.

11 | JOHN-2: And you didn't see anything sticking
12 | out?

13 | STEVE: Nothing at all. I mean, literally
14 | nothing.

15 | JOHN-2: Okay. We've, -- did you see that
16 | hole, that hole in the wall itself?

17 | STEVE: No, I did not. I saw no hole.

18 | JOHN-2: Okay, do you know the window in the,
19 | let's see, it's overlooking the construction site, it
20 | --

21 | STEVE: So, you're saying it's the end of the
22 | building. Not at the front or the back, but it's at
23 | the very --

24 | JOHN-2: Okay, it's the very, very north end
25 | of the building. So if you were facing the front door,
 | it would be at the extreme left side of the building.

1 | Okay, so if you were actually in the window or looking
2 | out of that hole, you would be looking at that new
3 | construction area.

4 | STEVE: So, okay, --

5 | JOHN-2: Kind of at the pit there.

6 | STEVE: I'll go try to check it out one more
7 | time.

8 | JOHN-2: Thank you very much. Thank you. I
9 | appreciate it very much.

10 | STEVE: Okay, bye.

11 | [gap]

12 | STEVE: Hello.

13 | JOHN-2: Steve?

14 | STEVE: Um-hum.

15 | JOHN-2: John, how are you doing?

16 | STEVE: The same.

17 | JOHN-2: Okay, you took a walk up there?

18 | STEVE: Yeah.

19 | JOHN-2: And what did you see?

20 | STEVE: There was absolutely nothing.

21 | JOHN-2: Okay, what we understand --

22 | STEVE: What's up then?

23 | JOHN-2: Okay, what we understand from the
24 | guys are out front, is that it's a barrel. Apparently
25 | there's some, apparently they can see in the sunlight
 | there, a barrel of a .50 caliber weapon coming out of a

1 hole in the siding, and it's near the window but not
2 the window itself. And it would be over the
3 construction, it would be the last window as if you're
4 --

5 STEVE: Unless, unless they're talking about,
6 say, are they're talking about the metal water tower by
7 chance?

8 JOHN-2: No, no, no. It's the other, it's on
9 the, where the water tower is, if you were at the water
10 tower, it would be to the right and it would be all the
11 way over. In other words, if you were looking from the
12 water tower, it would be the window that was furthest
13 to the right on the upper level.

14 STEVE: There's nothing there.

15 JOHN-2: You physically went up there?

16 STEVE: Yes. There's nothing there.

17 JOHN-2: What, okay, what my guy, the guy
18 outside there, this is being relayed of course, you
19 know, by not, not the person directly, obviously, but
20 what they're saying is that there's a hole to -- if
21 you're looking at the window -- a hole to the left of
22 the window, that's where the barrel of a .50 caliber
23 weapon is sticking out of.

24 STEVE: Okay, the truth of the matter is,
25 there is no such thing.

 JOHN-2: There's no .50 caliber?

1 STEVE: There's no such thing as a .50
2 caliber or even a broomstick sticking out anything out
3 of that wall.

4 JOHN-2: Okay, and you personally --

5 STEVE: And when it comes to holes, yeah,
6 there are holes in the walls of this building, but that
7 was made by the ATF agents, of course.

8 JOHN-2: Okay, and there's no, there's
9 nothing sticking out?

10 STEVE: And if they feel safe, you know, if
11 they don't believe me, well, of course, they can always
12 back off and get off the property as originally was
13 agreed.

14 JOHN-2: Well, once again, on the --

15 STEVE: What do you think of that, John?

16 JOHN-2: If, if I were, if it were me I'd
17 say, hey, let's you and I talk and get everybody out
18 today. Those things will be off the property and there
19 would be --

20 STEVE: You guys, you know what? I hate to
21 tell you but you sound almost identical to the five
22 guys before you. I'm starting to wonder if there's not
23 a factory that stamps out these people.

24 JOHN-2: (laughs) I don't know. Yeah,
25 that's maybe a good idea. That's, or a bad idea.

STEVE: When you go back, listen, when you go

1 back and you listen to all these tapes, listen to how
2 much alike you guys sound. If, that would bother me to
3 some small degree at least.

4 JOHN-2: Well, you know, part of the problem
5 is that, the problem, the same problem remains, and I
6 guess you and I probably talk about the problem a lot.

7 STEVE: Well is that, is it the problem that
8 we're inside this building as we were two weeks ago? A
9 month ago? A year ago? Is that the problem?

10 JOHN-2: No, that's not a problem. That's
11 not, it's not a problem to be in a building. That's --

12 STEVE: In here, studying the bible, doing --

13 JOHN-2: Okay, excuse me --

14 STEVE: -- the things that we would normally
15 do that are not out of the ordinary.

16 JOHN-2: Steve, let me just interrupt you for
17 a minute.

18 STEVE: Yeah, please do.

19 JOHN-2: Okay, somebody just passed me a note
20 and as of the moment we're speaking right this instant,
21 that barrel is protruding from that hole by the window.

22 STEVE: Maybe God's point, maybe God's
23 pointing a barrel at somebody out there because I'll
24 tell you something, I, no physical eyesight, my
25 eyesight's 20/20 at least, and there is no such thing.

JOHN-2: You were physically up in that room?

1 STEVE: There is no such thing there. It was
2 checked and double checked.

3 JOHN-2: Okay, well, if you say it's not
4 there, and they say it's there.

5 STEVE: Believe me, it's not there.

6 JOHN-2: Okay, what's, what's --

7 STEVE: How long have they been doing this
8 thing? Is this the same thing that was supposedly seen
9 yesterday when Jim called?

10 JOHN-2: No, Steve, no, that's a different
11 thing.

12 STEVE: What about this woman looking out the
13 window also with a balaclava and camouflage? What was
14 that about?

15 JOHN-2: I don't know what happened on that.
16 All I --

17 STEVE: Well take a look at the report
18 'cause, there's no question you keep them, I know you
19 do.

20 JOHN-2: Oh, of course, of course. A
21 balaclava, I used to race cars, a balaclava is a thing
22 you put over your head and your face to protect you
23 from flames and stuff if you have an accident, so.

24 STEVE: I see. I didn't even know what it
25 was.

JOHN-2: Yeah.

1 STEVE: They said something about something
2 black or a mask or something. I didn't know what he
3 was talking about.

4 JOHN-2: Yeah, kind of like a ski mask thing,
5 you know.

6 STEVE: Dick was so excited about that. You
7 wouldn't have believed.

8 JOHN-2: Um-hum.

9 STEVE: It makes you wonder what the motive
10 is or what the psychology is involved with all this.

11 JOHN-2: Is David still asleep?

12 STEVE: Yeah, he is.

13 JOHN-2: You know, you know --

14 STEVE: That's why I told you 9:00, you know,
15 I mean, I could have, I suppose I could tell you all
16 sorts of different times, but no, 9:00 would be more
17 than likely a time that you might be able to converse
18 with him.

19 JOHN-2: Okay. What's, what's going on in
20 there?

21 STEVE: The usual, I guess.

22 JOHN-2: Okay.

23 STEVE: Some are sleeping, some are up.

24 JOHN-2: What's, when is the plans for the
25 burial service today?

 STEVE: I'm not certain yet because it was

1 | just decided last night that they would go and bury the
2 | person.

3 | JOHN-2: Okay.

4 | STEVE: And they mentioned sometime late
5 | morning, like, 10:00, 11:00, 12:00, somewhere in there.

6 | JOHN-2: In the 10:00 to 12:00 range?

7 | STEVE: Yeah.

8 | JOHN-2: Okay, all right.

9 | STEVE: And it would be clearly seen. The
10 | guys will go out there and, probably right out front,
11 | dig a whole and bury the person.

12 | JOHN-2: Right, pretty much in front of the
13 | front door?

14 | STEVE: Um-hum.

15 | JOHN-2: Okay.

16 | STEVE: Or in front of the fence probably.

17 | JOHN-2: Right by the fence?

18 | STEVE: Yeah, well, there's, right near the
19 | fence there's kind of a road with some gravel, so it
20 | would probably be in front of that which is dirt.

21 | JOHN-2: Okay, kind of between -- the road
22 | like, where the, beyond where the vehicles are parked?

23 | STEVE: Exactly.

24 | JOHN-2: Okay. Over in the grassy part, or?

25 | STEVE: Right, exactly.

 JOHN-2: Okay. There's like a trailer parked

1 | there or a white vehicle?

2 | STEVE: There's, let's see, I believe you

3 | people left --

4 | JOHN-2: Not me, not me.

5 | STEVE: Well, okay, the ATF, they left a red

6 | truck and a white, I think it is -- what, some kind of

7 | a trailer.

8 | JOHN-2: Like a trailer attached to it,

9 | right. I can see it.

10 | STEVE: So that's there's. And I believe

11 | there's a white van of ours.

12 | JOHN-2: Yeah.

13 | STEVE: Of the people that were here.

14 | JOHN-2: Um-hum.

15 | STEVE: Somewhere beside that I would

16 | imagine.

17 | JOHN-2: Beside the white van?

18 | STEVE: Um-hum.

19 | JOHN-2: Okay. Right in that grassy area?

20 | STEVE: Exactly.

21 | JOHN-2: Okay. Do you know, you're gonna

22 | have, two, three, out there doing it?

23 | STEVE: That sounds about right.

24 | JOHN-2: And then looking some time in that

25 | 10:00 to 12:00 range?

 STEVE: Um-hum.

1 JOHN-2: Okay. And what, David gonna decide
2 who's going to do that when he gets up or who the
3 gentlemen are that's gonna --

4 STEVE: Well, we'll get it together.

5 JOHN-2: Okay. Are you gonna come out
6 yourself and pay respects?

7 STEVE: Probably, probably not.

8 JOHN-2: No? Okay. Okay, I'll be back in
9 touch with you and just try to get a, get some new life
10 into, you know, you and I and David and moving ahead
11 and moving off the stalemate. Let's see if we can re-
12 institute the things that Jim had going and hopefully
13 we'll get this resolved safely.

14 STEVE: Okay.

15 JOHN-2: Okay.

16 STEVE: Sound good.

17 JOHN-2: Talk to you, Steve.

18 STEVE: Okay, bye.

19 [gap]

20 JOHN-2: Is David there?

21 STEVE: He's still not around. I just called
22 for him about two minutes ago.

23 JOHN-2: Is he still sleeping, or?

24 STEVE: Yeah, he is.

25 JOHN-2: Okay. Is there any chance you could
wake him up? There's a couple of things --

1 STEVE: Well, I just tried to. That's what
2 I'm saying. I just, about two or three minutes ago I
3 called him fairly loud and he's not moved so I guess
4 I'll just give him a little bit yet.

5 JOHN-2: He's not moving? He's got to be
6 out.

7 STEVE: Right. Yeah.

8 JOHN-2: Were there any more plans on the
9 service?

10 STEVE: Any plans on the which?

11 JOHN-2: Service? The burial service?

12 STEVE: I haven't been able to talk to him
13 about it yet and that's what I wanted to do.

14 JOHN-2: Okay. Do you know if the infant was
15 going to be buried also today?

16 STEVE: I don't know. I'll try to find out
17 about that.

18 JOHN-2: All right. Are you going to wake
19 him up then shortly?

20 STEVE: I'm going to give him a call in about
21 another half hour or so.

22 JOHN-2: Okay.

23 STEVE: I'll tell you what I'll do. I'll
24 call you as soon as he wakes up.

25 JOHN-2: I would appreciate that. We'd
really like to talk to David about the funeral

1 services.

2 STEVE: I realize that.

3 JOHN-2: Yeah, as you can understand.

4 That's, that's a significant event and I think we
5 should just talk about that and try to understand it,
6 you know?

7 STEVE: Okay.

8 JOHN-2: So that, that's really all we're
9 looking to do.

10 STEVE: All right.

11 JOHN-2: Okay. How, hopefully by 9:20 maybe?

12 STEVE: Well, I don't know. I don't know,
13 you know, I'm just gonna keep on try -- keep an eye on
14 him and I'll call to him every now and then and see if

4 decide with David how it's going to go?

5 STEVE: Um-hum.

6 JOHN-2: And you'll call me before anybody
7 comes out or anything like? David and I will hopefully
8 discuss all those arrangements.

9 STEVE: I'll give you a call.

10 JOHN-2: Oh, okay, thank you very much.

11 STEVE: Sure, bye.
