Do you think the 16 government is going to look worse by charging 40 women, 17 pregnant -- some of them pregnant at this --18 DAVID: Now, here's, here's Easter right here 19 now, right. They were booked, they were 10 booked by the FBI --11 KORESH: No, we're not talking about Rodney. 12 We're talking about the ATF agents that came out here. 13 No, they went, they went right back around and went out 14 and raided our Laverne house. The same way and same 15 manner. 16 The ones who JOHN DOLAN: No, no, no. 17 participated in the raid out here have all been removed 18 from, not only the area, but from the case. Totally. 19 That is standard, standard procedure. 20 So, they're in jail now? KORESH: 21 No, no, no. I'm just saying --JOHN DOLAN: 22 I didn't think so. KORESH: 23 JOHN DOLAN: -- they're removed from the 24 case, they're under investigation for the case. You 25

can't expect that many people -- in fact, even all your

witnesses, to be interviewed that quickly. The results of the interview have to be typed up, they have to go to the U.S. Attorney's Office and they have to be presented to a Grand Jury.

KORESH: Oh, John.

JOHN DOLAN: And -- no. And if you're talking about a possible indictment, that's extremely possible. You know. I'm not kidding you. I mean, this country's enraged over what happened. You, you know? JOHN DOLAN: That's what I mean. Yeah. Same thing. But we've got to get, we've got to get that treated for her and as far as personal safety, it's really not an issue at all.

KORESH: What's she want to do, Rach? Okay, she wants to, she wants to have Steve take close-ups on it in the tape and get a doctor, because I mean she, you know, she's, she's not that strong of a girl anyway, you know.

choice, but I, I'm telling you as we sit here, I can have her in the emergency room with the best doctors around here treating that in 25 minutes, before she loses the finger or the hand. So let's not have that happen to her, you know what I mean? How are you today? 4 RACHEL: Fine. 5 JOHN DOLAN: I didn't get much chance to talk 6 to you. 7 RACHEL: No. I haven't talked to you at all. 8 JOHN DOLAN: No? I'm concerned about Judy's 9 finger and --10 RACHEL: It looks really bad. 11 JOHN DOLAN: Well, you know --RACHEL: It, it's really sad. At the --12 below the knuckle? Not so much the tip of the finger, 13 14 but below the knuckle -- I mean below the -- is that 15 right? Not the knuckle, below the bend of the finger, 16 the middle of the finger it's really sad and it's 17 looks --18 JOHN DOLAN: The, the bone needs to be set, 19 the bone needs to be set. It may need a pin. I'm not 20 a doctor, but you know, we, we've all been -- read articles on what happens and she's going to need some 21 massive amounts of antibiotics. Otherwise she may lose 22 the finger and she may lose -- I hate to say this, but 23 she may lose her hand and her life. I, I talked to her 24 and I think that you and I and David need to give her a 25 little push to get that treatment needed, because --

RACHEL: Well, can you send a physician in 1 2 here for her? 3 JOHN DOLAN: I don't think I can get a physician to go in there, to be honest with you, but I 4 can have her in the, in the emergency room in 20 to 25 5 6 minutes from the front door. We will run, as we say in 7 the business, we will run Code 3, we will have her in 8 the emergency room in 20 minutes and, and hopefully we'll be able to save her life and her hand and 9 certainly her finger. 10 RACHEL: Well, that, that's up to her. I 11 mean, if you talk to her I don't know what she --12 13 JOHN DOLAN: I know. I know, but sometimes, you know, sometimes people -- I know people who hate 14 doctors and they just -- they need a little bit of push 15 for their own good. Give her a little push, would you? 17 RACHEL: Um-hum. Yeah. JOHN DOLAN: Seriously, you, you and I both 18 know what's going to happen. 19 20 RACHEL: I bet there's someone out there that would come in here to help her. 21 22 JOHN DOLAN: I don't think so. It's a 23 situation where that's not going to happen. RACHEL: I think if you found someone that 24 wanted to, you guys wouldn't let them come in. 25

what I think.

JOHN DOLAN: Well, it's a question of safety, 1 2 you know, and let's just --3 RACHEL: What I'm saying, if there was honestly someone out there who was willing -- a 4 physician who was willing to come in here and help her, 5 you guys would not let them. I don't think you would. 6 7 JOHN DOLAN: Well, let's just say that a physician did go in and, and something happened to him 8 9 and that he were hurt that, you know, there'd be a huge question of, of who caused him to get hurt and huge 10 liability issue and all kinds of that. And you know --11 12 RACHEL: Well, we're not going to hurt 13 anybody. That's for sure. 14 JOHN DOLAN: Well, I'm not saying you are, you know? I'm not saying you are, nor am I implying 15 you are. It's just that you got to look at it on the 16 17 other side of, of the guy --18 RACHEL: Yeah. 19 JOHN DOLAN: -- who's being recruited to go in, you know. And hey, you know, she -- I don't know 20 21 -- she --22 RACHEL: If there was a physician out there that wanted to come in, would you let them? 23 24 JOHN DOLAN: Well, these commanders are going to have real problems with it because of the 25 safety/liability issue. In other words, they're going

to have to vouch for somebody's life before they go in 1 and that's really a tough call to make. Do you know 2 what I mean. 3 Can't the physician sign something RACHEL: 4 5 that says they take full responsibility or what -- of themself. 6 JOHN DOLAN: Full responsibility -- no, 7 legally they can't do that, because they're entering a 8 -- well, it's referred to as a crisis site, you know 9 what I mean? So, no. That's a difficult situation. 10 That's not -- to give you the bottom line and without, 11 without dancing around the point, the -- I guess the 12 bottom line is just simply and plainly no. 13 Without, without giving you a big 14 15 explanation, because you know, I just don't -- I'm not going to, going to try to mislead you or try to dance 16 around the point. And if I said something that might 17 indicate that he would, I would not be truthful with 18 you and I'm not going to do that. So, the point is 19 that the bottom line of that is that he's not going to 20 go in there. 21 For whether it's liability or civil 22 liability, but, but he's not just going to go in.

23 liability, but, but he's not just going to go in. Bu
24 you know, I -- if you can make her -- tell her that
25 she's going to feel safe. We're going to treat -we're going to have a physician treat her wounds.

We're going to have a physician care for her. She will get the very, very best medical care possible.

RACHEL: Oh, I'm sure she doesn't doubt that.

JOHN DOLAN: No. I mean -- so that's going to be done and, and she's going to be in the hospital in a very short time. So if you could exert on a little friendship with her and a little support, be a support to her, maybe we can save her hand. And if she's got blood poisoning then, you know, they can do it if they get it early. They can save her.

But let's not lose anybody else over this, please, please, please. It's just been too much loss of, of life. Of young life. Of children and, and people in the prime of life. Let's not lose another person at all in any way, whether it's their hand or their fingers. Let's, let's keep everybody in tact, both spiritually, emotionally, and physically. So, if you could just exert a little pressure onto her, here's what'll happen.

We'll simply put her in that armored vehicle. We'll run it down the road where it hooks up with an ambulance, we'll put her -- transfer her to the ambulance and transport her in the ambulance all the way directly to the emergency room, nonstop. We'll have her in the emergency room in 20 to 25 minutes.

RACHEL: Um-hum. And then what happens?

1	JOHN DOLAN: She's going to be treated by the
2	best physicians in the hospital and in fact, I'll tell
3	you what else we'll do. We will call the emergency
4	room, we will call the emergency room and tell them the
5	extent of the injuries. If she knows her blood type,
6	we will notify the hospital of her blood type in the
7	case that she needs a transfusion. We will tell him
8	the type of wound, and have him have the E.R.,
9	emergency room, standing by with all the medical
10	equipment that's necessary. She will be treated the
11	minute she walks in. And nello?
12	RACHEL: Yeah, I'm here.
13	JOHN DOLAN: It's Rachel, if you want, we
14	can even have the sheriff standing by there to
15	guarantee all these things happen.
16	RACHEL: Well, I don't doubt that you would
17	take her to the hospital.
18	JOHN DOLAN: Oh. I mean, there's no
19	question.
20	RACHEL: No, I
21	JOHN DOLAN: There's just no question.
22	RACHEL: I don't doubt that at all.
23	JOHN DOLAN: Okay. So, let's get it done.
24	RACHEL: And then what happens after that?
25	JOHN DOLAN: I don't know, but let's, let's
	1

take the first step.

RACHEL: You, you don't know. 1 2 JOHN DOLAN: Okay. I -- I'll tell you. Okay. Let's take the worst case scenario. Okay? 3 Let's take the worst case scenario, she's charged as a material witness. We take her fingerprints, we take 5 her photograph. Both of which are totally painless. 6 Okay. And she's going to -- it'll save her life, it'll 7 save her hand. 8 Then she'll be charged, I mean, she'll be 9 asked -- she will be a material witness, in which case 10 she's going to be remanded before a Magistrate. The 11 Magistrate will set bond. She'll, she'll make bond and 12 she'll be out on bond. She'll make her appearances. 13 At the end of the court case, her bond will be returned 14 to her. She has to post ten percent --15 RACHEL: How do you, how do you know -- what 16 determines if you're a material witness or something 17 else or not or whatever? 18 JOHN DOLAN: Well, I don't think at this 19 point there's sufficient --20 RACHEL: I'm just curious. 21 I don't think at this JOHN DOLAN: Yeah. 22 point in time there's going to be sufficient evidence 23 to charge her. Being struck by a bullet doesn't mean 24 that you, personally, were doing anything wrong, as you 25 know. Fully.

RACHEL: Yeah. 1 2 JOHN DOLAN: So I don't know that there's any 3 evidence to charge her with a specific crime. In which case she --4 5 RACHEL: And what, what --6 JOHN DOLAN: In which case she's only a material witness. 7 RACHEL: Um-hum. 8 9 JOHN DOLAN: And that's the, you know, that's 10 the worst case scenario. RACHEL: So if the, if the -- I know this 11 doesn't really have much to do with her, you know, her 12 injury or whatever, but I'm just talk -- speaking to 13 you out of my curiosity. So, if a person is held for a 14 15 material witness, they could be held up to a year. I heard on the radio that the court case might not be for 16 a whole year. So that means they're in jail for a 17 18 whole year? JOHN DOLAN: No! Absolutely not! Absolutely 19 20 not! This is -- no. This is America. You post bond. Everybody's entitled to a bond. You --21 RACHEL: Well, where's Catherine and Margaret 22 then? 23 JOHN DOLAN: They're out on bond. They've 24

been released. They're totally out. They are out on

25

bond --

RACHEL: Oh, I haven't heard that. 1 2 JOHN DOLAN: I can find out the bond for you. And I can --3 RACHEL: Well, who got them out? 4 5 JOHN DOLAN: Somebody posted bond. I don't know what the bond is. We'll try to find out. 6 7 they are out. In fact, there's somebody who was downtown and just shook their head to me confirming it, 8 which I had checked before, whether that was --9 RACHEL: Well, they don't have any family in 10 11 this town, so I don't know who would get them out, 12 unless it's just people that feel sorry for them. JOHN DOLAN: Okay. The attorney can post 13 bond for them. The way it works in the federal 14 15 system --Uh-huh. RACHEL: 16 JOHN DOLAN: -- is you -- it could be an OR 17 bond, which is own recognizance, just to guarantee your 18 19 appearances. If it's a cash bond, you post ten percent of the cash bond. 20 21 RACHEL: Um-hum. JOHN DOLAN: And once you make your 22 appearances, they return the bond to you, they return 23 the cash to you. From what I understand -- I was just 24 25 handed a note, a Mr. Coker, C-O-K-E-R --RACHEL: Okay, I understand.

JOHN DOLAN: -- is their attorney and he could also be, I'm sure, the attorney for Judy, for everybody, you know. So let's, let's, you know, let's get this done.

RACHEL: Um-hum.

JOHN DOLAN: So --

RACHEL: So they're just somewhere in town then, huh?

JOHN DOLAN: Yeah -- they're free on a bond. They, they've given their address to the court records, to the Clerk of the Court is the person required to get their address as well as the U.S. Magistrate's Office, same thing, and they're on their way. So we can do the same thing with her, but, but you know, (a) we can't let her lose her life or her hand or her arm over a fear of, of me. You know, that's not worth it. It's just not worth it.

Something's going to happen for life. This whole thing, legally, is going to be over in, you know, probably by the end of the year. So, it's not a quest -- it's not worth losing your arm or your life or your hand, you know, over worrying about posting bond. You know, it's just not worth it. There's no comparison. If you put this on the scales, you know, one side losing your life, losing your arm, losing your hand is going to be on one side. It's not even going to come

close to matching, you know -- being a little bit 1 2 afraid of coming out. 3 RACHEL: Not to have a change of subject 4 here --5 JOHN DOLAN: Yeah. 6 RACHEL: -- because she's still, you know, 7 down there with the -- Steve making the tape or whatever. 8 9 JOHN DOLAN: Okay. Would you, would you do 10 me a favor personally? 11 RACHEL: What's that? 12 JOHN DOLAN: Would you ta -- and this isn't 13 for me, this is for her. Would you talk to her and try 14 to help her and help me to get --RACHEL: I'll tell her what you said. 15 16 JOHN DOLAN: Okay. Would you do that? 17 RACHEL: Yeah. 18 JOHN DOLAN: Maybe she -- is she concerned 19 about the medical treatment, that she's not going to 20 get it or is she concerned about she's going to be hurt 21 coming out or --22 RACHEL: Actually, to tell you the truth, I haven't talked to her about it. 23 24 JOHN DOLAN: Okay 25 RACHEL: But, you know, I'll talk to her after, you know -- a little bit later I'll talk to her

about what you told me. 2 JOHN DOLAN: Okay. RACHEL: That she could lose her finger or 3 her hand, for that matter. 4 5 JOHN DOLAN: She can. I mean, it could be even worse. You know, gangrene is -- we're talking 6 7 amputation. 8 RACHEL: Um-hum. 9 JOHN DOLAN: I mean, so it's, it's superserious and every second counts and every minute counts 10 11 and if it's in the blood, then --12 RACHEL: What, what could they do for her 13 besides -- do they just give her antibiotics or --JOHN DOLAN: No, they're going to have to 14 15 look at it --16 RACHEL: -- they have to reset the bone --17 JOHN DOLAN: Okay. It sounds, it sounds to me, and I'm not a professional physician by any stretch of the imagination, they're going to have to, to x-ray 19 20 it. 21 RACHEL: Yeah. JOHN DOLAN: They're going to have to take 22 some x-rays. They may have to rebuild some of the 23 They may have to put pins in the bone. They may have to get the infection out. There may be minor in the sense -- it's, it's minor surgery because it's a

finger, but it's major surgery because it concerns the 1 2 loss of a life. 3 So they're going to have to work on the finger big time and that's not something we're talking 4 about just giving somebody a shot of penicillin. 5 6 RACHEL: No, no. 7 JOHN DOLAN: So, you know, we're talking about, we're talking about a serious, life-threatening 8 -- I mean, truly life-threatening situation. So, you 9 know, is she around there somewhere? 10 11 RACHEL: No. She's with Steve. They're 12 making the tape. JOHN DOLAN: They're make -- could you get 13 14 her back to the phone and let me see if, if you and I could talk some sense in -- and why don't you just hang 15 16 around here by the phone with her? And I'll wait till 17 you get her. 18 RACHEL TO UNIDENTIFIED PERSON: -- see if she can come to the phone -- if she wants to talk to him. 19 20 RACHEL: Uh-oh. 21 JOHN DOLAN: What's the matter? 22 RACHEL: I asked someone to go get her and they went to stand up and bumped their head on the TV. 23 24 JOHN DOLAN: Oh, no. 25 They kind of got conked out here. Now, now they're flat on the floor.

1	JOHN DOLAN: Revive them. Who, who got
2	knocked out then?
3	RACHEL: It's not, it's not funny, but
4	JOHN DOLAN: Who got knocked out?
5	RACHEL: My sister.
6	JOHN DOLAN: Your sister? Who's that?
7	RACHEL: She said it doesn't matter.
8	JOHN DOLAN: It doesn't matter? She'll just
9	have a big goose egg.
10	RACHEL: Someone else went to get her, okay?
11	JOHN DOLAN: Okay. You and me, we're going
12	to help her.
13	RACHEL: Okay.
14	JOHN DOLAN: Against her own will, we're
15	going to help her. Okay?
16	RACHEL: You know what's funny about talking
17	to Jim, Gary well, I never talked to Gary, but I
18	talked to Henry and John Cox, and that is your, your
19	voice sounds very similar to Jim kind of a
20	mixture
21	JOHN DOLAN: Well
22	RACHEL: And
23	JOHN DOLAN: Really?
24	RACHEL: Yeah.
25	JOHN DOLAN: I don't know that there's much
	similarity, but I'm glad our voices are, are the same.

1 We're --2 RACHEL: Actually you sound very, very young. 3 JOHN DOLAN: Very young. I know. I told, I told, I told David, I said that's because of what's 4 inside, you know. That's really what counts. 5 6 RACHEL: Yeah, well, my dad was always as young as -- he always wanted to be young and he didn't 7 like it when he started getting older, but he always acted young, so he was always young. But you know he's 9 gone now. 10 11 JOHN DOLAN: Yeah. Yeah. My dad is -- my dad's not doing too well, personally --12 13 RACHEL: Well, he's gone because of this whole incident. 14 15 JOHN DOLAN: Yeah. Yeah, I know what you mean. Look, you and I are going to get her medical 16 treatment whether she likes it or doesn't like it. 17 18 They just came back and they said RACHEL: that she's taking care of her finger right now. 19 20 JOHN DOLAN: Yeah, but that's not really 21 going to do any good. 22 RACHEL: Well --23 JOHN DOLAN: You and I both know that. 24 That's --25 RACHEL TO UNIDENTIFIED PERSON: You want to come to the phone?

JOHN DOLAN: Rachel? 2 RACHEL: She didn't want to come to the 3 phone. JOHN DOLAN: Rachel, why don't you go down 4 and talk a little sense to -- into her and tell her 5 that you don't want her to lose a finger. 6 7 RACHEL: You don't -- well, yeah. I'll tell her what you said, but as far it getting -- Judy -- you 8 9 can't really persuade her to do anything. She does what she wants to do. She's very set in her mind. 10 JOHN DOLAN: Okay. You know best along those 11 lines. You know best. 12 13 RACHEL: Can I ask you another question? 14 JOHN DOLAN: Sure. 15 RACHEL: What will be the charges against David after this is over? Or now or whatever? 16 17 JOHN DOLAN: I don't know. I could probably check and find cut what the -- what affidavit has been filed downtown. We could pull that from the 19 20 Magistrate's Office. I don't have a copy. Otherwise I'd read it to you, but I just don't know where that 21 22 stands, to be totally honest with you. It's not something that we've been really concerned about, you 23 24 know, in the sense of, of research court records, you 25 know.

So I honestly don't know, but we could find,

1

we could find that out. But, you know, charge, charge is one thing. Conviction is another. And they are ten million miles apart.

RACHEL: I know that, but I also, you know, I know how the Government, Government is and they convict innocent people a lot of times too.

JOHN DOLAN: Well, obviously there's going to be a felony charge. It's not going to mis -- be a what they call a misdemeanor infraction. There's no question about that.

RACHEL: Oh, I know that.

JOHN DOLAN: But, I mean, there's hundreds of, I'm sure, very worthwhile attorneys, you know, in this country who, who want to represent him and I'm prob -- you know, I don't know who they are for a fact, but they want to represent him because, like I told you before, there's a lot of problems with this case.

There's a lot of problems. Based on what -- just a couple of people, like Steve, have told me. But, you know, let's face the facts.

Guilty people, regardless of what they've done, get off every day. Innocent people get off every day. And there are huge civil suits against police officers for doing the wrong things. You know, if, if what you say is true and there's a deceased child in there, the Government has an absolutely, you know,

incredible problem with this case. 2 And, you know, as far as I know there's many nationally known attorneys who would like to handle 3 4 this case because why? It's absolute front, front page 5 publicity. 6 RACHEL: Um-hum. 7 JOHN DOLAN: You know, the Government loses a 8 lot --9 RACHEL: And I don't think Gary Coker would 10 be good enough for this. 11 JOHN DOLAN: Oh, I'm not saying that -- I'm 12 not saying --13 I mean, he was a good lawyer. RACHEL: 14 get me wrong. 15 JOHN DOLAN: Yeah. 16 RACHEL: But I don't know if he's, he's for things like felony or --17 18 JOHN DOLAN: Let me tell, let me tell you 19 about a case in San Diego, California, southern 20 California. There was a ride-along, a lady who went on a ride-along with a uniformed police officer in a car. 21 22 They got a call of a disturbance call. Loud shooting 23 -- loud yelling and screaming. Okay? They, they come up to the driveway and what happens is there's a lot of 24 25 verbal exchanges between the officer and a guy by the

name of Saigon Pen, that was his name.

To make a long story short, a physical, a physical fight erupts, the uniformed officer gets killed, shot and killed. A second backup, backup, backup officer gets wounded and the ride-along lady gets wounded.

RACHEL: Oh, boy.

JOHN DOLAN: Saigon Pen is charged with murder. Saigon Pen goes to trial and is acquitted on the charge, on the charges of murder and his defense was self defense.

RACHEL: Um-hum.

JOHN DOLAN: Okay. That's an absolute case from Southern California, you know. And, and that's nothing, nothing in intensity like this case where you have people who are like innocent infants shot and killed. Do you understand what I mean?

RACHEL: Yeah.

JOHN DOLAN: Okay. I've got a couple of questions that they're trying to get down to the doctor as soon as possible. And it would probably be better if I asked Judy what the questions were -- about where it entered and all that stuff.

RACHEL TO UNIDENTIFIED PERSON: Can you go get Judy, please, to ask her some questions about her finger so he can tell the doctor? Tell her to hurry up.

1	RACHEL: Did you hear about this woman who
2	was out, I can't remember where it was, but she got
3	stranded somewhere. And her, her child got eaten by
4	JOHN DOLAN: What?
5	RACHEL: some animal
6	JOHN DOLAN: No.
7	RACHEL: and she got charged for murder
8	for killing her child and then
9	JOHN DOLAN: Oh, that was a TV movie, wasn't
10	it?
11	RACHEL: No, this is true.
12	JOHN DOLAN: Oh, no, no, yeah. But it was a
13	TV it was one of those factual movies.
14	RACHEL: I don't know.
15	JOHN DOLAN: Yeah, yeah.
16	RACHEL: And she went to jail and served time
17	and then later they found they went back to I
18	think it was around some sort of mountain or
19	something
20	JOHN DOLAN: Some kind of grizzly bear or
21	something actually killed the child.
22	RACHEL: and they found some evidence
23	there that showed that she did not kill her child.
24	JOHN DOLAN: Oh, yeah. That was
25	RACHEL: Do you remember that
	JOHN DOLAN: That was on TV. She was and

she was charged and then later she was acquitted, you know, or, or released or whatever. Yeah. 2 3 RACHEL: That is --4 JOHN DOLAN: Pretty scary. 5 RACHEL: You know, because I, I can relate to that because I think what if, you know, I, I can relate 6 to that because I'm a mother myself, you know. 7 8 JOHN DOLAN: Of course. 9 RACHEL: To think that I could go to jail for, you know, my daughter's death and then them, you 10 know, accusing me of, you know, doing something like 11 that, when here it is an animal. 12 13 JOHN DOLAN: Oh, yeah. 14 RACHEL: That is dreadful. (Tape 102) 1 2 MAX: -- is for an adult. Some adult person 3 to come out of there the next time a tape comes out or there's some reason for us to come physically close together an adult come out. And I'm recommending Judy 5 because of the injury. I really am. And I think -- I 7 don't see how you could object to that. STEVE: I haven't. 8 9 MAX: Okay. And I think -- okay, I know. She's got her choice. But you, you and she have a long 10 11 history. If you can think back, you and she have a bond. 12 Well, this is true. We do --13 STEVE: MAX: And, and you have to do sometimes what 14 is right for her whether she at the moment realizes it 15 or not. And an adult, significant adult coming out of 16 there to gain medical treatment would --17 I see I -- Max, I, I --STEVE: 18 MAX: -- go so far right now --19 STEVE: -- I appreciate. 20 I --MAX: -- to continue. 21 STEVE: I --22 23 MAX: Do you remember what a big step the milk was? It would just be that much and more. 24 STEVE: I appreciate all that you're saying, 25 the considerations. But she's still an individual that has her own conscience that she has to answer to and her own convictions. I can, I can sit there like I told you and lay out the pros and the cons. But ultimately it's for her to decide.

MAX: Well, okay. Let's -- if I may interject, Steve, you know.

STEVE: Um-hum.

MAX: We go -- we look back and we see when the children were released. We know who released the children. David said you go and you go at this time. And then he said you go and you go the next time. Or you four or you three. He didn't send any of his own out.

STEVE: Well, he did ask --

MAX: It's funny that this --

STEVE: -- he did ask the mothers.

MAX: -- funny that just the children that were not his --

STEVE: He did ask.

MAX: -- all volunteered to go out at the given times when David decided it was time to release someone. So I really think, you know, you look at the political side of the, the structure you have in there. David is in control of those things. And if you can use your influence on both David and Judy. And I don't think you've totally lost it with Judy. There's still

got to be something there somewhere. That you -- the two of you could do the right thing for her before she 3 is disabled somehow or worse. 4 We are your best friends out here. Those of us that plead with you on the phone and try to, to make 5 you think back a few years before you were so deeply 6 involved in this thing, we are trying our best. We are the best friends you have. 8 STEVE: I realize where you're coming from, 9 10 Max. 11 MAX: All of you have. STEVE: I do realize where you're coming 12 13 from. MAX: And without us, things are going to be 14 different. I can't say just how. But I don't know. 15 But I know without the influence we have out here --16 it's kind of like the influence you have in there. 17 Without the influence --18 19 STEVE: I really --MAX: -- we have out here the situation is 20 21 going to turn --22 STEVE: Max, I don't have the kind of --MAX: -- to others. And you've seen how some 23 24 of the others deal. 25 STEVE: Max. MAX: Without you in there, I know this

situation would be a lot worse. 2 STEVE: I don't have the kind of influence you think I do. I don't. You don't understand. 3 really don't. People will hear my opinions, but that's 4 about as far as it goes. 5 6 MAX: No. You have more credibility than that, Steve. 7 8 STEVE: You don't --9 MAX: You know you do. 10 You're giving me credit that, that is STEVE: not even so. That, that doesn't even belong. 11 MAX: You stood up and argued with us the 12 first day. You have something, or you couldn't have 13 14 done that. 15 STEVE: Oh, I mean of course I've been in (indiscernible), you know --16 17 MAX: You get angry and you tell us -- you put us in our place sometimes verbally. You --18 19 STEVE: Well, we all do that. You do that --20 MAX: -- know that you've got some stroke in 21 there. It comes from you. 22 STEVE: We all have our opinions and, and believe in certain things that we'll stand up for and try to lay down as we see it. You and I both. But you 24 know, again we're looking at a book that talks about if 25 you put father, mother first, sister, spouse, brother,

you're not worthy of me Christ said 2,000 years ago. He repeats that in all the gospels. That's not a reality to those people that claim to know him 3 throughout all the churches, but it is to this group. 4 5 MAX: Why --6 STEVE: So you got, you've got to keep that 7 in mind. 8 MAX: Why is it so hard for you to accept 9 credit for, for being someone of influence, someone 10 worthy and someone --11 STEVE: It's not --12 -- that gets something done? 13 STEVE: -- it's not that I don't accept 14 credit. It's just that once --15 MAX: It hasn't all been stripped from you, has it? " 16 Well, here's the thing. Once these 17 STEVE: people have met him and have seen his ability and what he can do with that book, it's night and day between 19 20 them and myself. 21 As an example, when I went to England in '88 22 in about June, July of that year, I went to a couple of religious schools and raised questions. And a number 23 of theology students stopped, and they were amazed at 24 25 the questions. And they looked at me, said do you have

the answer? And I says well, they're in the book.

Would you show us? So I raised more questions. When I showed them where it was found they were astounded after spending 10,000 a year to go to a school that showed them literally nothing.

So in the process, I studied with about oh, 30, 40 people for 6 weeks, Max. And they had never heard anything like it in their life. Even though they were listening to many scholars in a, in a particular school they were going to. I finally told them, I said what I'm showing you is nothing. There is a guy that will blow you and I both away that will come behind me if you're really interested.

MAX: I know you think a lot of his interpretations. No question about it, you really do.

STEVE: Well, I'd give anything if you could come up with some, some of the greatest scholars in Catholicism or in the Lutheran church, Methodists that could either on the phone or in some manner debate with him on any given topic that they would like.

MAX: I would give anything in the world if I could have had this conversation with you 6 years ago.

I think you would have hopped on one of those motor scooters out back and, and raced to the front gate with Judy on behind you.

STEVE: One never knows.

MAX: But --

1 STEVE: One never knows. 2 -- a little too much influence here 3 is --4 STEVE: I, it's --5 MAX: -- you know, you've lost something to 6 it I guess. 7 STEVE: Max, I know. I realize. 8 MAX: Where's your drive? 9 I know from your perspective it would 10 seem that way. I know that. If I were in your shoes 11 now, I would be saying the same thing to this human 12 being sitting where I am now myself. I'd be going 13 through the same process you are trying to talk myself out of it using the same arguments. 14 15 But see, the whole thing is it comes down to 16 that book which you don't believe nor do you 17 understand. Now if I can see that that book is not credible itself, all the book talks about is some guy 18 19 that comes in the final days. It may not be this man, 20 Max. It may not be. 21 MAX: Well --STEVE: But so far he's been able to do --22 23 MAX: -- you're taking an awful big gamble it 24 is, aren't you? 25 STEVE: Well, why can't the scholars shoot him down? Why can't they rip him apart? Why can't

they controvert what he has? I mean if it wasn't --1 2 I don't think it's a matter of MAX: knowledge. I think it's a matter of presentation. 3 4 STEVE: Oh, presentation --5 MAX: He's a great BS'er. 6 -- presentation is nothing. 7 are guys that are have, are such -- have such ability 8 to speak to --9 MAX: Um-hum. Um-hum. 10 STEVE: -- articulate their words --11 MAX: This looks good. 12 STEVE: -- to really express themselves. 13 MAX: (Indiscernible.) 14 STEVE: There, there are times, you know, I mean he'll even say himself it depends upon who he's 15 talking to. But that's not what impresses me. 16 the very information, the knowledge. And Mark Bro 17 (phonétic sp.) himself who gained a Master's degree was 18 not able to, to shoot this guy down to controvert what 19 20 he has. 21 David flew all the way to Australia to give him that opportunity. Then he sent me back a second time, 6 months later. And he didn't want me to debate 23 24 with him. I, I really did want to. But he says take down what he has. Let him open up his doctrine. Bring

it back. Let everybody have an opportunity to hear it,

to wrestle with it, to decide. So that's exactly what happened. But no one --2 3 MAX: You, you are, you are so -- calling yourself up so short, counting yourself in so short, 4 Steve. We talked to -- how many people do you think 5 there are that are former members of your group or your 6 sect or that have been involved with you and Mark and 7 8 David over the years. Former members. 9 STEVE: I have no idea. 10 Be quite a few of them, wouldn't there? 11 STEVE: Not really. Not that many at all. The majority would have been Australians. And even 12 that there's not that many. 13 14 Um-hum. Okay. There's a few in MAX: California, and there's a few people out --15 16 STEVE: Yeah, the Bunds family. 17 -- there still associated with --MAX: 18 But the father remained, you know. 19 MAX: But the, the people that have been associated with you or are knowledgeable of you and 20 David are not all in that compound. We've talked to a 21 lot of them. That's our job. We go out --22 23 STEVE: Um-hum. 24 -- and we find these people, and we 25 talk to them. STEVE: Okay.

Of course. 22 Because in my past there was like I told you my mother 23 being Catholic, Dad, Lutheran became Seventh Day Adventist. I rebelled in my high school years. I did 24 not -- I saw hypocrisy in all the churches. So I left 25 for about 4 or 5 years, hung around with movie stars,

1 actually made a lot of connections. But that got to be 2 old hat. I got kind of tired of that scene.

You got to have a court to use evidence in. 11 12 STEVE: I'm glad you brought that up 13 because --14 MAX: So come on out here --15 STEVE: -- the whole Bible deals in a judiciary system with attorneys, with mediators, with a 16 judge. You know, you -- if you're used of Western 17 literature you would be familiar with the Bible, how 18 it's based in fact and, and law. All the way through, 19 right from Genesis through to Revelation. That's what 20 David's message is is there's a, there's a judgment set 21 in Revelation 4 and 5. And all the eyes of all the beings of the universe are on that book. 23 24 What's in the book? One that sits on the throne is quiet. He's not speaking any longer. 25 information's already been written. It's been

foreordained. There it is. Who wants to know ahead of 2 time --3 MAX: Come back, Steve. Come back. 4 STEVE: I know. I know you don't like to get off into anything to do --5 6 MAX: You're going too far for me. 7 STEVE: -- with the Bible or religion. 8 MAX: How many pockets you -- how many tickets you got in your pocket? One or two? 9 10 STEVE: Well, I don't have any. But 11 anyway --12 MAX: Well, you're plan. You going back to Hawaii alone, you going to take Judy with you? 13 14 STEVE: Oh, I have no plans of that. I just take a day at a time and try to do the best one can for 15 16 that day. MAX: Well, there's, there's another one that 17 give you reason to, you know, make your loophole a 19 little bigger. Make it big enough to drag Judy through to and both of you go back to Hawaii. 20 21 STEVE: Oh, I have, I have the highest respect for Judy. Always have. We've always, we've 22 always been seen as the, the most perfect couple 23 anybody's ever known. 24 25 MAX: We hear the same thing. We hear the same thing. In fact, that article --

18	we first started, my wife and I first started. We had
19	a very dinky apartment too. Former cult members say
20	that Judy was sweet if the word was ever used properly.
21	That they were Judy and Steve were a team and that
22	they couldn't whatever Steve couldn't do she could.
23	So
24	STEVE: Oh, yeah. We've always
25	MAX: that's, that's about the nicest
	thing that can be said about

STEVE: David himself has said as Mark and everyone else said if there was ever a marriage where two really worked out they had never seen anything like it, it was her and I. This is -- and it's always been that way. It's not changed.

But when it comes down to spiritual things, when it comes down to one soul and the possibilities that there's a God, I've always told her don't ever let me make up your mind. I can't be responsible for your decision. That's between you and your maker if there is a God. I mean everybody's got to come to that on their own. And there's -- I can share with what I understand, what I know, what I think. But the bottom line is everyone has to make up their own mind, their own decision with something so serious as that.

So right from the beginning when I met Mark
Bro and he opened up that he did I said to Judy look,
if I go, don't you go before, -- because I do. Or if I
stay and you believe it, don't you stay with me and you
believe it. I says go with what you see. Go with what
you believe. And that's the way it's always been.
Always has been.

And I've even been very hard with her on that. But I have seen that it has, it's not been necessary, because she has followed the dictates of her own conscience.

1 MAX: Well, that's, that's strange. very unorthodox following that, you know, a marriage 2 would be treated that way in a religious --3 STEVE: Well not, not if you read the -- not 4 at all, Max, if you read the -- read any --5 6 MAX: Well, like I say --7 STEVE: -- read any book of the New 8 Testament. 9 -- it's a little hard to understand. MAX: Little hard to --10 STEVE: Any book of the New Testament. 11 any -- you could go to any minister, they'll tell you 12 the same thing. It doesn't matter what --13 14 MAX: Not many people thought you have to give up your wife to be, you know, part of the --15 16 STEVE: Oh, the ministers will --17 MAX: -- to be dedicated to, to --18 STEVE: -- the ministers will tell you that also. If you put mother, father, spouse, sister, 19 brother before God, you're not worthy of God. But of 20 course, you put God first, first and the scriptures say 21 he'll put you first. He'll work it out for you. 22 mean it's always worked for me, and we've not had any 23 24 problems. 25 MAX: Hmmm.

STEVE: But when it comes to something

2 MAX: I bet that was hard to accept in the beginning, wasn't it? 3 4 STEVE: Pardon? 5 Wasn't that a little hard to accept in MAX: 6 the beginning? 7 No, because all through my life as I read that Bible I always figured how come it was for 8 the apostles of 2,000 years ago and the people they 9 worked with, and it no longer exists in this 10 generation. There's definitely I -- in honesty I'll tell 12 you the truth. I don't believe there is any such thing 13 that exists in this generation as Christianity. 14 doesn't exist anymore. I'm not a Christian. 15 I don't 16 know of any. A Christian 2,000 years ago they would lay hands on one another's heads, they would have a 17 supernatural power to be able to raise the dead, heal 18 19 the sick, feed thousands. That doesn't happen anymore. 20 So I can't blame the world in their worldly wisdom when they see all these religious social clubs 21 taking money and like say Baker and like Swaggert and 22 all the others. I, I mean anybody that has any insight 23 24 should be able to read through all of this. 25 So people say that about this group from what they understand. But they haven't -- those that take

like --

the time to hear, then they can evaluate, and then they have something to judge by. But if one doesn't take the time, they'll never be able to see the points laid 3 out, the consistency, and thereby they'll be doing themselves a disservice. 5 MAX: Well, let's if we can, can we just 6 assume for a minute that, that the exact conclusion 7 that David envisions has a flaw. How would you like to 8 see it resolved? 9 Well, you know, it's such a weird 10 situation that we're in. It's so strange. I mean in 11 regards to number one I mean all that took place and --12 MAX: Hey, hey, little equivocation there. 13 If there's a flaw in David's vision or his perception, 14 how would you like it to work out? Let's discount the way he says it is going to for a moment. What's the 16 alternative? 17 STEVE: I really don't know. In honesty I 18 don't. I mean I -- how, how do you second guess 19 something like this that has taken place and where it 20 might go and where it could go. I don't have the 21 foggiest idea. 22 Second guess. Let's look at it as a 23 MAX: fall back plan. 24 Okay. For instance like with him, if STEVE: 25 he says that he's expecting something, it has always

happened. There's never been a time where he hasn't had an answer or hasn't at least given one. And in, in 2 doing that, you're going to have people reacting pro or con to it and making a decision and going with it. But they've all decided they on their own, it's concluded 5 on their own that they've wanted to give him the 6 opportunity one last time to see what he has or what he 7 8 has to say. 9 And of course, this is why on a day-by-day basis I still go and ask people do you want to leave 10 today? What do you think? 11 12 MAX: Oh. 13 STEVE: Do you see? 14 Oh. Are you saying their, this is sort MAX: 15 of a test? 16 It, it would seem like --STEVE: 17 MAX: Wait a minute. If he pulls this one off then, you know, it's, it's 100 percent. And if he 18 19 doesn't then --20 STEVE: No, it would seem like it is. It actually would seem like it is. 21 22 MAX: Well, yeah. I, I can see that. 23 STEVE: So --24 If he doesn't, you go back to Hawaii. 25 STEVE: Well, it's true. MAX: Uh-huh.

1 STEVE: It's true. This thing falls apart, if he's not able to show and to continue to do so -- I 2 3 mean I've -- see I make my judgments every day. It's not like I accepted this 6-1/2 years ago and I'm stuck. In honesty if you, you talk to those that know me that 5 are on the outside or that were part of this, they'll 6 tell you for a fact that every day is a new wrestling 7 match looking over the issues. Is this right? Is this 8 wrong? Do I go with this today? Do I throw my hands 9 up in disgust and go back to Hawaii and go back to what 10 11 I was and what I had? 12 MAX: How about just throwing your hands up in disgust and walking out the front gate? 13 14 STEVE: Well, you don't think I consider it 15 constantly? 16 Well, I sure wish you'd think about it MAX: 17 more seriously. 18 STEVE: I do. It's a daily thing. something that I'm wrestling with constantly moment by 19 20 moment. 21 Well, I'm glad to hear you say that. MAX: really am. It, it leads me that there's some hope 22 23 It leads me to believe that you have a mind of your own and there is some hope for this thing. 24 25 STEVE: Well, I'm not the only -- they all --I mean I'll give you names of people that come to me

today like yesterday also, and they'll say -- they'll tell me their thoughts. And I'll sit there quietly and 2 3 listen. 4 Yeah. MAX: 5 STEVE: And what they're going through. and I tell them well, do what you think you've got to 6 do. Do what you think is best for yourself. 7 always, you know, wrestle with the issues. So I mean 8 that's the way it's got to be, and I'm always 9 expecting, you know, anybody can go. Anybody can 10 choose to and they may. 11 12 Well, is there, there any questions in MAX: your mind that we could answer out here or find the 13 answers to or anyone we could talk to for you to, to 14 give you facts or give you reason to, to tip these 15 scales in one direction or --16 17 STEVE: Well, the biggest --18 MAX: -- anything you need --19 STEVE: Max. 20 -- to help you make a decision. MAX: 21 STEVE: Well, the biggest thing would be for honestly for these people, you've got to be able to 22 find a scholar from maybe the university of this or 23

MAX: No, no. Somebody to come in there and

that knows --

1 argue with David. He's too --2 STEVE: Well, not quite. 3 MAX: -- big of a manipulator. That's not going to happen. 4 5 Well, no, not quite like that. 6 It's, it's the presentation. 7 STEVE: You don't by choosing --8 It's, it's not the, the show, it's the MAX: 9 showmanship. 10 Could there be a way -- see well, these people are expecting that there, there should be 11 a scholar out there with a number of degrees or the 12 ability of language that, that's older than David that 13 in their ability of memory, memorization, holds and 14 understands something of scripture where they can raise 15 the questions or shoot him down. Or at least show that 16 he's fallible, that he's not able to have a consistent 17 answer directly from that book. There's got to be. 18 19 I mean before I came here, I went to Andrews University. I went to the University of Hawaii. 20 spent some time studying on my own at the University of 21 Wisconsin and had spent time in England. And with all 22 the comparisons and, and listening to these men of 23 different ability, there was a man over there in 24

England, his name was Dr. Scoil (phonetic sp.), who

could speak many languages. There's been many men I've

25

met through the years that have quite an ability.

But I would like to see these men take this guy and controvert what he has. You would see these people walking out of here so quickly you wouldn't believe. Seriously. Just let them raise some questions that he can't answer clearly or consistently or that, that it's very questionable.

There's got to be men out there like that. I mean look at all the millions of people that, 'that say they're into the Bible that make money off of this book that have studied it all their lives that are, that are more than twice his age, maybe almost three times his age. Do you understand what I'm saying?

MAX: Yeah. I've, I've heard it all before.

What about Baylor University? There's over 10,000 students that go there. They've got to have some sharp minds there, some doctors and so forth. But where are they? Where are the arguments? Why don't they raise the questions with the man? Have you considered this? What about that? I mean if this group here could hear and see a dialogue --

MAX: Well --

STEVE: -- questions raised that he could not answer or at least that where it's questionable, it would make a huge, a huge difference. I mean if you

look at that tape tonight, it's because these people have experienced Adventist ministers, Lutheran 2 ministers, Catholic priests, and they've not seen 3 anyone that even came close to having an ability to 4 have answers, always having answers. But it's not to 5 6 say that they're not out there, Max. It's not to say 7 that at all. And, and --8 MAX: No, there's no one out here. There's no one anywhere in the world that we can bring in there 9 with David and with the people in there and sit and 10 11 have a discussion that you and everybody in there would not see David as really 100 percent winner. Whether he 12 said a word or not, he would be declared the winner. 13 14 STEVE: Max, no, it's not like that. There's nobody going to win in a 15 religious argument with him in front of that audience. 16 17 It's not like that. Max, honestly, STEVE: it is not like that. 18 19 MAX: It is. STEVE: They will always take the time like I 20 did with Mark Bro in November over in Australia of 21 22 I did not interrupt him. I sat there quietly, attentively -- in fact, I've even wanted to see an 23 underdog like Mark come about and, and come up with 24

some doctrine or the ability to shoot him down.

really -- if you ask Mark back in '89, I says Mark,

you've claimed to be a prophet all these days. know, Mark is another human being that has claimed to have visions and dreams. Did you know that? 3 MAX: No, I, I didn't know he did that. 5 STEVE: Oh, yes. I've got -- you ought to --I've got stacks of papers that he typed out of his 6 visions and dreams. He denied that he ever had this experience and that he was a prophet in Michigan a year 8 ago before the judge. And that really floored me. 9 Because he had made the biggest thing of that right up 10 until the very time he took, his seat, stand in the 11 12 courtroom. 13 MAX: Um-hum. 14 STEVE: And so that blew his credibility with I told him Mark, well what's the thing now. Now 15 you're saying you're not a prophet. And then after the 16 courtroom situation was over, then he went back, 17 reverted back to that yes indeed, he was a prophet. 18 19 MAX: Well, wait a minute. He lost credibility with you because he had visions --20 21 STEVE: Well, yeah. I've got --22 MAX: -- and David didn't need the credibility with you because he has them. 23 24 He volunteered -- you see, Max, he volunteered giving me those visions. I never asked for 25 them.

1 MAX: Okay. 2 He sent them to me. I, I could send STEVE: you copies. I could give --3 4 MAX: No. STEVE: -- or I could get them out to you of 5 course to the gate out there, and you could look them 6 7 This is the guy that introduced me to David. 8 MAX: Um-hum. 9 I never knew this David. Not at all. STEVE: 10 MAX: Well --11 STEVE: It was, it was he. 12 -- you know, he says that he introduced you to him to be able to shoot him down. 13 Thought you were the only one that could. And then you got taken 14 15 in also. STEVE: Well, not -- that's not exactly how 16 17 it happened at all. Well, I took all his information, and I sent it to a professor friend of mine at a university. And he got back to me. I says well, what do you think? And he said to me I'm also dubious. And I says well, take more time with it. Wrestle with it and get back to me.

Well, we were in contact probably six different occasions long-distance from Hawaii to Michigan where the professor was. But ultimately when Mark came back, he had all this information. I says Mark, where did you get it? And you know, ultimately told me from the source. And so I finally flew over to that source.

And Mark took a back seat when David spoke, and I could see why. Because his information was so far beyond what Mark had, I could then see the very mannerisms that Mark was using he had picked up from David.

But through the next 6 months I went back to Hawaii to get away from him and wrestled with those scriptures, with the text. Some friends of mine in Hawaii called up a man by the name of Ortega. And I think he's got a doctor degree if I'm not mistaken. But they flew him over to deal with me to show where this was wrong. And I was such a, so naive and a

novice as to the information David had opened up. But I had the basics down.

So I started saying to him well, show me what you think about what he has shown me. And I, I laid out that number of chapters. The man kept on reverting to the scholars' opinions. I says I don't need that. Show me what the writers have said. Go back to that same source. Well, he was not able to do so. And those people that sat to listen and see what happened were astounded at the lack of ability of this man that was much older than myself. So that just gave more strength to the arguments to the very doctrine that David had opened up.

So and every day since that day, I've never been able to rip the man apart. And I have tried.

I've lost my patience with him at times and said what about this, what about that. What are you going to do with -- I've had it with this. And he's always been able to go back to chapters and context. Always has been able to do that

See, that's the reason why I'm here still.

If that, if that would stop, if it, if it had quit, if it had abruptly come to a close. But it has not.

That's why I even hoped that Mark on the outside would still be able to have some strong arguments.

We invited Mark to come back and bring

anybody. We'd pay his way. Fly him back. He could present whatever he wanted before everybody. But of course, he would not do it. So that showed to the people that he had nothing. That he, he was not able to do it even though he boistered (sic) his opinion and, and made some pretty strong statements, when it came right down to it he was not there to, to back what he thought he might be able to do.

MAX: Okay. Well, it's, you know. I've never seemed to accomplish much. We never seem to accomplish much toward resolving this with discussions of, you know, the religious issues and the, the connections therewith. It's too big of a gap in, in the perceptual world or percepting worlds that we have here.

What we are able to put together from out here, and as I said earlier, you know, we talked to people and, and they tell us the position that you're in and the position that David's in and a lot of what goes on in there and what is necessary to, to be a member and to stay a member in good standing and all those things. And we pretty well know how that fits in with the, the society in which we all must function, this real world that exists around you, around Mt.

Carmel. And you know, that's one of the problems that brings us up to where we are now.

And I -- and, and that's where we all believe the situation is going to be solved is from in that real world setting. And I think David knows that. believe you know it. And it's a matter of -- I think David is very concerned if not if I may be a bit stronger afraid of what an unknown judicial system might do with him. The difficulties that he might face in this system. I think that's the bottom line.

> STEVE: I --

-- if we through you could help answer some of those questions for him, it might bring about a resolution that we can all be happy with. And you can use your ticket.

MAX: Okay. I would like to, to ask you again to, oh, increase the visionary process or help in this preparation. And that is with the judicial process. You keep saying a lot of things prefacing it with you might not understand.

STEVE: Um-hum.

MAX: So let me preface this with you might not understand but would you believe or would you go along with it anyway. Look up some of the judicial process. Get with Wayne and find out just what should happen in the system from here.

STEVE: I'll try to do that. I'll try to see what we have here for reference books and --

MAX: And, and enlighten and discuss it openly with David just in case that's the way the vision leads him. He needs to know.

STEVE: Sure, I'll do that.

MAX: He needs to know what the process will 1 If the Sheriff Hartman --2 STEVE: He does like these guys. 3 serious. I mean just like this summer when I think the 4 man's name Johnny Leondo (phonetic sp.) and there was another one that came. And he'd have sat down with 6 them. He went down into town by the way, Max. 7 MAX: Well, my continuation of my sentence. 8 STEVE: Okay. 9 If, if Harwell, Sheriff Harwell could 10 be of assistance in helping him answer questions --11 STEVE: He may be by the way. 12 MAX: -- or maybe, you know, he could put 13 some oil on the water for him. 14 STEVE: That's -- this is true. 15 MAX: Since they go back so long ways, maybe 16 he could help spread the oil on the water. And the --17 That could be. STEVE: 18 -- two of those together could answer 19 any questions he might have if the vision leads him in 20 that direction. 22 STEVE: Right. MAX: And then third thing. That's two. 23 Third thing I wish you'd kind of tag on your sleeve 24 there is the, the funeral. Let us know --Right. STEVE:

MAX: -- if there's going to be any 1 2 activity --3 STEVE: Okay. MAX: -- on, on account of that and when and 4 5 how that needs to take place. 6 STEVE: All right. MAX: And just any other thing that you can 7 help us with in using your influence to get things 8 moving in there. 9 STEVE: Well --10 MAX: We have got to show some something out 11 here, or there's going to be more incidents like we had 12 earlier this evening when we're going to be out of 13 control. 14 STEVE: Do you know that I was resigned and 15 thought and was -- I thought it was all over a week ago 16 too. I my mind I thought well, it's finally done. 17 We're walking out. It's all over. Everybody here 18 thought that. Not maybe. Not, not anything. 19 Everybody thought it was over. It's like you take a 20 deep breath. You breathe a sigh of relief. Walk out 21 that door. I mean that's -- you know, from that time 22 on it's been like, of course, everybody's been blown 23 24 away by it. Well, from that time on we haven't 25 MAX: received any positive reinforcement that we're doing

the right thing. 1 STEVE: Well, you really have if you really 2 think about it. You know --3 MAX: No. 4 5 -- it did slow down over the weekend. But of course, he's not wanted to lose communication. 6 Because well, number one, he's not kidding when he says 7 he likes you people in the first place. 8 MAX: Well, liking --9 STEVE: He knows you've got a job to do. 10 he wants to work with you. He wishes that his God 11 would hurry up and give him an answer or at least show 12 him something. He was ready to leave a week ago 13 Tuesday and he wants to -- he told me again today I 14 want to pick up on that. I want to do it and be done. 15 And that's what he said today. And he said where's my 16 God? Why hasn't he spoken to me? Why hasn't he showed 17 me something? 18 The last confirmation that we out here 19 have that you want to see this resolved without further 20 21 problems --STEVE: Are you thinking about Heather as 22 someone coming --23 -- (indiscernible) 4 days -- Heather, 24 MAX: 25 pardon me, was the last one.

STEVE: And then what about --

MAX: And since then we have received no 1 positive confirmation --2 STEVE: Well, at least he --3 MAX: -- that we're doing the right thing and 4 to make him show our --5 STEVE: He's wanted to at least show you, 6 he's wanted to at least show you the people, the faces, 7 the names and --8 MAX: Yes, yes. 9 STEVE: -- show who's here, what they think, 10 what they want to do and --11 MAX: Well, please continue in that vein 12 13 and --STEVE: Well, that's what we're doing. 14 That's --15 MAX: -- and --16 STEVE: -- what we're going to do. That's 17 18 why --MAX: -- give us something that we can take 19 in to our commanders and sit in front of them and say look, this is what we have. This is all worth it 21 because of this. And --22 STEVE: Well, that's why like tomorrow, you 23 know, I'm going to, of course, take the camera again. 24 And we're going to start working on just seeing who 25 else and what else we can all film and, and what, you

| know, what we can accomplish.

MAX: One of those people that would best be an example would be an adult and I think Judy. And I think that would do, give you so much more peace of mind and freedom. You know, David knows that she is the most, right now the most deserving and the most needy. And whether she wants to or not, whether she ---you all know what is best for her.

And that would -- if we could stand her up in front of our bosses with her injury and see that she gets medical care and say look, guys. Look, bosses.

Look, tank drivers. This is what we're working for.

This is what we got. Because we --

STEVE: I realize what you're saying, Max -- MAX: -- went for 4 days without --

STEVE: She would -- but she would never trust me if I tried to coerce her against what her will is. Did you get to hear her on the tape?

MAX: Yes, I heard.

I didn't tell her what to say ahead of time. I didn't even know what she was all going to say. I really didn't. What some of these, what some of these people they'd say to me ask us a few questions. And I says well, what kind of questions? I'll ask anything you want. Just because, you know, it's funny how people

get in front of a camera.

MAX: Um-hum. Oh, I --

STEVE: And so I says what would you like me to ask? And so I jotted a few things down. And some wanted different things asked or some might -- like of course, Kathy Schroeder forgot what she wanted to say.

MAX: (Laughing.)

STEVE: And then she kind of lost her composure. And she said can I come back on and say something? I didn't even then know what she was going to say. So I knew that you guys having the experience you have with emotions and all the rest that you take things in the context as they are. So you know, I left the tape as it was.

And a couple of them, of course, as you could see the tape was stopped a couple of times. Because some just sat there blank.

MAX: Yeah.

STEVE: So I had to stop there. Or they'd just sit there not knowing what to say next, so I stopped the tape, backed up, and let them go again.

MAX: Yeah, that's all right.

STEVE: Yeah. So that's basically what happened. And tomorrow we're going to pick up on that again. And there's going to be this time a lot of guys that are going to get on and --

MAX: Well, our, our people out here, the ones that we respond to and plead with, are looking for, for people brought to safety. You know, we can rent videos at the corner store. Lives are hanging in the balance here, and that's what we'd like to, to sit before them if we could.

STEVE: But you know, never forget that there's nothing I could do if your commandos ever wanted to come in on the building, there would be nothing I could do. I mean these people, it would probably get them to stay all the more in honesty. So you know, this is why I like talking the way we are.

MAX: Um-hum.

STEVE: -- if anything then they start seeing a trust develop. They see something happening. And little by little, the guard comes down.

But when there's this -- I mean it never helps when the phone calls come and they see these -- I mean the tanks. They see these, the troop movement right outside the window. They see all sorts of strange things going on. Then they get leery again about trusting the government.

So I'm telling them well wait, now wait. Now don't, don't be hasty. Don't, don't come to any quick conclusions. But I mean you got to, you got to

acknowledge yourself, you know, there's a lot of strange things happening all at one time. 2 In one half we're talking to you. You people seem to be calm at 3 times. It seems to be logical what you're offering and what you're showing. On the other hand, they see 5 something totally sometimes that isn't even under your 6 control, things that you don't even know about that are 7 going on outside the windows. 8 9 MAX: True. True. STEVE: So see, this is where they get leery. 10 It's like you don't have your hand on top of the 11 situation. So, you know, once -- like today, those 12 were the kind of questions they were hitting me with --13 MAX: Well, that works a little bit both 14 ways, Steve, you know. 15 STEVE: Oh, yeah. 16 17 The pipes out the window and the firecrackers. scholars, the theologians. See what they can do and
show you from that book.

JOHN: All right. Just run by me your, your predicament. What you're saying where we are.

STEVE: We're nowhere. We're nowhere at all.

I'm, I'm thinking right from the very beginning, day

one with Jim when we started the communication about

being on the perimeter of the property. You and I both

know these tanks are so large and all the rest that

they, they could be 5 miles away, it doesn't make any

difference.

JOHN: Okay.

STEVE: But to think they went contrary to the agreement that we had with, with you people and they start digging in. They've moved our motorcycles around. Somebody tells me they ran one over in the back there. They've, they've taunted us by sticking these cycles in front of their sandbags. They've, they've shown their asses to us. They've flipped us the finger.

This is not the America or the, the America that I see that the people have backed. This whole government, the corruption of it. You want these

people to come out and surrender to this kind of nonsense? 2 Okay. I tried very, very hard 3 yesterday with David, maybe not so much with you, as to 4 try to explain the predicament that I as a negotiator 5 was in. We went in last night and said look. 6 making some headway. And their position was -- when I 7 say their position, I'm talking the commanders. 8 9 commanders position --STEVE: Who -- John, who's in control here? 10 Who -- what's the person? What agency, what human 11 being over there has the final say. Ultimately 12 somebody says no, we're not going to do it this way 13 anymore or yes, we are. Who is it? 14 It's a conglomeration of commanders JOHN: 15 from different --16 Commanders of what? 17 STEVE: Commanders. JOHN: 18 STEVE: Are you talking about the military? 19 Well, I don't know about the military 20 Don't -- we can't use military in an operation 21 per se. like that. That's called posse comitatus. 22 there's no military per se. But you got, you got our 23 commanders from different offices. You got Washington. 24 STEVE: You mean to tell me you guys got --25 You got Justice Department. JOHN:

1 -- you mean, you mean to tell me FBI 2 guys are actually they have the experience of being 3 able to operate these tanks and military --JOHN: 4 Yeah. They were --5 STEVE: -- vehicles. 6 They were trained for 2 days. 7 were trained for 2 days. Which could explain, you 8 know, some, perhaps some of the erratic movements of 9 the tank. But they were trained. But no, you can't -we can't use military. It's just against the law. 10 11 STEVE: Oh, that -- it's against the law for 12 you to --13 JOHN: Yes. It's called --14 STEVE: It seems --15 -- it's called posse comitatus. Wayne would know about that. You just use those words, 16 17 posse comitatus, and Wayne will tell you that you can't use military. It's just -- " 18 19 Well, it was against the Constitution 20 to have some kind of a federal police force like yourself and the ATF and doing the kind of things they 21 22 do. Rights, the rights of, of people have long eroded. 23 And there's no question that yours are going to be 24 eroding more and more. Everybody's are going to be. 25 Okay. happen this morning. We're going to -- the power will

And the lights last night. Do you know that 5 6 we've got these automatic lights that come on if there 7 is --8 JOHN: Yeah. 9 STEVE: -- dogs or anything moving around outside? They've been on since day one. Yesterday I 10 11 think -- was it yourself? 12 JOHN: Well, wait --STEVE: Or was it -- somebody, Max or you 13 14 called me all excited saying turn those off, or we're going to turn the electricity off. 15 I don't get too excited. 16 JOHN: 17 STEVE: It was Max that did that. Yeah, I don't get too excited. 18 JOHN: 19 STEVE: Called up saying turn those lights 20 off, or we'll turn them off for you. 21 JOHN: Well, Max --22 That was, that was the attitude. STEVE: 23 I said to him you do what you've got to do. I mean you 24 call me with a spirit and attitude like that, go ahead. Do what you've got to do. I mean if that's the way it's going to be after I mean one day you're trying to

work this out with me. I'm trying everything I can do.
Everything I can do.

JOHN: Okay.

STEVE: But I mean there's still people here that have -- they have their own minds, their own wills and choices. I can't go around telling them what to do or what they can't do. And they're -- they themselves are getting itchy. And it does not go very far with gaining any kind of a trust with and about you people. That's the thing I was trying to tell Max last night.

JOHN: Um-hum.

STEVE: I said it seemed like every time there we have about a day or so where it starts kind of calming down and people start doing some real -- that's what David tried to say yesterday. If you people would back off and leave these people just have a day or two or at least some time to think about what's going on, you might see some different choices.

STEVE: But wait, let me tell you. But these kind of tactics of turning out the electricity, digging down and the things that they're doing, whether you're in control or not, I mean that causes these people to want to stay in here all the more.

It doesn't make my job any easier. Max asked me to go talk to these people. I've been trying to get

interviews. I've been trying to lay out the issues. Give the positive, the negatives. But it makes the job 2 10 times harder with all the things that you're doing 3 on the outside. 4 Let me say that I appreciate exactly 5 what you're saying. But you got to understand over 6 here this is -- you have a direct chain of command. 7 And I put it like you on one end of a string with a can 8 and David on the other. You have a real easy chain of 9 command, because you go right to David. But by the 10 same token, you've got to wait for David's word, and 11 David's got to wait to hear the word from God. 12 I'm in the same situation. I've got to wait 13 down this chain of command to hear what the commanders 14 want done.
