UNIDENTIFIED FEMALE SPEAKER: Okay. Just a moment.

UNIDENTIFIED MALE SPEAKER: All right.

MR. KORESH: Sheriff Harwell?

SHERIFF HARWELL: Yes.

MR. KORESH: How you doing there, Buddy?

SHERIFF HARWELL: Is this Steve?

MR. KORESH: No, this is Dave.

SHERIFF HARWELL: Oh, Dave. I didn't -- I haven't talked to you that much that I recognized your voice readily. I'm sorry.

MR. KORESH: Steve's a better orator than I am.

SHERIFF HARWELL: Oh, you're, you're all right. I, I wanted to talk to you yesterday, David. Did Steve tell you I called and, and talked to him a while?

MR. KORESH: I'm not, I'm not really sure. I've been kind of, you know, separated from the people here for a while.

SHERIFF HARWELL: Yes. Well, I just came into the negotiating office here just a little while ago and I asked that I be permitted to talk to you. I called out yesterday afternoon to talk to you, David,

and I, I'm just so determined to, to try to get this thing resolved, David, as soon as --

MR. KORESH: Well, we -- so are we. Like, like, like you understand, Mr. Harwell, that, you know, our, our beliefs are very well established in --

SHERIFF HARWELL: Sure.

MR. KORESH: -- certain scriptures.

SHERIFF HARWELL: Sure. And I respect you for that.

MR. KORESH: And the thing of it is is that these men have done nothing but lie to us, they've misrepresented us. They're, they're doing their little thing and if, and if they want blood, then our blood is here for them to shed.

SHERIFF HARWELL: Well, let me, let me talk to you from, from the standpoint of just me and you, David.

MR. KORESH: Well, I don't really know if you have that much authority.

SHERIFF HARWELL: Let me -- yes, I do. This is my county. These are my folks. You're my folks.

MR. KORESH: I appreciate that.

SHERIFF HARWELL: I've always represented you. And I have the authority to sit down and try to work something out and ask these people to, to back off

or whatever is necessary to get this thing resolved, David. And you know I have that authority. I'm the sheriff of this county. I'm not a big shot or anything, I don't like to play that role, but sometimes we have to stand up for -- and do our job, and that's what I'm trying to do.

MR. KORESH: Okay.

SHERIFF HARWELL: And what I would like to do, really, I'd like to sit down and just talk face to face with you, because I think you and I have a mutual trust for each other, the, the kind of trust where we can sit down and talk.

MR. KORESH: You, you've always been good to us, I have to admit that. And we just had a little misunderstanding in '88, but, you know, that's, that's nothing. We got those things straight.

SHERIFF HARWELL: Well, those things happen, David. We, we can always live tomorrow and forgive and forget on those kind of things. But this is one of those things we need to get resolved and start moving toward that same circumstance. I've talked to all these people for the last two weeks, David, about your property out there and how much I've always respected it. And even after this is over, it's going to still be you all's property.

MR. KORESH: Well they've already torn up our motorcycles, they've torn up sheds and buildings with property in it. And, you know, we, we've already seen --

SHERIFF HARWELL: Well, I regret that, David. That didn't --

MR. KORESH: You know, we've seen what they've done. And, like I say, now, our flag is flying. We stand under God and this nation, and, like I say, when they came here, you know, I was at the front door. I opened the front door, you know, I was halfway out the door.

SHERIFF HARWELL: Sure, I know that.

MR. KORESH: And when that, and when that -- of course, I heard on the radio that one of the ATF agents said that his, that his pistol fired by accident, but, you know, I, I, I can't, I can't afford to stand and talk to, to, to people that are firing at me. And so, you know --

SHERIFF HARWELL: Sure.

MR. KORESH: -- I --

SHERIFF HARWELL: David, let me assure you that when this thing is, is ended, and it has to come to an end at some time, I don't -- I would like to see it end today, I really would, because we can start

doing some things and, and providing you all with attorneys. In fact, you've got attorneys already waiting to, to work with some of you. We can provide you everything, so that your, your side of this story is going to be told. It was that way before, when all these -- that incident happened, where you, you went through the system and you won, you walked out. You go back to your, to your facilities out there and you go on with your life.

MR. KORESH: That was a really strange thing, because, like I say, they kept that going two weeks when it should have been resolved in three days, but --

SHERIFF HARWELL: Well, you see what I'm talking about, David, is you and I are still going to be here in the county when most of these folks are gone. As dedicated as these folks have been in talking to you here --

MR. KORESH: You know they, you know they cut off all negotiations with us? Everything was going fine, everything -- they even called -- they sent us a tape. You should see this tape.

SHERIFF HARWELL: Yes.

MR. KORESH: And then, all of a sudden, the lights went off what, at 11:00, Steve? That night. And it was John Cox was talking to, right?

SHERIFF HARWELL: Yes.

MR. KORESH: And so we called back up and says well, what's going on? And, and, all of a sudden, everything just changed. They just -- they were very abrupt, they were just like well, the generals -- no, the commanders, the commanders have decided that you're not acting fast enough. And, you know, the thing of it is is that after that, it's just been cold. They haven't called us or nothing and they never sent us the magazines they promised. It's just -- everything -- And they started putting these lights up and some of the guys are wanting to shoot these lights out. And, you know, and I says --

SHERIFF HARWELL: Well --

MR. KORESH: And I says no, don't shoot the lights out, just, you know, just, just let these people do what they want to do and, you know, it's in God's hands now.

SHERIFF HARWELL: You and I have enough old hard sense to sit down, David, good old common sense to sit down and talk. I would -- I told the folks here I've always trusted David enough and the folks out there that if you told me to come out there and sit down and talk to you and everything would be all right, and I would do it because I, I trust you to that

extent.

MR. KORESH: Well, I don't --

SHERIFF HARWELL: And I do right now.

MR. KORESH: I don't mind you coming to visit.

SHERIFF HARWELL: Well --

MR. KORESH: We'd like to see a happy face some time.

SHERIFF HARWELL: What I would like to do, and if this is -- I haven't talked to everyone to be sure that this can be done, cause -- and I know I can do it, but I, I would like to come out there and meet you at the gate. Just sit down and talk.

MR. KORESH: Well, I, I --

SHERIFF HARWELL: With every assurance that everything would be -- when we'd get through talking --

MR. KORESH: I wouldn't come to the gate. And the thing of it is is, like I say, you know, if that kind of mutual trust is to be established, like I say, we've asked for doctors, we've asked -- we've got a couple women here that are pregnant and, and, and Ayeesha's going to have a baby here, you know, some time this month. And --

SHERIFF HARWELL: Well understand, David, that I haven't been familiar, and I haven't been aware

of all the things that you all have talked about.

MR. KORESH: Oh, well, they, they don't tell nothing --

SHERIFF HARWELL: Well, it's, it's not because they weren't -- they didn't put confidence in me to tell me. I've had a, a department to run here.

MR. KORESH: Oh, yeah, I understand.

SHERIFF HARWELL: And we've had so many things to do that I -- even yesterday evening, after I talked to Steve and told him I wanted to talk to you, I had to leave just shortly thereafter, and I didn't know whether you had called back or whether anyone had called back to talk to me. So I have a lot of responsibilities to take care of other than, than doing this. I'm just working hard to get this thing resolved. I even talked to the Governor a little while ago. She's said to, to everybody sit down and talk common sense and get this thing over with so that no one else would get hurt.

MR. KORESH: Our position right now is we're, we're fixing to tell these guys to get off our property and go home and we'll work this out ourselves. I mean, you know, we are not afraid of the government. Like I say, if we have to die for what we stand for, we're going to. We're not going to commit suicide.

You know, it's kind of like --

SHERIFF HARWELL: David, I know that. I know you --

MR. KORESH: -- when, when you're, when you're a little kid and you walk into school, mind your own business, and the bullies come up and want your quarter. You know, they came here all decked out, dressed fine --

SHERIFF HARWELL: No one wants to hurt --

MR. KORESH: -- and for two weeks, two weeks of -- Sheriff Harwell, for two weeks -- excuse me, two months we worked with Robert Gonzalez. When the ATF agents moved in across the street, you know, when they first moved in?

SHERIFF HARWELL: Yeah.

MR. KORESH: We went over there, we made the first steps. He, he -- I was going to allow him to come and live with us. He wanted to come and stay for two weeks with the guys here, you know, to get more Bible studies?

SHERIFF HARWELL: Yes.

MR. KORESH: And I kept telling over and over again, you know, I says look, you know, you want to come here and you want to learn this book, you'll learn everything there is to know about me and about these

people. You know, we can give him a tour around the place, you know. But the fact of the weapons, we told him we had weapons. You know, he comes over and says well, I have this -- he brought this pistol over.

SHERIFF HARWELL: Yeah.

MR. KORESH: Robert Gonzalez did. And he says well, I had this thing worked at the factory and when it came back, he says, I fired it and all the rounds fired. And I go what do you think is wrong with that?

SHERIFF HARWELL: Sure.

MR. KORESH: And I told him, I says hey, I says, you better get that thing fixed, that's illegal. And I told him about the incident where we bought that hell fire System and that it was out in the back, you know, firing with the hell fire system. Little spring thing goes on the trigger --

SHERIFF HARWELL: Um-hum.

MR. KORESH: -- and people reported that we had an automatic machine gun. And I told him, I says well, you know, Paul -- I sent Paul down there and he gave it to you all and everything and, and it says right there in the packet ATF regulation says that it's legal.

SHERIFF HARWELL: Yeah.

MR. KORESH: You know, and, and --

SHERIFF HARWELL: But, David, that's all in the past. You and I are going to have time probably to sit down and visit some. And I want to sit down and visit with you, but right now you were talking about the lady being pregnant, going to deliver some time, and I'm, I'm not totally familiar with all the injuries out there. I understand you've been injured and there are several other injuries out there that need attention.

MR. KORESH: Um-hum.

SHERIFF HARWELL: And I'm, I'm -- straight from the heart, I'm worried about you folks and you all's well being. I, I --

MR. KORESH: The FBI, in the beginning, we, we called them up and we told them to come and take their wounded. We were concerned.

SHERIFF HARWELL: Sure.

MR. KORESH: And we let them come here, and they did come in the building to take one of the guys out. They said they didn't, but that's a lie.

SHERIFF HARWELL: Yeah, that was the ATF.

MR. KORESH: No one fired on them.

SHERIFF HARWELL: Yeah, that was ATF people. Yeah, yeah.

MR. KORESH: Yeah, the ATF, right.

SHERIFF HARWELL: Yeah, it wasn't the FBI.

MR. KORESH: We, we -- you know, there was a couple of guys, two or three guys, that were held up here, guys had them, you know, held up.

SHERIFF HARWELL: Well, that showed a compassionate thing on you all's side.

MR. KORESH: (Indiscernible) to get hurt --

SHERIFF HARWELL: David, that's all going to be good in, in any proceedings after this comes out.

MR. KORESH: Ohhhh. Yeah, but
(indiscernible) --

SHERIFF HARWELL: You see, you've got a lot of things working for you on this thing, if we can get you in a position where you can voice what's happened and, and have a chance to let people know what's happened --

MR. KORESH: Well --

SHERIFF HARWELL: -- from your standpoint.

MR. KORESH: People are watching.

SHERIFF HARWELL: Sure.

MR. KORESH: They slandered me on the radio, the newspapers slandered me.

SHERIFF HARWELL: Well, they've slandered me on the radio and all of us somewhat, David. I'm not

concerned about the radicals out here who are doing things like that. What I'm concerned about is David, Steve, all you folks out there who I've known as our citizens here. And, and we've always -- let me ask you, David, just straight out, man to man, what can we do right this minute to get things moving so we can get this thing maybe resolved today?

MR. KORESH: Well, you --

SHERIFF HARWELL: What, what --

MR. KORESH: You can tell these agents that if they want to come in here, we're here to fight back. Like I said, I don't mind if I die, you know --

SHERIFF HARWELL: Well, I mind if you die, David. I, I mind.

MR. KORESH: Any time Big Brother stands up and pushes me, I'm going to push back. That's --

SHERIFF HARWELL: Yeah.

MR. KORESH: Just like in 1988, I went down and asked you gentlemen for assistance 'cause George Rodin had pushed some old people off his property. Sheriff Dickerson -- I would have never -- I didn't even have a gun till that time. Sheriff Dickerson told me when, when I brought those pictures back, he said now, boys, be careful 'cause -- he told me to come back and get some more pictures of the casket. He said now,

boys, be careful, there's some dangerous customers out there.

SHERIFF HARWELL: Yeah, we were concerned about your well being.

MR. KORESH: Right. And so, and so when we brought the weapons on, it was only for a diversion. And that day that that battle took place -- this is the honest to God truth, Sheriff Harwell. That day everyone that fired was firing in the ground. The only one who fired towards George is me, and that was only because I was pushed in the corner to do so.

SHERIFF HARWELL: Sure.

MR. KORESH: See, George was firing at Stan and Floyd, who was, who was out in the open, behind that old burnt down foundation.

SHERIFF HARWELL: Um-hum.

MR. KORESH: That's the only way I could keep him behind that tree. But I did not fire at him, I fired at the tree.

SHERIFF HARWELL: And you got that all cleared up and you walked out of the courtroom a free man, to walk right back out into your facilities, David, and I wouldn't be a bit surprised if maybe that won't happen on this occasion. I don't know.

MR. KORESH: It should.

SHERIFF HARWELL: I couldn't tell you it will because I won't lie to you. I won't tell -- and I'm not skilled in, in the legal aspects of this, but I'll tell you this, that anything that I have, have control over, and I'm sure that being a citizen of McLennan County and this all happening in McLennan County, if there's any confinement or anything, it will be in, in our facilities here. And you're going to be treated just as courteously as we treated you before. You, you know that we're not mean folks.

MR KORESH: (Indiscernible)

SHERIFF HARWELL: We're humane in what we do. By the way, let me tell you about something I did yesterday with your neighbors out there. I met with a group of folks out at Elk. We met in the community center out there.

MR. KORESH: Uh-huh.

SHERIFF HARWELL: And, of course, they were concerned about -- you all been good neighbors to, to all of them out there. They haven't had any problems and --

MR. KORESH: We never had any problems.

SHERIFF HARWELL: -- and they spoke highly of the, of the living around out there and not bothering anybody. And, of course, I was real impressed. They

were concerned about their well being and what's happening. David, a lot of them out there, you know, they're farmers and cattle ranchers and what have you, and this is kind of interfering their -- interfering with their going on about their lives and, and making their livelihood out there, working their places and taking care of the stock. Those people are going to be available to talk about you all's neighborly existence out there. They have not -- not a one spoke up that I recall who had anything derogatory about your being there.

MR. KORESH: Have you talked to Mr. Perry yet?

SHERIFF HARWELL: Beg your pardon?

MR. KORESH: Have you talked to Mr. Perry, our next door neighbor?

SHERIFF HARWELL: I haven't talk to him myself, personally. I don't know whether he was out there, but there were about 120 people out there, and they all expressed the thoughts that you all were peaceful, you didn't bother anyone, they weren't afraid to drive up there on the road. They just didn't have anything bad to say about you. And, like I've always told you, I wasn't afraid to come out and visit with you. If I called you and told you I was coming, David,

I'd be treated just as nice.

MR. KORESH: If you all had called us up and said you had a warrant for us, I'd have met you in town.

SHERIFF HARWELL: David, I wish I'd -- we're talking hindsight now. I've, I've laid awake thinking about that and worrying about it.

MR. KORESH: Well, I've asked (indiscernible) Robert Gonzalez to call me because I wanted to give him a straight man-to-man talk, because I told him over and over and over again. See they wanted this, they wanted this. They wanted, they wanted some big --

SHERIFF HARWELL: Well, see, you've got me at a disadvantage because I don't -- I wasn't involved in any of the meetings. I, I don't know anything that preceded this. David, the only thing I can tell you is that I'm deeply involved from the standpoint of being your sheriff.

MR. KORESH: Right.

SHERIFF HARWELL: And I want to do everything I can. It's my job to protect life and property in this county, and it's my job to protect your life and property. It's my job to work with, with everyone, and I want to see this -- if I can, nothing would make me happier and a lot of folks out here in this county who

would be just tickled to death to see everyone come out of this and just -- let's sit down like people, communicate with each other, get this thing behind us, because I'll tell you, David, straightforward, the only times I've heard anything that would be contrary to you folks out there is the last few days some people are getting a little bit hesitant to think well, are they sincere in what they're doing? Do they really want to come out and, and resolve this thing in a logical reasonable way, through the court system, through the system that will protect you? And this is what I want to do. My job is to try to handle this thing, as the sheriff of this county, get everything resolved and get you folks back to your, to your lives. If, if you're confined, I can't tell you that, David. You've made -- I can't tell you the outcome of this thing. But I know this, that the outcome right now, as it stands right now, just don't look good. It's, it's -- I'm talking about from the standpoint of any of us. From all over the country, people are talking about this and wondering why in the world can't those folks get this thing settled?

MR. KORESH: Yeah, why can't the FBI get this thing settled?

SHERIFF HARWELL: Well, let me ask you, what

can I do? What can I do? You tell me what I can do and I'll, I'll do everything that I've got the authority to do, just about what I need to do to get this resolved. You tell me, because I'm not smart enough to figure this out, David. I'm just an old dumb country sheriff in a lot of ways.

MR. KORESH: Well, that ain't true.

SHERIFF HARWELL: I don't, I don't sit and try to compete. But all I know to do is talk to you straight from the heart, David, and I'm interested in everybody's best interest and I want to get this thing resolved. So if you will tell me, and I'm asking for your advice, I'm, I'm pleading for your advice, tell me what I can do.

MR. KORESH: Well, Sheriff Harwell, this, this originates overseas. What we believe this is is it originates overseas. Now, let me, let me try to explain just very simply, all right? As you know, you know, Lois Roden -- remember Lois?

SHERIFF HARWELL: Yes, I sure do.

MR. KORESH: See, she taught the Holy Spirit being female as a message.

SHERIFF HARWELL: Yes.

MR. KORESH: Remember that?

SHERIFF HARWELL: Um-hum.

MR. KORESH: Now, every Jewish scholar will tell you that's, that's the way it is. That's just the ancient concept of the Elohim. Now, but not to get into that, now, what I teach is I teach the Seven Seals. And I'm not trying to convert you, I'm just trying to give you a layout.

SHERIFF HARWELL: No, and I started to tell you, David, I don't want to be rude to you at all and never would I be rude to you.

MR. KORESH: Right.

SHERIFF HARWELL: Again I'm talking straight. You know I'm a, I'm a straight-shooting old fellow.

MR. KORESH: Okay.

SHERIFF HARWELL: If I -- I, I really want to get this thing resolved and let me have an opportunity to sit down with you later on, just me and you sit down, and I'll, I'll sit and talk with you. But, but right now my main interest is to get this thing --

MR. KORESH: This is where the foundation becomes resolved, okay?

SHERIFF HARWELL: Well, then --

MR. KORESH: You see -- Let me, let me explain again.

SHERIFF HARWELL: All right.

MR. KORESH: It's a political thing.

SHERIFF HARWELL: All right.

MR. KORESH: It's a political thing. You see, in all the denominations of this great nation, you know, our Constitution, our forefathers foresaw, based upon the experience of the ancient European tyrannies -- you see, used to -- the church used to have control of the government, the Papacy.

SHERIFF HARWELL: Yes.

MR. KORESH: You see, and, and the voices, Hush and Jerome, Tenda, Weinert, they were men who, who had scholarly minds, who were reading the Bible, which was, you know, the Vulgate and the manuscripts of old, and they said hey, wait a minute, the scriptures teach contrary to what the Papacy institutes. Well, when they rose their voice, the Papacy killed them. Okay, so, you know, they, they kept the freedom of speech, it just did not exist in those days.

SHERIFF HARWELL: Um-hum.

MR. KORESH: But, finally, when God arose this nation and men began to come -- they began to realize the importance that now under -- now no longer under the yoke of the Papacy, which is religious political government, you understand? They realized the importance to protect every man's right to believe in conscience, not just for religion, but even in --

against religion. So church and state separation was, was declared. The state would be a political state for individuals, irrespective of color or creed or, or religious beliefs. But, nonetheless, the state was not to interfere with those religions who had religious conviction or freedom of conscience. Okay. So now we've got all the -- we've got, we've got the Papacy, we've got the Catholics, the Lutherans, the Presbyterians, Methodist, Baptist, you know, Church of Christ, Church of God, Armstrong, and everyone has these different viewpoints, and that's perfectly all right.

SHERIFF HARWELL: Sure, sure. I respect that.

MR. KORESH: Based -- exactly. Based upon the good old four-square gospel, Matthew, Mark, Luke and John.

SHERIFF HARWELL: I respect everyone's right to, to worship and, and have their faith and to -- but back --

MR. KORESH: Now, but here, here's the point I need to make. Here's, here's the concrete point. Now, when it comes down to the Book of Revelation, very clearly in Revelation 4 and 5, John the Apos -- now, we know John was an Apostle, don't we?

SHERIFF HARWELL: Yes, but here -- let me, let me interrupt you again, David. You're talking -- I'm not scholarly, I'm just plain down to earth old folks and I, I would enjoy sitting down -- but what I, what I wanted to do, David, is is -- you see, you're going to have an opportunity, after this is resolved, I'm going to see that you have an opportunity to talk to the press --

MR. KORESH: These FBI agents have lied to us since day one.

SHERIFF HARWELL: Well, take them out of it. You're going to be here with me. They're going to be gone when this thing is resolved and, and we're going to still be living here in McLennan County. If I give you my word that you will have access for a news conference or access to -- and when I say a news conference, you're going to have access to the media and you'll have a chance down through the months. You're going to have a telephone available to you there in jail, if you stay there. You might bond out, I don't know. But you're going to have a chance to talk to folks, David, when this is over. You're not going to come out and just be cut off from the world. And these things need to be looked at after we get this resolved, but we need to get this over so that we can

look at what we can do. I can't promise you everything that I'm talking -- but I'll tell you this, I'll give you my best effort and --

MR. KORESH: Well, I understand --

SHERIFF HARWELL: -- I promise you that.

MR. KORESH: Like I say, I understand --

SHERIFF HARWELL: But we need to get this -- This is a pretty good day and we need to get this resolved. And I asked you a while ago what -- give me some idea, give me your input on what we need to do.

MR. KORESH: Well, like I say, there's people here that were going to come out. Me, I'm waiting on God. I've been told to do so. I teach the Seven Seals. Read Revelation 4 and 5, you might get an insight on what that may mean. But here's the thing. I know you don't want to talk religion, but that's all I am is religion (indiscernible). I have -- as an American citizen, somebody has stepped on my property, destroyed my property, and there's going to be some butt whooped over this.

SHERIFF HARWELL: You, you have to do it --

MR. KORESH: It's either my butt or it's going to be their butt. Now, they're here and they've flaunted the right arm of their strength and they've stood underneath my -- my flag's flying out here.

SHERIFF HARWELL: Why don't you whip butt in court, David, or in the legal process?

MR. KORESH: Now, let me tell you something.

SHERIFF HARWELL: That's the way you're going to be heard.

MR. KORESH: Now, wait a minute.

SHERIFF HARWELL: Not, not the other way. About these other people who wanted to come out, I didn't know about that, David, but --

MR. KORESH: Well, you --

SHERIFF HARWELL: Are there some other people who want to come out now?

MR. KORESH: Sheriff Harwell, there were people ready to come out. It's just -- Jim told us and one of the guys told us that at nighttime we would, we would finish it up in the morning. Now, now, now, John Cox, he waited five hours to call us from the time that Ollie was released. What's going on now?

SHERIFF HARWELL: Nothing. I'm just sitting here listening, because I'm unaware of all --

MR. KORESH: Now, now, they've just knocked down the fence. Now there's cows coming on our property now.

SHERIFF HARWELL: Who knocked down your fence?

MR. KORESH: The FBI agents over here.

SHERIFF HARWELL: Oh, my goodness. David, I'd give anything if --

MR. KORESH: I'm telling you the truth of what they're doing.

SHERIFF HARWELL: Well --

MR. KORESH: They promised us they would not come on the property, they would stay on the perimeter, and, and here they are, they come all over our property, by our lake. Everything they tell us, they've lied about.

SHERIFF HARWELL: Well, I, I --

MR. KORESH: And all they do is broadcast on the phone things that we don't say. They're making it sound like oh, honky dorey. The last two days there's been no negotiations, right, Steve? Anyway, what happened was is that that night everything was smooth. They sent us a tape. We got to see the picture of the, of the negotiators. They showed us pictures of the family and all that. We were making tapes for them. You know, the other two guys were going to come out. Other people were talking about it. They were waiting for Ollie to call back. Ollie never called back. Ollie was taken --

SHERIFF HARWELL: You're talking about Ollie,

now, he's the young man --

MR. KORESH: Oliver. Yeah, the one that they have now.

SHERIFF HARWELL: -- who came out? See, I'm not familiar with some of these things.

MR. KORESH: Right. He never called back that night. And, also, at eleven o'clock our lights were taken off. So, you know, we thought well, it might be just a fuse from the weather or something.

SHERIFF HARWELL: Well, did you talk to Ollie or have you talked to him since he's been out?

MR. KORESH: Well, let me explain what happened then.

SHERIFF HARWELL: All right.

MR. KORESH: So Steve -- I told Steve well, call John Knox up and, and we'll get this worked out. Steve called up John Knox and, all of a sudden, it was just cold. Well, matter of fact, here, let me, let me let Steve tell you real quick what --

SHERIFF HARWELL: No. Let me, let me go ahead and talk to you for a little while, David, on this because I think me and you --

MR. KORESH: No we've still got to catch up our worship here, but the thing of it is is that --

SHERIFF HARWELL: I think you and I can work

this thing out, David, if we'll just keep talking to each other.

MR. KORESH: Sure, we're going to work it out. But the thing of it is is that these guys don't scare me. I'm not afraid of their tanks, I'm not afraid of their --

SHERIFF HARWELL: I don't want to dispute you. Let me, let me do this. You tell me what we need to do to get this thing moving in the right direction, to get this thing resolved, whatever we need to do. And, like I say, I'm the sheriff of this county, I have some authority on what's going on.

MR. KORESH: Well, you tell these people to pack up, get out of here and leave us alone and let us have time to think --

SHERIFF HARWELL: Well, I can't tell them just to leave and set on it, now, David, I, I have to be honest with you.

MR. KORESH: Okay, well --

SHERIFF HARWELL: Can me and you meet or, or if not you and me, can Steve come out and talk to us?

MR. KORESH: Well, I'll tell you what. If Steve does decide to come out --

SHERIFF HARWELL: I don't mean leave. If he will just meet us. If he does decide to come out, I,

I'd want you to know about it. We wouldn't pull any tricks. I wouldn't come out there and tell you --

MR. KORESH: Well --

SHERIFF HARWELL: -- to let Steve come out and we take him. But if he'll meet us at the gate --

MR. KORESH: Here's where the deal stands. If Steve does come out and talk to you at the gate, okay?

SHERIFF HARWELL: Yeah.

MR. KORESH: And any foul play is done --

SHERIFF HARWELL: I give you my word --

MR. KORESH: -- then all these guys around here better get ready for --

SHERIFF HARWELL: David, I don't even carry a gun. I, I haven't carried a gun in years.

MR. KORESH: We don't mind if you carry, if you carry a gun. We're not, you know, we know you know how to use it. You, you wouldn't have came here and, and, and shot up our doors --

SHERIFF HARWELL: No, no.

MR. KORESH: -- and walls and all that with automatic -- what'd they have, Ouzis?

SHERIFF HARWELL: Let me assure you and I'll give you my word as solid as I ever gave it to anybody, there will be no tricks. If I give you my word -- you

see, I'm going to trust you like I want you to trust me.

MR. KORESH: Well, you can trust us.

SHERIFF HARWELL: I know it. That's why I'm willing to come out there. Do you think I would come to that gate if I didn't trust you?

MR. KORESH: Well, Sheriff Harwell, have we ever really given anybody any problems?

SHERIFF HARWELL: No. Your neighbors -- I was just telling you about your neighbors a while ago, having a meeting with them.

MR. KORESH: Mark -- what's Mark's name over there? Mark, Mark Spoon over here, we've loved him. He's been right across the street from us.

SHERIFF HARWELL: David, your neighbors out there all yesterday. You know, I was telling you a while ago they all said that you all have been good neighbors, they've not had any problems. What I would like to do, David, just to show you my good faith and what I'm trying to do, let me meet with Steve. I know you've got a physical problem where it would be difficult --

MR. KORESH: It's hard for me to get around, that's true.

SHERIFF HARWELL: Yeah.

MR. KORESH: I'm sure you --

SHERIFF HARWELL: Let me meet with Steve this afternoon, say, about four o'clock out at the gate.

MR. KORESH: Okay. Well --

SHERIFF HARWELL: Would that be all right?

MR. KORESH: -- let me let you talk to him and we'll work this out, all right?

SHERIFF HARWELL: Beg your pardon?

MR. KORESH: Let me let you talk to him and we'll work it out, okay?

SHERIFF HARWELL: All right, all right.

MR. KORESH: Okay. Nice talking with you.

SHERIFF HARWELL: You bet, David. Listen --

MR. KORESH: Thanks for calling.

SHERIFF HARWELL: Listen, let me tell you again, David, let me tell you again how serious I am. I care about you all.

MR. KORESH: Oh, I believe that.

SHERIFF HARWELL: And, and, believe me, trust me, and let me work on these other folks out here, see if we can get this thing resolved and let me work with them to do whatever we need to do in the way of the show of force and all that. I think we can resolve some of that if it will be favorable.

MR. KORESH: Well, we're not afraid of these

old tin cans out here. I mean, you know --

SHERIFF HARWELL: Well, yeah, I -- but can me and you keep talking, David?

MR. KORESH: Sure, we'll talk.

SHERIFF HARWELL: Will that be all right, for me to sit and talk with you? I'm not a negotiator, I'm just one who can just sit and talk to you and try to talk common sense.

MR. KORESH: I'd rather talk to you with a fishing pole in my hand, but that never materialized.

SHERIFF HARWELL: Well, let me talk to Steve and see if we can work it out. Now, like I say, I trust you and I trust your folks out there that I will come to the gate.

MR. KORESH: Okey doke.

SHERIFF HARWELL: Now, if I sound a little loud, Steve -- I mean David -- that's the way I talk. So don't think my, my tone of voice is something that's sounding --

MR. KORESH: There's a lot of pressures around here.

SHERIFF HARWELL: And I've been through a lot of pressure, trying to get this thing resolved without any of your folks or anyone else getting hurt. So let me keep on a talking basis with you and let's try to

use some old horse sense and work this thing out.

MR. KORESH: Okey doke. Well, here's Steve.

SHERIFF HARWELL: I appreciate it.

MR. KORESH: I know.

SHERIFF HARWELL: Bye.

MR. SCHNEIDER: Hello, Mr. Harwell?

SHERIFF HARWELL: Hello, Steve.

MR. SCHNEIDER: How you doing?

SHERIFF HARWELL: I'm pretty good. I had to leave early yesterday evening, after I talked to you.

MR. SCHNEIDER: Right.

SHERIFF HARWELL: And I didn't know whether you all had called back or not, so I came back up earlier, just a little while ago, and asked them to let me check back with you all.

MR. SCHNEIDER: Okay.

SHERIFF HARWELL: Let me ask you, Steve, people can do more looking at each other and just talking eye to eye, and I would like to come out and just meet you at the gate there, just sit and talk with you a while. I talked to David about this and he was in agreement with it and told me to talk to you and see what we could work out.

MR. SCHNEIDER: Um-hum.

SHERIFF HARWELL: And I'd like to work

something out where you, you and I could meet there at the gate. Might be one of the negotiators with me, but I assure you there will be no tricks, nothing, 'cause I'm trusting you, trusting David, and I want you all to trust us. And is there a way we could just sit down and talk eye to eye, so you can see my sincerity?

MR. SCHNEIDER: Well, sure.

SHERIFF HARWELL: So we could get a feel of what we're talking about?

MR. SCHNEIDER: I'd be willing to do anything that would help, you know, bring this to a better relationship.

SHERIFF HARWELL: Let me assure you we're not out there to pull any tricks. You'll be free to walk back in when you get ready. If you get upset at us in talking to us, we will be just straight with each other.

MR. SCHNEIDER: Okay.

SHERIFF HARWELL: And not, not pull back any, any effort whatsoever to get this thing resolved. And if we can do that, Steve, maybe we can make some progress. I -- we need to do something. We need to get this thing over, so let's try to work something out. I haven't made any arrangements for this. I need to get some folks here to make arrangements.

MR. SCHNEIDER: Okay.

SHERIFF HARWELL: Now, it might be me and Byron or one of the negotiators come out.

MR. SCHNEIDER: Byron was the first man I spoke with.

SHERIFF HARWELL: Yes. Byron's a fine man and if he -- and I trust him totally. I want you to trust us now.

MR. SCHNEIDER: Yes. Okay. If they wanted to send one, I really did like John Dolan. I mean, we got along very well.

SHERIFF HARWELL: He's -- I think he left, went back home, Steve.

MR. SCHNEIDER: Oh, he did? That's a shame because, you know, it was through him that the momentum was really picking up quickly --

SHERIFF HARWELL: Yeah.

MR. SCHNEIDER: -- and there was a real trust that was developed.

SHERIFF HARWELL: Well, Byron's been here through all this time and he's still here and he's familiar with -- he knows more about this.

MR. SCHNEIDER: Okay.

SHERIFF HARWELL: I'm not familiar with all of it, Steve, so --

MR. SCHNEIDER: That'd be fine. I saw him on the video. That'd be all right.

SHERIFF HARWELL: That's why I want to bring one who is familiar with all of it, because you might ask me some questions, 'cause, you see, I've got a department to run and I'm not here all the time to hear everything that has happened. So there may be some questions you would want to ask that I wouldn't have the answer to. If Byron would be with me, where he can -- we want to talk straight. We want to talk honest.

MR. SCHNEIDER: Let me just say this. The way the people -- to phrase it in a, in a -- just a statement or two, the way the people have seen what has happened is right to our face there was a handshake, there was friendliness, there was a look of sincerity. But on behind the back, there was nothing but total encroachment and, and a push and a shove when we were looking forward.

SHERIFF HARWELL: Steve, you all can look at my record here in McLennan County.

MR. SCHNEIDER: Right.

SHERIFF HARWELL: I've been sheriff for over 20 years and I don't think you've ever heard of anything like that from me. I've always been just one

to talk straight to people --

MR. SCHNEIDER: Right.

SHERIFF HARWELL: -- try to resolve problems in a simple sort of way, if we can, do whatever to get things back the way they should be so we can all live and go on with life. And I appreciate you for meeting us out there.

MR. SCHNEIDER: Right.

SHERIFF HARWELL: If I could let you talk with one of the other people here --

MR. SCHNEIDER: Well, you know, David himself has let me know, too, of the concern of the people about the freezers, refrigerators being cut off, all the food going bad.

SHERIFF HARWELL: Yeah.

MR. SCHNEIDER: He mentioned the (indiscernible) --

SHERIFF HARWELL: Well, maybe we can talk about that when we come out there and set and talk with you.

MR. SCHNEIDER: All right. When are you -- What, what time are you looking for? Say, today, tomorrow ?

SHERIFF HARWELL: Say at four o'clock. At four o'clock.

MR. SCHNEIDER: Four o'clock?

SHERIFF HARWELL: Yes.

MR. SCHNEIDER: As soon as that?

SHERIFF HARWELL: Yes. And what they're going to do now probably is --

MR. SCHNEIDER: Well, how, how about something like this. That you and, that you and Byron meet me about halfway down the driveway. I walk up halfway, we both walk toward each other and about -- or by that -- yeah, about halfway there.

SHERIFF HARWELL: Let me see. Let me talk to Byron and be sure he's --

MR. SCHNEIDER: All right.

SHERIFF HARWELL: Hold on just a moment. Let me -- Byron, I need to locate Byron, be sure that he's in agreement 'cause I don't want to --

MR. SCHNEIDER: All right.

SHERIFF HARWELL: -- I don't want to pull any -- tell you we'll do something and then it not work that way, Steve.

MR. SCHNEIDER: Okay. Okay.

[gap]

(Voices in background not discernible.)

SHERIFF HARWELL: Steve?

MR. SCHNEIDER: Yeah.

SHERIFF HARWELL: Let me, let me tell you what, what we need to do for this first meeting.

MR. SCHNEIDER: All right.

SHERIFF HARWELL: So that we'll all be comfortable with it. I'm comfortable, anyway we go but I want the other folks who are with me, Byron, to feel comfortable, too, Steve, because I'm talking for him.

MR. SCHNEIDER: All right.

SHERIFF HARWELL: What we would like to do is just pull down there in a Bradley. We'll get out of it. I'll step out where you can see me.

MR. SCHNEIDER: Okay.

SHERIFF HARWELL: And you come on out to the gate, because I've always respected you all's property out there. I don't want to be one to walk in on you all's property without, without proper authority or without a reasonable reason for being there. But if we work it that way, if we pull down in the Bradley, we'll get out and stand behind the Bradley. I'll step out where you can see me. Byron will be with me. You come out and whatever distance is comfortable with you, I'd like to just walk up and shake your hand myself and, and sit and talk eye to eye. Whatever distance is comfortable with you, if you feel comfortable to come on out, you'll be free to leave. If you get upset at

something we're saying and you want to go back,
whatever you feel like doing.

MR. SCHNEIDER: Would you -- so there would
be the two of you then?

SHERIFF HARWELL: Yes. There would be Byron,
because, you see, the reason I want Byron, Steve, is
because --

MR. SCHNEIDER: That's fine.

SHERIFF HARWELL: -- I haven't been here -- I
explained a while ago I haven't been here and I don't
know all the details.

MR. SCHNEIDER: I think -- would it be okay
if Wayne Martin would be with me?

SHERIFF HARWELL: That would be fine.

MR. SCHNEIDER: Okay.

SHERIFF HARWELL: That would be fine.

MR. SCHNEIDER: All right. Then let's --
About four o'clock then, huh?

SHERIFF HARWELL: At four o'clock.

MR. SCHNEIDER: All right.

SHERIFF HARWELL: What time is it now? I
said four, I want to be sure we've got time.

MR. SCHNEIDER: Okay, I have about 16 minutes
to 3.

SHERIFF HARWELL: I think we'll have time.

Be there at four.

MR. SCHNEIDER: All right.

SHERIFF HARWELL: We'll call you up when we start moving out there. Or wait a minute, let me be sure I'm right on this now, Steve.

MR. SCHNEIDER: All right. Okay, we'll --

SHERIFF HARWELL: Steve?

MR. SCHNEIDER: Yes.

SHERIFF HARWELL: As soon as we're out there, they'll call you from here and let you know we're out there. And when we see you come out of the building, I'll step out where you can see me.

MR. SCHNEIDER: Okay.

SHERIFF HARWELL: And then we'll, we'll meet at a distance that's comfortable with you all. If we can just walk straight up and shake each other's hand and, and stand and talk and, and do what we can, that's the way I would like to do it.

MR. SCHNEIDER: Okay.

SHERIFF HARWELL: And you all feel comfortable with us because I'm certainly going to feel comfortable with you all.

MR. SCHNEIDER: All right.

SHERIFF HARWELL: And, and believe me, trust

me.

MR. SCHNEIDER: Okay, we'll do that.

SHERIFF HARWELL: All right.

MR. SCHNEIDER: Okay, we'll -- I'll wait to hear from you.

SHERIFF HARWELL: They'll call you, Steve, when, when everything is worked out and when we get up there.

MR. SCHNEIDER: Okay, sounds good, Jack.

SHERIFF HARWELL: All right, Steve. Bye-bye.

MR. SCHNEIDER: Bye.

10 | response. He was very clear in what he had to say. I,
11 | I understood it and took it very well and I, you know,
12 | the very mood and the spirit of it all was, was good.
13 | I really thought it was. And I, I see -- I believe
14 | that he's a very genuine person, I really do. So, to
15 | me, you know, it did help, you know, and like I said,
16 | you know, the people were waiting to hear how it went
17 | and I could say really nothing negative about it.

18 | What I'm trying to work out with some of
19 | these people yet is their concern. See, it's not your
20 | agency. We've seen how you've stepped in and tried to
21 | right a wrong. I'm still trying to work it with Wayne
22 | and, and some of these people, and it'll go a long way
23 | to try and understand the workings of the ATF, what
24 | happened, what might happen, how it pertains to us, the
25 | movement, the court system. And it's helped, also, you
 | people explaining procedure to those people that have

1 | wanted to hear. I, I'm hearing more about it myself,
2 | you know, of course. So that's -- Right now I'm -- You
3 | know, getting to be more trust. I'm just trying to get
4 | those things out and the explanation of those things
5 | and how they work.

6 | But, you know, there still has been, of
7 | course, that concern with the other agency, how it came
8 | about. And, and like I was telling Byron, a lot of
9 | people have listened on the radios for -- There hasn't
10 | even been a mention of a reprimand of this agency or of
11 | some of those involved. Somebody has to take some
12 | responsibility and, and see how this happened. So, you
13 | know, we're talking about those things right now more
14 | than ever, and it seems like, you know, something's
15 | coming from it. So that's what I'm hoping for, you
16 | know, keeping on talking and discussing these things
17 | and it's like the ice is being broken again.

18 | JOHN: You know, Steve, I'm, I'm glad to hear
19 | you say that, and I hope Byron alleviated your
20 | concerns. Like I say, if he said he was going to check
21 | on those things, he meant it.

22 | STEVE: Yeah.

23 | JOHN: And I know that today he's been trying
24 | to do that.

25 | STEVE: Right.

 JOHN: And he's been trying to get some more

1 | information from you -- or for you.

2 | STEVE: Okay.

3 | JOHN: And how did the folks in there feel
4 | the meeting went, though, everybody else?

5 | STEVE: They thought it went, they thought it
6 | went pretty good from what they heard. We described
7 | things -- I went and talked to David about it. He had
8 | a smile. He liked Jack. I told him about Byron and he
9 | had a good response to that, too. He said now, Steve,
10 | you know, for the people that's fine, work with them,
11 | talk to them and encourage and all that. He said to me
12 | for himself, he says right now I'm still waiting. I've
13 | got to, he said. They can -- Whatever they need to do
14 | with me is fine, but he says I will -- I told them I
15 | would come out, and he says and I meant that. He says
16 | the only thing that has, has slowed me down was that,
17 | he says and pray to God one audible word, wait.

18 | And I says well, what's happening now? I
19 | asked him again and he said well, he's still doing
20 | that, he's looking at the Bible, he's waiting for that
21 | word or whatever. But for the rest, he says now, make
22 | it plain that, you know, you talk to them, anybody
23 | wants to, encourage, whatever. So that's why, you
24 | know, I'm working with them again. We're sitting down,
25 | we're talking about these things and there seems to be
 | a different -- a little bit different view again. More

1 | so like it was, like I said, last week. So --

2 | JOHN: So you think things are looking up in
3 | there as far as getting something done here, Steve?

4 | STEVE: Yeah, that's -- You know, today was
5 | one of the better days since -- In fact, it has been
6 | the best day since Friday. Friday, to me, was the best
7 | day of all, though, because, I mean, I really felt good
8 | about what was going on and, and I'm disappointed. I
9 | told Byron I, I kind of feel it was my fault that there
10 | was that five-hour gap Friday afternoon. That might
11 | have made a difference with whoever your bosses were.
12 | But, see, those three, they were coming out and they
13 | were waiting for the return call from Kathy and I, I
14 | just -- He said to me, John, you know, John Dolan, that
15 | he would be calling back in minutes.

16 | So I went away for just a couple minutes,
17 | came right back and waited, and nothing happened for a
18 | half hour. So I went away again and I came back about
19 | three hours later and picked up the phone. There was a
20 | dial tone, so I thought it was okay. I thought maybe
21 | they're working something else out, something, or
22 | whatever. But then when I saw the cooler -- Now, get
23 | this, John. When I saw the cooler sitting out by the
24 | tree, someone told me that they were out there, I
25 | thought well what? So that's when I went back right
away and called, and here Byron is -- A couple people

1 | told me that they had called 25 times.

2 | JOHN: Yeah.

3 | STEVE: Yeah, and I don't know that. So
4 | here, apparently, the ringer on my phone was not
5 | working.

6 | JOHN: I'm sure that that was a technical
7 | difficulty.

8 | STEVE: Yeah. Well, I, I kind of, I kind of
9 | -- If I had it to do over again, I would have checked
10 | the phone. I'd have called in to see if the problem,
11 | you know, if it was -- I never thought about it,
12 | really, but it was that evening at 11:15. And, of
13 | course, it was cut off and, all of a sudden, just a
14 | total change of, of mood, the attitude here, and I just
15 | -- I didn't know hardly what to do then, because I --
16 | Actually, I'd said a number of things, I'd stuck my
17 | neck out, and, all of a sudden -- And these people
18 | didn't want to go.

19 | Actually, I told Byron there were about 20,
20 | 30. I was not going to even say that until I actually
21 | had more substance, but I actually thought there might
22 | have been that many that were going to come out,
23 | seriously. And there were -- Three were going to go
24 | out Saturday and I really believed as many as that
25 | would have gone out either Saturday afternoon or
 | Sunday. And then when that happened, that whole

1 business, that's when -- All of a sudden, I mean, it
2 was like no one was really giving me the time of day.
3 It was like I had worked something out with these guys,
4 like John Dolan and, and either they pulled something
5 or I was involved or my perceptions were not any good,
6 from what I was hearing them say, but they wondered
7 about my ability to communicate and to hear, and to
8 also share what their concerns were.

9 JOHN: Steve, Byron said it was cold out
10 there, huh?

11 STEVE: Oh, John, I'm -- I mean, hey, I've
12 been in some northern winters. I mean, it gets cold.
13 But to have rain, you know, this wetness and the
14 dampness go through the clothes. I felt for poor Jack,
15 being an older man like that, having a flimsy jacket
16 on. Oh, yeah, even, you know, Byron himself was -- At
17 least I had a goose down kind of a parka on.

18 JOHN: Right.

19 STEVE: But, yeah, it was cold. The water
20 was dripping off our noses and, and it kept raining and
21 -- But we, we, we managed it for about an hour or so.

22 JOHN: Jack got mud all over his boots, I
23 know that.

24 STEVE: He mentioned that, huh?

25 JOHN: And the rest -- Oh, yeah.

STEVE: New boots. He was saying he might

1 | need a new pair now.

2 | JOHN: Yeah. But regarding that other stuff,
3 | the commanders did that. I hope you appreciate that,
4 | Steve, and it wasn't the negotiators. We're all
5 | concerned and we're all -- we all feel the same way.
6 | Byron does and we're all -- we all feel the same way
7 | here.

8 | STEVE: I believe that.

9 | JOHN: Okay.

10 | STEVE: I was always -- You know, I would
11 | have liked -- Too bad that John Dolan took off because,
12 | I mean, I, I did spend a, a number of days talking with
13 | him, but --

14 | JOHN: You know, he, he didn't take off, but
15 | he had something else going. And he wanted to stay,
16 | but --

17 | STEVE: Uh-huh. Well, you know, some time
18 | again, you know, one of these -- Some time soon here,
19 | you know, we're working away on this now, maybe there
20 | will be the possibility of speaking with him again,
21 | huh?

22 | JOHN: Yeah. You know --

23 | STEVE: What about --

24 | JOHN: -- you mentioned Friday was the, the
25 | best day yet. I think we could make today the best day
 | yet, too. You know what I mean? A better day if we

1 | can just get something going here. You had a question
2 | for Byron yesterday regarding some court hearings or
3 | something? I just --

4 | STEVE: Yeah. I think we were -- Also, both
5 | Wayne and I were concerned and wondering more about
6 | the, the sealed warrant. See, David, I was talking to
7 | him this morning again and he was saying why haven't
8 | they still let me know? He says don't they think
9 | that'd go a long way as to see what my response would
10 | be? He says to this day, I never -- I still don't know
11 | what they came to serve me with. He said I opened up
12 | the door, I looked out, and then he saw them charging
13 | with the guns, of course. And this is true.

14 | I mean, there were four people that were
15 | right behind him that witnessed this. Perry Jones, the
16 | older man, got it, in fact. He stepped -- First, he
17 | got shot in the leg, then he stepped back and he
18 | started crying, of course. He was an older guy. And
19 | he stepped back and then he got it in the stomach, and
20 | then finally, of course, he died. But they saw what
21 | happened. And David still said there was no paper --
22 | All he saw was a lot of guys rushing toward the door.
23 | So, but anyway, he's still -- That'd go a long way, to
24 | see well, what was it exactly? What was, what was he
25 | being charged with, what's the warrant? You know, he
 | had a few questions.

1 I think what I should do today, in the next
2 hour or so, is go sit down, if he's not sleeping, write
3 down a few things and, and a couple other questions and
4 hand them over to you guys. Maybe you can give me an
5 answer. I can go a lot quicker then.

6 JOHN: Well, you know, Steve, I was just
7 going to say that I think Byron has got some of this
8 stuff --

9 STEVE: Okay.

10 JOHN: -- answered for you.

11 STEVE: Okay.

12 JOHN: And there was something about the
13 court hearings being closed or things like that?

14 STEVE: Right.

15 JOHN: And I understand that there was an
16 open court hearing today regarding Kathy. So --

17 STEVE: Oh, really? How --

18 JOHN: Yeah.

19 STEVE: You know how that went then, John?

20 JOHN: I don't have the particulars on it. I
21 think it's going to be at, at 3:00 or -- It's going to
22 be held, but it is going to be open to the public, I
23 guess.

24 STEVE: Oh, it is?

25 JOHN: Yeah.

STEVE: Is there any way you could keep

1 | abreast on that for me, and I'll call you back? And
2 | then I'm going to take that -- That'll, that'll help a
3 | lot, too, to see what happens with that.

4 | JOHN: Okay. And you mentioned the press
5 | conference, also?

6 | STEVE: Yeah. I, I don't know anything about
7 | that. Are they only having one a day now or --

8 | JOHN: Yeah.

9 | STEVE: They are? Okay. In the morning, I
10 | guess?

11 | JOHN: You know, in the same usual time.

12 | STEVE: Ten thirty?

13 | JOHN: Right.

14 | STEVE: Okay.

15 | JOHN: But what I wanted to ask you was --

16 | STEVE: Sure.

17 | JOHN: -- I understand that Byron has got
18 | some, some answers to some questions here and I just
19 | wondered would you want to meet today?

20 | STEVE: It's possible, yeah. Is there any
21 | way I can call back?

22 | JOHN: Well, Steve, I'm here. Whenever you
23 | want to call, we're here.

24 | STEVE: Okay. Let me call you right back on
25 | that. It's more than likely so, in fact.

 JOHN: Steve, just -- If you could call back

1 fairly early, okay?

2 STEVE: Yeah, I'm not going to leave a lot of
3 time.

4 JOHN: Back to me because --

5 STEVE: When I say call back, I mean, you
6 know, pretty quick here, 'cause I know you're asking
7 the question now and they're probably available now.

8 JOHN: Yeah. Okay?

9 STEVE: The day is getting already on.

10 JOHN: That's right.

11 STEVE: Okay, I'll, I'll call you back.

12 JOHN: So we'll be here.

13 STEVE: Okay.

14 JOHN: All right.

15 STEVE: Talk to you in a bit. Bye.

16 JOHN: Bye.

17 * * * * *

18 (Telephone dialed and rings two times.)

19 UNIDENTIFIED FEMALE SPEAKER: Hello?

20 JOHN: Hello, is Steve there?

21 UNIDENTIFIED FEMALE SPEAKER: Just a minute.

22 [gap]

23 UNIDENTIFIED FEMALE SPEAKER: Hello?

24 JOHN: Yes.

25 UNIDENTIFIED FEMALE SPEAKER: He's downstairs
discussing some things with Wayne, and it's also the

1 | worship hour, so he said that he would call back after
2 | three.

3 | JOHN: After 3:00?

4 | UNIDENTIFIED FEMALE SPEAKER: Um-hum.

5 | JOHN: Okay.

6 | UNIDENTIFIED FEMALE SPEAKER: Okay?

7 | JOHN: That's great. Thank you.

8 | UNIDENTIFIED FEMALE SPEAKER: All right.

9 | Bye-bye.

10 | JOHN: Bye.

11 | * * * * *

12 | (Telephone dialed and rings five times.)

13 | UNIDENTIFIED FEMALE SPEAKER: Hello?

14 | JOHN: Hello. Is Steven there, please?

15 | UNIDENTIFIED FEMALE SPEAKER: He just laid
16 | down. He's been up all night and --

17 | JOHN: Okay. I just wanted to mention one
18 | thing to him, if I could.

19 | UNIDENTIFIED FEMALE SPEAKER: You want me to
20 | pass it on?

21 | JOHN: No. If I could talk to him personally
22 | so there's no mix-up.

23 | UNIDENTIFIED FEMALE SPEAKER: Just a minute.

24 | JOHN: Okay.

 UNIDENTIFIED FEMALE SPEAKER: Just a moment.

1 | Here he is.

2 | JOHN: Is this Rachel?

3 | UNIDENTIFIED FEMALE SPEAKER: No.

4 | JOHN: Okay.

5 | STEVE: Hello?

6 | JOHN: Steve?

7 | STEVE: Yeah.

8 | JOHN: I just wanted to let you know that

9 | they're going to drop off those tapes and they're going

10 | to drop off a tape player with some fresh batteries in

11 | it.

12 | STEVE: Oh, okay.

13 | JOHN: These are the tapes, the five that I

14 | mentioned to you from the relatives.

15 | STEVE: All right.

16 | JOHN: Okay?

17 | STEVE: I think it -- Was it John Cox or

18 | someone had told me about them a while ago maybe, or is

19 | that the same ones or --

20 | JOHN: The same one.

21 | STEVE: I see.

22 | JOHN: Yeah, the same ones.

23 | STEVE: Are there any names --

24 | JOHN: There might be, there might be some

25 | new ones in there, too.

 STEVE: Okay. Do they have the magazines

1 | then or --

2 | JOHN: No, we haven't gotten any answer on
3 | those yet.

4 | STEVE: I see. I was told Friday, I guess,
5 | they had gone all the way to Dallas or something like
6 | that. John had told me or -- I think John Cox told me
7 | they had picked them up already.

8 | JOHN: Sold out.

9 | STEVE: Yeah, he said they had picked them
10 | up, though.

11 | JOHN: Yeah, yeah.

12 | STEVE: Okay. Well, let me know then about
13 | that. I'll send somebody as soon as they're down there
14 | and drop them off. I'll let them know.

15 | JOHN: Yeah, yeah, they're coming now.

16 | STEVE: Oh, okay. Okay, thanks much.

17 | JOHN: All right.

18 | STEVE: Okay, bye-bye.

19 | JOHN: All right, bye.

20 | * * * * *

21 | STEVE: Hello, John?

22 | MIKE: Mike.

23 | STEVE: Mike?

24 | MIKE: How are you, Steve?

25 | STEVE: Not too bad. How's it going there?

 MIKE: Okay.

1 STEVE: I was talking to John earlier and he
2 mentioned, you know, I, I told him I'd get back if I
3 talked to David, and I was able to talk with him.

4 MIKE: Okay.

5 STEVE: And, apparently, like you already
6 know, you know, David's had an interest in theologians
7 or scholars responding to what he had to say with the
8 Seven Seals. And there might be a guy that knows
9 something or can show contrary to what David believes
10 are shown. He seems to be very sharp. David heard him
11 on the, on the radio and he would like -- He was
12 thinking about giving the guy an opportunity, if he
13 wanted to that is -- But his name, if you wanted it --
14 (Loud screeching noise.) Are you okay?

15 MIKE: Yeah. I don't know what that was.

16 STEVE: Okay.

17 MIKE: Something's turned up too loud.

18 STEVE: Okay. His name was Dr. Philip
19 Arnold. He's down in Houston. He's with the Reunion
20 Institute.

21 MIKE: The Reunion Institute?

22 STEVE: Institute, yeah. He's a doctor of
23 probably theology, I would imagine, but his name is Dr.
24 Philip Arnold. He was on the radio. He seemed to have
25 some understanding. And a couple of these other people
heard it and they came and told me about it. They said

1 | if this guy can show something else or equal or
2 | anything else or stump him, they're out of here, they
3 | told me. When I heard that, I says okay, I've got
4 | something to work with and I'm going from there because
5 | that's been the biggest thing from day one.

6 | MIKE: What is?

7 | STEVE: You know, his whole thing about the
8 | Seven Seals. And, really, you know, that's why the
9 | people came here. That is the bottom line. So I don't
10 | know what you -- If you want to, if you would want to
11 | get him on the phone in a dialogue with him or to
12 | record it, ask some questions, or whatever, you know, I
13 | think it'd go a long way.

14 | MIKE: Okay.

15 | STEVE: It doesn't have to be aired or
16 | anything of that nature. If he wouldn't -- I mean, you
17 | know, it's just -- It comes right down for the people's
18 | sake.

19 | MIKE: Yeah.

20 | STEVE: So if you want to pass it on to them.

21 | MIKE: Sure. We can -- We'll look into that,
22 | Steve.

23 | STEVE: All right.

24 | MIKE: But you're saying that some of the
25 | people in there are aware of this individual?

 STEVE: Yeah.

1 MIKE: Not necessarily David?

2 STEVE: Well, what happened was apparently
3 early this morning he must have come on some radio
4 station. I didn't hear what station. And the man
5 seemed to know what he was talking about. He made
6 comments about the Seals or about David Koresh, and it
7 sounded like he knew what he was talking about. So
8 some came to me. I didn't hear it, I didn't know what
9 it was about.

10 MIKE: Um-hum.

11 STEVE: They told me about it and I says
12 well, what's the man's name? They told me that and
13 they thought maybe -- They says well, we'd like to hear
14 this guy and it'd go a long way with us to making up
15 our mind, because, they said, that's the reason why
16 we've been here in the first place. And I says well,
17 I'll -- I went and talked to David now. He's -- And I
18 asked him about it. He says well, yeah, he says you
19 know, let them hear -- if we have a speaker phone, they
20 can hear him through that and they can hear and make up
21 their mind. You know, the guy's definitely educated.

22 MIKE: Sure.

23 STEVE: And he's got a doctor degree, of
24 course, and he sounds like he knows what he's talking
25 about. So, you know, that's the only information that
they gave me about the man.

1 MIKE: Okay. But you're also saying David
2 would allow --

3 STEVE: Oh, yeah.

4 MIKE: -- that to occur, to have a one-sided
5 presentation on the Seals?

6 STEVE: Yeah. Well, what happened is, see,
7 they first -- they came and talked to me about it, then
8 I, I mentioned it to him, 'cause I says there's a guy
9 that might be able to take you on and, and show a
10 different point of view on that or might have something
11 or he might challenge you or ask questions that you
12 can't answer. Are you willing for these people here to
13 sit and listen and -- And that's when he said yeah. He
14 says of course. And I says well, then I'm going to go
15 talk to John, and he says well, yeah, go do so. So,
16 you know, I just came from there, just minutes ago.

17 But I, I wasn't aware of it, but they told me
18 it was on, apparently, early this morning, on one of
19 the -- I don't know what radio station, but at least he
20 gave where he was from, a doctor of what institute and
21 so forth.

22 MIKE: Okay.

23 STEVE: But, you know, that was really, from
24 the beginning, almost two weeks -- about two weeks ago,
25 that was his main challenge and, and at least there's
someone that, that's reacting of a stature that's

1 | educated and apparently has some experience and
2 | knowledge about it.

3 | MIKE: Yeah. Well, you know, Steve, what we
4 | don't want to get into is, is another debate.

5 | STEVE: No, I under-- No, you know, you know,
6 | it's not really that as much as it's maybe the man can
7 | give information that can be heard or ask questions
8 | that he can't answer or show a different perspective.
9 | I mean, this is what the people are saying to me.

10 | MIKE: Okay.

11 | STEVE: Because, remember, the challenge was
12 | he's saying the only one that can open the Seals and
13 | show what they're about.

14 | MIKE: Um-hum.

15 | STEVE: And this man has reacted to that and
16 | they -- a couple of these -- See, I wished I could have
17 | heard the thing, because I don't know exactly what it
18 | was or what he said, but they're apparently convinced
19 | that the man would have a, a good shot at it. And if
20 | that's so, they said well, what's the sense in being
21 | here? That's what a few of them have told me, 'cause
22 | they're the only ones that heard. They've talked to a
23 | number of other people here, so that's how I heard
24 | about it. Then they finally came and -- I said well,
25 | what was it all about? And they told me a little bit
about the man, but, you know, I mean, it's not the same

1 as hearing him directly.

2 MIKE: Okay.

3 STEVE: Yeah.

4 MIKE: What's your feelings on it, Steve?

5 STEVE: Well, the truth -- I'm, I'm
6 interested myself, because the only -- I came here, you
7 know, like six-and-a-half years ago, and the only
8 reason I ever left Hawaii is because I was pretty
9 convinced. I had studied a lot of religions in my life
10 and had compared them. And the truth is when I ran
11 into David, he was so beyond a lot of people I had met
12 and I'd never really heard any of the scholars open up
13 or respond to some of the questions he laid open. But,
14 finally, after all this time -- But, of course, you
15 know, it's always hard to know -- I mean, there's a lot
16 of good minds out there, but where are they?

17 You know, you're not going to run into
18 everybody or hear about them or --

19 MIKE: True.

20 STEVE: There's so many thousands of colleges
21 in the United States alone.

22 MIKE: That's right. We could be students
23 forever.

24 STEVE: Well, this is it. So, I mean, I've
25 always been a student. I'm interested in information
and --

1 MIKE: True.

2 STEVE: -- and always increasing knowledge
3 and understanding. But, you know, with this man,
4 apparently they saw something in what he was saying,
5 the sincerity, the, the way he actually laid out his
6 information. They were -- They thought that the man
7 may have something. So I said to David, what do you
8 thin? If the guy -- If they let him call through or if
9 you call or they can monitor it or -- And he says sure.
10 Sure, he said.

11 MIKE: This is David or others?

12 STEVE: This is David. But they want to
13 hear, you know.

14 MIKE: Right.

15 STEVE: Or, or if they could, they might --
16 he might say well, let this person on the phone to ask
17 you a question or something or what do you think about
18 David's presentation. Well, it's weak, I see that it's
19 this or that. You know, that's what they're expecting
20 to maybe hear.

21 MIKE: Okay. How do you think David would
22 react to this individual, though?

23 STEVE: I think -- Oh, yeah.

24 MIKE: But say there --

25 STEVE: I think --

MIKE: There may well be major differences.

1 STEVE: There could be, and he's -- You know,
2 I've been with him in the past. He is cordial and
3 decent with people. If they ask questions, he a lot of
4 times will stop, back off, and give them their
5 opportunity. Or if they ask him a question, you know,
6 he will get into it. But if they want to stop and ask
7 him something, he's, he's actually usually pretty
8 cordial and polite.

9 MIKE: Um-hum.

10 STEVE: And I think it would go well. I know
11 there's a lot of people here he wants -- Like, of
12 course, you know, those that have come from Britain.
13 There are some that have not really known him long and
14 they've raised questions, rightly so, because they
15 don't know him that well or they haven't heard that
16 much. So for that reason, I thought well, you know, if
17 they, you know, if they're starting to raise those kind
18 of questions, that's what it all surrounded was that
19 kind of subject matter in the first place. That's what
20 brought them here.

21 MIKE: Right.

22 STEVE: So I, I guess that's probably about
23 -- In fact, for me even, you know, I mean, that's why I
24 came here, was to hear. And if someone had another
25 perspective -- I had a couple friends at another
university that I did contact in the beginning when I

1 | heard this information and I gave them opportunity to
2 | respond, and they never did. So for that reason, after
3 | time and after my trying to nail him down, show him
4 | that he was wrong, not able to do so because of his
5 | ability to show so many chapters in context, like
6 | pulling many pieces of a puzzle together, looking at
7 | one big picture, so after a while that's how I got
8 | involved and have continued on.

9 | MIKE: Yeah.

10 | STEVE: And I've always said until I can
11 | prove him wrong or I can controvert it somehow -- So
12 | far, I've taken it day by day, basically, for myself.

13 | MIKE: Yeah. I, I guess our concern here
14 | initially, and we will obviously, you know, throw this
15 | around and discuss it and make a decision --

16 | STEVE: Okay.

17 | MIKE: -- but our initial reaction is, you
18 | know, how, how freely are the individuals in there
19 | going to be in their reactions to what that doctor may
20 | say. You know --

21 | STEVE: Well, what we'll --

22 | MIKE: And again I'm going back to are we
23 | going to get into a debate.

24 | STEVE: Yeah. What we'll do --

25 | MIKE: Because David has consistently said
this and --

1 STEVE: Right.

2 MIKE: -- now Dr. Arnold might say this.

3 STEVE: Well, maybe -- You know, if you guys
4 -- if you have any suggestions, what you think might
5 work or how, you know, definitely I would, you know,
6 I'll talk to these people or put them on or, or if they
7 have questions for him or whatever, you know, he would
8 be more than willing to allow whatever, especially -- I
9 mean, his main interest, his main interest, Mike, is
10 spiritual things, obviously. You know --

11 MIKE: Sure.

12 STEVE: -- the Bible and, and if he's not
13 able to open these Seals, he'll tell you he's nobody,
14 he's nothing, this is a farce, it always has been.
15 He'll acknowledge it right now, but he says until -- He
16 says right now I can show the Seals. Well, maybe
17 there's other scholars that say hey, I've studied and I
18 think this is -- And if they're here and if it's
19 plausible, I believe these people will look at it,
20 weigh it out, and definitely make a, a decision and
21 move on. There's no question.

22 MIKE: Do you think, do you think they would
23 be free to make that decision?

24 STEVE: Positi-- I, I'd put my -- I'd stake
25 my life on it, I'd stake my reputation, all of that on
it, I would.

1 MIKE: Um-hum.

2 STEVE: I know so, because even in the
3 discussions with him, he himself has talked about
4 sending people out of here and -- I mean, if they, if
5 they're even questioning at all, he thinks that they
6 should be out there.

7 MIKE: Sure.

8 STEVE: And there's other reasons, you know,
9 I haven't brought up and so forth. It's kind of
10 amongst -- Some of them are having, you know, personal
11 things and so forth, but, you know, the question was
12 actually raised in the minds always, you know, people
13 wonder and -- But sometimes one talks, one way to talk,
14 another, you know, it's, you know, it's been unique
15 here in the past two weeks, of course.

16 MIKE: Oh, definitely, for all of us.

17 STEVE: You know, sometimes one gets, you
18 know, you get humorous and you talk about it in one
19 manner or another, even though you don't mean half of
20 what you say. So when I'm sitting down with these
21 people, I'm actually trying to get to the bottom of
22 what they want to do. But, you know, I mean, most of
23 all, people are pretty sober and, and straight and
24 serious about it, they really are.

25 MIKE: Well, I'd certainly hope so, after
the --

1 STEVE: Oh, they are. I mean --

2 MIKE: -- the undertakings of the last two
3 weeks.

4 STEVE: Oh, for sure, for sure.

5 MIKE: You know, let me clarify one thing
6 here.

7 STEVE: Okay.

8 MIKE: I know we're still probably in the
9 midst of talking a little bit. Would, would they want
10 a give-and-take presentation from this or a, a --
11 literally a tape recording from this individual?

12 STEVE: Well, I think --

13 MIKE: Would they accept that, if, if that's
14 all he would do?

15 STEVE: Possibly. It would probably help,
16 but I think they -- A couple of them -- I didn't --
17 Apparently, some of them spoke to David and kind of
18 gave like a challenge, and that's when I went and
19 talked to him, also. And in the process, he says well,
20 you know, let the guy, you know, if there's some way
21 they can hear him and myself -- And I don't think it
22 would be a debate, Mike, I really don't. I think it'd
23 be more of a discussion where the man could open up
24 what he, he sees, or if he had questions of David where
25 he could -- Like, even me, from the beginning, when I
met him I says yeah, but what about this, what about

1 | that?

2 | And the truth is he backed off from me. I, I
3 | jumped all over him. I says yeah, what are you going
4 | to do with this, what are you going to do with that? I
5 | was calling him long distance from Hawaii. My bill was
6 | nothing less than \$200 a month. And a lot of times I'd
7 | think I had him nailed down and he would just come back
8 | with -- and show me a lot more in context and it closed
9 | my mouth. And then I'd go back to the drawing board
10 | again.

11 | MIKE: Um-hum.

12 | STEVE: That went on for me for six months,
13 | for six months, calling him back and forth between
14 | California and Hawaii where I was at. And, and I've
15 | seen him with others. I saw him like in Jerusalem and
16 | I think it was -- Yeah, it was '90 and sitting down
17 | with a number of rabbis. I mean, I was so impressed, I
18 | really was, the way he, the way he opened up, allowed
19 | them to speak. And very logical thinkers, very
20 | logical.

21 | MIKE: Sure.

22 | STEVE: And I really liked the dialogue I
23 | heard. I always hoped I could get back and that we
24 | could see and hear a little more from that, but it
25 | never happened. But I really believe that between the
 | man, the way they're speaking about him, from what I've

1 | heard about this doctor, I think that it'd, it'd go
2 | very well.

3 | MIKE: Okay. Well, I've, I've got a feeling
4 | or at least an indicator from being around here for the
5 | length of time that we've all been here is that, is
6 | that the, the people here will, in all probability,
7 | agree to a tape recording. And we haven't even
8 | consulted Dr. Arnold. What will he agree to?

9 | STEVE: Oh, right. Maybe you could do that
10 | and then --

11 | MIKE: Well, we were -- Our initials thoughts
12 | are perhaps an initial tape presentation, and then, if
13 | need be, go from there.

14 | STEVE: Okay. That, that --

15 | MIKE: Probably follow up.

16 | STEVE: Yeah, if you think that, you know,
17 | that's what I mean. You know, whatever -- I'm open
18 | myself to what your views or what you might think about
19 | it.

20 | MIKE: Sure.

21 | STEVE: But the only thing I can tell you is,
22 | you know, why the people are here in the first place.
23 | I mean, the hundred and some that are left. And I
24 | mean, the bottom line, that's why they came here,
25 | because he says he can show them all things are in the
 | book.

1 MIKE: Well, he's consistently said he's the
2 only one that can open the Seals.

3 STEVE: That's true, that's true. And not to
4 -- That's totally true. So -- Well, what I'll do is
5 I'll get back to you then in the morning --

6 MIKE: Okay.

7 STEVE: -- unless you have anything else
8 between that time. But, you know, I've been -- I about
9 wore myself out today. I was up really late last
10 night. I got up extremely early this morning.

11 MIKE: Really?

12 STEVE: And, yeah, I was talking to a lot of
13 the people, trying to get something going again and --

14 MIKE: That's what John passed along to me.
15 We came on this evening and --

16 STEVE: Right.

17 MIKE: -- we understand that there's, you
18 know, potentially a, a face-to-face meeting in the
19 works or --

20 STEVE: Right.

21 MIKE: -- whatever that John was going to
22 pursue in the morning with you, but --

23 STEVE: I'm still trying to -- We're still
24 working on that, and --

25 MIKE: Okay.

STEVE: -- Wayne, I'm a little disappointed

1 | because I was hoping he would get more views down more
2 | quickly, but he's acting like he's kind of worn out and
3 | he hasn't really done much on it. I mean, he's the one
4 | that understands more of the details of the legalistic
5 | --

6 | MIKE: Yeah.

7 | STEVE: -- points, so --

8 | MIKE: Why is that, do you know? Is he
9 | just --

10 | STEVE: I think he's, he's been up a lot
11 | himself and, apparently, today he seemed to be kind of
12 | slow and tired. I stopped in a few times and he was
13 | nodding his head most of the day, and I says well,
14 | maybe later on you can sit down and start nailing those
15 | points down so when I call back the guys in the morning
16 | I might have something and can go from there. He
17 | didn't seem too excited today, I don't know why.

18 | MIKE: Okay.

19 | STEVE: He just looks tired. I guess kind of
20 | forlorn and --

21 | MIKE: Well, we're all tired.

22 | STEVE: Oh, yeah, I'm sure. I'm sure.

23 | MIKE: We're all tired.

24 | STEVE: Right. So I guess by the morning,
25 | maybe you might know something, maybe not.

 MIKE: Sure.

1 STEVE: I don't expect, but maybe, you know,
2 you can of course --

3 MIKE: We might --

4 STEVE: Okay.

5 MIKE: We may well know.

6 STEVE: Okay.

7 MIKE: How's everything else? Is there
8 anything we can do for -- We're consistently worried
9 about the, you know, the health problems --

10 STEVE: Right.

11 MIKE: -- of Judy and Scott and the family.

12 STEVE: They're still there.

13 MIKE: Okay.

14 STEVE: And, you know, they're still
15 monitoring it and we're talking to him still and --

16 MIKE: Okay.

17 STEVE: -- and they're, they're both saying
18 they're interested in hearing this guy. And so far,
19 he's the only one apparently they've picked up on the
20 radio.

21 MIKE: I was going to say there's been a lot
22 of it, at least what we're getting on the media.

23 STEVE: There has, huh?

24 MIKE: People, you know, presenting
25 themselves --

STEVE: Right.

1 MIKE: -- as, as being knowledgeable. I
2 mean, we just haven't pursued it because, like I say,
3 our main concern is we don't want to get into a --

4 STEVE: I understand.

5 MIKE: -- a large, you know --

6 STEVE: Right.

7 MIKE: -- religious debate between David or,
8 or anyone else, anyone who may want to come in and --

9 STEVE: Right.

10 MIKE: -- and express their, their opinions
11 on it.

12 STEVE: Well, you know, I mean, the more I
13 gave it thought about what they were telling me today,
14 why they came here, and I've always known why and I
15 know why they've stayed, because of their belief that
16 he has this ability, so the more I thought about it, I
17 thought well, I'm going to go over and see if he's
18 willing to do that if, if you guys worked it out and
19 the man would call or vice versa somehow. And he says
20 why, sure. He says that's what I've always said. He
21 said that's what I was trying to state plainly two
22 weeks ago.

23 And I says okay, then I'm going to go talk to
24 John or whoever is there now.

25 MIKE: Sure.

STEVE: He says go ahead. So I thought -- I

1 | mean, there's no question in my mind it would be the
2 | greatest thing over any other reason or cause to get
3 | the majority, if not all of them, out of here.

4 | MIKE: Oh, sure, that's our, our goal. Our
5 | goal at the outset is that we want you all to come out
6 | and we're --

7 | STEVE: Yeah.

8 | MIKE: -- we're anticipating that, you know,
9 | happening sooner or later.

10 | STEVE: Right. If this guy has some good
11 | strong questions or statements on the Seals, I mean,
12 | that's where it is with them. It would show them that
13 | these people wouldn't care if he says he's waiting on
14 | his God or not. I mean, I go in there and talk with
15 | David a lot, and sometimes he'll say things, sometimes
16 | he'll say things I don't even agree with or, or we'll
17 | talk about things that are, you know, all sorts of
18 | dialogue I've had with him. But I've always tried to
19 | keep an open mind and listen to all different factions,
20 | compare and weigh it out and try to go by the weight of
21 | evidence. I mean, that's been more or less --

22 | MIKE: Sure.

23 | STEVE: -- the bottom line for me.

24 | MIKE: Sure.

25 | STEVE: But, so --

 MIKE: As we've generally said, too, we're

1 | not trying to, trying to, you know, alter the beliefs
2 | of everyone in there or, or shut down the, the group.

3 | STEVE: Well, that --

4 | MIKE: We're just trying to resolve this last
5 | two weeks, Steve.

6 | STEVE: Yeah, I understand that. You know,
7 | the biggest difficulty, no question, has been you guys
8 | are not -- I mean, you know, this, this is a -- such a,
9 | a group that's tuned in to spiritual things or what
10 | they see as prophecies, events taking place in the
11 | final days, which they believe are here. And I know
12 | you men don't have the same background and so forth. I
13 | mean, I know you're trying to sympathize and give room
14 | for that, but I know from your perspective it would be
15 | difficult and hard.

16 | But, you know, I mean, the reason they came
17 | here, all that they are and what they want to be
18 | revolves around what they see him showing from that
19 | book. So, and, you know, he's constantly giving them
20 | studies. People come to his door. A lot of times even
21 | if he's half sick here and they want studies and,
22 | and --

23 | MIKE: Sure. And he's done that for them.
24 | He's been there for them --

25 | STEVE: Yeah.

 MIKE: -- when they, when they do that.

1 STEVE: He's always challenged them to go
2 back and read on their own and, and challenge him or
3 find something or -- And if they don't see it, what's
4 the sense of being here. He's brought up that over and
5 over again. He's actually thought about sending people
6 out that even haven't shown an interest that they want
7 to. I mean, that's been discussed in the last few
8 days. And I don't -- I mean, sometimes I talk about
9 it. You know, I'm more quiet about that than not,
10 because I am just wanting to pick up on just definitely
11 what's going on or what, what can be worked out here.

12 MIKE: Well, you know we would welcome them
13 for, for whatever reason that they decide to come out.

14 STEVE: Right. That I, that I realize.

15 MIKE: And after the situation, you know,
16 resolves itself, we're not saying they're not free to
17 return to the group, go back in to the --

18 STEVE: Right.

19 MIKE: We're just -- The immediacy is to
20 resolve this situation.

21 STEVE: I can -- I understand that.

22 MIKE: Not long term to do anything about
23 the, the group, the organization.

24 STEVE: Yeah. It would have been so much --

25 MIKE: They'll be free to continue that.

 STEVE: Right. It would have been so much

1 | easier, as you know, if there were --

2 | MIKE: I know.

3 | STEVE: -- no religious aspect to this at
4 | all. I mean, well, then shoot, everybody would have
5 | been out single file that first day.

6 | MIKE: Yeah.

7 | STEVE: In fact, I'll tell you what, when
8 | those bullets were flying through that wall where I
9 | was, and I was ducking and trying to talk on the phone,
10 | man, I mean, if you would have heard me on the
11 | telephone with first Larry Lynch and --

12 | MIKE: Sure.

13 | STEVE: I mean, if you play back -- If they
14 | record that with the -- with Larry Lynch, you'd hear --

15 | MIKE: That wasn't done. Everything that's
16 | been recorded --

17 | STEVE: I supposed, but, you know, Wayne, I
18 | never heard him talk so high, in such a high-pitched
19 | voice. Later on I had to chuckle about it. I says
20 | Wayne, I hardly knew it was you, if I wouldn't have
21 | seen you there talking myself. And he was saying call
22 | them off and let's talk and what's going on, of course,
23 | you know, and all that. So --

24 | MIKE: Well, I think what you just said, you
25 | know, that you would have all, barring the religious
 | aspect of it, you would have all been out single file

1 | the first day --

2 | STEVE: Oh, positively, positively.

3 | MIKE: -- you realize that can still happen.

4 | And I know --

5 | STEVE: Yes. Well, see, that's --

6 | MIKE: -- I shouldn't, I should not say it,
7 | but any time they're still free to do that and --

8 | STEVE: Exactly. But, see, it's still hard,
9 | Mike --

10 | MIKE: I know.

11 | STEVE: -- to, to separate that. That, that
12 | is the most difficult thing, even for myself, after
13 | six-and-a-half years of traveling with him, studying,
14 | talking to theologians in London, Melbourne, all around
15 | America. Even for me, I mean, I've really challenged a
16 | lot of good minds, I really have.

17 | MIKE: Um-hum.

18 | STEVE: You know, there's a lot of people, as
19 | you probably -- You already know there's, you know,
20 | there's almost two billion people in this world
21 | claiming to be Christians or having some kind of
22 | contact with Christianity, and of all those people I've
23 | gotten to challenge a lot of good minds. And in the
24 | process --

25 | MIKE: Oh, you have, huh?

 STEVE: Yeah. And in the process --

1 MIKE: More than most.

2 STEVE: That's it. And in the process,
3 they've had very few answers. Whereas, this man has
4 actually shown one, not so much given an opinion and a
5 theory. But he says look at this chapter in light of
6 this chapter. So that's where the, the strength has
7 been. That's where the weight of evidence has been for
8 the majority that have looked and listened and gone
9 back and compared. Like I was telling I think it was
10 --

2 MR. SCHNEIDER: So, to me, it's always been a
3 healthy thing and, you know, it's something that he
4 still does. But as to this latest thing that we're
5 talking about, I'd be very interested to see how it
6 could work out and whatever suggestions you have, you
7 know, I'd more than want to talk about it.

8 MIKE: Okay.

9 MR. SCHNEIDER: 'Cause that's really been my
10 area, also.

11 MIKE: Sure. We'd be, you know, more than
12 happy to pursue that. We appreciate you --

13 MR. SCHNEIDER: Okay.

14 MIKE: -- bringing that up.

15 MR. SCHNEIDER: Okay.

16 MIKE: One quick thing, also --

17 MR. SCHNEIDER: Sure.

18 MIKE: -- while we have a little time that we
19 need, but we're kind of bouncing around ideas here,
20 just --

21 MR. SCHNEIDER: Okay.

22 MIKE: You know, I'd like your personal
23 insights on how the face to face went.

24 MR. SCHNEIDER: Well, I, I don't know if you
25 heard earlier when I -- or if it was recorded earlier
when I was speaking with John-3.

1 MIKE: Yes.

2 MR. SCHNEIDER: But I really, seriously,
3 totally I liked Byron, I really like the man. I got --
4 I listened to him carefully. He was very articulate --

5 MIKE: He is.

6 MR. SCHNEIDER: -- and handled himself well.
7 His concerns, I thought he was genuine. I, I think
8 he's probably put in a lot of years of good service.
9 He said enough things for me to see that -- I mean, it
10 sounded like it's a guy that I would definitely like
11 backing me or, or being in the position he's in. And,
12 of course, Harwell, I didn't talk to him as much as did
13 Wayne. I never knew the man before. It was the first
14 time I'd met him, other than speaking, speaking to him
15 on the phone I think once.

16 MIKE: Okay.

17 MR. SCHNEIDER: But I thought it went well.
18 And, and Wayne did, too. Wayne is more a person that
19 wanted to probably get more into the issues, the
20 legalities.

21 MIKE: That's what it sounded like.

22 MR. SCHNEIDER: Right. And --

23 MIKE: You know, those are so simple.
24 Nothing's maybe simple, but they aren't as complex or
25 difficult as, as Wayne may think they are.

MR. SCHNEIDER: Right.

1 MIKE: Those are very workable areas that,
2 that we can resolve

3 MR. SCHNEIDER: Well, see, that's --

4 MIKE: -- very easily.

5 MR. SCHNEIDER: Right.

6 MIKE: Whatever it's going to take, you know,
7 some written documents or promises from others in
8 authority, in the legal, legal aspect of, of it having
9 to do with, you know, the issues you brought up, the
10 forfeiture or the, the evidence and stuff, the --

11 MR. SCHNEIDER: Right.

12 MIKE: -- general investigation, the trial,
13 the documents.

14 MR. SCHNEIDER: David has brought up the
15 issues again as of today. He was saying to me
16 something about -- he was talking about his mother and
17 the lawyer she apparently retained and about how he
18 heard that the judge, the federal judge here said that
19 he didn't -- I don't know if it was we at large or he
20 himself had no rights. Pertaining to what all the
21 issues he was talking about, he didn't make that clear
22 to me. But that was a concern and he wanted that
23 discussed. He wanted me to speak to both Wayne and
24 maybe yourselves about that.

25 MIKE: I don't follow you on that one, Steve.

MR. SCHNEIDER: I don't really know, either.

1 I've got to go back and get really what, what he meant
2 by that, because he said something to -- It was
3 something to do with an attorney being retained for him
4 by his mother, and something to do with a response that
5 he heard. I don't know where he heard it from or how,
6 but something to do with a federal judge here that, in
7 essence, said he didn't have any rights.

8 He wanted to know also about -- understand
9 more about house arrest, the condition that we're in
10 right now, along with, you know, a great concern
11 about -- not so much has been said about you people,
12 but, you know, a great concern about the ATF and the
13 part they played and where -- and about the sealed
14 warrant. You know, these are some of the things he's
15 still -- He says he'd still like to know why they came
16 in the manner they did, and he never got to see
17 anything.

18 He still wants to know what, what actually
19 was the warrant for, what was he being arrested for.
20 And, you know, you hear much through the press. Your
21 agency hasn't told us a whole lot about that, but we've
22 heard, of course, through the air waves and elsewhere
23 that it's sealed. What does that really mean? It's a
24 sealed warrant. And, you know, it definitely bothers
25 him. Does it mean that it can be changed if they
finally come here and look around, they'll change it to

1 | what they find?

2 | MIKE: No. No, no.

3 | MR. SCHNEIDER: These are concerns, of
4 | course.

5 | MIKE: Okay. I guess we made an assumption,
6 | maybe false, that Wayne might, might be knowledgeable
7 | in the sealed warrant. And the purpose for a sealed
8 | warrant in a criminal investigation, as we all, all are
9 | involved out here, we're criminal investigators, it's
10 | totally for the safe -- or the well being and safety of
11 | those agents, whether they be FBI or ATF, so that
12 | whatever the warrant is for, if it's a search warrant
13 | for a piece of property or an arrest warrant for an
14 | individual, that that warrant and the documents in
15 | support of the warrant aren't released to the public.

16 | Once we file, we, law enforcement, file a
17 | document, any type of warrant with the court system --

18 | MR. SCHNEIDER: Do you know --

19 | MIKE: -- that's public, that's public
20 | information.

21 | MR. SCHNEIDER: I see. Mike, do you know
22 | personally what it is? You probably would, wouldn't
23 | you?

24 | MIKE: For?

25 | MR. SCHNEIDER: The warrant itself, what it
was? I mean, not that I'm asking you or that you would

1 | give it now, but are you yourself aware of what the
2 | warrant is or the details or what it's about?

3 | MIKE: Now, which warrant are you talking
4 | about?

5 | MR. SCHNEIDER: I don't -- Apparently,
6 | whatever the ATF said they came to serve. That's I
7 | guess what we're talking about.

8 | MIKE: Oh, okay. That's -- That was -- To my
9 | knowledge, that's -- that was a search warrant for the
10 | buildings out there.

11 | MR. SCHNEIDER: And that's all it was? I
12 | mean, from your understanding, that's all it was, was a
13 | search warrant? We also heard they came with a
14 | warrant, an arrest warrant or something?

15 | MIKE: Okay, yeah. I have been corrected
16 | by --

17 | MR. SCHNEIDER: Okay.

18 | MIKE: There were, there were two warrants.
19 | One was a search warrant for the premises for
20 | weapons --

21 | MR. SCHNEIDER: All right.

22 | MIKE: -- in violation of the statutes that,
23 | that ATF has jurisdiction to investigate. And there
24 | was an arrest warrant for David --

25 | MR. SCHNEIDER: Okay.

 MIKE: -- involving, you know, violations of

1 | those same, same laws.

2 | MR. SCHNEIDER: Right.

3 | MIKE: But, you know, all, all the supporting
4 | reasons behind that, I'm, I'm not --

5 | MR. SCHNEIDER: Oh, and that would be part of
6 | the warrant itself then?

7 | MIKE: I don't know specifically --

8 | MR. SCHNEIDER: Is that what you're saying?

9 | MIKE: Yes.

10 | MR. SCHNEIDER: Oh, I see.

11 | MIKE: It's called, it's called an affidavit.

12 | MR. SCHNEIDER: Okay.

13 | MIKE: And what happens is in that case an
14 | ATF agent involved in that investigation would swear in
15 | court to that affidavit, here are the facts that we
16 | have found in our investigation in support of why we
17 | want, first, a search warrant and then an arrest
18 | warrant. That's the documents that are sealed, and
19 | they're sealed only for the safety of those agents.
20 | They would be -- Once it's executed, you know, if, if
21 | this thing would have gone as normally they do on that
22 | Sunday, and let's say David was arrested and the, and
23 | the buildings were searched, the next day in court all
24 | those documents would have been opened.

25 | MR. SCHNEIDER: Okay.

 MIKE: They would have been opened and

1 released in court and then to the -- or be open to the
2 media. And the reason they don't is literally for the
3 safety of the agents until they're what we call
4 executed, until they're, they're carried out, an order
5 of the court.

6 MR. SCHNEIDER: All right. But, of course,
7 you know, what I want Wayne to do, I still want him to
8 jot down or make a list of some of the concerns --

9 MIKE: Sure. Sure. I'm sure we can answer
10 those.

11 MR. SCHNEIDER: -- and -- Right, I'm sure you
12 can. That would help a lot. It would help a lot.

13 MIKE: Well, while we're talking legal
14 things, I don't know if you're aware that your sister
15 has retained a lawyer or counsel for you.

16 MR. SCHNEIDER: Right, I, I --

17 MIKE: Are you aware of that?

18 MR. SCHNEIDER: Yes, I was aware of that.

19 MIKE: Okay.

20 MR. SCHNEIDER: Is she -- Someone said she
21 was in Waco. Is that true, or would you not know that?

22 MIKE: We, we can find out. I don't know
23 that. If she was, I would tell you.

24 MR. SCHNEIDER: Yeah, I'm sure you would.

25 MIKE: We, we got all these, what we call
reports of people, and I've got a couple in my lap just

1 | as we're talking. You got a call from an old friend of
2 | yours in Hawaii, I guess.

3 | MR. SCHNEIDER: And who is that?

4 | MIKE: David Shideler, Shideler,
5 | S-H-I-D-E-L-E-R? University of Hawaii, Department of
6 | Religion.

7 | MR. SCHNEIDER: David, what's his last name?

8 | MIKE: S-H-I-D-E-L-E-R.

9 | MR. SCHNEIDER: Shideler.

10 | MIKE: Shideler?

11 | MR. SCHNEIDER: I've never heard -- I
12 | can't -- Huh, interesting.

13 | MIKE: Says he attended University of Hawaii
14 | with you and was a good friend.

15 | MR. SCHNEIDER: Really?

16 | MIKE: Is concerned, you know.

17 | MR. SCHNEIDER: Well, great. Did you get his
18 | tape message?

19 | MIKE: No, just a written one that he called.

20 | MR. SCHNEIDER: Oh, okay. Well, that's
21 | interesting.

22 | MIKE: Just a written one making inquiry and,
23 | you know --

24 | MR. SCHNEIDER: Anything -- Any address or
25 | return phone number or anything of that nature?

MIKE: Yeah, there's a phone number here.

1 MR. SCHNEIDER: Oh, okay.

2 MIKE: Yeah.

3 MR. SCHNEIDER: Huh.

4 MIKE: I assume he called --

5 MR. SCHNEIDER: Honestly, I don't remember
6 the last name. That's interesting. I mean, 'cause
7 that's been a while ago, of course.

8 MIKE: Yeah.

9 MR. SCHNEIDER: Let me write that -- I'm
10 going to write it down here on a piece of paper.

11 MIKE: Okay.

12 MR. SCHNEIDER: Okay, David, and then could
13 you spell it one more time, please?

14 MIKE: Sure. S-H-I-D-E-L-E-R.

15 MR. SCHNEIDER: Man, I never -- I don't ever
16 remember a name like that. Shideler, Shideler.

17 MIKE: Hmmm. Well, maybe they, they could
18 have misspelled it, too.

19 MR. SCHNEIDER: I, I sure wish that they
20 could have gained a little -- oh, gained a little more
21 information on that. Very interesting.

22 MIKE: Then we have -- While we're speaking
23 of that, too, and we can spend the next -- Well, we can
24 get back with you, but we've got numerous inquiries
25 from family and friends that we'd be more than happy to
pass them on. Most of them are written, you know, just

1 | phone calls --

2 | MR. SCHNEIDER: Yeah.

3 | MIKE: -- saying -- I've got one here from
4 | Judy's mother and obviously she's concerned about her
5 | welfare and your welfare and Judy's injuries.

6 | MR. SCHNEIDER: Right. I'm sure. I mean,
7 | knowing her all these years, I was surprised that we
8 | didn't hear more about her sooner.

9 | MIKE: Yeah. Well, she's called, and we've
10 | had just numerous inquiries. We keep a separate folder
11 | just to have them if we get into a time to pass them
12 | along, but we've --

13 | MR. SCHNEIDER: Okay.

14 | MIKE: -- we've had continuing inquiries,
15 | obviously, to --

16 | MR. SCHNEIDER: Right.

17 | MIKE: -- ask about their welfare and, and
18 | their concern, and they're all hopeful, as you and I
19 | and everyone are, Steve, that it's going to be resolved
20 | soon.

21 | MR. SCHNEIDER: Oh, I, I surely hope so
22 | myself, I do. And that's what, you know, well, like
23 | this, this latest thing, I'm hoping that'll have a lot
24 | to do with it, play a big part of it somehow.

25 | MIKE: Right. We're hopeful that anything we
 | can do together will, will be helpful and we're more

1 | than willing to explore the possibilities of Dr. Arnold
2 | coming forth and presenting --

3 | MR. SCHNEIDER: And tell -- You can tell him
4 | of David's willingness. I'm not aware who all heard,
5 | but, anyway, he has a willingness to speak with him, to
6 | listen to him, to share anything. I think there would
7 | be a good dialogue there, I really do.

8 | MIKE: Okay. As long as it's a good, a
9 | good --

10 | MR. SCHNEIDER: Yeah.

11 | MIKE: -- a good dialogue and not a, not a
12 | heated debate.

13 | MR. SCHNEIDER: Yeah, I, I understand. You
14 | know, and first -- Number one, like you said, you'd
15 | have to contact the man even to see if he'd be willing
16 | in the first place.

17 | MIKE: Sure. And I think there's various
18 | steps there.

19 | MR. SCHNEIDER: Yeah.

20 | MIKE: And my inclination is that he may be
21 | willing to sit in Houston and make a tape for his
22 | presentation.

23 | MR. SCHNEIDER: That's true.

24 | MIKE: And maybe the next step, if it's
25 | necessary, is, is to get into some kind of three-way
 | conversation. And we'd have to work up the mechanics

1 of how, how everybody in there could, could listen to
2 that.

3 MR. SCHNEIDER: That's true, that's true.
4 That sounds good. I, I think that'd be one of the
5 greatest -- I mean, that, to me, would be the best
6 thing I've heard yet, seriously.

7 MIKE: Do you, do you -- The way you're
8 talking you have some serious indicators that that type
9 of situation or that type of presentation could resolve
10 the situation?

11 MR. SCHNEIDER: Positively, positively,
12 because the only reason -- I'm serious. The reason
13 these people are here is because he has put out
14 challenges and there's not been any response. But what
15 kind of a response is he going to get in Waco, anyway?
16 Isn't that true? You know what I mean?

17 MIKE: Yeah, yeah, I know where you're coming
18 from.

19 MR. SCHNEIDER: I mean, who's here?

20 MIKE: Who's here?

21 MR. SCHNEIDER: No majority university or
22 colleges.

23 MIKE: Yeah.

24 MR. SCHNEIDER: Or what do you have for, you
25 know, well known theologians or anything else? I mean,
unlike yourself, I haven't heard, you know, too many

1 | responses to his tape or what he said by theologians.
2 | If they're out there on the air waves or have responded
3 | to you or to your people there, I mean, I wouldn't know
4 | that. But that's the kind of thing that would have
5 | made a difference from the beginning with these people,
6 | I mean, in leaving here, every last one of them, every
7 | last one of them.

8 | I mean, the only thing -- the main thing has
9 | been because they have seen something that he has done,
10 | and maybe if they've seen or somebody else shows
11 | something, I mean, no question they'll look at it,
12 | because, I mean, right from the beginning, anybody
13 | that's come here they do a lot of comparing, they
14 | listen carefully, very carefully. I mean, when they
15 | listen to me, they've asked me some pretty hard
16 | questions.

17 | MIKE: Well, that's good. Yeah, the
18 | questioning --

19 | MR. SCHNEIDER: Exactly, exactly.

20 | MIKE: -- what's being said and whether or
21 | not they agree with it or can't agree.

22 | MR. SCHNEIDER: He says, he says if I'm
23 | false, how would you -- He says compare. He's always
24 | said himself listen. I mean, seriously, he's never
25 | held onto people. If anything, he'll actually chase
 | them away. And, I mean, so these people now, the ones

1 I've talked to, when they mentioned this, I thought
2 well, good, here's one of the best opportunities I've
3 heard yet, over anything else.

4 I mean, I can be talking to him about, you
5 know, relatives, about carrying on with their life, but
6 that's not been so effective.

7 MIKE: That has not --

8 MR. SCHNEIDER: No.

9 MIKE: -- not been effective?

10 MR. SCHNEIDER: Well, you know, to a degree.
11 Like, say, the three people that were coming out and
12 then -- Actually, there would have been about 20, 30,
13 and still might be. It might even --

14 MIKE: Well, that's what we --

15 MR. SCHNEIDER: I was talking to him today
16 and he himself was even talking about sending like that
17 many out himself.

18 MIKE: Hmmm.

19 MR. SCHNEIDER: So -- And, in fact, that,
20 that's been the discussion, I would say, in the last
21 two or three days, but I didn't want to say anything
22 because I don't want to go telling you people that and
23 then you're saying well, you're reneging, you're this
24 and that, because, you know, I'm still talking to them.
25 And --

MIKE: Yeah.

1 MR. SCHNEIDER: Pardon?

2 MIKE: Again, again, you know, we've talked
3 about this before and I shouldn't have to but I'm going
4 to, you've also realized that sending 30 people out to
5 us tomorrow would be the greatest thing that we've done
6 in the last 17 days --

7 MR. SCHNEIDER: Well, I do realize that.

8 MIKE: -- together. You know, we'd be doing
9 it together.

10 MR. SCHNEIDER: I'll tell you the truth. I'm
11 not joking when I say I really thought that would have
12 happened, like by Sunday, seriously. But I now think
13 I, I realize a little bit more what happened. I think
14 you probably would -- From today and hereafter, I've
15 got a feeling you guys will know what happened. I
16 think there was a, a response to us, maybe Friday, or
17 maybe you picked up on negative vibes or something of
18 that nature, I don't know. But, but maybe it didn't
19 come across clear.

20 MIKE: Yeah, yeah. There were decisions made
21 on Friday, as we've referred to before, by those people
22 that make the decisions. They literally went into a
23 mode that they needed to see significant positive
24 signs.

25 MR. SCHNEIDER: Oh, what a -- You know, I'd
have given anything if just 24 more hours, Mike, could

1 have gone by. I'd have given anything.

2 MIKE: You and I both, Steve. You and I
3 both.

4 MR. SCHNEIDER: I mean, I'll tell you the
5 truth.

6 MIKE: We can't sit here and second guess
7 it --

8 MR. SCHNEIDER: Yeah, I know.

9 MIKE: -- and wonder what would have
10 happened.

11 MR. SCHNEIDER: If I would have known, if
12 John or John Cox would have just said to me we have
13 made this and we might be doing this. If I would have
14 had that to work on, I would have known what to say to
15 them and so forth.

16 MIKE: If we would have known that.

17 MR. SCHNEIDER: Yeah, that's true.

18 MIKE: Truthfully.

19 MR. SCHNEIDER: I could tell John --

20 MIKE: If we would have known and would have
21 had the presentation or had the, the forewarning that
22 that decision was going to be made, obviously, we would
23 have fought it.

24 MR. SCHNEIDER: I believe, because John
25 Cox --

MIKE: And we would have given you the, the

1 | indicators in a, in a positive way, not in a
2 | threatening way, saying --

3 | MR. SCHNEIDER: Right.

4 | MIKE: -- we need the significant movement,
5 | the significant sign, and our decision-makers are
6 | saying that means not two or three, that means 20, 30,
7 | 40.

8 | MR. SCHNEIDER: Right.

9 | MIKE: And -- But it got, it got away from
10 | us.

11 | MR. SCHNEIDER: But, you know, like for me,
12 | see, what was really going to help me -- I mean, even
13 | though I was talking to that many people, it seemed
14 | like that was going to happen, I didn't want to say
15 | anything until -- I knew that Saturday morning those
16 | three were going out, no -- They were going out. Then
17 | I was going to plan that to say okay, now, here we go,
18 | do you see this? I mean, and that's -- I'll tell you
19 | the truth. John Dolan came across very well. A lot of
20 | people, for some reason or other, were hanging around
21 | me by the telephone.

22 | They saw the smiles, the response, the easy-
23 | going conversation and so forth. So it just seems like
24 | it picked up. And then David had apparently some
25 | things to say to some of them. So this will more than
at-ease the -- start getting the ball rolling and to

1 | look at being out like by Sunday, say.

2 | MIKE: Sure. That's what we thought, too.

3 | We really --

4 | MR. SCHNEIDER: Yeah.

5 | MIKE: We thought it was going to happen.

6 | MR. SCHNEIDER: But I think this may even be
7 | better, to tell you the truth. In fact, this is what
8 | it's always been about, this, this challenge of the
9 | spiritual, of the Bible. I mean, here's the book
10 | that's been around for a couple thousand years now. A
11 | lot of people make a lot of money off this book.

12 | MIKE: Sure.

13 | MR. SCHNEIDER: So, so I'd be -- Myself, I'd
14 | be interested to hear what Dr. Arnold would have to
15 | say, I really would be. I, I -- And what I'm hearing
16 | from these people, it sounds like the guy was extremely
17 | sincere. He came across very well to them and had an
18 | honesty about him. A lot of people -- In fact,
19 | probably even yourself or religious types, I don't know
20 | about you, but I'm always skeptical of those people
21 | more than almost any part of society.

22 | MIKE: Oh, sure. Well, especially when we're
23 | established in, in, in our -- with our religious
24 | beliefs.

25 | MR. SCHNEIDER: Exactly. Exactly.

 MIKE: All of sudden, if someone comes on the

1 | scene, it --

2 | MR. SCHNEIDER: For sure.

3 | MIKE: -- may cause you to question it and --

4 | But that's part of the growing process and, like you
5 | say, the educational process of it.

6 | MR. SCHNEIDER: Right. Well, all --

7 | MIKE: Again, what --

8 | MR. SCHNEIDER: Okay.

9 | MIKE: And I don't want to beat a dead horse,
10 | but what I'm hearing you say is the possible
11 | involvement of Dr. Arnold could be the -- a significant
12 | act that might result in --

13 | MR. SCHNEIDER: I, I really believe so,
14 | because --

15 | MIKE: -- in a great number of people coming
16 | out now.

17 | MR. SCHNEIDER: Right. Because let me say
18 | this even, even before this happened where, you know,
19 | that, that tragic Sunday, I mean, he was all ready --
20 | When people come here to study, to hear him, he's
21 | always putting out that challenge. If there's anybody
22 | out there -- Like he sent a couple people out that came
23 | to hear him, when he sent them out, he says go to the
24 | theologians, go to the, to the professors, to the
25 | ministers, to the priests, the rabbis, ask them
 | questions. Ask them to show you where the Seven Seals

1 are. And for that reason, you know, this is why some
2 of the people have gone back and haven't heard from
3 some.

4 They've wanted to hear a response themselves.
5 There's a lot of people that -- They always keep an
6 open ear and an open mind.

7 MIKE: Sure.

8 MR. SCHNEIDER: Because if they heard this
9 guy, who's, who's to say there's not another 20 minds
10 in this world that are beyond or that have something
11 they can show that is more solid, or that have another
12 perspective that's just as viable.

13 MIKE: Right.

14 MR. SCHNEIDER: So --

15 MIKE: Right. You know, and the possibility
16 exists that however this Dr. Arnold may, may be willing
17 to present --

18 MR. SCHNEIDER: Right.

19 MIKE: -- his side of it that those that do
20 come out, the 30 or 40 or whatever, the possibility
21 exists that he could meet with them in person after
22 they've come out.

23 MR. SCHNEIDER: Sure.

24 MIKE: And they can get into a dialogue and
25 then let those 30, 40, 50 people --

MR. SCHNEIDER: Anything's possible.

1 MIKE: -- make up their mind what they want
2 to do.

3 MR. SCHNEIDER: Yeah. Anything's possible.

4 MIKE: Next week, next month.

5 MR. SCHNEIDER: So, you know, if he's
6 got -- If he wants, if he wants to make a tape and
7 raise questions or if he's got even good responses,
8 that -- You know, even if the man said he might --
9 David might have something there, they would, they'd
10 listen all the more. Or if he wants to raise more
11 questions to David or whatever, you know, any --
12 Whatever format there, you know -- in all his elements.

13 MIKE: Sure. Okay. Well, we'll, we'll
14 explore several formats.

15 MR. SCHNEIDER: Okay, sounds good.

16 MIKE: Again, my concern is that, that coming
17 from our decision-makers that we've been told people
18 are coming out before and it didn't happen, whether it
19 just took a little longer than they thought it should
20 or whatever. But, you know, that's what we're going to
21 have to present to them now.

22 MR. SCHNEIDER: Right.

23 MIKE: Saying that this could may well be the
24 break through.

25 MR. SCHNEIDER: You know, you know that I
could never emphasize enough how disappointed I was --

1 MIKE: Right.

2 MR. SCHNEIDER: -- because they should have
3 been out. Not maybe. I mean, that's -- Not, not maybe
4 at all. I gave those names because they told me to
5 give their names. And they had made up their mind and,
6 I mean, I just plopped down that next morning. I'm
7 serious. If you would have heard my -- the way I came
8 across the deck all that afternoon, I was so
9 frustrated, disgusted. I, I didn't even know what to
10 do. I just felt like throwing my hands in the air and
11 saying okay, I'm going to just go lay down and sleep
12 this off.

13 MIKE: Well, you know, again, that's a
14 concern as, you know, are we back to square one if
15 David, you know, doesn't agree with Dr. Arnold or,
16 or --

17 MR. SCHNEIDER: No, I think --

18 MIKE: -- can't seem to counter him.

19 MR. SCHNEIDER: I don't think, in honesty,
20 that will happen.

21 MIKE: We don't want to start on day one
22 again. We're on day 17.

23 MR. SCHNEIDER: No, I realize, I realize.
24 But, you know, this has really been his personal
25 challenge even from the beginning. And I was --
Even --

1 MIKE: David's?

2 MR. SCHNEIDER: Yeah.

3 MIKE: Okay.

4 MR. SCHNEIDER: And I've even thought myself
5 what could be done to alleviate that or to bring in
6 another perspective or to counter. And I know, of
7 course, you men aren't into that aspect, but you're
8 into working things out, doing what you can.

9 MIKE: Right.

10 MR. SCHNEIDER: And I know you don't run into
11 every day some kind of a religious group of people that
12 are so buried into the Bible that it might seem
13 lopsided to you and their total perspective of things,
14 but, I mean, this is what, you know, what it's really
15 been from the beginning, is people that really want to
16 see that book and understand it because they, they see
17 there's something to that book that seems to be very
18 truthful. Meaning the Bible. So if there's other
19 minds out there that, that see something, understand
20 something, that can raise some really good questions --

21 MIKE: You know, we have, though --

22 MR. SCHNEIDER: Yeah.

23 MIKE: I guess we haven't to this extent or
24 the, the length of this negotiations, but we have dealt
25 with, with other individuals that had their strong
religious beliefs, and I can historically start talking

1 | about them.

2 | MR. SCHNEIDER: Right. I believe that.

3 | MIKE: But the important part of it is that
4 | we resolved them all.

5 | MR. SCHNEIDER: Right.

6 | MIKE: Resolved and we were able to get
7 | through those questions and, and their beliefs and to,
8 | and to peacefully resolve the situations. They were
9 | not as large as this. I mean, you know as well as I
10 | this is probably the largest and longest situation of
11 | this type that we are aware of. Not that we haven't
12 | had other similar, but not to, not to this size and the
13 | number of people involved and the length of time.

14 | MR. SCHNEIDER: Right.

15 | MIKE: So we have come across individuals
16 | like David.

17 | MR. SCHNEIDER: Okay.

18 | MIKE: But just not on the grand scale.

19 | MR. SCHNEIDER: Right, right. Okay.

20 | MIKE: Okay.

21 | MR. SCHNEIDER: Well, I'll be happy to be
22 | talking with -- I suppose it'd be -- Who tomorrow would
23 | I be talking with about 9, 10 in the morning?

24 | MIKE: I'm assuming just the way it goes,
25 | because we're going to be rotating our people.

 MR. SCHNEIDER: Okay.

1 MIKE: You know, people are -- John-1 is
2 here, John-2 has been here.

3 MR. SCHNEIDER: No kidding?

4 MIKE: Sure. No one, no one left here. No
5 one here.

6 MR. SCHNEIDER: All right.

7 MIKE: We just wanted to get a fresh voice.

8 MR. SCHNEIDER: Tell you the truth, I
9 wouldn't mind speaking again with John Dolan or John-2,
10 or even, of course, after speaking with Byron
11 yesterday -- I mean, it -- you guys -- I believe you
12 all have it together, of course.

13 MIKE: We do.

14 MR. SCHNEIDER: You wouldn't, you wouldn't be
15 where you're at, dealing with humanity and so many
16 personalities through the years in the way you have.

17 MIKE: We're here, we've all

18 MR. SCHNEIDER: You've got a little insight
19 and so forth and trying to work it out.

20 MIKE: That's all we want.

21 MR. SCHNEIDER: Right.

22 MIKE: Obviously, the sooner the better for
23 all of us.

24 MR. SCHNEIDER: Yeah.

25 MIKE: Both sides.

 MR. SCHNEIDER: Uh-huh. You know, it's

1 | always dealt with on our part this deep conviction we
2 | have and, you know, if it wasn't for that, it would be
3 | something more, you know, familiar to yourselves. I
4 | know that, but, but, anyway, I'll, I'll be calling then
5 | in the morning. I'll definitely be calling somewhere
6 | around 9 or 10 in the morning.

7 | MIKE: Okay, you'll give us a call, right?

8 | MR. SCHNEIDER: Yeah.

9 | MIKE: And if we've got something prior,
10 | we'll, we'll get back with you.

11 | MR. SCHNEIDER: Okay. Oh, by the way, what
12 | happened with -- Apparently then it didn't -- they
13 | didn't decide to send -- Friday night I know they had
14 | gone out of their way to pick up a Newsweek and a Time
15 | magazine. I guess they didn't drop that off when they
16 | went to pick up the, apparently the tapes and -- I
17 | think it was tapes. I don't know what else was in
18 | there.

19 | MIKE: Today?

20 | MR. SCHNEIDER: Yeah.

21 | MIKE: Yeah, they were just tapes, and my
22 | understanding is that the magazines had been there but
23 | weren't there or weren't included in the package.
24 | Something got lost in the translation.

25 | MR. SCHNEIDER: Right.

 MIKE: And I'll check and see what or where

1 they are.

2 MR. SCHNEIDER: Well, you know, it dawned on
3 me, of course, that they mentioned something about
4 having to get them in Dallas or some other place far
5 away. But it dawned on me that there are people living
6 here using this address that both get Time and
7 Newsweek. There's a Novella Kipsman (phonetic sp.).

8 MIKE: The mail for your people? Oh, okay.

9 MR. SCHNEIDER: Yeah. And there's always
10 Wayne Martin, Jr., who -- Between the two of them, one
11 gets Time, one gets Newsweek. So -- But, anyway,
12 however you'd want to work it.

13 MIKE: We'll have to research that whole
14 thing. I thought that was one of those things on last
15 week, it was all sent on Friday.

16 MR. SCHNEIDER: Right.

17 MIKE: And it's kind of gotten beyond us and
18 I, I don't know --

19 MR. SCHNEIDER: Yeah, John -- Even John Cox
20 was going to send it around that night even, Friday
21 night, even though it was late. He said well, that's
22 no problem. He says we'll just -- He says it'll take
23 maybe an hour. I says well, I'll probably be up still.

24 MIKE: I know initially we couldn't find one,
25 they were such a popular item in the newsstands. They
were sold out.

1 MR. SCHNEIDER: I'm sure that from David's
2 perspective or about him, it's going to be extremely --

3 MIKE: Sure.

4 MR. SCHNEIDER: So what? You know, so what?

5 MIKE: Yeah. And as far as my belief with,
6 with the mail that's, that's being held for, for any of
7 you, I can -- That's literally a violation of law. We
8 can't go in and get that mail, believe it or not.

9 MR. SCHNEIDER: Uh-huh.

10 MIKE: We'd have to go through a rigmarole of
11 authorization, written, probably from Wayne or whoever
12 to pick up his mail. You know, that's, that's a minor
13 thing.

14 MR. SCHNEIDER: Right. Well, you know, I'm
15 concerned about myself and bills and other things.
16 And, you know, two weeks have gone by. You know, you
17 start wondering about what's going to be happening with
18 all of that.

19 MIKE: That's true, yeah. There's another,
20 another reason to, to get this resolved quickly.

21 MR. SCHNEIDER: Right.

22 MIKE: We've got the same thing back at home,
23 wherever our various homes are.

24 MR. SCHNEIDER: Yeah, I'm sure you do. I'm
25 sure you do.

MIKE: Bills sitting there waiting for us.

1 MR. SCHNEIDER: Right. Well, you can have
2 mine, Mike.

3 MIKE: You want to trade?

4 MR. SCHNEIDER: No, I don't want to do that.
5 I don't want to do that. No. Yeah, pass on that I'll
6 be calling in the morning for sure.

7 MIKE: Okay, will do, Steven.

8 MR. SCHNEIDER: Okay.

9 MIKE: We really sincerely appreciate you
10 bringing up Dr. Arnold's name as, as a suggestion, and
11 we can, we can get over the hump here and get, get the
12 bypass over with.

13 MR. SCHNEIDER: Or if you even -- You know,
14 if you know -- Mike, if you know of any other names of
15 someone that knows something about those seals or has
16 some -- that is really informed or spent a lot of years
17 dealing with the Bible or that topic or that subject
18 matter, you know, that is what I really believe will
19 work more than anything. I say this name because
20 that's what they brought up.

21 MIKE: Okay. Well, that's, that's an
22 indicator. You know, I'm sure we could find other
23 individuals.

24 MR. SCHNEIDER: Yeah.

25 MIKE: There have been numerous who have, who
have come to us, you know, over the phone or in

1 | writing, saying that they could, and --

2 | MR. SCHNEIDER: Seriously, you know, if I'd
3 | have known that, I mean, that's what the main thing has
4 | been right from the beginning.

14 STEVE: That would be the father, the
15 husband, right?
