Maybe this was, maybe this was directed by God so that you can get out here, and you can tell the rest of this country and the world what happens when law enforcement authorities unfortunately get into a position where, where something like this happens.

Now there were people hurt in the law enforcement community, and all of us are grieving for those people. We also grieve for the people inside there that are close to you. We're not selective in our grief. We grieve for all of you and all of them. But let's, let's make something positive out of that. Let's don't ever let this happen again.

You, you have a gift that all of us would love to have. You can take and make something positive out of this by going up front in front of a Congressional committee by, by offering testimony, by ministering, by doing these kinds of things that only you can do, David. I cannot do it. I cannot do it.

Sita mentioned to me today why don't you go, Dick, and, and provide this information to these interested parties? I said I can't do it. I can't do it. I wasn't there. Only you can do that. Only you have the ability. Only you have the gift that people will, will listen and understand what you're saying. And you know, to pass that up is a horrible, horrible waste.

You can do it. You can come out. You can go
to these people and make it clear. You can represent
those folks and every other person that feels in the
same way you do. It's your responsibility. It's, it's
an absolute must that you do that. It's an absolute
must. You can do it. I can't do it.

Some of the folks you have inside are able to articulate some of that stuff, but not like you, David. You have what so few of us have ever been given, the ability to do that and to convince people and to make them know that you know and you believe and you have that conviction. What you need to do is, is take it upon yourself to do that. And, and to not do so is a waste.

Show us a sign. Get out there. Send those kids out there. You get ready, you come out there, and you get it done. You get it done. Don't pass on this opportunity. You cannot pass on this opportunity. You must make, take advantage of it. You're not going to be given this forum. This is, this is just has never happened. Was, was it perhaps ordained that this happen so that you could get out and correct and rectify these kinds of problems? Is that possible?

DAVID: Well, I wish that you were the voice of God. I would be up and out right now. I mean I

wish that you were actually God so that I could abide

by and follow your instruction. But that's not the 1 2 instruction that God has given. 3 DICK: Well, I'm not suggesting I'm trying to give you God's instruction. What I am telling you from 4 5 a --6 DAVID: Is what man --7 DICK: -- practical point. Absolutely. 8 DAVID: Yeah. Man's practicality but not 9 God's. 10 DICK: I don't speak for God. And you know 11 that. And I know that. But what I do, what I do tell 12 you is that you have an opportunity to go before the court of public opinion. You go before that court. 13 14 You make your, your thoughts, your emotions and your knowledge known. Okay? You do that. Not Dick. Not 15 Jim. Not anybody else. Do it. You have the ability 16 to do it. I don't. Okay? You were there. Let's 17 18 don't let this happen again. 19 The Congressional inquiry is underway. 20 FBI's going to be reviewing this whole thing. The ATF 21 will be reviewing it. It will never happen in law --22 it better never, ever happen in law enforcement. And 23 we need to get this, work together to ensure that it doesn't. You have that choice and that chance. 24 25 DAVID: Well, I understand what you're saying.

1 DICK: Does that make sense to you? 2 DAVID: Oh, it makes a lot of sense. Well --3 DICK: 4 DAVID: It's a great opportunity in every 5 means. 6 DICK: It's an absolute -- you know, the 7 press is so, so riveted on you at this point in time. 8 But Dave as, as the time goes on -- let's face it. As 9 time goes on, something else happens to direct the 10 attention of the public to some other event, some other place. You know, the public is fickle. The press is 11 12 fickle. They look at things -- they've got an attention span about the same as a 10-year-old kid. 13 14 DAVID: Agreed. 15 DICK: And you've got to take advantage of 16 the opportunity. You've got to take a chance, take 17 advantage while it's here. This opportunity will not 18 present itself. You have the power. You have it. 19 Sita was asking me, she said Dick, you have power. 20 Power? I don't have a darn thing. You do. 21 Now you, now you know how I feel, DAVID: 22 Dick. 23 DICK: You do have the power. You have the power. 24 25 DAVID: See, me and you are both negotiators.

To a degree you're right. Right.

DICK:

1 DAVID: You know, 2,000 years ago as Christ 2 sat before Pilate, he told Pilate I can do nothing in myself. 3 4 Well, listen, you have --DICK: 5 DAVID: Only that which I receive of the 6 Father. 7 The power is here, and it's here now. What I want you to do for me is, is give me, give me 8 9 something so I can go to my boss and say listen, the 10 man wants to get out and do this thing. Okay? I don't 11 want to go in to him say well, he may come out next week and next year. I want you to come out now, take 12 13 advantage of, of the opportunity. 14 You have the responsibility. You've been 15 given a responsibility. You represent the people inside there. Don't let it get away from you, David. 16 17 Don't let it get away from you. 18 This is power like few people in this country have ever been given. I'll never have an opportunity 19 20 like that. You cannot waste it. 21 DAVID: My --22 DICK: You absolutely cannot waste it. 23 DAVID: My authority and my power is not measured in the realms of man. 24 25 But let's work on that. DICK:

DAVID: Well, let me explain, please. Let me

try again. If you would do me a favor, if you would --1 2 DICK: Let's exchange favors now. 3 DAVID: Well, now wait. DICK: 4 Okay. 5 DAVID: I mean this, this is to your 6 advantage. 7 DICK: Okay. Let's hear it. 8 If you would be able to collect from 9 my mother --10 DICK: Okay. 11 DAVID: -- my grades and my report cards 12 throughout my life --13 DICK: (Laughing.) 14 -- and the special schools that I had 15 to go to because of learning disability and all that. 16 DICK: I remember you mentioned that. 17 DAVID: You would, you would find that what 18 is now speaking to you and what is now talking to you 19 is not the ability of a man. Now in man's effort, God 20 doesn't -- God goes pooh on man's effort. But when God 21 sees within a soul and a heart a desire to reach beyond 22 oneself, to lay claim to a source of, of strength and 23 power not of this world, then that's where the whole 24 concept of Christ comes in. 25 Now when this Christ who brings these seven seals comes, the judgment is not against him, for God

has already judged him. The judgment is for the world. 1 2 And so what really needs to be understood at this point is that what you are doing and your bosses 3 and all of those who by man have been given authority, 4 5 you should understand that your authority is in jeopardy, because as you speak and as you think, you 6 7 are showing not to what is seen of this world, but to what you don't see. You're being judged and tested 8 based upon your sincerity and your purpose of honesty. 9 10 Because if it is true, I say hypothetically just for 11 your sake. 12 DICK: Okay. 13 If it is true that this God who sits 14 on the throne has sent this Son into the world. 15 DICK: Okay. 16 DAVID: And if it is true that you at this present time are confronting such an individual who has 17 18 the ability to be able to show forth the seals in the light of all of the prophets. 19 20 DICK: All right. Go out and show those 21 seals, David. Come out of there and do it. 22 DAVID: Well, now you see you cannot 23 frustrate the work of God by --24 I'm not attempting to. DICK: 25 DAVID: -- by telling Christ what he is or is not to do. You see, the reason being is, is that what

Christ is or is, or is not to do has already been 2 preset. 3 DICK: All right. DAVID: Now --4 5 DICK: Maybe this event was preset too then. 6 Preordained. 7 DAVID: Well, the thing of it is this event 8 was preset. But you don't know that for a fact. 9 DICK: No, you just told me it was. 10 DAVID: Because -- but you cannot believe me. 11 Because he that believeth on me cannot believe on me 12 but on him that sent me. That's why scriptures made it plain that the seven seals have to be understood that 13 it is a book from God. And that the authenticy (sic) 14 15 of the prophetic writings which are harmoniously 16 matched to these seals. The seals are a preview. 17 the prophetic writing gives the details of what's --18 DICK: Okay. David, I'm, I'm getting a 19 little confused here now, okay? 20 DAVID: Now what I'm saying is if I was to 21 show you the first seal --22 DICK: Okay. 23 DAVID: -- you would know clearly in 24 revelation that what scripture has given is that when 25 the Lamb in heaven opens the first seal, the subject a

revelation of Jesus Christ which God gave to him which

is the book, the first seal, has something that 2 pertains to a noise of thunder and behold a white 3 horse. He that sit upon him had a crown, right? He had a bow and he went forth conquering and to conquer. 4 5 Now a person would have to be honest by saying well, I don't know how this really reveals 6 7 But of course, men might stand in the way and 8 say, well, a horse could mean this. White could mean 9 this. A bow could mean -- which is speculation. 10 it's very vast. But scripture has already deadlocked the key by saying that whatever this mystery may be 11 1.2 will have to be according to God declaring it to his 13 servants, the prophets. 14 Now we already know that Moses was a prophet. 15 Elijah was a prophet. Isaiah, Jeremiah, Ezekiel, 16 Daniel, Hosea, Zephaniah, Habakkuk, Malachi, you know. 17 Such and of the sword, Zechariah, Haggai. Now we already know that these men are content of our 18 19 scriptures or our Bibles which we say is the word of 20 If we do not understand their testimony, then it 21 goes right back to what I said earlier. 22 Sure enough in the writings of the prophets, 23 these prophets were told to seal their book until the 24 time of the end. That at the time of the end God would 25 miraculously preserve their writings so that the time of the end these writings would be opened as a fair

1 | sign. It's a sign. It's a miracle.

It's a miracle that man in his own wisdom who has researched and who has become scholarly who claims to have Master's Degrees of the knowledge of God, it would be a miracle that these men of this world would not know these things. Except for the fact that God says they will not know these things until it's time for these things to be revealed.

Now this is the one last miracle as a sign to a pending judgment against a nation whose sins have reached to heaven. A nation of great merchants. Revelations says of this empire that her merchants were the great men of the earth and for by her sorceries. You know, the art of deception. Advertisement, music video, sensuality. All nations were deceived.

The same also is in the realms of

Christianity. You know when a person plays an organ in
the background you get this nice, smooth music and a

What's the national seal? 5 6 I understand what you're saying. 7 Which is beyond Ethiopia. In other 8 words, farther than the realms of Northern Africa. 9 prophet no doubt was talking about ancient Assyria. 10 But he was predicting a prophecy which of upon Assyria 11 that was way beyond on the other side of the world. 12 And he says which sends ambassadors of peace to a 13 people terrible and scattered and (indiscernible). And God says regard ye amongst the heathen. You know, 14 regard marvelously. He talks about how he's going to 15 16 set up an end sign, and he's going to chase and, and punish this nation. It says the ambassadors of peace 17 18 shall weep bitterly. For God, God will regard no man. 19 The proud, the arrogant, the mighty shall be humbled. And it's just a terrible thing that's got to be 20 21 avoided. And the only way we can do it is as it says 22 in Isaiah. Let us reason together. But God's not 23 saying let me reason -- let you reason with me. 24 says let me reason with you. And God's word has to be 25 heard or forever taken away from those who refused it.

So what does it mean -- help -- maybe, maybe

I'm wrong. Help me out. In Psalms 2, the heathen 1 2 rage, the rulers take counsel, and the judges together, 3 prince together against God. They probably don't know what God's counsel is in the first place. 4 5 probably can't help it. They probably don't know what 6 they're doing, you know what I mean? It's probably 7 just a natural thing to think contrary to God. 8 And against his anointed -- of course, the anointed one knows the thoughts of God. He's got the 9 10 seven seals, right? And they kind of like saying let 11 us break their bands asunder and cast their cords from I mean they don't want the loosing of these seals, 12 13 do they? The knowledge of the seals would imply that 14 such a one who could do so would be the one which God 15 says is his son. 16 17 18

Of course, when you read Psalms 2 right there it shows that he that sits in the heavens shall laugh. Maybe that's why God says to wait. Maybe he's laughing at, at you. Maybe he's ready to bust your rear-end, and I don't want that to happen.

It says then shall he speak unto you in his wrath, and vex you in his sore displeasure. Although your ideals against the anointed one is contrary to God, it says yet have I set my king, my king upon my holy hill Zion.

DICK: 22 -- thee the heathen for thine DAVID: 23 inheritance. 24 Well, I hope you're not indicating that I'm that heathen you're talking about. 25 Well, let's see how you listen. DAVID:

The Adventist is going to be the remnant church and, and they have the -- anyway, a lot of 10 11 statements are made which in a degree when being 12 approached I approached them and I stated look, you claim because you go to church on Saturday that you are 13 a step better than those who go to church on Sunday. 14 15 DICK: Okay. 16 True, the levitical Sabbath is DAVID: 17 Saturday. The day of the Jews is the Sabbath. But 18 when men who have kept the Sabbath have sinned against 19 Christ who is the Lord of the Sabbath, then the Sabbath 20 is made no Sabbath, wouldn't you agree? 21 DICK: I would agree 100 percent. 22 DAVID: Okay. So in other words, Paul says 23 clearly in the scriptures based in Timothy and his 24 writings that since Christ has come, Christ and Hebrews has lived another Sabbath. Okay, and Paul said that 25

each man be persuaded in his one mind. One man astains

1 (phonetic sp.) one day unto God. Another man astains
2 not a day. Okay? One man astains one day above
3 another. Another man astains all days alike.

So if Paul's writings are clear, then the subject of the Sabbath and the laws have to be redefined and re-understood. Because those who keep the Sabbath really don't keep it. And those who don't keep the Sabbath may be more sincere in their observance to Christ and his nature than in some kind of law saying well, today's the Sabbath day. I guess I better sit home and be holy.

So you see the Adventists teach in their writings the great controversy very direct political things revolving around what they say this United States of America is going to do for them.

DICK: Um-hum.

DAVID: Although when Dr. Walter Martin, you know, the late Walter Martin, when he confronted them, they would always deny their doctrines and deny their LNG White as a prolific prophet of God. And they would in turn go right back to the same old basic Evangelical well, no, we believe in doing good. And we believe in being just Christians. And, and this, that and the other.

When you confront the institution with the seven seals, they will tell you that they know clearly

what the seven seals are. Okay, that's their right as
well as any other organization in this country.

But when it comes down to the right of freedom and speech -- when I went to Australia, I presented the seals to certain students in schools and to certain people. And one night as we were having a study, there were eight men, the conference president of the Adventist Church was one of them. Some of their top ministers came over, came in very aggressively into our meeting, and they sat there wanting to know what this was all about.

Okay, very politely I said well, sirs, it's very simple. And we began to read Revelation 4 and 5 about well, this be hereafter, God on the throne, a book in his hand, gave it to the Lamb who only can open the seals.

DICK: And they didn't appreciate it.

DAVID: Well, I mean they, they couldn't say nothing. Because we was reading word for word.

DICK: Um-hum.

DAVID: And I'll just read a few words the way I teach and ask a question. Well, does this not mean and then I'd read the same words again. Everyone goes yeah, that's what it means. Okay.

DICK: Um-hum.

DAVID: So then I said sirs, the point of

issue here is that I would like you to allow me to serve you. I would like to emphasize that many minister of this world will have the nerve to tell you that that book is the Lamb's book of life and that it has our names in it. Although scripture says no one knows what's there. And of course, they kind of like, you know, well, yeah, yeah.

I said now it would be an unjust statement for a minister to tell his denomination that our names are written in that book when nowhere in the Revelation does it say that. You know?

And besides, question number two is if only the Lamb can reveal it, only when the Lamb reveals it will we know these things. Well, the Lamb did reveal it, son. Well, where did he reveal it? He revealed it in heaven. Now why -- okay. Okay, now here's the deal. If the ministers say that he revealed it, and it pertains to the horses, well then what lesson is there to be able to increase my knowledge in Christ and to make me the saint the scripture promises I'm supposed to be with the knowledge of Christ. Well, again, there's nothing. It's a dead end, it's a dead end argument. They don't know. Okay.

So then when I go okay, sirs, we look here at chapter 22. Jesus promises to come with his reward.

Now a question honestly. What was the reward that

Christ received that no one else in the heaven was worthy to receive?

And they all kind of like look at each other and it's kind of like oh, it's obvious, isn't it? A book. A statement so long misunderstood their first instinct would be to say we received honor, glory, power, riches, right? But no. They think and so they go, well, wait a minute. Oh, boy. He's got us on that one.

I go this is just like what Isaiah says.

Isaiah says behold, the Lord God will come with a strong hand. His reward is with him. What's stronger than the reward? The word of God. His work before him. Once he comes, he's got to do a work. His work's before -- he's got to do a work with this word of God. He's got to teach this word of God. He shall gather his flock, those who believe in God's word, like a shepherd.

I said now this is very unique, isn't it?

And they're like oh, well, what's your point, you know?

So see these, these men of scholarly, these guys

telling me, you know, this guy knows some odd 10 or 12

languages all -- you know, these are, these are top

dogs, right, in the religious spectrum. You know, and

But when you have guys having these 16 Bradleys come and sit in like -- within 100 feet of like the gymnasium, moving back and forth, crunching 17 18 over buildings and all the rest. Now they're down 19 there with their sandbags and all the rest of it, 20 that's not what the agreement was at all. 21 Let them do it over across the street or 22 wherever else they want, but we agreed not on the 23 property. 24 DICK: Steve, listen --25 STEVE: Is that such a hard request to make? DICK: -- there were some agreements, there

If he is, the reason I'm here to hear his 15 information is because he has gotten it from a source 16 that I've seen a scholar to be able to obtain the same 17 information. So this man says his god said to him to 18 wait. And as whatever that may seem to anyone and, and 19 what it might look like to my own name or association, it still came down to either I fear God or I fear man. 20 21 So, you know, we went through those issues, 22 around and around. But it still remained before or 23 after that --24 JOHN COX: You know, I'm not, I'm not going 25 to argue that the spiritual issue --

STEVE: No. No, no, of course not. But,

1 John, that --2 JOHN COX: And I know it's both a logical 3 issue and a spiritual, factual issue. 4 STEVE: Okay, but it still comes down to --5 JOHN COX: And they're there. John, but it still comes down to 6 STEVE: 7 every day and in the evenings these men are doing the maneuvers. I mean, they're coming as close as like 50 8 9 to 100 feet near the back building. Men are deployed. 10 They're out running around, they're in vehicles, 11 they're digging around, you know, all of these kind of 12 things. They're -- They've got certain calls and 13 sounds. 14 JOHN COX: Let me, let me respond to a couple 15 of those issues --16 STEVE: All right, go ahead. 17 JOHN COX: -- that you have. Again -- And 18 again, it, it may not be satisfactory in, in your point 19 of view, but I'll be happy to respond to them and, and 20 we can kick around a little bit. 21 STEVE: And keep in mind, though, not happy 22 and satisfied because of the statements made from night 23 one, the evening and the, and the beginning night that 24 we started negotiating. 25 JOHN COX: Um-hum.

STEVE: Go ahead.

JOHN COX: Okay. And we can probably argue 1 2 the issue about the, the tract vehicles that are out 3 there. They're out there. They're not probably going 4 to infringe any further, but they were put out there with a purpose in mind initially, and that was we are 5 aware that there's a lot of weaponry out there and, and 6 7 some that we would consider some devastating weaponry. And, as a matter of fact, David brought up an issue of 8 some of it last night and, and we didn't want to pursue 9 10 that with him. And I, and I have no intention of 11 pursuing, you know, raising threat levels, lowering threat levels. I'd just like that to remain neutral. 12 13 As far as whether you saw people in, in 14 bunkers, you're talking sandbag positions --15 Well, see, you don't --STEVE: 16 JOHN COX: -- it's because of --17 STEVE: What David says about -- Understand, 18 John, you don't -- you yourself, from your perspective, from your position, you don't need to say anything. 19 20 It's your actions, by what these men are doing, 21 contrary to what was stated, the word given the first 22 night. Think of that, keep that in mind when you're talking to me about maybe threats or what he was saying 23 24 or anything else. 25 JOHN COX: No.

JOHN COX: No. You understand there's a, you know, there's about three or four mindsets bouncing

1 around out here. You've got the theologian mindset 2 going, you've got the, the negotiating mindset --I do understand --3 STEVE: JOHN COX: -- that we're certain trying to 4 5 do, you've got the tactical mindset out there that 6 we're trying to keep that to a minimum. And even 7 though we all have a purpose, and the purpose is, is 8 safety --9 Okay, John --STEVE: JOHN COX: -- and control --10 11 STEVE: John, David wants to talk to you. 12 JOHN COX: Go ahead. Go ahead. 13 Okay, here he is, John. STEVE: 14 JOHN COX: Fine. 15 STEVE: This is, this is David. 16 JOHN COX: Fine. 17 DAVID KORESH: Hello, Mr. Cox. 18 JOHN COX: Hey, David, nice to talk to you. 19 DAVID KORESH: Nice to talk with you, too, 20 The issue that we're trying to resolve here is that, you know, definitely in our, our crisis, at our 21 22 present position, is that it is stated, it's stated 23 publicly that investigations some eight to nine months 24 ago have unveiled and proven that we have stockpiled an 25 enormous amount of, of military-type weapons. that it proves that we have .50-caliber machine guns

and possibly destructive devices. 1 2 JOHN COX: Yeah. 3 DAVID KORESH: Now, based upon this premises 4 or this fact, of which, you know, the public is 5 hearing, you see, what happens is that we have -- we've been confronted, they say, with a warrant, you know. 6 JOHN COX: Well, again, we're not saying it's 7 8 fact, David. We're saying that we, we believe we have 9 probable cause to believe, all right? 10 DAVID KORESH: Exactly, probable cause --11 JOHN COX: That's what we're saying. 12 DAVID KORESH: -- to believe --13 JOHN COX: Sure, go ahead. I didn't mean to 14 interrupt you. You go right ahead. 15 DAVID KORESH: Okay. All right, now, now, this probable cause I know as a fact is based upon 16 17 hearsay of which students in the past that I have tried 18 to teach have taken from certain prophetic writings in 19 certain degrees, such as the book of Nahum. I've tried to explain this. And they have seen in picture, a 20 21 layout of what God foretells in the future. Okay. And 22 certain, certain passages would not be properly 23 understood until certain mechanical modernization or 24 such devices of modernization of today was to be obvious and seen in our today's world. 25

Certain passages of scripture would not be

understood in the past decade because --1 2 JOHN COX: We're not talking about a matter of misinterpreting passages or what somebody's 3 observed. 4 5 DAVID KORESH: Yes, yes, we are. Now, here's 6 the thing. You are saying, in one degree, that we are 7 well armed. Okay? And so on the other hand --JOHN COX: No, I'm saying that there's that 8 9 feeling in mind. 10 DAVID KORESH: -- you are saying that you are concerned with not just the safety of us, but the 11 12 safety of your personnel. 13 JOHN COX: Well, that's reasonable, isn't it? 14 DAVID KORESH: It's reasonable, very reasonable. And on the other hand, the negotiators 15 16 have stated very clearly that their purpose is to 17 provide a perimeter of safety, not so much for, for the 18 purpose that they're afraid of us, 'cause we've given our word, but they're concerned about people coming in 19 20 from the outside of the property. Okay, now --JOHN COX: Well, it is a two-way street. You 21 22 know how many -- Well, you may not know physically, but 23 you have a pretty good idea that there are a lot of 24 media people in very close proximity out there. And 25 per se you keep them out of harm's way. We have an

obligation, not just, you know, some administrative

procedure, we have an obligation to ensure the safety 2 and the welfare of those people, as well as we really 3 have an obligation to see that we don't have another problem like we had last Sunday, and we want to ensure 4 5 that that doesn't happen. And don't you agree there? 6 DAVID KORESH: Yeah, I definitely agree with 7 this now. 8 JOHN COX: Sure. 9 DAVID KORESH: When the wisdom of speech is 10 now being presented, we would consider it if we was 11 able to consider it at an earlier time. Now everyone's 12 got the right words to say. Now, but what you're --13 JOHN COX: Well, we're trying to rectify --14 DAVID KORESH: You didn't let me finish. 15 JOHN COX: -- maybe things that have gone, 16 gone wrong before. You know that and I know that. 17 DAVID KORESH: You didn't let me finish. 18 JOHN COX: Go ahead. 19 DAVID KORESH: Now, Robert Gonzalez, I have 20 asked the, you know, mediators there --21 JOHN COX: Sure. 22 DAVID KORESH: -- let me speak to this young 23 A young man that knew every day that I jogged. I 24 jogged up and down. We've got a mile-and-a-half road 25 here, from one end of the water towers down to the other end of this dirt road. At any -- Now, at any

time you boys -- Of course, you're FBI, but the --1 2 JOHN COX: We've got all the different 3 agencies around here. 4 DAVID KORESH: Anyway, right now -- Or the Sheriff's Department had any question in regards to my 5 so-called stockade, you could have taken me any number 6 7 of times that I go to town or I go to Wal-Mart -- And the report that I've been here for two years without 8 9 leaving is a lie, a bad lie. 10 JOHN COX: What would, what would they have 11 taken you for? 12 DAVID KORESH: They would have taken me, 13 given me a warrant in regards to my premises, a search 14 warrant for illegal weapons. Very naturally, what they 15 say is my violation. 16 JOHN COX: But that would have to be served -- That would have to be served upon you at the 17 18 premises. 19 DAVID KORESH: Well --20 JOHN COX: It's a warrant for the premises, 21 not for the person. 22 DAVID KORESH: For -- Okay, look -- For the 23 premises? 24 JOHN COX: Sure. 25 DAVID KORESH: Wait a minute. This is supposed to be against David Koresh.

JOHN COX: No, it's not. It's for the 1 2 premises known as, not for the individual known as. 3 DAVID KORESH: There, there, there again, there again, this is a problem with what you, the ATF 4 agents, have stated on national TV and what now you're 5 6 telling me now. Okay. JOHN COX: No, I don't think there's a 7 conflict at all. 8 9 DAVID KORESH: It's --10 JOHN COX: No one had a warrant for your 11 arrest or -- to my knowledge. 12 DAVID KORESH: Steve. Wait, wait one moment. 13 Now he's saying no one had a warrant for my arrest. 14 JOHN COX: I'm not aware of it is what I'm 15 telling you. But I am telling you --16 DAVID KORESH: Unbelievable. 17 JOHN COX: I'm telling you that they had a 18 warrant to search the premises and --19 DAVID KORESH: Unbelievable. 20 JOHN COX: Hang on. 21 DAVID KORESH: Well, again --22 I'll, I'll get it clarified. JOHN COX: But 23 I do know that they had a warrant to search the 24 premises. 25 DAVID KORESH: Well, Robert Gonzalez, who is the informant, which we knew he was --

1 JOHN COX: And they did have a warrant to 2 arrest you. 3 DAVID KORESH: Okay. JOHN COX: But that was as of that time, 4 5 okay? 6 DAVID KORESH: Right. Now, Robert Gonzalez, 7 as you know, preparations were made for him to move in 8 here. 9 JOHN COX: Sure, sure. DAVID KORESH: Now, the thing of it is is 10 11 that if you all had desired to be so cautious in all 12 those respects, you know, except for maybe possibly 13 other reasons that you haven't quite stated as of yet, you know, Robert Gonzalez who was developing a pretty 14 good friendship with us over here -- Excuse me, uhhhh. 15 16 JOHN COX: Why don't you get yourself 17 something to drink? DAVID KORESH: Well, it, it comes in and out 18 19 like that. 20 JOHN COX: All right. 21 DAVID KORESH: That morning, that Sunday 22 morning, you know, I sat down and had a real close talk 23 with him. And it just appears to me that in the 24 promises that I have been given, that I got in 25 Australia, the threats and the warnings, and also, you know, the -- when I was over in England last and stuff

like that, it seems to me that an agency, either 1 2 knowingly or unknowingly, is being utilized to possibly 3 genocide a work or a people, even though they may make up lies to, to try to bring about something which 4 5 really -- it comes down to a conscience freedom. 6 Now, I've explained this so many times to every different agent that I've talked to so far. 7 8 I've been pretty, pretty privy to JOHN COX: 9 most of the, the dialogue that's been going on. 10 DAVID KORESH: Okay. So --11 JOHN COX: You know, not 24 hours a day, but 12 throughout the period of time I have and, and, you 13 know, you're, you're raising the issue of genocide and, 14 and --15 DAVID KORESH: Again --16 JOHN COX: -- I think that's a, that's a pretty false term to be throwing out. 17 18 DAVID KORESH: Again, again, we find another 19 lie being presented here, because, very clearly, Jim 20 and --21 JOHN COX: John. 22 DAVID KORESH: No, Jim, Jim was the first one 23 we was talking to --24 JOHN COX: Okay. 25 DAVID KORESH: -- before Gary, and then came, you know, Henry.

1 JOHN COX: Go ahead. 2 DAVID KORESH: You know, they're always 3 acting as if no one hears what we're saying but them. 4 Now, here you are implying that you all are privy to 5 it. I mean, you know --6 JOHN COX: No. 7 DAVID KORESH: -- you guys are not very good 8 when it comes down to being honest. 9 JOHN COX: No, no, no. Listen, I've been 10 sitting here with Henry most of the time. 11 DAVID KORESH: Right. Now, I like Henry, too, just like I like --12 13 JOHN COX: And, and that's why I say what I 14 I have been here with Henry, accompanying Henry 15 and, and I'm an associate of his. I'm not out running 16 around some other area or, or in a different area. 17 I've just been here, so I've been privy to most of the 18 dialogue that's going on during the --19 DAVID KORESH: So where's Jim at right now? 20 JOHN COX: Henry's got another assignment 21 right now. 22 DAVID KORESH: Okay. 23 JOHN COX: He's not assigned here permanently 24 and I, I can't tell you he'd be back here in an hour, I can't tell you he'd be back here in a day. He just --25 As a result of his work, you know.

DAVID KORESH: Okay, we'd appreciate that the 1 2 gentlemen don't try to, you know, that they stay out of 3 the sandbox tonight, okay? JOHN COX: Well, I think they pretty well 4 stayed out of the sandbox the last couple of nights. 5 6 Things were pretty peaceful and quiet out there. 7 DAVID KORESH: Okay. Well, I'm just, I'm 8 just saying you guys are saying that you want peace and 9 I'm just --10 JOHN COX: Well, we do. 11 DAVID KORESH: -- saying be sure to --12 JOHN COX: Don't you? 13 DAVID KORESH: -- tell the people to stay out 14 of the sandbox. 15 JOHN COX: You know, something that you 16 brought up kind of struck a nerve with me and I hope 17 you didn't really mean it seriously, and that's when 18 you talk about the issue of genocide. And I think 19 that's an awful strong word to come up and, and we know 20 that we can talk freedom of speech and freedom of 21 religion and all of these items. And, really, the, the 22 only way others are going to hear about your, your thoughts here and your, your opinions and -- is really 23 24 for you to discuss them. 25 Now, whether it's discussing it with the media, whether it's through the judicial system, you

know, we've got from the old days of political science 1 2 we've got our three systems. And, of course, we're 3 only one of them, right? We're the executive branch. And the judicial system's going to resolve this in the 4 5 end. And it's the best system there is. You may not 6 as a result --DAVID KORESH: Well, it's patterned after 7 other worlds. 8 9 Yeah, but if you want to, if you JOHN COX: 10 want to look at any other systems in the world --11 DAVID KORESH: Okay. 12 JOHN COX: -- what we have is the best and 13 it's as close to the peers as it'll ever get. And, and 14 we have to accept it from, from a law enforcement 15 standpoint, and it's a good adversarial system. But 16 we're -- Certainly, certainly genocide is a strong, 17 strong word for you to throw out. And you know better 18 than that. 19 DAVID KORESH: Well, now, let me --20 JOHN COX: You know what I'm talking about 21 there. 22 DAVID KORESH: Let me, let me make another 23 statement. Let's be realistic now. You have an agent 24 in here -- Not you, this is the ATF. 25 JOHN COX: I know what you're talking about.

DAVID KORESH: You know, ATF is, is not well

experienced as, as the guys in the FBI. Now, the FBI, 1 that's the top, no doubt about it. You are the top. 2 3 JOHN COX: Well, I'm not going to make any disparaging remarks about them, either. 4 5 DAVID KORESH: I'm going to just state some A month ago, possibly two months ago, several 6 7 young men moved into a house across the street, all of 8 them possibly from their, you know, thirties, mid-9 thirties to early, early forties. Each one drives a 10 new vehicle, you know, a late model vehicle, and each 11 one begins to state that they are going to junior 12 colleges to, to take certain classes. Now --13 JOHN COX: Sure, what's you're saying, it's a 14 sham, right? 15 DAVID KORESH: Well, what I'm saying is is 16 that the, the undercover didn't need to be in the first 17 The undercover was very poor. Well, anyway, we, we went ahead and sent some friends over. Like I 18 say, there's nothing that I, that I like more than to 19 20 be understood, you know. 21 JOHN COX: So I understand. 22 DAVID KORESH: And so the thing of it is is 23 that I -- we sent some guys over to talk with these individuals and, and, of course, when they addressed 24 25 individuals, individuals are kind of jumpy and nervous and --

1 JOHN COX: Sure. 2 DAVID KORESH: -- you know. And so, finally, 3 what happened was is Robert Gonzalez came over and another guy, I think Jeff -- And who's the other guy, 4 5 Jim? And the first thing they wanted to start 6 talking about is, is guns. 7 JOHN COX: Um-hum. 8 DAVID KORESH: You know, Jeff and -- Anyway, 9 and the subject they wanted to bring up was AR-15's. They said they had just purchased two AR-15's and tried 10 11 to act very naive in regards to what they had 12 purchased. Of course, they had paid some sum of 900 13 and some dollars apiece for these and wanted to know if 14 I knew anything about it, which, of course, I says to 15 them -- 'Cause I do go to a lot of gun shows, and this 16 is where the trail began in the first place. 17 So what happened was is that in going to 18 these gun shows and obtaining knowledge and stuff on 19 these things, we started a conversation and they came 20 over and, and he brought a pistol over that he wanted 21 to show me, which was a little target pistol. 22 JOHN COX: Um-hum. 23 DAVID KORESH: And just the way the thing was 24 feathered and everything, it was definitely a gun that 25 a novice would not have.

JOHN COX: Okay.

DAVID KORESH: Okay? So he asked if he could come over and if he could shoot. I said sure, we've got a place in the back where we, where we practice at, you know, we have a place where, where me and some of the guys out here practice. And, and definitely, anybody that wants to come around can fish on our property and they can come and --

JOHN COX: Sure.

DAVID KORESH: And if we have, you know, a proper day and stuff like that where no one's -- no activities are too involved, then sure, you know, a little handgun practice is all right. So, anyway, though his mannerisms were trying to be naive, there's just one thing that, that you cannot hide, and that's proficiency. So then he started asking me all these questions about this AR and I kept saying now, now, Robert, you know, I says, you know in your line of work you know what this is. I gave the man every opportunity to come straight across the table and to confront me. Okay.

He says to me, he says well -- I explained to him one time he had better be careful because he had mentioned about when he first got his pistol back from the shop that he went out and put a clip in it and all of a sudden it just went -- fired all the rounds out of it. And so I says, I says hey, I says you better be

1 careful. I says because one time --2 JOHN COX: Well, you're talking from a safety standpoint or --3 4 DAVID KORESH: Well, no. 5 JOHN COX: -- a proficiency standpoint? DAVID KORESH: Well, see, the thing of it is 6 7 not only safety, he said he'd had some work done to it and it was firing full auto. It was emptying the whole 8 clips out of it. Okay. So I told him, I says look, 9 10 Robert, I says you've got to be careful with that 11 stuff. I says one time at a gun show we purchased a 12 little unit that they were advertising. It's called a 13 It's a little spring thing that fits on the hell fire. 14 back of a trigger well for a mini 14, or they have them 15 for AR-15's or such like guns. And, and you put this little spring back behind this trigger and you, and you 16 17 hold the gun a certain way and, and you kind of hold it there and it kind of fires rapid fire, faster than what 18 19 you can do it yourself. 20 JOHN COX: Um-hum. 21 DAVID KORESH: I said now, we had, we had --22 we bought a couple of these and, and we put them on a 23 .223 rifle one time and we was out in the back and we 24 were having a blast. 25 JOHN COX: But it's still not an automatic

weapon, though.

1 DAVID KORESH: No, it's not an automatic. 2 JOHN COX: It's still a semiautomatic weapon. DAVID KORESH: But, but what happened was is 3 4 that as we were in the back of our property firing 5 this, low and behold, the report comes back that there's an investigation. You know, this came, this 6 7 came through some of our neighbors around here. We've got a lot of good neighbors around here. And certain 8 9 agents and stuff were, were asking to set up special 10 microphones and things like that because of our machine 11 gun fire. 12 JOHN COX: Um-hum. 13 DAVID KORESH: So here we go again. So I 14 told, I told a friend of mine, I said look, you know, 15 one of the guys had purchased one. I says look, tell them if they want to come out, they can come out and 16 17 check the place. I said but here's the thing. Every 18 -- Any --19 JOHN COX: You didn't, you didn't address 20 that as Robert can come out, you're basically talking 21 about --22 DAVID KORESH: No, no, this is before Robert 23 and them came. 24 JOHN COX: Sure. Sure. 25 DAVID KORESH: Okay, this was, this was long before. This was when we first heard about, you know,

the agents and stuff wanting to --1 2 JOHN COX: Okay. DAVID KORESH: -- gather 'round the place and 3 go to the people's properties and put up, you know, 4 little listening devices in case of any full auto, 5 6 automatic fire was heard again. JOHN COX: 7 Okay. DAVID KORESH: Okay, so we went down to the 8 Sheriff's Department and we took the units and we said 9 10 look, here's your machine gun right here. We says --11 And they threw it down on the table and they says, you 12 know, you know, if you ever have any question or 13 anything, you know, you know where we're at. We've 14 invited you guys out to fish, we've invited you to 15 If you need to do anything, we are here. We've 16 worked this place over since 19, since 1970 -- since 17 1987, 1988. We've totally remodified. We've worked 18 our rearends off, we've tried to make this place nice, 19 you know, we've done everything in our power. 20 We've had the, the case when it came to so-21 called child abuse charges. All of our children were looked at, they were perfectly all right. You know, 22 23 social workers, we know those ladies down there, 24 Mrs. Coon and everything. 25 JOHN COX: Sure.

DAVID KORESH: They came through.

They

1 wanted to know where I kept my firearms. I showed them exactly where I kept my firearms. They went down, they 2 3 saw the firearms. They, they saw where they were at. They were in a safe place. I mean, everything --4 5 JOHN COX: They were very satisfied, I take it? 6 7 DAVID KORESH: Well, the thing of it is this. 8 If there needed to be any further investigation, we 9 were open at all times. Who were the two lieutenants, 10 the two Sheriff's Department guys that came, Steve? 11 STEVE: Larry Abner --12 DAVID KORESH: Larry Abner. (Steve in 13 background not discernible.) The Spanish guy. 14 Jim Leondo. You know, very, very nice agents. Very 15 nice guys. You know, they came up and, of course, what 16 happened was is that there was, there was some, some 17 vehicles -- When they came with the social workers, 18 there was vehicles parked down by the water towers and 19 down below the dam. You know, back-up teams in case 20 something happened. This was ridiculous. The, the 21 three stories -- The two-story and three-story 22 structure --23 JOHN COX: Well, why do you think those 24 vehicles were there, David? 25 DAVID KORESH: -- that you all were calling -- Because of nothing but rumors.

1 JOHN COX: That's probably the bottom line, 2 huh? DAVID KORESH: Okay, but here's the deal now. 3 4 JOHN COX: But they were, they were just there, whether it was rumor or wasn't rumor, to try and 5 6 support somebody. 7 DAVID KORESH: We understand -- Now, here, here's what I -- here's how I dealt with the situation. 8 9 You can call --10 JOHN COX: Sure. 11 DAVID KORESH: -- Mr. Abner up and talk to 12 him. 13 JOHN COX: Okay. 14 DAVID KORESH: Like here's, here's the situation. When I left to go on a, on a, on the 15 16 little missionary trip one time and certain individuals around here -- We were building this place, getting it 17 18 ready for, for the teachings, okay? So people could 19 come from all over the world and learn these seals, 20 'cause, 'cause I physically am not able to keep up 21 traveling like I've done to different countries and 22 change all different time zones and stay up physically 23 and be able to teach this stuff night and day. 24 JOHN COX: Sure. 25 DAVID KORESH: But here's the thing. left, they asked me if they could build, you know, the

1 building and stuff, you know, in a certain place, and I 2 said yes. When I came back, they had built the three 3 stories and I -- It's not that I -- we've tried to make no tower or nothing. It's we had tore down 13 houses 4 off this property. There was plenty of lumber and we 5 bought the siding and stuff and the place just evolved. 6 7 There's no floor plans on this building, it just 8 evolved. 9 Now, all the neighbors around here can tell you that. Okay, now, so we used to -- people used to 10 11 drive by and say it looks like a, looks like a fort, it 12 looks like we're Indians and they're cowboys, you know. 13 And that's, that's perfectly all right. 14 JOHN COX: Maybe that's 'cause you have the 15 high ground, huh? 16 DAVID KORESH: Well, the thing of it is is --17 JOHN COX: Whatever it is, it's very visible. 18 DAVID KORESH: -- the high ground --19 JOHN COX: That's all. 20 DAVID KORESH: Yeah, okay. Now, but here's 21 the thing. So when the Sheriff's Department came out 22 assisting the social workers, I went out on the front 23 porch, at which they were sitting -- standing out 24 there, and I went out there and I, I came straight 25 across the table and I said, I said -- 'cause I was intimidated to a small degree because of all this back-

1 JOHN COX: That's why they came here. 2 DAVID KORESH: -- of their, their days. 3 We all agree, Lady Liberty. Okay, now, but what 4 happens is, as I said, well, you know, the thing -- the 5 place where we're coming from that gets us into a lot of trouble is that connected with religion is also a 6 form of politics. In other words, churches as well as 7 8 political powers, they have their presidents, their vice presidents, their board of trustees. They have 9 10 their elders, they have their, you know, their little pyramid system of government. 11 12 JOHN COX: Sure, they all do. 13 DAVID KORESH: Exactly. And they have an economic government. 14 15 JOHN COX: You have to have some structure to 16 any, anything. 17 DAVID KORESH: Definitely. You have to have 18 some organization. 19 JOHN COX: Sure. 20 DAVID KORESH: But now, the point is this. 21 That organization, nonetheless, states clearly that it 22 is dedicated to the service and worship of Christ. 23 That's one thing they all harmonize on. 24 JOHN COX: Sure. 25 DAVID KORESH: They're doing it because of the reality of Jesus. They're, they're doing it in the

name of Jesus. Jesus owns it, really. Jesus is really 1 2 in charge of them. You see what I'm saying? JOHN COX: 3 Um-hum. 4 DAVID KORESH: And they're really just doing 5 it 'cause Jesus wants them to. And when Jesus comes 6 back again, they're going to turn it all over to him 7 and, you know, they're all going to go to heaven. 8 this is the whole overall picture of the hope of 9 Christianity. 10 JOHN COX: You bet. 11 DAVID KORESH: Okay. 12 JOHN COX: Everybody's looking for the same 13 ideals. 14 DAVID KORESH: Right. Now, so when you, when 15 you back-track and you confront the Christian church, 16 the question is do they believe in Matthew's record of 17 Christ? Yes, they do. Okay. Do they believe in Mark, 18 Luke and John? Yes, they do. Okay. 19 JOHN COX: Sure. 20 DAVID KORESH: Now, do they believe in the 21 record of Acts and Paul's writings and Timothy and, and 22 Romans and James and Jude and John? Definitely, they 23 They may not understand every record clearly. 24 JOHN COX: And they may interpret them a 25 little differently.

DAVID KORESH: Exactly. And so, but that's

1 their right. 2 JOHN COX: That's human, human logic, huh? 3 DAVID KORESH: Exactly. And that's just 4 something we all have to, to tolerate, especially in 5 religion. 6 JOHN COX: Sure, it is. 7 DAVID KORESH: Now, remember, some people 8 with their opinions can become quite convicted and 9 become quite aggressive or zealous for their opinions. 10 So we know what the Jews did to Christ 2,000 years ago 11 with their opinions, right? 12 JOHN COX: Sure. 1.3 DAVID KORESH: So, you know, we know what 14 the Papacy --15 JOHN COX: Well, we can go through, you know, 16 one religion after another there, can't we? 17 DAVID KORESH: Exactly. 18 JOHN COX: Sure. 19 DAVID KORESH: So, you know, we know that the 20 Papacy, when it was questioned by the Lutheran Reform, 21 or even before by Hush, Jerome, Tenda, Wynard, Wycliff, 22 whatever, we know that when it was questioned, instead 23 of producing, you know, very simple and conclusive 24 answers, it rose the sword and killed these men. 25 JOHN COX: No question the strength of the Papacy.

DAVID KORESH: Exactly. So the Europe which 1 2 was once ruled by Roman Catholic Catholicism which, you 3 know, the name in itself tells you its, its purpose is for Rome to rule universally. Catholic, you know, 4 5 everything. It takes on the garment of religion and still holds the power of policy and anything that goes 6 7 against its religion is going to get this policy, and 8 the policy has the power to execute, capital 9 punishment. And so those who went against the religion 10 were going against the government, and they were 11 proscribed and they were condemned and put to death. 12 Now, the --13 JOHN COX: Yeah, you can't argue that fact, 14 can you? 15 DAVID KORESH: Exactly. The Inquisition was 16 a political religious move. So, now, we, the United 17 States of America, God bless this country, we understand the, the importance of having the right to 18 19 think. We also know that Christ on the cross, when he 20 died, he made a very clear statement for all men to hear, and that his Father, forgive them for they know 21 22 not what they do. 23 JOHN COX: Yeah. 24 DAVID KORESH: Now, whatever God knows and 25 whatever Christ knows, we don't know, but we know that Christ does know we don't know. And so, therefore,

Christ confers to the Father and asks the Father to 1 2 forgive us based on our ignorance. Okay. So now, if Christ can do this --3 JOHN COX: Well, I think that's one of the 4 5 strongest teachings of any religion, right? 6 forgiveness, isn't it? 7 DAVID KORESH: The whole teachings of the new 8 covenant. 9 JOHN COX: Sure. 10 DAVID KORESH: Okay. Although the Papacy in 11 the same name didn't quite so forgive. And the blood 12 we share --13 JOHN COX: Well, that's a few years ago, too. 14 DAVID KORESH: Exactly now. 15 JOHN COX: Sure. 16 DAVID KORESH: But, but remember that because 17 it was such a, you know, nonevasive fact for that time, 18 the forefathers finally developed the desire and the 19 knowledge to be able to come to a country, which this 20 country opened up, and they began to realize by 21 experience that the oppressive tyranny of religion and 22 politics must be done away with, avoided, by a definite 23 rule of church and state separation. 24 JOHN COX: Absolutely. 25 DAVID KORESH: There needed to be a political law which was good for all men and just for all men,

Like you were 4 5 saying, you can go to different places and, because of who someone perceives you to be, you get whacked. 6 7 DAVID KORESH: Well, you said it and I 8 agreed. 9 JOHN COX: Sure. 10 DAVID KORESH: Now, here's the deal. 11 explaining to these gentlemen out here in my front 12 yard, we're sitting out here, and I'm saying now, now 13 where I come from, what gets me into a lot of trouble with denominations and with -- You know, denominations 14 15 are people. People made up together are denominations, 16 aren't they? And they name themselves, to entitle 17 themselves to be distinct and separate from another 18 group, not to be, you know, excused as another group. 19 So they have their denomination. 20 And so I come along and I, I refocus back on 21 the subject of the one reason for there even to be a 22 profession of Jesus Christ, and that's Jesus Christ. 23 JOHN COX: Um-hum. 24 DAVID KORESH: And so very clearly I try to, 25 to tell the brethren, the fellow humanity, that well,

is it not true that maybe we might not know exactly

what we're doing? I mean, you know, we may think we 1 2 know what's right, but maybe we might be wrong. Could be. And none of us should escape that possibility or 3 4 to deny that possibility. You know, there's women and 5 men, you know, that seems to be right, but they may be leading to death, you know. It's, it's a sad thing, 6 7 but we can only go in the best obvious light that we 8 perceive, giving ourselves over --9 JOHN COX: And it's very difficult to 10 criticize someone else's feelings and someone, you 11 know, whether they're religious, moral, ethical 12 feelings, unless you sit down and listen to them and

listen to what they have to say.

DAVID KORESH: Exactly. Now, Christ on the cross didn't say much, but what he said was important. He says into thy hands, Father, I commit my spirit. And that's the thing I've been trying to illustrate to each one of the individuals thus far I've spoken to.

Now, we find in the hand 8 of God there is to be a book, and, of course, we see 9 that the apostles state that Christ is the word of God made flesh. You know, all of those are made by God, by 10 11 one spirit, God's spirit. All things are created from 12 God. There's only one God, there's one spirit, there's 13 one knowledge, one power, one reality.

And if we're out of tune with this source, then definitely we may be involved with many ideals of God which means we're worshipping many ideals of God's.

Many gods, in other words. Many --

JOHN COX: And that's, that's a difficult point, you know, where you're saying are we in tune with it or aren't we. And, and that's what searching's all about, isn't it?

DAVID KORESH: Exactly. And that's what freedom in this country has been blessed by God -JOHN COX: Sure.

DAVID KORESH: -- because naturally God has blessed this nation above any nation, hasn't he?

1 JOHN COX: You bet. 2 DAVID KORESH: This nation has been blessed with any nations because for the longest time, since 3 4 its birth, this nation has purported and proposed not 5 to restrict or to interfere with the conscience of man. 6 In other words, we have a political law which says that 7 if you do this, irrespective of whether it be of God or 8 of man, then we the state, we the nation, must do this. 9 JOHN COX: And we, we all have to accept that, right? 10 11 DAVID KORESH: Oh, exactly. 12 JOHN COX: Sure. 13 DAVID KORESH: This is why people come to 14 this county. JOHN COX: You know, neither you nor me or 15 16 anyone else is above the law. 17 DAVID KORESH: Exactly. 18 JOHN COX: You know, the only way we get the 19 law changed is through legislation, right? 20 DAVID KORESH: Exactly. 21 JOHN COX: Sometimes we don't like it. 22 Whether you like it or I like it, you know, there are 23 laws that I don't like, but it's something we have to 24 live with, huh? 25 DAVID KORESH: It's something that we have to be really perceptive of.

JOHN COX: Sure. Sure. DAVID KORESH: Okay, 'cause that's what our life is, is one day-to-day, another perception, another lesson of life to learn. So here's the point we're developing now. So I'm talking with these Sheriff Department who come out here --(End of Tape #59.)

I said look, in the Book of Revelation, 4 5 very clearly -- And I grabbed the book and I showed 6 I said look, right here, God sits on the throne 7 and there's a questions asked in regards to this book in his hand. Who is worthy to open this book and loose 8 9 the seals thereof? There are seven messages here. 10 There's, there's something to do with God, God's mind, 11 God's will, and God's perception. And who is able to 12 open this book and loose the seals thereof? The 13 scripture says no man in heaven or on earth. 14 And, you know, they could see that and they both shook their head yes. And I said now, it says 15 16 that the lamb, the lamb (indiscernible) he can open it. 17 So I said this is Christ, isn't it? Of course --18 JOHN COX: I think you can confuse them there 19 a little bit, too, if they're not really knowledgeable 20 of, of all of theology, and they may be looking at who 21 can accurately interpret the seals, you know. 22 DAVID KORESH: Well, actually, what happened 23 is is that when you just simply let them read word for 24 word and just guide your finger underneath the word, I 25 mean, it's very obvious communication. John's telling us that no man in heaven -- Watch out, baby.

1 I think you have somebody calling JOHN COX: 2 you, huh? 3 DAVID KORESH: Yeah. No, no man in heaven --Hey, Cyrus, take her into her room real quick, okay? 4 5 Bobby, be good baby. Anyway, the point is no man in heaven -- have opened and looked thereon. 6 I mean, it's just -- it's a mystery, and it's called a mystery by 7 8 Revelation. 9 JOHN COX: Sure, sure. 10 DAVID KORESH: But the content, though, that the lamb does come and he, and he takes the book, and 11 12 the book is called -- The very first opening chapter, 13 the subject is called the Revelation of Jesus Christ 14 which God gave to him to show to his servants and what 15 God clearly gives to Christ is a book with seven seals. 16 Very obvious, very clear. And the, and the gentlemen 17 were just like, you know, hey, it's very simple. That's what makes it so awesome is it's so simple. 18 19 Now, I said now, remember --20 JOHN COX: You know, that's, that's obvious 21 to some people, but some that are stronger towards the 22 New Testament as opposed to the Old Testament. 23 DAVID KORESH: No, no, this is New Testament. This is Revelation. 25 JOHN COX: Sure. Sure.

DAVID KORESH: This is the New -- This is the

last book of the New Testament. Now, but what this 1 2 book does for us is it makes a very clear picture for 3 those who are going to follow after John's day to be informed of who giveth to the churches of Asia, to be 4 5 shown what must be after their day, that there would be this revelation Jesus Christ which God would give to 6 him to show to his servants. Now, John's a servant and 7 John sees the lamb opens the first seal and there's a 8 9 white horse, the second seal's a red horse, and so 10 forth, these horses and events of which scholars have 11 busted their brains ever since the Apostolic Church and 12 they've tried to --13 JOHN COX: Interpret it. 14 DAVID KORESH: Exactly. 15 JOHN COX: Sure. 16 DAVID KORESH: Now, you can't say that a man 17 doesn't have the right to give a fair opinion. God put 18 it in there for everybody to see. We are all told blessed is he that readeth, and may they hear the words 19 20 of this prophesy and those that keep the things written 21 Now, if we don't understand it, we can't keep 22 If we don't understand it, we can't be judged by 23 it because if we don't know what we're doing, we can't 24 be condemned, can we? Jesus said so, right?

JOHN COX: You've got it.

DAVID KORESH: Forgive us for we don't know

what we're doing. Okay. But there comes a time, 1 2 uniquely enough, to where in the event of the seventh 3 seal the trumpets are being administered, which, 4 remember, each seal is a revelation to do with Christ 5 somehow, some way. In the seventh seal, the trumpets begin to sound and during the sixth trumpet an 6 7 interruption is made and a mighty angel ascends from 8 heaven and he has this little book in his hand and it's 9 opened. I mean, all seven seals have been opened, you 10 see? 11 JOHN COX: Um-hum. 12 DAVID KORESH: At the time of this event. In 13 heaven, that is. And he comes to the earth and he 14 cries and the lion roareth and seven thunders are 15 Now, John was going to write, but a voice 16 says seal up those things and reveal them not, John. 17 And so the voice said, the angel said that he swore by 18 God that when there's time no longer then this mystery 19 of God will be finished, as God has declared to his 20 servants the prophets. Okay. So there, there, 21 there's, there's our footnote. 22 23

Whatever this mystery of Christ is, whatever, whatever God has to say about Christ that we don't know yet, when there's time no longer this book will come to earth and it will be revealed, of which the events connected to that is that at that time there's a

measuring of the Temple of God, there's an event in
Chapter 11 and 12 in Revelation dealing with a woman in
heaven bringing forth a manchild, of which this dragon
fights against the manchild.

The event finally turns into Revelation 13 of 5 how that there's this political power on earth that's 6 7 lamb-like but it'll speak as a dragon, you know. lamb is a symbol of Christianity. Speaking as a 8 9 dragon. Well, we know who the dragon is. But, anyway, 10 the event finally ends up to where a student of 11 scripture who avails themselves of the written word are 12 to fill their heads full of what the book may be saying, but honesty will always bring the fruit of 13 14 realizing that I, I don't know what the book really 15 I know what it's saying, I can quote word for 16 word what it's saying, but I still as of yet do not 17 know what it means.

And I can give opinions on it, what I think, but the realities I cannot really honestly say. Now, in Chapter 22, the last chapter of this book, the statement is so clear, it's so obvious that it answers any question in regard to why men do not understand this book in its entirety. Jesus says now, I Jesus, he tells us, have sent my angel to testify to you these things in the churches. Now, the churches (indiscernible) were the churches of Asia. Okay? He

says I am the root and offspring of David and the 1 2 bright morning star. Then he goes on to say behold, I come 3 4 quickly. My reward is with me to give unto every man 5 according as his work shall be. Okay, now, the question that I presented to the law enforcement 6 7 officers, as well I have always presented to any 8 institution of theology or any of the higher, you know, 9 levels of, of theology and philosophy, whether 10 apostolic, apocalyptic, prophetic or whatever they may 11 profess to, to follow, the keynote is that I asked them 12 a simple question: Now, what is the reward that Christ 13 received? 14 The natural obvious answer is he received 15 power, glory, riches, honor, and all this. But when I 16 asked the question again --17 JOHN COX: But you can ask some people that 18 and they really can't give you the answer, right? 19 DAVID KORESH: Well, now, remember --20 They, they kind of feel different JOHN COX: 21 under the -- under some pressure and they may not be 22 able to give you the accurate answer that you're 23 looking for. Yet, you accept that. 24 DAVID KORESH: Well, God -- Well, now, here's 25 the thing. That's true, I do accept that. But here's the key. I never ask anybody that question --

DAVID KORESH: -- unless we've already looked at the facts thus stated in Chapter 4 and 5 of Revelation.

DAVID KORESH: You know, God on the throne, does he sit on a throne? Has he got a book in his hand? Who'd he give it to? You know, (indiscernible) before the lamb. What was the first seal? What does this mean? Who knows? Chapter 10 -- Well, is it true when there's time no longer, whatever that time may be, this mystery of God -- What is the mystery of God? Is God mysterious? Sure, he is. Does he sit on a throne? Sure, he does. What's the mystery of God? He's got a book. What's in the book? Nobody knows.

What do these symbols reveal? Nobody knows. It's the mystery of God, seven thunders. When the lamb opened the first seal, the sound of thunder, seven thunders, a message for the last days, the last time. Okay. Well, so the question is what is this reward that Christ received that no man in heaven nor earth, neither under earth, was able to receive? And then everyone thinks and they go ahhh, a book. Exactly. Only Christ himself can reveal the seven seals.

I mean, 6 7 for instance, say God was to do to the gentiles as God 8 did to the Jews. The Jews, who went by the prophets, believe in a Messiah who was a warrior. 9 They believe 10 in a Messiah who is going to come, make the covenant 11 with Israel, according to Daniel 9 or -- Zephaniah or 12 Habakkuk or whichever of the prophets we're, we're referring to, and that the Messiah was going to destroy 13 14 the oppressive power of whatever part of -- Remember, in Daniel 2, when Daniel saw the vision as 15 Nebuchadnezzar saw it, remember that the head of gold, 16 17 the arms of silver, the belly of brass, and the legs of iron were all one complete body. In other words, when 18 19 it comes to wickedness, even though the Babylonian 20 nation may have fallen into the hands of Middle Persia. 21 the Meads and Persians were really no better than the 22 Babylonians. Do you understand what I'm saying? 23 JOHN COX: Sure. 24 DAVID KORESH: In other words, and when Middle Persia fell into the hands of Alexander the Great, the Greeks, they were really no better, you

know, than the Mead or Persians. And when --1 2 JOHN COX: Well, how the actions were conducted back then and given the "label", it was being 3 done for religious purposes. 4 5 DAVID KORESH: Well, actually, it was 6 political, but, of course --7 JOHN COX: Sure. 8 DAVID KORESH: -- in all the ancient governments they all worshipped gods, no doubt about 9 10 it. I mean, they all --11 JOHN COX: Their own gods in their own ways. 12 DAVID KORESH: Exactly. 13 JOHN COX: Sure. 14 DAVID KORESH: Exactly. 15 JOHN COX: Sure. 16 DAVID KORESH: And this was why throughout the Babylonian kingdom the God of Israel was dealing 17 18 with the God of Prophecy. Daniel and then his three 19 Hebrew servants were, were prophets. They were able to 20 interpret the dreams of Nebuchadnezzar, you know, and 21 they always gave God the credit, just as in Middle 22 Persia when they, when they threw Daniel into the 23 lion's den because he would not adhere to the Persian 24 belief of God. What happened was that God intervened and saved this man from the lion's den. 25 Okay, this gave the nation, the leaders, a

We have a 14 problem in communicating because the authorities of 15 this nation and this government have seen, according to 16 the appearances that they perceive, an injustice done 17 to their system. Okay. 18 Whereas, on the other hand, we would have to 19 say that we feel, or actually we know that injustice 20 has been done against us, the people. 21 JOHN COX: Sure. 22 DAVID KORESH: I'm the little guy right now. 23 JOHN COX: And I appreciate that. 24 DAVID KORESH: But the gin and the snare is, 25 is that, for instance, let's count, let's see, if we were simple Bible students and we really believed in

Daniel 2, we would have to know that the empires that 1 2 were to rule Europe would have to be under the number of the sea. A head of gold, which was Babylon, that's 3 one. A dual kingdom of arms of silver, Middle Persia. 4 That's two. A belly of brass or bronze, which would be 5 Grecia, number three. Legs of iron, 'cause there was 6 two providences of Rome, which would be Rome. 7 8 And then the feet, part of iron and part of 9 clay, which says that the kingdom shall be partly strong and partly broken, but in the kingdom there 10 11 shall be, you know, within it the strength of iron and 12 then the weakness of clay. But you have to say well, 13 see, when Rome fell, it didn't really fall --14 Politically it did but religiously it didn't. 15 became Roman Catholicism and it ruled over what was 16 finally combined or organized as a nation called 17 Europe. 18 And within Europe there were many providences 19 and many countries, some being strong, you know, such 20 as -- Well, like (indiscernible) when you had the 21 Visigoths, the (indiscernible) and all the different 22 nations. Some were strong and some were weak. And 23 Daniel says to us in scripture that while Europe 24 remains in existence, that in the days of these

kingdoms shall the God of heaven set up a kingdom which shall never be destroyed nor given unto other people

again, for this kingdom shall arise and destroy all 1 2 other kingdoms and it shall rule forever. 3 sometime --4 JOHN COX: And how many, how many different 5 religions or religious sects, religious groups, et cetera, you know, whatever label you would want to put 6 7 on them, who all feel they are that chosen religion? DAVID KORESH: Well, now, here's the thing. 8 9 JOHN COX: Have a, have a different interpretation of that, huh? 10 11 DAVID KORESH: Well, nobody basically in 12 theology has a different interpretation, but their interpretation is --13 14 JOHN COX: Is to whether or not they are that 15 chosen church, religion, group, et cetera. 16 DAVID KORESH: No, no. What they believe is 17 this. This is the basic knowledge of all theology in all denominations. And that is in the time of this 18 19 empire, the broken state of Europe, Rome, whatever the, the final facet of where Rome has its name still 20 21 numbered over the nations, which we again know as Roman 22 Catholicism, that when the kingdom is set up they 23 believe that that will be the time of the coming of Christ, because it says -- Daniel says to 24 Nebuchadnezzar that thou saw and behold a stone without 25 hands and smote the image in the feet.

And the stone smote the image so that the, the iron, the brass, the clay, the silver, and the gold was broke into pieces and became as the, as the chaff on the summer threshing floor and the wind blew it In other words, these, these empires are gone now forever. The rulership of men, men being given power over other men, is once and forever broken. Now, they know this to be the coming of Christ, but that coming is what we interject by saying yes, you are correct, but what we interject is that God who sits on a throne in heaven is that rock.

God is the (indiscernible) starting stone,
God is the rock, God is the one that's going to hit the
image in the feet. Now, the question is will God be
merciful if man on earth has not been given proper
provision or opportunity to know what aforetime God has
spoken he will do? Well, Christ doesn't think so.

JOHN COX: Well, we all, we all believe and hope that God will be merciful, though.

DAVID KORESH: Okay, so God will be. So then we find, the last book of the Bible before these events meet their ultimate fulfillment, is that I come, my reward is with me to give to every man according as his word shall be. Just as in Matthew 24 Christ says to the disciples that when you see the abomination and desolation, spoken of by Daniel the Prophet, Christ

1 referring to the Prophet Daniel, right? Evidently, Christ believed in Daniel, didn't he? He said --2 JOHN COX: Certainly. 3 DAVID KORESH: -- that they were to flee from 4 5 Judea. But he also talks about a time where there's a carcass and the eagles will be gathered there. 6 7 that's a, a statement again that only Christ himself would know. Okay. So, anyway, the coming of Christ, 8 no doubt we hope, is the coming that will inform us and 10 to the events that we ourselves are to get in line with 11 In other words, if God has some information God. 12 called seven seals, we already know by the revelation 13 that no man on earth can reveal such a subject but 14 Christ himself. 15 That's what scripture plainly teaches. Okay. Now, that being the case, it needs to be tested. 16 I 17 mean, man on earth who has a mind and the 18 comprehension, should be able to thoroughly test such a 19 doctrine. Okay. So then man has the right to question 20 and to have opinions and to continue on in his religion 21 as he knows to do so, continue on in his religious 22 government and to follow whatever he believes, until 23 the time comes, till finally someone says hey, I will 24 show you the seven seals. 25 Now, knowing what this may mean, mankind should submit himself to a thorough honest

Once we establish this foundational truth 3 that no one but the lamb can reveal this, which is exactly what Revelation teaches, you know, clear-cut, 4 5 you know, no way around it, impossible to misunderstand if anybody's honest at all, I said now, here's what I 6 I come along and I tell these churches, I say 7 8 here, let me show you. 9 Now, all of a sudden, Larry, I tell him, I 10 say now, Larry, all of a sudden, either I meet with 11 direct anger, wrath and opposition, people saying are 12 you saying you're Christ, you know, blasphemy. 13 already made a judgment. Or I meet with the element of surprise and people say well, hmmm, oh, okay, okay, 14 15 well, show me then, let me see. 16 JOHN COX: There's got to be a happy medium 17 someplace, doesn't there? 18 DAVID KORESH: Exactly. But either I, I 19 either meet with just extreme you're not going to do 20 it, there ain't no way, even if you could I know you're 21 the devil, or people with surprise saying well, okay, I'm, I'm sitting here, I'm ready to, to be shown then. 22 23 You see? Because the prophecy already state very 24 clearly that only the lamb can do this. Now, the 25 meeting is because well, right before the world and this, this great nation is to be judged we've got to

1 understand in Revelation what Daniel tried to already
2 tell us in the 13th Chapter.

Revelation, John says he saw this beast emerge out of the sea. It had the head of a lion, the body of a leopard, the feet of a bear, and that it spate great things against the most high God and wore out the saints of the most high God and changed God's tongues and laws, and we've got to find out what that possibly means in Revelation 13. Well, Daniel also presented to Nebuchadnezzar another dream. And just as the empires that would rise and fall to the end of time over God's people, that is the empires that God would have his people be subject to, they didn't want to be subject to him or his law, they wanted to be like the heathens, so God says all right, get on out there and let the heathen rule over you then.

Okay. So what happens is we already know that the symbol of the image is the head of gold, arms of silver, belly of brass, legs of iron. Now, that's one way of depicting the world empires. But Daniel also says a next way of understanding them as in images of certain beasts. So he had this dream of these beasts, these four beasts, and he said the first was like a lion, which was Babylon; the second was like a bear, which was Middle Persia; the third was like a leopard, which was Grecia; and the fourth, he said, he

1 | couldn't really describe. It was nondescript.

2 But Daniel says the fourth beast devoured and 3 ate up the three beasts that were before it. So the three beasts were eaten up, which became a part of the 4 5 fourth beast. Well, Daniel says he wouldn't know the meaning of this until the time when the saints would 6 7 possess the kingdom, which would be in the latter days. Of course, Revelation discusses the subject and tells 8 you what Daniel didn't tell you. Revelation tells you 9 10 that this beast with the head of a lion, body of a 11 leopard, and feet of a bear is a, a composite beast or 12 the remnants of the ancient empire that have commingled 13 together into one co-optic beast, complete beast.

Rome devoured all the empires and all the cultures of men and mingled the seeds of men, just like Daniel said they would. So here we have a picture of this Europe still under Roman Catholic rule, but yet Revelation states that the dragon gave him his power, seat, and great authority. That's not too good. Okay. Now, we know that the devil likes religion, too, doesn't he? Doesn't he?

So the knowledge of scripture is definitely an advantage to 3 4 have when we're confronting the powers of darkness. 5 Okay. Now, but that's not the beast really to fear, because, you see, Revelation takes you another step. 6 7 It tells you that because of something to do with judiciary of heaven there will arise another beast 8 9 after Europe. Now, it says -- another beast rose up 10 out of the earth having two horns. It was lamb-like 11 but, lo and behold, it speaks as a dragon. 12 Now, this lamb-like beast, no doubt, is the 13 beast that denotes Christianity. Lamb-like is also it's peaceful, promotes peace, believes in peace. But 14 15 John says that it speaks as a dragon. It causes all, 16 both small and great, rich, poor, free and bond, to 17 receive a certain mark in his right hand or forehead, 18 and that no one can buy or sell unless they have this 19 mark. Well, you know, the question is who possibly or 20 what empire can rise to, you know, pre-eminence after 21 Europe that has such world-wide influence? 2.2 You know, what empire do we know of in our 23 modern time that's a great nation that has great power, 24 that's lamb-like, that's Christian, that trusts in God, 25 and yet maybe what it says, its interpretation may be as the dragon? Do you know of such a nation? Well,

it's a nation of nations, the United States of America. 1 2 JOHN COX: You're talking about an awful 3 large time span between then and now, right? 4 DAVID KORESH: Well, remember, to God a day 5 is a thousand years. JOHN COX: We went through a lot of, a lot of 6 7 different not only religious nations, but nations as we 8 know them. DAVID KORESH: Exactly. And that's why 9 Daniel was told that the time of the end would be the 10 11 vision and it would be for many days. 12 JOHN COX: And, and it's a presumption on our 13 part that it's the United States. 14 DAVID KORESH: Well, not really. And let me 15 explain this way. The prophet Isaiah discusses the 16 nation who's overshadowed with wings, which is way 17 beyond the rivers of Ethiopia. You know, if we say we will assume, then we have to back-track and say that we 18 19 have to assume that God first sits on a throne, because 20 naturally the first focal point is that we know that 21 the revelation of Jesus Christ which God gave to him 22 was originally written or compiled by the Apostle John 23 on the Isle of Patmos. Okay, let's go back 2,000 years 24 ago first. 25 You know, John was a Christian, wasn't he?

You know, John was a Christian, wasn't he?
He was a follower of Christ first, wasn't he? Before

you or I were born, correct? 1 2 JOHN COX: Sure. DAVID KORESH: Okay. Now, he does write his 3 letter to the churches of Asia of which those churches 4 5 being Christian were gentile churches, but yet they had, had become righteous to the belief in Christ. 6 Messiah that the Jews had rejected was the Messiah that 7 8 the gentiles were accepting. Now --9 JOHN COX: You know, their, their belief was, was accurate as far as they were concerned and --10 11 DAVID KORESH: Well, God --12 JOHN COX: -- I think we can look at that at 13 so many churches today and then. You know, they may 14 not be accurate in someone else's heart, minds, 15 viewpoint, but at least they're a believing truth, you 16 know. They, they, they shouldn't have negative views just because of a person's belief, particularly 17 18 religious belief. 19 DAVID KORESH: Well, remember, as we say, the 20 Christian church originally started out as a sect. 21 That's why in Acts 28 the Jews are talking to Paul the 22 Apostle and they say yeah, we've heard of this sect 23 forever where it's evil spoken of. That's the way, 24 that's the way to merge. 25 JOHN COX: Yeah. It's like Christ is seen in different forms, whether it be a lamb, whether it be a

dove, you know. So the devil's seen in different 1 2 forms, or Satan or whatever, you know, what, whatever 3 character you want to, to call the devil in many different forms. 4 5 DAVID KORESH: Okay. So --JOHN COX: And are they all, you know, are 6 7 they all looked at accurately? You may yes, I may say yes in different forms, but I'm certainly not a 8 9 theologian, you know, and certainly never expressed to 10 be one. But we see all these different forms, don't 11 we? 12 DAVID KORESH: What, what's the avenue left 13 open or the door remain open for us to come into unity 14 in one of the greatest, one of the greatest --15 JOHN COX: Taking vacations, huh? 16 DAVID KORESH: Well, no. 17 JOHN COX: Is certainly one in trying to accurately accept the Lord in, in whatever manner that 18 19 may be. But not to prejudge people because of our own 20 feelings, you know. 21 DAVID KORESH: Oh, definitely. 22 JOHN COX: I certainly wouldn't. Because of 23 my religious beliefs, I'm not going to be prejudging other people's religions. And yet, we see it happen 24 25 every day, don't we?

DAVID KORESH: Definitely, every day.

You see, it's like 15 yourself. Whether you believe the Bible or not, that's 16 not the question. You see, it's not a matter of 17 whether you believe in the Bible or not, it's a simple 18 story, like I've told the other agents. It's the story 19 of Peter Pan. Okay, me and you have just read the book 20 Peter Pan and we're clear as far as we perceive on this 21 entertainment story. Now, we go to school Monday morning to start another week, and as we're in 22 23 literature class the teacher gets up to the front and 24 says wasn't that a wonderful story on Peter Pan and 25 Peter Pan and Jack.

And we're going to ourselves and I say hey,

1 what's this Peter Pan and Jack? And I put my hand up 2 and I say excuse me, sir, you mean Peter Pan and Tinkerbell? Oh, no, Peter Pan and Jack. And I look 3 and I say, you know, hey, where's this guy coming from? 4 5 There's no such thing as Jack --6 JOHN COX: Somebody read a different story, 7 didn't they? 8 DAVID KORESH: Right. And, and I ask the 9 question again. Excuse me, sir, our assignment was 10 <u>Peter Pan</u> and it had Dr. Hook in there and it had, you 11 know, I don't remember it having this Peter Pan and 12 Jack in it. And he begins to tell us that we're not interpreting it properly, we're misreading it, you 13 14 know, we, we shouldn't, we shouldn't question his 15 authority, he is the teacher, he's the one that's going 16 to grade us, this is his test paper and we need to just 17 stifle ourselves before we cause too much commotion. 18 We're in the wrong. You have to say Robert, every time when you 12 were sitting in that class with some of the people 13 there --14 JOHN COX: Yeah. 15 DAVID KORESH: -- and you looked all the way 16 around, did you happen to think that nobody knew that 17 you were looking all around? You know, but the thing 18 of it is, when Robert saw what he saw, he was 19 convicted. He cannot deny Psalm 45. He cannot deny 20 Psalms 1, Psalms 2, Psalms 3, Psalms 4. 21 JOHN COX: Well, you, you just didn't want to 22 have a confrontation with him. Is that what the bottom 23 line was? 24 DAVID KORESH: No. Well, the thing -- There 25 was no reason to.

JOHN COX: No, I mean just say hey, you're --

1	DAVID KORESH: If he wanted to say
2	JOHN COX: you're not welcome here because
3	of what you're doing, that type of thing.
4	DAVID KORESH: Oh, look, it didn't make any
5	difference and he was welcomed here.
6	JOHN COX: Was he?
7	DAVID KORESH: Exactly. He was going to move
8	in for two weeks. I already told him he could. He
9	could have been with all the guys here.
10	JOHN COX: And knowing that he had another
11	purpose in mind?
12	DAVID KORESH: It didn't make any difference.
13	JOHN COX: You really, you really didn't
14	care?
15	DAVID KORESH: I have nothing to hide.
16	JOHN COX: Yeah.
17	DAVID KORESH: Here, Steve, tell him what you
18	and Robert was talking about.
19	JOHN COX: Well, I trust you. You tell me.
20	DAVID KORESH: No, one second. Just talk to
21	Steve for a second.
22	JOHN COX: Sure.
23	
	DAVID KORESH: I need to move, adjust myself
24	again.
25	JOHN COX: Go ahead. Go ahead.
	DAVID KORESH TO STEVE: You know, tell him

about Robert, about how we liked that guy. He's really 1 2 a good guy. I mean, you know --STEVE: John. 3 JOHN COX: Sure, go ahead. 4 5 STEVE: Yeah, like he was saying, I mean, 6 right from the beginning we suspected, because you 7 don't have, you know, -- seven guys almost 40 years of age, very articulate in their speech. You could tell 8 9 they were professional people. 10 JOHN COX: Yeah. 11 STEVE: We didn't care. It didn't matter. 12 JOHN COX: Yeah. 13 STEVE: But like when Gonzalez came over here, we sat down, spent a lot of time with the guy. 14 15 JOHN COX: Oh, I just, I just asked David, I 16 said, you know, if, if you really didn't have any 17 positive idea, I guess, about him and you know that he was over there for the purpose that he was over there, 18 why didn't you have a confrontation and say look, I 19 20 just --21 STEVE: Well, I tried to. 22 JOHN COX: -- don't appreciate you being 23 here? 24 STEVE: Well, no, it wasn't -- because here's a possible guy, here's a soul maybe, here's someone 25 like myself --
