JOHN COX: 15 AYESHA: Except she's a, lacking some milk. 16 JOHN COX: Well I'm sure she is. How come you 17 don't have any milk in there? 18 AYESHA: Because we asked, we --19 JOHN COX: No, no, no. I'm saying why don't you 20 have milk in there? 21 AYESHA: Why don't we have milk? 22 JOHN COX: Yeah. You have refrigerators, I'm 23 sure, in there, huh? 24 AYESHA: You guys didn't send us any milk that's 25 why we don't have any.

JOHN COX: No but I'm saying, you must have

1 refrigeration in there and, and things with a --2 AYESHA: But wait a minute --3 JOHN COX: -- orange juice and apple juice and 4 milk and all of these, you know, products of life --5 you must have things in there to have well-balanced meals. 6 7 AYESHA: So the reason why you haven't sent us any 8 milk is cause you think we have milk. 9 JOHN COX: No, I'm just asking you why you didn't 10 -- you just ran out of milk? 11 AYESHA: Yeah, we don't have any milk for the 12 baby. 13 JOHN COX: Well do you understand that we told 14 David that we would send him six gallons of milk, the 15 milk is probably no more than ten or fifteen minutes 16 away, he can have six gallons of milk, if he wants six 17 gallons of milk. And the only thing he has to do in 18 return is to let two of the children come out. And if two of the children come out, six gallons of milk go 19 20 in, it's as simple as that. 21 AYESHA TO UNIDENTIFIED PERSON: If two of the 22 children come out, six gallons of milk go in. 23 JOHN COX: Do you understand that? Hello? 24 AYESHA: Well, he said kiss my ass. 25 JOHN COX: Well I kind of expected something like

that from him.

1 I thought --AYESHA: 2 JOHN COX: But I really didn't, I really didn't 3 expect he'd say it that way. 4 AYESHA: Well I thought he sent a thousand bucks 5 out there, for, for six gallons of milk. 6 JOHN COX: He, he sent a, he sent a thousand 7 dollars out? I'm sure that money is, is probably being 8 used to take care of those youngsters. 9 AYESHA: Yeah but we also asked for, for six gallons of milk with that money. 10 11 AYESHA TO UNIDENTIFIED PERSO: And didn't you have 12 three kids already out there for six gallons of milk? 13 UNIDENTIFIED MALE: (Indiscernible). 14 JOHN COX: Hey, hey, Ayesha. Hello? AYESHA: Yeah. 15 16 JOHN COX: Now it was my understanding that the 17 money is to -- was to take care of the utility bills 18 and other bills that had been incurred out there and, 19 and, I'm not going to get into an argument with you, 20 I'm not --21 AYESHA: Uh-huh. 22 JOHN COX: -- going to get into a, you know, a big 23 dialogue with you --24 AYESHA: Uh-huh. 25 JOHN COX: -- the, the solution is, if two

youngsters want to come out of there, six gallons of

1 milk will come in. That's it. It's as simple as that. 2 And that's it. Okay? 3 AYESHA: But we --4 JOHN COX: Do you understand that? 5 AYESHA: I can hear what you're saying but we sent 6 Kevin out there to already get that milk. 7 JOHN COX: I'm unaware of any children being sent 8 out to specifically get milk. 9 AYESHA: Well okay, we've already discussed this, 10 I quess --11 JOHN COX: We have. 12 AYESHA: -- (Indiscernible) to discuss it more. 13 JOHN COX: Sure -- let me ask you something. Do 14 you know David Thibodeau or Jeff Little or Margarita 15 Vega? 16 AYESHA: Do I know them? 17 JOHN COX: Yeah. 18 AYESHA: Sure. 19 JOHN COX: Or Sherri Jewell? 20 AYESHA: Why you asking this? 21 JOHN COX: Because I asked David earlier to speak 22 to these people and I asked Steven earlier to speak to 23 these people and he said that he would make 24 arrangements for me to speak to them, so, you want to 25 see if you can get one of those people on the telephone with me?

1 AYESHA: So if Steve said he'd make arrangements, 2 well I'm sure he's going to get into that. 3 JOHN COX: Yeah well we had decided to make those 4 arrangements where we had determined, we had agreed upon that last night. And I know they're really not 5 that far away. 6 7 AYESHA: Wait a minute. JOHN COX: You know it doesn't take 24 hours to 8 walk that far. 9 10 AYESHA: Okay wait one moment. 11 JOHN COX: Okay. 12 AYESHA TO UNIDENTIFIED PERSON: He said that 13 (Indiscernible). 14 UNIDENTIFIED MALE IN BACKGROUND: (Indiscernible) 15 to make up his mind (Indiscernible). 16 AYESHA: Okay, well do you want to talk to the 17 women with babies or the other people? 18 JOHN COX: Hey, I'm happy to talk to anyone -- but 19 the reason I mentioned those names to you --20 AYESHA: Uh-huh. 21 JOHN COX: -- and there were some other names too 22 -- that people had called and enquired as to their 23 welfare.
