**BAPBOMB**

An article which appeared in the June 7, 1965, edition of the "New York Times" indicated that on that date, a stained glass window which was a gift from the people of Wales to the Sixteenth Street Baptist Church, had been dedicated. The stained glass window according to the article showed an agonized Negro Jesus being pounded by water from fire hoses with the inscription "You do it to me." It is also noted that of the six white people who attended the dedication ceremony, Mayor Albert Boutwell was present and was asked to stand so that everyone could see him.

It is not known if your office is aware of the publicity this matter has received. If not already done, you should notify the police department and Sheriff's Office and also advise Mayor Boutwell of the publicity since he may desire to take extra precaution.

You should be alert through informants and sources for any information indicating action may be taken to destroy the window or that further action may be taken against Mayor Boutwell.



CHIEF INSPECTOR WILLIAM J. HALEY, ACTING CHIEF, BIRMINGHAM PD, IN THE ABSENCE OF CHIEF JAMIE MOORE; H. A. DONAHOO, ADMINISTRATIVE ASSISTANT TO SHERIFF A. M. BAILEY, JEFFERSON COUNTY SO, AND W. C. HAMILTON, EXECUTIVE SECRETARY TO MAYOR ALBERT BOUTWELL, HAVE BEEN CONTACTED PURSUANT TO INSTRUCTIONS CONTAINED IN BUREAU AIRTEL TO BIRMINGHAM JUNE ELEVEN LAST, BEARING ABOVE CAPTION.

EACH OF THE ABOVE ADVISED THEY WERE WELL AWARE OF THE PUBLICITY GIVEN TO THE DEDICATION OF THE STAINED GLASS WINDOW PRESENTED BY THE PEOPLE OF WALES TO SIXTEENTH STREET BAPTIST CHURCH. MR. HAMILTON ADVISED HE FELT THE BOMBING INVESTIGATIONS PREVIOUSLY CONDUCTED AND NOW UNDERWAY, IN ADDITION TO THE CLIMATE OF PUBLIC OPINION THIS AREA, MADE IT UNLIKELY THAT ANY ATTACK WOULD BE MADE ON THE CHURCH OR THE MAYOR.

INSPECTOR HALEY AND MR. DONAHOO ADVISED APPROPRIATE PRECAUTIONS COMMENSURATE WITH THE EXISTING SITUATION HAD BEEN

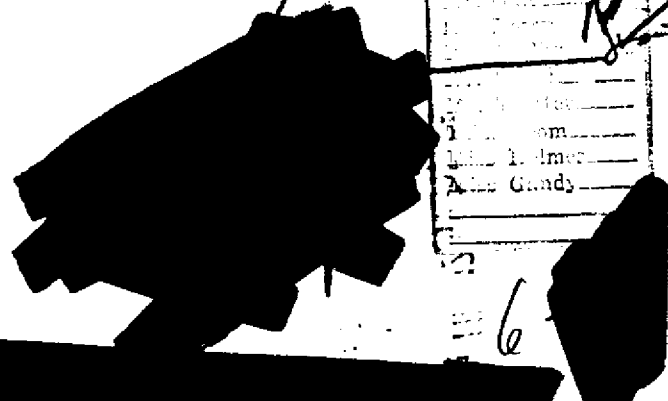

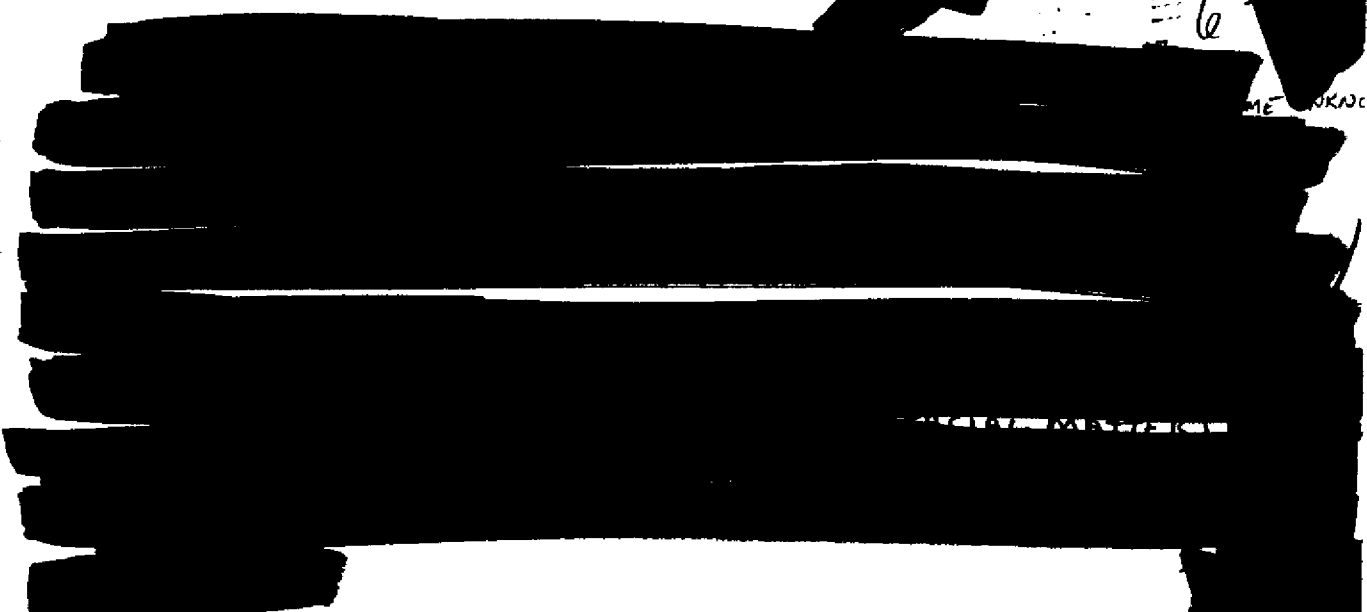

It is felt that certain information relating to selected suspects and individuals who are primarily of BAPBOMB interest, even though the information was obtained during the GREENBOMBS Special, properly should be reflected in this report.

The investigation in this matter and the investigation of the bombings of the Sixteenth Street Baptist Church, Birmingham, Alabama, 9/15/63 are being handled by a squad of ten Agents assigned to the Birmingham Office under the direct on-the-scene supervision of Inspector [REDACTED]

The Birmingham Office is currently investigating the possibility that there is a pattern between the recent bombing incidents and those which occurred in Birmingham as far back as 1945. There have been forty-three bombing incidents in Birmingham since 12/11/45. A detailed file review and analysis of available source materials relating to the earlier bombings have been undertaken. A report incorporating this material is in preparation. Inspector [REDACTED] advises this analysis will develop additional suspects and witnesses; disclose logical leads for interviews of persons with possible knowledge of bombing incidents; and disclose other pertinent information concerning suspects or witnesses which can be used as a wedge to encourage their cooperation. The far reaching investigation to determine the source of the components of the bombs is being pressed.

Continuing pressure is being exerted on the prime suspects involved in the bombing of the Sixteenth Street Baptist Church in which four Negro girls were killed. Some excellent informants have been developed among close associates of the suspects and efforts are being made to develop more. Every legitimate opportunity is being taken to maintain the pressure on these suspects in an effort to induce them to make admissions of guilt which can be the subject matter of testimony by these informants. There have been no bombing incidents in Birmingham since 4/1/65.

The following items should be clarified by Birmingham and amended pages submitted immediately by return airtel. Page 8, last word in first paragraph "tight" does not appear to be correct in the context of this sentence. Page 11, next to last paragraph "... further substantiating details and facts that were not obtained from informant."
