On January 13, 2011, [redacted] white, male, date of birth [redacted] social security number [redacted] who resides at [redacted] Kingman, Arizona was interviewed at his residence. Also present for the interview were DETECTIVE SERGEANT [redacted] and DETECTIVE [redacted] of the KINGMAN POLICE DEPARTMENT (KPD). After being advised of the identities of the interviewing Agent/Detectives and the nature of the interview, he provided the following information:

It should be noted that [redacted] residence was surrounded by a chain link fence. The gates to the chain link fence were secured with padlocks. There appeared to be no way to approach the residence to make contact with the occupant(s). There was a chain link fence surrounding an adjoining lot south of [redacted] residence. There was no padlock on that gate. DETECTIVE SERGEANT [redacted] entered the gate to hopefully make contact with the occupant(s) of the residence next door. DETECTIVE [redacted] and SA [redacted] followed. DETECTIVE SERGEANT [redacted] stated verbally "Hello, Police" several times with no response. DETECTIVE SERGEANT [redacted] got far enough into the adjoining lot that he was parallel to the back porch of the [redacted] residence. SA [redacted] overheard DETECTIVE SERGEANT [redacted] state "here we go" indicating that someone had exited the rear of the [redacted] residence. SA [redacted] observed a heavy set white, male, wearing nothing but his underwear. The older white male was later identified as [redacted]. SA [redacted] did not observe the right side of [redacted] body from SA [redacted] vantage point. DETECTIVE SERGEANT [redacted] then stated "put the gun down" at which point SA [redacted] and DETECTIVE [redacted] obtained cover behind an older model pick up truck. Once behind the pick up truck, SA [redacted] observed that [redacted] had a handgun in his right hand that he was holding down to his side. DETECTIVE SERGEANT [redacted] identified himself to [redacted] and advised him that we just wanted to talk to him. [redacted] then stated he was going inside to put the gun away, and to bring his five dogs inside the house from the yard.

[redacted] exited the residence a short time later, without the gun, and with clothes on. [redacted] invited SA [redacted] DETECTIVE SERGEANT [redacted] and DETECTIVE [redacted] into the residence. The residence was unkept and littered with trash and debris. [redacted] escorted us into the living room, while his wife was on the telephone attempting to contact [redacted] attorney. [redacted] wife

would only identify herself as \_\_\_\_\_ had a New England accent, but would not say where she was from. \_\_\_\_\_ put someone on the speaker phone that she alleged was \_\_\_\_\_ attorney. The attorney, via speaker phone, advised the law enforcement in the room that his client was invoking his right to silence. SA \_\_\_\_\_ informed the attorney that he could not invoke his client's right to silence, only \_\_\_\_\_ could do that. SA \_\_\_\_\_ informed the attorney that SA \_\_\_\_\_ was going to explain why she wanted to speak with \_\_\_\_\_ and that it would be up to \_\_\_\_\_ not his attorney, whether \_\_\_\_\_ would talk to SA \_\_\_\_\_ or not. The attorney then told \_\_\_\_\_ that he did not have to talk to us, at which point the telephone call was terminated.

\_\_\_\_\_ refused to provide his social security number. \_\_\_\_\_ had stated that the State of Arizona does not require that he has to provide that information. \_\_\_\_\_ did state that he is unemployed, and is on disability. \_\_\_\_\_ stated that he and \_\_\_\_\_ have been married since August 2010. \_\_\_\_\_ did state that he had no children, and that he and \_\_\_\_\_ live alone.

SA \_\_\_\_\_ asked \_\_\_\_\_ if he was aware of the shooting that had occurred in Tucson. \_\_\_\_\_ looked at his wife, and they both seemed confused. \_\_\_\_\_ stated she had heard something from her mother about a shooting in Tucson, but neither appeared to know much about the details surrounding the shooting. SA \_\_\_\_\_ informed \_\_\_\_\_ that the FBI was made aware by an anonymous caller that \_\_\_\_\_ may be a threat to politicians in Arizona. \_\_\_\_\_ immediate response was "this came from \_\_\_\_\_ didn't it?" SA \_\_\_\_\_ gave the impression that the information came from an anonymous source. \_\_\_\_\_ stated that in 2006 he had been a victim of identity theft by \_\_\_\_\_ who owns property in Kingman, Arizona, but lives in \_\_\_\_\_. \_\_\_\_\_ stated that \_\_\_\_\_ only purchased property in Kingman, Arizona to harass \_\_\_\_\_ stated he had been working with the Attorney General's office regarding the identity theft case. \_\_\_\_\_ stated that is when \_\_\_\_\_ started making all kinds of allegations against \_\_\_\_\_ provided the examples that \_\_\_\_\_ had been stating that \_\_\_\_\_ had killed people and had buried them, and that he had been part of the Oklahoma City bombing.

cases pending with \_\_\_\_\_ but those cases were with the MOHAVE COUNTY SHERIFF'S OFFICE, not KPD. SA \_\_\_\_\_ advised \_\_\_\_\_ that SA \_\_\_\_\_ preferred that they stayed, and that no one was going to ask him any questions about his pending criminal cases.

SA \_\_\_\_\_ asked \_\_\_\_\_ if he intended to shoot any individuals, including any politicians. \_\_\_\_\_ stated "no." \_\_\_\_\_ stated that he had been on disability since 1997. SA \_\_\_\_\_ asked \_\_\_\_\_ about his disability. \_\_\_\_\_ stated that he has a back injury which requires him to take pain medication. SA \_\_\_\_\_ asked \_\_\_\_\_ if he owned any other weapons besides the handgun. \_\_\_\_\_ stated he didn't have to answer that question. \_\_\_\_\_ then volunteered that he is a gun collector. SA \_\_\_\_\_ asked \_\_\_\_\_ if he collected handguns or long guns. \_\_\_\_\_ stated he did not feel comfortable answering that question.

\_\_\_\_\_ started initiating a conversation with the KPD Detectives regarding the police not doing anything about the individuals that had been breaking into his yard. SA \_\_\_\_\_ again asked \_\_\_\_\_ if he had any intention of harming anyone, and he stated no.
