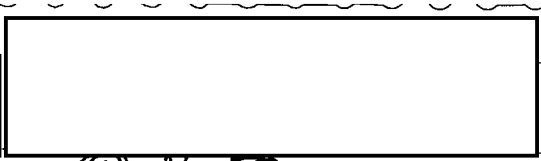

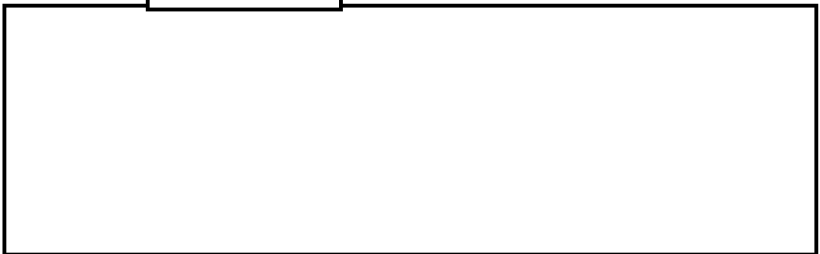

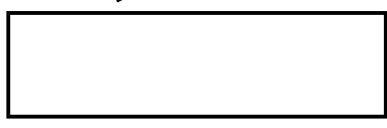

SA [redacted] Det. [redacted] Maricopa County Sheriff's Office (MCSO), and Det. [redacted] Pima County Sheriff's Office (PCSO) appeared at the home of [redacted] supra. [redacted] date of birth [redacted] wife of [redacted] was at home. [redacted] advised [redacted] was out of town, working in Globe, Arizona. [redacted] agreed to call [redacted] and advise him SA [redacted] needed to speak with him. [redacted] called [redacted] and gave the phone to SA [redacted]

[redacted] is a member of the American Legion Post [redacted] and goes by the nick name [redacted] is the owner of [redacted] [redacted] is in the business of repairing medical equipment. At the time of this interview, [redacted] was in Globe, Arizona working.

[redacted] advised he was at a recent barbeque, hosted by the American Legion, for veterans. [redacted] advised he was talking about the shooting that recently occurred, involving Congresswoman Giffords, at the barbeque. [redacted] advised everyone there was talking about it. [redacted] advised Giffords was not his favorite person and did write a letter to her, advising he would not support her if she voted for the health care bill.

[redacted] advised he did not say he wished he was the shooter. [redacted] described himself as a patriot and that he would rise up to defend anyone. In way of background, [redacted] was arrested by the Tucson Police Department (TPD) at UNIVERSITY HOSPITAL after making threats that included the statement "I'm going to shoot everyone just like what happened to Gabrielle Giffords". [redacted] was intoxicated, and being treated by hospital staff at the time he made threatening statements on 01/15/2011.

After being advised of the identity of the interviewing agents and the purpose of the interview, [redacted] provided the following information:

[redacted] had been sober for the last 8 months, and recently was kicked out of the program that was helping him stay sober. He was upset about the situation and went out "to the street" to drink. He remembered drinking beer with some guys on E. Stone Ave. and Fort Lowell Rd., and his next memory was waking up at University Hospital. [redacted] does not remember the events that led to his admission to the hospital, and does not remember making threatening statements regarding his intention to shoot everyone just like what happened to Gabrielle Giffords. [redacted] said that he had no issues with Gabrielle Giffords and regreted making threatening statements.
