MOHDAR MOHAMMED ABDULLAH, date of birth (P-1) 5, 1979, mobile telephone number (P-1) was interviewed first at the Restaurang Thang Long, Upplandsgatan 51, Stockholm, Sweden, then at the Knut Restaurang and Bar, Upplandgatan 17, Stockholm. An Officer of the Swedish Security Service, Sakerhetspolisen (SAPO), was also present for the interview. After being advised of the identity of the interviewers and the nature of the interview, ABDULLAH provided the following information:

ABDULLAH stated that he is very tired of answering the same questions posed by security services, notably the FBI, regarding the events surrounding the attacks on September 11, 2001. He wanted to speak to the interviewing agent again because he felt this time was different, since during their interview with him the previous day, on December 19, 2013, agents did not ask him the questions he is usually asked. ABDULLAH wanted to put the events of the past behind him.

ABDULLAH was angry and upset when he was first showed the surveillance video taken at Los Angeles International Airport (LAX) on June 10, 2000 (hereafter the "LAX video")

He stated this was because he had been told that the unknown individual in the LAX video (hereafter the UNSUB) was there with him, Nawaf AL HAZMI, and Khalid AL MIHDHAR, although he did not recognize the UNSUB. Additionally, he saw what he believed to be AL MIHDHAR speaking to the UNSUB over the UNSUB's shoulder in the LAX video, which exacerbated ABDULLAH's feelings of being used and lied to by AL MIHDHAR and AL HAZMI. ABDULLAH reiterated that he did not know or recognize the UNSUB, but postulated that AL MIHDHAR and AL HAZMI maybe did, since they had lied to him about so many other things.

It was ABDULLAH's opinion that the UNSUB appeared older than him, AL MIHDHAR, and AL HAZMI in the LAX video. When asked how old he thought the UNSUB appeared to be in the video, ABDULLAH stated that he wasn't sure, but maybe he might have been in his early thirties.

ABDULLAH was told that the object in the UNSUB's hand in the LAX video was a camera (C-2) when he first saw the LAX video, and that they had shown him blown-up pictures of it emphasizing what

they said was a light on the top and a dark area which was a lens aperture. ABDULLAH does not remember what his impression of the object was prior to them stating it was a camera.

ABDULLAH believes that the third person he had referred to in his e-mail to the San Diego Union Tribune newspaper reporter (P) was (P) was (P), though that was a mistake caused by not having seen the video yet. He did not think the person was (P) upon viewing it the previous day, on December 19, 2013. Additionally, he reiterated that he was fairly sure he had travelled to LAX on June 10, 2000 with only AL MIHDHAR and AL HAZMI, and absolutely certain that he had travelled back to San Diego that day by car with only AL HAZMI. ABDULLAH stated that they had listened to music of Quranic verses on their trip.

When asked about his statement that he had been shown a picture of himself, AL MIHDHAR, AL HAZMI, and the UNSUB standing in front of a departures status board in LAX, ABDULLAH stated that his memory of that picture had them standing in the same positions that he had seen them in the LAX video he had seen the previous day, on December 19, 2013. ABDULLAH believed he misremembered the location of the photo, and that it was likely from the security line as depicted the LAX video.

ABDULLAH has not told anyone in Sweden about his involvement with AL MIHDHAR and AL HAZMI or his arrest and detainment by the United States Government, and did not think anyone he currently associates with knew about it. He was careful to keep only a small group of friends and avoided sticking out in any way. ABDULLAH feared the release of the video will cause many people not to want to associate with him, and make his life very difficult and possibly dangerous.

ABDULLAH primarily wanted his immigration issues in Sweden resolved so that he can visit his sick father, who resides in Italy. ABDULLAH's brother also resides in Italy with their father.

ABDULLAH was very concerned that he has not ever seen his son. When asked when his son was born, he stated that the FBI knows already, and that he had been born in the year 2002. ABDULLAH did not know the child's full birth date. He stated that his ex-wife (P) (understood by the interviewing agent to be (P) had three children, the middle one being his, and that he FBI had tricked (P) into lying about not being married to him and not having his child. ABDULLAH believed (P) knew the child to be his, but despite this had faked his son's death with a fraudulent death certificate in order to prevent ABDULLAH from trying to see the child. ABDULLAH identified his primary motivation in life as trying to meet his son.

ABDULLAH had participated in an interview on Al Jazeera television in Yemen in 2005 or 2006 in which he and Anwar AL ALAWKI were interviewed by reporter Yusri Fuda in Arabic. The night before the interview, ABDULLAH met Fuda and AL ALAWKI for dinner, during which AL ALAWKI espoused Takfiri principles, specifically justifying violence against Muslims. ABDULLAH stated he disagreed and argued with AL ALAWKI, and that interaction carried on into the televised interview the next day. ABDULLAH had asked Fuda that Al Jazeera obscure his face during the interview.

ABDULLAH met AL ALAWKI one other time in Yemen, but stated that he did not remember what the context of the meeting was.

ABDULLAH did not remember AL ALAWKI ever saying anything inflammatory or extreme while he was Imam of the mosque in San Diego, though that had changed once AL ALAWKI moved to Yemen. ABDULLAH remembered a group in San Diego who split off from that mosque, and that there was one individual who was a convert to Islam with very radical views among them. ABDULLAH did not remember the individual's name.

At this time in the interview, the Restaurang Thang Long closed and Abdullah and the interviewing agents travelled down the street to Knut Restaurang and Bar to continue. During the walk, ABDULLAH received phone calls from his brother in Italy, and his housemate. ABDULLAH stated that he did not drink for religious reasons, but would not be offended if anyone else did.

ABDULLAH was very angry about the method in which AL ALAWKI had been killed. ABDULLAH believed that since AL ALAWKI was a U.S. citizen, he should have been given a trial. ABDULLAH was even more upset over the way AL ALAWKI's son had been killed, since unlike AL ALAWKI, he was a boy and had not done harm to the United States.

ABDULLAH's father and AL ALAWKI's father had been friends when he was growing up in Sanaa, Yemen. ABDULLAH did not remember AL ALAWKI well from this time, but ABDULLAH was friends with AL ALAWKI's brother, Omar. ABDULLAH had not spoken to Omar in years, and said he wondered how Omar was doing.

ABDULLAH stated he sides very strongly with the plight of the Palestinians, and does not agree with the Israeli occupation of Palestine. ABDULLAH has always dreamed of visiting Jerusalem.

ABDULLAH stated that he has a theory regarding the UNSUB, specifically that the UNSUB was an Israeli agent. ABDULLAH stated that he had no way to know

that this was true, but that he thought the FBI should check the passports of any Israelis who were in the Los Angeles area at the time of the LAX video.

ABDULLAH stated that in retrospect, he did not know whether AL MIHDHAR and AL HAZMI did or said anything that would indicate the future plans they had regarding the events on September 11, 2001. ABDULLAH remembered he was watching the news, and AL HAZMI refused to sit and watch with him, stating that the way the female reporters dressed was "haram" (forbidden). ABDULLAH told him that AL HAZMI should recognize the great opportunities they had by living in the United States, and that they must make some allowances and be forgiving of some customs in return for those opportunities. AL HAZMI stated that ABDULLAH does not understand. ABDULLAH became angry, and asked AL HAZMI if he was so concerned about Quranic Law, why he did not grow his beard. AL HAZMI smiled and stated that there were things ADBULLAH would only understand later. ABDULLAH stated that he did not know what AL HAZMI meant at the time.

ABDULLAH was initially introduced to AL MIHDHAR and AL HAZMI by Omar Al Bayoumi, and stated that everyone in the Islamic community at the time believed that Al Bayoumi was working for the Saudi Arabian government.

ABDULLAH questioned why Al Bayoumi had asked him to look out for AL MIHDHAR and AL HAZMI, and stated that since he had not heard anything about Al Bayoumi in the media since the attacks on September 11, 2001, the U.S. Government had not done an adequate job of investigating him.

ABDULLAH also stated that the FBI should talk to Hashim Al Attas, but would not elaborate on why, stating that it should just be done.

ABDULLAH had previously been detained in Sanaa, Yemen following his deportation from the United States. He remembered being detained in group holding cells along with two individuals who had been transferred there from U.S. detention in Guantanamo Bay, Cuba. ABDULLAH did not remember their names. He additionally remembered there was another prisoner in the Yemeni jail who had been held in U.S. detention in Guantanamo Bay, but that individual was held in solitary confinement in the basement of the jail. ABDULLAH had heard about three other former Guantanamo Bay detainees who where in Yemen, but they were held in a separate jail.

ABDULLAH stated that he was an individual of above-average intelligence, and that he had taken IQ tests to prove this. He understood why he had been continuously approached since the attacks on September 11, 2001, but reiterated that he was very tired of being chased and confronted with the same questions.

ABDULLAH had been thinking of giving

the interviewing agent to be (S) . ABDULLAH stated that (S) had ruined his life, but that they had both good and bad times together.

MOHDAR MOHAMMED ABDULLAH, date of birth (P-1) 1979, was interviewed at the Scandic Victoria Tower Hotel, Stockholm, Sweden. Officers of the Swedish Security Service, Sakerhetspolisen (SAPO), were also present for the interview. After being advised of the identity of the interviewing agents, ABDULLAH was advised by the Swedish officers of information as required by Swedish law, to include the purpose and nature of the interview.

ABDULLAH immediately advised that his primary concern was his immigration status in Sweden. Specifically, he had been told by SAPO that his request for status had been denied for unknown reasons, and that he would be deported from Sweden. ABDULLAH stated that he would listen to agents' questions, but would not provide information until his immigration status had been resolved.

ABDULLAH stated that he had previously undergone polygraph examination regarding his relationship to individuals associated to the terrorist attacks on September 11, 2001. He had initially been told by (C-2) that he had passed the polygraph examination, and was later told that the result were inconclusive.

ABDULLAH was shown the text of the email sent by him to San Diego Union Tribune newspaper reporter (P) on October 2, 2006, referring to the surveillance video taken at Los Angeles International Airport (LAX) on June 10, 2000 (hereafter the "LAX video"). This email stated that "I could not make the face of the third person whether he was Khalid or their friend who was residing in LA. They introduced me to him when we were here as a person they had known before coming to San Diego." ABDULLAH stated that he believed the LAX video had been released in the media, and that it had been shown in a television news broadcast. He was informed by interviewing agents that the video had not been released, and that the news report had only verbally referenced the video.

ABDULLAH then stated that he had first heard of the LAX video through

(P) and that he was unsure whether he had seen the video at the time the email had been sent. He thought that maybe the friend he had been referring to in the email as residing in Los Angeles was (P).

who had stayed at the hotel in Los Angeles with ABDULLAH, Nawaf AL HAZMI, and Khalid AL MIHDHAR on the night of June 9, 2000, prior to the trip to LAX the next day. ABDULLAH did not remember (P) travelling to LAX with them, or meeting them there.

ABDULLAH was then shown the LAX video. He identified himself, AL HAZMI, and AL MIHDHAR. He stated he did not recognize the unknown individual (hereafter the UNSUB) who was initially standing in front of them at the security line and who appeared to be holding a camera. ABDULLAH noted that the UNSUB does not talk with him, AL HAZMI, or AL MIHDHAR in the video. ABDULLAH claimed he had been shown pictures in a previous interview where he, AL HAZMI, and AL MIHDHAR had been standing next to the UNSUB for approximately twelve seconds in front of a departures status board at LAX to check the gate they were to go to. They did not interact with the UNSUB at that time, either.

ABDULLAH advised that he, AL MIHDHAR, AL HAZMI, (P) (known to interviewing agents to be (P)), and (P) attended the King Fahd Mosque in Los Angeles the night of June 9, 2000. He advised that the King Fahd Mosque Imam, Fahad Al Thumairy, was also possibly present during their visit. ABDULLAH advised that he had visited the King Fahd Mosque again the next day on June 10, 2000, but he did not recall whether it was before or after the trip to LAX. He did not remember any other persons than himself, AL HAZMI, and AL MIHDHAR travelling to LAX on June 10, 2000. He recalled driving to Los Angeles in a car belonging to AL HAZMI or AL MIHDHAR.

ABDULLAH stated that the UNSUB appears Arab, in his opinion. However, he stated that he did not know the identity of the UNSUB and had never met him, as he was sure AL HAZMI and AL MIHDHAR would have introduced the UNSUB if they knew him as per custom in the Arab culture. ABDULLAH was informed that absent any assistance he could provide, the last investigative step available to the FBI to identify the UNSUB would be to potentially publicly release the LAX video. ABDULLAH requested that his face be obscured if the video was released, and he reiterated that he did not know the UNSUB.

ABDULLAH inquired about the status of his son, and asked for pictures of him. ABDULLAH was informed that since the individual was a minor, the sharing of any information about him had to be approved by his legal quardian.

ABDULLAH then reiterated his position that he could not talk until he knew his immigration status in Sweden, and that he had always been cooperative when questioned by any agency.

Prior to his departure from the hotel, ABDULLAH asked the SAPO Officer who

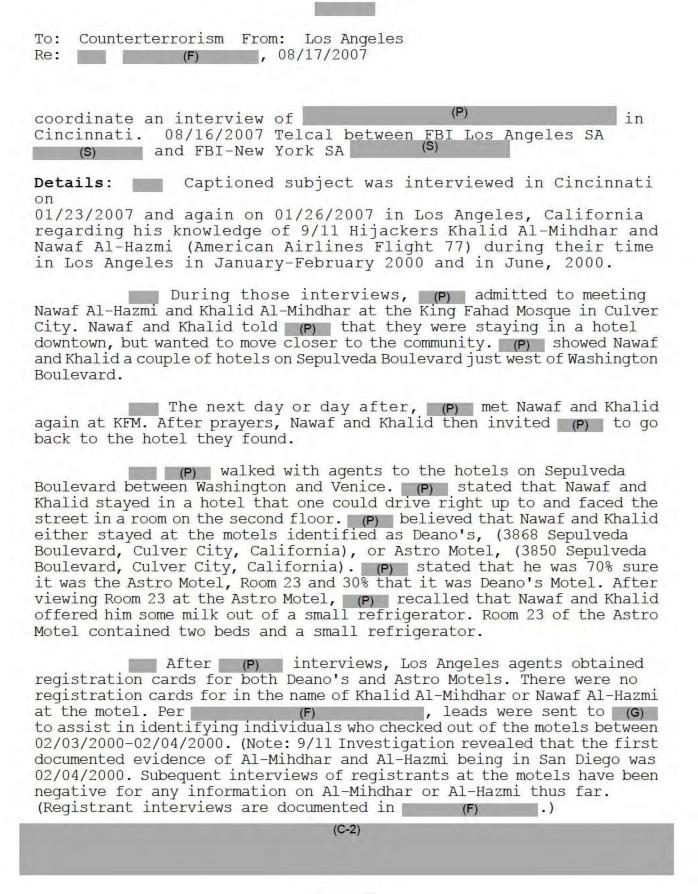

escorted him out if he could meet (S) by himself in the hotel met ABDULLAH in the lobby of the Scandic Hotel, and lobby. ABDULLAH again stated that he wanted information about his son. He additionally stated that should the LAX video be released, it may put him in danger and he again requested his face be blocked in it. He was informed that in the event of a release, his face would not be obscured. ABDULLAH asked if the FBI was sure that every possible method of finding the UNSUB had been explored. He recommended checking the records of the long-term parking area near LAX, which is where he, AL MIHDHAR, and AL HAZMI parked their car when they went to LAX on June 10, 2000.

ABDULLAH stated that if the UNSUB knew AL MIHDHAR and AL HAZMI or was a member of Al Qaeda, he would be a very dangerous individual who should be caught. ABDULLAH requested another meeting with (S) the next day, on December 20, 2013. While leaving the hotel, ABDULLAH stopped the SAPO Officer and informed him that ABDULLAH next intended to travel to the Swedish immigration office nearby to check his status.

On 08/02/2007, during an interview with New York PENTTBOM Intelligence Project case agents, KAYSON BIN DON was questioned about specific information in the "chance" meeting that he and OMAR AL-BAYOUMI had with Al-Hazmi and Al-Mihdhar at the Mediterranean Restaurant in Culver City on 02/01/2007. BIN DON stated that during the meeting, AL-BAYOUMI translated for BIN DON that Al-Hazmi and Al-Mihdhar were currently living in an apartment nearby but that he had invited them to come to San Diego since AL-HAZMI and AL-MIHDHAR did not like Los Angeles. BIN DON added that he believed that AL-BAYOUMI gave his cell phone number and Al-Hazmi and Al-Mihdhar gave a land-line number.
Los Angeles believes that there is a discrepancy on when or if Al-Mihdhar and Al-Hazmi stayed at the motels in Culver City. The evidence that supports this is as follows:
1) Los Angeles has not been able to find any information through the registration cards or subsequent interviews of registrants at both motels that Al-Hazmi and Al-Mihdhar were there in the beginning of February, 2000.
2) During the 08/02/2007 interview, KAYSON BIN DON recalled AL-BAYOUMI translating to him that Al-Hazmi and Al-Mihdhar were staying at an apartment as of 02/01/2007.

By way of background, MOHDAR ABDULLAH assisted 9/11 Hijacker NAWAF AL-HAZMI in acquiring a California drivers license; made inquiries in obtaining a social security card; made telephone calls for the hijackers to enroll in flight lessons with a flight school in Florida; made calls to a community college in San Diego to enroll AL-HAZMI in a computer class; and helped AL-HAZMI attempt to enroll in an English language school in San Diego. On 06/10/2000, MOHDAR traveled with AL-HAZMI to take AL-MIDHAR to the LAX Airport in Los Angeles, California, when AL-MIDHAR returned to Saudi Arabia. After dropping off AL-MIDHAR at the airport, MOHDAR and AL-HAZMI visited the King Fahd Mosque in Culver City, California. MOHDAR was at one time employed at a Texaco Gas Station in San Diego, which was the same station where AL-HAZMI worked for a three week period at the end of 2000.

The UNSUB appears to be holding a camera and may have been conducting reconnaissance of LAX. To date, FBI-LA investigation has not identified the UNSUB.

Some FBI agents believe that one of the men may be holding a video camera and rotates in a circle while secretly videotaping the security area. . . Since the LAX Video was discovered on 07/26/2004, investigation to date has not identified the UNSUB. Steps taken to identify the UNSUB have included:

- 1. Sending photographs to the High Value Detainees (HVDs) and GITMO Detainees for recognition including questions regarding any reconnaissance video of LAX;
- 2. Exploiting all evidence related to contacts in Los Angeles found in ABDULLAH's possession at the time of his arrest;
- 3. Exploiting all Los Angeles area telephone numbers called by ABDULLAH;
- 4. Analyzing (G) that passed through LAX on 06/10/2000 to match photograph with the UNSUB;

It is recommended a meeting take place with the leadership of CTD, Office of Public Affairs, appropriate (G) officials, ADIC and SAC Los Angeles, SAC San Diego, LEGATS (G) and (G) members of PENTTBOM, and respective case agents to discuss the options identified below. Since the meeting in (G) was over two months ago, it is requested the suggested meeting occur before 05/25/2007.

- 2. Coordinate with the SAC in San Diego to work an operation with the San Diego Union Tribune reporter to gain more information from her email contact with ABDULLAH. This option may gain the information needed to determine the identity of the UNSUB in the LAX Video but carries the obvious exposure to a potential leak. 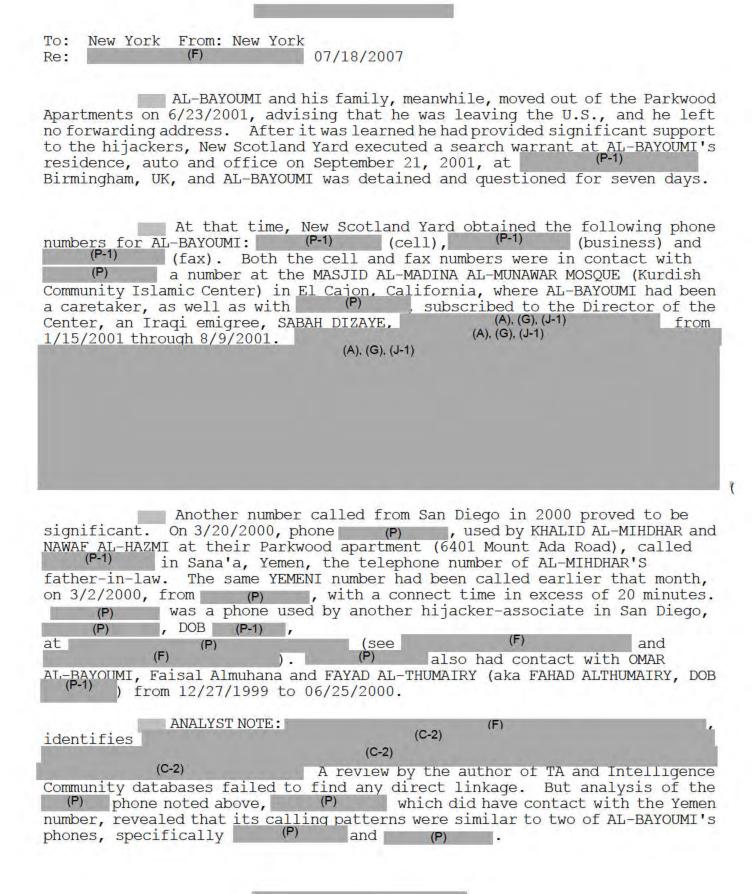

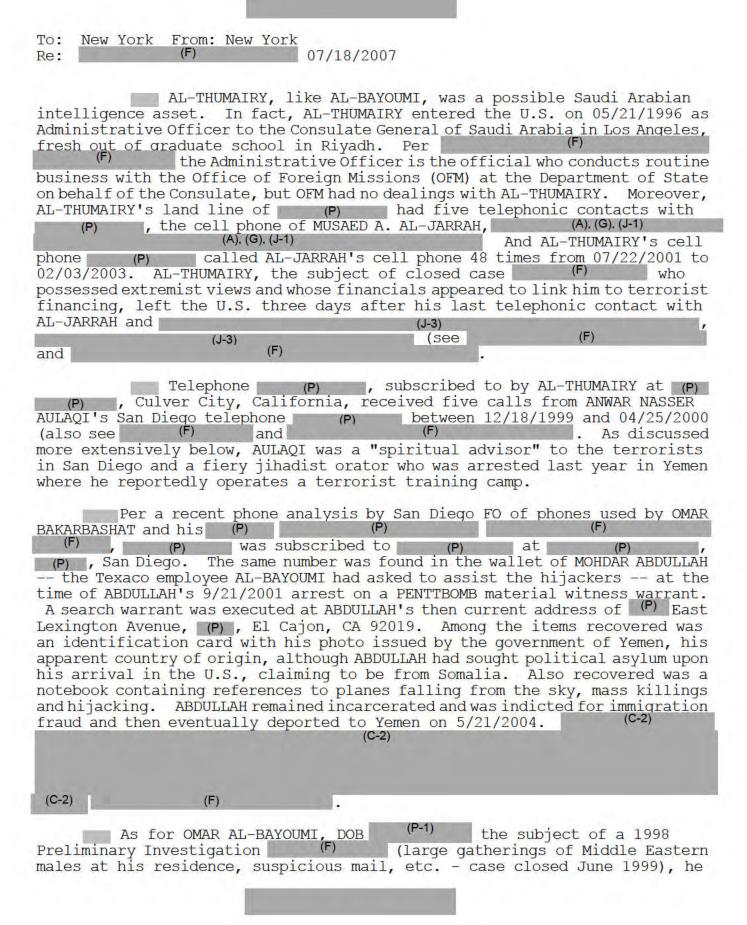

■ The investigation of the San Diego subjects commenced within hours of Flight 77 crashing into the Pentagon, when a car was found parked at the hourly lot in Dulles International Airport on 9/11/2001 that was registered to NAWAF AL-HAZMI, one of the passengers on Flight 77. determined that the vehicle was registered by AL-HAZMI at in Lemon Grove, a suburb of San Diego, California. Investigation by San Diego FO found the building was owned by ABDUSSATTAR SHAIKH, who was renting SSAN BAKARBASHAT, a foreign student from Yemen who had dropped out of college and was out-of-status, admitted to associating with (D) and later deported AL-HAZMI and AL-MIHDHAR and was arrested as a for immigration fraud. BAKARBASHAT further identified MIHDAR MOHA AL-MIHDAR ZAID (aka MOHDAR MOHAMED ABDOULAH, aka MOHDAR ABDULLAH), DOB as a close associate of AL-MIHDHAR and AL-HAZMI. ABDULLAH in turn admitted meeting the hijackers at a San Diego mosque in early 2000, where OMAR AL-BAYOUMI tasked ABDULLAH with acclimating them to the U.S. At the time, ABDULLAH was (P), La Mesa, another San Diego suburb, with residing at several others.

The hijackers were housed, through AL-BAYOUMI, at the Parkwood Apartments, 6401 Mt. 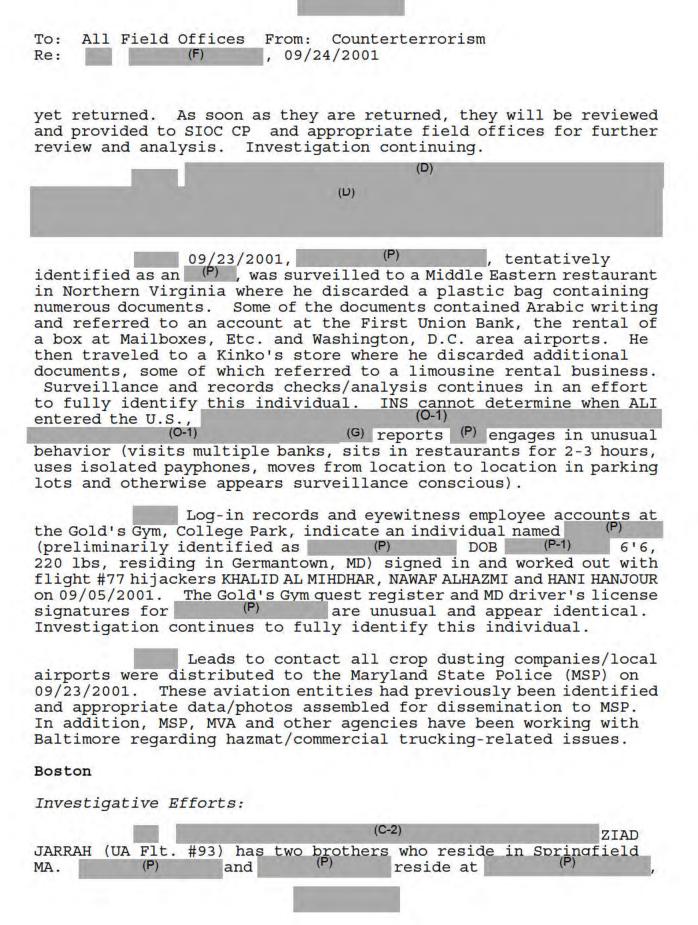

A review of the manifest determined that there were no matches to the Security Directives Watch List. On 09/23/2001, a draft affidavit for the arrest of MUSTAFA AL HAWSAWI (aka MUSTAFA AHMAD ADIN AL-HUSAWI; aka MUSTAFA (P-1) AHMAD; aka MUSTAFA AHMED; DOB ) was prepared in concert with the U.S. Attorney's Office in Boston, FBIHQ Office of General Counsel, Department of Justice Terrorism and Violent Crimes Section, and the Southern District of New York. HAWSAWI will be charged with Providing Material Support to Terrorists, Conspiracy, and Aiding and Abetting. Investigation determined that he was the recipient of four Western Union money orders sent by MOHAMAD ATTA (AA Flt. #11), WALEED ALSHEHRI (AA Flt. #11), or MARWAN ALSHEHI (UA Flt. #175) between 09/8/2001 and 09/10/2001, totaling \$18,260. HAWSAWI was also the recipient of a wire transfer from a Sun Trust account held by ATTA (approximately \$8,055 on 09/06/2001). All of these transactions were sent to locations in the United Arab Emirates HAWSAWI, a native of Saudi Arabia, flew from the U.A.E. (U.A.E.). to Karachi, Pakistan, on 09/11/2001. FBI BS (G) executed a Search Warrant at the apartment of who is under INS detainment in Washington, D.C., for gave written consent to search his apartment. Additionally, FBI CG was advised that a knife was located hidden under a seat in a Delta aircraft in Bombay, India. FBI CG is continuing liaison with Delta Airlines regarding these incidents, and to determine any similar incidents. Investigation continuing. Dallas Investigative Efforts: (G) identified ZIAH JARRAH (UA Flt. #93) taking one flight from Munich to Istanbul (Lufthansa) on 12/22/2000. FBI Dallas (FBI DL) is trying to identify as many flights as possible. Ten hard drives have been received by FBI DL. Four from Las Vegas have been reviewed, and the only information associated to terrorists was Travelocity information. has received all flight manifests from December 1999 through September 11, 2001. Information is being reformatted by (G) in order to properly forward information to SIOC CP. Further, the team is acquiring Passenger Name Record (PNR) for future travel (60 days in advance) to be forwarded to SIOC CP. The Kinkos hard drive project continues with eight hard drives fully examined. All eight were received from Las Vegas and none contained relevant information other than the Travelocity query. The wife of ADEL ALJUHANI, a cousin of AMMAR ALJUHANI, stated she spoke with ADEL last night, who stated AMMAR was in Saudi Arabia.

Investigation in Houston has determined FAROUQ AQRAWI is the Saudi Medical Health Officer at the Royal Embassy of Saudi Arabia. AQRAWI stated TAREQ ALJEHINI has worked directly for PRINCE KHALID BIN FAISAL ASSAD of the Saudi Royal Family for the past nine years. ALJEHINI arrived in Houston, Texas, on 08/27/2001 and departed 09/20/2001 in route to Jeddah with PRINCE ASSAD.

As previously reported, MUHAMMED ASRAR was detained by INS for being an illegal alien in possession of a firearm. ASRAR also had photographs of several high-rise buildings in Texas and Georgia. ASRAR remains in custody and has been appointed counsel. Through his attorney, ASRAR has not agreed to be re-interviewed. Investigation continuing.

The last remaining subject of investigations regarding UBL extremists has been located and will be interviewed. The subject is the mother of one of the subjects of the 1993 World Trade Center bombing. Her son is currently in prison. Houston is waiting for an Arabic translator and expects to interview her on Tuesday, 09/25/2001.

Miami has identified the Cessna bought by (P) (ph). Aircraft has been located. Miami is working with FBI Jacksonville (FBI JK) on a list of crop dusters in Florida.

FBI Miami (FBI MM) received an anonymous call report regarding an individual who works at the Miami Airport. FBI NK has identified KHALID ALMIDHAR (AA Flt. #77) and SAEED ALGHAMDI (UA Flt. #93) as staying at the Holiday Inn in Totowa, NJ during 09/01/2001 to 09/02/2001. FBI NK continues to analyze the significance of this lead.

FBI NK has witnesses who placed ZIAD JARRAH (UA Flt. #93) and MARWAN ALSHEEHI (UA Flt. #175) at MAS JID AL-SALAAM mosque in Jersey City. Similarly others such as (P) and (P) were also seen at the mosque. A recent development identified that (P) also attended the mosque and had trained at the Teterboro Airport where HANI HANJOUR (AA Flt. #77) and SAEED ALGHAMDI (UA Flt. #93) were seen. NASR will be served an arrest warrant for theft by the New Jersey State Police and interviewed.

FBI NK continues to track known financial records from Dime Savings Bank, First Union, Hudson United Bank and Bank of New York for activities which may identify others yet not known to this investigation.

Newark continues its PEN on the home telephone and cell phone of (P) and is going to make a decision in 24 hours whether they will go further on the pen register. Subpoenas are outstanding for subscriber information. (P) 's E-mail records have not produced any substantive material at this time.

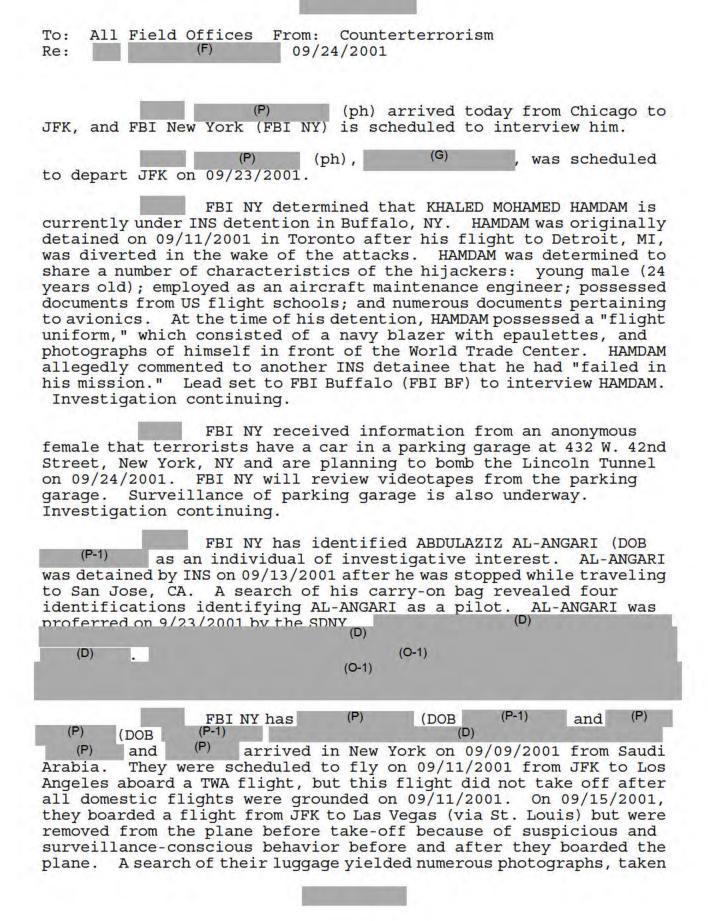

These individuals turned in licenses from Virginia, Michigan, Washington, Tennessee, Kentucky, Kansas and Texas when receiving the Pennsylvania licenses. Investigation by FBI PG determined that a Pennsylvania Department of Transportation (PA DOT) employee was accepting \$30 - \$50 to issue fraudulent identifications. This individual has been detained and is cooperating with investigators. The employee indicated that he may have issued as many as 30 identification cards with HAZMAT ratings. The employee indicated that he dealt with a "middle man" known only to him as BEN LNU, to arrange for these licenses. FBI PG is attempting to further identify and locate BEN LNU. FBI PG has prepared an affidavit for federal arrest warrants for the 20 known Iraqi nationals who obtained the fraudulent identification cards. The affidavit has been presented to the U.S. Magistrate for the Western District of Pennsylvania, who is expected to sign it on 09/24/2001. as the warrants are signed, they will be entered into NCIC. Investigation continuing.

FBI SI advised that, on 09/23/2001, a vehicle that was stopped for speeding. This vehicle was occupied by three males claiming Israeli citizenship. The notebook is being sent back to the Lab at FBIHQ for analysis. San Diego has also requested the (G) to review the notebook.

A box-cutter was found under seat (G) of an AA Flight #160 which flew from San Diego to JFK on 09/10/2001. The same plane flew back from JFK to San Diego on 09/10/2001 carrying Flight #127. On 09/11/2001 the same plane was scheduled to fly from San Diego to JFK carrying Flight #160, but it never left San Diego due to the airport closings. The plane was grounded in San Diego until 09/13/2001 when it flew to LAX without passengers. On 09/14/2001it flew, without passengers, from LAX to AA's maintenance facility in Ft. Worth where it remains. On 09/17/2001 maintenance found the box-cutter under seat (G) On 09/10/2001, seat (G) Flight #160 (P) (SD to JFK), was occupied by , one of the 13 Saudi Arabian pilots previously reported on by San Diego. Investigation is continuing in an effort to ascertain the occupant of seat (G) Flight #127, on 09/10/2001 (flight from JFK back to San Diego) and to verify that no passengers boarded the plane on 09/11/2001 prior to the airport closing.

During an interview of SOLIMAN in 10/2001, he advised that he obtained his private pilot's license at Caldwell Flight Academy, located at the Essex County Airport, NJ in 1997. His instructor was AHMED ELASHMOUNY. ELASHMOUNY has several references in indices regarding a case out of New York. This case involved the first WTC attack. Specific information regarding the reference is kept in New York. There were also references to the current PENTTBOMB investigation.

SOLIMAN has not had contact with ELASHMOUNY since he finished his private pilot's license in 1997. SOLIMAN believed that ELASHMOUNY spent some time in jail for credit card fraud and believes he is living in New York. SOLIMAN advised that ELASHMOUNY had been a flight attendant instructor for Egypt Air prior to being a flight instructor.

After he obtained his private pilot's license, SOLIMAN traveled to Airman Flight School, Norman, Oklahoma, for his other ratings, specifically his Instrument, Commercial, and Multi-Engine. SOLIMAN recently finished his Certified Flight Instructor certification (CFI) in the spring/summer of 2001 at Teterboro Airport, NJ.

rrived in the United States (U.S.), he first Paterson, NJ, with SOLIMAN advised that the house was owned by the (P) family. Which consists of a group of brothers, (A), (G), (J-1) by Newark. This family has potential ties to the hijackers and may be involved in document and credit card fraud. While residing in Paterson, SOLIMAN opened P.O. Box # (P) Paterson, NJ, and still utilizes the PO Box.

SOLIMAN advised that he obtained his undergraduate degree in Egypt in photography and had worked for Egyptian TV prior to coming to the U.S. He still does some freelance work for them. SOLIMAN served in the Egyptian Military in 1995, and was assigned as a Peacekeeper in Bosnia. He denies any foreign travel to or having contacts in Europe, Afghanistan, Saudi Arabia, United Arab Emirates or Pakistan. SOLIMAN stated that his only foreign travel was when he came to U.S. in 1997, with approximately \$14,000 for flight training. Upon completion of his training, SOLIMAN went back to Egypt to obtain his Egyptian pilot's license and returned to the U.S. in 12/1999.

SOLIMAN's parents and two brothers still reside in Egypt. One brother drives tanks for the Egyptian Army, the other is an Agricultural Engineer. SOLIMAN is (P) whom he met in New York, she is currently in (P)

Throughout the interview, SOLIMAN did not appear to hide any information and voluntarily provided information already known to the FBI. He did not identify any of the photographs of the terrorists, nor did he know of any planned attacks.

Newark closed the investigation/lead into SOLIMAN since no ties to terrorism were identified, however toll records were requested, and were still pending.

Although SOLIMAN denied foreign contacts and travel, and denied prior knowledge of terrorists or their activities, a review of toll records from his residence possibly shows a connection between SOLIMAN and past/present International Terrorism Investigations. It should be noted that SOLIMAN's roomate, yet to be identified, also has access to the telephone in the residence.

#### TELEPHONE ANALYSIS:

Telephone analysis of (P), subscribed to MOHAMED S. SOLIMAN, of (P), Lodi, NJ., revealed numerous calls to Egypt, Saudi Arabia, United Kingdom, Germany, France, and Italy. Furthermore, a large number of calls have been placed to numerous locations throughout the U.S., to include Oklahoma, California, Massachusetts, West Virginia, Washington D.C., Virginia, and Niagra Falls, New York. In addition, telephone analysis revealed calls to the United Arab Emirates Mission in New York. Many of the phone numbers called have links to (A), (G), (J-1)

The following telephone calls are of interest and possibly link SOLIMAN to ongoing terrorist activities:

Through appropriate FBI database searches, it was revealed that this number is associated with EYAD MAHMOUD MOHAMMED ALRABABAH, DOB (P-1) and (P) These individuals, located in New Jersey, are being investigated by the Newark office under the PENTTBOMB investigation. It appears that several of the hijackers, specifically HANI HANJOUR and NAWAF ALHAZMI may have stayed at the Virginia address with ALRABABAH. ALRABABAH also provided the hijackers transportation to Connecticut, and Patterson, New Jersey, and assisted them in obtaining identification. ALRABABAH and (P) have (D) pending.

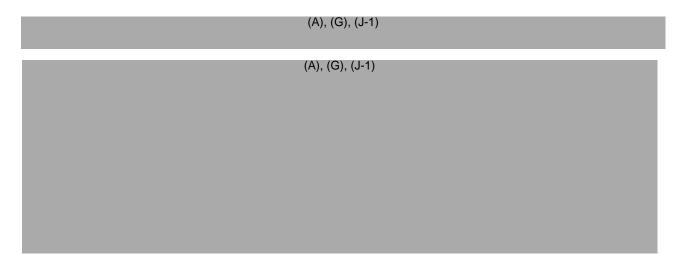

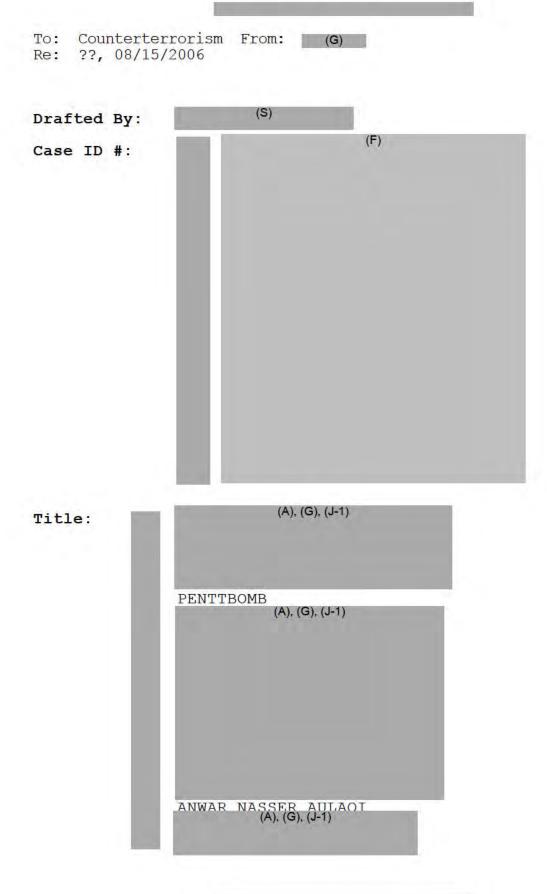

Given the above description of (A).(G).(J-1) and his connections to four terrorist attacks, (G) is increasingly concerned with what relationship (A).(G).(J-1) may have with international terrorism and the intelligence gaps that exist with relation to his activities. Even though source reporting continues to indicate (A).(G).(J-1) espouses mostly conservative rhetoric, (G) believes his behavior could be indicative of the infamous Ramzi Yousef (mastermind of the 1993 WTC bombing), who himself kept a very low profile prior to the attack. Unlike Yousef, (G) isn't speculating (A).(G).(J-1) may be planning an attack himself. It is simply becoming more plausible that (A).(G).(J-1) may have had prior knowledge of past attacks and could have current knowledge of pending ones.

Nevertheless, it could be justified that just because you associate with individuals who have been involved with terrorist attacks doesn't mean you yourself had knowledge of those attacks. In fact, shortly after the 9/11 attacks it was reported

that likely nobody in the U.S. but the hijackers themselves were aware of the 9/11 plot. However, the Los Angeles recently came across information leading them to believe the hijackers had assistance inside the U.S.; thus, leading them to reopen their PENTBOM-related investigations. Thus, as will likely be revealed in the Los Angeles reinvestigation, many more people may have known about these other attacks than what was once believed.

Even though AJAJ was incarcerated at the time of the attack, he was nevertheless convicted for his role based on his association with Ramzi Yousef. According to (F), in September 2002, Ajaj and Ramzi Yousef arrived together at JFK airport in New York. Since Ajaj was holding an illegal passport, he was detained and not allowed to enter the country. In his possession were several bomb making manuals. Based on this association and others later identified during the course of the (A).(G),(J-1) investigation, AJAJ was convicted for his role in the attack.

AJAJ reportedly met Ramzi Yousef in Pakistan in April 1992, just after AJAJ hurriedly fled from Houston, where he was living. According to (F), AJAJ and his friend, were hastily driven to the airport by (P) where they boarded a plane destined for Peshawar, Pakistan. 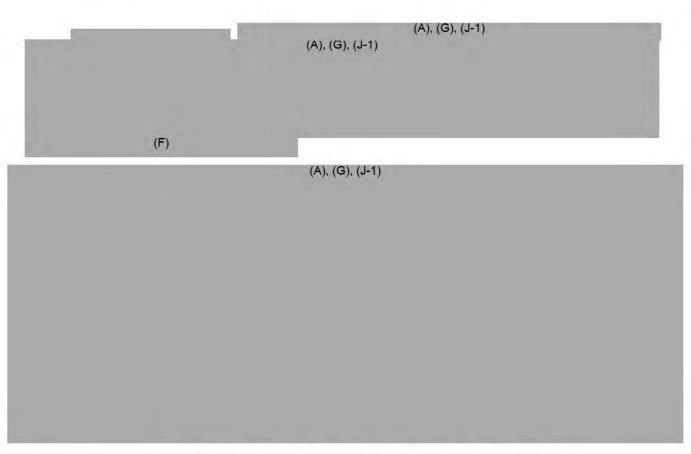

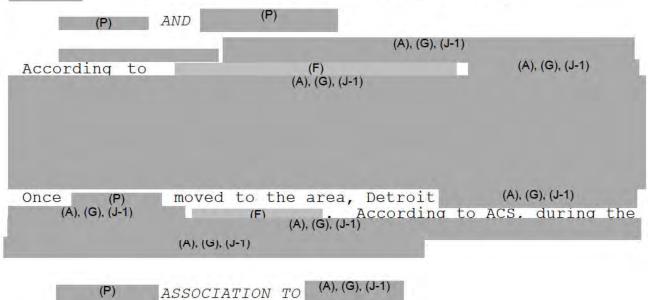

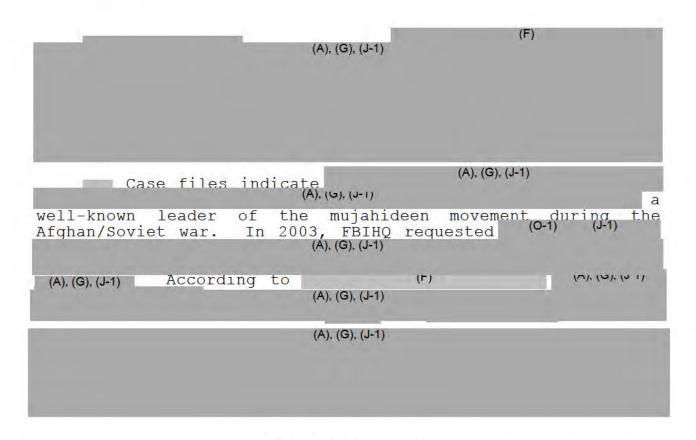

# 9/11/01 ATTACKS

(S) On 9/11/01, 19 hijackers overtook four U.S. airliners and crashed them into the World Trade Center, the Pentagon, and a field in Pennsylvania. Two of these hijackers were Nawaf Al-Hazmi and Khalid Al-Mihdar. Prior to their moving to the D.C. area before the attacks, they were living in San Diego, CA. They first arrived in the U.S. at Los Angeles, where they stayed for approximately two weeks. However, from there they moved to San Diego.

While in San Diego, these two hijackers ingratiated themselves with a group of Muslim males who all attended the same mosque, Masjid Ar Ribat, and were closely associated with each other. The hijackers even played soccer with them.

### ANALYSIS

After analyzing the above information, believes an extensive terrorism network exists within the United States and that high-ranking members of the network all had prior knowledge of the four terrorist attacks described. It is believed this network has existed since the early 1990's and continues to exist today. Even though several members have been incarcerated, it is likely the network continues to be run by those involved but not yet convicted or by those who fled the country prior to any conviction. This belief comes from the fact

that many of the individuals involved in one terrorist attack are also associated with other terrorist attacks or are at least associated with those convicted for these other attacks. Whereas individual terrorism "cells" (once thought to be autonomous) may exist in various cities across the U.S., (S) believes a level of leadership exists whereby the leaders are aware and approve of various terrorist attacks occurring within the U.S. and overseas.

(S) Further, based on the fact that associated with so many individuals either directly involved or one person removed from each of these attacks, IA (S) believes (A). (G). (J-1) is a much higher ranking member of the terrorist community than previously thought. Based on his connection to these individuals believed to be terrorism leaders, (G) cannot ignore the possibility that (A). (G). (J-1) himself may be part of this leadership. Not only is he (A). (G).
