





Chicago transportation workers affected fresh hope of recovering on Chicago Rapid Transit Co. fare comes today when the Supreme Court at Washington, D. C., was asked to reverse the decision of the United States District Court at Chicago upholding a 10-cent fare on the elevated lines.



Illustration of Mrs. Louis Rosenblum, 312 W. Belmont Rd., who was born June 21, 1902, in France.





the tax evasion of \$1,000,000 and for the period to which Capone had been allowed to grow outside of 1926 and 1927 by government investigation. The greatest prohibition violation, up to the point of trial, was held to be the evasion of \$1,000,000.

The possible maximum sentence in the indictments to which Capone pleaded guilty is 11 years in the penitentiary for the income tax evasion and a fine of \$10,000, and five years in the penitentiary and a fine of \$2,500 on the beer concession charges.

Reasons for Concurrent Sentences.

However, the highest income tax sentence of record is that received by Louis Gensk, Capone's business manager, and that was five years and a day. Gensk was convicted by a jury, however, it was reported, in hopeful that the sentences on his income tax and beer fines will be made to run concurrently.

Capone will be sent away, an objective of more than two years standing on the part of Mr. Johnson, agents of the intelligence unit under A. P. Madden, the special prohibition agents, and Washington authoritarians of the treasury and Justice departments.

President Hoover, who acclaimed the government's income tax drive here, is reported to have been insistent on wiping out Capone and his gang.

Reasons for Guilty Pleas.

Capone would not discuss his decision to plead guilty with newspaper men, nor would his attorney, Mr. Ahern and Leopold B. Mehlbeck, but several reasons were ascribed for the move by federal officials. One of these is that Capone, though not broke, has exhausted such financial resources in the last year that he did not wish to spend the expense of a jolly trial.

High bonds and high attorneys' fees have already been paid by Capone and his leading lieutenants in the federal courts. It was pointed out, and the prohibition agents have been wrecking his finest breweries and stills.

Aids from the expenses of a trial and probable appeal, the federal officials declared that Capone availed himself of the plea of guilty in an effort to obtain mitigation of sentence, because he feared to face a jury. The government has not lost a major prosecution since United States Attorney Johnson assumed office. His motto having been: "Every indictment a conviction."

Reported Planning comeback.

There is a third reported motive for the plea of guilty. This was that Capone, though plump young at 42, believes that he can still come back into full health and climb the ladder of leadership after he has served a term of few years. The depression is reported to be over, the gangster is reported to have recovered, and there will be a letup in the present cranks of law enforcement. If he went to trial and then carried his case to the Supreme Court, he might be sent away just when times begin to pick up, is the way his reasoning is reported to have run.

When Capone gets away to Leavenworth, which is expected to be soon after he is sentenced on June 26, it will be his second incarceration in the penitentiary. Two years ago he served nine months with his bodyguard, Frank Rife, in a Philadelphia jail for gun toting.

Capone will find in Leavenworth the former chanceller of his confederate, Myron McCormick, who went down in January to serve an eighteen month term for tax evasion. He will also find McCormick's other confederate, John Dillinger.

Knot of Super Criminals

All Capone's men, save the informants, finally found a way of leading him toward prison, the persecution of the gangland set that arose with the attempt to uncover the position here. His approaching departure from the scene of his triumphs is now regarded as the passing of that era of the super-gangster.

Capone was born in Brooklyn about 24 years ago, in Neapolitan stock.

His formal education included the passing of the fourth grade in grammar school. Thereafter his learning was of a practical nature. Before the war he ran with the notorious Five Points gang in Brooklyn. He served during the war as a soldier of the United States and was honorably discharged.

Capone comes to Chicago.

In 1919 Capone, a youth of 21,

came to Chicago to serve as bodyguard for Big Jim Colosimo, a sometime street swarmer who came to power and wealth through political alliances and prohibition law violations.

Colosimo died by a murderer's bullet and John Torrio, who succeeded him as the first gangster of Chicago, took over the young bodyguard. Capone was then a minor figure, one of a group of bad men subject to orders from superiors.

As late as 1921 Capone was only a minutiae of Joseph Fusco, to whom Torrio, interested in the lucrative business of speakeasy vice resorts, turned over the beer concessions in the city.

In this capacity Capone was sent east to buy the trucks that Fusco needed.

The Fusco organization at one time had fifty trucks and was merchandising a thousand barrels of beer daily—at least their breweries turned out that much. Capone, somehow, grew up with the business.

He takes Torrio's Throne.

Torrio, shot after the killing of the picturesquie Dutch O'Hanlon among his crew in the Several days opposite the Holy Name cathedral, left top his stable and turned back to Brooklyn to take his place as successor to Gangster No. 1. That left to Capone, and Capone quickly established his headquarters.

Within hours, old enemies returned and Capone's old foes gathered around him. He had a beginning made. He founded small private villages like West and Loop central. His slogan was: "We don't want any trouble." There are stories that in the little towns where he placed his resorts he paid off mortgages, bought new furnaces or repaired leaky roofs for those whom he wanted to be "good neighbors." He persuaded some of the villagers to permit barbers and bootfurns in the guise of roadhouses before the police appeared, when he was about.

Murders Follow His Rule.

He proclaimed himself that he was only a business man, that he was giving the people what they wanted for their money. Murders occurred. His enemies died by the machine guns and the pistol.

It has been only a coincidence, but Al Capone and Gennaro Angerio, who inspired go leadership in Michigan, were both killed by Capone.

Capone's influence reached to the ends of the earth, and with the United

States and with most of Europe. His influence was so great that he could make his mark in Mexico and Spain. He is reported to have been responsible for the kidnapping of the Chicago banker, Marshall Field, and his wife, and for the kidnapping of the president of the Bank of America, Charles E. W. Elkins, Jr., and his wife, and for the kidnapping of the president of the Chicago Stock Exchange, Mr. L. C. Hartman, and his wife. All of these cases ended in failure.

In making his kidnappings winter Torrio said that when he was in St. Petersburg he had approached at least once a week to propositions to get in on some kidnapping or rust running racket, but he had turned them all down.

Capone has been a visitor here Torrio frequently called on his master at Capone's Miami Beach home.

Only Capone kills Bugs that.

Capone, however, was in jail Philadelphia then, sentenced for carrying a pistol. He got out and returned to Chicago again to take up the ruffianism.

As to his wealth, it really exists Capone could go to California and find. He could go to Florida purchase a splendid seaside estate those cities in other states secure him. They rejected him in the end of his career. He was finally left without. And then his depreciation started, and his business in Chicago was gone quickly. That he could buy a thousand dollars, but nothing. The administration opened, so keep in the past its power to tax him. The going appears to be at an end. And when the prison in front of him the era of gangland, authority will be gone.

Cleaners Defy Capone Offer; War on Gangs

CHICAGO

An attempt by Al Capone to bring about the end of the gangster and during the past year he has organized his own organization, the Chicago Crime Commission. He has a meeting of all the 30 members of the commission, held at the Knickerbocker Hotel, at which the master cleaners voted unanimously to defy Capone.

"I am pleased to learn that this organization has the backbone to tell Al Capone his gang will not be allowed to make him a big-time business," said Justice Antonin Scalia.

"The cleaners and dyers asked me yesterday if we could turn up in getting the gamblers and I told them I certainly would be helpful."

Boss Reserves for Gang.

Capone's efforts to take over the cleaning and dyeing industry were regarded by Assistant State Attorney Charles J. Sturtevant, in charge of racketeer presentations, as an indication of the pressure suffered by the gang in recent months.

"There is no question that Capone's mob has been hard hit, and that he needs money," said Prosecutor Sturtevant. "His gambling market has felt the force of raids by the police and the state attorney's office. In connection with the age-old grand jury, some of the biggest breweries have been raided by the federal agents. The pressure of the big banks in the gang by the federal government and the local bankers required have undoubtedly caused Capone to look around for new ways of raising funds."

Capone Bullets on Spud

After Capone's offer was rejected, he apparently turned to his old ally, the gangster, Spud Murphy, for help. Murphy is the leader of the notorious gang that robs the Bank of America, based according to the New York Daily Mirror, on the 11th floor of the Bank of America building.

Spud Murphy and several individuals who claim to represent Capone appointed members of our organization," said Mr. Squires. "They said he would raise \$100,000 per cent of our annual revenue plus 10 per cent. In return, Capone would keep clean up, bring the industry and save 10 per cent of any recruitment cleaners we needed to be shipped into line."

Committee Ares Capone.







CAPONE KILLED TWO YEARS AGO, SAYS MAGAZINE

Gang Leader Willing to Let Story Stand, But Terms It Just Plain "Applesauce"

By FREDERICK C. OTHMAN

CHICAGO, May 1 (U.P.)—“I ain’t dead, but it’s all right for ‘em to think so if they want to,” So said “Scarface Al” Capone today.

ORIGINAL DEAD

But J. M. Lansinger, publisher of the *Red Detective Magazine*, insisted:

“The original ‘Scarface Al’ Capone is dead. It gives me great pleasure to explode the halo surrounding the bogus Capone.”

Which indicates that there is a certain difference of opinion concerning the status of America’s most notorious criminal, the fat, pudgy ruler of Chicago’s vice, liquor and gambling syndicates, the scarred-face criminal who became a multimillionaire through his nefarious operations.

Strange stories have seeped up from the underworld of late about Capone. Speculation has become rife over his affiliation, over whether he is the supreme boss of the underworld, or whether he takes his orders from a ring of high-ups.

BROTHER IN SHOES

Mr. Lansinger climaxes the rumors and a stool pigeon whispers with an airish that Capone was killed two years ago, that his half brother, Giacomo Calabrese, submitted to a plastic operation to obtain a synthetic scar on his left cheek and that the latter now rules the criminal syndicates under the almost mythical name “Capone.”

Mr. Lansinger said his facts were authenticated and documented and that he would prove to an incredulous police department soon that his story is correct.

The scowling Capone, or maybe it was Calabrese, when reached by the United Press, said:

“Do I look like Calabrese? Huh, that’s a lot of applesauce.”

Veteran police reporters said that the Capone of today, as far as they could tell, was the same Capone of a decade ago. Pat Roche, chief investigator for the State’s attorney, said:

“If you think Al Capone’s dead, you’re crazy.”

INFLUENCE ON WANE

And that leads up to the fact that Capone’s influence apparently is beginning to die, now that Chicago’s new mayor, Anton J. Cermak, has started his campaign to “run the gangsters out of Chicago.”

The Capone gangsters are laying low. Capone speakeasies are closing with increasing frequency and Capone breweries are running with less brew in the vats than at any time since the advent of prohibition.

23 Indicted After Raid On 2 Capone Breweries

CHICAGO, May 1 (I.N.S.)—Bert Delaney, alleged chief of the Al Capone brewery division; Steve Svobda, his first assistant, and 21 other reputed employees of Capone breweries, were named in indictments returned today by the Federal Grand Jury. The indictments charge violation of the Federal prohibition act, following raids on two breweries, one of them among the largest beer manufacturing plant ever to operate in Chicago.
