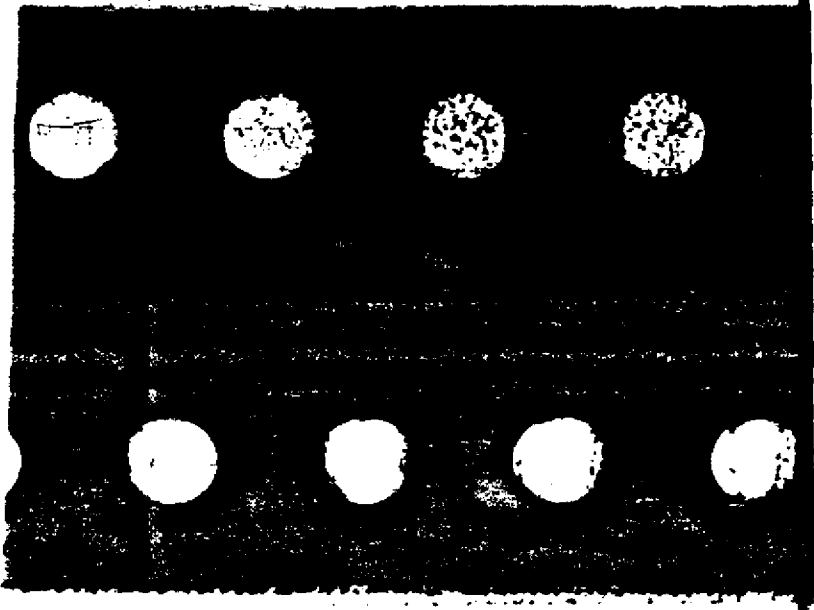

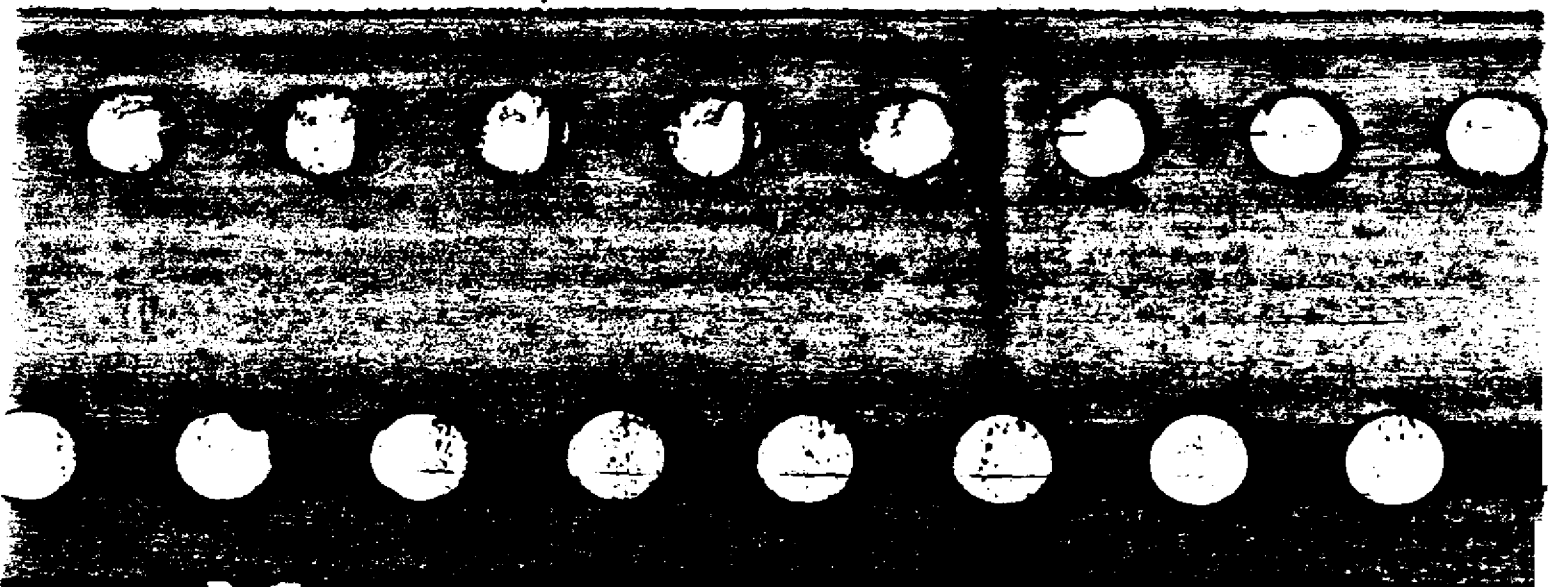

SUMMARY:

Attached radiogram advises that a fishing boat had recovered some blue material similar to clothing worn by Alcatraz inmates from the San Francisco Bay. Arrangements made for skin divers who are correctional officers at Alcatraz to dive in area, when conditions permit, Warden pointed out inmates clothing often found in bay as they flush them down their toilets.

FOR BUREAU'S INFORMATION [REDACTED] WHILE FISHING ON A LOCAL PARTY BOAT IN SAN FRANCISCO BAY, THOUGHT HIS HOOK HAD CAUGHT ON A CHUNK OF MOSS AND PULLED IT ALONG. [REDACTED] THEN REELED IN HIS LINE AND NOTED THAT THERE WAS A PIECE OF BLUE AND WHITE CLOTH ON THE LINE. THIS CLOTH TURNED OVER TO THE FBI AND MATTER DISCUSSED WITH WARDEN OLIN G. BLACKWELL, USP, ALCATRAZ, WHO STATED THAT SAID CLOTH APPEARED TO BE SIMILAR TO THAT WORN BY INMATES AT ALCATRAZ; HOWEVER, WARDEN POINTED OUT THAT NUMEROUS SIMILAR PIECES OF CLOTHING TURN UP AT SAN FRANCISCO BAY AND ON THE BEACH AT ALCATRAZ, AS INMATES FREQUENTLY THROW THEM DOWN THEIR TOILETS.

WARDEN BLACKWELL SAID HE PLANS TO HAVE TWO SKIN DIVERS, BOTH OF WHOM ARE CORRECTIONAL OFFICERS, CHECK THE AREA WHERE THE CLOTH WAS FOUND. HE ADDED THAT SUCH DIVING CAN BE DONE ONLY AT SELECTIVE TIMES, IN VIEW OF EXTREME TURBULENCE OF THE WATER IN THE AREA WHERE CLOTH FOUND AND PLANS MADE TO START DIVING WITHIN THE NEXT FEW DAYS.

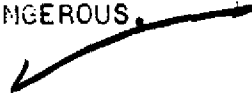

in segregated cell block, became disciplinary problem and has
exhibited psychotic tendencies. Believes [REDACTED] furnished

prison employees in belief that this would obtain him a transfer
from Alcatraz. Additional information believed merely figment
of imagination and when same did not obtain [REDACTED] transfer
[REDACTED] refused to discuss it further. [REDACTED]

Interviews of relatives, acquaintances and contacts of Subjects fail to develop any information that Escapees successfully made mainland.

Fisherman in San Francisco Bay near Alcatraz pulled human cranium to surface. San Francisco coroner determined same had been in bay for several years. Another fisherman hooked piece of inmate clothing while fishing near Alcatraz. Determined pieces of inmate clothing periodically are flushed into bay from clothing factory and by inmates through plumbing facilities. Expert skin divers searched area where piece of clothing hooked but nothing pertinent located.

[REDACTED] at Dothan, Alabama, claims knew Subject MORRIS as inmate at U. S. Penitentiary, Atlanta, Georgia, and in July 1962 says saw Escapees at hideout he located for them near Langley, South Carolina. [REDACTED] admits having been committed in mental hospital and also receiving group therapy for mental condition while in prison at Atlanta. [REDACTED] indicate [REDACTED] is mentally ill. Investigation in area of alleged hideout discloses no such cabin as described by [REDACTED]

"I, [REDACTED] make the following free and voluntary statement to [REDACTED] whom I know to be a Special Agent of the FBI. No threats or promises have been made me to induce this statement.

"I do not remember what cells I occupied at the U.S. Penitentiary at Alcatraz during the summer of 1961. However, in no cell were there holes around the air vent that I noticed and I drilled none.

[REDACTED] further claimed to know nothing of the escape plans of FRANK LEE MORRIS, JOHN WILLIAM ANGLIN and CLARENCE ANGLIN. He said he read about it in the paper and knew escapees to speak to but that is all.

He stated the air vent is located beneath the sink in all of the cells, but reiterated that he never noticed any drilled holes. He said he could not say that he would have necessarily noticed them if they had been there.

[REDACTED] said he is aware of the Harboring Statute and would have his wife advise should escapees contact him. However, he believes this is impossible as no one knows where he is except his immediate family.

INTERVIEWS RE ALLEGATIONS OF SUBJECT [REDACTED]
THAT ESCAPEES HAD HELP FROM ALCATRAZ
OFFICERS AND [REDACTED] AN EX-CONVICT

Date August 31, 1962

Warden OLIN G. BLACKWELL, United States Penitentiary, Alcatraz, California, advised that initially when [REDACTED] an inmate at that institution, had volunteered that [REDACTED] and [REDACTED] another inmate, participated with FRANK MORRIS, the ANGLIN brothers and [REDACTED] all inmates, in the escape plot, [REDACTED] did so since he thought the holes in his cell walls would be discovered by the prison officials. BLACKWELL also believed that [REDACTED] thought by furnishing this information, he might gain an immediate transfer from Alcatraz. At that time [REDACTED] advised that he had furnished all of the information he knew as to the escape plot and it was believed from the ensuing investigation in the cells of [REDACTED] and [REDACTED] that [REDACTED] was telling the truth as to his participation. b7c

After it had been determined that [REDACTED] and [REDACTED] were all evidently involved in the escape plot, they were segregated from the regular cell block and placed in the Treatment Unit having individual open front cells. This Treatment Unit is utilized for inmates who refuse to comply with prison regulations. After having been in this Unit for awhile [REDACTED] together with some of the other inmates, refused to stand up and go to the front of his cell door for routine prison inmate counts during the day.

[REDACTED] then indicated to Associate Warden ARTHUR DOLLISON that he believed [REDACTED] identified as [REDACTED] had assisted MORRIS and the ANGLIN brothers in escaping. Also, he indicated that the [REDACTED] at the institution [REDACTED] had innocently made available 200 pounds of cement and an electric drill used by the Escapees. BLACKWELL believes that this latter story by [REDACTED] relative to the escape as it concerns [REDACTED] and [REDACTED] was a figment of [REDACTED] imagination and was told by [REDACTED] merely in the belief that it would obtain him an immediate transfer from Alcatraz.

After the refusal of [REDACTED] and some of the other inmates in the Treatment Unit to stand up for inmate count, they,

together with [REDACTED] were placed in that portion of the Treatment Unit having closed front individual cells. After a few days in that portion of the Treatment Unit [REDACTED] and some of the other inmates indicated their willingness to comply with prison regulations, and they were returned to the Treatment Unit open front individual cells. b7c

On August 23, 1962, BLACKWELL discussed with [REDACTED] his insubordination as to prison rules and regulations. [REDACTED] would not discuss the allegations he had made concerning [REDACTED] or [REDACTED] nor would he give any further details as to the escape. [REDACTED] also advised Warden BLACKWELL that he would not discuss this matter with anyone. [REDACTED] further declined to tell Warden BLACKWELL whether the story he had told relative to [REDACTED] and [REDACTED] was true or not.

BLACKWELL stated that a disciplinary report had been prepared relative to [REDACTED] which indicated that he, [REDACTED] had made serious charges against two officers of that institution and then had refused to furnish details of same or to discuss it further. It was expected that action would be taken concerning [REDACTED] relative to this report and that he would be returned to the Treatment Unit closed front individual cell section.

BLACKWELL advised that [REDACTED] appears to have a mental problem, having psychotic tendencies, and this appears to be more apparent as time goes on.

BLACKWELL stated that he believes that the latter's story told by [REDACTED] was merely to enable [REDACTED] to get a transfer from Alcatraz. BLACKWELL felt that [REDACTED] had merely "dangled" the information that he had knowledge as to the details of [REDACTED] and [REDACTED] participation as an inducement for a transfer. He believed that [REDACTED] had probably refused to conjure up the details since it was probably the workings of [REDACTED] mind that he might be transferred elsewhere by prison officials since they felt he would then furnish such details.

[REDACTED] advised that [REDACTED] and for the past number of months they have been in the process of installing an entire new plumbing system in "C" Cell Block. This requires his presence in the cells in "C" Cell Block, as well as in the utility corridor behind "C" Cell Block. In addition, as difficulties arise in the plumbing in "B" Cell Block, it has been necessary to enter certain of the cells, as well as the utility corridors in "B" Cell Block.

[REDACTED] advised that generally three or four inmates [REDACTED] assist on these projects. Inmate [REDACTED] was one of the inmates who had been assigned [REDACTED] and [REDACTED] had done so for approximately one year until about the middle of June 1962 when [REDACTED] was removed from that job.

Of necessity, [REDACTED] must take numerous tools inside the main cell house. When he goes into the main cell house, every one of his tools is listed by the guard to the main cell house and upon leaving the same day he must check all of his tools and equipment out through this guard. During the approximate three years he has worked at this position, he has never missed any tools and has always accounted to the guard for every tool that he has taken into the cell block. [REDACTED] states that his tools are never left in the cell block overnight but of necessity must be taken by him out of the cell block.

It is necessary for him to use cement to patch up the cell walls after the various plumbing installations. He always mixes his own cement for patching the walls on the outside of the cell block and then takes it into the cell block where it is utilized. He recalls that upon one occasion he took some cement in sacks into the cell block and stored it in "A" Cell Block, which is locked up and not utilized by the inmates for housing.

He advised that there was continuous work being done repairing the cell walls and painting in the main cell house. In the course of doing this work, inmates would naturally have access on many occasions to cement; however, the cement which he used in connection with his work had always been mixed and would have to be used immediately.

[redacted] advised that he, of necessity, used electric drills and many other type tools concerning his plumbing activities. At all times the inmate plumbers were supervised by either [redacted] or another guard while they were doing their plumbing jobs and using the various tools and equipment.

He volunteered that they had never asked him to assist them in any manner as to escape or, in fact, ever hinted as to their desire to escape.

While on that shift, he was extremely busy in conducting the duties of that position since he was the only man inside the main cell block. Thus, he was almost constantly on the move and had no time to visit with any of the inmates.

[REDACTED] advised that he never knew much concerning the aforementioned four individuals since they were never assigned to any of his work details at the kitchen or in the industries at the institution. He advised that the portion of the cell house where these four individuals were housed was noisy upon occasion; however, he could never attribute the noise to any of these four individuals, but determined that the shouting and arguing and loud voices came from the second tier of that cell house. He noted that these four individuals were on the first tier.

When the lights are out at 9:30 p.m., any small noise thereafter sounds like an explosion. He never heard any unusual noises after 9:30 p.m. while on that shift.

On September 4, 1962, Warden OLIN G. BLACKWELL, U. S. Penitentiary, Alcatraz, advised that an inmate who insisted upon being anonymous, said that [REDACTED] was a close friend of escapee MORRIS. The anonymous inmate reportedly obtained this information from [REDACTED]. A few months ago, it was known that [REDACTED] would probably have a hearing in court on a writ at New Orleans about September, 1962. b7c

MORRIS had allegedly agreed with [REDACTED] that if he, MORRIS, was successful in escaping he would get in touch with [REDACTED] when [REDACTED] was in court in New Orleans and would possibly assist [REDACTED] in escaping. b7c

The following inquiries at San Francisco, California, were made by SA [REDACTED]

On September 15, 1962, [REDACTED] **b7C**

[REDACTED] advised that a [REDACTED] had been fishing west of Alcatraz between the Raccoon Straits and Alcatraz. While fishing he hooked onto something on the bottom of the bay and after finally jerking his line loose, he pulled a cranium to the surface. This was a human cranium and merely consisted of the skeleton part, near beginning of the eyes in front and to the beginning of the neck of an individual in the rear. **b7D**

[REDACTED] stated that it appeared to have been there for an extended length of time since there were many barnacles on it, no hair, etc., and the skeleton of the cranium was completely clean and the bones worn. [REDACTED] advised that the skeleton was being taken to the coroner of San Francisco for analysis.

On September 15, 1962, [REDACTED] **b7C**

[REDACTED] advised that he was fishing in San Francisco Bay with [REDACTED] **b7D**

[REDACTED] stated that approximately one-half mile west of Alcatraz and about 50 yards east of the H and R Buoy his fishing line became snagged. He finally pulled it loose and in doing so pulled up a human cranium. He stated that he believed that it was approximately 50 to 60 feet deep where they were fishing and that he was using a three pound lead sinker which would cause his hook to be near or on the bottom of the bay in that area. [REDACTED] advised that he had taken the cranium to [REDACTED] of the San Francisco Police Department.

From the condition of the human cranium it was apparent that this cranium had been in the bay for several years and definitely more than one year. He volunteered that he had closely

[REDACTED] stated that this cranium could not possibly be concerned with the Alcatraz escape.

Both [redacted] and [redacted] volunteered to display the area where this occurred.

On September 21, 1962, this matter was discussed with Warden OLIN G. BLACKWELL, U. S. Penitentiary, Alcatraz, who volunteered to check the depth charts around the island. Arrangements were made to discuss the matter further with Mr. DOLLISON, Associate Warden, on September 24, 1962.

On September 24, 1962, ARTHUR DOLLISON, Associate Warden, U. S. Penitentiary, Alcatraz, advised the piece of clothing appeared to be similar to that worn by inmates at Alcatraz. However, numerous similar pieces of clothing turn up in San Francisco Bay and on the beach of Alcatraz as inmates throw them down their toilets.

DOLLISON said he planned to have correctional officers [redacted] and [redacted] both skin divers, check the area where the cloth was found. He also planned to have [redacted] who located the cloth, display the area. b7c

On September 25, 1962, DOLLISON advised that the two correctional officers who were skin divers had attempted some diving west of Alcatraz in the vicinity where the piece of inmate clothing was hooked by the fisherman. DOLLISON stated that there was considerable turbulence in the water and visibility practically zero. The divers were unable to conduct an adequate search in that area due to these conditions.

On October 3 and 4, 1962, DOLLISON stated that three expert skin divers of the United States Coast Guard, supplemented by four expert Navy skin divers, had completely covered the area where the piece of inmate clothing was snagged by diving on those two days. DOLLISON stated that these skin divers working as a team had carefully plotted the entire area and had gone over it very carefully. In the area where the fisherman located the piece of inmate clothing the skin divers determined that this was sandy without rocks or any other type of obstacles and that due to the turbulence and currents in that area, it would be impossible for any drowned body to stay in that area. DOLLISON stated that the skin divers advised that they had good visibility, up to six feet, during their diving on the aforementioned two days.

As he was starting on a fishing trip at about 5:30 A.M., he stopped in a truck stop located a short distance north of Meadowlark Motel. He is not sure of the name of the truck stop but thinks it was merely "Truck Stop."

He was served by and talked to a man who indicated that he was the owner of the truck stop having just purchased it. The man told a story of having been wandering around for a year and not having worked for that period of time. He talked of fishing in various places.

On the morning of July 24, 1962, [REDACTED] observed wanted posters in the Fort Knox, Kentucky, Post Office and believes that the man he talked to closely resembles the photograph of FRANK LEE MORRIS, I.O. 3584. He said that he was not good on descriptions, but felt that the description of the man he had talked to in the truck stop was close to that of MORRIS on the IO.

[redacted] explained that she does not drink and does not visit the taverns for pleasure. She explained that she makes corsages and sells them in and near the various taverns and bars in the downtown section of Seattle. She said that the reason she believes she has seen CLARENCE ANGLIN is "his eyes look so tough and mean" and she does not believe she will ever forget those eyes. She stated that she recalls absolutely nothing relative to him and cannot recall what he was doing when she saw him, whether he was with anyone else or not or whether he was drinking at the bar. In this regard, she stated that when she observed ANGLIN's photograph in Canby, Oregon, she immediately recalled that she had seen ANGLIN and reasoned that it must have been in one of the bars on First Avenue in Seattle, although she could not specifically recall it being one of the taverns.
