The Q2 material from the hole consists essentially of small lumps and loose particles of neat Portland cement mixed with small particles of lime mortar, sand grains, small wood particles and paint chips.

The Portland cement has had some moisture in it but is not believed to have had enough moisture to form a slurry. The length of time the cement was in use could not be determined. The Q2 cement was found to be different from the K2 white cement paint submitted.

The particles of blue-green paint which were in Q2 were found to be similar in color, texture and composition to the blue-green paint of specimen K1. The paint chips in Q2 and the paint of K1 could have come from the same source.

As a matter of information, nothing of particular significance was noted during the comparison of the questioned writing with the writings on K8 through K10 and with the fingerprint card signatures of .

Specimens K8 through K10 and the ALSO SUBMITTED dental charts are being retained. The disposition of the items included in specimens Q7 and Q15 will be reported separately.

SA [redacted] conducted an investigation at Peoria Illinois. [redacted] advised on 7/26/62, after receipt of his letter to the Bureau was acknowledged, that a man by the name of [redacted] had rented a room in the Hotel around the 1st of June, 1962, and stayed about a week to 10 days. He was arrested for writing bad checks and was given a year in jail. The checks were passed in clothing stores. While [redacted] was in the Hotel there were 3 other men who seemed to be friendly with him. [redacted] could not describe these men and said that he got the idea that these men could have been the subjects of this case because of 3 things. [redacted] was arrested while buying clothes, some of [redacted] clothes were stolen while these men were in the Hotel, and after [redacted] left there was a letter came for him with the return address of [redacted]

[redacted] said there was something strange about this because there are very few [redacted] in the country. He theorized that possibly the theft of his clothes with possible laundry marks could be used by anyone who might take the name of [redacted]. He could not identify any of the men as the subjects in this case. He said that he wrote the letter to the FBI strictly because of theory.

No blood was identified on life preservers (your numbers 2 and 4). The life preservers (your numbers 2, 3 and 4), the partially completed pontoon (your number 5), the fabric in with the personal items (your number 6) identifiable with the Anglin brothers, and the raincoat (your number 1) are all composed of the same type of material, namely, rubber-coated cotton fabric. The submitted life preservers were inflated until firm. It was necessary to first seal three small punctures in the life preserver located in San Francisco Bay (your number 4). Weights were placed on these life preservers. The specimen from on top of "B" cell (your number 2) appeared to be completely airtight remaining firm for several hours. The life preserver located at Fort Cronkite Beach and the one located in San Francisco Bay lost most of the air in about an hour. However, the rate of deflation was slow and pressure could no doubt be maintained by mouth.

All of the submitted saw blades in your items 14, 16 and 20 appear to be homemade. It appears that pieces of steel from your number 16 and your number 17 could represent materials from which the homemade saws were made. Some of these steel fragments are 1 1/16" wide and approximately .015" thick. Other fragments are 1/2" wide and approximately .021" thick. In dimensions and appearance the 1 1/16" steel strips are similar to metal from a large spring. Steel banding strap material for use in preparing boxes for shipment is usually softer than the instant strip metal but it looks strikingly similar. The source of the 1/2" wide material is not known.

There has been no definite information that all, or less than all, of subjects reached the mainland. Under circumstances you must insure careful investigative attention is being afforded case to insure obvious and logical leads are not being overlooked.

Communications from your office indicate virtually all investigative effort is being expended toward the location of the bodies of subjects in the San Francisco Bay or nearby Pacific Ocean area. While there certainly is ample reason to conclude the escape might have been unsuccessful, the possibility does exist that the subjects reached the mainland and hence your office, as origin, must be continuously on the alert for indications subjects are alive.

On 7/12/62, the body of LEON ROSS MELLICK, a truck driver from Colusa, Calif., was recovered from San Francisco Bay near Golden Gate Race Track, Albany, Calif. MELLICK had jumped off of the Oakland-San Francisco Bay bridge on July 2, 1962. His body was somewhat decomposed and identification was effected by numerous personal papers, as well as clothing found on the body.

Continuing contact with law enforcement agencies, U. S. Coast Guard, and other facilities in the Bay area, together with various searches and inquiries, as well as interviews of associates, relatives, inmates and former inmates of escapees, has failed to develop any evidence that escapees were successful in making the mainland.

Another report is being prepared in this matter and will be submitted by 7/23/62.

As the Bureau is aware, the inmates at the United States Penitentiary, Alcatraz, California, are for the most part incorrigibles, having been unable to comply with the laws of society and then subsequent to their incarceration in a penal institution have been in serious conflict with prison rules and regulations or other inmates at these institutions. In view of the past histories of these inmates, it can hardly

Liaison with police agencies has developed no pertinent information as to Escapees. Spoon handles, pieces of metal and wire similar to those in ventilator grills of inmates' cells, located in solidified paint in can in paint room of U. S. Penitentiary, Alcatraz, California. [REDACTED] and [REDACTED] had access to paint room. b7c

FBI Laboratory advises the life preservers recovered from B Cell Block, on Fort Cronkhite Beach and from San Francisco Bay; the partially completed pontoon recovered from B Cell Block and the Alcatraz inmate raincoat are all composed of same type of material, mainly rubber-coated cotton fabric. The life preservers are all yoke type, placing flotation behind the head as well as in front of the body. "Popular Mechanics" March 1962 issue located in cell of [REDACTED] contains article discussing the various types of life preservers. However, the article states that the yoke-type preserver makes swimming difficult. "Sports Illustrated" March 21, 1962, issue located in cell of MORRIS contains article discussing various inflatables, including life preservers and indicates composition of most inflatables as vinyl plastic or rubberized fabric, the latter being durable and more difficult to puncture. b7c

FBI Laboratory inflated life preservers and placed weights on them. Life preserver recovered from B Cell Block discovered completely air tight, remaining firm for several hours. Other two life preservers lost most of their air in about an hour by slow rate of deflation, but pressure could be maintained by mouth.

Hair on dummy faces recovered from cells of Escapees and [redacted] is of human origin. Three of dummy faces recovered from cells composed variously of Portland cement, sand and white cement paint with coloring by flesh-colored paint. Dummy face recovered from cell of CLARENCE ANGLIN formed from soap packed over bundle of white cotton rags and painted with flesh-colored paint. Two paddles recovered similar in design and construction and composed of similar materials. All saw blades recovered appear to be homemade.

On June 13, 1962, seventy five photographs of subjects were reproduced and copies placed in the hands of all police personnel in Las Vegas. [redacted] advised his department was giving close scrutiny to all abandoned cars located in Las Vegas, and were giving consideration to each stolen car report received for immediate check-out to determine if there was any connection with the subjects.

[REDACTED] United States Penitentiary, Alcatraz, advised that on July 17, 1962, he was checking material stored in the paint room in "A" cell block at the institution. This portion of the cell block has been enclosed and locked off from the other cell blocks. "A" cell block has not been used for housing prisoners since 1952, because of lack of plumbing and security grill work. The material in the paint room is issued to inmates who are working inside the main cell block in painting and refurbishing the cell block areas. He noticed a five gallon can of white cement paint and took the lid off of it. The paint was solidified, evidently due to someone placing water therein. He cracked the cement and upon doing so found the following items inside the cement:

- 7 Spoon handles
- 9 Pieces of heavy metal, ranging from 2" to 12" in length, similar to the framework of the ventilator grills in the back of the inmate's cells.
- 4 Pieces of heavy wire similar to that of the ventilator grill.
- 2 Pieces of metal from 5" to 7" long.
- 1 Three-eighths inch screw bolt about 4" long.

He said that inmate [REDACTED] had been on the paint crew and would have had access to the paint room. In addition, inmate [REDACTED] as an inmate plumber in the main cell block, would also have had access to the paint room.

He identified this material and gave it to Special Agent [REDACTED] so that it could be maintained.

**Results of examination:**

The life preservers, the partially completed pontoon, the Q7 packet and the K3 raincoat are all composed of the same type of material, mainly rubber-coated cotton fabric. The adhesive used on these items is a rubber adhesive different from the Rem-Weld glue of specimen Q22.

The life preservers are all the yoke type, that is with a hole for the head, placing flotation behind the head as well as in front of the body.

Specimen K4 (Popular Mechanics, March 1962) contains an article discussing various types of life preservers. The article includes pictures of a man wearing a yoke type preserver similar in shape to Q3 through Q5, with the caption "Yoke-type vest holds swimmer high and upright; keeps unconscious man riding high, face out of water." The article states, however, that the yoke type preserver makes swimming difficult.

Specimen K5 (Sports Illustrated, May 21, 1962) in discussing various inflatables, life preservers, toys, et cetera, states that "The composition of most inflatables.....is either vinyl plastic or rubberized fabric. Rubberized fabric is durable and more difficult to puncture than vinyl."

Specimen K6 (Popular Mechanics, November 1960) contains an article on making decoys out of inner tubes by a vulcanizing process. Neither the material nor the process was used in constructing Q3 through Q7.

The life preservers were tested for their ability to retain air. They were inflated until firm, and then weights were placed on them. It was necessary first to seal three punctures in Q5. Specimen Q3 appeared to be completely airtight, remaining firm for several hours. Specimens Q4 and Q5 lost most of their air in about an hour. However, the rate of deflation was slow, and pressure could no doubt be maintained by mouth.

The hair on the dummy faces was verified as being of human origin.

The dummy faces were examined for the presence of bristles similar to those composing the K7 brush, but none were found.



Specimen Q18 has a base of concrete composed of Portland cement and sand. Over the concrete is a layer of white cement paint similar to the K2 white cement paint.

Specimen Q19 is basically a mixture of Portland cement, sand grains and white cement paint with a layer of white cement paint over the mixture.

Specimen Q21 is similar to Q19 in that it is basically a mixture of Portland cement and white cement paint over which is white cement paint.

Specimen Q20 is formed from soap packed over a small bundle of white cotton rags.

Although the tan or flesh-colored paint on the dummy faces was basically similar to the K7 paint, differences were noted. It appears that paint like K7 could have been used on the dummy faces; however, prior to use other paint ingredients were added to it. For example the paint on Q20 and Q21 contained barium not found in the K7 paint, and the paint on Q18 and Q19 contained more lead than the K7 paint. Paint ingredients, pigments or extenders containing barium or lead could have been added to K7 and then the mixture could have been applied to the dummy faces.

The two paddles, Q24 and Q25, are similar in design and construction and are composed of similar materials.

The blue-green paint used on the cells, specimen K1 (FBI Laboratory report dated July 3) was similar in color and composition to the blue-green paint on Q24 and Q26.

The walls or sides of the periscope, Q23, and the backing on Q26 were composed of a material similar to an artist panel which is a white cotton canvas over a stiff cardboard backing. This panellike material present in the periscope, Q23, bears the trade name "Blue Boy" and "18" X 24". The adhesive on the inside of the periscope is similar to Rem-Weld liquid plastic adhesive as found in specimen Q22.

All of the submitted saw blades in specimens Q8, Q10 and Q13 appear to be homemade. The following information was compiled concerning the saw blades:

It appears probable that the four pieces of steel listed in the last table represent materials from which the homemade saws were made.

In dimensions and appearance the 11/16" wide steel strips are similar to metal from a large spring. Steel banding strap material for use in preparing boxes for shipment is usually softer than the saw blade metal but it looks strikingly similar to it. The prison officials probably can determine the most logical source of the saw blade metal including the 1/2" wide metal.

It is not possible to estimate the age of the saw blades on the basis of the amount of rust on them.

Specimen Q9 consists of the round knurled handle and 1 5/8" of the filing portion of a small, broken file. The information "2 SIMONDS" appears on the handle of the old file which identifies it as a product of the Simonds Saw and Steel Company, Fitchburg, Massachusetts, a large volume manufacturer of saws and files.

In addition to the three thin pieces of steel in Q11 which appeared similar to the steel from which the saw blades were made, there were numerous pieces of miscellaneous metal, homemade tools, tablespoon handles, a small wooden block with three set screws and a homemade flashlight.

The wooden block could be used as a chuck on an electric drill.

The flashlight demonstrates the ingenuity of the prisoners in utilizing available material to accomplish their purpose. The housing for the two penlight batteries (one battery is a spare) is a small rectangular plastic box which has a hole in one end through which the bulb is screwed so that the base of the bulb contacts the center post of the battery. A fastener, similar to an Acco type file fastener, is employed as the means of carrying the electricity from the battery base to the side of the bulb and it also acts as the switch. There is no lens or other protection for the bulb.

No pertinent information was developed from examining the electric motor, Q12, the steel scraping or digging tool, Q14, the electric cords of Q16 and Q17 and the two pieces of steel in Q16.

Specimen Q15 consists of three tablespoon handles, a homemade steel tool with a paper tape handle and some black fabric tape stored around part of a small Singer Sewing Machine book containing some writing. No significant information was developed concerning the tablespoon handles or the small tool.

No blood was identified on specimens Q4 and Q5.

[REDACTED] stated that [REDACTED] was living in Oklahoma City and that [REDACTED] was of the opinion that the ANGLIN brothers were with [REDACTED]

[REDACTED] advised that he would not testify in court to the information he had given, but that he would, over the weekend, write out all information, which he would then furnish to Mr. DOLLISON, on July 30, 1962.

DOLLISON stated that from the job assignments the individual called [REDACTED] would be correctional officer [REDACTED]

[REDACTED] an inmate of United States Penitentiary, Alcatraz, California, was interviewed at that institution. [REDACTED] was advised initially that he was not required to make any statement and that any statement he did make could be used against him in a court of law. He was advised to his right of counsel. b7c b7D

[REDACTED] stated that he had no information to furnish, however, he volunteered the opinion that perhaps one or two but not all three of the escapees, would return again to Alcatraz. He stated that on the night of the escape, the night was dark, the water was calm, and there was no wind blowing.

SA [REDACTED] asked [REDACTED] how he knew of those conditions, and [REDACTED] smiled and stated "I know, I know." [REDACTED] did not elaborate further on the general conditions.

[REDACTED] further volunteered that he had made all of the life jackets, stating that the interviewing Agents had seen his life jacket and that they knew it held air. [REDACTED] stated the life jackets were meant to be used as a support, keeping one's head out of the water, and that they were not designed for swimming. [REDACTED] stated that the valve of the life jacket was close to the mouth of the user of the jacket and from time to time anyone using the life jacket could easily inflate the jacket if it was necessary.

[REDACTED] stated that the physical condition of the ANGLIN brothers and MORRIS was good. Prison inmates were of the opinion that the escapees had succeeded, while others maintained that they had not been successful.

He stated that others had attempted to escape and that they were successful in going to court and he felt that his participation in the escape attempt would be a good way to insure his court appearance.

"I was previously interviewed as to the escape from Alcatraz Penitentiary by inmates JOHN and CLARENCE ANGLIN and FRANK MORRIS. At that time I was emotionally disturbed and I do not recall what I said. I believe I gave a plausible story at the time for the benefit of the prison official who was present as I was in fear of repercussion from the prison officials as to the escape.

"Between February and May 1962 I had put blankets around the top of B cell block while

"painting. While in the prison yard one day inmate JOHN ANGLIN in the presence of his brother CLARENCE ANGLIN said I should have the blankets up as they were going to store some beer up there. A week or so later I told JOHN I was going up on B cell block again to paint some more. JOHN said he still wanted me to leave the blankets up as he had something going. I said 'OK' and he didn't explain further nor did I inquire. Later on I went to JOHN ANGLIN and said I'd have to take the blankets down as the officials might ask me about them. JOHN said he was going to try to 'beat the joint,' meaning escape, and I left the blankets where they were.

"Any connection on my part with the escape attempt was merely an attempt on my part to get into court to air my problems.

After reading this statement [REDACTED] declared that it was true. He then requested that he have an attorney. Since he had no attorney with whom he could consult at that time, he did not sign this statement. b7C
