The following is a summary of BPP activities within the Charlotte Division during the month of September, 1970:

The group continues to receive and sell BPP newspapers and articles continue to be published in the BPP newspaper bylined Winston-Salem. It is noted that one of these articles sets forth that the group at Winston-Salem was the only officially recognized BPP group in North Carolina. They continue to have financial difficulties and there is dissension and dissatisfaction within the leadership.

About ten members of the group attended the Repressed Peoples Constitutional Convention at Philadelphia, Pa., 9/5 - 7/70 accompanied by approximately 25 individuals from Winston-Salem not known to be members. The group traveled in a rented truck and rented cars.

Date 10-30-70

Attached relates that a group of Negroes claiming to be Black Panthers broke up the meeting of the Redevelopment Commission in Lumberton, North Carolina, on 10-29-70. Subsequently, there was an exchange of gunfire. Because of this shooting incident and the organization of an organization called National Committee to Combat Fascism (another name for Black Panther Party), there was considerable tension in the Lumberton area.

Copy of attached sent Inter-Division Information Unit and Special Interdivisional Unit of the Department. Pertinent parts will be included in teletype summary to the White House, Vice President, Attorney General, the military and Secret Service.

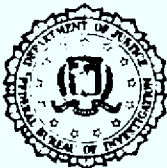

On October 13, 1970, [REDACTED] High Point, North Carolina, advised that at approximately 11 A. M., October 12, 1970, an anonymous telephone call from an unidentified male was made to the High Point, North Carolina [REDACTED] advising that seven unidentified industrial plants were to be bombed in the city if two Negroes, presently being held in jail, were not released by October 14, 1970. [REDACTED] identified these individuals as LEO WOODBURY, an identified Black Panther Party member, and JOSEPH ERWIN WADDELL, both from Winston-Salem, North Carolina, who are being held on local armed robbery charges. 11 C

On October 14, 1970, [REDACTED] supra, advised that at 6:03 A. M., that date, an anonymous caller, believed to be a Negro female, telephoned the switchboard at the [REDACTED] High Point, advising that her brother was in the Black Panther Party at Adams-Millis; that he had been refused a job; and that a bomb was set at the plant to go off during the morning. This mill was evacuated and searched, but nothing found.

On October 14, 1970, an Agent of the Federal Bureau of Investigation reviewed the voice on the tape at the [REDACTED] switchboard, High Point, and the following conversation was noted:

"Please sir, I know for a fact someone has set a bomb at Adams-Millis. My brother is with the Black Power people. I don't know - I don't want anything to happen to those people. Please call the police."

The switchboard operator [REDACTED] asked the woman what the problem was, at which time the conversation heard was as follows:

"Someone has set a bomb. I know for a fact. My brother at Adams-Millis. He is in with the Black Panthers. I know somebody wouldn't give him a job. Please help those people down there. I don't want anything to happen to them. I couldn't call the Police. It's set to go off - I don't know when - it's set to go off sometime this morning - sometime."

BLACK PANTHER PARTY (BPP),  
also known as  
Black Panther Party for Self-Defense

According to the official newspaper of the BPP, the BPP was started during December 1966 in Oakland, California, to organize black people so they can take control of the life politics, and the destiny of the black community. It was organized by BOBBY G. SEALE, BPP Chairman, and HUEY P. NEWTON, Minister of Defense, BPP.

The official newspaper, called "The Black Panther," regularly states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to as "pigs" who should be killed.

The newspaper, in its issue of September 7, 1968, had an article by the then Minister of Education, GEORGE MURRAY. This article ended with the following

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is revolutionary culture. Change. Freedom everywhere. Dynamite! Black power. Use the gun. Kill the pigs everywhere."

The BPP newspaper, issue of October 5, 1968, had an article introduced with the following statement: "We will not dissent from American government. We will overthrow it."

DAVID HILLIARD, Chief of Staff, BPP, in a speech at the San Francisco Polo Field on November 15, 1969, said "We will kill Richard Nixon."

DAVID HILLIARD, in the "New York Times," issue of December 13, 1969, was quoted as follows: "We advocate the very direct overthrow of the government by way of force and violence."

In the issue of April 25, 1970, the BPP newspaper had an article by Minister of Culture EMORY DOUGLAS as follows:

"The only way to make this racist US government administer justice to the people it is oppressing, is...by taking up arms against this government, killing the officials, until the reactionary forces are dead, and those that are left turn their weapons on their superiors, thereby passing revolutionary judgement against the number one enemy of all mankind, the racist U.S. government."

The BPP Headquarters is located at 1046 Peralta Street, Oakland, California. Branches of the BPP, and Committees to Combat Fascism, under control of the BPP, have been established in various locations in the USA.

BARBARA C. WESTMORELAND at Winston-Salem, North Carolina, has been publicly identified as being the defense attorney for members of the Winston-Salem National Committee to Combat Fascism (NCCF) in local cases. The Winston-Salem Telephone Directory reflects that Miss BARBARA C. WESTMORELAND maintains law offices at 300 North Main Street, Room 2323, and resides at 225 North Peace Haven Road, Apartment 20, Winston-Salem, North Carolina. From observation by Special Agents of the FBI, Miss WESTMORELAND is a white female, age approximately 45. [REDACTED]

[REDACTED] Miss WILLARD is an unmarried white female who has been publicly identified as the local American Civil Liberties Union affiliate at Winston-Salem, North Carolina. He had no information that her relationship with members of the Black Panther Party (BPP) was other than attorney-client.

The Charlotte, North Carolina, City Directory lists GEORGE S. DALY, JR. as being a member of the law firm of Casey and Daly, 730 East Trade Street, Charlotte, North Carolina, with home address of 201 Wales Avenue, Charlotte, North Carolina.

During June of 1969, DALY was the attorney of record in a civil action filed in United States District Court, Western District of North Carolina, at Charlotte, North Carolina,

wherein a complaint and motion for preliminary injunction was filed on behalf of seventeen plaintiffs, the majority of which were reported to be preparing for membership in the BPP. The suit was against city, county, state, and Federal law enforcement agencies at Charlotte, North Carolina, and alleges violations of the group's civil rights by police harassment requesting \$10,000 damage for each of the seventeen plaintiffs.

As of October 16, 1970, the suit has not been adjudicated, however, has been dismissed in connection with sixteen of the seventeen plaintiffs.

On May 9, 1970, DALY, representing the American Civil Liberties Union, was a speaker at a rally held in Freedom Park, Charlotte, North Carolina, protesting the death of Ohio College students and the war in Southeast Asia. DALY, during his speech, referred to the Charlotte Police Department as "the enemy" and gave the talk upon the right of peaceful assembly to protest.

During August of 1970, DALY was listed on literature of the Southern Legal Action Movement to be a speaker at their annual summer institution on drug defenses.

On October 15, 1970, DALY was the speaker at a rally at Freedom Park, Charlotte, North Carolina, sponsored by the Progressive Political Union, a New Left type student group at the University of North Carolina, Charlotte, protesting United States involvement in Southeast Asia. DALY quoted from the speeches of H. RAP BROWN, a former leader of Student National Coordinating Committee (SNCC), emphasizing that violence was an American trait.

A characterization of BPP and SNCC are attached as appendices to this memorandum.

BLACK PANTHER PARTY (BPP),  
also known as  
Black Panther Party for Self-Defense

According to the official newspaper of the BPP, the BPP was started during December 1966 in Oakland, California, to organize black people so they can take control of the life politics, and the destiny of the black community. It was organized by BOBBY G. SEALE, BPP Chairman, and HUEY P. NEWTON, Minister of Defense, BPP.

The official newspaper, called "The Black Panther," regularly states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to as "pigs" who should be killed.

The newspaper, in its issue of September 7, 1968, had an article by the then Minister of Education, GEORGE MURRAY. This article ended with the following

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is revolutionary culture. Change. Freedom everywhere. Dynamite! Black power. Use the gun. Kill the pigs everywhere."

The BPP newspaper, issue of October 5, 1968, had an article introduced with the following statement: "We will not dissent from American government. We will overthrow it."

DAVID HILLIARD, Chief of Staff, BPP, in a speech at the San Francisco Polo Field on November 15, 1969, said "We will kill Richard Nixon."

DAVID HILLIARD, in the "New York Times," issue of December 13, 1969, was quoted as follows: "We advocate the very direct overthrow of the government by way of force and violence."

In the issue of April 25, 1970, the BPP newspaper had an article by Minister of Culture EMORY DOUGLAS as follows:

"The only way to make this racist US government administer justice to the people it is oppressing, is...by taking up arms against this government, killing the officials, until the reactionary forces are dead, and those that are left turn their weapons on their superiors, thereby passing revolutionary judgement against the number one enemy of all mankind, the racist U.S. government."

The BPP Headquarters is located at 1046 Peralta Street, Oakland, California. Branches of the BPP, and Committees to Combat Fascism, under control of the BPP, have been established in various locations in the USA.



STUDENT NATIONAL COORDINATING COMMITTEE (SNCC)

A source advised the Student National Coordinating Committee (SNCC), formerly known as the Student Nonviolent Coordinating Committee, is a nonmembership organization founded in 1960, during the civil rights movement in the South.

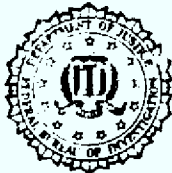
Under the leadership of Stokely Carmichael, who served as National Chairman during the period 1966-67, SNCC evolved from a civil rights oriented group into a full-blown black revolutionary organization.

A publication entitled, "1967 High Tide of Black Resistance" indicates the year 1967 was considered by SNCC as a historic milestone for the liberation of black people in the United States and the year that revolutionaries throughout the world began to understand more fully the impact of the black movement. The publication declared that "liberation will come only when there is final destruction of this mad octopus--the capitalistic system of the United States with all its life-sucking tentacles of exploitation and racism that choke the people of Africa, Asia, and Latin America. The realities of black life, together with the recognition instilled in SNCC workers, forced its members to further popularize the legitimacy of self-defense and rebellions when oppression became too great."

A second source advised that H. Rap Brown succeeded Carmichael as National Chairman of SNCC in May, 1968, and served in that capacity until June, 1968, at which time SNCC reorganized, creating ten deputy chairmen in an effort to relieve pressure by law enforcement.

In April, 1969, SNCC moved its national headquarters from Atlanta, Georgia, to New York City, where it is presently located.

H. Rap Brown announced at a press conference in New York City on July 22, 1969, that he had been elected Chairman of the Student Nonviolent Coordinating Committee. He announced the organization was dropping the word "Nonviolent" from its title and will be known as the Student National Coordinating Committee, with a Revolutionary Political Council functioning as its governing body. Brown, at that time, stated the use of force is necessary in obtaining revolutionary goals.



I. REVOLUTIONARY PROGRAM AND POLICIES AS  
EXPRESSED BY BLACK PANTHER PARTY LEADERS

On September 15, 1970, [REDACTED]

[REDACTED] advised that, [REDACTED] approximately thirty-five individuals from Winston-Salem attended the Revolutionary Peoples Constitutional Convention which started September 5, 1970, at Philadelphia, Pennsylvania. Among these were JULIUS WHITE CORNELL, JR., JAMES FORD, JAMES CATO, LARRY LITTLE, and WILLIAM GARY, along with LEE FAY MACK, her daughters, RUTH and HAZEL MACK, and her husband, HAZEL LEE MACK. The group departed Winston-Salem on the night of September 4-5, 1970, in a van-type truck rented by JULIUS CORNELL, a Ford Torino, rented by LEE FAY MACK, and a station wagon (Ford), rented by JULIUS CORNELL. CORNELL had approximately \$800 in expense money which was all used in view of the fact the group left on September 4, 1970, and returned on September 8, 1970. They stayed at a church on Seventh Avenue near Temple University. In addition to the individuals named as attending, [REDACTED] advised that the rest of the group was made up of members of the community who reside near the Panther Headquarters. '1

On September 25, 1970, SF T-16 reported that an unidentified individual from North Carolina had traveled in various areas of North Carolina and in addition, had talked to someone in Atlanta, Georgia, concerning getting a train in connection with the Revolutionary Peoples Constitutional Convention. This individual was reportedly to attend a staff meeting to be held in New York on September 26, 1970. (U)

In addition, NY T-66 reported that [REDACTED] (phonetic), a Black Panther Party member functioning out of Winston-Salem, North Carolina, had traveled in cities throughout North Carolina and South Carolina, attempting to create interest in establishing BPP community centers and to raise money for the convention. (U)

[REDACTED] at Winston-Salem, North Carolina, as JULIUS WHITE CORNELL, JR., the Defense Captain of the Winston-Salem National Committee to Combat Fascism (NCCF), a BPP affiliated group. (U)

[REDACTED]

JULIUS WHITE CORNELL, JR., was a section leader in the Winston-Salem NCCF and had attended a "staff meeting" over the past weekend in New York. (It is noted this would have been the weekend of September 26-27, 1970). (U)

On October 9, 1970, [REDACTED]

[REDACTED] became aware of two vehicles with New York State tags on them. These vehicles spent three or four days in the Negro area of Lumberton and

contained numerous occupants. They were not identified nor were the license plates copied down. On or about the first of October, these vehicles had disappeared and the following sign was erected on the yard of BETTY JEAN McNEAL, 817 Fairmont Road, Lumberton, North Carolina: (U)

"Revolutionary Peoples Constitutional Convention, power to the black man, kill the pig. Black Panther Party."

During the weekend of October 3-4, 1970, meetings were held with groups of Negroes at Lumberton Recreation Center, and also at the house of an unidentified Negro male, residing at 813 Fairmont Road. (U)

On October 9, 1970, [REDACTED]

[REDACTED] that unidentified individuals were in High Point recently attempting to recruit Negroes to go to the Revolutionary Peoples Constitutional Convention. [REDACTED]

[REDACTED] that fare, food, and housing will be taken care of and there is some indication the group will go by train. (U)

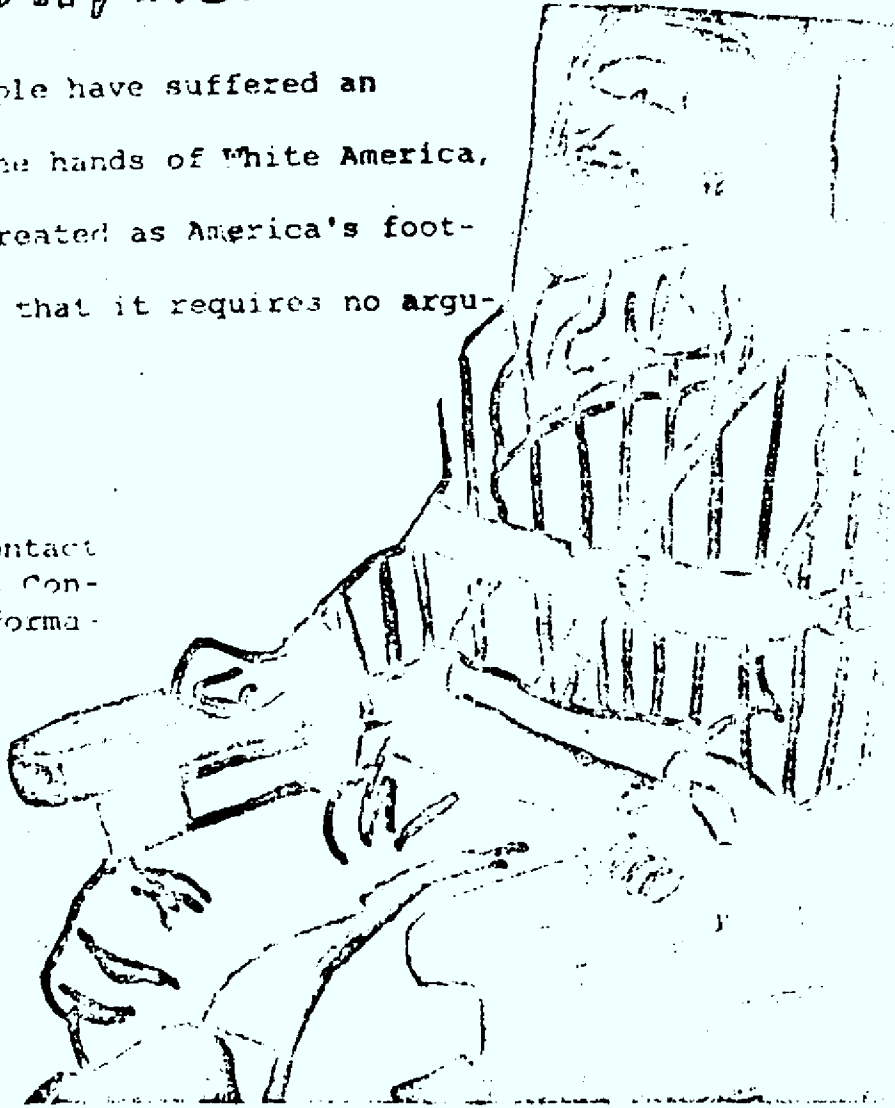

[REDACTED] stated that according to Article 6 of the Ten-Point Program of the Black Panther Party, it was set forth that Panthers believe all black people should be exempt from the Armed Forces of the United States. [REDACTED] stated that he has been a member of the Winston-Salem National Committee to Combat Fascism, which is affiliated with the Black Panther Party, for about two years. In his party membership, he has attended political education classes and sells the Black Panther Party newspaper. In addition, he works in the black community educating the people to the Black Panther Party Program and is trying to hold classes at Winston-Salem State University where he has previously attended concerning the Black Panther Party. [REDACTED] stated that the "Red Book" of Chairman MAO TSE-TUNG is now partly obsolete.

He stated he has no other employment other than his working for the Black Panther Party and [REDACTED] JULIUS W. CORNELL, JR., is a Section Leader with the Black Panther Party at Winston-Salem, North Carolina. [REDACTED] stated he has participated in rallies of the Black Panther Party, wherein as many as 35 to 40 white people have attended, these being people who believe in the revolution as the Panthers do. When asked to explain his meaning of revolution, he stated that the Panthers believe in the overthrow of the Government of the United States and to believe in revolution is to be a revolutionar to be a revolutionary is to be a revolutionary of the state, and he did not believe the United States wanted him in the United States Army.

II. ACTS IN FURTHERANCE OF THE REVOLUTIONARY  
PROGRAM OR POLICIES

On September 16, 1970, [REDACTED] Senior Army Instructor, Reserve Officers' Training Corps (ROTC), Atkins High School, Winston-Salem, North Carolina, advised he is establishing a ROTC Unit at this high school and has obtained some of his supplies from Fort Bragg, North Carolina. In August, 1970, while at Fort Bragg with a truck for other supplies, he obtained screens described as ten four feet by eight feet heavy duty screens, Stock Number 5450-526-4565, and two four feet by eight feet heavy duty screens, Stock Number 5340-526-4560, from [REDACTED] Chief Storage Section, Fort Bragg, North Carolina. He did not have to sign any document to obtain these screens which were apparently spare screens which Colonel [REDACTED] possessed. The screens were taken to Winston-Salem and placed in the yard of Atkins High School. U

[REDACTED] stated on September 16, 1970, he drove past the BPP Headquarters, 1602 East Fourteenth Street, Winston-Salem, North Carolina, and observed some screens which were similar in appearance to captioned screens nailed over windows of BPP Headquarters. Upon checking the high school, he found that the screens which he had placed in the yard were missing. U

[REDACTED] Chief Storage Section, Fort Bragg, North Carolina, stated [REDACTED] legitimately draws supplies from Fort Bragg, North Carolina, and on August 24, 1970, came to Fort Bragg and requisitioned ten weapon racks. On this occasion, [REDACTED] gave him the screens, described above, which were left over from an order he had previously made for his own use. Accordingly, no requisition was submitted and no record made of this property transaction. [REDACTED] stated that accountability for this property ended when these screens were issued to Central Storage, Supply Division, Fort Bragg, North Carolina, and [REDACTED] was not required to place them on inventory. He advised that the screens without the door panel are expendable. He stated the screens do not have a unique serial number but have a stock number which is the same on all screens of the same type but which will not serve for individual identification. U

[REDACTED] stated screens of this type have been in military stock for approximately two years. The total number produced is not known nor is it known if they are made for civilian sale. The above-described screens would have a total value of \$299.80. They were manufactured at USONA, 3512 Chouteau, Saint Louis, Missouri, under DSA Contract Number 700-69-9542. They were sent from the manufacturer to the Arms Depot at Granite City, Illinois, and from there to Fort Bragg, North Carolina. U

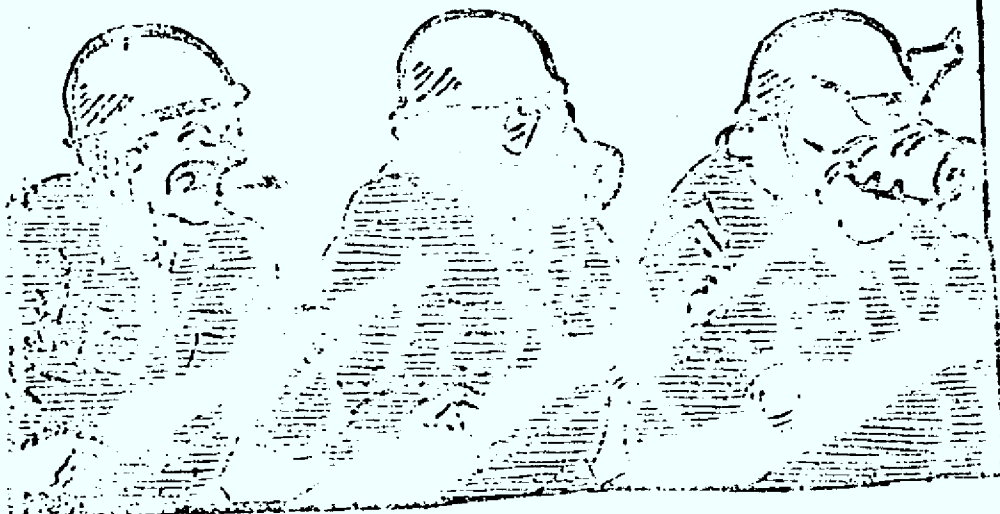

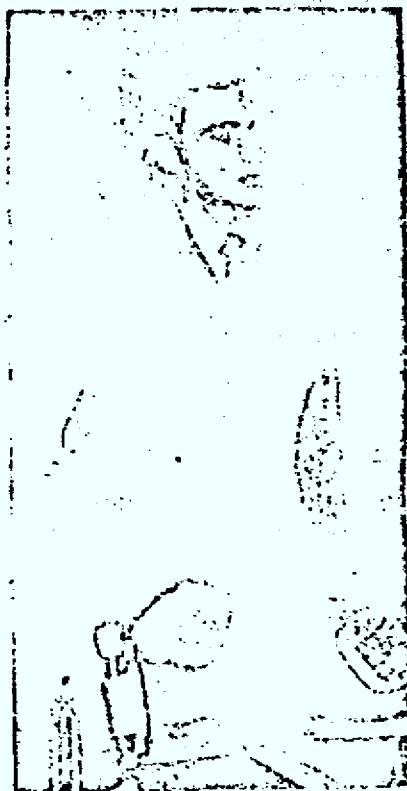

During this period, one weekly order, according to SF T-22, was for 2,500 papers. (1)

It is noted that SF T-16 reported during August, 1970, that there had been difficulty with the group at Winston-Salem, North Carolina, not ordering their papers correctly and were at times behind in their payments for newspapers.

## JAMES CATO OF WINSTON SALEM SUBJECTED TO FASCIST FRAME-UP

James Cato, 26, year old resident of Winston-Salem has now been added to the many attempts by the pigs of the power structure to be framed. This case is just one of many where trumped up charges have been placed on brothers who in some kind of way are striving for freedom and liberation in Babylon and Winston-Salem.

Brother Cato was arrested at his home in the darkness of the night (Fred Hampton Hour 5:00 a.m.) on the trumped up charges of robbery. Thursday morning 8/20/70, brother Cato was asleep in bed when 10 carloads of pigs armed to the gills and looking like Nazi storm troopers (foaming at the mouth) approached his house. His parents not knowing what was coming down were really astounded to find so many pigs at their house that early in the morning. Cato, himself not knowing what was happening was not the least bit surprised to see so many fascist at his house because of the situation at hand here in recent days in Winston.

Earlier today when he was first arrested he was charged with robbery; of what, no one knows. Later on in the evening he was charged with storebreaking and larceny. But when it comes to tactics employed by them, they don't need much decision making ability because a fascist doesn't need much of a mind. They know they don't need much of a case, which is not their main concern anyway. They

It is very important to mention the fact that the brother just came out of the fascist and racist army of the U.S. He came to the N.C.C.F. headquarters shortly after his arrival home from the army. BLACK PANTHER PARTY (BPP).  
also known as  
Black Panther Party for Self-Defense

According to the official newspaper of the BPP, the BPP was started during December 1966 in Oakland, California, to organize black people so they can take control of the life, politics, and the destiny of the black community. It was organized by BOBBY G. SEALE, BPP Chairman, and HUEY P. NEWTON, Minister of Defense, BPP.

The official newspaper, called "The Black Panther," regularly states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to as "pigs" who should be killed.

The newspaper, in its issue of September 7, 1968, had an article by the then Minister of Education, GEORGE MURRAY. This article ended with the following

"Black men, Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is revolutionary culture. Change. Freedom everywhere. Dynamite! Black power. Use the gun. Kill the pigs everywhere."

The BPP newspaper, issue of October 5, 1968, had an article introduced with the following statement: "We will not dissent from American government. We will overthrow it."

DAVID HILLIARD, Chief of Staff, BPP, in a speech at the San Francisco Polo Field on November 15, 1969, said "We will kill Richard Nixon."

DAVID HILLIARD, in the "New York Times," issue of December 13, 1969, was quoted as follows: "We advocate the very direct overthrow of the government by way of force and violence."

In the issue of April 25, 1970, the BPP newspaper had an article by Minister of Culture EMORY DOUGLAS as follows:

"The only way to make this racist US government administer justice to the people it is oppressing, is...by taking up arms against this government, killing the officials, until the reactionary forces are dead, and those that are left turn their weapons on their superiors, thereby passing revolutionary judgement against the number one enemy of all mankind, the racist U.S. government "

The BPP Headquarters is located at 1046 Peralta Street, Oakland, California. Branches of the BPP, and Committees to Combat Fascism, under control of the BPP, have been established in various locations in the USA.

Black Panther Party for Self-Defense

According to the official newspaper of the BPP, the BPP was started during December 1966 in Oakland, California, to organize black people so they can take control of the life politics, and the destiny of the black community. It was organized by BOBBY G. SEALE, BPP Chairman, and HUEY P. NEWTON, Minister of Defense, BPP.

The official newspaper, called "The Black Panther," regularly states that the BPP advocates the use of guns and guerrilla tactics in its revolutionary program to end oppression of the black people. Residents of the black community are urged to arm themselves against the police who are consistently referred to as "pigs" who should be killed.

The newspaper, in its issue of September 7, 1968, had an article by the then Minister of Education, GEORGE MURRAY. This article ended with the following

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is revolutionary culture. Change. Freedom everywhere. Dynamite! Black power. Use the gun. Kill the pigs everywhere."

The BPP newspaper, issue of October 5, 1968, had an article introduced with the following statement: "We will not dissent from American government. We will overthrow it."

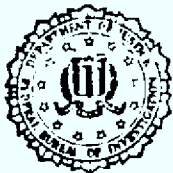
DAVID HILLIARD, Chief of Staff, BPP, in a speech at the San Francisco Polo Field on November 15, 1969, said "We will kill Richard Nixon."

DAVID HILLIARD, in the "New York Times," issue of December 13, 1969, was quoted as follows: "We advocate the very direct overthrow of the government by way of force and violence."

In the issue of April 25, 1970, the BPP newspaper had an article by Minister of Culture EMORY DOUGLAS as follows:

"The only way to make this racist US government administer justice to the people it is oppressing, is...by taking up arms against this government, killing the officials, until the reactionary forces are dead, and those that are left turn their weapons on their superiors, thereby passing revolutionary judgement against the number one enemy of all mankind, the racist U.S. government."

The BPP Headquarters is located at 1046 Peralta Street, Oakland, California. Branches of the BPP, and Committees to Combat Fascism, under control of the BPP, have been established in various locations in the USA.

Referenced Bureau airtel states that "...The Department, in connection with efforts to develop a prosecutive theory against the BPP for the violation of security statutes, has previously requested this Bureau to develop evidence regarding documents of the BPP which urge its revolutionary doctrines and to also develop evidence showing a cohesion or unity between national headquarters of the BPP and its chapters and affiliates.

"Information regarding the shipment of BPP newspapers and other publications falls within the above categories and it is essential that every effort is made to develop full and complete details concerning such shipments. This should include not only the ascertaining of information contained on shipping papers and invoices but; whenever possible through established sources, the confirmation of exactly what is included in the shipment.

"It is anticipated that in the event of prosecution of the BPP, it may be extremely important to be able to conclusively prove that a specific BPP publication containing revolutionary doctrines was in fact shipped by the BPP to various BPP members and/or supporters. Accordingly, it is essential that this Bureau develop evidence of this nature in order to support possible prosecution of the BPP..."

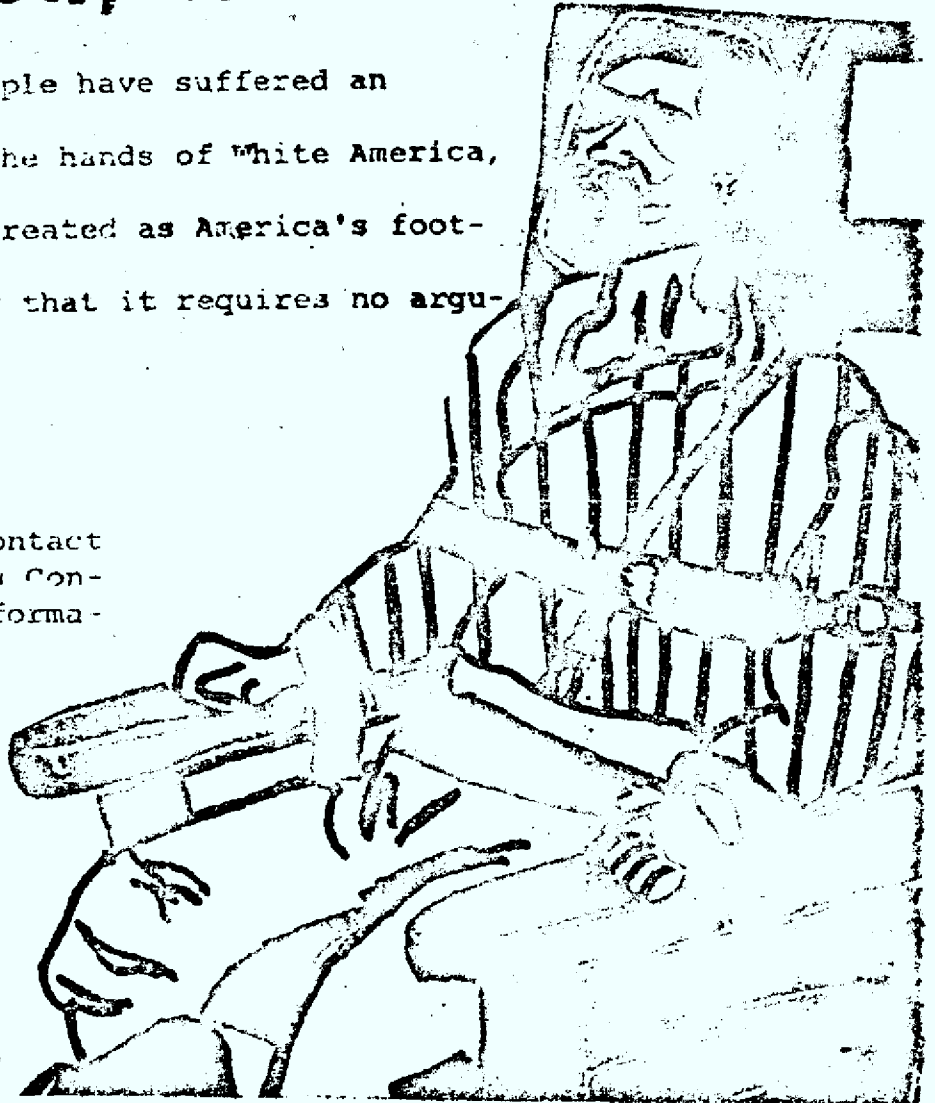

"Black men. Black people, colored persons of America, revolt everywhere! Arm yourselves. The only culture worth keeping is a revolutionary culture. Change. Freedom everywhere. Dynamite! Black Power. Use the gun. Kill the pigs everywhere."

Included in the introduction to an article appearing in the October 5, 1968, edition of "The Black Panther" is the statement "...we will not dissent from American Government. We will overthrow it."

Issues of "The Black Panther" regularly contain quotations from the writings of Chairman Mao Tse-tung of the People's Republic of China and feature Mao's statement that "political power grows out of the barrel of a gun."

The national headquarters of the BPP is located at 3106 Shattuck Avenue, Berkeley, California. Branches have been established at various locations throughout the United States.
