The following technical and electronic installations were made at the premises occupied by Bugsy Siegel, Suite 201, First National Bank Building, telephone 1808, [REDACTED]. [REDACTED] advised that installations were made covering the telephone in the "Boiler Room" of the Las Vegas Club. The "Boiler Room" is the room utilized by Moe Sedway as a business office and which is frequented by Bugsy Siegel when at Las Vegas. The telephones covered are Las Vegas 2460, [REDACTED] Las Vegas 2281, [REDACTED] Las Vegas 2281. The installations were made at 2 p.m., Pacific Standard Time.

[REDACTED] Siegel left Los Angeles at 1:30 p.m. today and will arrive at Las Vegas at 3:30 p.m., Pacific Standard Time, travelling by plane.

The latter indicated that he planned on returning to Las Vegas the evening of July 18, 1946. According to the informant, SUGER mentioned to SA AY that "the boys" have been working on a wire service for their own on a nationwide basis. He indicated that their plans were about seven months old and that their headquarters is in their store in the Loop district. SUGER stated that a person named [redacted] of the group is SA [redacted] and is head of the group and also called the "brains" of the group long range. He also mentioned that SUGER was the businessman for them. He mentioned others as well.

SAC Newman, Salt Lake City, at this time telephonically furnished the following information.

Yesterday Siegel suddenly announced that he had to return to Los Angeles immediately and indicated something very important was going to happen. He took a plane last night at 6:30 out of Las Vegas to return to Los Angeles. Mr. Newman advised that in a conversation with SAC Hood he had learned Hood apparently has picked up information in Los Angeles as to what the big deal is about. They believe it has to do with the Flamingo hotel which is being constructed on the Las Vegas - Los Angeles Highway just outside of Las Vegas. Siegel and Lacey are interested in this hotel.

Siegel is worried about his finances at this time and everything he has is tied up in the hotel construction.

MEMORANDUM FOR THE ATTORNEY GENERAL

RE: REACTIVATION OF THE CAPONE GANG

In the course of the above investigation, we have ascertained that Benjamin "Bugsy" Siegel, notorious racketeer with underworld connections on the west and east coasts and Las Vegas, Nevada, will again visit the latter city within the next few days and reside at the Last Frontier Hotel there in Suite 401. As previously pointed out, we are desirous of following Siegel's widespread activities and, therefore, are requesting authority to place a technical surveillance on his telephone at the Last Frontier Hotel which will be Las Vegas 1800.

At this time, I also wish to point out that Siegel, because of his far-flung interests, is almost in constant travel status, thereby making it extremely difficult at times to follow his activities and anticipate his movements. It is recommended, therefore, that authority be granted to cover any hotels, residences, or places of business which might be used by Siegel in his journeys throughout the country. I strongly feel that this type of coverage is necessary if we are to establish his racketeering connections.

Re confirmation of the telephone call from the Bureau to SAC J. C. [redacted] of the Salt Lake Field Office on July 18, 1946, authority is granted to place a technical surveillance on the telephone of Benjamin "Bugsy" Siegel at the West Frontiers Hotel, Las Vegas, Nevada, where his telephone number will be Las Vegas 1800. This authority is granted, of course, with the understanding that full security is assured. The Salt Lake City Office should furnish by teletype to the Bureau and the Chicago Office the time, date of installation, symbol number, and plant location of the technical surveillance.

The authority received from the Attorney General for the installation of technical surveillances in this case, because Siegel is in almost constant travel status, extends to any hotel, residence or place of business which might however, in connection with any future technical surveillances which offices receiving copies of this letter may desire to install on Siegel, to obtain prior Bureau authority therefor, based upon assurances of full security for each installation.

The Salt Lake City and Los Angeles Offices, in addition to obtaining Bureau authority for any further technical surveillances which may be desired on Siegel, should keep the Chicago Office as the office of origin currently advised with regard to installations both contemplated and put into operation.

Re: BENJAMIN "BUGSY" SIEGEL

MOE SEDWAY had received a Long Distance telephone call in Las Vegas on July 15 from SIEGEL in Los Angeles. SIEGEL desired to know if SEDWAY had heard WINCHELL'S broadcast Sunday evening, July 14 (referred to in my letter of July 15, 1946), and also was interested in knowing what comment had been heard around Las Vegas concerning WINCHELL'S allegation that a prominent West Coast racketeer was attempting to "muscle" a prominent West Coast newspaper publisher out of his interest in a hotel. SEDWAY, according to the informant, told SIEGEL that he had heard the broadcast but there had been no comment whatever around Las Vegas about it. SIEGEL was reportedly somewhat relieved when SEDWAY informed him that no comment had been heard there. According to the informant, SIEGEL, in conversing telephonically with SEDWAY on July 15, referred to and stated that he had made the "S-I-E-B" sign up that day.

In his telephone conversation with SEDWAY on July 15, SIEGEL is reported to have informed SEDWAY that he might return to Las Vegas the latter part of this week or the first part of next week.

## Purpose

WALTER

To advise that Siegel has been informed that Winchell claims the Director furnished him the item he broadcast July 14, 1946, concerning a West Coast racketeer's interest in a hotel. Siegel referred to the Director in a most degrading and insulting manner and claimed he would have Winchell bring the Director to him so that Siegel could make the Director disclose his source of information.

## Phone Call to Siegel

Special Agent in Charge Newman of the Salt Lake City Field Division at 1:00 a.m., July 21, 1946, telephonically furnished the following information which was obtained from the technical installation covering telephone Las Vegas 2460, one of the phones in the "Boiler Room" of the Las Vegas Club, Las Vegas.

At 7:15 p.m., July 20, 1946, [redacted] telephoned "Bugs" Siegel from Los Angeles advising that he had received a letter from Walter Winchell today, (July 20, 1946.) In this letter Winchell explained that the Director was his source of information concerning the item he had used on his radio broadcast last Sunday, (July 14, 1946) to the effect, "According to the FBI, a prominent West Coast racketeer is endeavoring to muscle a prominent West Coast publisher out of his interest in a West Coast hotel."

(In the course of his conversation with Siegel relative to Winchell's letter, [redacted] referred to the Director by his last name, his initials, his first name, and his initial and first name, according to Mr. Newman.)

In this letter, Winchell explained that the Director in furnishing him the item had not identified the persons (West Coast racketeer and publisher) involved. Winchell stated that he thought the Director was referring to [redacted] Winchell indicated that if the Director had even mentioned the city (Las Vegas) he (Winchell) would have had a good idea who was involved and "laid off." Winchell in this letter further stated that while he considered [redacted] a very good friend, he considered the other two even better friends. (Mr. Newman advises that apparently Winchell was referring to the Director and "Bugs" Siegel as his better friends.)

Special Agent in Charge J. E. Newman of the Salt Lake City Field Division advised that information previously reported concerning the telephone conversation between "Bugs" Siegel and [redacted] in which Winchell's letter [redacted] was discussed, was obtained from Salt Lake City [redacted] (telephone installation covering Siegel's suite at the Last Frontier Hotel) and not from Salt Lake City [redacted] (one of the phones of the "Boiler Room" of the Las Vegas Club) as was originally reported.

Winchell states he has written no letter to [redacted] Siegel. He claims he did not answer [redacted] [redacted] that Siegel has not communicated with him.

MEMORANDUM FOR THE DIRECTOR

Dear Sir:

Reference is made to my teletype dated July 13 last, in which information was set forth that [redacted] would be contacted for information concerning [redacted].

As the Bureau already knows, [redacted] and a friend of his, [redacted], intend cutting out of the Las Vegas Hotel, and in which all three of them are interested. [redacted] has told the above informant that he intends to force [redacted] out and in the process get his hands on half million dollars, taking his home, his car and everything he has. [redacted] told the informant that [redacted] couldn't personally force this act in view of its attendant publicity, but that he, [redacted], intended going ahead with it.

[redacted] has told the informant that "a lot of revenue men have been around looking to insure tax" in connection with the Flamingo Hotel in Las Vegas.

It has been pointed out that [redacted] is a henchman and general messenger boy in Los Angeles, and is well known and listed upon in the underworld as a person with no loyalty. [redacted] connection apparently makes him feared and influential. [redacted] informant stated that [redacted] instructed [redacted] to go out to dinner. [redacted] and [redacted] were working with [redacted] and [redacted] one

Informant stated that [redacted] collected some sort of a payoff from an individual named [redacted] who resides in Beverly Hills. [redacted] grew quite friendly toward [redacted] at the informant's presence on one occasion and remarked that "this isn't child's play" in connection with a payoff which [redacted] allegedly was to [redacted] later [redacted] told another person in the presence of the same informant that he had "three sizable payoff checks" and [redacted] he had to cash the checks the bank opened in the morning.

[redacted] has been friendly with

[redacted] and [redacted] W. HART. Incidentally, along these lines [redacted] horse was broken into recently and unknown individuals stole jewelry, money and binoculars. [redacted] told [redacted] that he would shoot the individuals responsible for this if he knew who they were, and [redacted] offered to attempt to find out.

On July 19, the informant stated that an individual named [redacted] teated [redacted] by telephone on a horse in the last race at Del Mar named Queen of May. This horse allegedly belonged to a party named JAY. [redacted] teated the horse to [redacted] [redacted] and [redacted] all of whom he advised to place a thousand to three thousand to win. [redacted] stated that the horse won the race.

The above information covers the period through July 22, and it is anticipated that the informant will be kept advised at least weekly concerning information these individuals can develop, and oftener in the event it is deemed important.

The memorandum of the 19th also reflects that according to information developed in a technical surveillance on his residence, has been in contact with [redacted] who is described as an influential Chicago political figure. [redacted] in turn, is said to be very close to [redacted] in Chicago. It also reports that [redacted] Illinois News Association is replacing the Midwest News Service as the principal retail distributor of racing news in the Chicago area for the Continental Press.

In an effort to establish a Federal violation within the Bureau's jurisdiction on the part of Duger Siegel, I believe it will be necessary to set up a special squad to handle this matter since otherwise we will just get involved in a rambling bifurcation of leads between Salt Lake, Los Angeles and probably Chicago, with entoreppings in Reno and Las Vegas. I think a special squad, probably out of Las Vegas, or out of Los Angeles if it appears desirable, will enable me within a period of 45 or 60 days to establish completely all possible evidence which might be used in prosecuting Siegel. With this in mind, it is recommended that Mr. James E. Ellsworth, Assistant Special Agent in Charge at Los Angeles, be designated in charge of this special assignment. Ellsworth knows the background of Siegel's connections in Los Angeles and is a good administrator and a good criminal investigator.

It is recommended that Special Agent A. E. Gethelthoff, presently Assistant Agent in Charge at Cincinnati, be designated to work on this case as part of the special squad, and that Special Agents [redacted] of the New York office be assigned to the squad. It is suggested these four men, in addition to Agent [redacted] who is presently resident agent at Las Vegas and has the contacts [redacted] will constitute sufficient personnel to carry on this investigation.

If this squad is approved, I believe it would be well to let Ellsworth take Ellsworth for a day-long conference in order that he can outline to him what the Bureau expects of him, and it would be well to let him go ahead a day or so to Chicago upon his departure from Washington to take care of the work at his office in Chicago. Yesterday I talked to Mr. Reed about the problem involved in selecting a man to supervise a special assignment to establish a base against Sugar Siegel. Mr. Reed wanted to give the matter some thought.

Mr. Reed called early this afternoon and stated that he did not have anyone in his office that was sufficiently heavy to handle this assignment which he thought was a major operation. He stated he thought the case was too big for any Agent in his office to supervise and direct particularly in view of the ramifications in a number of the field districts. He thought the work to be done on this assignment would require a minimum of 4 Agents to start in Los Angeles and several times this number in the course of a few weeks. I told Mr. Reed that the Bureau was very disappointed in this attitude since Mr. Reed had no suggestions the Bureau could turn back and decide not to investigate this case. Mr. Reed was very sorry but there was no one in whom he had sufficient confidence to place the responsibility for directing this investigation since Mr. Ellsworth would not be available. In an hour or so later Mr. Reed called back and stated he wanted to change his mind and that he believed Special Agent [redacted] of his office would be capable of setting up and directing this assignment. [redacted] file is attached.

In attempting to select a suitable agent for this assignment it appears that Assistant Special Agent in Charge Cuthbert of [redacted] would be a very good man. He could be Special Agent [redacted] assigned to the Washington Field Office.

Mr. Tolson believes that it would be better from the point of administration to put Mr. Cuthbert, who is an Assistant Special Agent in Charge, in the head of this matter rather than Agent [redacted] a Supervisory Agent. 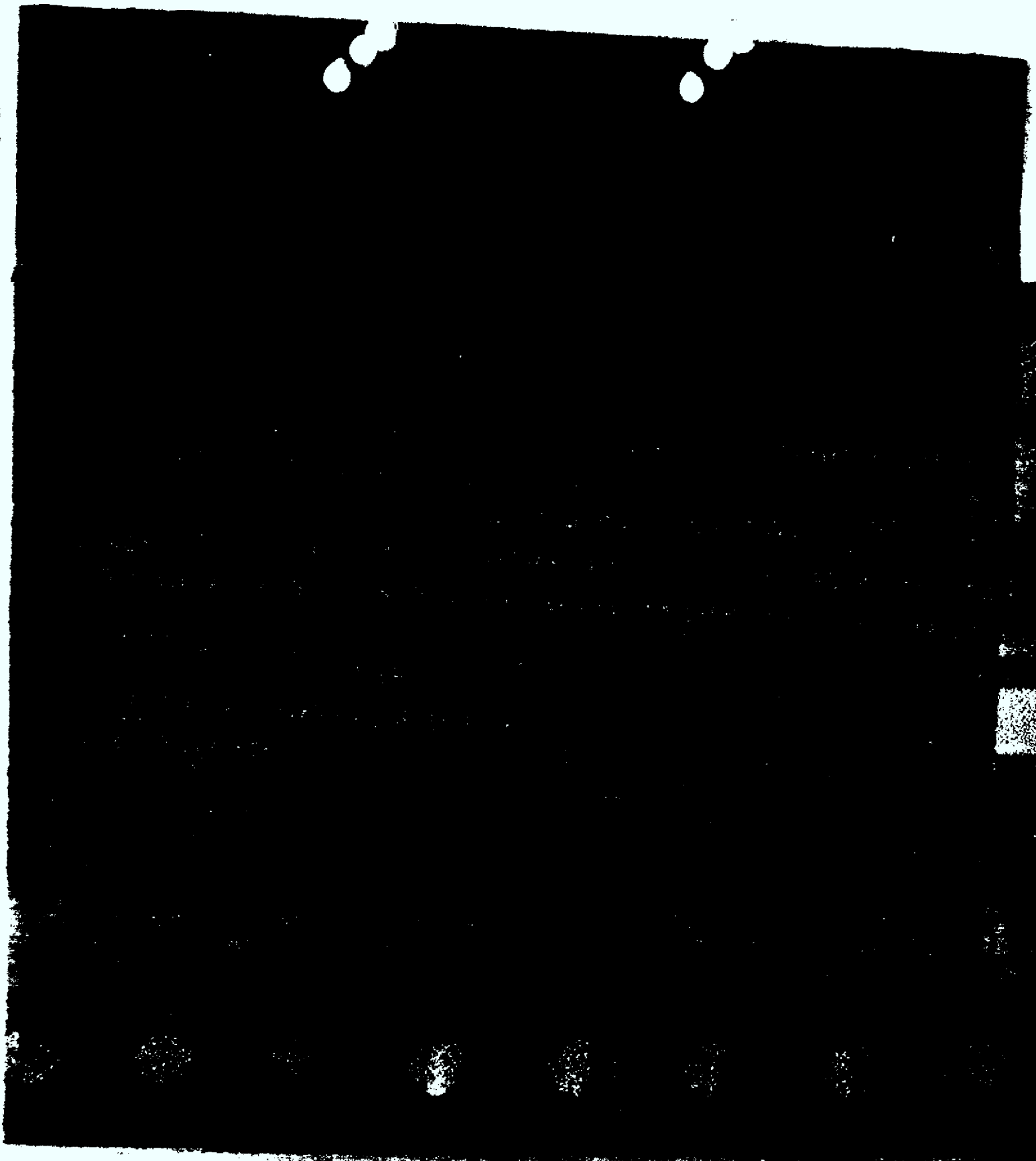

Reference is made to a teletype from the Bureau, dated July 3, 1946, addressed to the Los Angeles, Chicago and Salt Lake City offices, wherein a request was made that the Los Angeles office make certain that the Bureau and Chicago are in possession of all pertinent data not previously forwarded concerning BENJAMIN "Bugsy" SIEGEL. This resume is taken from the Crime Survey Memorandums and other files in the Los Angeles office.

BENNY SIEGEL, his wife and family have resided in the Los Angeles area at different times since 1937 when he moved here from New York City. Shortly after his arrival in Los Angeles, he was arrested and charged with the murder of AL GREENBERG, a local character, who was prominent in the motion picture labor rackets. SIEGEL, were ultimately dismissed on these charges. The allegation has been made that SIEGEL was a direct associate of LOUIS LEPKE, New York mobster, who was recently electrocuted in New York State. Through his association with LEPKE, SIEGEL was identified with the notorious Murder, Incorporated which had received considerable publicity in the press.

SIEGEL has been having marital difficulties for some time and the thought of divorce was always distasteful to him because he did not want to injure the reputation of his two children. He has received considerable publicity in the Los Angeles press, particularly in connection with his arrest for bookmaking which is a felony in the State of California when he was picked up in company with GEORGE RAFT. SIEGEL each pled guilty and were fined \$250.00 each.

While he lived in Los Angeles he maintained a palatial residence at 250 North Delfern Drive in Holmby Hills.

Persons of the hoodlum element who are known to be friendly with SIEGEL are

the Mocambo, prominent night spot, and his current mistress is IRIS L. HILL, who has been the consort mistress of several hoodlums and night club figures.

is SIEBEL's lieutenant in this area and carries out the latter's orders and this office has determined that while is SIEBEL's errand boy because of this connection he is quite powerful in underworld circles.

Information has been developed indicating that SIEBEL operates as a front for Eastern hoodlum interests and that he himself has never been worth over one-quarter of a million dollars, but that his funds and backing come entirely from Chicago and New Jersey hoodlums.

SIEBEL is supposedly operating as a front for this group which is siphoning funds into the hotel business through Kirkeby Hotels which is the subject of an investigation in the Los Angeles Office, entitled "Reported Interest of Racketeers in the Purchase of Hotels."

Allegations have come from several sources to the effect that SIEBEL had acquired the Beverly-Wilshire Hotel in Beverly Hills which is affiliated with the Kirkeby chain. SIEBEL is supposed to be very friendly with FRANK COSTELLO and JOE ADONIS, prominent mobsters in New York City, and the allegation had been made that SIEBEL recently negotiated for the purchase of a large ranch in Mexico, acting in behalf of CHARLES "Lucky" LUCIANO. The exact location of this ranch is not known although informants state that it is near the California border, but not located in Tijuana. SIEBEL is supposed to have purchased this residence in January or February of this year while LUCIANO was still in Italy. It will be recalled that LUCKY had been deported; allegedly, LUCIANO has been seen in Los Angeles within the past ninety days, and the opinion has been expressed that LUCIANO would have little difficulty in running his former syndicate from Mexico using SIEBEL as his main connection.

SIEBEL currently spends a considerable portion of his time in Las Vegas where he has gambling interests and where he is currently building a large hotel in partnership with

SIEGEL is referred to by underworld informants of this office as the man in control of the Western States and he is referred to as a person who can put his friends in touch with the underworld boss of any city in the United States. He acquired his title of BUGSY because many of the associates in the old days considered him as "going bugs" when he got excited in that he acted in an irrational manner. There seems to be no doubt in the fact that he seems to be generally respected and feared by underworld characters because he is supposed to personally have killed at least thirty different individuals. Allegedly, SIEGEL is a pleasure smoker of opium, but he does not have the habit.

In connection with the case entitled "Reactivation of the Capone Gang" the reference has been made by informant that SIEGEL is instrumental in the attempt of the Chicago mob to take over the wire service currently operated by JAMES RAGEN. Approximately one and one-half years ago SIEGEL attempted to move in on the wire service in Los Angeles and at that time SIEGEL made the statement to several people that he would soon be operating the service.

Along these lines it follows that the MAFFIA, operating through its New York headquarters, where FRANK COSTELLO and JOE ADONIS, using SIEGEL as a front, have put themselves into the hotel business through SIEGEL and others under the trade name of the Kirkeby Hotels. Also, this same mob is attempting to take over the wire service and if they are successful in so doing will extort tribute from every bookmaker in the United States. It has been pointed out that the MAFFIA operates through "fronts" who are usually of Jewish or Irish extraction.

SIEGEL according to local informants was a power in New York gangland and considerable information concerning SIEGEL's past activities can undoubtedly be obtained by the New York office. He allegedly likes California and considers it his home and for that reason confines his activities to other parts of the country simply coming here to visit.

SIEGEL is registered at Local Draft Board #215 in Westwood Village, California. He originally registered for Selective Service while in the custody of law enforcement officers at the Los Angeles County Jail on a murder charge. His Order Number is 2427-A and at that time he resided at 250 North Delfern Drive, West Los Angeles. He was born February 28, 1906 at New York and married his wife, ESTHER, at 332 Rogers Avenue, Brooklyn, New York, on January 28, 1929.

In addition he supports his father, MAX, age 66, and his mother, JEANNIE, age 65. He set out \$12,000 as the amount necessary to support his family with an income of \$50,000 a year from his occupation as betting commissioner and investment broker. He claims eight years grade school education and he gives the following relatives. Parents reside at 1719 - 67th St., Brooklyn, New York:

The Local Draft Board by letter, dated March 10, 1944, asked the State Director of Selective Service for the waiver of an age limit in order to request SIEGEL to report for induction, but by letter, dated March 15, 1944, State Director refused the waiver. There was a communication in the file from the legal firm of Pacht-Pelton-Warne & Black, signed by N. JOSEPH ROSS, dated September 8, 1941. Judge ISAAC PACT has been SIEGEL's attorney for some time and it is known that this firm has represented him as early as 1941.

The Del Mar Race Track near San Diego, California, has recently been acquired by interests allegedly representing SIEGEL.

has been in company with various hoodlums and gamblers in Los Angeles and does not bear a good reputation because of his association with certain underworld characters.

If as has been pointed out SIEGEL actually represents the mob attempting to take over the wire service, conclusion follows that the RAGEN interests will not be successful in obtaining racing information from the Del Mar track because SIEGEL will control this information for the benefit of the new service which has already rented its quarters in the Ferguson Building in Los Angeles.

Following are additional excerpts from subject's record which are being set forth as being of possible interest in connection with any current investigation of him.

"On November 9, 1932, SIEGEL while attending a meeting of the organization in the Hard Tack Social Club at 547 Grand Avenue, New York City, suffered rather severe head injuries as the result of a bomb explosion. He and some other members of the mob were taken to a hospital for treatment. An Italian named FABRIZZO had lowered a bomb down the chimney, but failed to take into consideration that the chimney had a right-angle offset which caused the bomb to become stuck before reaching the proper elevation. FABRIZZO was shot and killed on 11/20/32 for this attempt on the lives of the mob. SIEGEL still has the scars on his head caused by the flying bricks. One of these scars, about 1½ inches long on the upper side (left) of his head, is visible through his thinning hair.

"In 1933, SIEGEL was arrested when the New York Police conducted a raid on a suite of rooms in the Hotel Franconia. In this raid, he and eight other men were surprised during a 'conference' of the mob attended by 'LEPKE' BUCHALTER and his partner 'GARRAH' JAMES GILBERTO. This raid occurred two months before 'LEPKE' and 'GARRAH' formed their syndicate known as MURDER, INC.

"In 1939, while LEPKE BUCHALTER, was hiding to avoid arrest on a Federal indictment, SIEGEL met him and was informed by LEPKE that he, LEPKE, was being subjected to blackmail by 'BIG SAMUEL' GILBERTO, a former henchman. GILBERTO was threatening to go to District Attorney Dewey's office. SIEGEL agreed that GILBERTO must be killed. SIEGEL then returned to Los Angeles and made plans for the killing of GILBERTO. Thereafter two guns were flown to Los Angeles by \_\_\_\_\_ and given to \_\_\_\_\_ was brought to Los Angeles by SIEGEL to do the actual killing. This murder was committed by SIEGEL, \_\_\_\_\_ and \_\_\_\_\_ in Hollywood on the night of Nov. 22, 1939.

"In 1941, SIEGEL was arrested by the FBI on a charge of harboring LEPKE BUCHALTER, and after a hearing before the U. S. Commissioner, was released on bail of \$25,000. ABE RILAS, admitted killer of fourteen men, and member of MURDER, INC. testified against SIEGEL before the U. S.

"Commissioner in Los Angeles on the harboring charge. RELES testified that some of the fourteen men he had killed had been killed upon orders of SIEGEL. In 1941, while the GREENBERG murder charge, as well as the Federal harboring charge, was pending against SIEGEL, ABE RELES fell from the fifth floor window of the Half Moon Hotel in Coney Island, New York, and was instantly killed. RELES' death ruined the murder case as well as the harboring charge against SIEGEL.

"GEORGE RAFT, the motion picture actor, and are close friends of SIEGEL. SIEGEL and were arrested in May, 1941, for bookmaking, and paid fines of \$250 each. RAFT was present at the time of the raid, but was not arrested.

"In December, 1945, the informant interviewed

He stated that SIEGEL, along with MOE SEDWAY and GUS GREENBAUM had bought out a large gambling hall about a year ago.

"Concerning SIEGEL, confided that his reputation of having unlimited funds is entirely false, and claimed that he is 'nearly on the rocks' and was forced to sell a large mansion in Holmby Hills. Litigation concerning this residence and its sale to LORETTA YOUNG has received publicity during the past year. This 35-room mansion is located at 250 Del Fern Avenue in Holmby Hills.

"Information was obtained by informant during contacts with various sources of information in Las Vegas. It is understood from proprietors of gambling establishments that the wire service used by bookmakers in Las Vegas is supplied through the organization controlled by SIEGEL. The price charged for this service is said to be so high that most of the proprietors of the gambling casinos in Las Vegas have found it unprofitable to operate,

"and a large number of them have leased their bookmaking concession to the operators of the wire service, with the effect that SIEGEL's wire service controls all bookmaking in Las Vegas. It was also learned that the same situation prevails in Reno to a large extent.

"It was observed by investigators in the Palace Casino in Reno that the wire service from Bay Meadows which was operating at that time, March, 1946, was very prompt and accurate inasmuch as official notices were posted in the Palace five to six minutes after post time. Several sources of information in Reno stated that their service was good from Bay Meadows, but that they were not getting run-downs and descriptions. It was also noted by investigators that the Palace was getting instantaneous wire service from Oaklawn Park in Hot Springs, Arkansas, and from Tropical Park in Florida. Informants stated that the gambling houses had direct lines to these tracks and a running description of the races was given, together with results and prices. They also received service from the New York tracks, including Belmont. It was not known whether the eastern service is connected with SIEGEL.

"SIEGEL's description is as follows: 42 years, 5' 9", 157 pounds; dark brown hair; grey-green eyes; medium complexion; medium build; Jewish,

I have designated Mr. A. E. Gorthelthoff to supervise the special squad handling this matter. Mr. Gorthelthoff will make his headquarters in the Los Angeles Field Division.

The field divisions receiving copies of this letter are instructed immediately to make available to Mr. Gorthelthoff any clerical or Agent personnel required.

While this investigation is being handled separate and apart from the Capone investigation, it appears it will overlap with the Capone case. However, the new syndicate which as has been pointed out has already rented office space in the Ferguson Building in Los Angeles intends putting out a scratch sheet of its own and has been looking around town for an individual to edit this.

[REDACTED] pointed out that if this is true the [REDACTED] interests are not necessarily tied in with the new syndicate, but as has been pointed out previously the new syndicate is attempting to get a direct wire from Chicago through Kansas City into Los Angeles. [REDACTED]

On August 8, 1946, Supervisor A. E. Ostholthoff of the Los Angeles Division advised that the Los Angeles Office has just received information to the effect that a "stop order" has been issued against Siegel and his associates in connection with the construction of the Flamingo Hotel at Las Vegas, Nevada by the Civilian Production Administration, dated August 7, 1946.

Mr. Ostholthoff stated that he wished to advise the Bureau of the issuance of this order if it were not already known and also wished to be informed whether it would have any effect upon the instructions which he received from the Bureau yesterday, August 7, 1946, which authorized the initiation of immediate and appropriate investigation into all aspects of reported irregularities dealing with the construction of the Flamingo Hotel at Las Vegas, Nevada. *b7c*

Mr. Ostholthoff further advised that the original information received by the Los Angeles Division concerning bribery allegations involving [REDACTED] and Senator McCarran were furnished by [REDACTED] of Los Angeles, California. He said [REDACTED] apparently received his information from an individual by the name [REDACTED] who was described as the head of the Investigative Division of the Civilian Production Administration in Los Angeles. *b7c*

It is also of interest to note that on August 5, 1946, the Clark County Commissioners at Las Vegas, Nevada temporarily denied the application of Siegel and his associates for a gambling and liquor license at the Flamingo Hotel. As a result of this denial, it was determined that Siegel, accompanied by [REDACTED] one of the principal investors in the Flamingo Hotel, had decided to appear personally before the County Commissioners at Las Vegas with regard to the denial of the same. Informants in Los Angeles and Las Vegas have advised, however, that this is only a temporary denial and that these licenses will be granted to Siegel and his associates at a later date. *b7c*

ACTION TAKEN

Mr. Ostholthoff was requested to proceed with the investigation authorized by the Bureau on August 7, 1946, and in full compliance with existing instructions and was also informed that in the event any pertinent information concerning the issuance of the "stop order" by the Civilian Production Administration in Washington was developed that the same would be furnished to him. It was again suggested that the inquiry concerning Senator McCarran be handled in a most discreet manner.

Siegal inquired if "that friend" was still in Los Angeles, later referring to this individual as [redacted]. It is believed he might possibly have been referring to [redacted] of the Capone Syndicate. The latter may have been in Los Angeles in conjunction with the new Trans-American wire service which will compete with the Regen Continental Press organization. Los Angeles is being requested to probe this possibility.

Reference is made to my letter of July 30, 1946 which sets out certain confidential information received from [redacted] at Los Angeles concerning rumors to the effect that "BUGS" SIEGEL and his associates in the construction of the Flamingo Hotel paid a bribe in order to secure Civilian Production Administration authority to proceed with the construction of the Flamingo Hotel in Las Vegas.

Along the same line, I am transmitting herewith the front page of the LAS VEGAS TRIBUNE, dated August 1, 1946, which contains a front-page editorial criticizing the construction of this gambling casino at a time when materials are badly needed by veterans for the construction of homes. It would appear that at this point we have jurisdiction to investigate the construction of the Flamingo Hotel in connection with the bribery investigation concerning the C.P.A. Official at Reno, Nevada. It would also appear that we would have jurisdiction on the theory of Fraud Against the Government since it was probably necessary to furnish false information to the Civilian Production Administration in order to obtain the permit to proceed with construction of the Flamingo Hotel. While I do not have available here the legislation creating the Civilian Production Administration and the rules and regulations promulgated by that organization, generally, from information carried in the press the C.P.A. was organized in order to channel building construction into homes rather than commercial enterprises. Also, I am not aware whether the C.P.A. has an investigative staff or whether violations of the rules are within the Bureau's jurisdiction. Certainly, it would appear that furnishing false information to this agency would be our jurisdiction under the Fraud Against the Government Statutes. It is requested that the Bureau ascertain through the Department what jurisdiction we might have in connection with a violation of the C.P.A. regulations.

An open and thorough investigation into the construction of the Flamingo Hotel would have distinct advantages at this time. First of all,

Such an investigation might develop a bribery and fraud against the government violation which could be attributed to SIEGEL, if not directly then perhaps under the conspiracy statute. Secondly, such an investigation might have the effect of stopping construction of the Flamingo Hotel which could conceivably be about the bankruptcy of SIEGEL and his associates. In this connection

stated that SIEGEL and his associates are bending every effort toward the completion of the gambling casinos in the Flamingo Hotel in order that they might be in operation this fall. The informant has stated that once this casino is completed "there will be no stopping SIEGEL" because the casinos will be good for a \$2,000,000 a year income.

In substantiation of the theory that stopping the construction of the Flamingo Hotel would bankrupt SIEGEL and his associates, on July 30, 1946 SIEGEL had a conversation in which he stated that as of today they have \$1,162,500 in the Flamingo Hotel. SIEGEL is making arrangements through GUS GREENBAUM to obtain a \$500,000 loan

SIEGEL also stated that the Utah Corporation had made him a \$350,000 loan and the Cortez Hotel is also going to make them a \$600,000 loan on the Flamingo Hotel. This would indicate that SIEGEL and his associates have already put up all of their available cash. An investigation of this matter under the Fraud Against the Government Statute would permit us to examine witnesses under oath. It would also give us an opportunity, through detailed examination of books and records, to trace back all of the money invested in the Flamingo Hotel, which should, in turn, show exactly how much SIEGEL has invested in this and it could possibly reveal a violation of the Income Tax Laws. Independently of our special investigation of SIEGEL's activities in general, it would appear that the article in the LAS VEGAS TRIBUNE is of such a nature that it might bring about a public demand for an investigation either by the F.B.I. or some other Government agency. No open investigation will be undertaken concerning the Flamingo Hotel until advice is received from the Bureau. We will make a preliminary check into public records at Las Vegas to ascertain the date that construction was started on the Flamingo Hotel and such other information as can be discreetly ascertained in an effort to substantiate the information that the construction of the Flamingo Hotel had gotten no further than "a few stakes being driven in the ground" when the freeze order regulating all commercial building under Civilian Production Administration came into effect.

Mr. Ostholtzoff, Los Angeles Division, advised that [REDACTED] at Los Angeles is very friendly towards the Bureau and on occasion furnishes confidential information. On July 30, 1946, [REDACTED] advised the Agents that he had obtained information from a highly confidential source, whose identity he did not reveal, that the construction of the Flamingo Hotel had not progressed much further than having the stakes driven in when the Civilian Production Administration issued the "freeze order" on the construction of buildings of this type. b7c

[REDACTED] stated that construction on the Flamingo Hotel was temporarily stopped on the basis of this "freeze order" but that [REDACTED] arranged to have funds made available to Senator Pat McCarran the construction of the Flamingo Hotel was permitted to continue. Mr. Ostholtzoff stated that [REDACTED] indicated funds made available to Senator McCarran were in the nature of a bribe probably originating from Siegel. [REDACTED] has indicated that the official in charge of the construction division of the Civilian Production Administration at Reno, Nevada, was involved in the deal and that the construction records of the Flamingo Hotel were falsified to show that the construction was farther along than it actually was. Thus enabling the CPA to authorize the completion of the construction. b7c

NEWSPAPER PUBLICITY: An editorial in the Las Vegas Tribune, a weekly newspaper, prominently placed on the first page of the issue dated August 1, 1946, complains of the fact that the Federal authorities are permitting the construction of the Flamingo Hotel while the veterans are homeless due to a shortage of building materials. The editorial comments on the fact that it is difficult to prevent men of great financial means, such as Benjamin Siegel and Harry Rothburg, from engaging in such building activity. INDEXED

FINANCIAL DIFFICULTIES OF SIEGEL AND ASSOCIATES: Information obtained from the technical surveillances was to the effect that Benjamin Siegel claims he and his associates have spent \$1,162,500.00 to date on the Flamingo Hotel and that Siegel is at the present time in rather straitened financial circumstances. Siegel at the present time is endeavoring to make arrangements through Gus Greenbaum to obtain a \$500,000 loan [REDACTED] He is also endeavoring to obtain a \$600,000 loan from a Utah corporation, the identity of which is being determined as it is known that Siegel previously borrowed \$350,000 from the same corporation on a similar loan in connection with the construction of another hotel. b7c

**ACTION TO BE TAKEN:** Mr. Ostholtz points out that the Bureau now has allegations of both a Bribery and a Fraud Against the Government and if considered advisable would be in a position to make open inquiries in connection with the construction of the Flamingo Hotel. A discreet preliminary check is presently being made to determine the date the CPA "freeze order" was issued and the extent to which the construction of the Flamingo Hotel had progressed on that date.

**OBSERVATION:** The Fraud Against the Government violation could be investigated on the basis of the editorial in the Las Vegas Tribune and statements under oath could be obtained from all persons interviewed. The initiation of the investigation might result in stoppage of construction on the Flamingo Hotel and the resultant financial embarrassment to Siegel and associates might bring their activities out into the open. The allegation of a bribe payment to Senator Pat McCarran is rather nebulous. Information concerning same could be developed incidental to the Fraud Against the Government investigation. In connection with this investigation many of the individuals who would be interviewed under oath unquestionably are not involved with the racketeers and there is a possibility some information of value concerning the operations of Siegel and his associates might be obtained. If such investigation is authorized the desirability of suggesting to the Department the assignment of a Special Assistant should be given consideration it being anticipated that it will be necessary to issue subpoenas for the examination of books and records in some instances and the potential witnesses may have local political connections and affiliations.

**RECOMMENDATION:** It is recommended that the initiation of Fraud Against the Government investigation in connection with the construction of the Flamingo Hotel be given favorable consideration.
