BENJAMIN "BUGS" SIEGEL, MISC INFO CONCERNING, 'CRIME SURVEY. LAST NIGHT SIEGEL SPENT CONSIDERABLE TIME AT THE COPACABANA NIGHT CLUB WHERE HE TALKED FOR A SHORT TIME WITH FRANK COSTELLO AND SUBSEQUENTLY HAD A PRIVATE CONVERSATION WITH AN UNKNOWN INDIVIDUAL, UNIDENTIFIED AS YET.

AT CHICAGO AND KANSAS CITY. A [REDACTED] WHO IS UNKNOWN TO THIS OFFICE ALSO COMMUNICTED WITH SIEGEL AND THE SUBJECT OF "LEAVING AT FIVE PM TOMORROW" WAS DISCUSSED. IN VIEW OF THE LATTER TWO PHONE CALLS A CHECK OF THE RESERVATION LISTS OF THE TRANSPORTATION FACILITIES OUT OF NY WERE CHECKED WITH NEGATIVE RESULTS INSO FAR AS DETERMINING WHETHER SIEGEL HAD ANY RESERVATIONS. IT DOES NOT APPEAR THAT THESE CONVERSATIONS CONCERN SIEGELS LEAVING NYC TODAY IN VIEW OF THE FACT THAT [REDACTED] HE HAS AN APPOINTMENT TO HAVE DINNER THIS EVENING WITH HIS TWO DAUGHTERS.

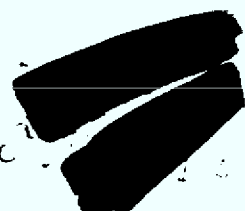
Reference is made to the report of Special Agent [redacted] dated August 20, 1946 at Los Angeles, in the above-captioned case, wherein on page 7 information is set forth concerning BEN SIEGEL contacting MEYER LANSKY at New York City on August 14, 1945. [redacted] reported SIEGEL inquired of LANSKY as whether he could get "that guy" to send a carload of beer.

[redacted] This source stated LANSKY was interested in knowing what the beer was for and BEN stated he wanted to send it to [redacted] and for [redacted] to send it to "them." This reference to "them" was indicated to be "fellows on the Commission" and probably referred to the City Commissioners in Las Vegas. SIEGEL instructed LANSKY to send the carload of beer direct to [redacted] at the Nevada Beverage (Las Vegas, Nevada Beverage Company). This information was developed shortly after SIEGEL had difficulties in obtaining liquor and gambling licenses for the Flamingo Project and it was indicated that there was a pay-off in connection with the issuance of the licenses.

For your further information in this regard, there are attached copies of a transcript of the conversation reported by [redacted] on September 30, 1946 between [redacted] and BEN SIEGEL at Beverly Hills. Two copies are being designated for the Bureau and one copy each for the New York and Newark Field Divisions.

It will be noted during the conversation that [redacted] inquired as to whether BEN had spoken to MEYER who is thought to be MEYER LANSKY and that she had a message for BEN. The message which was given to BEN [redacted] was very confusing, but it is noted that BEN was furnished the names of [redacted]

It appeared that BEN was to advise as to what size beer bottle was desired. BEN appeared to understand what the particular incident was about; however, he was unable to determine from [redacted] as to whom he should advise as to the desired size beer bottle. This particular conversation is believed to refer to the previous conversation had between SIEGEL and LANSKY regarding the sending of a car of beer [redacted] as mentioned previously herein.

For the assistance of the Newark Field Office, the Los Angeles Field Office is office of origin in the instant case concerning Subject SIEGEL and a portion of the investigation has been conducted in reference to the building of the Flamingo Hotel at Las Vegas, California, in which SIEGEL has a considerable interest. There has been evidence of possible Fraud Against the Government in connection with the building of this hotel as well as other information indicating the use of bribes to local and state officials in connection with the securing of favors in order to build the hotel.

BENJAMIN SIEGEL, WAS, MISC., INFO CONCERNING, CRIME SURVEY. LAST NIGHT SIEGEL VISITED HIS WIFE'S RESIDENCE AT EIGHT EIGHT CENTRAL PARK WEST FOR SEVERAL HOURS, RETURNED TO HOTEL ROOSEVELT AT NINE PM., AND RETIRED. HOWEVER, AT APPROXIMATELY TWO THIRTY THIS MORNING HE RECD A PHONE CALL FROM VIRGINIA HILL IN CHICAGO WHO INDICATED THAT SHE WAS RESIDING IN ROOM EIGHT ONE FOUR AT THE EDGEWATER HOTEL IN CGO UNDER THE NAME OF VERA HARDING. THIS ORIGINAL CONVERSATION LASTED APPROXIMATELY FORTY FIVE MINUTES AND SHE INDICATED THAT SHE WAS AT A PARTY AND HE REQUESTED HER TO CALL HIM BACK WHEN SHE ARRIVED AT HER RESIDENCE. SHE SUBSEQUENTLY CALLED HIM ABOUT FOUR AM THIS MORNING AND TALKED FOR ALMOST AN HOUR. A GREAT DEAL OF THE CONVERSATION WAS OF A PERSONAL NATURE. HOWEVER, IT WAS DETERMINED FROM BOTH OF THESE CONVERSATIONS THAT ~~REX~~ WEBB WAS FLYING TO NYC FROM CGO IN HIS OWN PLANE AND WOULD VISIT SIEGEL UPON HIS ARRIVAL HERE. SIEGEL INFORMED VIRGINIA THAT HE HAD LUNCH THAT DAY WITH [REDACTED] IT IS TO BE NOTED THAT [REDACTED] WAS OBSERVED HAVING LUNCH WITH TWO UNKNOWN INDIVIDUALS AT DINTY MOORES RESTAURANT YESTERDAY. HE ALSO TOLD VIRGINIA THAT HE HAD A LONG TALK WITH [REDACTED] AT THE PARK LANE HOTEL AND THAT [REDACTED] ALSO SAW [REDACTED] OTHER REFERENCE IS MADE TO NY TEL DATED OCT NINE, FOR INFO INDICATING [REDACTED] SIEGEL WAS TO MEET [REDACTED] AT THE PARK LANE HOTEL.

AM THIS DATE. IT WOULD APPEAR THAT THIS IS AN ERROR AND THAT IT SHOULD HAVE BEEN [REDACTED] INSTEAD OF [REDACTED] IS UNKNOWN TO THIS OFFICE AND IN VIEW OF THE FACT THAT SIEGEL WAS OBSERVED TODAY IN THE VICINITY OF THE PARK LANE HOTEL IT IS NOT DEEMED ADVISABLE TO CONDUCT ANY INVESTIGATION AT THE PARK LANE UNTIL SIEGEL'S DEPARTURE FROM NYC. IN THIS REGARD HE INFORMED VIRGINIA THAT HE STILL HAD QUITE A BIT OF WORK TO DO BUT REQUESTED HER TO PACK HER BAGS AS HE WOULD LEAVE NY TUESDAY OR WEDNESDAY OF NEXT WEEK AT THE LATEST AND WOULD PICK HER UP IN CHICAGO AND THEN BOTH WOULD RETURN TO THE WEST COAST. 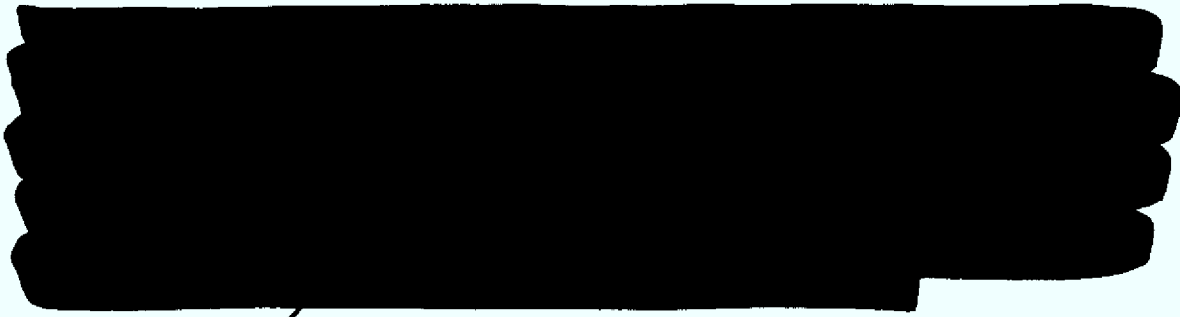



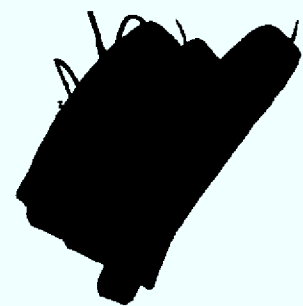

The following is a brief summary of pertinent developments which occurred in the New York Field Division in the above entitled matter since the submission of the last weekly letter on October 4, 1946:

BENJAMIN "BUGS" SIEGEL

SIEGEL arrived in New York City on October 5, 1946 and registered in the early morning of October 6, 1946 at the Roosevelt Hotel.

During the period from October 5 to October 10, 1946 it was determined from confidential sources that he had been in telephonic communication with FRANK COSTELLO and [redacted] who is unknown to the New York office. He also communicated with numerous other individuals who used only their first names and whose identities have not been determined as yet.

[redacted] morning of October 10, 1946 he received two calls from VIRGINIA HILL in Chicago. At the time these conversations took place VIRGINIA HILL advised that she was residing at the Edgewater Hotel under the name of VERA HARDING.

During the time that SIEGEL was under physical surveillance, he was observed meeting FRANK COSTELLO at the Copacabana Night Club where he also talked to several unknown individuals who, from their appearance, were undoubtedly racketeers of some sort. He spent one entire morning at the Park Lane Hotel and it was subsequently determined that he had been in conversation with [redacted] it is believed that [redacted] is a resident of the Park Lane Hotel.

He was also observed entering the offices of the Mastan Company, Inc., 350 Fifth Avenue, New York City, at which time he was carrying what appeared to be a bundle of floor or building plans. He was

observed to enter the office of this company and remained there for a considerable period of time. [REDACTED]

In view of the nature of this company's business and the fact that SIEGEL was observed entering this establishment with what was probably the plans of the Flamingo Hotel, it is believed he approached this company for the purpose of obtaining a loan to carry on the completion of his Flamingo Hotel in Las Vegas, Nevada.

From information previously submitted from the Los Angeles office, the principal reason for SIEGEL's visit to New York was to obtain a loan of a million and a half dollars. It was also ascertained from a confidential source that SIEGEL anticipated leaving New York City on October 15, or 16, 1946, after which he would travel to Chicago and pick up VIRGINIA HILL and then proceed to the west coast. However, in view of the Bureau's telephonic instructions of October 10, 1946, the physical and technical coverage of SIEGEL was discontinued on the afternoon of this date.

MEYER LANSKY
211 Central Park West, New York City

As previously set forth, close association was reported to exist between MEYER LANSKY and BENJAMIN "Bugs" SIEGEL. It was believed that possibly some of SIEGEL's funds in the erection of the Flamingo Hotel at Las Vegas, Nevada might have had their source in LANSKY. In view of SIEGEL's arrival in New York City on October 5, 1946, spot surveillances were maintained at the residence of MEYER LANSKY, 211 Central Park West, and at his business enterprise, the Emby Distributing Company, 525 W. 43rd Street. However, LANSKY was not observed during the time of these surveillances nor was it ascertained that SIEGEL contacted or attempted to contact LANSKY in New York.

Investigation has been continuing concerning the activities of the Emby Distributing Company and their activities in the distribution of juke boxes under a franchise from the Rudolph Wurlitzer Company, Tonawanda, New York. Full details concerning the corporate set-up of the Emby Distributing Company will be set forth in report form.

Spot surveillances had been maintained on COSTELLO up to October 10, 1946, at which time instructions from the Bureau were received to discontinue all physical surveillances in connection with the Capga case. It has been ascertained that COSTELLO visits the lobby of the Hotel Waldorf Astoria practically every day. At that point it is noted he makes frequent personal contacts and conducts his business. It is also known that in the evenings at about 6 p.m. he visits the Copacabana Night Club where he also conducts his business and in which he is reputed to have a financial interest.

During the period COSTELLO has been observed in the company of BENJAMIN "BUGS" SIEGEL at the Copacabana Night Club. It is also known that SIEGEL on several occasions attempted to contact COSTELLO but the nature of their business dealings is not at present known.

COSTELLO has been observed in the company of [REDACTED] concerning whom information has previously been reported. He was also chauffeured by [REDACTED]

Information was received that FRANK COSTELLO intended to go to Hot Springs, Arkansas on October 10, 1946. It is known that in the past he has made yearly visits to Hot Springs and has been in contact with [REDACTED]

On the morning of October 10, 1946 COSTELLO left his residence at 5:30 a.m. in the company of [REDACTED] and two other individuals. Reservations were held in the name of [REDACTED] on Flight 207 of American Airlines for Little Rock, Arkansas. This flight was scheduled to Newark Airport at 7:00 a.m. and it is believed that COSTELLO was one of the [REDACTED] party which boarded the aforesaid flight.

In view of Bureau letter dated October 9, 1946 to New York, all physical surveillances and technical surveillances in the Capga case have been discontinued. In the event the same are desired in connection with the general crime survey program conducted in the New York area, separate communications will be addressed to the Bureau. Future investi-

1. Clipping from the issue of September 22, 1946, headed "Flamingo Project Still Going Despite Fearson", which refers to JOHN PEARSON'S radio broadcast stating that JOHN D. SMALL, U.P.A. official had assured PEARSON that work on the Flamingo Club would be halted.

2. Clipping dated October 2, 1946 under the heading "Killing the Hounds with Brigham Townsend". This is apparently a planted article in an effort to develop public opinion in favor of the construction of the Flamingo Hotel.

3. Two clippings dated October 2nd concerning resolutions by building trade unions and veterans in Las Vegas protesting the curtailment of commercial building in Las Vegas. It is noted that according to these clippings FRANK HARRIS, Secretary of the Building Trades Council in Las Vegas, sent a wire to JOHN D. SMALL, Civilian Production Director, in which he stated that 1200 veterans are employed on the Flamingo Hotel project. This is a misstatement and it is noted that the LAS VEGAS EVENING REVIEW JOURNAL ran a correction on October 3, 1946 stating that 800 men are employed on the Flamingo Hotel project, of which 50% are veterans.

Las Vegas Building Unions, Veterans Protest Curtailment of Commercial Construction

By A. Forgeron, business representative of the Las Vegas local of the plumbers union, was back in town today after a month in the east on business, and was outspoken in his lack of practical veteran housing here, as compared with communities elsewhere.

"There's nothing being done in Las Vegas to provide homes for veterans with modest means," he said. "The only way a vet can get a home is to be wealthy enough to buy or build. Prices are out of sight for working men."

He told observations in the east, where many communities have realized the great majority of veterans are unable to buy and have met the situation by construction of veteran apartment projects, to provide these rental for ex-GIs until they can afford to build their own homes.

"If such an apartment project were started in Las Vegas," Forgeron stated, "the townfolk would be glad to invest, were they assured that material priorities would be granted for completion of the project."

He recognized that there have been instances when contractors have used veterans' priority material on non-essential, but (Continued on Page Two)

"In other places, can solve their veteran housing problems," Forgeron said, "there is no reason why Las Vegas can't do likewise. When the hue and cry becomes great enough, the situation can be solved by action in Washington and at home."

300, Not 1200, Employed on Flamingo Job

Through a typographical error, yesterday's Review-Journal story regarding the Flamingo hotel construction contained the statement that 1,200 veterans were employed there.

Actually, the story should have said 1,200 veterans are employed on all construction jobs in Las Vegas. At the Flamingo hotel, 300 men are employed, of which 30 per cent are veterans.

The story had to do with the fight being waged by Las Vegas construction unions for elimination of building restrictions by the Civilian Production Administration.

Las Vegas building trades unions and veterans, in a threat that the Flamingo hotel project may be curtailed today disclosed they have protested to Civilian Production Director John D. Small and to Columnist Drew Pearson regarding the latter's radio report Sunday that work on the swank resort will be halted.

(Continued from Page One) men will be out of work, half of them veterans of World War I. . . . Veteran housing in area under construction now equal to or exceeds demand. Immediate action to prevent wholesale unemployment."

West disclosed he had sent a 400-word telegram to Pearson, pointing out the condition in Las Vegas, and calling for the columnist to publish "the true state of affairs."

He told Pearson that, while veteran housing is badly needed, the Las Vegas veterans are able to buy homes under present inflated prices.

He said over 1200 vets are employed on the Flamingo project. Curtailment of the job, he pointed out, would throw them, and 200 others, out of work.

In warning of the economic disaster to Las Vegas should 1,200 men suddenly become unemployed, West said no other work is available for a large majority of them.

The telegram stated that veterans' houses are receiving first consideration by the Las Vegas building trades unions, but that little activity is possible in this field until prices are adjusted.

West further claimed that very little critical material is being used on the hotel project which could be used in housing construction.

The local secretary also was Harry C. Bates, president of the International union, requested the latter's support in the situation by the Las Vegas unit.

Pearson stated that he will stop construction of the luxurious project, which overrules two decisions of approval granted by the same CPA office in San Francisco and one in Rome.

Work was still under way on the Los Angeles strip hotel morning. Officials of the Webb Construction company claimed knowledge of any to halt their operation.

The wire to Small was sent by Frank Harris, secretary of Building Trades council; deVilliers, secretary of the Gran Services Coordinating committee; Carl M. Hayes, second treasurer of Las Teamsters union, and Will West, secretary of the Brickmasons and Plasterers.

"Stopping of commercial building (in Las Vegas) already causing much unemployment," the telegram said "Within . . . 60 days approximately 2,000 building trades (Continued on Page Two)

regarding veteran housing West called attention to a number of vacant buildings, the de-activated army air field which, he said, could be decided surplus and remodeled into apartments.

"This is the only practical source of housing in the Las Vegas area," West said. "The air field will not be fully utilized again for several years and by that time, the shortage of building materials will have eased. This can be done easily and quickly if the veterans will demand it of their representatives in Washington."

Legionnaires of Las Vegas voted overwhelmingly last night in favor of a resolution which in effect aims at raising the Wyatt freeze on commercial building in the Las Vegas area.

The resolution, offered by H. E. De Villiers, demands that "restrictions on commercial type building be resolved by the Civilian Production Administration in line with the need of veterans in the various communities, both with respect to need for housing and for employment of said veterans."

Commander Madison B. Graves and members of the post heard a lengthy discussion on the resolution, and also a second resolution, which proposed investigation of commercial building operations on East Fremont street.

Several speakers asserted that the current freeze of the Wyatt program jeopardized employment of 4,000 men in this community, of whom half are veterans.

On the second resolution, however, speakers warned against the Legion taking a stand of "policing" the building operation referred to and succeeded in having the resolution defeated.

Francisco convention proved a "huge success."

Jack Egan offered his services for procuring assistance of the Las Vegas Army Air Field authorities in the Armistice Day parade.

I called [redacted] with reference to the attached memorandum. He stated that last Friday, [redacted] general counsel of the CPA, had called at his office with some representatives of the CPA and they were perturbed over Drew Pearson's broadcast concerning the Flamingo Hotel. Their representatives had furnished him with information concerning the hearings and furnished him with a transcript of the hearings and had given background information to him. The rumor was that the FBI was also investigating a certain phase of the case and [redacted] called merely to find out whether he could pick up some "loose straws" to find out what this thing was about. He said that Jack Small, the Administrator, had apparently been upset by some release which was made by his public relations man and thereafter Drew Pearson picked the story up and put it on the radio. I told [redacted] that I had called inasmuch as he had called [redacted] to find out what he [redacted] had in mind. [redacted] said that he was reviewing the matter; that it had not been formally submitted to the Department by the CPA and that from the looks of it he did not think anything could be done.

He said that in the discussion with CPA representatives one of them indicated they understood the FBI was checking into a certain phase of this case and he thought perhaps if that were true the information would be made available in due course to the Department.

I asked [redacted] if there was anything he wanted of the Bureau and he said no.

Reference is made to my teletype dated October 3, 1946 setting forth information concerning BEN SIEGEL's discussion with [redacted] with reference to the selling of SIEGEL's interest in the Hotel.

For your information there are attached hereto two copies of the transcript of the conversation which was reported by [redacted] which took place on October 3, 1946 at 12:55 p.m. between [redacted] and BEN SIEGEL. For clarification as to the identity of the individuals mentioned during the conversation, the following is set forth:

[redacted] "DEL WEBB" is the DEL WEBB CONSTRUCTION COMPANY, builders of the Flamingo Hotel.

[redacted] who is a partner of SIEGEL's in the Flamingo Project.

[redacted] and an associate of SIEGEL.

"GUS GREENBAUM" is an associate of SIEGEL, who spends considerable time at Las Vegas.

"MOE SEDWAY" is a front man for SIEGEL at Las Vegas.

[redacted] who is connected with the Flamingo Hotel.

It will be noted that the main purpose for this particular conversation is to determine the terms under which SIEGEL's interest could be purchased. [redacted] indicates that he has some one who may be interested in supplying the necessary money to effect the take-out. SIEGEL stated that he

wanted to know who would be able to pay the bills that DEL WEBB had. Further, WEBB had to be paid \$435,000 and if they were not paid today he would stop building on the following day. BEN informed [redacted] that he is to get one-quarter million dollars and another one-quarter million dollars in notes and that if the [redacted] were to remain in the Hotel Project they would have to have 50% of the stock and 50% of the voting rights and 50% would remain with [redacted]. This undoubtedly means [redacted] whom [redacted] represents. [redacted] wanted SIEGEL to give him time in order to get the deal underway and specifically requested until noon Monday. SIEGEL indicated that he was going "back to get it", undoubtedly meaning going to New York to arrange to get some money. b7c

In connection with the above conversation with [redacted] and the discussion of the purchasing of SIEGEL's interest, it is noted that shortly after this conversation, [redacted] reported BEN SIEGEL, at Los Angeles, had called GUS GREENBAUM at Las Vegas and stated [redacted] was coming to Las Vegas and would get there about 8:30 p.m. that day. Allegedly [redacted] would be going right through to the East. SIEGEL stated he was "finagling that other guy" into a deal and guaranteed that if it came the way he wanted it "he will be stymied and won't be able to go any further". BEN stated he will then be able to get it back and be in better shape. This particular portion of the conversation is thought to mean that SIEGEL was working a deal through [redacted] who was representing [redacted] and that [redacted] would be stymied; thereafter, SIEGEL would be able to buy back into the Hotel and take control. SIEGEL informed GUS that [redacted] would give GUS two checks, one for \$60,000 and one for \$40,000, which would be dated the first. SIEGEL instructed [redacted] to give [redacted] a check for \$40,000 made out to the Nevada Project Corporation. Further, GUS is to have [redacted] write a check for \$10,000 to the same corporation. SIEGEL stated [redacted] has a check for \$10,000 which he can give to [redacted]. Further, GUS was to take another check for \$10,000 or whatever "The Nugget" (GOLDEN NUGGET CLUB) owes the Frontier Turf Club. GREENBAUM was further instructed to give [redacted] another check on the Las Vegas Race Books for \$45,000 and to "lay out \$2500 for that". On October 14, 1946, pursuant to your request, Special Agent A. E. Ostholtzoff called from Los Angeles, California, to ascertain whether the Civilian Production Administration in Washington, D. C. had taken any action to stop the construction of the Flamingo Hotel since the 10-day period given this agency to act has now expired. Mr. Ostholtzoff also desired to be advised as to whether he should continue his investigation concerning this matter.

In the event that the Bureau deems it advisable for this investigation to be continued at this time, Mr. Ostholtzoff suggested that instead of interviewing all of the principal witnesses and principal subjects simultaneously, as previously planned, that it might be more desirable to interview

simultaneously but in different cities. If nothing affirmative was developed as a result of these two interviews, Mr. Ostholtzoff expressed the belief that nothing tangible would be developed as a result of simultaneous interviews with the remaining principal witnesses and principal subjects. If possible, Mr. Ostholtzoff requested to be informed of the Bureau's desires concerning the future handling of this case in the Field today.

ACTION TAKEN

The writer informed Mr. Ostholtzoff that his inquiries and suggestion would be considered and that he would be informed today, if possible, of the Bureau's desires in connection therewith.

[Redacted] Criminal Division of the Department, called and advised that several representatives of the Civilian Production Administration were in his office discussing the possibility of either civil or criminal action against the Flamingo Hotel of Las Vegas, Nevada. He explained that that organization had flaunted CPA restrictions against unnecessary building and was engaged in a large project in connection with a gambling casino.

[Redacted] advised that CPA representatives had received information that the FBI was investigating Bugs Siegel, who allegedly has a control, either personally or through his associates, of the Nevada Projects Corporation, which in turn controls the Flamingo Hotel. [Redacted] stated that he would appreciate receiving for himself and for the consideration of the CPA officials any information we might have concerning Siegel, the Nevada Projects Corporation or the Flamingo Hotel which might be of assistance in helping them determine whether legal action should be instituted against those individuals and groups.

ACTION:

MEMORANDUM FOR THE DIRECTOR

Although Mr. Osthoff believes that we may by interviews with the architects employed on the Flamingo Hotel ^{obtain} some data possibly implicating Bugs Siegel in the commission of perjury before the recent CPA hearing, I think any interview with these people will be futile. They obviously are going to protect Siegel, who is paying them apparently well for their services, and in addition, they will probably be afraid to furnish any facts if they have them because of implicating themselves in an illegal proceeding. Entirely aside from this, I doubt very much that a successful prosecution could be had in the Federal Courts for false testimony, even though it is under oath, before an administrative board such as a CPA examiner in San Francisco. After all, we took a terrible beating with a much stronger case in the [redacted] matter and, consequently, it is futile, I think, and actually hurts our prestige to conduct interviews of this kind. I recommend, consequently, that Mr. Osthoff be instructed not to conduct these interviews and that the entire matter be closed out immediately.

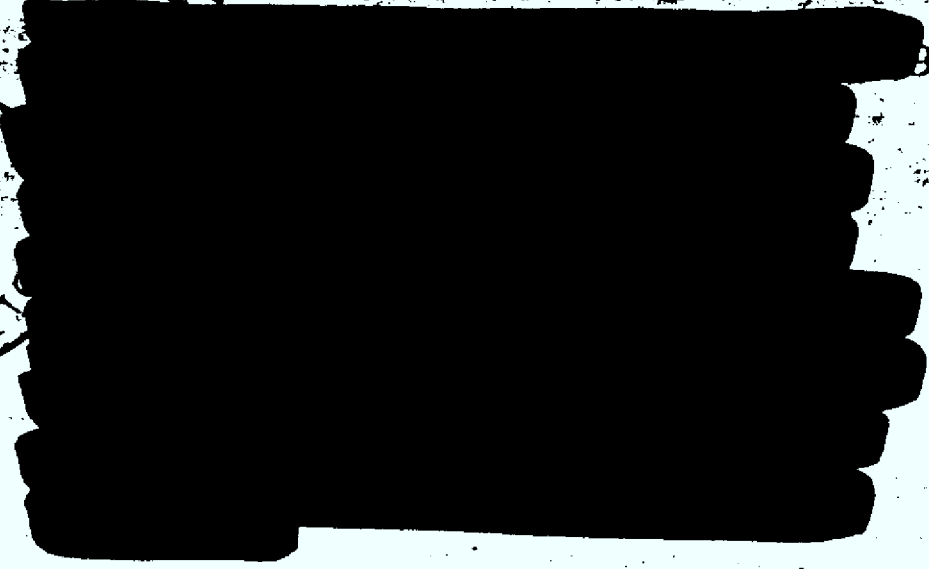
