At 8:40 a.m. today I spoke with [redacted] at the Bureau in the absence of Assistant Director ROSEN. I advised [redacted] that we received information here to the effect that the Civilian Production Administration at Washington had by telegram yesterday ordered further construction of the Flamingo Hotel at Las Vegas stopped. I asked [redacted] if the Bureau or the Department had discussed this matter with the Civilian Production Administration and asked who was responsible for the stop order. [redacted] said that he had no information indicating that the Bureau had taken this matter up with the C.P.A. I told [redacted] that we had been authorized by the Bureau only yesterday to conduct a complete investigation into the Flamingo Hotel but that I do not desire to go ahead with such an investigation if the C.P.A. is conducting an investigation of its own. I also told him that our original informant in this matter advised us that his information concerning irregularities in the construction of the Flamingo Hotel had come from [redacted] at Los Angeles. I advised him that we had planned to interview [redacted] this morning, but were doubtful about going ahead in view of the stop order from C.P.A. I then told [redacted] that in view of the fact that this had apparently not been instigated by the Bureau we would proceed with our interview of [redacted] [redacted] said that he would check on this matter further and would advise us either by telephone or teletype.

Special Agent in Charge W. J. MURPHY at San Diego called at 9:30 a.m. today and asked if we had any information here concerning deals between SIEGEL at Los Angeles and [redacted] at Del Mar. In other words, do we have any information to indicate that [redacted] is handling any deals for SIEGEL at Del Mar. I told him that we do not have any particular information on this point, although [redacted] upon his return to Los Angeles, August 9, 1946, was most anxious to get in touch with SIEGEL and we believe that he did see SIEGEL personally. At 5:30 p.m. on August 9, 1946 I spoke with Special Agent in Charge H. B. FLETCHER at the San Francisco Field Division. I advised him generally of the investigation concerning SIEGEL and particularly of the matter concerning the Flamingo Hotel. I advised him that a hearing was to be held before a C.P.A. Commissioner in San Francisco on Tuesday, August 13, 1946. I further advised him that SIEGEL planned to be in San Francisco for the hearing and that we desired coverage, both technical and microphone, on SIEGEL while he is in San Francisco. Mr. FLETCHER asked if there was any other action need be taken and I told him none other was necessary at this time. I advised Mr. FLETCHER that [redacted] stated to SIEGEL that he is attempting to secure Hotel reservations at the Palace Hotel. b7c

At 3:00 p.m. on August 10, 1946, Special Agent [redacted] of the San Francisco Office called me and said that they had found reservations at the Palace Hotel for [redacted] and party of four.

[redacted] I told Agent [redacted] that I did not believe that this was our subject and suggested that further check be made. I then referred him to our teletype of August 10, 1946 containing additional information concerning the C.P.A. hearing at San Francisco. I asked him to check the records of the Palace Hotel under the additional names listed in our teletype. b7c

With reference to San Francisco teletype of August 10, 1946 at 5:29 p.m. asking if [redacted] should be contacted by the San Francisco Office in order that arrangements may be made to cover any possible bribery meet. I spoke with [redacted] at the Bureau in the absence of Mr. ROSEN at 9:00 a.m. on August 12, 1946. I asked if the Bureau had advised San Francisco on this matter. He said that the Bureau had not because the Bureau could not tell whether the inquiry was addressed to the Bureau or to me. I told him that my first inclination was to instruct San Francisco not to get in touch [redacted] because of the rather general allegation that the C.P.A. is rife with graft and misconduct. However, after discussing the matter with agents here, we had come to the conclusion that [redacted] is of good character it would be wise to alert him to the possibility that he might be approached b7c

with a bribe. I pointed out to [redacted] that it is rather difficult to make a bribery case if the bribe has been passed; whereas, it is comparatively easy to make the case if we can see the pay-off. This matter was also discussed with [redacted] at the Bureau and it was agreed between [redacted] and myself that I would communicate with the San Francisco Office and advise them to make a quick check [redacted] if they found him an apparently reliable individual to put him on notice in a general way without revealing the source of our information as to the possibility of a bribe being offered and instructing him to negotiate with whoever offers the bribe in order that we might cover the pay-off. b7c

During the conversation with [redacted] at the Bureau he said that the Bureau was making every effort to get the authority through for a technical surveillance on the telephone [redacted] at San Francisco. I advised him that neither San Francisco or this office knows where SIEGEL is going to stay in San Francisco and he pointed out that we have blanket authority to cover SIEGEL and indicated that it would be all right for San Francisco to put on a technical and microphone surveillance without any further authority no matter where they finally located SIEGEL. b7c

At 9:15 a.m. on August 12, 1946 I spoke with Special Agent in Charge H. B. FLETCHER at San Francisco and advised him personally that it would be all right for San Francisco to put on technical and microphone surveillances of SIEGEL as soon as we locate him at San Francisco without securing any further authority, but that the Bureau should be advised of the installation. Mr. FLETCHER then referred me to Special Agent [redacted] who is handling this matter, and I advised [redacted] that he should get an idea [redacted] general reputation and character and if this appeared favorable he should then be approached in a general way, telling him only that we understand that BEN SIEGEL is interested in the Flamingo Hotel and under the circumstances it is possible that some one might attempt to make a deal on this matter and that if approached by any one he should immediately advise the San Francisco Office so that arrangements can be made for proper coverage. I told [redacted] that care should be taken that our source of information, which is a technical surveillance, is not revealed. Agent [redacted] asked if the situation developed where only a intermediary were involved, [redacted] should be instructed not to deal with the intermediary but insist that he deal with SIEGEL. In other words [redacted] wanted to know if we were interested only in getting SIEGEL or if it would be all right to arrange the set-up in order to apprehend an intermediary. I told [redacted] to go ahead and apprehend an intermediary; after he is in custody he will probably break down and the chain will work back to SIEGEL since we can obtain legal evidence of the fact that SIEGEL placed b7c

On August 8, 1946, through the courtesy of [REDACTED] b7c  
[REDACTED] Clark County, Nevada, the writer examined a  
certified copy of the articles of incorporation on the Nevada Project  
Corporation, owners of the Flamingo Hotel, Las Vegas-Los Angeles  
Highway.

The original articles of incorporation were filed with MALCOLM  
McEACHIM, Secretary of State, State of Nevada, Carson City, Nevada,  
July 26, 1946, by LOUIS WEINER, JR., of the law firm of JONES, WEINER,  
and JONES, 208 Beckley Bldg., Las Vegas, Nevada. WEINER is Resident  
Agent and Las Vegas attorney for the Incorporators of the Nevada  
Project Corporation, owners of the Flamingo Hotel.

Pertinent provisions of the articles of incorporation are  
summarized as follows:

ARTICLE I.

The name of this corporation shall be the NEVADA PROJECT  
CORPORATION.

ARTICLE II.

The principal office of the corporation shall be located at 208  
Beckley Building, Las Vegas. The corporation shall also have one or  
more offices located outside the state of Nevada where the books and  
records may be kept.

ARTICLE III.

The purposes of the corporation shall be to:

- A. To do all things set forth in the articles of incorporation  
to the same extent as natural persons could do.
- B. Purchase and/or construct hotels and to operate said hotels,  
together with casinos, liquor concessions, and other allied businesses  
connected with the operation of hotels.
- C. Engage in the concessions deemed necessary for  
the running of a hotel, dining room, and casino.

Purchase, acquire, own, hold, lease, sell, exchange, mortgage, improve, develop, construct, maintain, equip, operate, and generally deal in any and all lands, dwelling houses, hotels, apartment houses, boarding houses, business blocks, office buildings, and other buildings of any kind, and the products and avails thereof, and any and all other property of any and every description, real, personal, or mixed, wheresoever situated, including water and water rights.

E. Acquire by purchase or toherwise the good will, business, property rights, franchises, and assets of every kind, with and without undertaking in whole or in part the liabilities of any person, firm, association, or corporation, and to acquire any business as a going concern; to hold, maintain, and operate, or in any manner to dispose of the whole or any part of the good will, business rights and property so acquired; and to exercise all the powers necessary or convenient in or about management of such business.

J. Tend money, and deal in shares, bonds and notes.

K. Do everything suitable, proper and necessary for the accomplishment of any purpose and object enumerated.

1. Each of the above purposes are to be construed independently.

#### ARTICLE IV.

The corporation is authorized to issue two classes of stock:

1. One thousand shares of common stock of the par value of \$250.00 per share.

2. Two hundred and fifty shares of preferred stock of the par value of \$1,000.00 per share, earning an annual dividend of 3%, cumulative.

The total value of all shares shall be \$500,000.00

A. The common stock shall participate in the earnings of the corporation.

The preferred stock is not entitled to participate in the earnings of the corporation except as to the dividends stated.

No dividends shall be paid on common stock until all preferred stock issued shall have been retired by the corporation.

B. Voting rights shall be vested in the common stock only.

C. The preferred stock may be retired at the option of the Board of Directors at any time, provided, it must be retired within two years after its issuance upon payment of its par value.

D. Voting rights shall accrue to holders of preferred stock on the following conditions:

1. If the preferred stock is not retired within two years, it shall be entitled to vote until it is retired.

2. In the event of default of the corporation on any loan or obligation of the corporation, holders of the preferred stock, for the benefit of the corporation, may make advances of money to cure the defaults and voting rights shall then accrue and continue until such advances are repaid with interest at the rate of 7%.

#### ARTICLE V.

Directors of the corporation shall be:

The stockholders may agree to restrict and limit the sale or transfer of stock in the corporation. The shares of stock shall so reflect.

#### ARTICLE VII.

Whenever the amount of the subscription price or the par value of the stock has been paid in, the stock shall not be subject to assessment to pay debts of the corporation.

#### ARTICLE VIII.

The incorporators of the corporation shall be:

(Same as the Directors set forth under Article V.)

ARTICLE IX.

The existence of the corporation shall be perpetual in duration.

ARTICLE X.

1. The Directors are empowered to make by laws, fix working capital, and authorize mortgages and liens.

2. The Directors shall determine when, where and how the books of the corporation shall be open to inspection of the stockholders.

3. There shall be no sale of the property of the corporation without the approval of two-thirds of the shareholders.

4. The Directors shall have the right to hold meetings and keep the books of the corporation outside the state of Nevada.

ARTICLE XI.

The shareholders are entitled to purchase or subscribe for the number of shares of the corporation which may be authorized and issued for money which bears the same ratio to the number of shares then proposed to be issued as the number of shares then held by him shall bear to the number of shares subscribed immediately prior to such additional issue.

ARTICLE XII.


A majority of the shareholders may change the number of Directors of the corporation by amendment or by laws.

At 2:15 p.m. on August 19, 1946, I spoke with Assistant Director ROSEN at the Bureau and advised him that Special Agent [REDACTED] and myself had gone to the CPA office in San Francisco where we interviewed [REDACTED]

I explained that [REDACTED] was most cooperative and had instructed his man at Reno to make available all information to the FBI. I told him that [REDACTED] had refused to furnish their files to us and would not fully discuss the matter. I also advised him that later [REDACTED] refused to furnish us the name of the reporter who was preparing the transcript of the hearing before Commissioner [REDACTED]. I went into some detail concerning our conference with [REDACTED] and explained that he was not able to tell us what action the CPA planned in this matter, and I told Mr. ROSEN that it was my opinion that [REDACTED] decided that further investigation of this matter should be had at the time he walked into [REDACTED] office and found out that the FBI was interested in the matter. I told Mr. ROSEN that [REDACTED] wanted us to come back tomorrow to further confer with him after he had a chance to go over the matter with the Legal Department of the CPA. I asked Mr. ROSEN if the Bureau desired to get in touch with [REDACTED] the CPA in Washington, and have [REDACTED] instruct [REDACTED] to furnish the desired information to us.

Mr. ROSEN said that he did not feel it was a matter to be handled on a Washington level at this point but that we should see [REDACTED] on August 20 and formally request the information, that we should present the matter to him strongly indicating that we had to have this information, and that if he refused, to let him, Mr. ROSEN, know and that the matter would be handled in Washington.

On August 19, 1946, at 10 a.m. Special Agent [redacted] and the writer interviewed [redacted] of the Civilian Production Administration, 1355 Market Street, San Francisco, California. We advised [redacted] that we were interested in going over the files of the CPA in connection with the construction of the Flamingo Hotel at Las Vegas, Nevada. We advised [redacted] that we had information to the effect that there was possibly fraud against the Government involved and that there was possibly perjury involved on the part of the individuals constructing the Flamingo Hotel. We also advised him briefly of the background of the individuals concerned with the construction of the hotel. b7c

[redacted] explained that he was not intimately acquainted with the case of the Flamingo Hotel and that he had attended about 15 minutes of the hearing before Commissioner [redacted] on August 13, 1946. He said he had only a general idea that the controversy revolved around whether there was being constructed one building or several buildings, but he was not in a position to go into the technical aspects of the matter. He said that the entire file on this is in the possession of [redacted] for the region comprised of all California, Nevada, and Arizona and who was responsible directly to [redacted] for the CPA at Washington, D. C. In other words, [redacted] said that [redacted] does not report to [redacted] even though [redacted] for the CPA. [redacted] explained that [redacted] for Region No. 9 which cover the following territory: Northern California, Nevada, Oregon, Washington, Idaho, Montana, and Wyoming. [redacted] evidenced a great willingness to cooperate with us, and during the course of our conference with him he communicated with [redacted] who was in charge of the Reno office and works under [redacted] and instructed him to make available to the FBI his complete file concerning the Flamingo Hotel and to furnish whatever information an agent might ask. b7c

[redacted] called to his office [redacted] and at that time we explained to him our interest in the construction of the Flamingo Hotel. He said that he understood that the FBI had some interest in this matter. When he was asked to produce the file in order that we might review it, he said that he could not produce the file because the case was still pending, that there would probably be another hearing on this matter before the commissioner on September 5, 1946, and, therefore, he did not think that the FBI should look at the file. We asked him what further action the CPA planned to take, and he stated that he did not know. He said that he is going to have a conference with the legal staff of the CPA on August 19, 1946, and requested that we come back on August 20, 1946, when he would be in a better position. b7c

We told him that we were interested only in the facts in controversy, and he stated that he did not know completely what those facts were, that it would be necessary to review the transcript of the hearing before Commissioner [redacted] that the case apparently would turn on rather technical points, and that it would probably be necessary for his organization to secure technical help in working out their investigation. He said that at this point he was not certain that further investigation would be made or that the CPA would do any more about this case, but that he would be able to advise us concerning this on August 20. b7c

Upon our return to the San Francisco Office, Special Agent [redacted] telephonically communicated with [redacted] and asked him for the name of the firm which was preparing the transcript of the hearing before Commissioner [redacted]. At this time [redacted] advised that he did not think he should furnish us with the name of the reporter and did not think that he should furnish us with the transcript inasmuch as their investigation was still pending. He was asked whether or not he had gone into the matter with [redacted] for the CPA who had handled the hearing, and he stated that he had briefly done so but that they had not completed the discussion and would not do so in time for us to meet with him at 4 p.m. August 19, it having been explained to him that Agent OSTHOLTHOFF desired to catch a 5 o'clock plane rather than wait over until the following day. b7c

On August 20, 1946, at 9 a.m. Special Agent [redacted] and the writer had another conference with [redacted] at which there was also present [redacted] for the CPA who handled the hearing on behalf of the CPA before Commissioner [redacted]. This conference was held in the office of [redacted] and before the arrival of [redacted] [redacted] apologized for the fact that he had no control over anything that [redacted] does, thus indicating that he desired that we be furnished all possible information concerning this matter. b7c

At this time we again asked [redacted] to go over the file on the entire Flamingo Hotel matter, and [redacted] stated that he would not do this because of the fact that the investigation on the part of the CPA was still pending; that if we felt his attitude was unreasonable we would have to have his superiors in Washington order him to turn over the file to us. We also formally asked him for the name of the court reporter who was preparing the transcript of the hearing before Commissioner [redacted] and this was refused us. [redacted] said that he did not want to furnish this transcript to us because there were several things said at the hearing which were off the record and he wanted to go over those for the commissioner before making any transcript available to us. b7c

I told [redacted] that we could not understand their attitude, that we were not "outsiders" nor were we aligned with the respondents in this b7c

matter but were representatives of another Government agency which had jurisdiction to investigate fraud against the Government. I asked [redacted] if the builders of the Flamingo Hotel would be entitled to a copy of the transcript of this hearing, and [redacted] answered the question by stating, "Yes, they would if they pay the fee." b7c

[redacted] said that he did not want to appear unreasonable but suggested that we wait until the completion of the hearing on September 5, after which time he would be willing to turn over all of the information. [redacted] then pointed out that it was August 20 and the hearing was to be held September 5 and that we would be held up only two weeks. We pointed out that time is of the essence in a matter of this kind, that the individuals involved in this matter work fast, and that a great deal of evidence could disappear in two weeks. [redacted] then stated that we had gone over the case yesterday, and I advised him that if he had furnished us the facts in this matter yesterday I apparently had missed hearing them and asked that he repeat the facts in controversy on the whole investigation. He then stated that the matter revolved around whether the first permission which was granted by [redacted] was valid and whether the builders of the Flamingo Hotel were constructing one building or more than one building. I pointed out that we were dealing in generalities and that we wanted the facts in the matter. I pointed out that they had presented a case before a commissioner and had received an adverse ruling. I asked him why an adverse ruling had been received, and he stated that "You would have to read the commissioner's mind to get the answer to that." I told him that I did not believe that was the case, that in any court proceeding by analyzing the facts presented by the Government and those presented by the defense you can obtain the reasons for a decision. b7c

[redacted] then reverted back to the theory that the matter was highly technical. I then asked him why the stop order was sent to the builders of the Flamingo Hotel, and he said that was based on investigation conducted by the Compliance Division of the CPA which had been furnished to the Washington headquarters of the CPA, who had issued the stop order. I asked him in view of the fact that this investigation had been conducted if they were not in a position at that time to present a case before the commissioner which would uphold the contention of the Government, and he stated that they were supposed to be in a position to do that but sometimes they were caught short on a stop order and they do not have enough evidence to present. He said that he felt that if the FBI conducted an investigation of this matter at this time it would harm the investigation of the CPA. I asked him how it would harm the CPA investigation, and he said he did not know. I then advised him that I did not believe that our investigation would interfere with the CPA case. [redacted] remarked about swarms of agents out investigating this matter who had been duplicating the CPA investigation and said that the builders of the Flamingo b7c

Hotel would come up to the hearing with high-price lawyers and technical experts. I asked him if the builders of the Flamingo Hotel were not already on notice that his organization was conducting an investigation, and he admitted that they had already appeared at the first hearing with high-price lawyers and technical assistants.

[redacted] then proposed that we hold off our investigation until after the CPA hearing September 5. He said that if both the CPA and the FBI investigate this matter we might both fail, but that if CPA alone investigates it the chance of CPA failing is less. However, he stated that if the CPA fails to make its case then they will turn the matter over to us. I told him that he himself stated that we would be going over the same investigation, and I pointed out that if that is true that if the CPA fails then the FBI fails. He admitted that this was true. b7c

The only thing that [redacted] would reveal as to the future investigation of the CPA was that they planned to take photographs of the work as it now stands on the Flamingo Hotel and to try to get technical assistance. He said that they might not be able to get this technical assistance and then he did not know what the results of their case might be. He said that they thought they might try to get additional plans used by the construction company. b7c

I then asked [redacted] if he thought that the CPA could make a case that would "stick." He replied that he did think so, otherwise, they would not proceed with further investigation. Naturally he qualified this by stating that it depends on what evidence is secured, that if the same evidence is secured that he feels can be secured the stop order of the CPA can be made final. b7c

We asked [redacted] what recourse the builders have in the event the stop order is made final, and they stated that they can appeal to the Chief Compliance Officer of the CPA after which they can have recourse to the Federal courts for a restraining order. b7c

[redacted] then asked if there was anything else that I wanted, and I told him that we had not received anything that we came for, that what we wanted was the full facts on this entire matter. I told him that apparently he had no intention of furnishing that to us and his attitude was that he would have to secure the authority for him to furnish this information to us from his superiors in Washington. He stated that this was correct. b7c

At 5:40 PM on this date S.A. [redacted] <sup>Residence add.</sup> called from [redacted] Los Vegas to advise the following: An employee of TWA at Los Vegas was interviewed today re the identity of [redacted] who left on the plane on the 17th. He furnished a description which tallied with that of [redacted]. He was then shown a photo of [redacted] and he identified [redacted] picture immediately and stated that he could positively identify the [redacted] as [redacted] had the man initial the photo of [redacted] for future reference. b7c

[redacted] also furnished additional information relative to Siegel's trip. On August 17th Siegel made reservations for both Siegel and [redacted] with the Western Airlines for a trip to Chicago. However they were only able to reservations confirmed as far as Denver as United Airlines but of Denver could not give any reservations to them. They were scheduled to leave on August 21, at 9:20 AM and would arrive in Denver at 1:58 PM. The tickets were on flight 400 from Los Vegas. [redacted] stated that since I had contacted [redacted] this morning he learned that Siegel had cancelled his trip to Chicago and was to leave Los Vegas for Los Angeles by car on the afternoon of the 21st. The reservations for [redacted] have not been cancelled and [redacted] will check him out on the plane in the morning although he did not feel that [redacted] trip to Chicago had anything to do with the matter being presently checked. At 7:00 p.m. on August 14, 1946 Special Agent [redacted] of San Francisco advised that SIEGEL, [redacted] had left San Francisco via Western Airlines and were due to arrive in Los Angeles at 8:25 p.m. [redacted] said that SIEGEL told some one that they had received a favorable decision from Commissioner [redacted] and BEN planned to go to Las Vegas on August 15th. b7c

At 1:45 p.m. on August 15, 1946 I spoke with Special Agent in Charge H. B. FLETCHER, San Francisco, and asked him for the results of the interview with [redacted]. He advised that the agents were still interviewing [redacted] and had not returned to the office. I asked Mr. FLETCHER how the information was secured concerning the conversations of SIEGEL and his associates at the St. Francis Hotel and Mr. FLETCHER advised that this was obtained through a contact microphone. I asked Mr. FLETCHER if there were any recordings made of this and he said that there were not in view of the fact that a contact microphone was used. In connection with the mention of a senator, whose name was not obtained, as reflected in San Francisco teletype, I suggested to Mr. FLETCHER that this might have been State Senator MC CARRAN and suggested that the agent who was listening to the conversation be furnished this name to see if this name sounded like MC CARRAN. b2

At 3:15 p.m. Supervisor [redacted] of the San Francisco Office called me and said that the agent who had listened to the conversation in the hotel room said that he is pretty certain that the senator whose name was mentioned is not MC CARRAN, but it might be [redacted]. b7c

At 5:30 p.m. on August 15, 1946, Special Agent [redacted] called from San Francisco and advised that he had interviewed [redacted]. [redacted] told them that if this were true they were not violating the C.P.A. regulations in continuing the construction. However, he told them to write him a letter to this effect. The builders did this on April 29, 1946. [redacted] replied to their letter, stating that they could continue construction, if the project were in fact only one building. [redacted] said that the Government introduced a very sketchy plat of the project and they did not show the original plans of the project to compare with the plans that were shown to [redacted]. The respondents, that is the builders, then introduced plans dated January 12, 1946. This was done by [redacted] the architect. [redacted] of the Del Webb Company said that these were the plans they were following. [redacted] asked [redacted] if he could construct a building from those plans and [redacted] said no. [redacted] said that he felt the Government presented a very weak case and that he felt that a better case could be made; therefore, he gave a decision in favor of the respondents, but allowed the Government until September 5th to introduce new evidence which would justify a stop order. [redacted] said that no approach was made to him in the way of offering a bribe, although he was introduced to BEN SIEGEL. He remarked that [redacted] asked [redacted] if the hearing were to be a closed hearing, pointing out that ordinarily these hearings are not open to the public. [redacted] said that he would follow the usual rule. Then [redacted] asked if F.B.I. Agents could be present. [redacted] said that he replied to [redacted] that he felt it would be all right for F.B.I. Agents to be present since they are part of another Government agency. However, [redacted] did not follow through on this and [redacted] did not know why [redacted] asked this question. I told Agent [redacted] to submit a teletype to the Bureau and Los Angeles summarizing the results of the interview with [redacted].

At 1:15 p.m. today I spoke with [redacted] at the Bureau in the absence of Assistant Director ROSEN. I advised [redacted] that in connection with the proposed kidnaping of [redacted] SIEGEL received a telephone call at Las Vegas at 7:17 p.m. on August 20, 1946 which we believe was from [redacted]. The conversation was as follows:

SIEGEL: [redacted] where are you in Cleveland?

SIEGEL: Well, I'll see you tomorrow. At least I'll see you tomorrow night.

I advised [redacted] that we are not certain at this point where SIEGEL would be tonight, but we are covering his activities; that he had planned to come to Los Angeles tonight, but we have since learned that he has reservations to go to Chicago by plane, leaving Las Vegas at 6:30 p.m. tonight. I told [redacted] that we would communicate with the Chicago Office and instruct them to cover SIEGEL's activities by technical and microphone surveillance.

I also advised [redacted] that through our microphone surveillance we learned that from 11:40 p.m. until 1:50 a.m. last night, SIEGEL [redacted] had a conference in SIEGEL's room at the Last Frontier Hotel at Las Vegas. During the discussion [redacted] told of the difficulty they were having in getting a loan. He said that he and [redacted] had gone to about every bank in Los Angeles and were turned down by each one; that [redacted] then went back to a very good friend of his in the Bank of America and asked him why they were getting such a cool reception. The banker said: "You fellows are hot. Both the C.P.A. and the F.B.I. are investigating you". [redacted] also said that [redacted] had called [redacted] and told him that two F.B.I. construction of the casino at the Flamingo Hotel, asking him when the construction was started and where the money was coming from. [redacted] told [redacted] that he gave the agents everything they asked for and told them everything he knew about the Flamingo Hotel, which he thought was very little. [redacted] then stated that [redacted] told [redacted] that he was going to call the F.B.I., that he has a lot of friends there, and would find out just what the F.B.I. is looking for. Later he told [redacted] that he had called the F.B.I. and found out that they are trying to determine two things. First, did any one receive a bribe in connection with the construction of the Flamingo Hotel and secondly where does BEN SIEGEL get his money? [redacted] then suggested to [redacted] that he have SIEGEL go to the F.B.I. in Las Vegas and ask them what they wanted. SIEGEL said no he would not do that; that the F.B.I. should come to him. [redacted] then said that the F.B.I. would not come to SIEGEL, that he would have to go to the F.B.I. SIEGEL said he would think that over. SIEGEL then stated that he gave [redacted] 500 yesterday for campaign expenses. He said that Senator MC CARRAN is already cooperating with them. In this connection, [redacted] told SIEGEL that when he next sees Senator MC CARRAN to tell MC CARRAN that if the F.B.I. should talk to him that he should play dumb and advise that he knows nothing about [redacted] SIEGEL, et al. b7c

The discussion then turned again to obtaining a loan and they talked about getting a loan from the Reconstruction Finance Corporation. Their discussion also indicated that they believe we are interested in determining whether a bribe was given to [redacted] to secure approval for the construction of the Flamingo Hotel. SIEGEL said if that is what the F.B.I. is after let them go ahead and investigate that; indicating that he was not worried about such an investigation. They then discussed plans they have for pouring a concrete floor, concrete walls and roofs which will physically connect all of the buildings at the Flamingo Hotel project. They feel that this will completely fool the C.P.A. They are also going to erect a high fence completely around the Flamingo Hotel project in order that no one can see what is going on there. b7c

At this time I told [redacted] that in view of the attitude of the C.P.A. toward me at San Francisco, we would hold up our open investigation of the Flamingo Hotel until after the next C.P.A. hearing on September 5th. I stated that since the C.P.A. at San Francisco told me that they feel they could make a case, we would await the outcome of their investigation and if they have another hearing it might provoke SIEGEL into again attempting to bribe or corrupt some official which might give us an opportunity to get a better violation on him. At 8:45 a.m. on August 16, 1946 I spoke with Assistant Director ROSEN at the Bureau. I told him that we planned on Monday to begin our open investigation of the Flamingo Hotel pursuant to the authority given by the Bureau about ten days ago. I told him that I would go to San Francisco and examine the records of the C.P.A. there; that one of our agents assigned to the special would examine the C.P.A. records at Reno and that we would also examine available C.P.A. records in Los Angeles. Mr. ROSEN said that he knew of no reason why we should not proceed with this open investigation. I advised him that I anticipated that the C.P.A. may be reluctant to turn over their records and, therefore, the Bureau should get in touch with C.P.A. Officials in Washington in order that we might have no difficulty in securing the records in the regional offices. I pointed out that we have a possible perjury case now in view of the fact that San Francisco obtained its evidence of conversations between SIEGEL and the other individuals involved by means of a contact microphone. I pointed out that while primarily we are investigating this matter as a Fraud Against the Government, still it is in the nature of an administrative investigation and that if we secure before September 5th sufficient evidence to justify re-presenting this matter before Commissioner [redacted] at San Francisco, we should probably make the results of our investigation available to the C.P.A. Mr. ROSEN said that this would be done through the Bureau in Washington. b7c

I also advised Mr. ROSEN that we interviewed [redacted] C.P.A. Investigator at Los Angeles, and he advised us in the strictest confidence that Senator PAT MC CARRAN of Nevada was in San Francisco on the day of the hearing in case he were needed by the individuals building the Flamingo Hotel. b7c

While at the San Francisco Office on August 20, 1946, I called Mr. ROSEN at the Bureau at 12:20 p.m. I advised him of my second interview with [redacted] of the C.P.A. and [redacted] of the C.P.A., San Francisco, and that [redacted] had formally refused to make available to me the files of the C.P.A., that he would not discuss the facts surrounding the construction of the Flamingo Hotel, and would not advise me of the name of the reporter who was preparing the transcript of the hearing before Commissioner [redacted]. I told Mr. ROSEN that I had exhausted all possible arguments with [redacted] and that [redacted] had stated that he would not turn over any information to the F.B.I. unless he was ordered to do so by his superiors in Washington. Mr. ROSEN asked me if I thought that the Department could instruct the U.S. Attorney at San Francisco to secure the files from C.P.A. and I told Mr. ROSEN that I did not believe that the U.S. Attorney at San Francisco would have any better chance than I had of getting the information from the C.P.A., that apparently [redacted] is quite bullheaded and that the only way we can get the information is to have C.P.A. Officials in Washington instruct [redacted] to turn the files over to us. Mr. ROSEN agreed that there was nothing further I could do and I asked him if he felt that we should proceed with our investigation. I pointed out to him that we could go ahead with the investigation as we had originally planned, although the investigation would be harmed somewhat for not having all the information the C.P.A. has. Mr. ROSEN asked how we would justify our investigation to the public in Las Vegas and Los Angeles, and I told him that I did not believe the public would question this investigation. He said that perhaps the individuals we interviewed would question our authority to investigate this matter and would state that apparently this is a C.P.A. matter. I told him that we could then explain that the C.P.A. does have jurisdiction to investigate this matter from an administrative standpoint and that the F.B.I. was investigating the matter to determine whether there was a Fraud Against the Government in submitting false information to a Government official.

Mr. ROSEN asked what I planned to do tomorrow in the investigation and I said that we had planned to first interview [redacted]

[REDACTED] is reputed to be a respectable individual and we feel that he would rather quickly furnish truthful information to us rather than take a rap for SIEGEL. I also stated that we planned to go into the records of the Del Webb Construction Company and that one of our purposes was to trace back the money that had gone into the construction of the Flamingo Hotel in order to determine how much money SIEGEL had put into the Hotel and also if any money of [REDACTED] and the Syndicate had been put into the Hotel. Mr. ROSEN then inquired if I was not <sup>exercising</sup> ~~absconding~~ the authority granted in the telegram from the Bureau authorizing this investigation and I told him I did not believe so if the telegram was based on the letters that I had submitted to the Bureau requesting the authority to conduct this investigation; that those letters had indicated what I intended to do if this investigation were authorized. Mr. ROSEN then stated that he felt I could probably justify the investigation on the theory of Fraud Against the Government and he stated that the Bureau would handle the matter of forcing C.P.A. to make their files available to us. He requested that I submit a memo to the Bureau outlining my conferences with C.P.A. Officials in San Francisco in order that it could be made a matter of record at the Bureau in the event of any future difficulty. b7c

At 11:20 p.m. last night, August 26th, 1946, SIEGEL, [redacted]

[redacted] entered Room 412,  
Last Frontier Hotel, Las Vegas, according to [redacted].  
They were talking when they entered the room, and had  
evidently been discussing building plans on the Flamingo Hotel.

[redacted] stated that he had gone to the Bank of America  
and the Occidental Insurance Company, both of Los Angeles, in an  
attempt to obtain a loan to assist in completing the Flamingo Hotel.  
He said that both places turned him down cold on his application for  
a loan. He said that the Bank of America had "checked" with the  
Metropolitan Life Insurance Company and the Anglo-American Insurance  
Company, but that he [redacted] doubts that "it will come in".

He said that he and [redacted] went to the Bank of America because  
[redacted] knows one of the bankers there. [redacted] evidently went  
back to the bank later, from [redacted] conversation, because [redacted]  
said that [redacted] called him and stated that he [redacted] was  
surprised at the "cold reception" he got at the bank. [redacted] then  
told [redacted] that he [redacted] called his friend at the bank and  
asked what the difficulty was. The banker advised [redacted] that "we  
are hot" [redacted] asked why, and the banker replied that there was  
an investigation going on.

[redacted] later called [redacted] again and said that [redacted]  
[redacted] had had a visit Monday from two F.B.I. Agents, that the

[redacted] then told [redacted] according to the latter, that he knew the men in the Los Angeles F.B.I. office and that he was going to call them and find out "what's going on".

[redacted] said that [redacted] then called the F.B.I. office and found out that there are two things that the F.B.I. wants to know:

1. Was anyone bribed.
2. Where does SIEGEL get his money.

At this point SIEGEL said, "Why don't they ask SIEGEL?"

[redacted] said that [redacted] suggested to him, and he agrees that it is a good suggestion, that SIEGEL go to the F.B.I. in Las Vegas and ask them what they want to know.

SIEGEL replied, "Let them come to me."

[redacted] said, "They don't want to come to you."

SIEGEL then told [redacted] that he had given [redacted] \$500.00 yesterday (August 20, 1946) as a campaign contribution; that [redacted] should now cooperate; and that McCARRAN (U.S. Senator PAT McCARRAN) is cooperating pretty good.

SIEGEL then said, "They must feel we bribed [redacted]. If that's the way they feel, let them go ahead on it."

[redacted] asked SIEGEL if "anyone went on the job out there".

SIEGEL said that beginning today, he is going to have a high fence built around the property; was going to string wire all around there; and was going to place guards there at night. He spoke of contacting [redacted] about deputizing the guards.

SIEGEL said that he was also going to have the contractor "throw up a couple of walls", pour a concrete porch, and build a roof over it connecting the two hotel buildings so it would look like one building. [redacted] said, "Well, have them lay it out tomorrow" (August 21st).

[redacted] and SIEGEL then discussed the possibility of obtaining a loan from [redacted] and is connected with some KEE bonding company, it will be recalled that previous conversations between [redacted] and [redacted] have been recorded and reported, as well as conversations between [redacted] and SIEGEL relating to the application for this loan from [redacted]. Evidently, [redacted] are going to Chicago tonight for the purpose of attempting to negotiate this loan.

SIEGEL then said that he is going to attempt to obtain a loan from the Reconstruction Finance Corporation through the efforts of McCARRAN "and the other guy" [REDACTED] b7c

[REDACTED] replied that the R.F.C. will "not go along on it" because it is a political organization and when it learns that the F.B.I. and the C.P.A. are interested in the hotel they will not consider the loan. b7c

The name of one [REDACTED] evidently a former Agent of the F.B.I. was mentioned. SIEGEL said, "I know him. I have some of the main guys in the F.B.I.- tough ones, who worked on DILLINGER and "BABY FACE" NELSON." When SIEGEL said that he "has" some of the "main guys" in the Bureau, he obviously meant that he "has" some former Agents because he mentioned again the names of [REDACTED] and one [REDACTED]. He said, [REDACTED] was a head guy. All of them will break their [REDACTED] for me, and they won't go running to the F.B.I." b7c

SIEGEL then said, "If the F.B.I. wants to talk to me, let 'em. They'll ask questions, get a couple of affidavits, and then the matter will be closed."

[REDACTED] suggested that SIEGEL tell McCARRAN to "be dumb" and not know that SIEGEL is putting up half of the money for the hotel. b7c

In discussing financing the hotel, SIEGEL remarked that "we" have \$20,000.00 in whiskey that "we" can use.

The above is a resume of that conversation taking place in SIEGEL'S room. The technical logs will be submitted as soon as the recorded conversation is placed on the logs. Due to a lack of time, the records have not been transcribed, but will be mailed to you today.

On August 19, 1946, Special Agent [redacted] and the writer interviewed [redacted] local enforcement compliance chief of the C.P.A. [redacted] was advised that Agents would like to examine the file pertaining to his investigation of the Flamingo Hotel construction in Las Vegas in connection with investigation being conducted at the Los Angeles office of the FBI. He was told that Agents of this Bureau were in San Francisco, conferring with either [redacted] at the C.P.A. offices in that city and that shortly [redacted] would probably be contacted by telephone from the regional offices of the C.P.A. in San Francisco regarding our inquiry. b7c

While awaiting this call, [redacted] talked "off the record" to the reporting agents, saying that in the event he were ever quoted in connection with his remarks that "I will swear both of you are liars." The original cease-work telegram sent to the Flamingo builders was one of fourteen to twenty such wires sent out along the highway #66 from Los Angeles to Kingman, Arizona and south to the Mexican border, placing freeze orders on construction work on different cities along the route which construction was not considered essential and proper. He said that these wires had a very good effect on each one of the communities in which they were received in that it did put a temporary halt to unnecessary building and requests to build in each of these communities. However, about 90% of these projects were immediately approved for continuing construction by the construction division of the C.P.A. b7c

He appeared extremely discouraged in this connection to the Agents and remarked that in one instance a dog and cat hospital was being built immediately adjacent to another dog and cat hospital and that the building was authorized to continue after the wire to stop had been received. This is also true in connection with certain cocktail bars.

In discussing [redacted] trip to see [redacted] in Reno, [redacted] stated that it is his impression that a public stenographer was called in to [redacted] office and that the letters were dictated in his office wherein [redacted] pointed out what progress had been made in the building at Las Vegas and [redacted] replied that if what was said in the referenced letter were true the hotel should continue building. These letters to each other were dictated in [redacted] office before the public stenographer who was called in. b7c

Discussing the testimony in San Francisco before Commissioner [redacted] [redacted] said that the defense took the position that the buildings comprising the Flamingo Project were joined to the power unit which in effect made them one building [redacted] pointed out that [redacted] then made a good remark and b7c

[redacted] inferred it was the only good remark [redacted] did make, when the latter said that if joining buildings by air conditioning apparatus and power ducts constituted their becoming one unit that a person could conceivably build connecting buildings all the way from Las Vegas to Los Angeles. The defense immediately abandoned this point when [redacted] made the above observation. b7c

The defense then went to their second point that the construction already completed provided for the connection of the various buildings of the Flamingo Hotel into one unit. In this connection [redacted] emphatically stated that the physical facts did not substantiate the contention of the defense. b7c

In discussing the investigation conducted by his office in Las Vegas, [redacted] stated that affidavits from the union controlling the steel workers at that point showed that no such labor had been employed on the Flamingo job until after April 6, 1946 which was subsequent to the freeze date. Also, the records of the Pre-Mex Concrete Company allegedly were of importance in proving that certain work had not been done on the hotel prior to March 26, 1946. b7c

In discussing the blue prints on the project, [redacted] pointed out that "they have their own blue printing machines and can print them up by the hundreds or change them as often as they want to" and this situation materially affected the investigation as far as the plans themselves were concerned. However, [redacted] stated that he originally had in his possession the plans signed by the architect in his own writing that there was no connection between the buildings. This exhibit is presently in San Francisco and [redacted] does not have a copy or photograph of this. b7c

In this connection he also stated that the pertinent exhibits as well as pertinent information concerning their investigation was only incorporated in the original report which was sent to [redacted] of the C.P.A. office in San Francisco and that the files presently maintained in [redacted] office are incomplete. b7c

[redacted] had personally asked that this hearing be held in San Francisco on the theory that the freeze might be made to stick.

With regard to examining his records, [redacted] stated that as far as he was personally concerned he had no objection to the examination and was only too glad to cooperate to the fullest extent with the FBI, but that due to organizational procedures already established it would be necessary for him to secure authorization from his headquarters in San Francisco. b7c

In view of the fact that [redacted] did not secure approval on the day of the inquiry and the fact that it was subsequently learned a decision with regard to permitting the examination of records would not be reached until b7c

At noon on August 29, 1946, [redacted] former Special Agent of

this Bureau, appeared at the Las Vegas Resident Agency and advised that he had learned that about two weeks ago, SIEGEL and some of his friends were eating at Doc Ladd's Cafe, on South Main Street, Las Vegas. SIEGEL asked [redacted] who the head man was in the Chamber of Commerce besides [redacted] [redacted] is alleged to have informed SIEGEL that [redacted] is the Executive Secretary. SIEGEL instructed [redacted] to contact [redacted] and tell him to come to [redacted] at once. [redacted] did so and when [redacted] appeared, SIEGEL informed [redacted] that he was going to break [redacted] neck the next time he saw [redacted] SIEGEL is alleged to have produced copies of letters from the Chamber of Commerce, Las Vegas to Senator PAT McCARRAN complaining of the construction of the Flamingo Hotel when veterans cannot get materials with which to build homes. SIEGEL is also alleged to have produced a copy of a letter from McCARRAN to either the CPA or the Department of Justice, referring the complaint of the Chamber of Commerce to one of those Agencies.

[redacted] stated that SIEGEL told [redacted] that they came to Las Vegas with the intention of spending \$2,000,000.00 on the Hotel and they are spending \$4,000,000.00 instead and that if the Chamber of Commerce is not appreciative of that kind of money being spent in Las Vegas, they can go to hell. SIEGEL is alleged to have said that he had instructed MOE SEDWAY to give the "Live-wire" Fund of the Chamber of Commerce a check for \$3000.00 but that since he had learned of [redacted] attitude he had instructed SEDWAY to tear up the check. SIEGEL stated that if he heard of SEDWAY or anyone else connected with his business giving one cent to the Chamber of Commerce in Las Vegas he would break their necks. SIEGEL is alleged to have told [redacted] that he has been one of [redacted] best customers at the Hotel Last Frontier and that when the Flamingo Hotel is completed it will make the Last Frontier look like a two bit auto court; that he will get the real business at his hotel and [redacted] will get the tourists.

[redacted] was asked where he got his information and he said from [redacted] However, it is to be noted that none of [redacted] comments are included in the above and it is believed that had [redacted] obtained the above information from [redacted] [redacted] would have informed [redacted] what his reaction was. [redacted] of the Bureau telephoned me at 7:20 a.m. (September 3, 1946) and stated that the Director is interested in the possible perjury violation in connection with the C.P.A. hearing at San Francisco. [redacted] stated that the Bureau wanted to know who testified before the Commissioner and which parts of the testimony I considered perjured. I told [redacted] that I was still at my hotel and that I had this material at the office. [redacted] requested that I call him from the office. b7c

At 8:50 a.m. I called the Bureau and spoke with [redacted] in the absence of [redacted] and told [redacted] that I had examined the transcript of the hearing before the C.P.A. Commissioner at San Francisco and noted that the witnesses were not sworn, but were warned by the Commissioner that they must testify truthfully, otherwise they would violate the law and also told them that they did not have to testify if they felt that anything they might say would incriminate themselves. [redacted] asked what code section the commissioner referred to and I told him that the commissioner did not state the code section, but I assume that he referred to Section 80 of Title 18, U.S. Code. I then advised that the following individuals testified on behalf of SIEGEL and his associates: [redacted] b7c

[redacted] I then referred [redacted] to Page 15 of the report of Special Agent [redacted] San Francisco, August 26, 1946, wherein there is set out information overheard by the agents in a room at the St. Francis Hotel after the hearing before the Commissioner was concluded. I pointed out to [redacted] that [redacted] questioned [redacted] as to whether or not they could commit perjury before the C.P.A. Commissioner and [redacted] reminded [redacted] of the warning given by the Commissioner and it was [redacted] opinion that even though they had not been sworn they would still be guilty of perjury.

I told [redacted] that the facts in the matter briefly are these. There is being constructed at Las Vegas a casino and restaurant. Separated from this building by 120 feet of open space a hotel building is being constructed. On March 26, 1946 the C.P.A. issued an order stopping the construction of all commercial building unless it had been started before b7c

March 26th. The casino and restaurant were started before March 26th, but there is ample evidence that the hotel building was not started until some time in April, probably April 10, 1946. I told [redacted] that SIEGEL and his associates are claiming that the hotel and the casino are all one building; that they so claimed before [redacted] the C.P.A. representative at Reno on April 29th and took the position that since they had started their construction of the casino before March 26th they were not bound by the C.P.A. orders. b7c

I advised [redacted] that this question was put to [redacted] "In your discussion with [redacted] and in your discussion concerning the erection of this building, was it at all times to be constructed as one building?" [redacted] replied: "Yes". At another point [redacted] was asked: "Do the basements go all the way around and through this entire structure?" [redacted] answered: "Yes, they do". I told [redacted] that I believe that those two statements were at variance with the true facts in the case. I pointed out that naturally we cannot make a perjury case until we conduct the necessary investigation; that we must prove intent as well as the fact that the statements were false [redacted] wanted to know if we had documentary evidence disproving those statements. I told him that we had the building permits which were issued at Las Vegas and that the building permits called for two separate buildings. Further, that we had interviewed [redacted] and he advised us that he had been hired to construct one building; namely, the casino and restaurant. With reference to [redacted] testimony, I advised [redacted] that [redacted] had given confusing answers to questions and it would require a further study of the testimony to indicate that he had made any deliberate false statements; that [redacted] was apparently very careful in the answers he gave. With reference to the testimony of [redacted] I advised [redacted] that he had testified generally along the same lines as [redacted] testified. b7c

[redacted] said that this will probably be a difficult case to prove and I agreed with him, but stated that it was my theory that [redacted] who has a good reputation at Las Vegas, would probably give us the truth of the matter and possibly assist materially in making our case. I also advised [redacted] that another C.P.A. hearing was coming up September 5th and that if the C.P.A. is able to enforce its stop order we possibly would not want to go ahead with a prosecution on the false statement theory because this might appear to be harassment; that the stop order in itself would accomplish a great deal in that it would tie up approximately \$500,000 worth of SIEGEL's funds.
