At 1:05 p.m. today Assistant Director ROSEN called with reference to our teletype earlier today concerning the C.P.A. hearing at San Francisco tomorrow. Mr. ROSEN wanted to know if I considered [redacted] trustworthy enough so that we could go to him and ask him if he planned to place the witnesses under oath at tomorrow's hearing in San Francisco and if not whether we could suggest [redacted] that witnesses be placed under oath. I told Mr. ROSEN that I felt that we could approach [redacted] on the matter. However, from my reading of the transcript of the previous hearing it appears that it is the usual practice to examine witnesses without placing them under oath but giving them a warning that any false statements are in violation of the law. I told him that I believe [redacted] would receive our inquiry in a gracious manner, but would probably tell us that he will not place the witnesses under oath because it is not the usual custom. b7c

With reference to that portion of our teletype today concerning [redacted] of the C.P.A., Mr. ROSEN said that we should not approach [redacted] to ask him to work with us in connection with any attempts to bribe him. Mr. ROSEN said that we should place SIEGEL under surveillance and I told him that we had already done that. He also said that we should locate [redacted] and place him under surveillance. However, we are not investigating [redacted] but our surveillance of [redacted] is merely to cover our surveillance of SIEGEL in order that we would be apprised in the event SIEGEL approached [redacted]. I told Mr. ROSEN that we were attempting to locate [redacted] that we had checked the hotels at Las Vegas but had not found him and the informant at Las Vegas was of the opinion that [redacted] had proceeded to Los Angeles. I advised Mr. ROSEN that we were going to see [redacted] of the C.P.A. at Los Angeles since he had requested the agents to call on him today and during the interview with [redacted] the matter of [redacted] would be brought up and possibly [redacted] can tell us where he is presently located. I told Mr. ROSEN that after we locate [redacted] we will place him under discreet surveillance. b7c

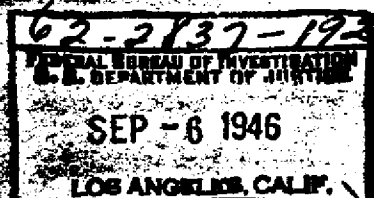

Reference is made to my letter, dated August 22, 1946, in the above-captioned case.

The following information is being brought to your attention in connection with the activities of [redacted] and his associates at the Del Mar Hotel and Track. b7c

[redacted] advised that on August 21, 1946, [redacted] an associate of BEN SIEGEL, had called [redacted] at which time [redacted] mentioned having been chased by the locals. This conversation apparently referred to the fact that [redacted] had been removed from the Del Mar Track. [redacted] inquired as to "whether it was for that thing" and [redacted] said, "No, horses." [redacted] also related that he had been the only one who had been chased from the track. With reference to "for that thing," it is believed to refer to the doping of the horses at Del Mar recently. On the same date this source also related that [redacted] had contacted one [redacted] who inquired [redacted] as to his having been taken out of the box. Apparently this refers to Del Mar. [redacted] stated that it wouldn't interfere with anything as it would be O.K. in a day or two and he could return. [redacted] informed [redacted] that it was the sheriff's office who had taken him off the track. [redacted] inquired as to whether "they want money" and [redacted] stated "No." b2 b7D b7C

Again on the same date this source reported [redacted] had called one [redacted] (phonetic) last name not known and [redacted] mentioned being chased. [redacted] stated that [redacted] was going to get it that day. This is believed to mean that [redacted] was to be chased from the track at Del Mar. [redacted] inquired as to how [redacted] would be chased and he reported that it "might not be true, but that is what a guy told me and he is close to those guys-- he is a legitimate man." [redacted] did not think there was anything to it and that he would be back in a couple of days. [redacted] mentioned that the other guy [redacted] is in "too strong with them." b7C

Indicated that [redacted] and removed [redacted] When the individual was identified as [redacted] stated, "You can straighten him out easier than you can straighten a collar out of your pocket." [redacted] then inquired as to whether [redacted] had talked to him and [redacted] said, "No," he figured the other guy was O.K. [redacted] then inquired as to whom he was speaking of and [redacted] stated [redacted] stated [redacted] is O.K." and inquired as to why he didn't straighten him out with [redacted] before. [redacted] asked, "What does it take for [redacted] replied, "Give a hell a C -- you will be giving him a lot of money." [redacted] then said [redacted] could go back and that he could talk to the guy "just like nothing" and said he thought [redacted] knew him. [redacted] said that he did not think it was necessary to fool around with him as he was "O.K. with the big guy." [redacted] indicated that these other guys "spooks" from Thoroughbred racing may have put a little heat on. According to [redacted] had told him "they have got me running my legs off, chasing people, and I am tired of it." [redacted]

With reference to [redacted] the Los Angeles Field Office files reflected one [redacted] was reported in the General Crime Survey, Los Angeles Field Division, for October 15, 1945, as being an associate of [redacted]

The same confidential source stated that on August 22, 1946 [redacted] called [redacted] at the Hotel Del Mar and stated that he had worked the track that day, but that he had been very quiet as there were "some real people" who were going to "catch me" and take me off. [redacted] stated that the boys had separated that day because they heard about the heat being on.

The Los Angeles Field Office files reflect that one [redacted] had been reported in the FBI Dress report, dated February 9, 1939, as being a friend of [redacted]

On August 22, 1946 [redacted] stated that [redacted] after talking to [redacted] had spoken to [redacted] at the Del Mar Hotel concerning the activities of the truck. On August 25, 1946 this source stated that [redacted] had called a [redacted] at the Del Mar Hotel. [redacted] During the conversation [redacted] stated that he was waiting for an O.K. before returning. [redacted] inquired as to how various individuals were making out at Del Mar and MORTON indicated that things were not going too well and that the action was "very dead here." b7C

With reference to previous information furnished to you in the referenced letter regarding [redacted] this is to advise that the confidential source reported that [redacted] was in contact with [redacted] at Los Angeles on August 23, 1946 and the conversation appeared to be in reference to the card game with [redacted] indicated that he had been with the "guy" the night before. [redacted] related that [redacted] but that he had never played with [redacted] stated that [redacted] could do "a few tricks himself." [redacted] stated that [redacted] had been playing a friend of [redacted] and this friend was losing and indicated that [redacted] was "doing tricks on my friend." It appeared from the conversation that the card game which was to take place between [redacted] never took place. b7C

Through [redacted] it appeared that [redacted] left Los Angeles on the evening of the 28th or the morning of Aug. 29th to return to Del Mar. It was thought that [redacted] would return to Del Mar with him. b2 b7D b7C

Mr. ROSEN called from the Bureau at 8:55 a.m. today and referred to the teletype from San Francisco dated September 5, 1946. He said that this teletype did not indicate whether the witnesses had been placed under oath. I referred Mr. ROSEN to my telephone call with [redacted] yesterday and He said he was familiar with that but since my phone call the C.P.A. Officials in Washington were supposed to have communicated directly with Commissioner [redacted] requesting him to place the witnesses under oath. Mr. ROSEN said that I should look over the San Francisco teletype and then communicate with San Francisco to clarify any questions that might occur to me in reading the teletype. He said he desired me to call him rather than for him to communicate directly with San Francisco. b7c

At 9:15 a.m. I spoke with Special Agent in Charge KIMBALL at the San Francisco Office and asked him to have Special Agent [redacted] call [redacted] of the C.P.A. to determine whether the witnesses had been placed under oath. Supervisor [REDACTED] of the San Francisco Office then spoke with me and gave a resume of the activities as secured over the microphone surveillance on BUGS SIEGEL's room. This was put in operation at 6:00 p.m. on September 5, 1946, and immediately after it was in operation mention was made of [REDACTED]. Also, there was mention of [REDACTED] who drew plans and I advised [REDACTED] that this was the Los Angeles Architect who drew the original plans for the casino and restaurant on the Flamingo Hotel project. There was then a discussion as to who would be the best witness on behalf of SIEGEL and his associates and mention was made of the name [REDACTED] of the Del Webb Construction Company. Some one then said: "We'll have to put on some one who can show up the expert". This was probably a reference to [REDACTED] the C.P.A. expert. Mention was then made of putting [REDACTED] on. Someone else suggested that [REDACTED] of the Del Webb Construction Company would be a good one because he is a "nice clean guy". Others in the party opposed this, stating that he would be "a hell of a witness". There was then some mention made of a letter received [REDACTED] July 1st, but this was not clarified. [REDACTED] b7c

[REDACTED] At 6:50 p.m. [REDACTED] mentioned that he thought the hearing would be favorable tomorrow. At 7:10 p.m. all of the persons in the room went to dinner. At 9:15 p.m. at least three persons returned to the room and a card game was started. [REDACTED]

[REDACTED] At 9:20 p.m. [REDACTED] believed to be [REDACTED] entered the room and joined the card game. He mentioned that he had had a very bad day. He stated that he had lost \$200,000 on the stock market in the last three days. At 10 p.m. [REDACTED] called the switchboard at the Hotel and said he was expecting a call and told the switchboard the room he was in in order that they would be certain to get the call to him. Some one then stated that they had better wait for the meeting tomorrow before talking to [REDACTED]. I told [REDACTED] that this might have been [REDACTED] referring to his brother [REDACTED] who is interested in the Flamingo Hotel project.

At 3:10 a.m. two players left the card game and used the phone in the next room but agents could not overhear the conversation. At 4:15 a.m. the card game broke up and the only additional information at this point was an individual named [REDACTED] was in the game. This might be [REDACTED] b7c

I then spoke with Special Agent [REDACTED] and he advised that Commissioner [REDACTED] had requested that [REDACTED] on the project, be called to testify. [REDACTED] advised the following telephone calls were made from Suite 1133-34 of the St. Francis Hotel: b7c

At 11 a.m. I spoke with Mr. ROSEN at the Bureau and advised him that the witnesses at the C.P.A. hearing had been placed under oath before testifying; that yesterday only Government witnesses had been heard but the respondents' witnesses would be testifying today. I also summarized for him the information concerning the activities of the individuals at the St. Francis Hotel as furnished by the San Francisco Office. I advised him that the individual mentioned in San Francisco teletype as [REDACTED] was in fact [REDACTED]. I also advised him that the identity of the individual named [REDACTED] referred to in San Francisco teletype is actually [REDACTED] who has handled criminal matters previously for SIEGEL in Los Angeles. I told Mr. ROSEN that this would indicate to me that SIEGEL is taking a prominent part in the present hearing since San Francisco indicated that [REDACTED] who was [REDACTED] attorney had not had much to say at the hearing. While speaking with Assistant Director ROSEN at the Bureau at 11:10 a.m. today, I called his attention to the San Francisco teletype of September 7, 1946 wherein mention was made that SIEGEL and his associates might have [redacted] for the Flamingo Hotel project, present their side of the case to an impartial architect, who might be selected by Commissioner [redacted]. I advised Mr. ROSEN that we learned this morning that SIEGEL was in conference with [redacted]. Mr. ROSEN asked me what [redacted] reputation was and I told him that we had not yet checked on that but we knew nothing derogatory concerning him. Mr. ROSEN asked if [redacted] had drawn up plans for the Flamingo Hotel project and I advised him that [redacted] had drawn the original plans from which [redacted] worked, but that this plan showed only a casino and restaurant and did not show a hotel building. I told Mr. ROSEN I did not know how SIEGEL expected [redacted] to be of assistance to them unless they persuaded [redacted] to prepare some phony plans.

At this time I also advised Mr. ROSEN that I had been in communication with the San Francisco Office and that they had been unable as yet to get in touch with [redacted] to determine what had occurred at the C.P.A. Hearing. I advised Mr. ROSEN that the San Francisco Office had told me that [redacted] is on sick leave today, but would possibly be at his office this afternoon and that we would have to wait until [redacted] is available before we can find out the details of the proceedings before the C.P.A. Commissioner.

Reference is made to the report of Special Agent [redacted] dated September 4, 1946 in the above entitled case. b7c

It is noted in the report of Special Agent A. E. Ostholthoff, dated August 7, 1946 at Los Angeles in this investigation, that a request is made for information concerning BENJAMIN "BUGS" SIEGEL which may be obtained from [redacted] b7D

During the investigation of Murder, Inc. by the then District Attorney [redacted] the New York Field office conducted some investigation concerning possible harboring charges growing out of the arrests made by [redacted] during this investigation. As a result of the Bureau's interest the New York office worked [redacted] b7c b7D

It does not appear, however, that any information was obtained concerning any homicides which were attributed to SIEGEL either as the actual trigger man or where he may have been a party in interest.

It is anticipated that some time in the near future the investigation of the Canza case in New York will necessitate some inquiry [redacted] In the event that such inquiry is made, an attempt will be made at that time to develop whatever information is obtainable concerning the homicides in which SIEGEL is alleged to have been implicated. b7D

Special Agent [redacted] called from Palo Alto, California, at 5:00 P.M., September 4, 1946, and advised that he had interviewed [redacted] who is to conduct the C.P.A. hearing on September 5, 1946. He said that [redacted] was cordial when he had his discussion, but on the matter of placing witnesses under oath [redacted] advised that ordinarily witnesses are not placed under oath unless this is requested by the attorneys. He said that he did not feel that he could place the witnesses under oath on September 5, 1946 since the September 5th hearing would be a continuation of the August 13th hearing at which time witnesses were not placed under oath and it would seem strange if he should on his own initiative ask that witnesses be sworn in before testifying. [redacted] suggested that we might have [redacted] do this and I told him that I would consult the Bureau on this matter before we make a request of [redacted] b7c

At 9:00 P.M. on September 4, 1946, Special Agent in Charge KIMBALL, of the San Francisco office called me and said that SIEGEL, VIRGINIA HILL, [redacted] were at the Saint Francis Hotel; that SIEGEL had reservations for six people at the Saint Francis Hotel for 1:00 P.M., September 4th, and when he had not arrived by 6:00 P.M. the hotel cancelled the reservations. SIEGEL arrived at the hotel at about 7:30 P.M. and insisted on accommodations. The management refused to take care of SIEGEL and his party until the Agents intervened and then the management agreed that they would place SIEGEL and his party in rooms at the hotel in order that the Agents would not have to surveil them around San Francisco while they sought accommodations. Mr. KIMBALL pointed out that under this arrangement we are not able to fully cover SIEGEL's activities, but the management said that if he stays over the evening of September 5, 1946 they will place SIEGEL and his party in other rooms which will permit us to ascertain their complete activities. b7c

Mr. KIMBALL likewise advised that [redacted] was staying at the Whitcomb Hotel at San Francisco, along with [redacted] that this hotel is located about two blocks from the C.P.A. headquarters at 1355 Market Street. I told [redacted] that Special Agent [redacted] of the San Francisco office had interviewed [redacted] at San Francisco yesterday (September 4, 1946) afternoon; that [redacted] said that he did not feel that he could place the witness under oath at the C.P.A. hearing on September 5, 1946 since ordinarily witnesses are not placed under oath unless the attorneys request it. Shortly thereafter BEN SIEGEL and another man with red hair, believed to be [redacted] appeared and all engaged in a conversation for approximately 20 minutes to one-half hour. [redacted] was then called to the opposite side of the street by an unknown individual. BEN SIEGEL, VIRGINIA HILL and the third party departed and were surveilled by Agents to the Mission Village Motel at 5675 ~~SW~~ Washington. It was noted here that BENJAMIN SIEGEL, VIRGINIA HILL and the third party took a table and were observed at all times. During several recent spot surveillances of MEYER LANSKY, who is considered a major subject in the Capga investigation in the New York office territory, he has been observed to spend a great deal of his time during the day at the offices of the Emby Distributing Company. Efforts are being made to determine whether LANSKY uses the offices of the Emby Distributing Company for the legitimate business that is carried on by this company in connection with the distribution of juke boxes or whether he also carries on any illegal activities in which he is suspected of being engaged at this office.

Since LANSKY is a major subject in the Capga investigation, all information concerning him will be reported in that file and copies of all reports are being designated to the Los Angeles Field office for its information.

This office will endeavor to secure further details regarding SIEGEL's departure for New York and the New York Field Office will be promptly advised.

It is requested that the New York Office make appropriate arrangements to cover SIEGEL's activities completely at such time as he arrives in New York. As SIEGEL has been in contact with MEYER LANSKY by telephone on several occasions during the past few weeks it is believed that he will be in contact with LANSKY during the time he is in New York City. Particular emphasis should be made to ascertain all details regarding financial transactions which take place in New York City during this trip. The Los Angeles Field Office is most desirous of securing all information regarding the source of SIEGEL's income and it is believed that moneys are being made available to him by unknown sources from interests in New York City.

At 9:50 a.m. on September 14, 1946 I spoke with [redacted] at the Bureau in the absence of Assistant Director ROSEN. I asked him if he had reviewed the San Francisco teletype of September 13, 1946 and he said that he was aware that the Government had lost the case before the C.P.A. Commissioner in San Francisco. I stated that the question now is whether this matter can be re-opened and [redacted] suggested that perhaps the doctrine of res adjudicata would apply, but I told him that I did not believe this since the proceedings before the Commissioner are not legal proceedings and are subject to review by the courts. I suggested, however, that this matter be discussed with the department. I pointed out that according to the VARIETY newspaper a case in Seattle had been handled by the United States Attorney to secure a court order stopping the construction of a \$100,000 theatre and [redacted] asked what the details of this were and I said that I do not know because VARIETY carried a very small article about it. [redacted] pointed out that it would probably be very difficult to establish a case at this point in view of the fact that the matter had been fully aired before a C.P.A. Commissioner. I stated that undoubtedly it would be a difficult case but that I could see no harm in at least conducting the investigation; that possible fraud in connection with the Flamingo Hotel is the only Federal violation that we have except the narcotic matter in Mexico, which is not under our jurisdiction. I said that I would like the Bureau's decision as soon as possible because the time element is important since construction of the hotel is going forward and we may find ourselves in the position of eventually going into court on this matter and having the defendants state that the hotel is practically finished so why should the government now try to stop them.

I told [redacted] that our principal purpose in desiring to go ahead with this investigation is to stop the hotel, if possible, and secondly to trace back the money which has gone into the construction of the hotel. I told [redacted] that it would be necessary to conduct an open investigation of this matter because we can no longer investigate discreetly; that we have conducted all of the discreet investigation that is possible, and the matter is now at the point where we must openly interview various individuals beginning with [redacted]. [redacted] requested that I submit a memorandum to the Bureau containing

my views on the matter and the investigation which I contemplated. I told him that I would submit such a memorandum, but would base it on the theory that we would investigate the false statement [redacted] at Reno, since the case will ultimately come back to that in any event and also since at this time I do not have the complete transcript of the hearings before the C.P.A. Commissioner, and, therefore, I am not in a position to analyze possible false statements at the hearing. I advised [redacted] that pending the Bureau's decision on this matter we would go to the C.P.A. 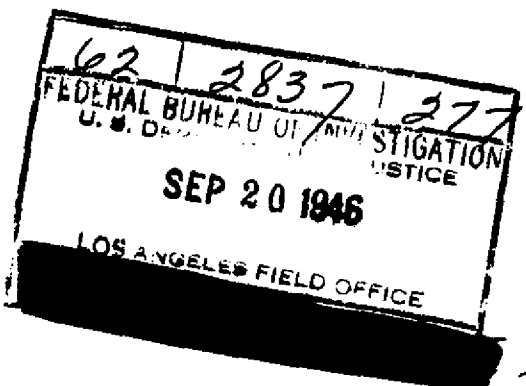

On September 17, 1946, the writer checked Local Draft Board #248, 1917 Westwood Boulevard, and examined the file of SIEGEL, their serial no. 2853, Order no. 2427-A, in his occupational questionnaire, dated August 8, 1942. He gave the duties of his present job as "Sporting Ventures--Wagering." He stated that he was self-employed and in that blank entitled "Address of Place of Work," SIEGEL put "None--continuously traveling to various sports events." Under the title of "Job for which you will be best fitted," he put down "Administrative Official" and in that blank, stating "Duties of job for which you are best fitted," he wrote in "Supervision--Personnel." As the "Job for which you are next best fitted," the subject wrote "None." He showed his education as eight years of grammar school, married, two children under eighteen years of age, and had three dependents including the above two children and supported two other people.

On March 10, 1942, SIEGEL wrote to the Board, asking permission to go to Mexico City March 13, 1942 "for about fifteen days for personal business." On March 23, 1942, SIEGEL wrote the draft board that

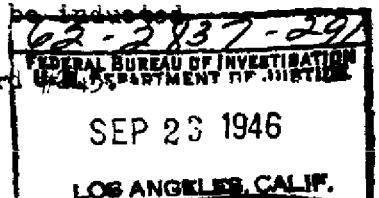
"I, BENJAMIN SIEGEL, of 250 Delfern Drive, West Los Angeles, returned to Los Angeles, Sunday, March 22nd, from Mexico City."

The Board sent the subject an order to report for pre-induction physical examination on February 5, 1944, ordering him to report at Westwood and Santa Monica Boulevards at 7:00 A.M., February 15, 1944. On March 10, 1944, a letter was directed to the State Director of Selective Service in the Plaza Building, Sacramento 14, stating as follows:

"Above-named registrant was sent an order to report for pre-induction physical examination on February 15, 1944. At the time that it was sent he was in New York and he did not receive it in time to take the examination.

"Registrant became 38 on the 28th day of February, 1944. In view of the fact that he was not yet 38 when he was classified I-A and also that he is employed as an investment broker, the Board respectfully requests that a waiver of the age limit be granted in his case in order that he may be sent an order to report for pre-induction physical examination and be inducted into the Armed Forces."

"We acknowledge receipt of your letter of March 10th, requesting waiver for induction of the above-named registrant.

"We have been advised by the National Headquarters that unless the Local Board is of the opinion that a registrant deliberately fails to report for induction, we should not request waiver for a man who has reached his 38th birthday.

"If the Local Board is of the opinion that the registrant had a plausible reason for not having received his order to report for induction, it should not request waiver for induction as it would not be considered a flagrant case.

"If, on the other hand, the Local Board is of the opinion that the registrant has intended to evade service pending his 38th birthday, then the Local Board may request waiver."

A letter from BENJAMIN SIEGEL, dated July 29, 1944 was in the file changing his address from 250 Delfern Drive to 721 North Doheny Drive. On his Selective Service Questionnaire, dated September 15, 1941, SIEGEL showed his occupation as "Betting Commissioner" and his duties "Receive and make wagers in connection with sporting events and the like." He showed his annual average income as \$50,000; stated that he was married at New York City January 7, 1928. His dependents were listed as the following:

had assisted the registrant because "hand hurt."

Registrant's affidavit, dated February 20, 1943, in that section under "Marital Information," set forth that he was married at 332 Rogers Ave., Brooklyn, New York. SIEGEL in addition said that he had earned \$40,000 in the past twelve months and showed as his dependents, MAX and JENNIE SIEGEL and [REDACTED] b7c He stated that he began contributing to the support of MAX and JENNIE in 1929 and to [REDACTED] in 1933. During the past twelve months, [REDACTED] received \$1,000 other income in addition to \$1200.00 from SIEGEL and his mother and father split \$2500.00 He gave the following relatives.

In that part of the affidavit having to do with the registrant's job, he gave the following "Investments and Promotions. I investigate deals such as hotel purchases, sporting event promotions and other enterprises and consummate deals." As to the specific nature of his duties, the following was noted, "I do the following kind of work: 'In consummating deals stated above, I usually obtain an interest in return for my work. I am required to make trips to appraise and investigate all matters connected with such enterprises and to negotiate terms.'" His average earnings were shown to be \$50,000 a year. This form was likewise filled out by N. JOSEPH ROSS.

A second registrant's affidavit, dated October 28, 1933 revealed that \$3500.00 was contributed to his mother and father and \$1,000 to [REDACTED] b7c who earned from outside sources \$1200.00 during the year. [REDACTED]

In the occupational section the subject stated, "Investment Broker" and also, "I consider various propositions concerning investments in enterprises and if satisfactory enter into such deals." Again his average yearly earnings were shown to be \$50,000 and likewise this form was filled out by N. JOSEPH ROSS.

On September 16 and 17, 1946, the writer contacted [redacted] Postmaster, Beverly Hills, California Post Office, concerning SIEGEL and the general hoodlum situation. [redacted] said that in his opinion the Nick Lutze Garage in Beverly Hills is a hang-out for hoodlums. [redacted] b7c

[redacted] but was refused by the civic administration in Beverly Hills. Allegedly, this refusal was occasioned by the fact that many hoodlums hang out in this garage and are acquainted [redacted] and apparently some persons thought that cars for rent might provide an easy means of transportation during the hold ups and murders. X

In discussing the local picture, the informant went on to say that in his opinion [redacted]

[redacted] stated that the best way to catch up with SIEGEL and other bigtime hoodlums would be to have a man working in [redacted] office, this man either being an FBI Agent or person giving information. He is positive that [redacted] cannot remain out of jail very long because of the manner in which he is operating and went on to say that someone planted in his office would soon show the tie-up between law enforcement and hoodlums in this area. Also, he gave as example of a "smart politician" [redacted] who according to his own statement spent in excess of \$40,000 in the recent political campaign. The informant said that if this were true that he is of the opinion that [redacted] probably spent \$142,000 because over the years he has done favors for many people and this is the first chance these persons would have had to return these favors. In other words, those individuals whom [redacted] has befriended politically in the past would now contribute funds ostensibly for campaign purposes, a portion of which LYONS could and is expected to pocket. b7c

Discussing the situation in Beverly Hills, [redacted] said that the town is full of hoodlums and that he considers the present Chief of Police a joke. He went on to say that "If I were a hoodlum, I would want him to stay in office." Because he is of the opinion that the Chief being the type he is, hoodlums have nothing to worry about as long as he remains in office. Inference was gained here that [redacted] was not dishonest, but he was not too bright. b7c

[redacted] was a friend [redacted] since childhood and he went on to say that in his opinion BENJAMIN SIEGEL is attempting to set up a new wire service in competition to that owned by [redacted] interests. The mob's power in Chicago makes itself felt through the [redacted] machine. [redacted] is a contact of theirs as is [redacted] in Washington, D.C. b7c

In the course of the conversation, [redacted] said confidentially that in the event information concerning the situation in Nevada is desired that Agents in Reno might find it well to contact [redacted] "The Swede Postmaster in Reno.... He knows what's going on and is a pretty square fellow. He would work along with you."

I advised NULTY that we were going to conduct an open investigation concerning possible Fraud Against the Government in connection with the construction of the Flamingo Hotel on September 30, 1946 and advised NULTY of the individuals who would be interviewed at Las Vegas and told him that additional Agents would be sent from Los Angeles to assist the regular Agents at Las Vegas in these interviews.

Mr. NULTY stated that the purpose of his call was to discuss the situation [redacted] but that this open investigation would probably take care of that situation. I told Mr. NULTY that I was not in favor of the Agents going to [redacted]

[redacted] that after this open investigation is completed and we continue with our investigation of SIEGEL's activities generally that Special Agents [redacted] can then make their usual calls [redacted]
