Reference is made to your report of July 13, 1946, in the above-captioned matter and Bureau teletype of July 23, 1946. In addition to obtaining further information from [redacted]

It is also desired that you obtain detailed information from him concerning the operation [redacted] referred to in your report of July 13, 1946.

Your attention is also called to the third last paragraph, page two, referenced report, which discusses the ownership of the Del Mar Race Track. The Bureau would appreciate your clarifying the facts of ownership of this race track. Your attention is also called to Los Angeles letter to the Bureau of July 3, 1946, entitled, "Bookmaking Activities, Los Angeles Field Division in which it is indicated that [redacted] as well as Benjamin "Bugs" Siegal was rumored to have furnished the money for the purchase of the Del Mar Race Track, it being noted that [redacted] was not mentioned therein as a purchaser.

It is suggested that in the future when confidential informants are interviewed an attempt to make such interviews more detailed be made in order that Assistant Director E. J. Connelley at Chicago and the Bureau will be in a better position to evaluate the stories related.

The Chicago Division is requested to furnish the Bureau with any information it might have available relative to the so-called [redacted]

Los Angeles has further informed that [REDACTED] was indicted by Federal Grand Jury in Los Angeles, March 6, last, together with 34 other individuals in a nationwide narcotic conspiracy case. In connection with the investigation concerning the reported irregularities dealing with the construction of the Flamingo Hotel at Las Vegas, including apparent irregularities of officials of the CPA Administration, [REDACTED] advised that Siegel received a telegram from CPA in Washington ordering further construction of the Flamingo Hotel be stopped and further that Siegel did not pay a bribe to secure a permit for the construction, although construction had been temporarily halted in April, 1946 but subsequently permitted to proceed. Siegel [REDACTED] intends to have [REDACTED] the contractor for the Flamingo Hotel, get in touch with [REDACTED] concerning the telegram from the CPA.

On August 5, 1946, I received a telephone call from Assistant SAC A. K. OSTHOLTHOFF, who is presently on special assignment at the Los Angeles Field Division, in connection with the above-entitled matters. Mr. OSTHOLTHOFF advised me that [redacted] Los Angeles, who is alleged to be BENJAMIN SIEGEL's associate, would be at the Del Mar Hotel, Del Mar, California, during the current racing meet at the Del Mar Turf Club, Del Mar, California. Mr. OSTHOLTHOFF also advised me that [redacted] has been under technical surveillance at Los Angeles and he was anxious that a survey be made looking toward the possibility of establishing like coverage [redacted] while he is at the Del Mar Hotel.

Reference should be made to the report of Special Agent [redacted] dated July 13, 1946, at Los Angeles, California, in the CAPGA matter.

After [redacted] registration at the Del Mar Hotel has been verified a very discreet investigation was commenced which revealed that [redacted] had been assigned a room on the third floor of the hotel on the opening day of the meet, August 6, 1946. [redacted]

[redacted] enjoys a wide acquaintance among all of those connected with the track and the hotel and is known to be highly reliable. His identity, as a source of information, of course should not be revealed in this case inasmuch as he enjoys the confidence of a large number of bookies, hoodlums, and track hangers-on who frequent Del Mar. Through [redacted] who is well acquainted with [redacted] it was learned that [redacted] did not like the room assigned to him and demanded to be moved to one of the nice cottages at the rear of the hotel grounds. A loose surveillance has been maintained [redacted] his arrival at Del Mar. The surveillance has been facilitated because of the crowded condition of the hotel and track and surrounding area. It appears that [redacted] is well known to the great majority of the guests and to the occupying boxes at the clubhouse at the track. Preliminary information indicated that a large number of hoodlums and racketeers from Los Angeles and Chicago would be in attendance at the race meet and would stay at the Del Mar Hotel, [redacted] which condition is discussed more fully below. A rather close observation of [redacted] on each day of the meet so far has not revealed this type of activity. The reliability of the track sources in this matter is questioned. [redacted] spends considerable time reviewing his form sheets and in conversation with those in attendance at the track and during the races remains in his box betting on every race. It is known that he has won a considerable amount of money, coming in with at least two good long shots. Therefore, the coverage [redacted] as of this date only indicates that he is here as a betting gambler and is not operating a book. It is also known that two or three San Diego bookmakers are operating in a limited capacity at the track without hindrance.

July 13, 1946, at Los Angeles, entitled, "CAPGA", that a confidential informant had advised the Los Angeles Office that the Del Mar Turf Club is actually owned by BENJAMIN SIEGEL. After many conversations [redacted] I am inclined to doubt very seriously that the information is correct. Upon the spreading of unverified rumors that members of some Eastern and Los Angeles mobs were moving into the Del Mar meet "to make a killing" it was speculated that this would be a crooked meet in that there would be a number of fixed races. Of course this is a matter very difficult to determine. [redacted]

[redacted] has advised that he has some very good sources among the jockeys, owners and trainers at Del Mar and that he does not believe that there will be any unusual number of fixed races. [redacted] specified, however, that even with all of the new mechanical and other safeguards to insure honest races it actually is easy to fix a race and that the same may occur. He confidentially advised that he possesses the identities of at least three jockeys and one or two owners or trainers who are very likely to attempt to fix some races as the meet progresses. [redacted] furnished this information to Special Agent [redacted] of this office with the definite reservation that the same not be repeated to anyone under any circumstances. [redacted] did not desire to reveal these identities at this time and of course it is impossible to know at this time whether any of the outside racketeers can get to these particular individuals. In this connection you will recall that I have stated in this letter that SIEGEL, RAFT and their associates enjoyed considerable betting success during the first two days of the meet, however, no allegations were made that any of those races were fixed.

With reference to the request of ASAC OSTHOLTHOFF that it be determined whether a technical surveillance [redacted] would be feasible at the Del Mar Hotel, I advised Mr. OSTHOLTHOFF at the time of his call that [redacted]

It is also noted that, as I mentioned in my memorandum of August 1, 1946, captioned, "DEL MAR TURF CLUB - CRIME SURVEY, SAN DIEGO FIELD DIVISION", [redacted] was also the purchaser of the #1 Rancho Vegas at Las Vegas, Nevada, a gambling house in which BENJAMIN SIEGEL may have an interest.

ASAC Ostholthoff, on special assignment in Los Angeles, telephonically contacted the Bureau with reference to information furnished by the San Francisco Division indicating that Benjamin "Bugs" Siegel has been in communication with [redacted] relative to the CPA stop order issued regarding the Flamingo Hotel at Las Vegas. Siegel asked [redacted] to get to [redacted]. It appears that reference is made to [redacted] before whom a hearing is to be held regarding the Flamingo Hotel Tuesday, August 13, at San Francisco. San Francisco has indicated the possibilities of developing a bribery violation in this case and Ostholthoff inquired whether the Bureau had any information on [redacted]. He was advised that the Bureau had not even been informed of [redacted] first name to date. Ostholthoff then suggested that the most desirable procedure was to instruct San Francisco to ascertain in a highly discreet manner background information on the reputation, character, etc. of [redacted]. If San Francisco checked this matter out and found him to be a high class, reliable individual then consideration should be given by San Francisco to approaching him in order that sufficient information might be furnished in order to develop a bribery case in this connection.

Ostholthoff was advised that the Bureau had no objection to checking the background [redacted] and he indicated that he would immediately communicate with San Francisco relative to this matter. It was also mentioned to Ostholthoff in connection with Siegel's contemplated trip to San Francisco that appropriate arrangements should be made to thoroughly cover Siegel's activities while in San Francisco, it being noted that blanket coverage had previously been authorized regarding Siegel's activities.

### RECOMMENDATION

None. San Francisco and Los Angeles have been instructed to keep the Bureau advised of every development in this matter.

Reference is made to my communication to the Director dated August 8, 1946, entitled as above, in which I set out the general results of the investigation being conducted at the Del Mar Turf Club Track and the Del Mar Hotel at Del Mar, California, as of that date.

Siegel continues under his usual modus operandi, i.e., he now has a rest room in a cottage, No. 236, at the Del Mar Hotel, in a rather secluded section of the grounds. This room is on the second floor of the cottage, which location renders a close-up coverage of the room and any occupants rather difficult. Siegel continues to visit the Club House and Jockey Club for all races and plays the \$50 window exclusively.

carrying a Jockey Club Admittance Book in the name of the managing agent of the film star [redacted] He was asked to leave the Club House at that time, which he cheerfully did. He immediately returned to the Del Mar Hotel and was inactive the balance of that day.

On the following day, August 8, 1946 [redacted] was back in the Jockey Club occupying the box of [redacted]

On August 9, 1946, [redacted] did not appear at the Track and at the Hotel it was ascertained through [redacted] mentioned in my previous letter, that [redacted] had gone to Los Angeles, but was expected back on August 10, 1946.

He was found to be occupying [redacted] box again on August 10, 1946, and was approached by [redacted] at which time he was able to prove that he was a registered guest [redacted] However, it was noted that [redacted] left the Track and returned to the Hotel shortly before the last race.

In this connection you will recall that I mentioned in letter of reference that [redacted] had stated confidentially that he suspected two or three jockeys would be very likely to attempt to fix some races as the Meet progresses.

Mr. Ostholthoff, Los Angeles, telephonically advised at this time that in accordance with Bureau instructions about ten days ago to go ahead with an open investigation of the construction of the Flamingo Hotel and any possible irregularities on the part of CPA personnel, that he plans to start this next Monday in this connection. Mr. Ostholthoff plans to go to San Francisco Monday and have Agents go to Reno at that time to talk to [redacted] and he is also having Agents in Los Angeles go into CPA records there, at the same time. He stated he wanted to be sure before he goes ahead that they would have the backing of the CPA in Washington in getting the records.

The observation was made by Ostholthoff that it appears the CPA hearing may have been a cover-up as they obviously did not present much of a case. [redacted] CPA investigator, had stated before the hearing that they had an open and shut case. [redacted] had also stated he had the blue prints which showed that there were two separate buildings and they should have constructed only one. Mr. Ostholthoff stated he did not know whether the blue prints were introduced at the hearing. It was also pointed out by Ostholthoff that a possible perjury may develop in view of the agreement which was made in [redacted] room that the Webb Construction would testify they were working from the January plan rather than the March plan. Ostholthoff stated the San Francisco office was using a contact microphone when this information was obtained. Ostholthoff said they will obtain a transcript of the hearing. [redacted] advised after the hearing in strict confidence that Senator Pat McCarran was in San Francisco the day of the hearing in case he was needed by the Flamingo people. The Government has until September 5, 1946, to present additional evidence to [redacted]

Mr. Ostholtzoff telephonically furnished the following information at this time from San Francisco. Ostholtzoff stated he talked with [redacted] of the Compliance Section of CPA, and [redacted] who presented the matter before the Commissioner. They refused to allow Ostholtzoff to look at their files and would not give him the name of the reporter who is recording the hearings, the theory being that this is still an open matter with them and they cannot let any other Government agency look at any of their files while the matter is pending. Mr. Ostholtzoff stated that he asked [redacted] if the respondents, the builders, could have transcripts of the hearings. [redacted] replied that they could, if they paid the fee.

[redacted] said there are some things off-the-record he wanted to go over with the Commissioner and urged Ostholtzoff not to do anything until September 5 when there will be additional hearings.

Mr. Ostholtzoff also talked with [redacted] for the CPA, today, and he again stated he had no control over [redacted] Ostholtzoff stated that [redacted] man in Reno made the information there available to our Agent, in connection with the plans for the construction of the Flamingo Hotel.

The Commissioner ruled that the Government did not present a case sufficient to justify the stop order, and, therefore, the construction of the building could continue. The Commissioner said he will give the Government until September 5 to present some new evidence to justify the stop order.

Ostholtzoff said that he can go ahead without the file, although it would be much easier with it. Ostholtzoff will take no further action regarding getting this material from [redacted] until he hears from the Bureau.

Ostholtzoff was directed to prepare a memorandum outlining just what the situation is and forward it to the Bureau AMSD for my attention. It was pointed out that the Bureau probably will go over to CPA, and if we cannot handle it directly we will probably handle it through the offices of the Attorney General. I told Ostholtzoff he would be advised as to what action the Bureau takes in this regard. I also pointed out to Ostholtzoff that in making these open inquiries he must be sure that they are confined to matters within the Bureau's investigative jurisdiction and not reveal our interest in any particular individuals.

Mr. Ostholthoff telephonically furnished the following information at this time from San Francisco. He stated that he and another Agent had gone to the CPA headquarters at San Francisco and talked with [redacted] for the CPA, and explained they wanted to look into the construction of the Flamingo Hotel. [redacted] was quite cooperative and he contacted the CPA man at Reno and told him to give our Agent anything he wanted.

However, Mr. Ostholthoff stated that [redacted] of the Compliance Section of CPA, is not answerable to [redacted] but directly under their Washington office, and when Ostholthoff asked him to go over the file on the Flamingo Hotel, [redacted] refused. [redacted] stated they had until September 5 to present more evidence to the commissioner and he said the Bureau investigation would probably interfere with their investigation. Ostholthoff asked [redacted] if they intended to conduct some investigation and [redacted] stated he did not know what they were going to do, that they were going to have a conference with the legal staff and go into the matter and for Ostholthoff to come back tomorrow. Ostholthoff stated he asked [redacted] the name of the court reporter who took the testimony of the hearing and [redacted] said he did not think he should give that to him. [redacted] said he did not think he should give us a transcript of the testimony until such time as he is finished with his investigation. Mr. Ostholthoff stated that [redacted] superior in Washington and he wanted to know if the Bureau desired to contact him. He stated he wanted to advise the Bureau regarding [redacted] as he did not know whether he intended to contact their Washington office.

**ACTION TAKEN:** I told Mr. Ostholthoff to make a formal request of [redacted] tomorrow for the material desired, pointing out that we do not feel justified in having two investigations running concurrent and that we are going ahead with ours, and that we certainly feel it is the duty of Government agencies to cooperate.

From 11:40 P.M., August 20, 1946, to 1:50 A.M., a conference, which was covered by Agents, was held in Ben Siegel's hotel room at Las Vegas which was attended by Siegel, [REDACTED]

[REDACTED] commented upon the fact that he and [REDACTED] were having considerable difficulty in arranging for a loan for further construction of the Flamingo Hotel from the Los Angeles banks. [REDACTED] is reported to have been told by a friend of his, unidentified, who is an executive in the Bank of America, that the reason the banks were unwilling to consider a loan was because Siegel was being investigated by the FBI. [REDACTED] told [REDACTED] that he had communicated with the Los Angeles FBI Office and had learned that the Bureau was investigating the case for two reasons: (1) to determine if any bribe was paid in connection with the construction of the Flamingo Hotel and (2) to ascertain the sources of Ben Siegel's money. Mr. Ostholthoff stated that no call was made to any person in the Los Angeles Division and he is of the opinion that [REDACTED] had made no call and was merely guessing as to the reasons why the FBI might be investigating this matter. *b7*

[REDACTED] suggested to Siegel that [REDACTED] thought it would be a good idea for Siegel to go to the office of the FBI and ask why they were investigating him. Siegel stated that if the FBI wanted to talk to him they could come and see him. [REDACTED] pointed out to Siegel that the FBI would never come to see him and it might be to his interest to find out what the matter was about. Siegel then indicated he would consider it. *b*

POLITICAL CONNECTIONS

Siegel stated that he had made a \$500 contribution to the campaign fund for [REDACTED] on August 20, 1946, and that he was not concerned with Senator McCarran because he was already cooperative. Siegel indicated he might attempt to obtain a RFC loan in connection with the construction of the Flamingo Hotel. [REDACTED] suggested to Siegel that when he next saw Senator McCarran he should caution Senator McCarran "to play cozy" in the event Senator McCarran was questioned by the FBI concerning their activities. *U*

NEW CONSTRUCTION FLAMINGO HOTEL

Mr. Ostholthoff advises that the pointed issue with the CPA in the construction of the Flamingo Hotel is whether or not there is more than one building. It would appear that there are actually three buildings: (1) the Casino, (2) the hotel itself, and (3) a building for stores in connection with the hotel. Siegel and his associates maintain that the same constitutes merely one building and they have planned connecting all three buildings by walls and roofs at an expenditure of \$15,000 so that there can be no question as to the fact they constitute one building. At the same time they are planning to erect a high fence around the project so that no one will be able to observe the construction from the street.

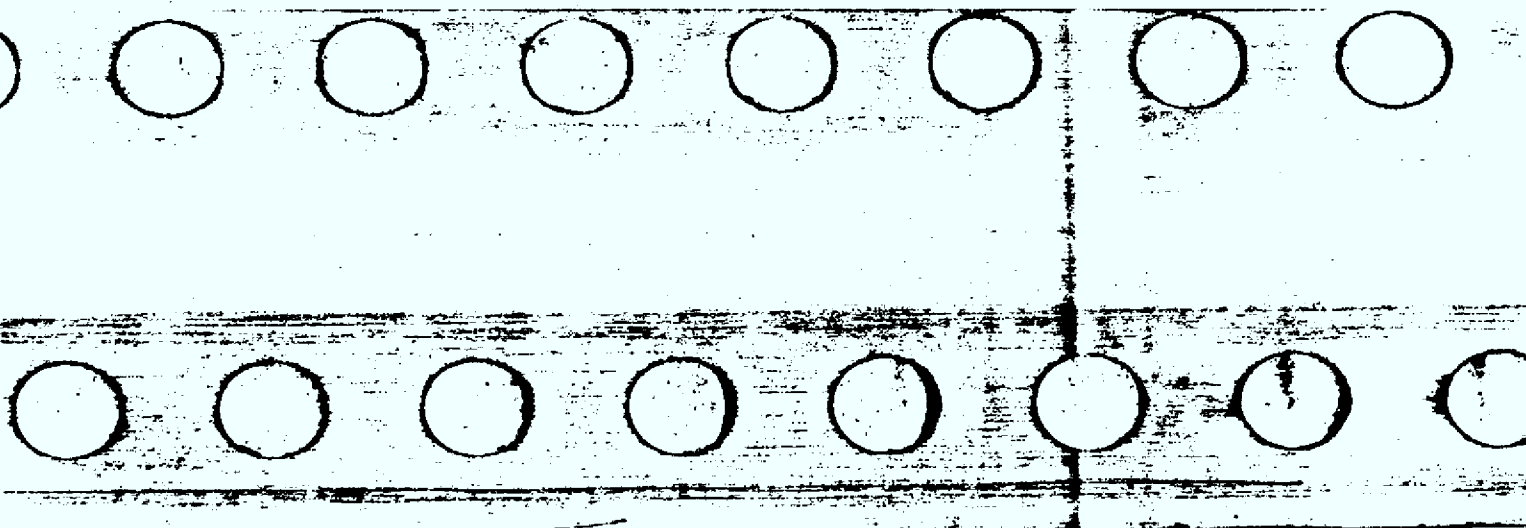

This is to advise that on July 22, 1946 a news article appeared in the LOS ANGELES EXAMINER under the caption "Sleuths Scrutinize Gin Rummy Game", in which was reported that the cards of a \$3,000,000 swindle "were laid on the table of Hollywood film colony yesterday". Listed among the victims were Colonel LEON MANDEL, Chicago Department Store magnate, who was reportedly taken for \$115,000 which was settled for \$95,000; SAM GOLDWYN, the Producer, was reportedly another big loser to the amount of \$40,000. The article indicated that Detectives MICHAEL MAC DOUGALL, exposé extraordinary of the card sharks and RAY SHINDLER, a New York Private Operative, were said to have been employed by MANDEL and two ranking Hollywood producers to investigate.

With reference to the above-mentioned article, the following information has been brought to the attention of this office in connection with the investigation being conducted with regard to subject SIEGEL. On August 4, 1946, it was reported by [redacted] that [redacted] had contacted [redacted] at which time there was a general discussion of propositions available in Las Vegas. [redacted] indicated he had a friend who was a lawyer in New York by the name of [redacted] (phonetic), who desired to place some money in a proposition. A discussion was had with regard to the new Hotel Flamingo at Las Vegas.

Further, [redacted] advised the fellows involved were [redacted] and [redacted] also indicated there was nothing to the story, that it was just newspaper talk. He related that [redacted] had beaten MANDEL in the amount of \$115,000, but had never collected a "nickel". [redacted] related that "they", undoubtedly meaning [redacted] were "moving around here among the good set".

On August 9, 1946, [redacted] reported that [redacted] had contacted BEN SIEGEL, at which time SIEGEL discussed at some length numerous difficulties that he was having with the C.P.A. with regard to the building of the new Flamingo Hotel at Las Vegas. [redacted] indicated that he had spoken to [redacted]

and he wanted to talk to [redacted] on the same thing as he had discussed with [redacted] indicated that [redacted] name was "tangled" up in the same matter and that the information had come [redacted] connecting [redacted] name with [redacted] undoubtedly [redacted] SIEGEL indicated that [redacted] was away and that undoubtedly he (SIEGEL) could give any information [redacted] desired. [redacted] related that the people who were hiring him had said that [redacted] was a buddy of [redacted] SIEGEL stated that [redacted] had not seen [redacted] in a year and one-half and that he has not talked to him more than five times in his whole life. SIEGEL stated: "You can put that in your report". [redacted] indicated he desired information on [redacted] background; however, SIEGEL indicated that [redacted] did not know [redacted] or "any one of them". SIEGEL stated: "You can say that you interviewed him in your report". This conversation was closed when SIEGEL stated that if "there is something I hear or that you want to know, just give me a call". The same confidential source as mentioned above indicates that SIEGEL, [redacted] and [redacted] had been in contact with each other on several occasions.

With reference to the name of [redacted] previously mentioned, the Los Angeles Field Office files indicate that [redacted]

Regarding [redacted] the Los Angeles Field Office files reflect that on August 13, 1946, [redacted] Los Angeles, advised that [redacted] is an associate of SIEGEL and GEORGE RAFT. [redacted]

Further, a letter from the Chicago Field Office dated August 12, 1946 in the CAPGA Case advised that [redacted] and other prominent members of the Chicago gambling syndicate meet frequently. [redacted]

Regarding the identity of [redacted] the Los Angeles Files reflect a case entitled [redacted] The Bureau was advised as to the inquiries made at Los Angeles in the report of Special Agent [redacted]

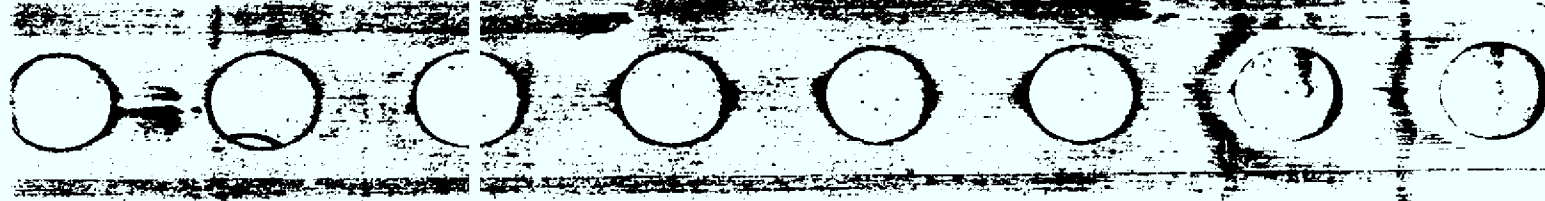

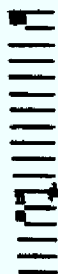

This memo will confirm the telephone conversations between the writer and Assistant Director ROSEN on August 19 and August 20, 1946.

Special Agent [redacted] of the San Francisco Office and myself on August 19, 1946, interviewed [redacted] of the Civilian Production Administration, 1355 Market Street, San Francisco, California. [redacted] was advised that we were interested in going over the files of the CPA in connection with the construction of the Flamingo Hotel at Las Vegas, Nevada; that we had information that there was possibly fraud against the Government involved in connection with the original permission granted to the builders of the Flamingo Hotel. [redacted] stated that he was not fully acquainted with the facts in the matter but that [redacted] for CPA, would have the complete file on this matter. [redacted] explained that he does not control the activities of [redacted] but that [redacted] reports directly to [redacted] of the Compliance Division of the CPA at Washington, D. C.

DEFERRED RECORDING

[redacted] came to the office of [redacted] at which time we requested that he permit us to review the file on the Flamingo Hotel, [redacted] he stated that he could not do this in view of the fact that an investigation was pending with regard to this matter. He advised that he did not know what further investigation would be conducted by the CPA and stated he was to have a conference with the legal staff of the CPA on August 19, 1946, and requested that we return on August 20, 1946.

On August 20, 1946, a conference was held at the office of [redacted] at which were present [redacted]

[redacted] and Special Agent [redacted] and the writer. At this time we again requested [redacted] to go over the entire matter with us, and they advised that they would not let us see the files nor would they discuss fully the facts developed by CPA in their investigation nor would they furnish us the facts brought out at the hearing before [redacted] by both the Government and the respondents. We also formally requested the name of the reporting firm preparing the transcript of the hearing held before [redacted] [redacted] said that he would not furnish that to us. At this point [redacted] stated that after the transcript is prepared by the reporter he desired to go

over the transcript with [redacted] in view of the fact that there were some matters in the transcript which were off the record. While [redacted] did not state he intended to change the record, the inference was there. b7c

It was pointed out to both [redacted] that the FBI had jurisdiction to investigate fraud against the Government cases and that was the reason for our request for information. [redacted] requested that we defer any investigation until after September 5, 1946, and stated that in the meantime the CPA plans to conduct investigation which they hoped will result in [redacted] ruling in favor of the CPA. He said that any investigation by the FBI would interfere with the CPA case. He was asked how an FBI investigation would interfere, and he stated that he did not know. b7c

Both [redacted] were pressed repeatedly for information concerning this matter, and [redacted] finally dismissed all questions by stating that he would not furnish us any information unless he were instructed to do so by his superiors in Washington. b7c

PURPOSE

To advise you that in connection with investigation being conducted concerning a possible Fraud Against the Government violation angle by Siegel in the construction of the Flamingo Hotel in Las Vegas, Nevada, difficulty was encountered by Agents making inquiries of [REDACTED] for the Civilian Production Administration and [REDACTED] IOF CPA. [REDACTED] would not cooperate with the Bureau and refused to allow Agents to examine the CPA files and further they would not furnish any facts brought out in a hearing held on August 13 unless they were instructed to do so by [REDACTED] of the CPA in Washington, D.C. [REDACTED] has advised that the regulations of the CPA specifically prohibit field offices of CPA to furnish information to other agencies. *b7c*

BACKGROUND

On the basis that the construction of the Flamingo Hotel in Las Vegas, Nevada, is being built in violation of a freeze order issued by the CPA in March of 1946, a possible Fraud Against the Government violation investigation was instituted against Benjamin Siegel. Information along this line was originally furnished by [REDACTED] of Los Angeles that the construction of the Flamingo Hotel has not progressed further than "a few stakes being driven in the ground" when the freeze order regulating all commercial building under CPA went into effect. The freeze order of the CPA went into effect on March 26, 1946. *b7c*

[REDACTED] further reported that when the order came through the construction had not progressed far enough to qualify for the granting of a permit for its continuance. [REDACTED] further informed that it was rumored that through [REDACTED] funds were made available to Senator Pat McCarran of Nevada and shortly thereafter construction was authorized. [REDACTED] further reported that after construction continued, the records of the construction company were falsified to show that the construction had progressed to a greater extent than it had as of March 26, 1946 when the freeze order became effective. *b7c*

An editorial appeared in the Las Vegas Tribune, a weekly newspaper, on August 1, 1946 complaining of the fact that the Federal authorities were permitting the construction of the Flamingo Hotel while the veterans were homeless due to a shortage of building material.

Siegel and his associates in connection with the construction of the Flamingo Hotel at Las Vegas. This stop order was dated August 7, 1946. At the time the stop order was issued the attorney for Siegel in Las Vegas, Nevada, [REDACTED] requested the regional office of the CPA in San Francisco to allow the construction of the building to be continued pending the outcome of the hearing, which was scheduled within a week. The request [REDACTED] was complied with. b7c

#### BUILDING PLAN

[REDACTED] of the CPA, upon being contacted by Agents informed that the CPA regulations specifically prohibited a person in the field from giving information to other agencies. [REDACTED] off the record, showed a diagram of the Flamingo Hotel, which comprised the Casino, the kitchen and the dining room surrounded by a 200-room hotel, a series of stores and a series of cottages which would complete the layout. [REDACTED] advised that Building No. 1, which comprised the Casino, kitchen and dining room, was actually under construction prior to the original CPA freeze order issued on March 26, 1946. However, none of the other buildings were under construction nor were there any connecting tunnels or conduits indicating that they were a part of the structure under progress. According to [REDACTED] relative buildings under construction, such as these wherein separate and distinct buildings were being built, the CPA has always refused to permit any further building except the ones actually under construction prior to the freeze order. [REDACTED] pointed out to the Agents that based on previous CPA decisions in similar cases he did not see how it would be possible for the CPA to give the Flamingo Hotel permission to continue with its construction. He stated that the CPA had an "open and shut case against Siegel". b7c

#### EVIDENCE PRESENTED AT HEARING

At the hearing held on August 13, 1946, before [REDACTED] who was appointed to hear the matter, he has advised that the architects for the Flamingo Hotel presented a plan dated January 12 and contended that this was the plan followed in the construction of the Flamingo Hotel. [REDACTED] pointed out at the hearing that this plan lacked details such as elevation and he, therefore, questioned whether they could proceed with the building, using only the plans of January 12. The contractors for Siegel further produced a letter directed to the CPA dated April 17, 1946, in response to a wire from the CPA dated April 16, which stated that they must stop construction if the construction was in violation of the freeze order. The respondents produced a letter to the effect that they were proceeding on the plan of January 12 and as the building was started before March 26 they were not violating any freeze order. [REDACTED] advised that the CPA failed to present any proof that the respondents were violating any order issued by the CPA, and from the facts presented he decided in favor of the respondents. b7c

#### ATTEMPTS TO SECURE INFORMATION OF [REDACTED]

Mr. Ostholthoff has advised that he personally talked with [REDACTED] of the CPA, and [REDACTED] who presented the matter before the commissioner on August 13. Mr. Ostholthoff b7c

has informed that these two individuals have refused to allow the Bureau to look at their files and would not give him the name of the reporter who recorded the hearings, the theory of [redacted] being that this is still an open matter with the CPA and they cannot let any other Government agency look at any of their files while the matter is pending. [redacted] had advised Mr. Ostholtzoff that there was some off-the-record things he wanted to discuss with the commissioner, and he urged Mr. Ostholtzoff not to do anything until September 5 when there will be an additional hearing. Mr. Ostholtzoff again on August 20 had a conference with [redacted] and made a further request to examine the files of the CPA and was again denied the information in the files of the CPA together with the transcript of the hearing held before [redacted]. Mr. Ostholtzoff pointed out to both [redacted] that the FBI has jurisdiction to investigate Fraud Against the Government cases and that was the reason for our request for information. [redacted] requested that the FBI defer any investigation until after the hearing held on September 5, 1946. [redacted] further stated that any investigation by the FBI would interfere with the CPA case. However, when questioned as to why any investigation conducted by the FBI would interfere with the CPA investigation, [redacted] stated he did not know.

Reference is made to the memorandum from Supervisor [redacted] to Mr. Rosen dated August 26, 1946, concerning the Flamingo Hotel in Las Vegas, Nevada, which Siegel and his associates are attempting to construct. Pursuant to the Director's desires on Saturday evening, August 24, I spoke to [redacted] a personal friend of mine [redacted] of the Civilian Production Administration. I told [redacted] briefly that certain individuals including Siegel had been attempting to obtain clearance to build this hotel near Las Vegas which it was my understanding was to be utilized as a gambling casino. I stated that a hearing had been held in San Francisco on August 13 relative to the freeze order which had been issued by the CPA and another hearing was coming up on September 5, at which it would be determined whether further construction would be permitted. I told [redacted] that he might want to personally check into this matter since it was potentially dangerous from the standpoint of public criticism and criticism from veterans organizations should such construction continue. [redacted] was very appreciative of my calling this to his attention, stating that he was familiar with it and that certainly if possible he would want to stop construction of this type.

I further told [redacted] that the Bureau was interested in this matter from a possible fraud against the Government violation angle. I stated that [redacted] for the CPA covering that area, had refused to furnish us with a transcription of the August 13 hearing and had even refused to furnish us the name of the reporter who took the hearing from whom we might ourselves obtain a copy of the transcription. I stated that he further refused to make their file available to us. [redacted] stated that this was absolutely silly and that he would take necessary steps to see that we got a copy of the transcription and that the file was made available.

As a result of this conversation [redacted] telephoned me on the morning of August 27 in compliance with [redacted] instructions. [redacted] He stated that under the war compliance act or statute, material collected by his investigators was considered to be confidential and they were under instructions not to make it available to other agencies without subpoena. He said, however, that as a practical matter they ordinarily would make it available to the FBI, Internal Revenue and other authorized agencies on a confidential basis for review and then if it was to be used publicly, appropriate subpoena could be issued.

He stated that he would telephone [redacted] office immediately and see that a copy of the transcription was made available and that the material from their files would also be available. b7c

Shortly thereafter he telephoned me back and stated that he had been in contact with [redacted] 1355 Market Street, San Francisco, who indicated that they could not previously make a copy of the transcription available to us since it had just been received yesterday and further their file only consisted of work papers which had constantly been in use in their efforts to prepare for the September 5 hearing. He said arrangements had been made for [redacted] to make available to our representative a copy of the transcription, together with any material desired from the file.

I again pointed out he wouldn't even give us the name of the hearing reporter.

PURPOSE

This is to advise you that a hearing was held at San Francisco on August 13 last concerning a "stop order" issued by the C.P.A. in connection with the construction of the Flamingo Hotel in Las Vegas, Nevada. [redacted] was appointed to hear the subject matter and from the facts presented at this hearing decided in favor of the respondents. [redacted] however, allowed the C.P.A. until September 5th to produce further evidence, and unless such evidence is presented, the case will then be closed.

BACKGROUND

The Los Angeles Office recently advised that in connection with the construction of the Flamingo Hotel in Las Vegas, Nevada, a stop order was issued by the C.P.A. against the Del Webb Construction Company which had been employed by Benjamin Siegel [redacted] to construct the Flamingo Hotel in Las Vegas, Nevada. [redacted] who was appointed to hear the case, has advised that the following appeared as interested parties: [redacted] Benjamin Siegel, and [redacted] of the Del Webb Architects. [redacted] further advised that the respondents were represented by the following attorneys: [redacted] At the hearing [redacted] advised that the respondents exhibited a plan dated January 12th and [redacted] testified that this was the plan followed in the construction of the Flamingo Hotel. [redacted] stated that he pointed out at the hearing that this plan lacked details such as elevation and he therefore questioned whether they could proceed with the building using only the plans of January 12th. [redacted] further advised that he asked if the local building code required filing of detailed plans, and he was advised in the negative. [redacted] reported that at the hearing the respondents showed that they had received a wire on April 16, 1946 from the C.P.A. to the effect that they must stop construction if the construction was in violation of a freeze order placed at that time. The respondents further produced a letter directed to the C.P.A. stating that the construction was proceeding on the plan of January 12th and as the building was started before March 26th, they were not violating any freeze order. [redacted] further advised that the respondents produced testimony to the effect that they had spent over \$700,000 and committed themselves to about \$500,000. [redacted] further advised that he was concerned with the operation of the C.P.A. in that they failed to present any proof that the respondents were violating any order issued by the C.P.A. Therefore, from the facts presented he decided in favor of the respondents. However, he allowed the C.P.A. until September 5th to produce further evidence if desired, and unless the C.P.A. requests a further hearing, the case will then be closed.

CONFERENCE CPA

Mr. A. E. Ostholthoff was contacted at the San Francisco Division and he advised that he had just had a conference with the CPA officials. The CPA officials made available a copy of the transcript of the minutes of the hearing held in connection with the construction of the Flamingo Hotel. They stated that everything in their files was contained in the transcript except the plans for the Flamingo Hotel which were in the possession of one of their investigators handling the matter at the present time at Las Vegas. CONTEMPLATED RFC LOAN

Mr. Osthoff's attention was called to his Personal and Confidential letter of August 26, 1946, wherein he advised that the Director had instructed that a letter be directed to George Allen of the Reconstruction Finance Corporation giving Mr. Allen some background concerning the people behind the Flamingo Hotel. In this letter Mr. Allen was to be further advised of possible efforts on the part of these individuals to secure a loan from the RFC so that Mr. Allen could block any such loan.

It was pointed out to Mr. Osthoff that in his telephone call to the Bureau on August 21, 1946, he merely advised that Siegel in general conversation had indicated [redacted] that he might attempt to obtain an RFC loan in connection with the construction of the Flamingo Hotel and that at that time Mr. Osthoff was advised to follow the matter closely and if any information was developed indicating that positive action was to be taken in obtaining an RFC loan the Bureau should be immediately advised. It was pointed out to Mr. Osthoff that at this time his letter of August 26 which purported to set out information concerning this matter had not been received at the Bureau. Mr. Osthoff advised that his letter of August 26 contained no additional information concerning this matter. He stated that the only information they had was to the effect that Siegel indicated [redacted] that he might possibly seek an RFC loan and that they had no information as to the amount of the loan he might seek, the place where he might make application, or the identity of any persons he might enlist to assist him in obtaining the RFC loan. He stated, however, that the Director thought it advisable that the information concerning this be called to Mr. Allen's attention at this time. b7c
